FIG. 7 is a bottom view of the baby bath.

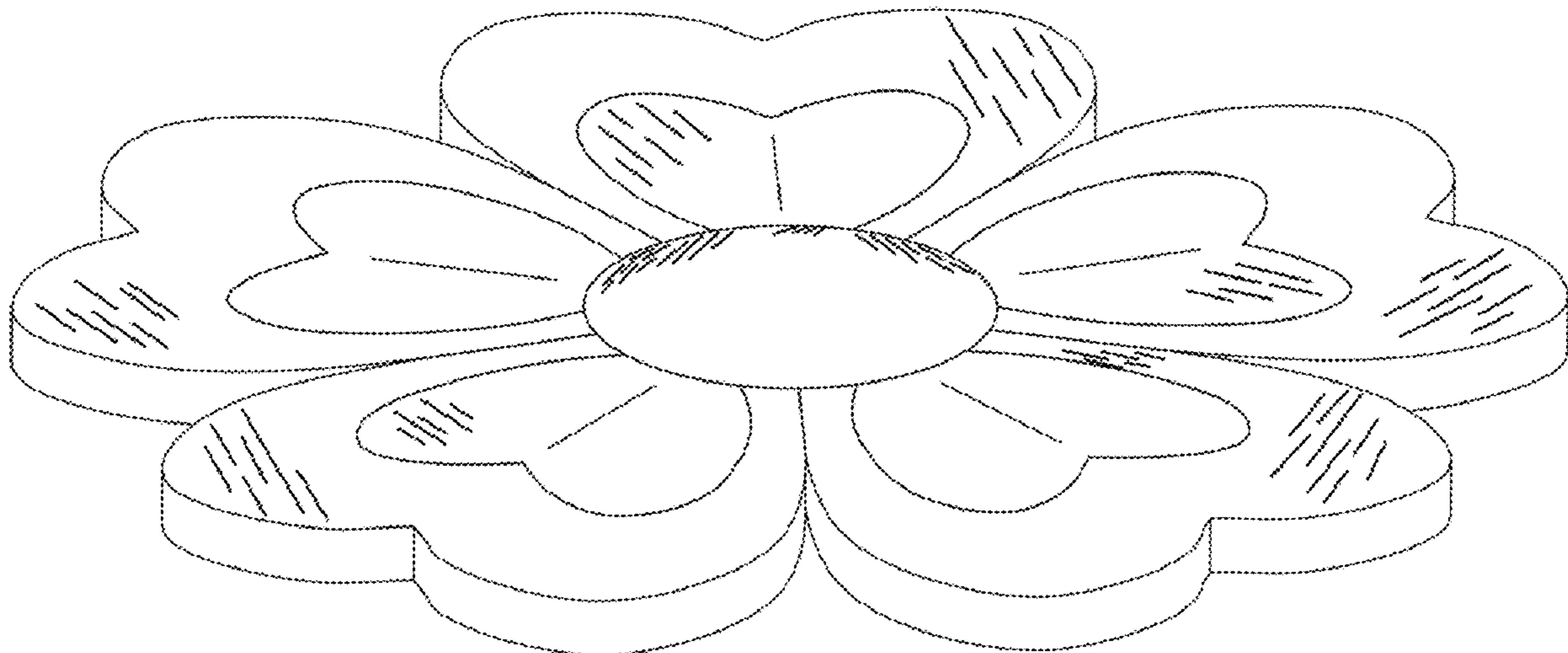
Any shading and cross-hatching are not features of the design but are utilized to illustrate the surface contours of the baby bath in the drawings.

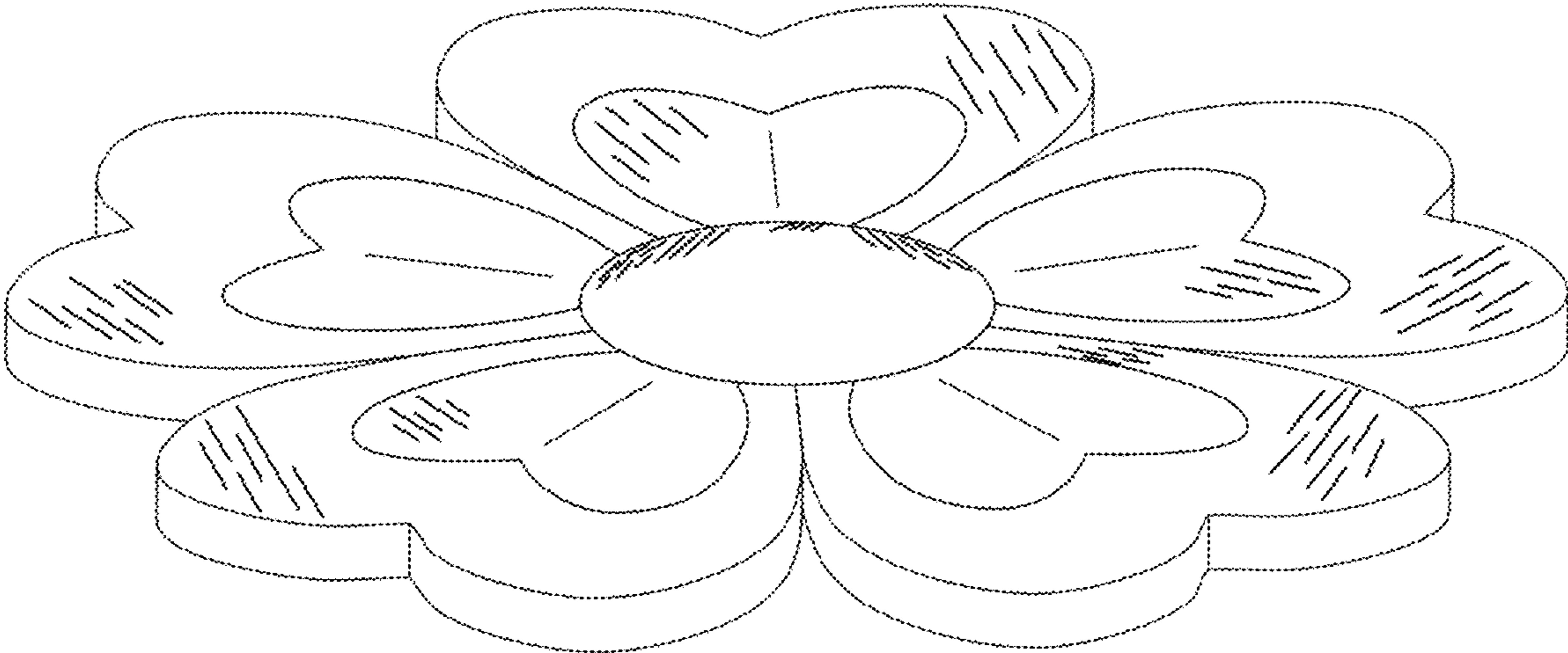

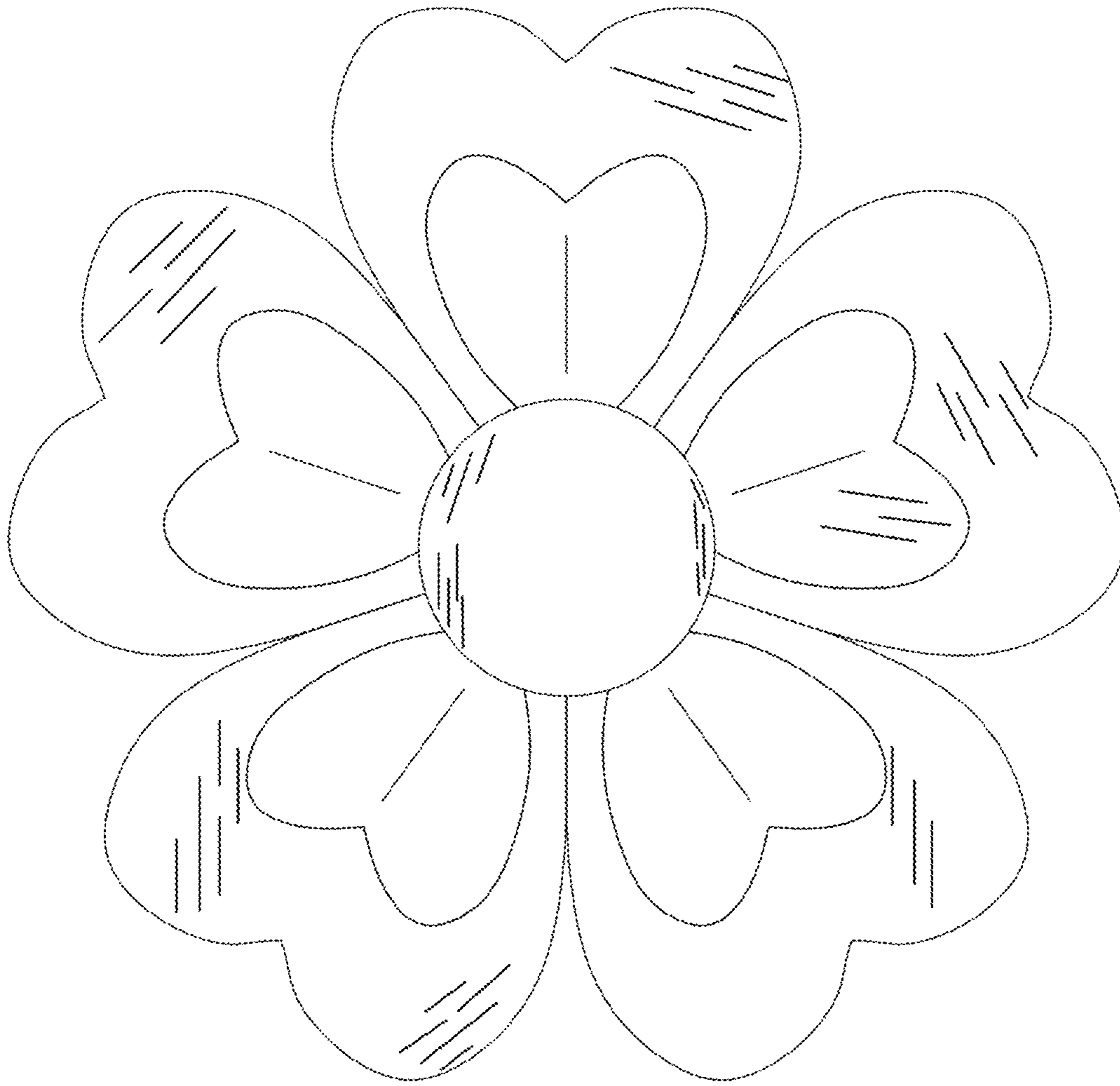

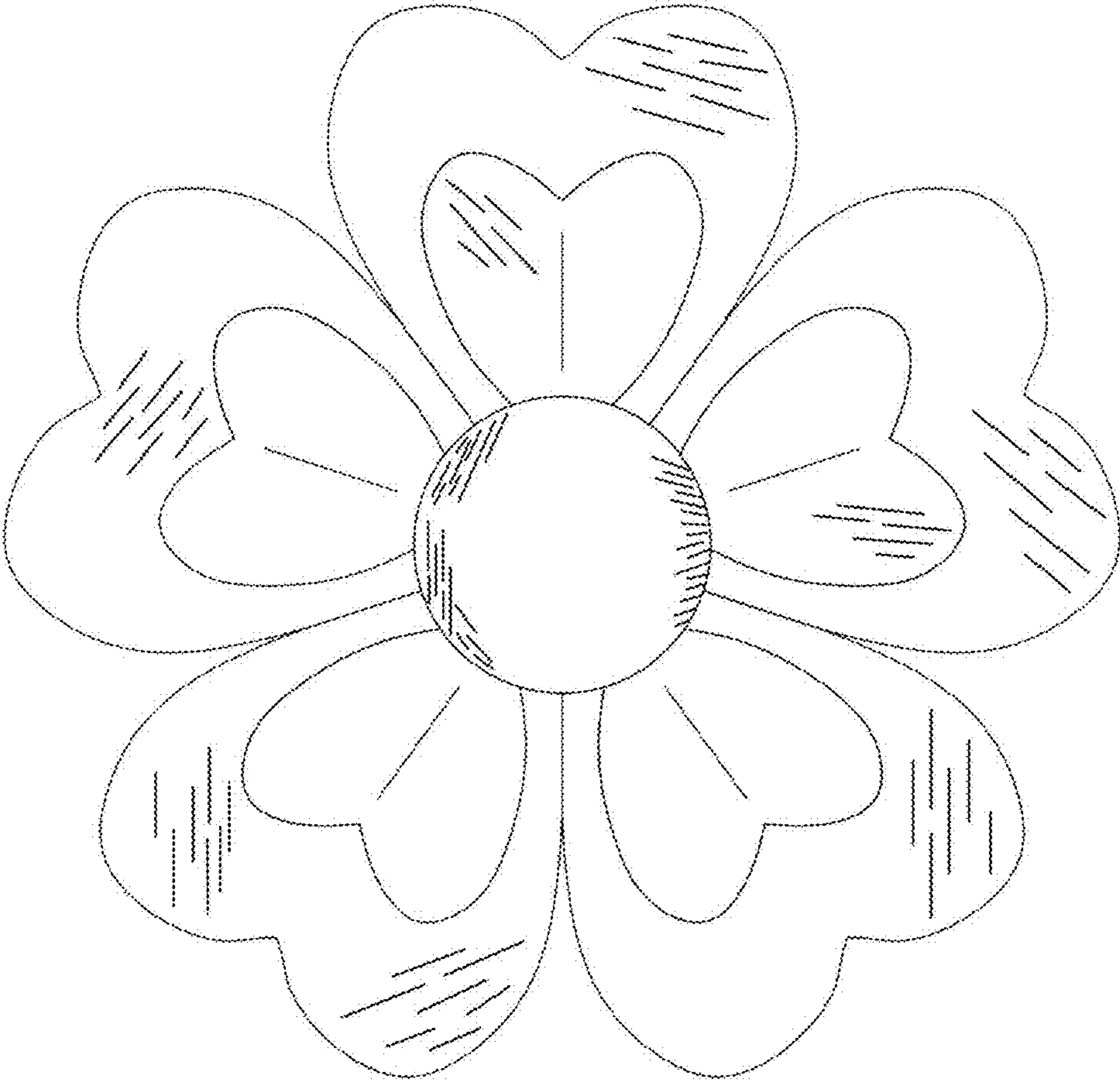

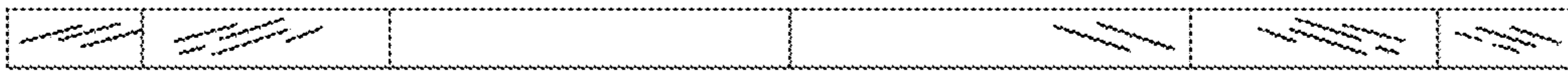
