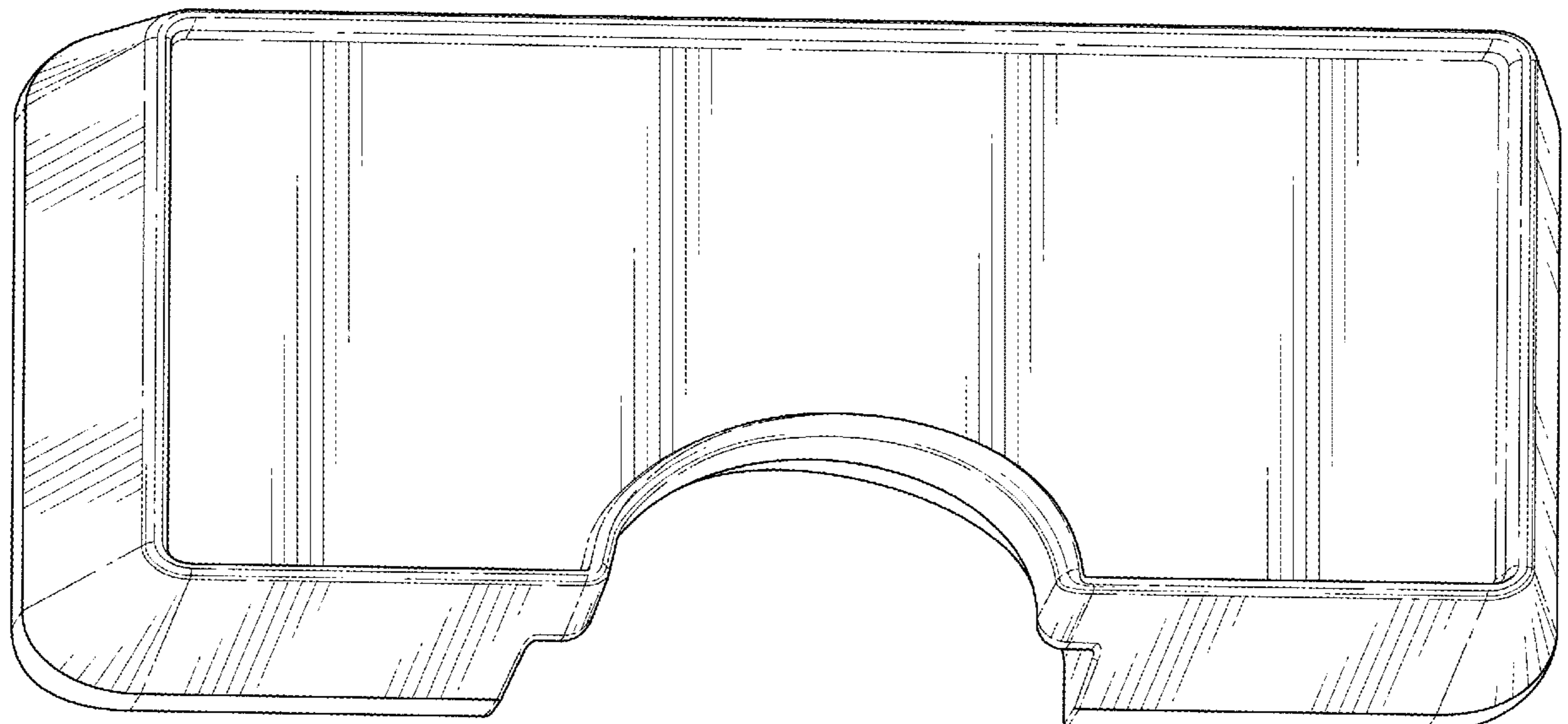
The ornamental design for a coiffeur platform, as shown and described.

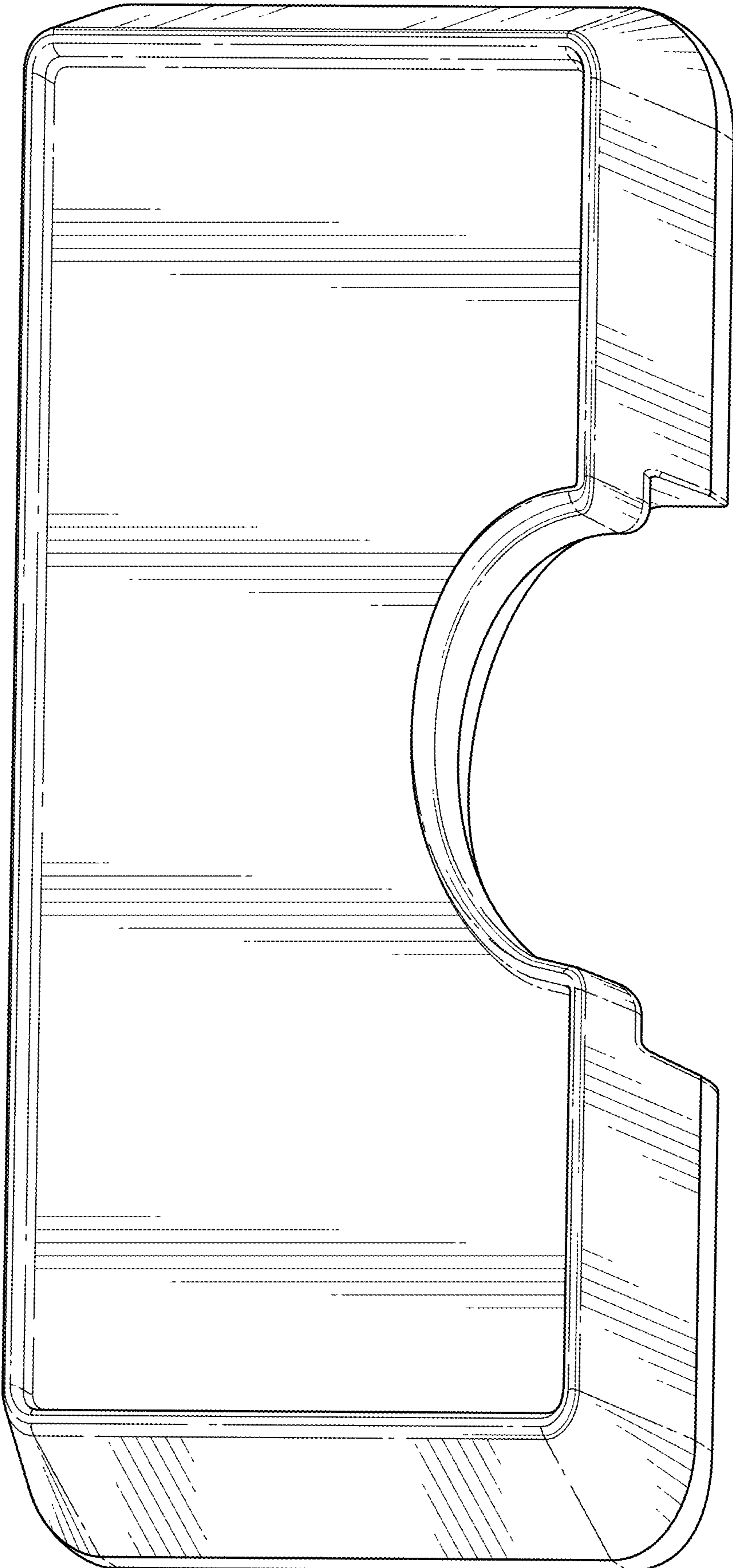

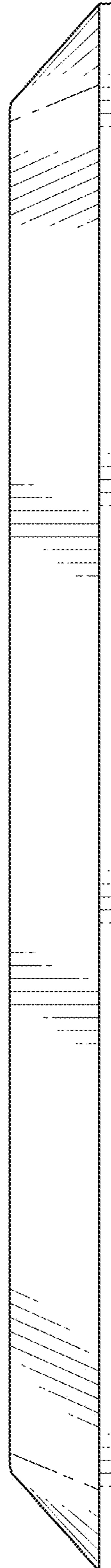

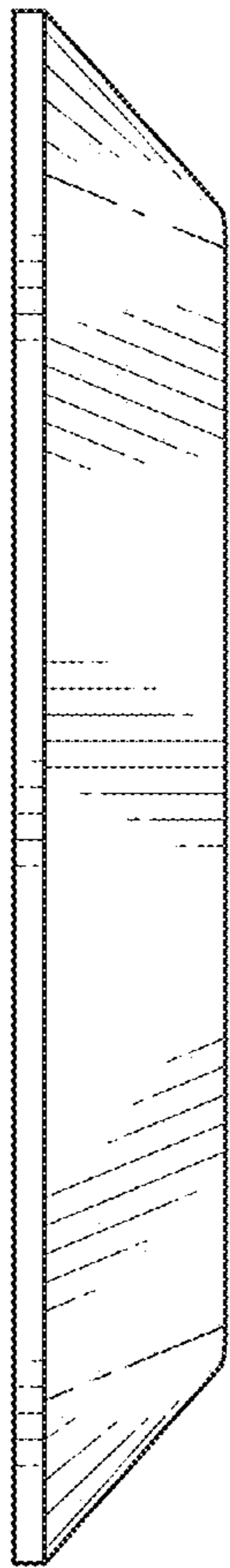

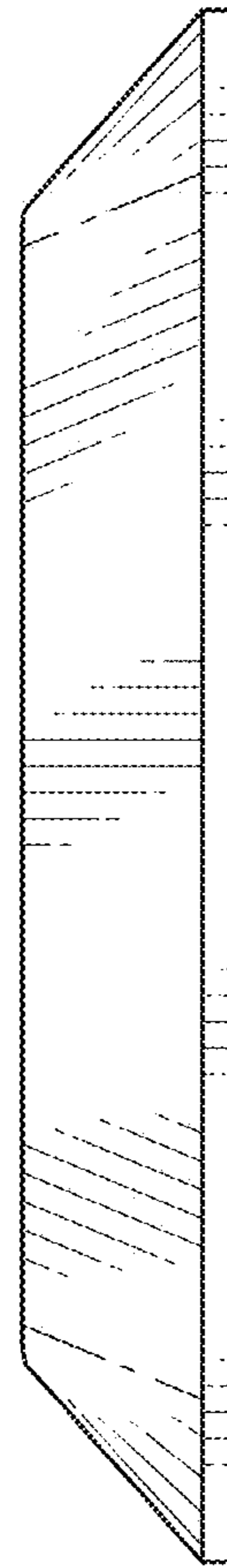

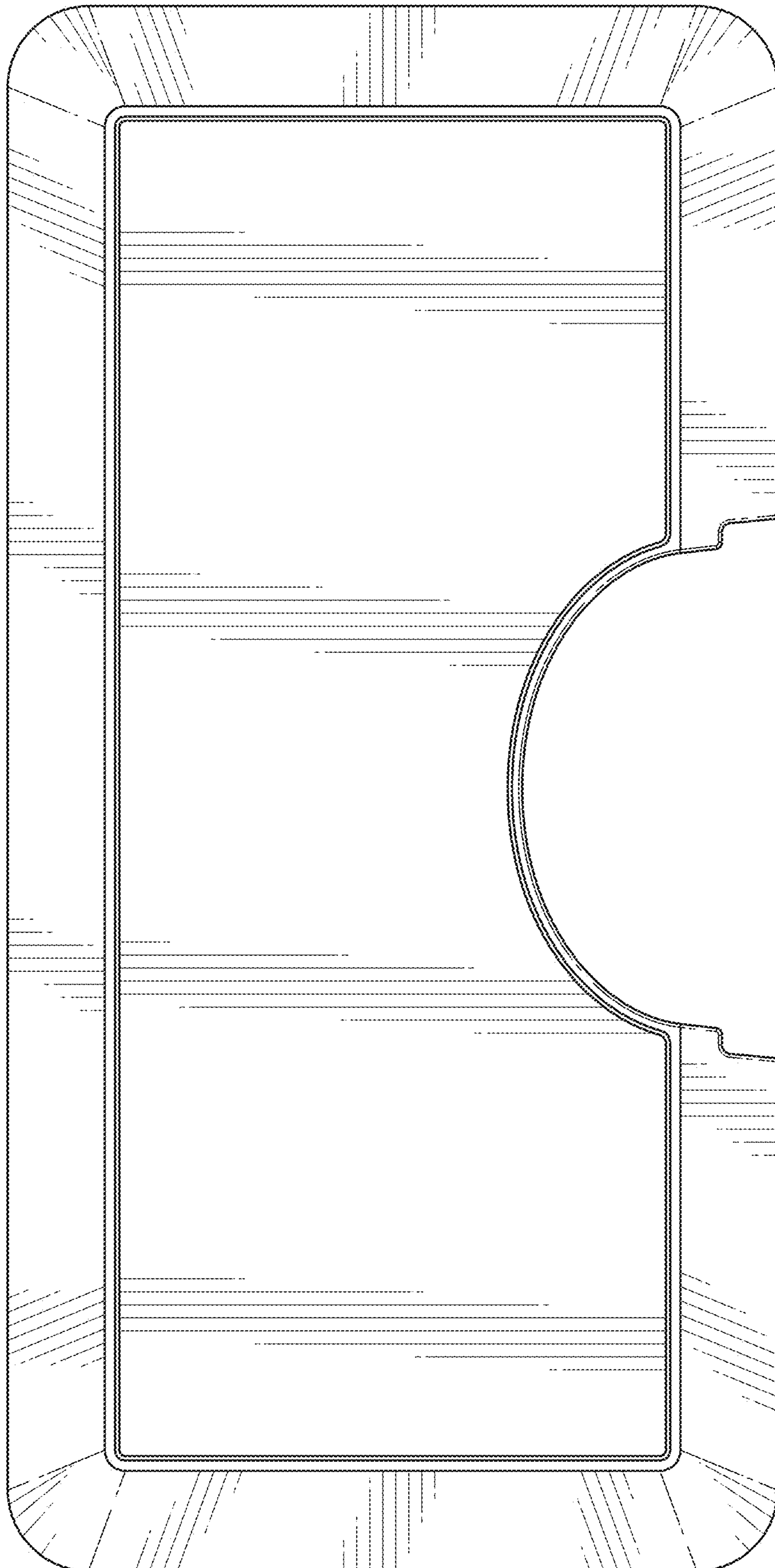

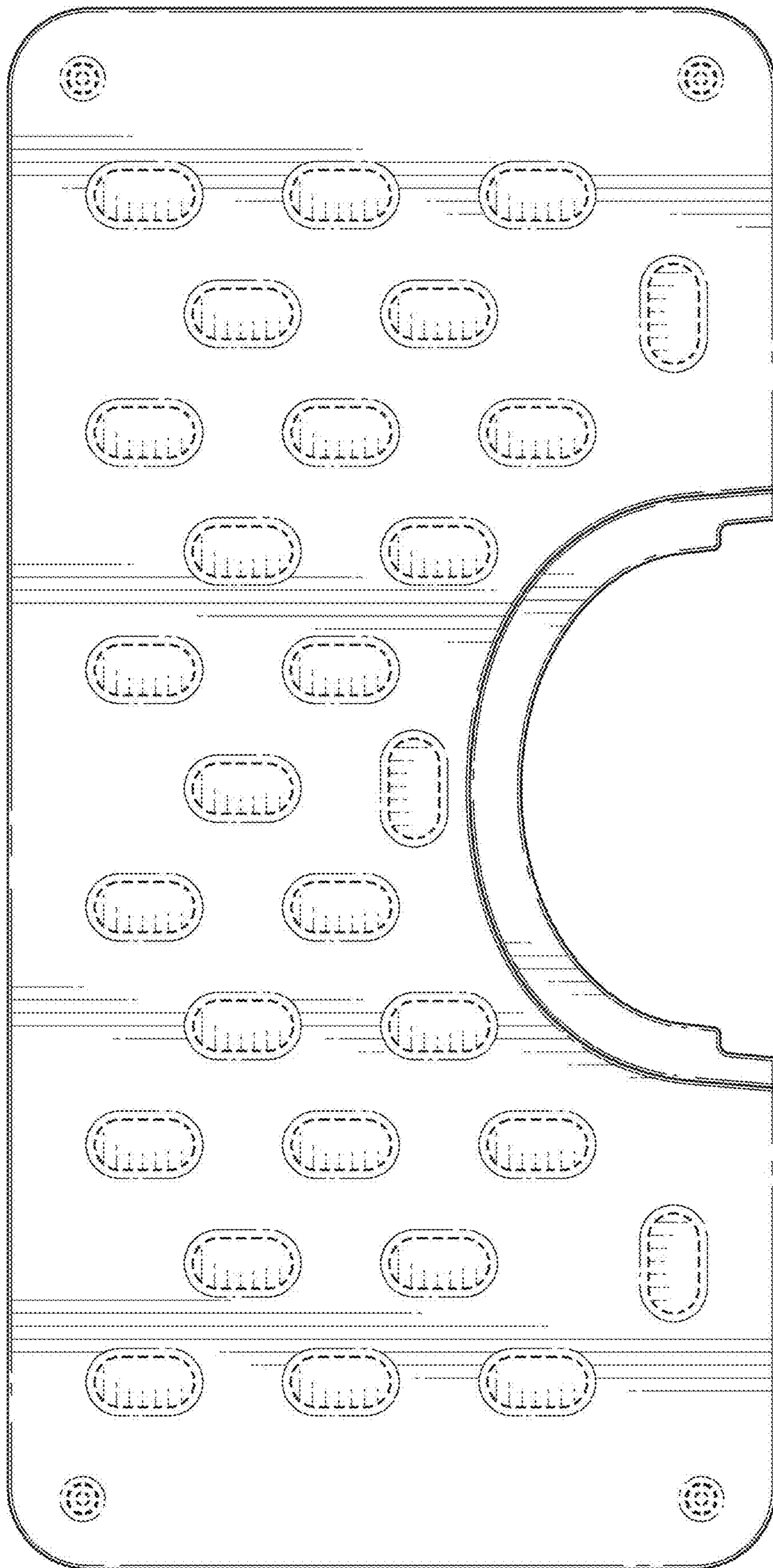
