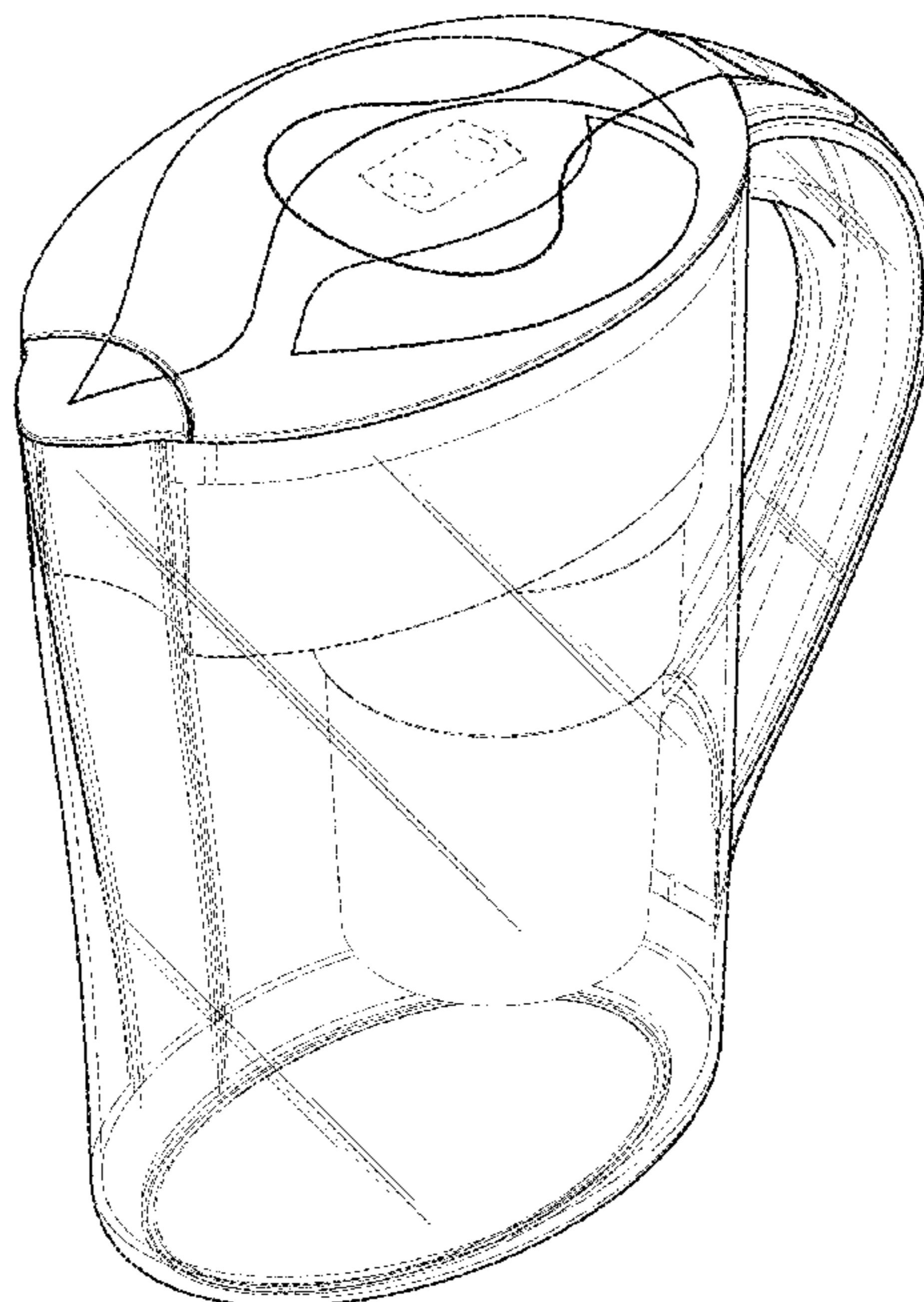
(57) **CLAIM**

The ornamental design for a water pitcher, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a water pitcher, showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a side elevational view thereof;
FIG. 5 is a side elevational view from the side opposite to that of FIG. 4;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The broken lines shown in the figures represent portions of the water pitcher that form no part of the claimed design.

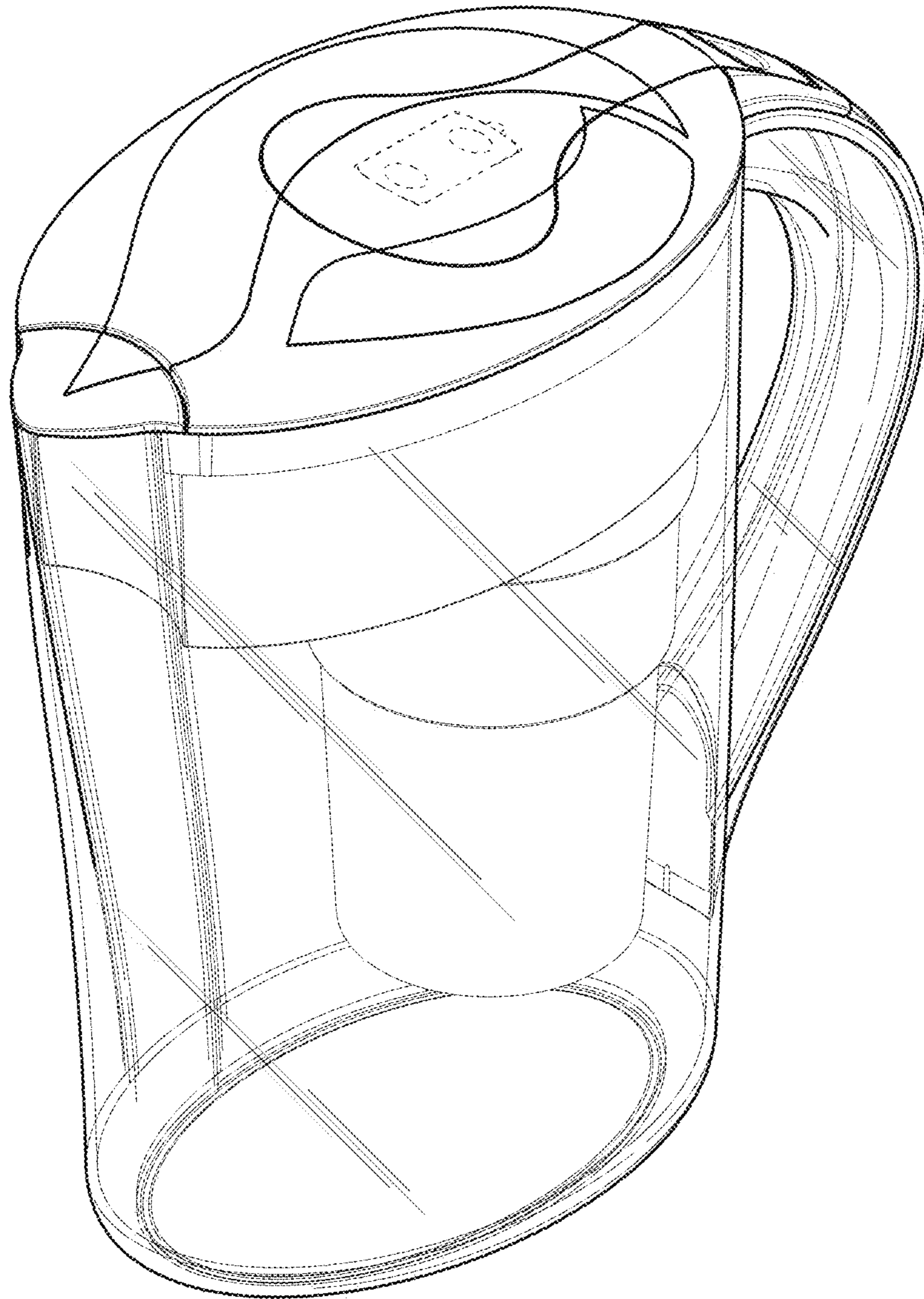

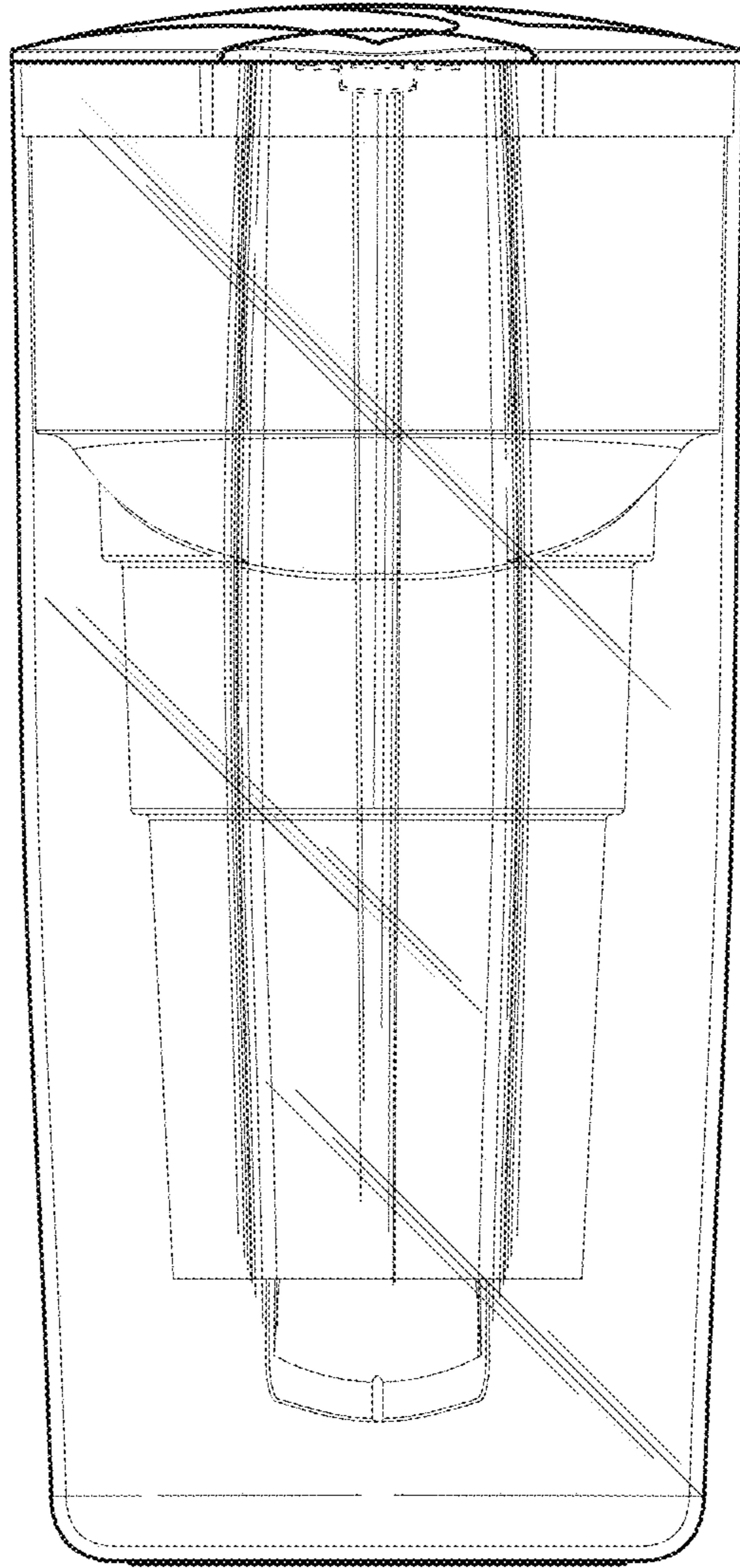

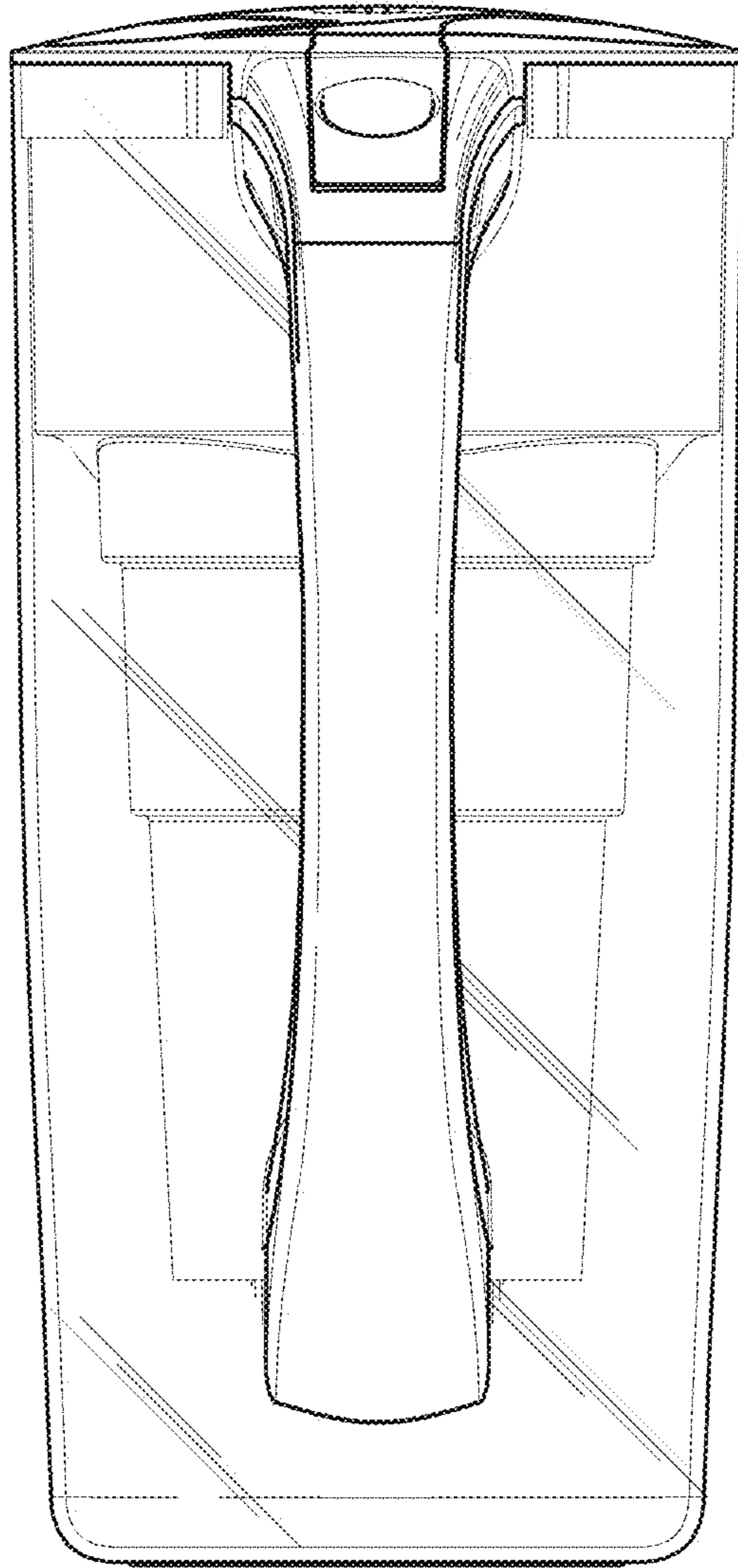

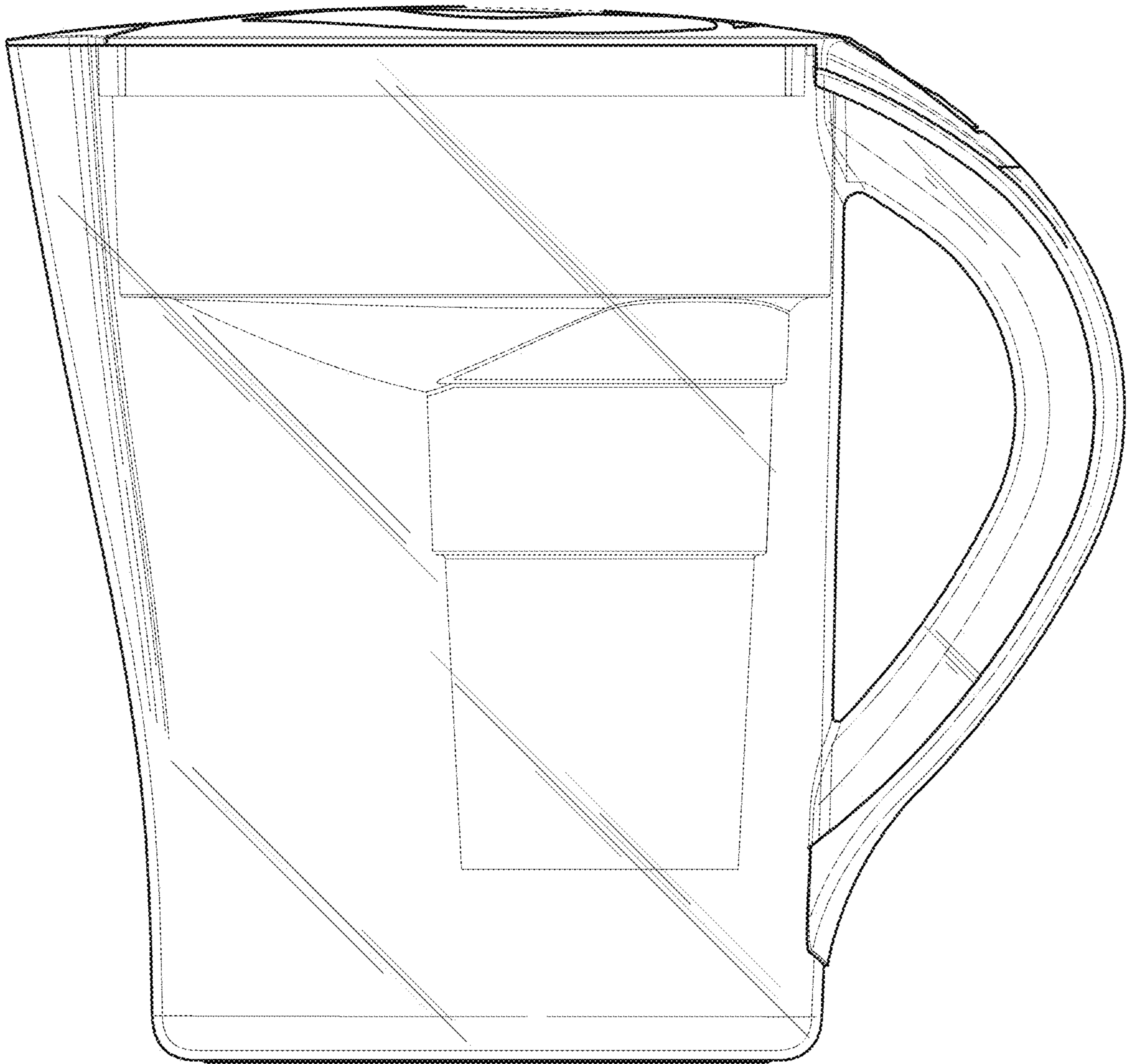

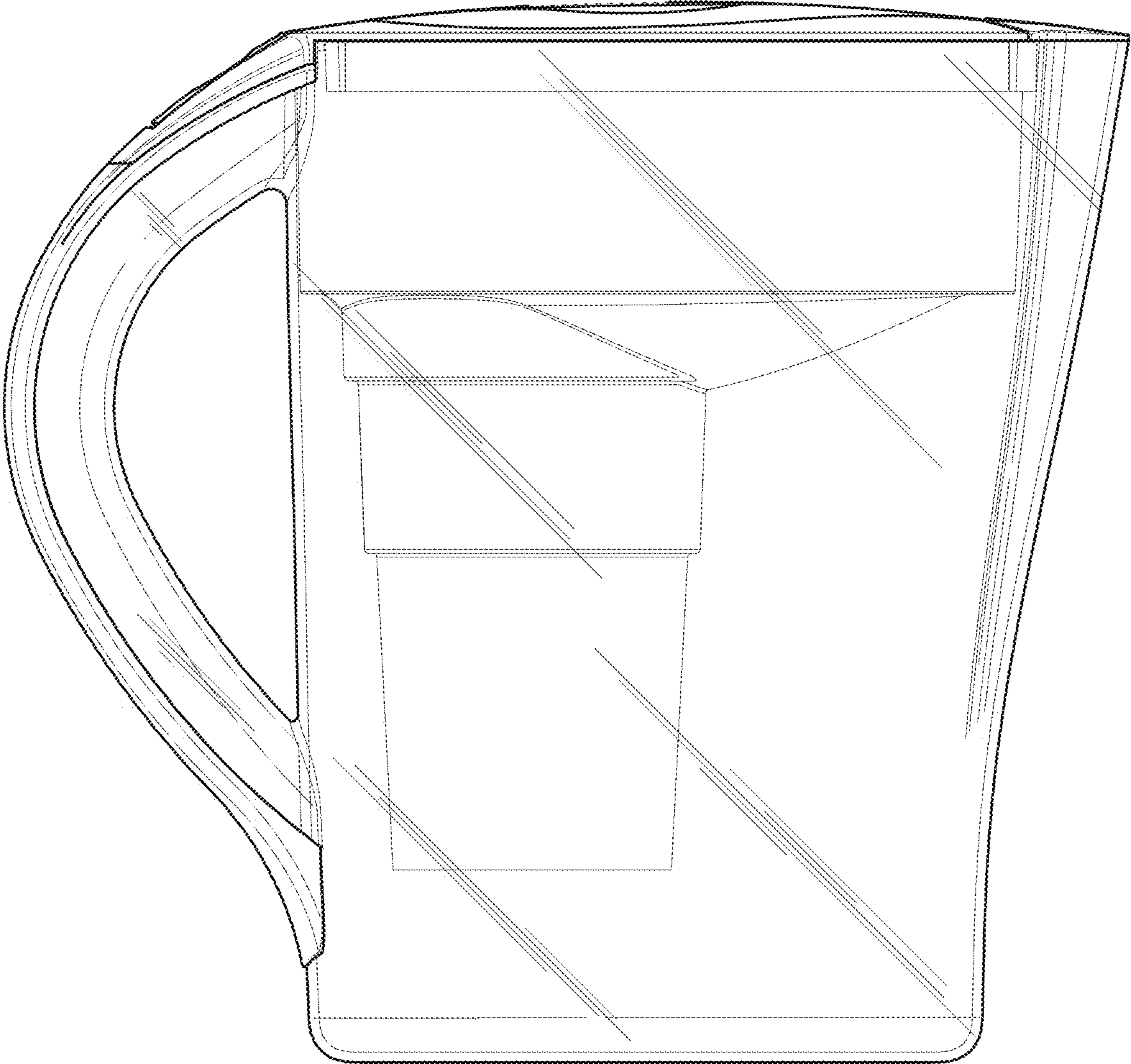

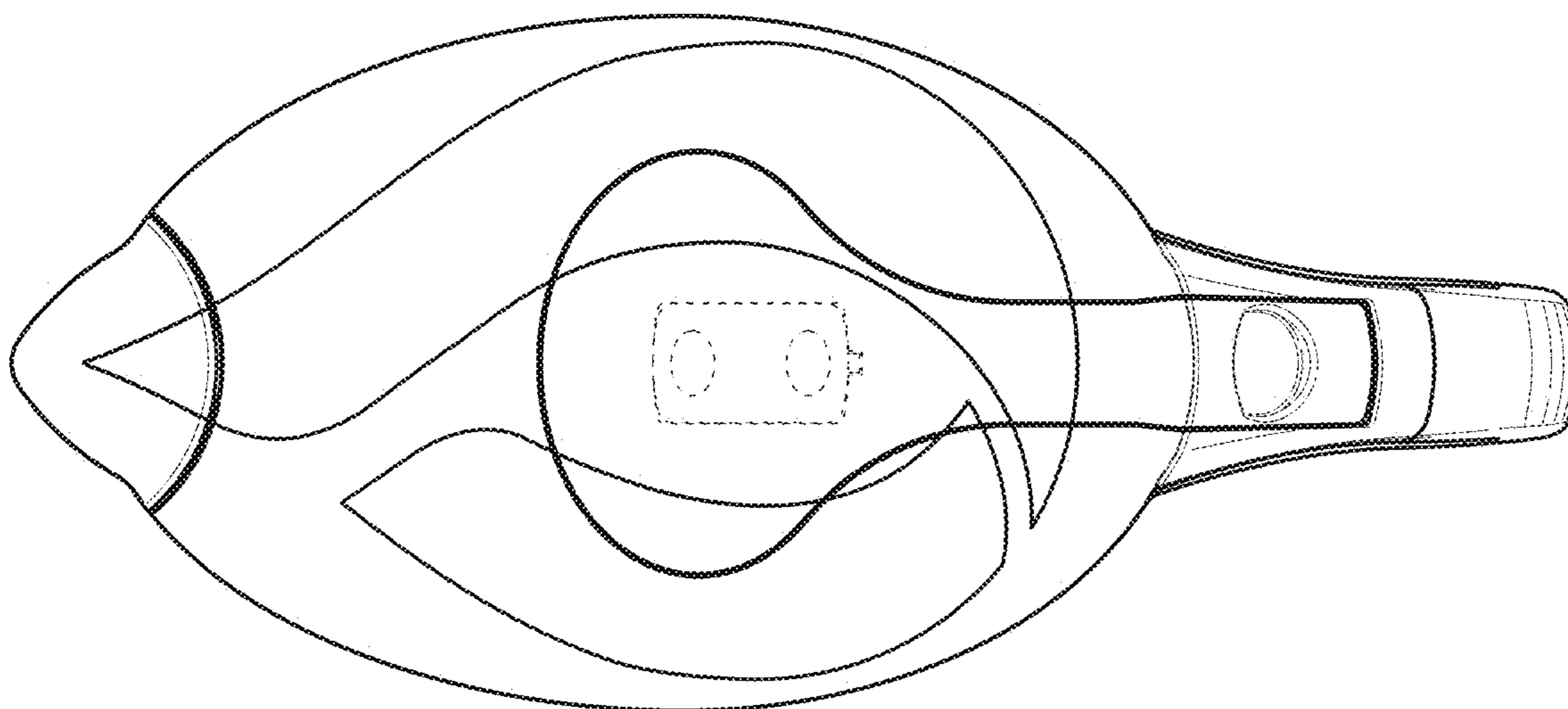

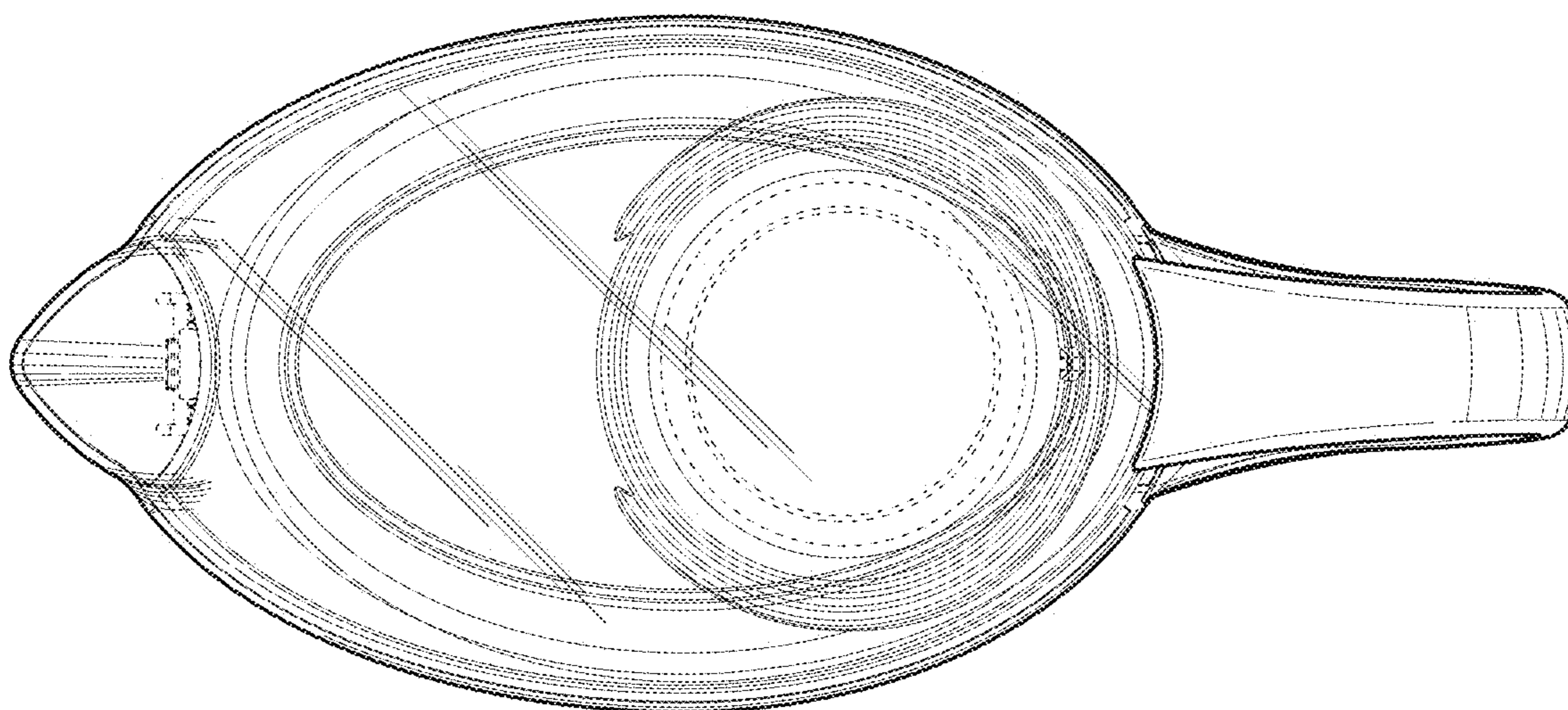
