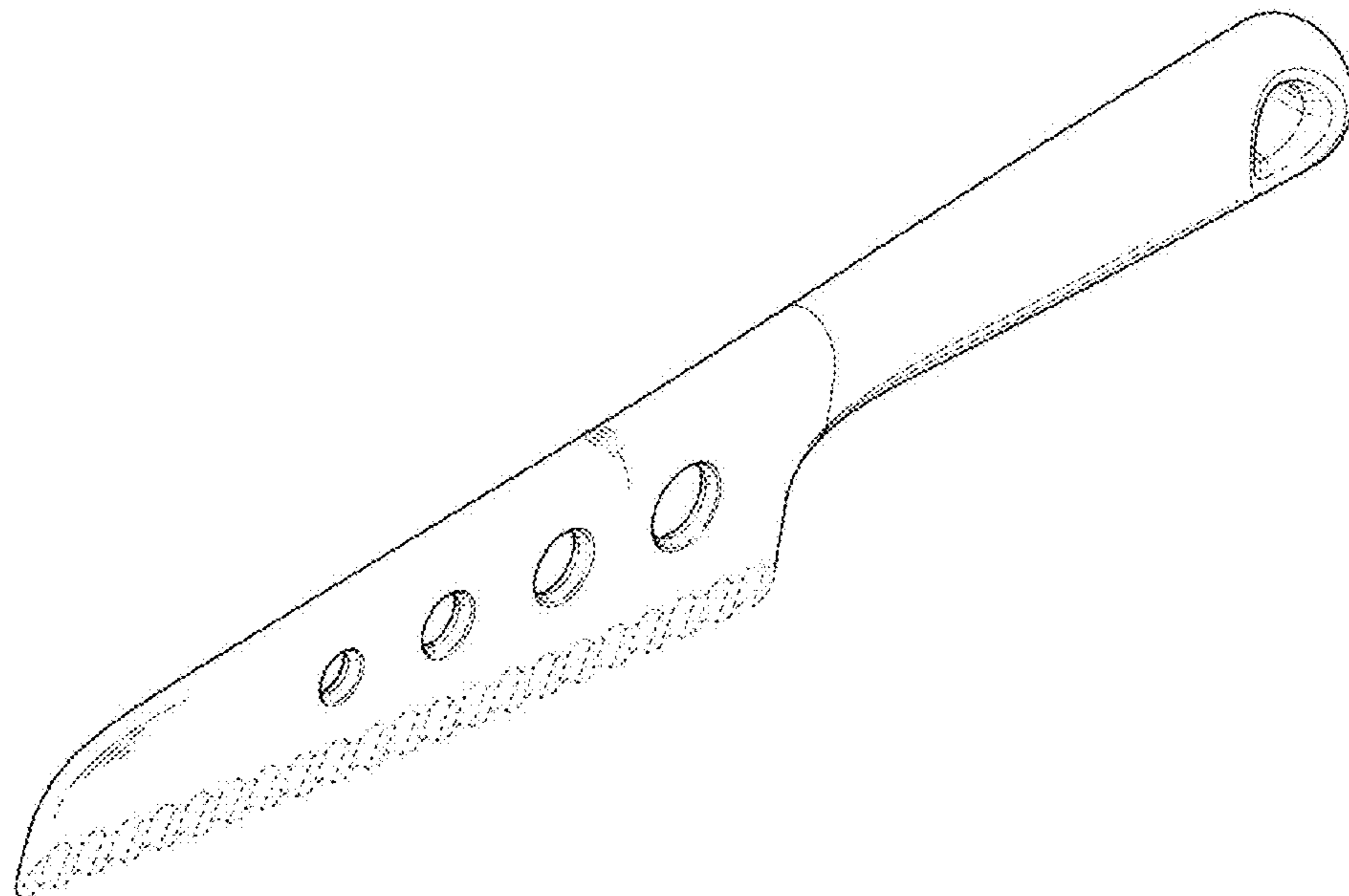
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a knife;
FIG. 2 is a left elevation view thereof (with the right a mirror image thereof);
FIG. 3 is a top view thereof;
FIG. 4 is a bottom view thereof;
FIG. 5 is a front elevation view thereof; and,
FIG. 6 is a rear elevation view thereof.
The broken lines represent a serration pattern which forms no part of the claimed design.

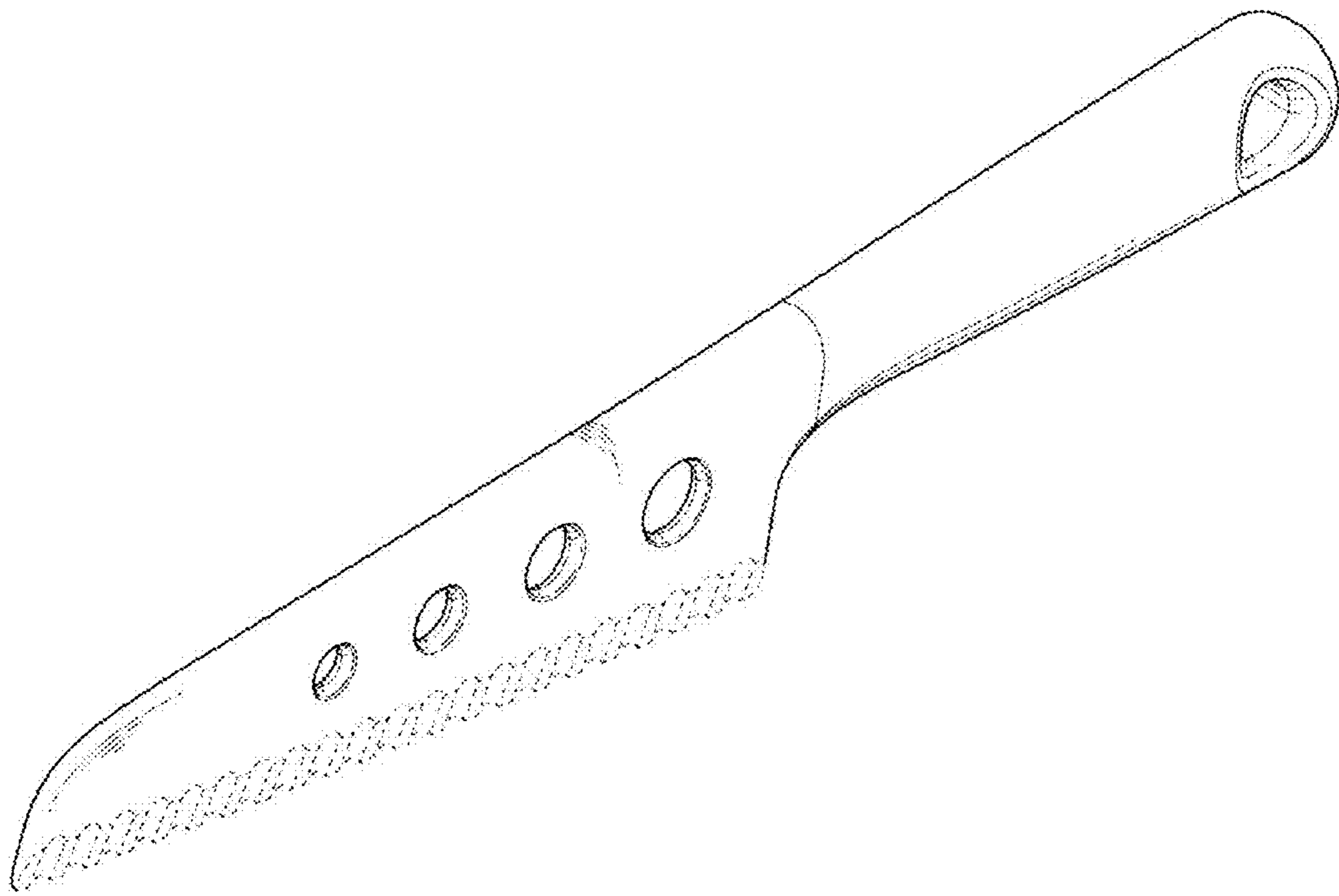

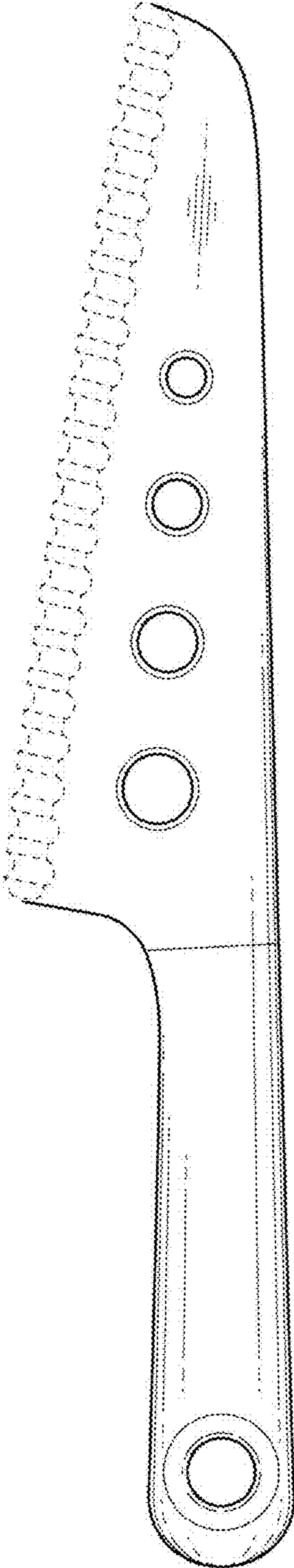

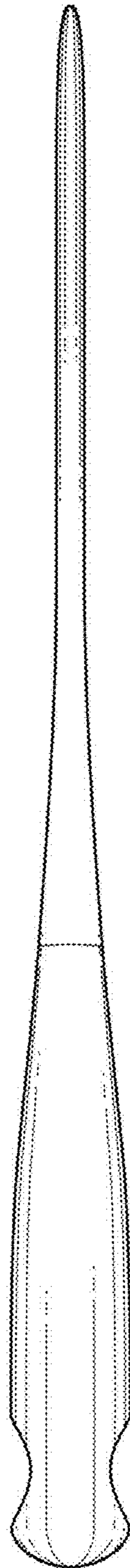

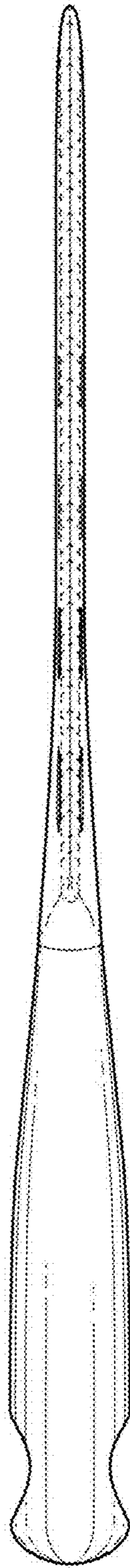

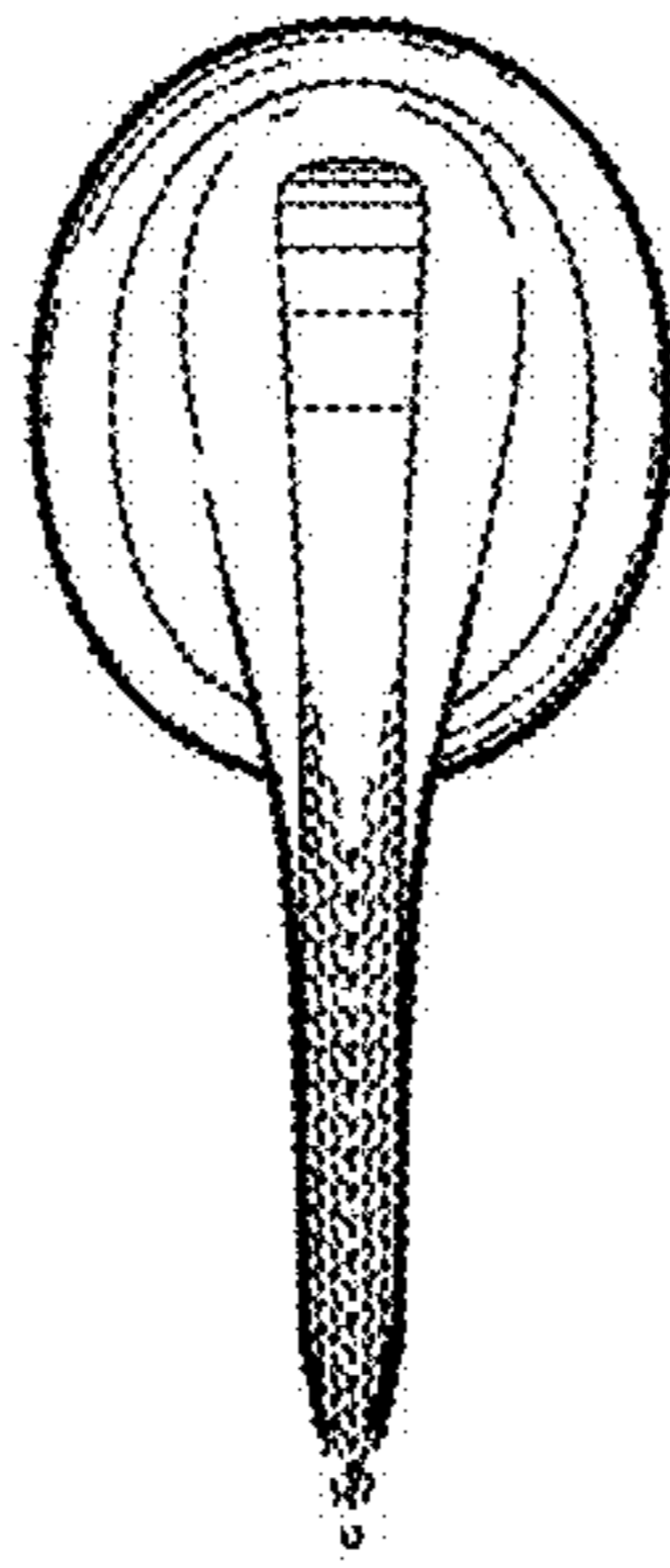

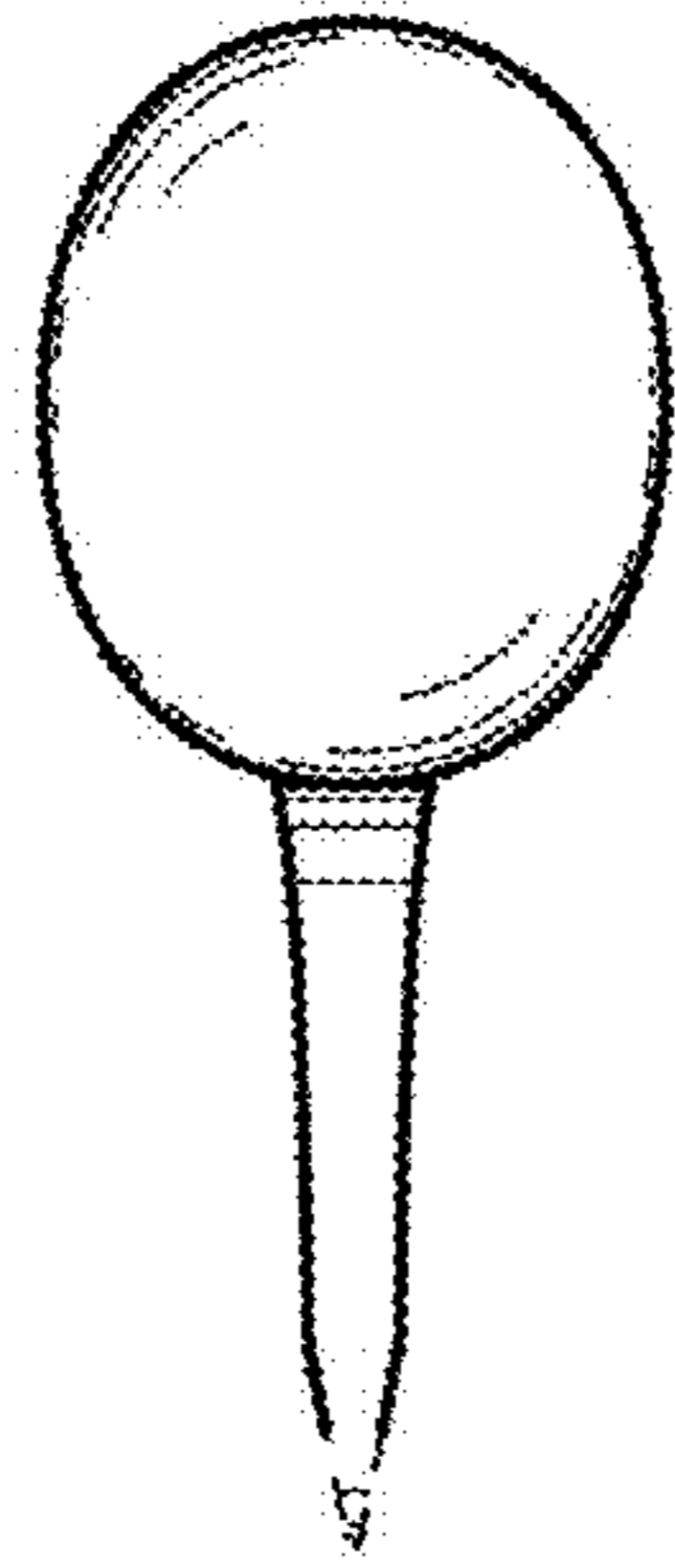
