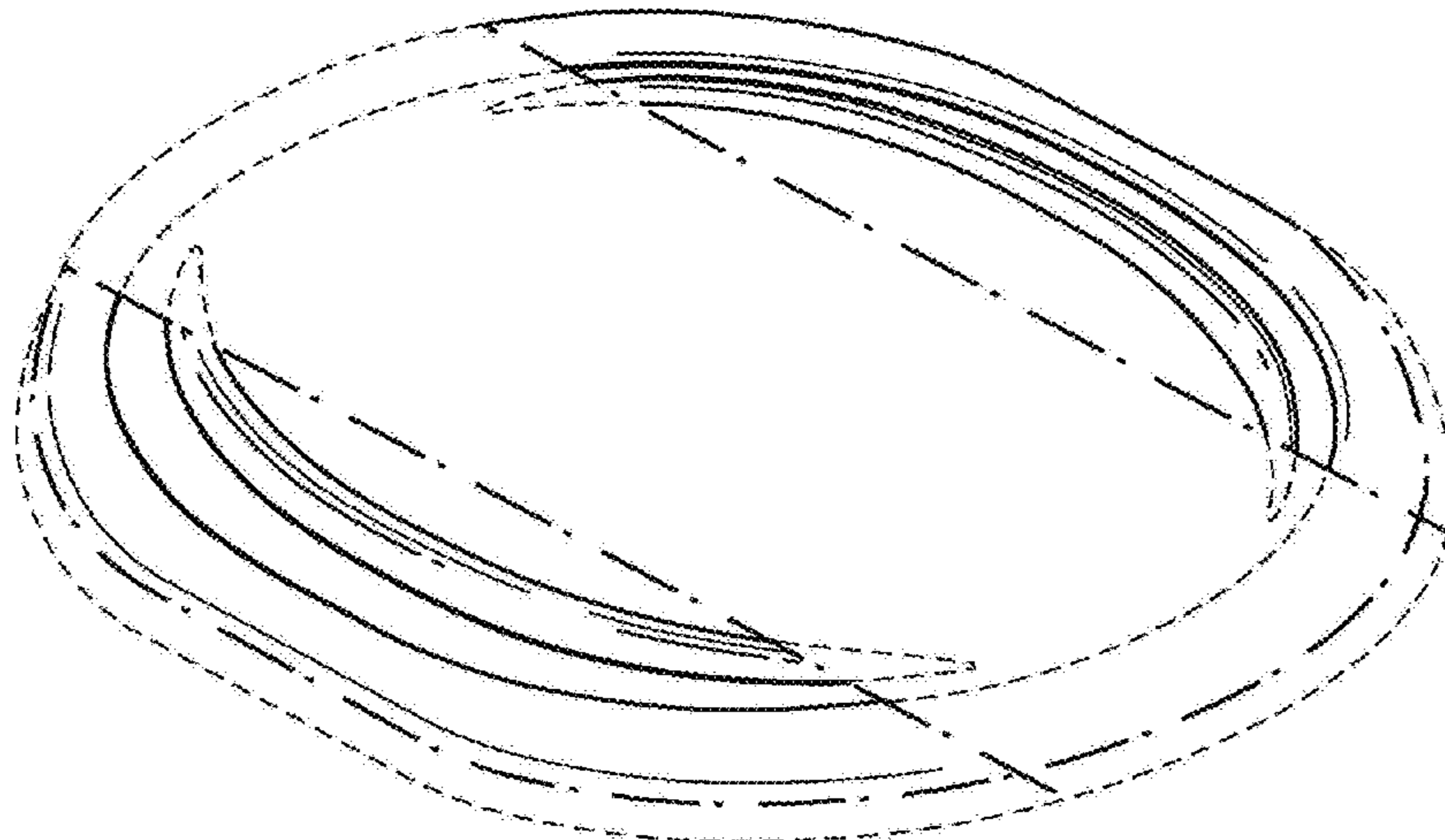

### (57) CLAIM

The ornamental design for a lid, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a lid showing our new design;  
FIG. 2 is a top plan view of the lid of FIG. 1;  
FIG. 3 is a front elevation view of the lid of FIG. 1, the rear elevation view being an identical image;  
FIG. 4 is a right side elevation view of the lid of FIG. 1, the left side elevation view being an identical image; and,  
FIG. 5 is a bottom plan view of the lid of FIG. 1.  
Portions of the containers, container and lids, and lids shown in broken lines in the figures are for illustrative purposes only and form no part of the claimed design. The appearance of any portion of the container between break lines in the figures forms no part of the claimed design. The broken lines which define the bounds of the claimed designs form no part thereof.

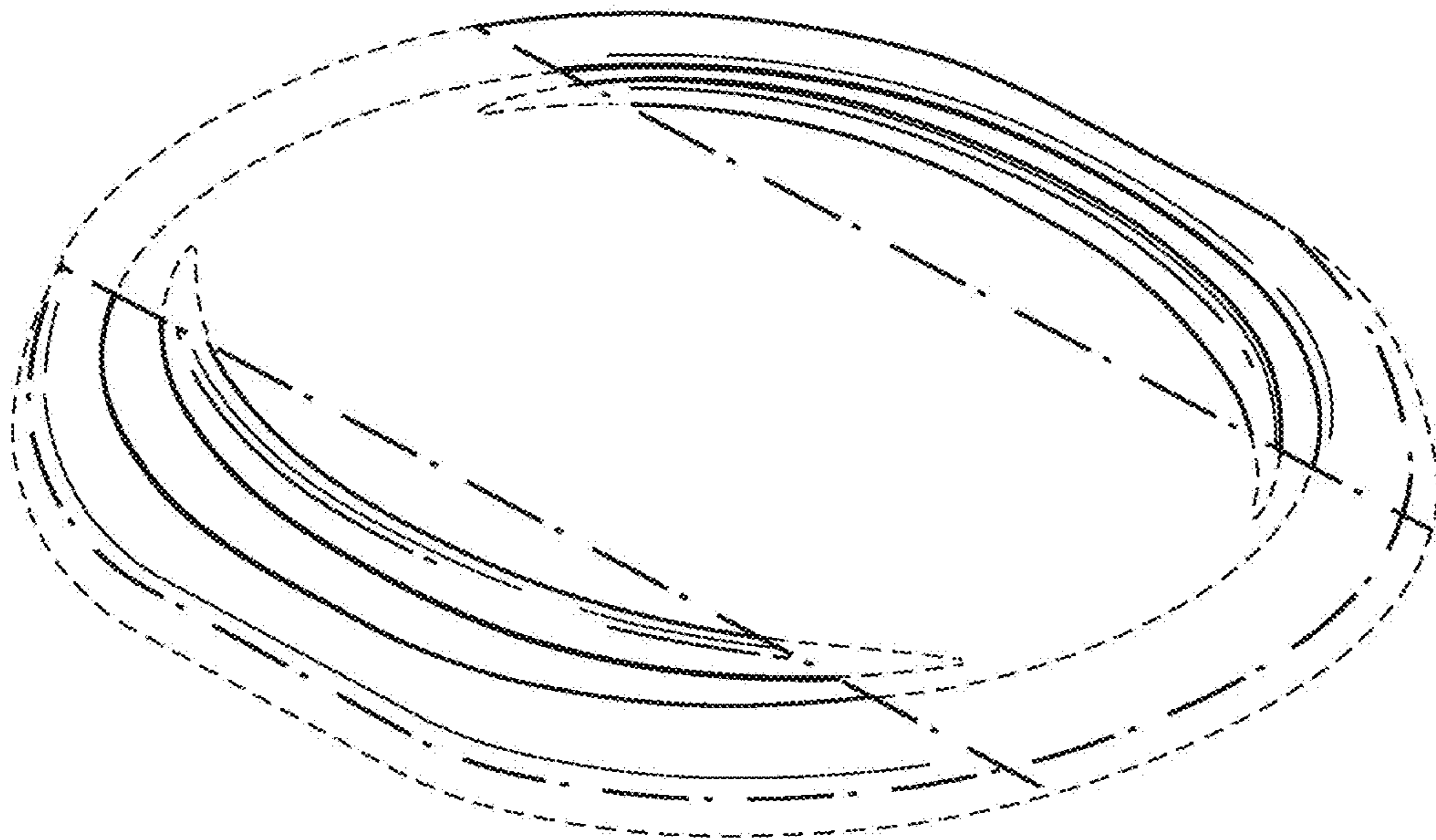

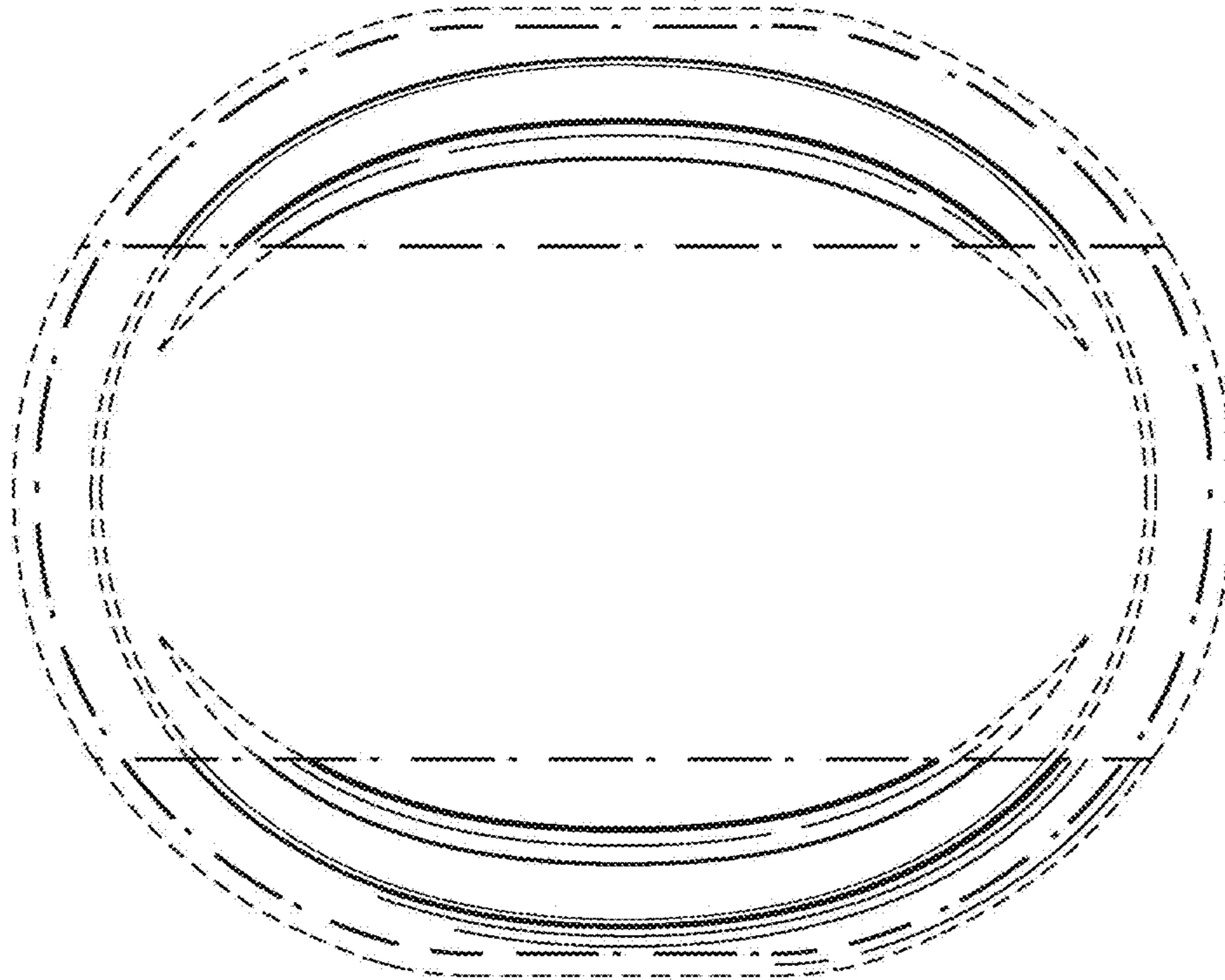

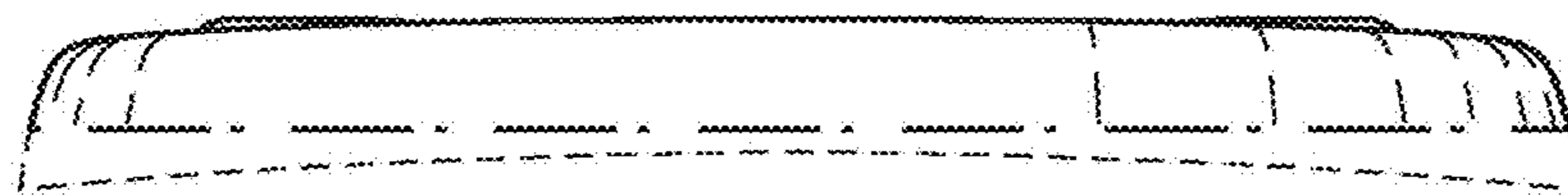

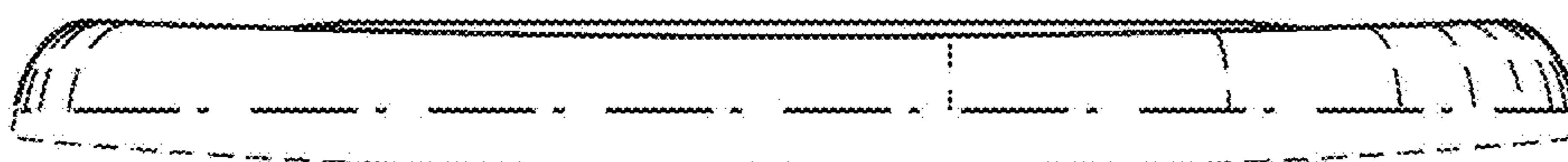
