(57) **CLAIM**

We claim the ornamental design for a five quart bottle, as shown and described.

DESCRIPTION

FIG. 1 is a right side anterior perspective view of a five quart bottle, showing our new design.
 FIG. 2 is an anterior view of a five quart bottle.
 FIG. 3 is a posterior view of a five quart bottle.
 FIG. 4 is a left side view of a five quart bottle.
 FIG. 5 is a right side view of a five quart bottle.
 FIG. 6 is a top view of a five quart bottle; and,
 FIG. 7 is a bottom view of a five quart bottle.
 The broken lines in the drawings depict portions of the five quart bottle that form no part of the claimed design.

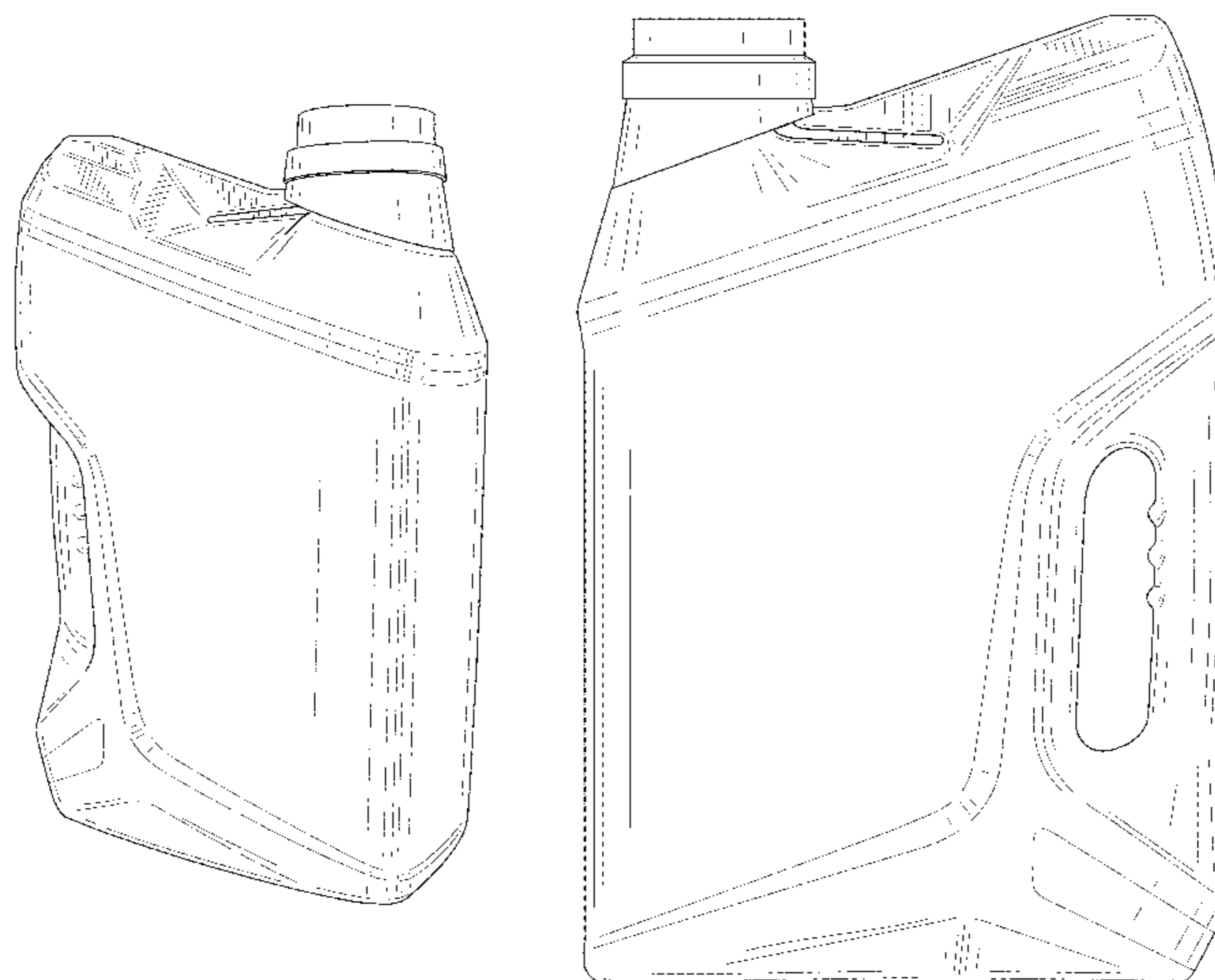

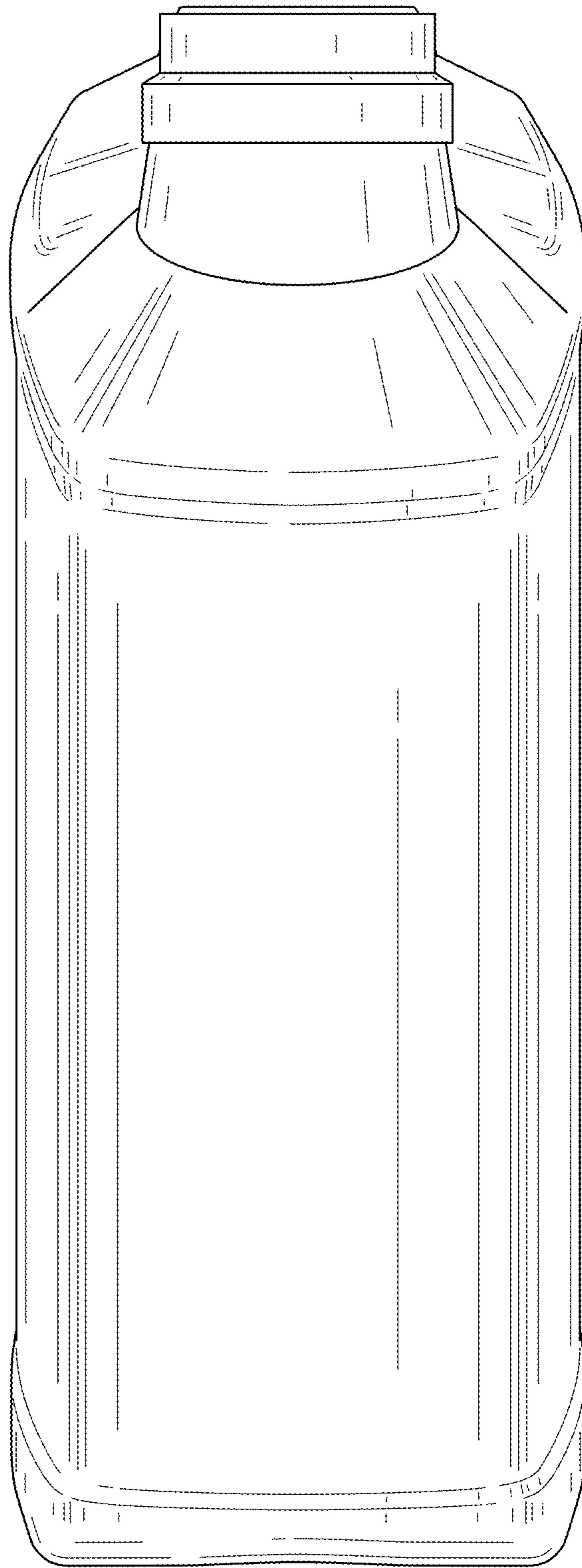

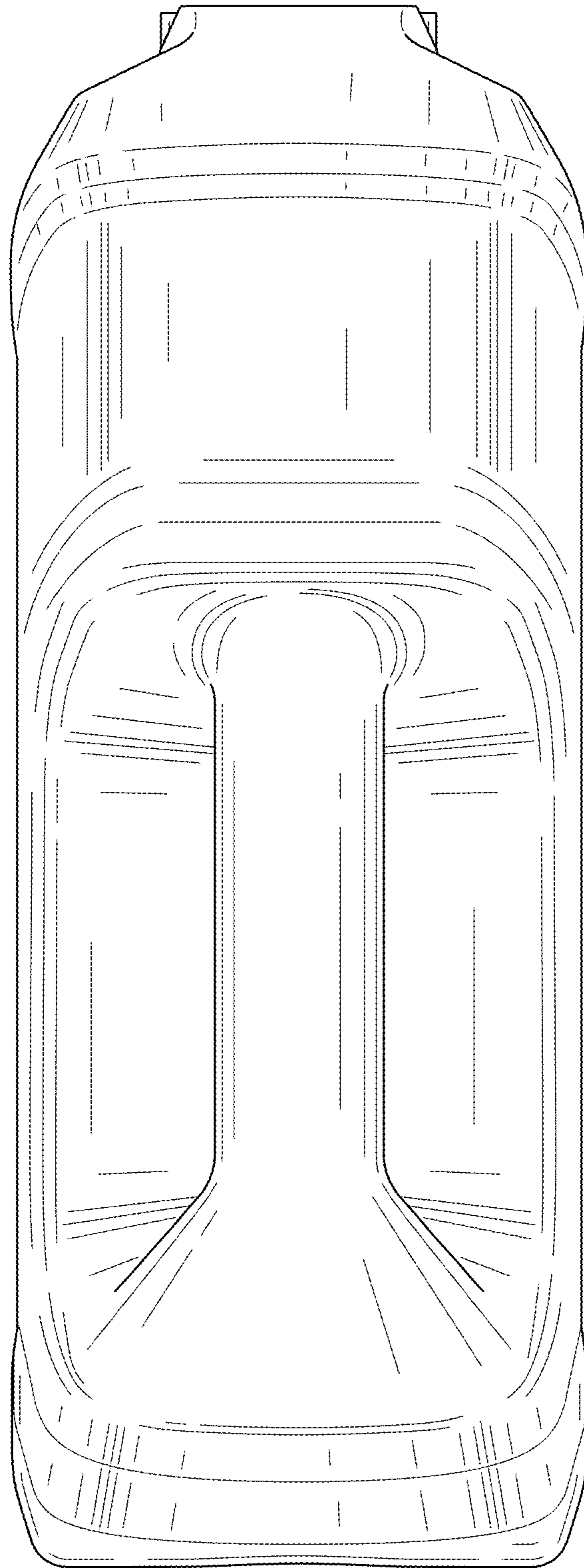

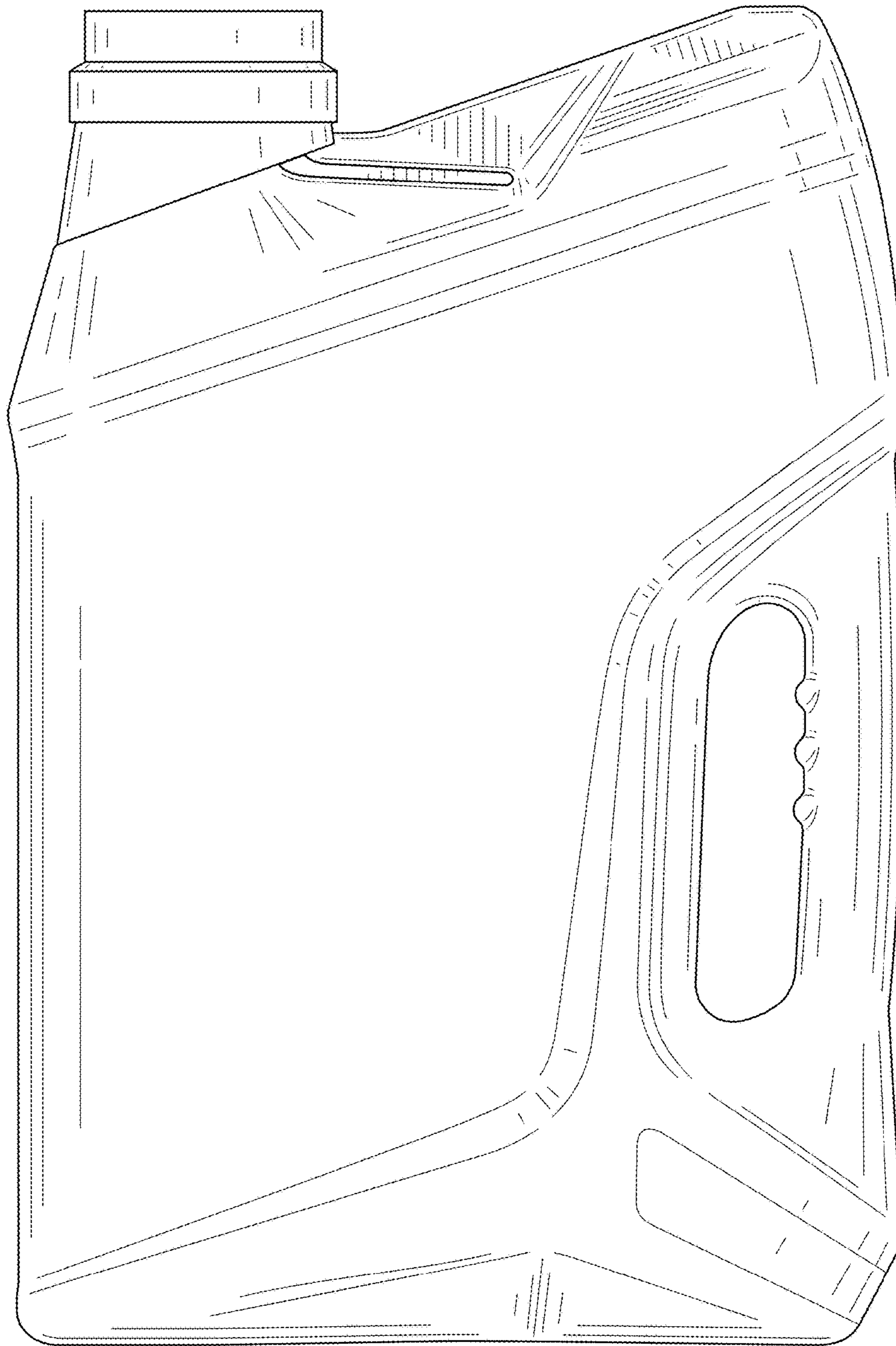

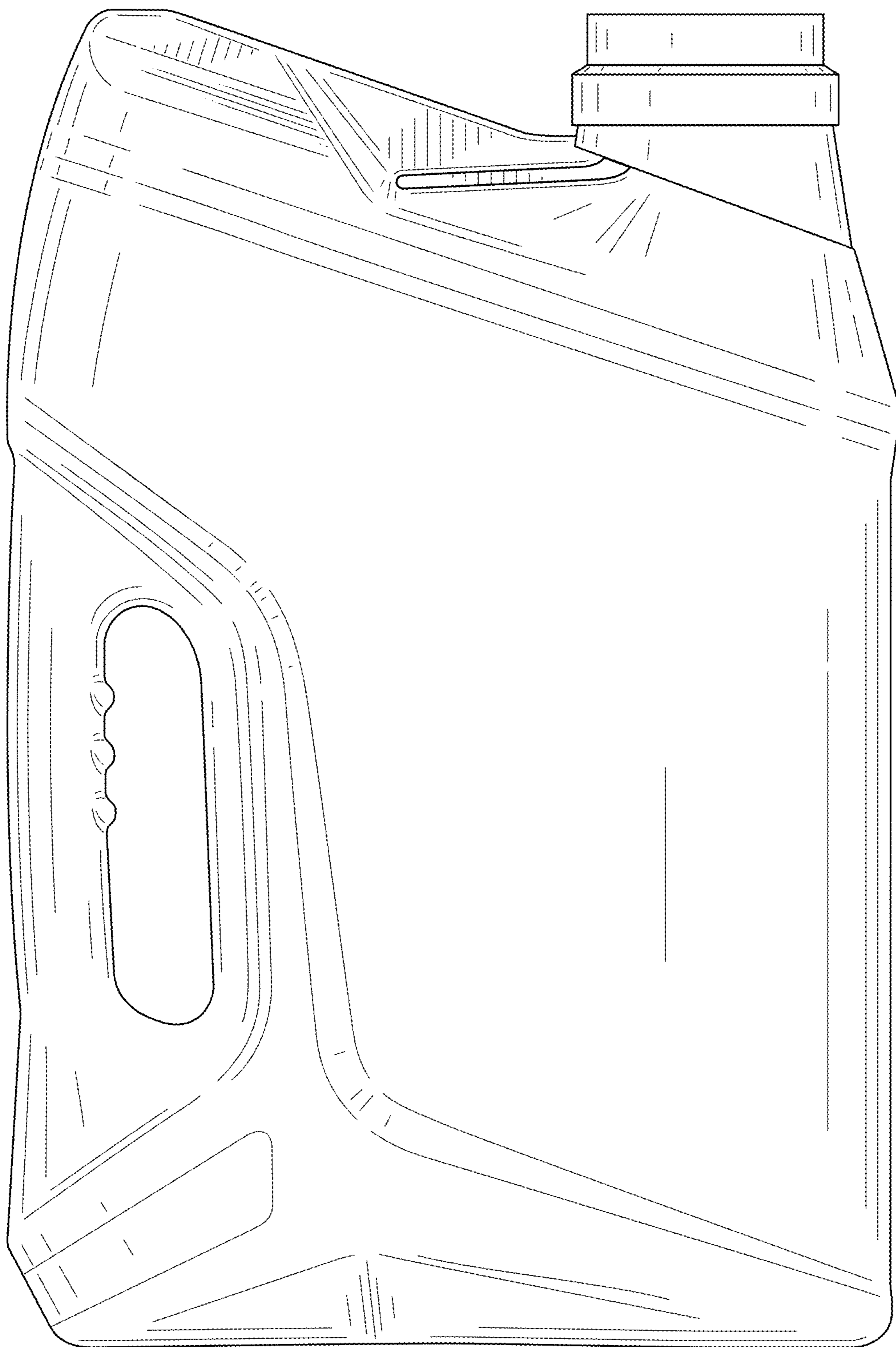

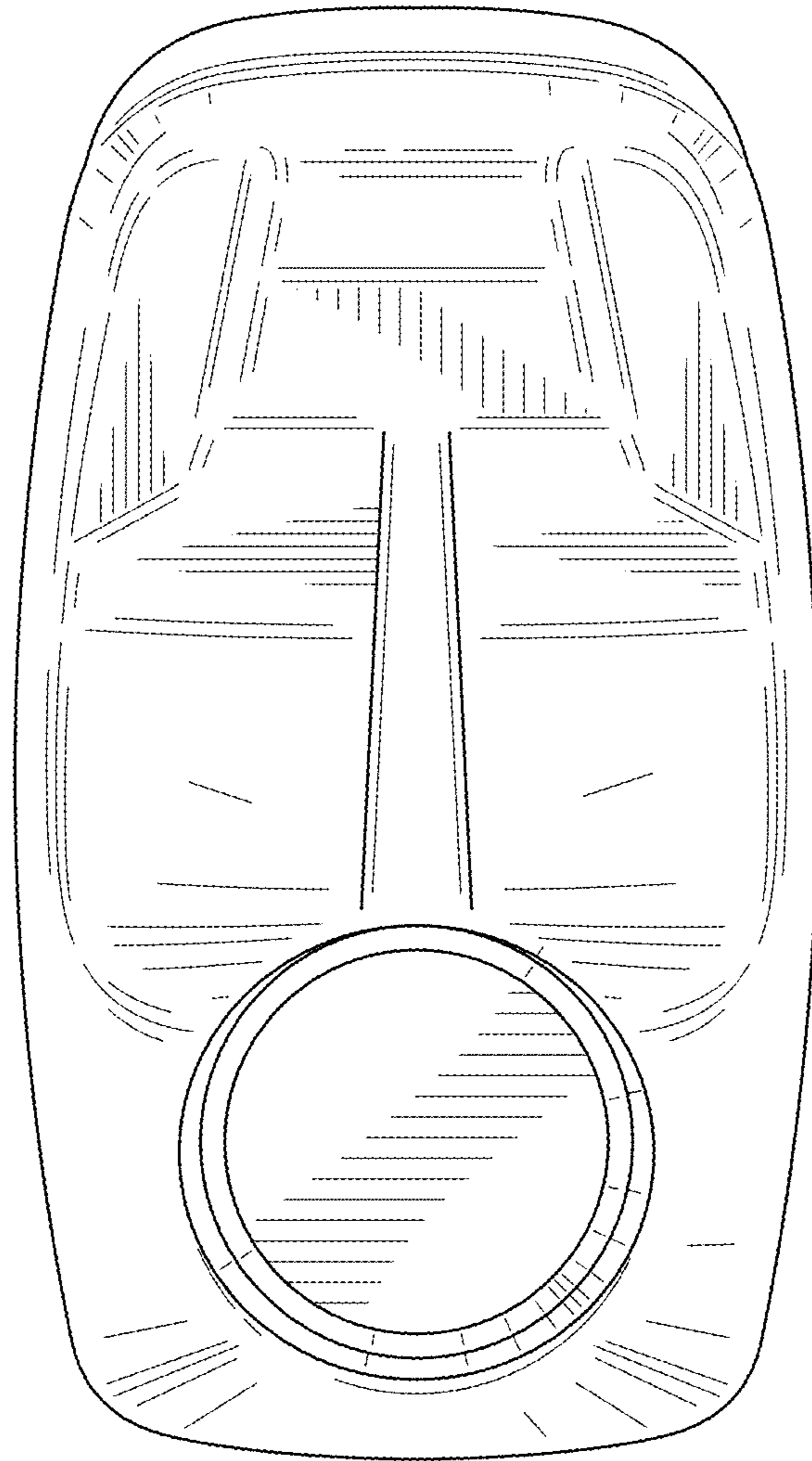

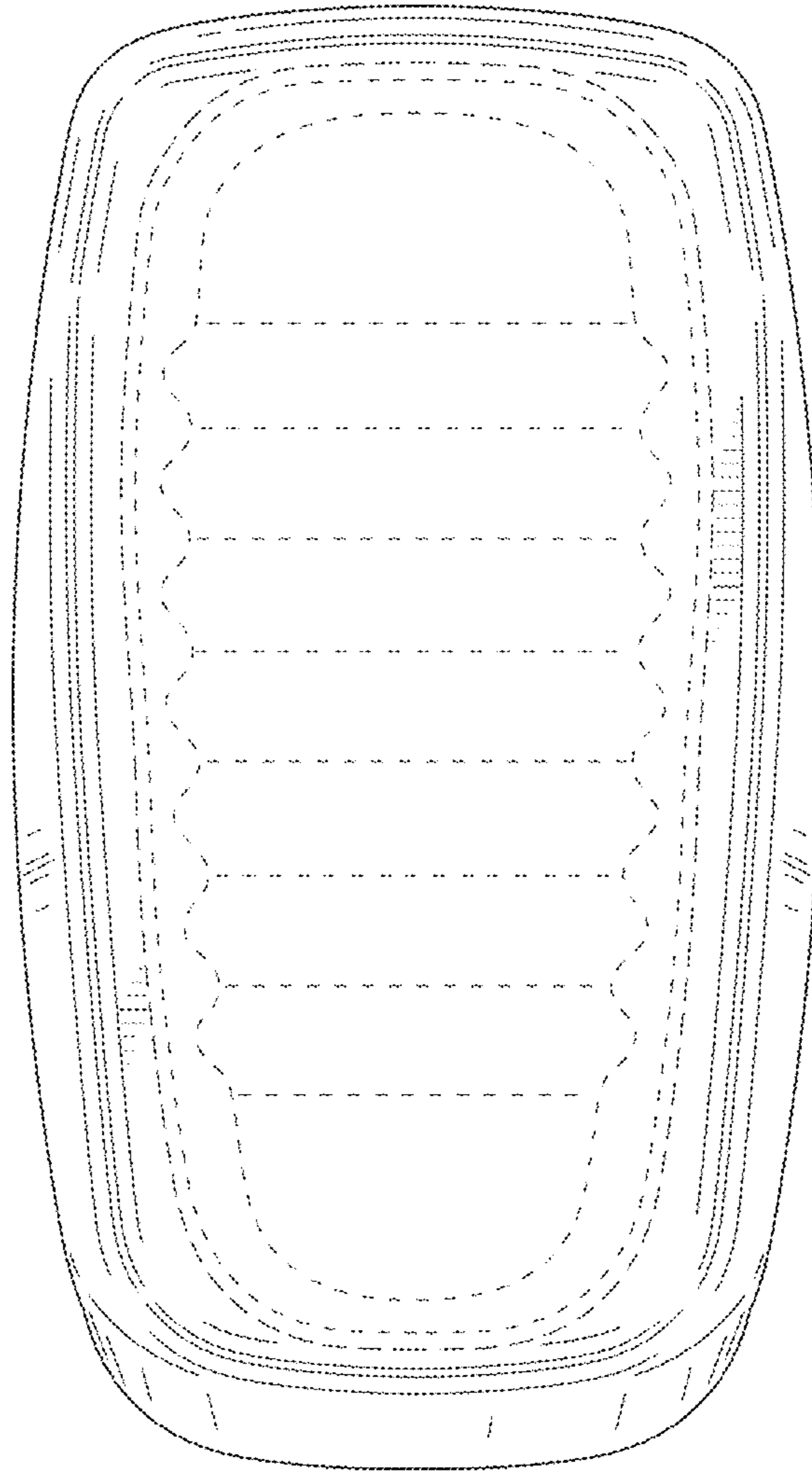
