FIG. 3 is a rear view of the band of FIG. 1.

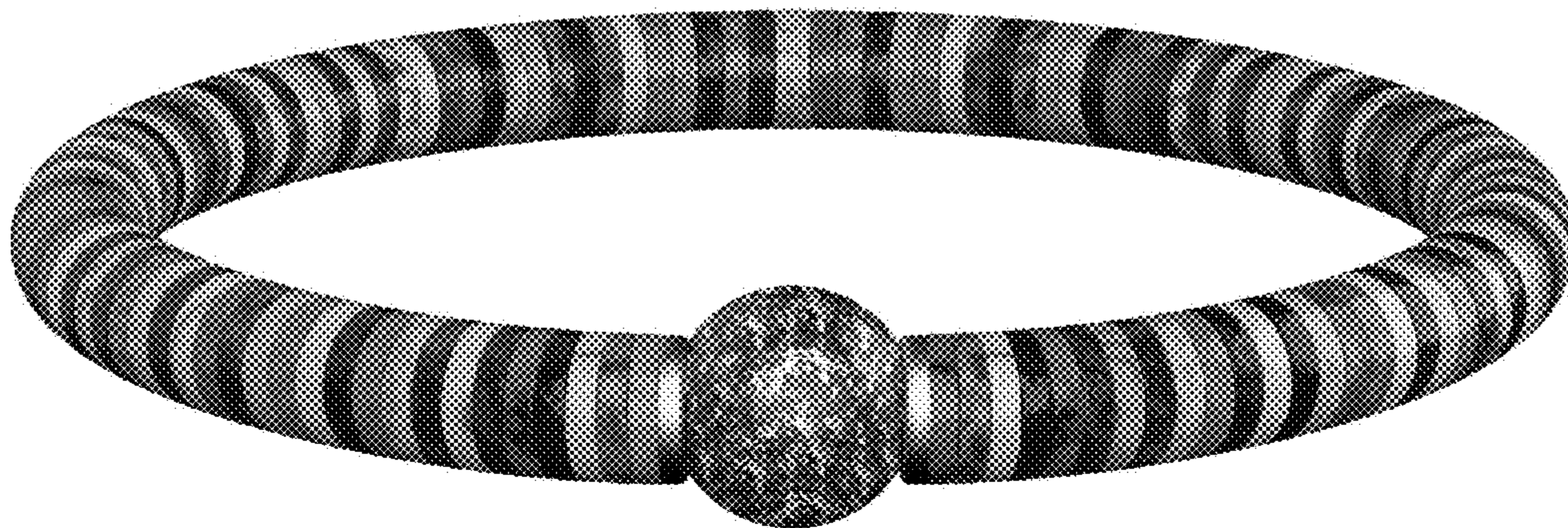
FIG. 4 is a top view of the band of FIG. 1.

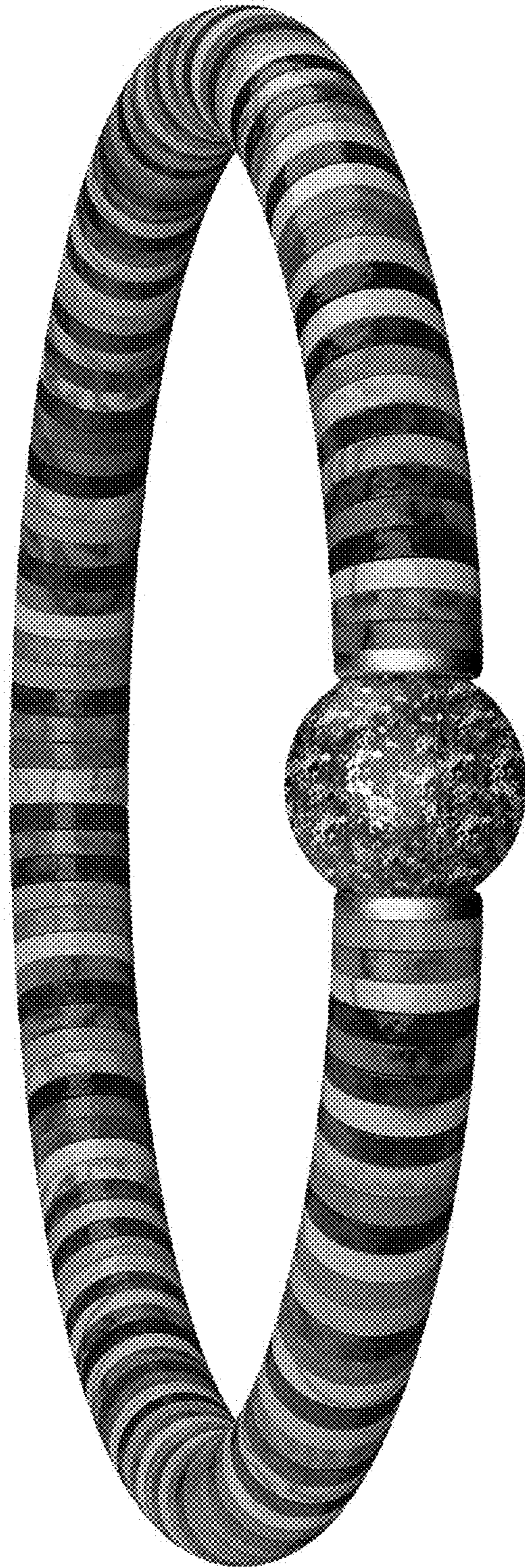

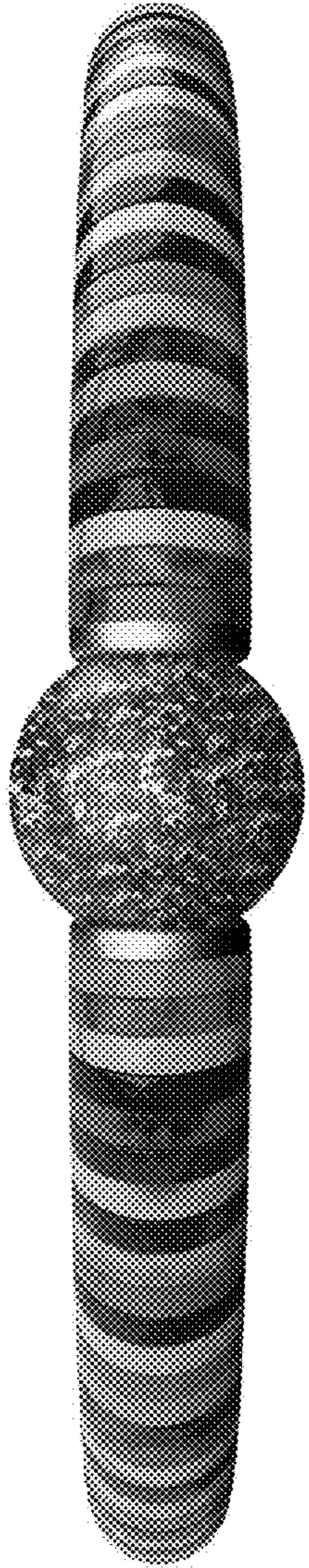

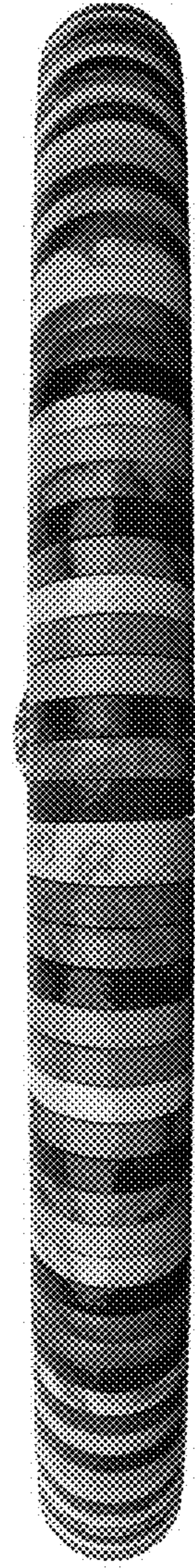
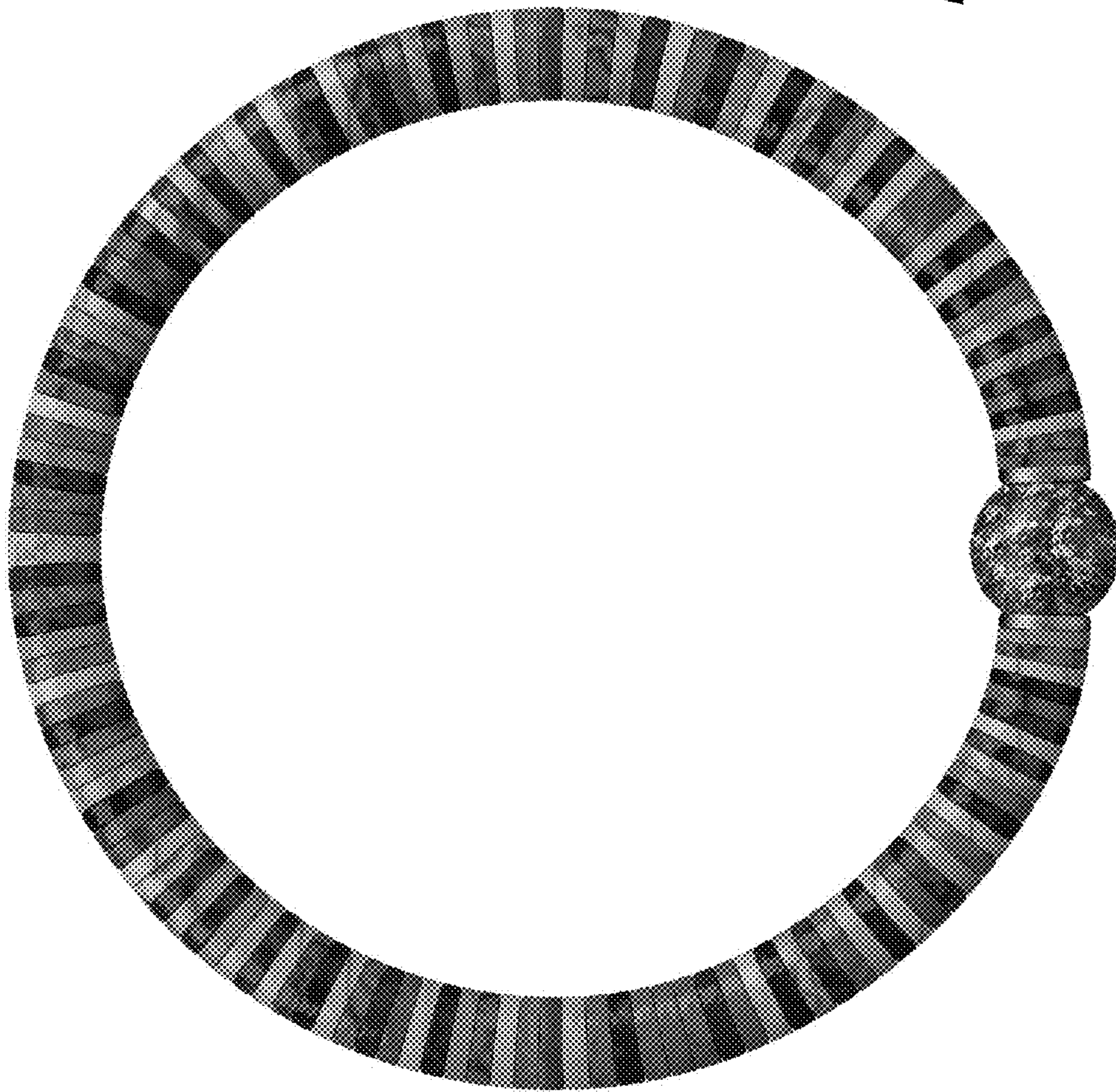

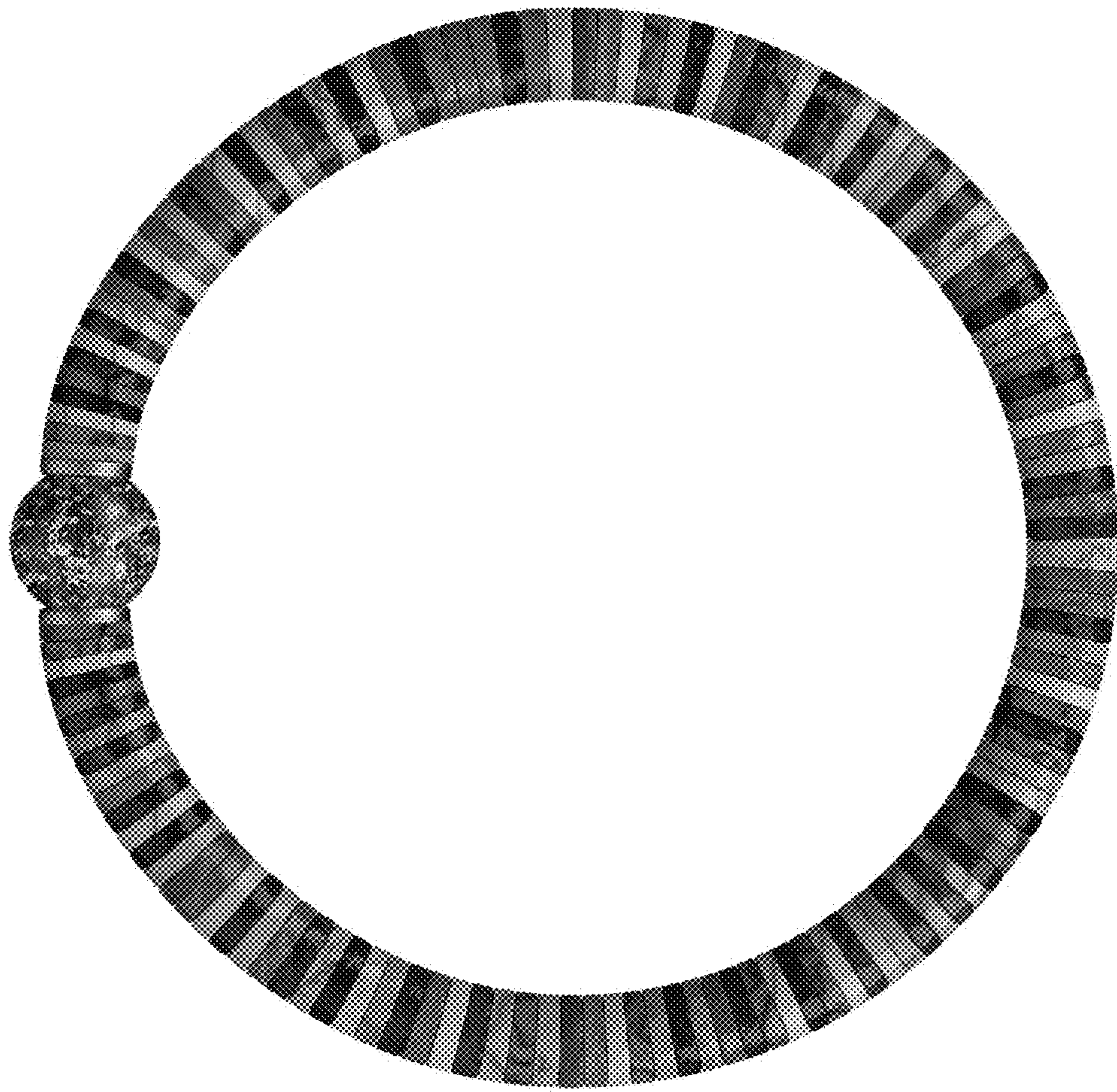

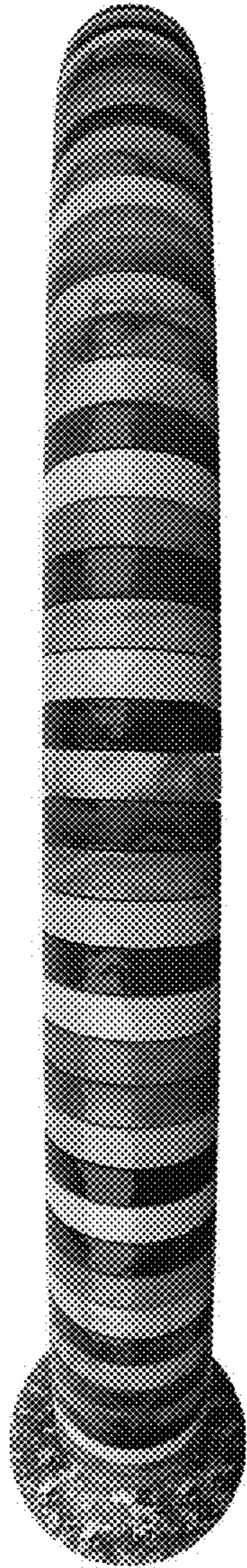

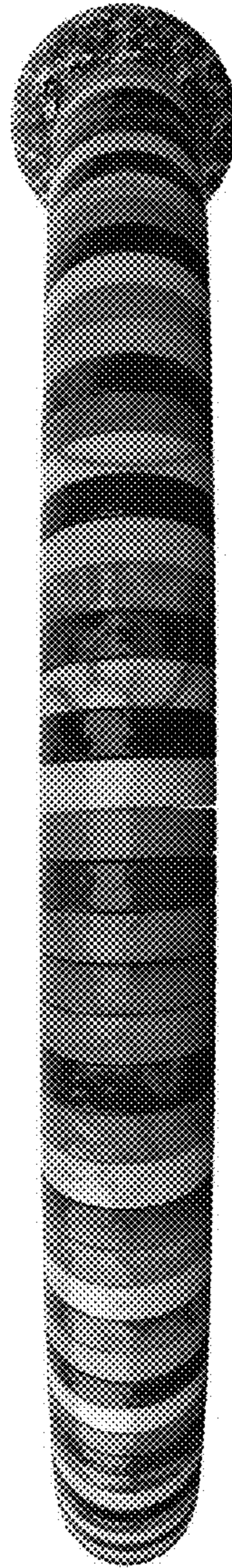
