The ornamental design for a door release, as shown and  
described.

**DESCRIPTION**

FIG. 1 is a front left perspective view of a door release  
according to the present invention.

FIG. 2 is a front right perspective view thereof.

FIG. 3 is a front view thereof.

FIG. 4 is a left side view thereof.

FIG. 5 is a right side view thereof.

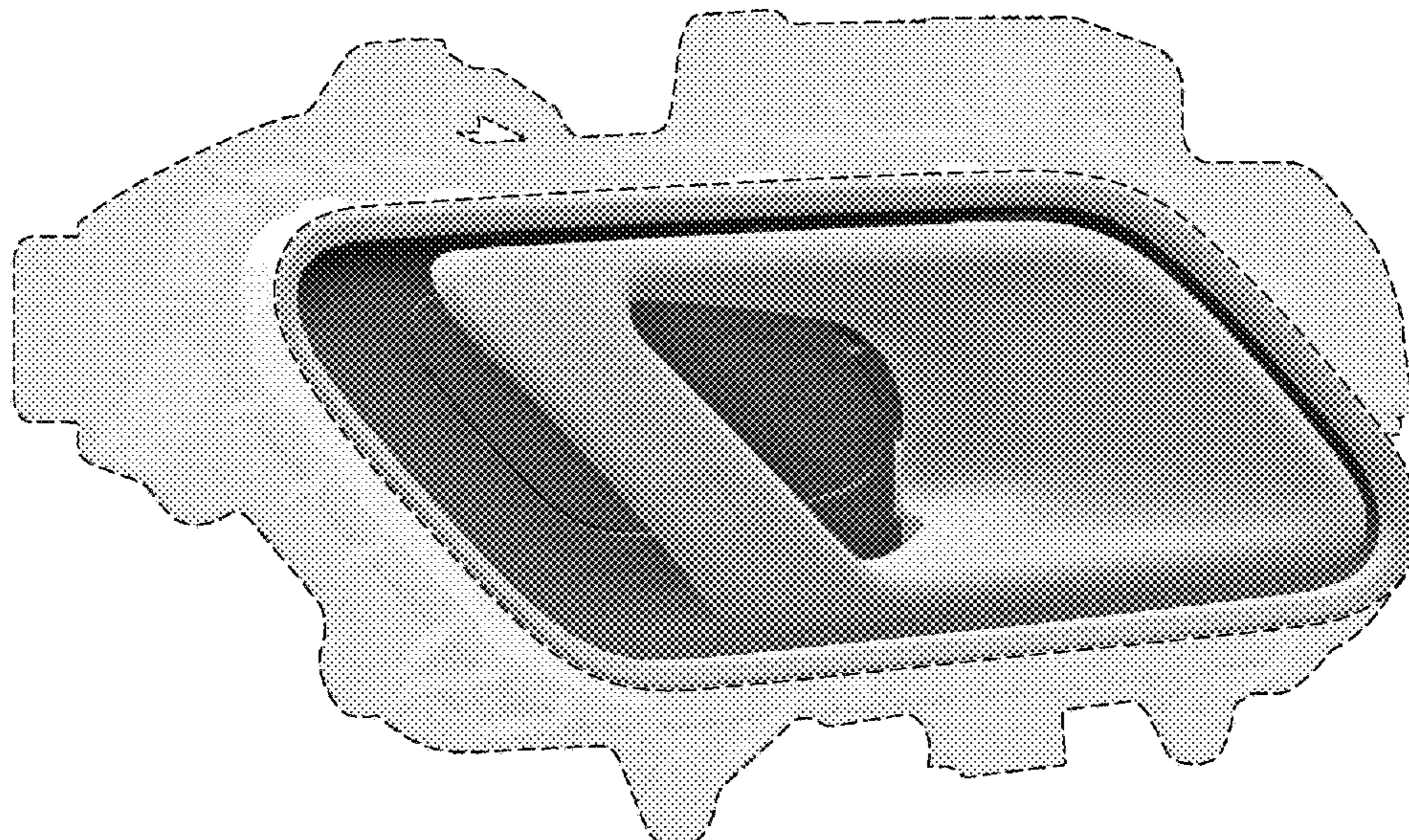
FIG. 6 is a top view thereof.

FIG. 7 is a bottom view thereof; and,

FIG. 8 is a left front perspective view of the door release  
illustrated in FIGS. 1-7, shown in a condition of use.

The broken lines and the surfaces between the broken lines  
in FIGS. 1-7 illustrate portions of the door release that form  
no part of the claimed design. The broken lines and the  
surfaces between the broken lines showing a car door in  
FIG. 8, illustrate environmental structure which forms no  
part of the claimed design.

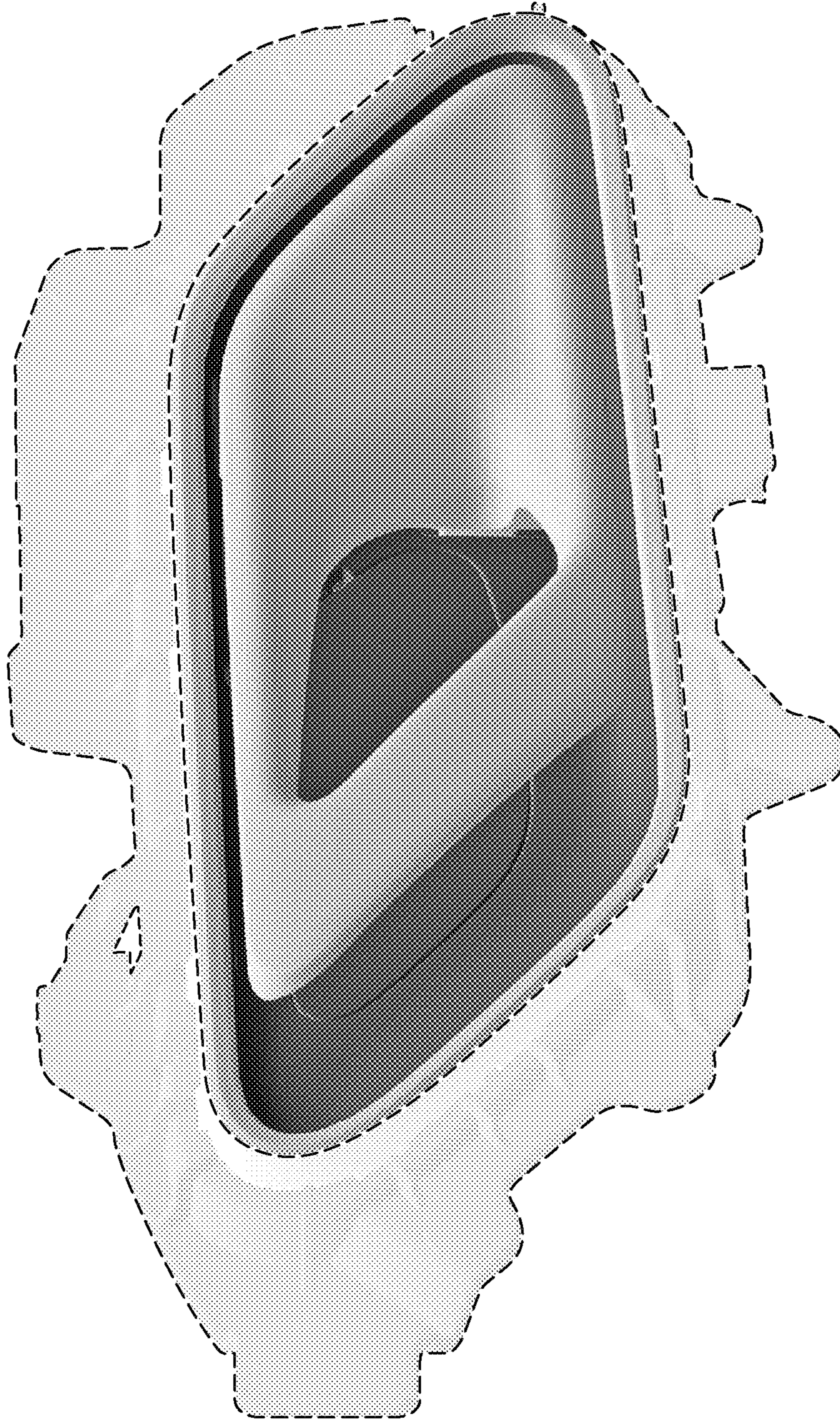

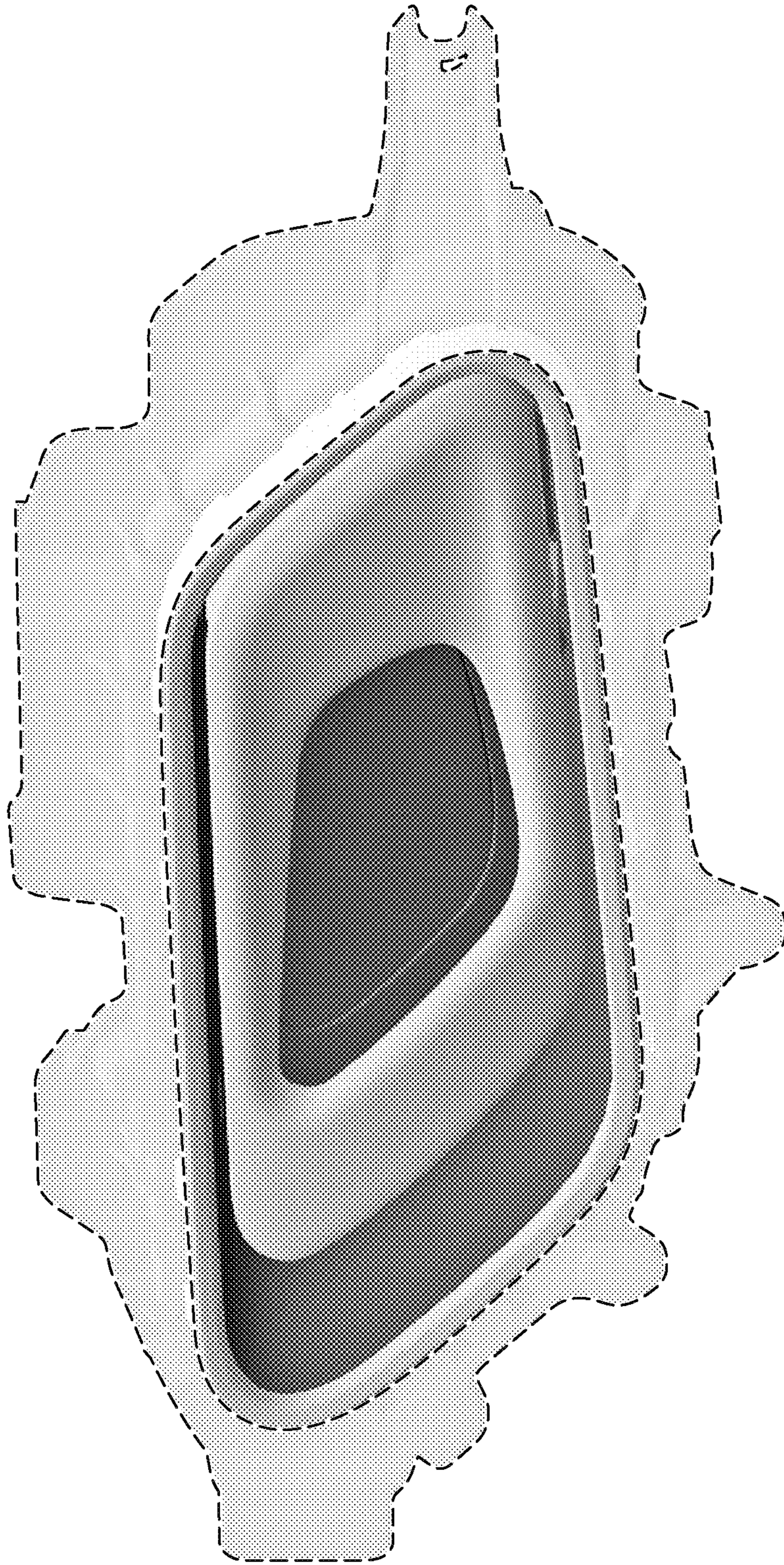

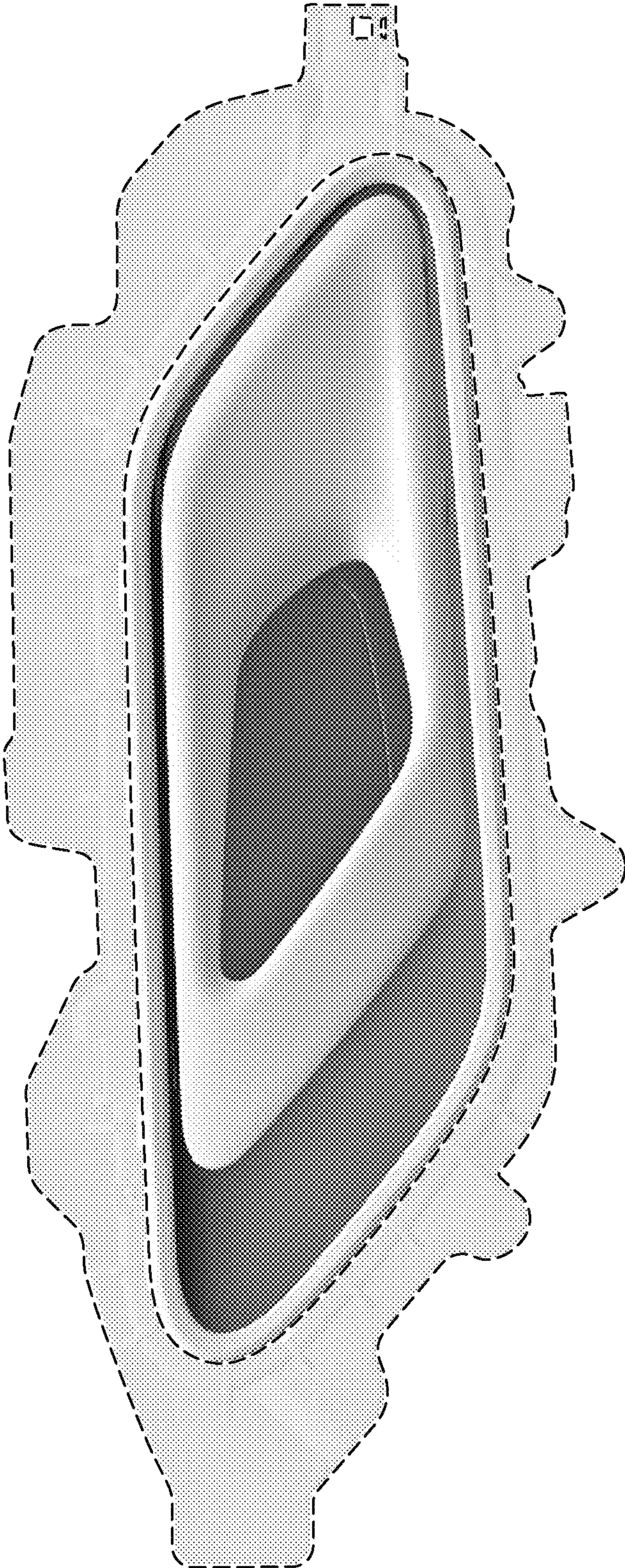

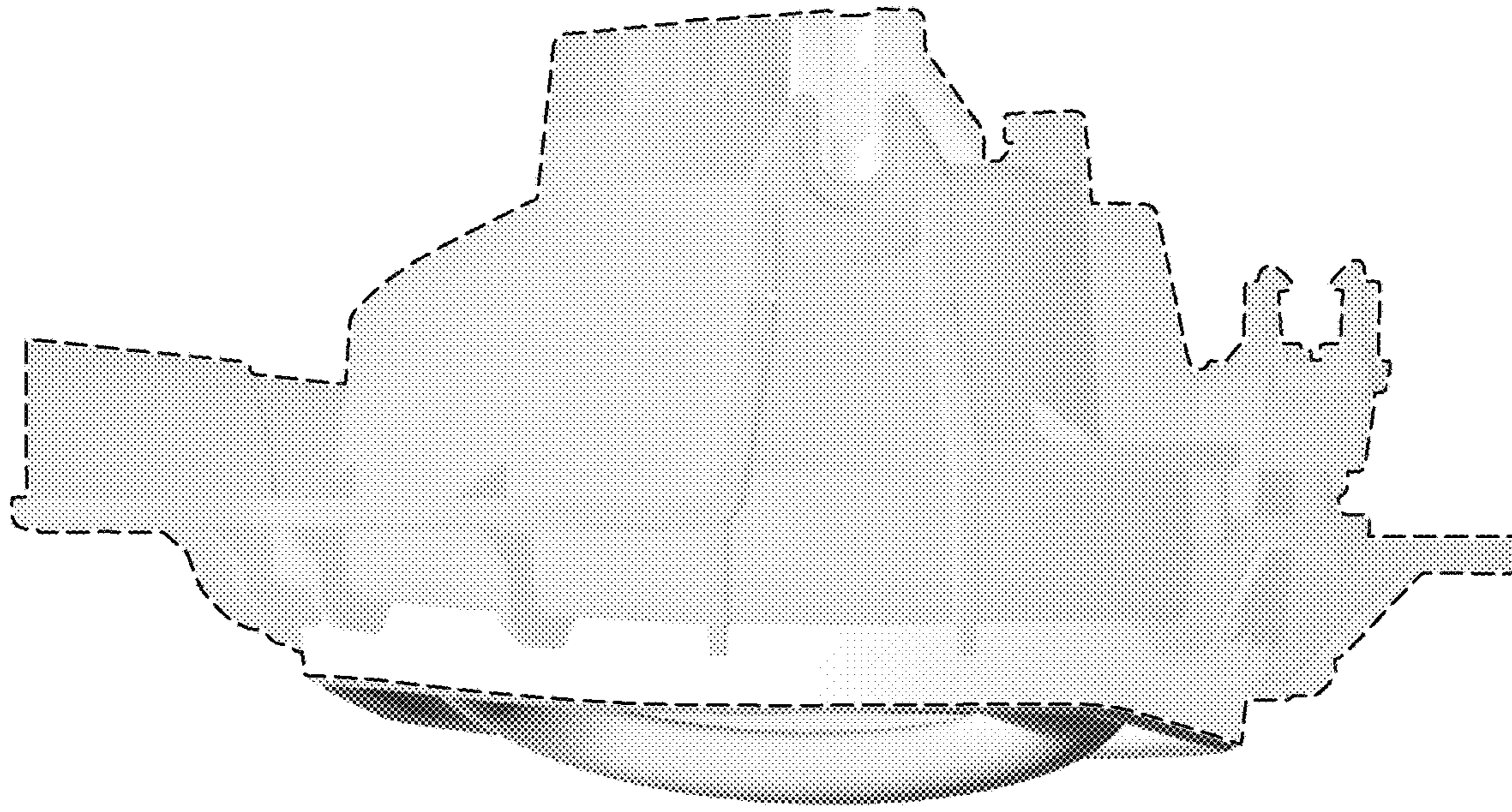

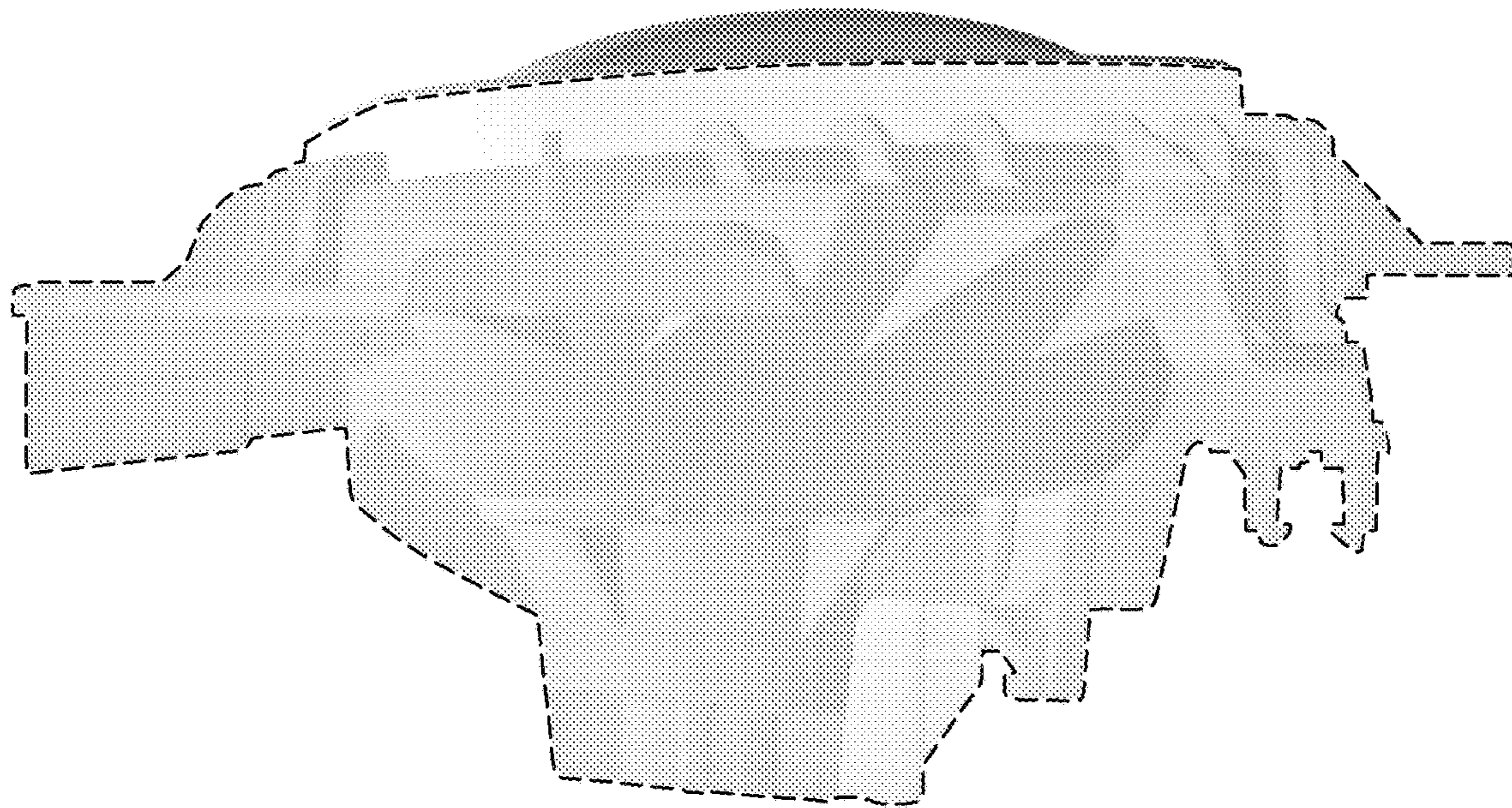

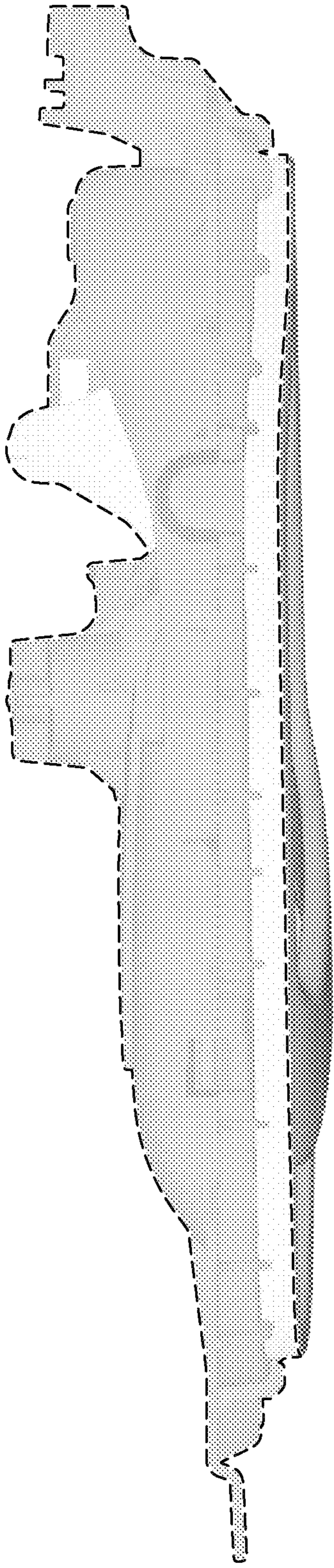

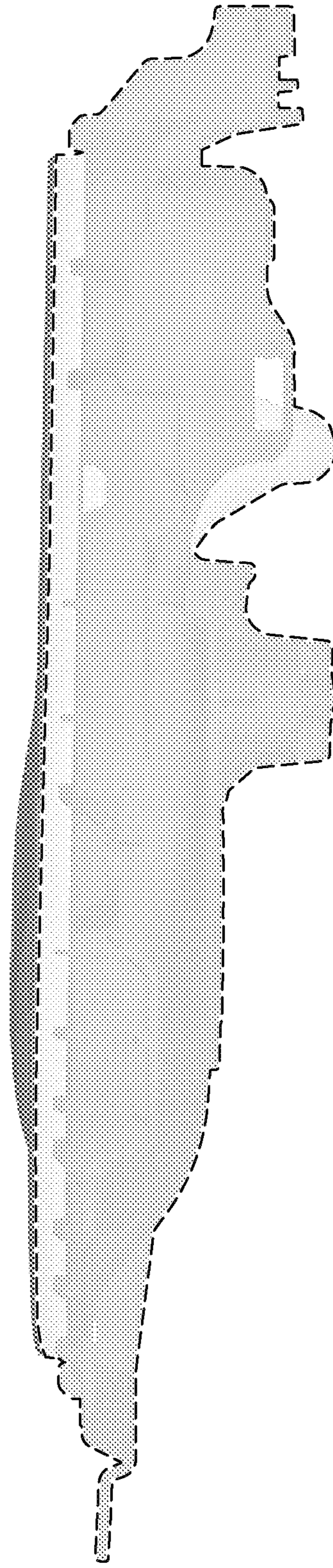

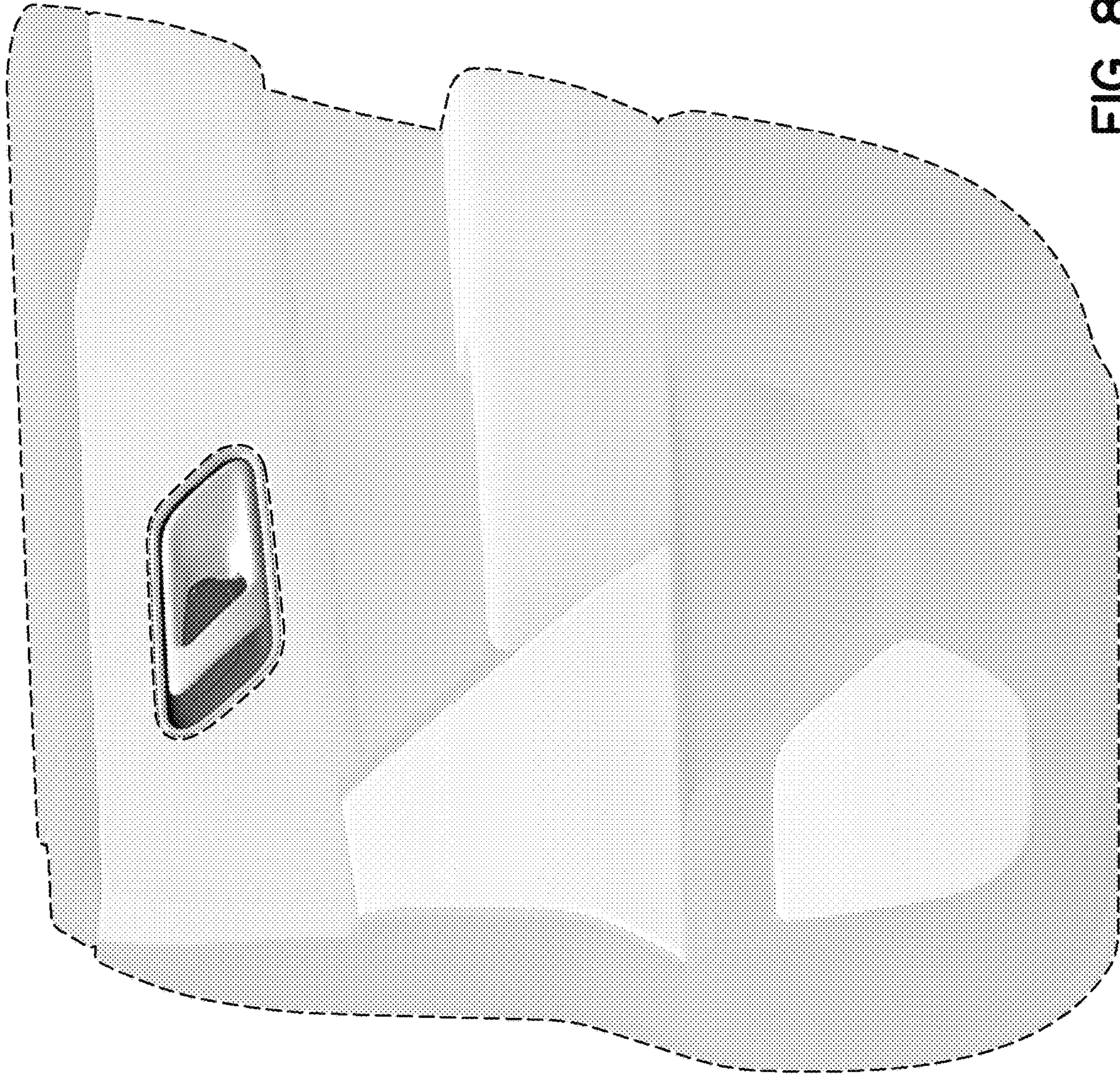
