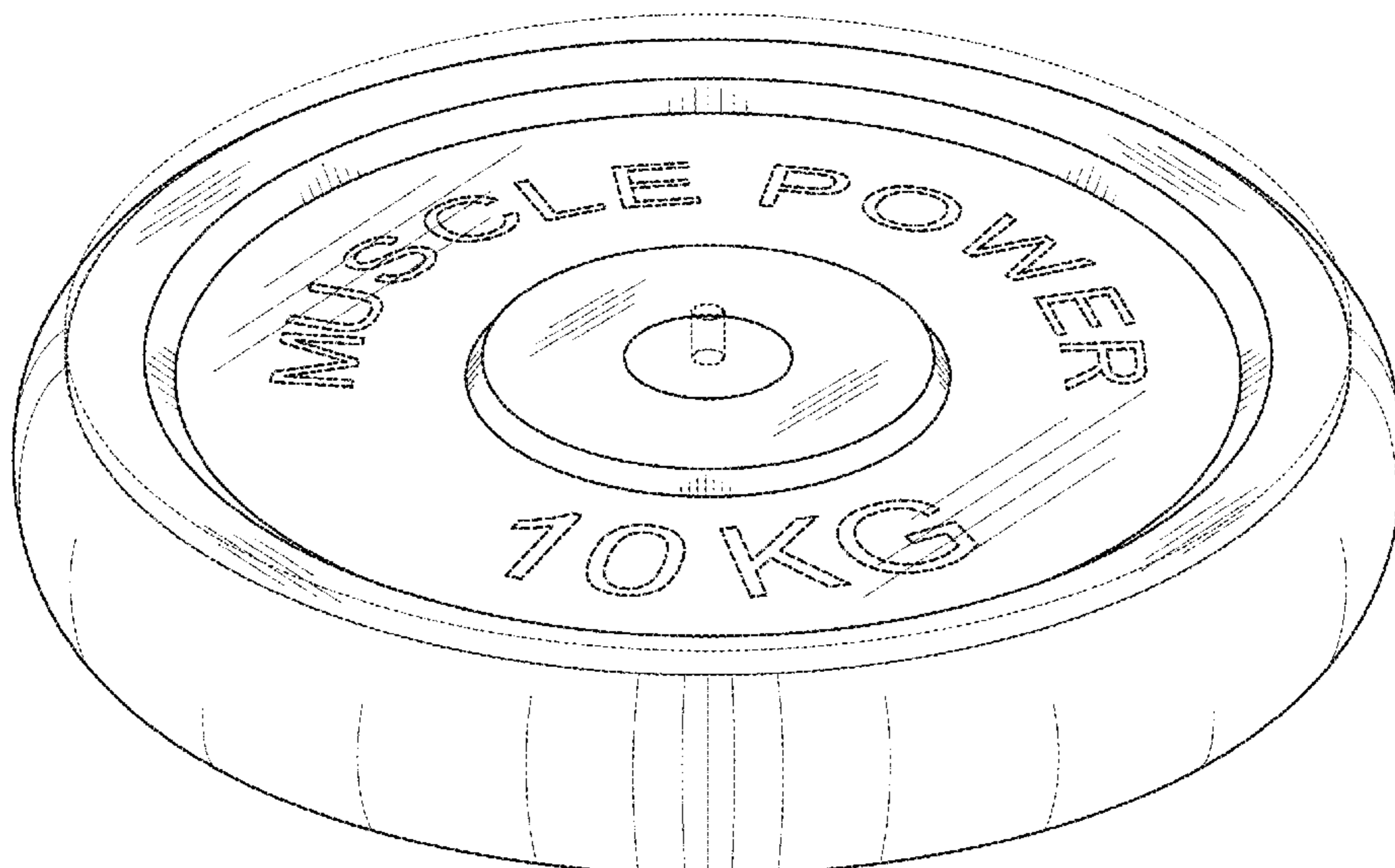
(57) **CLAIM**

The ornamental design for a turntable of a record player, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a turntable of a record player in accordance with the present design;
 FIG. 2 is a top view of the turntable of a record player of FIG. 1;
 FIG. 3 is a bottom view of the turntable of a record player of FIG. 1;
 FIG. 4 is a left side view of the turntable of a record player of FIG. 1;
 FIG. 5 is a right side view of the turntable of a record player of FIG. 1;
 FIG. 6 is a front view of the turntable of a record player of FIG. 1; and,
 FIG. 7 is a rear view of the turntable of a record player of FIG. 1.
 In FIGS. 1-7, the right, left, front and rear views are mirror images of one another.
 In FIGS. 1-7, the features of the turntable of a record player shown in phantom lines are for illustrative purposes only and do not constitute a part of the claimed design.

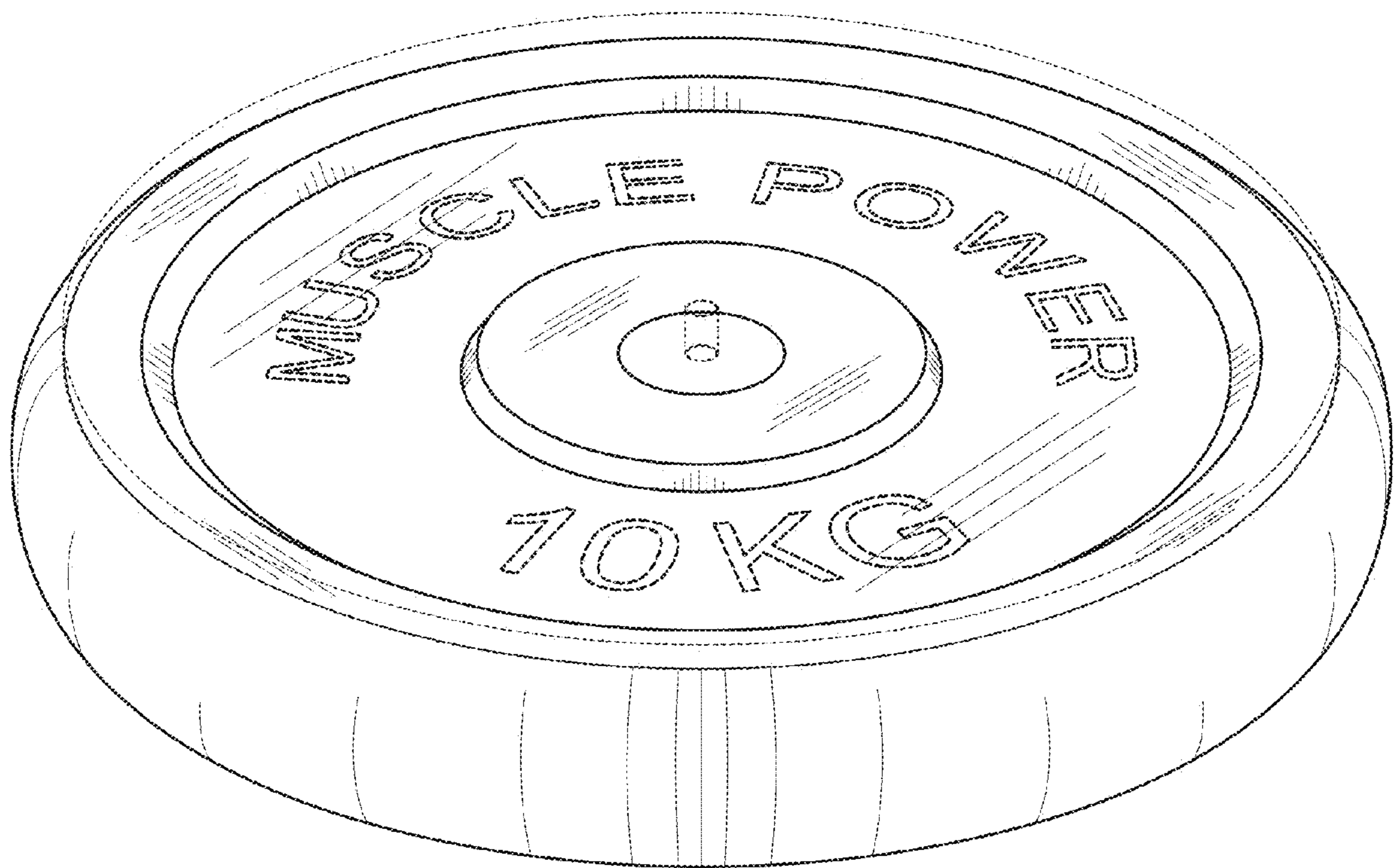

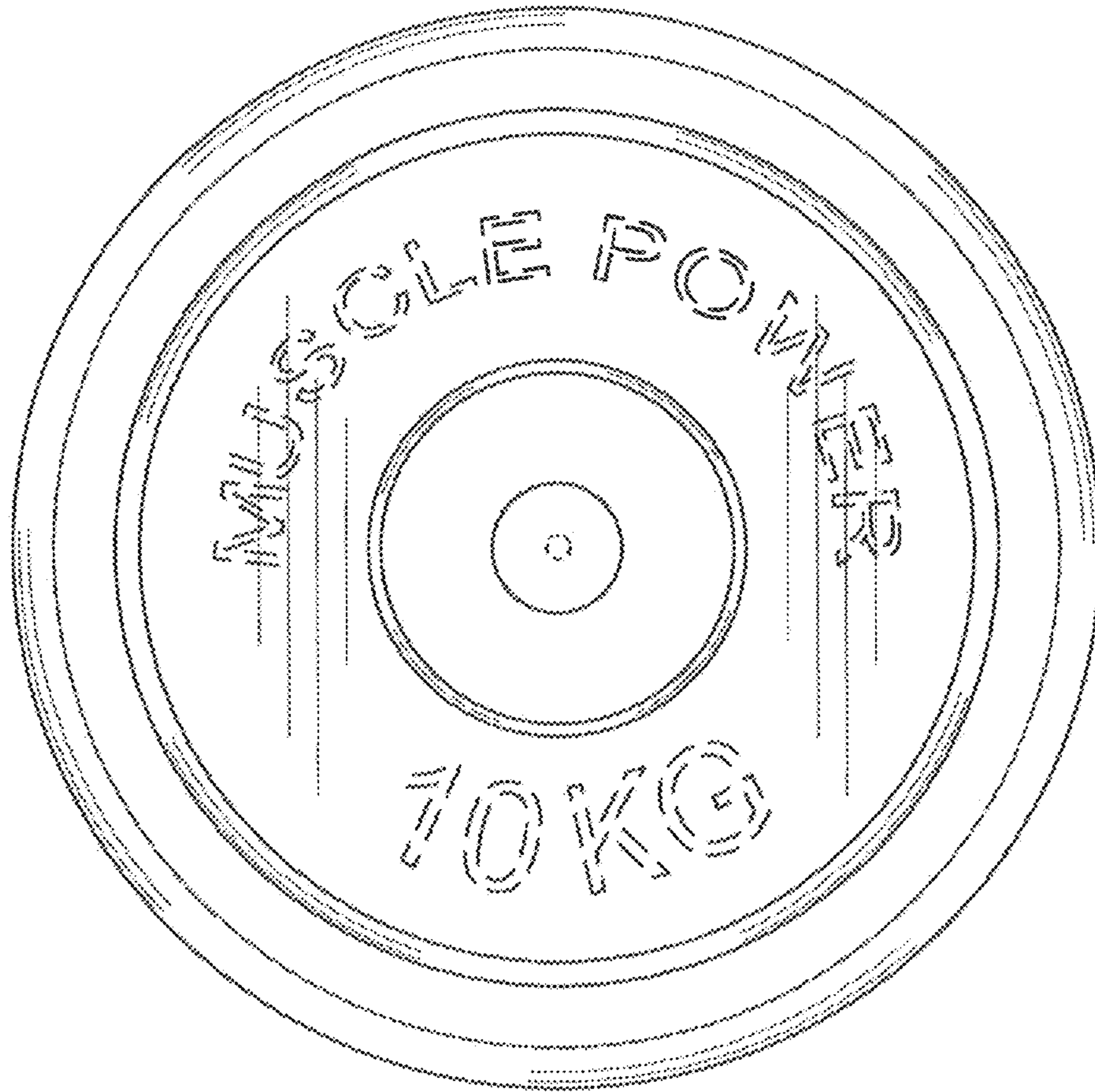

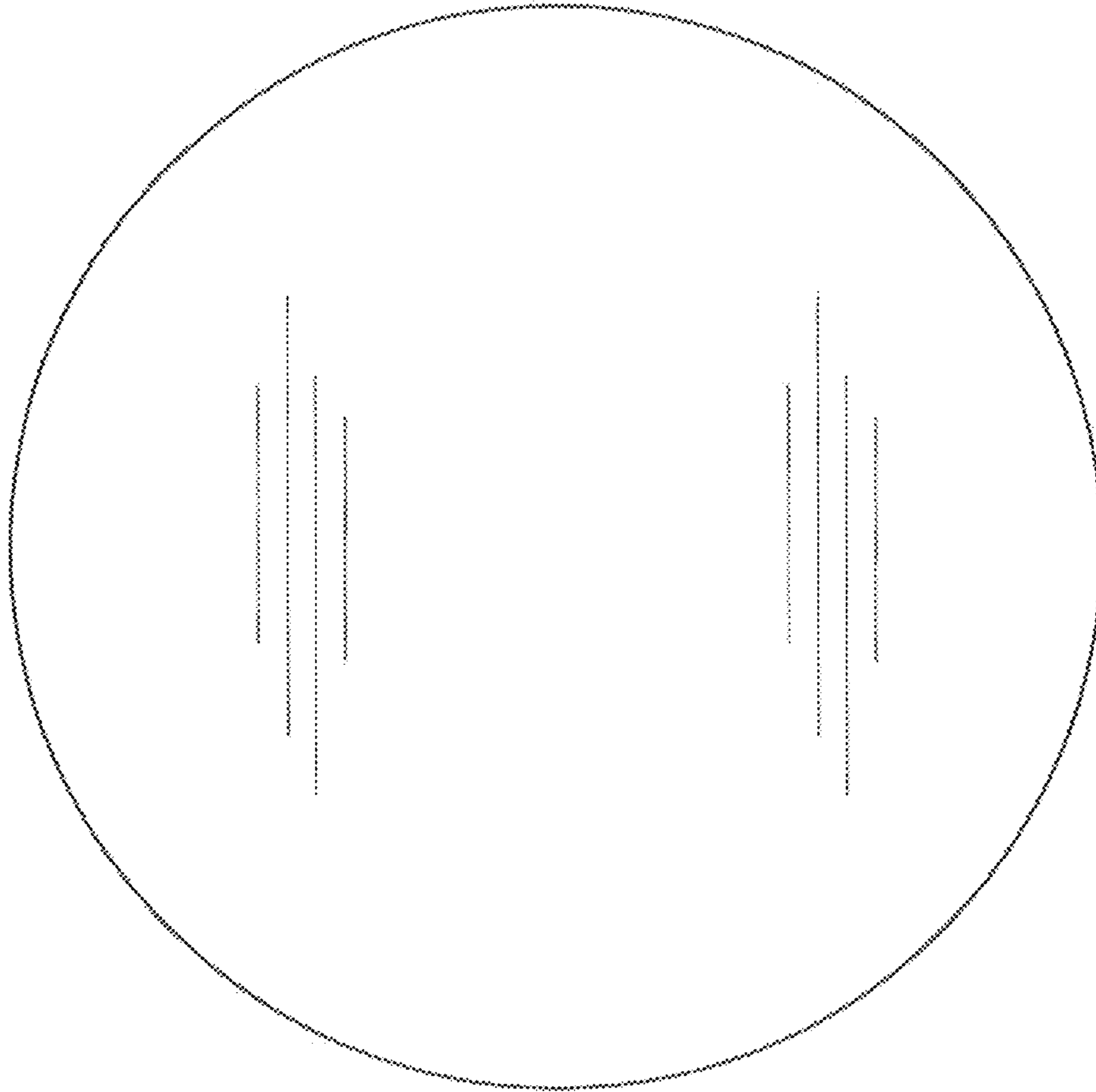

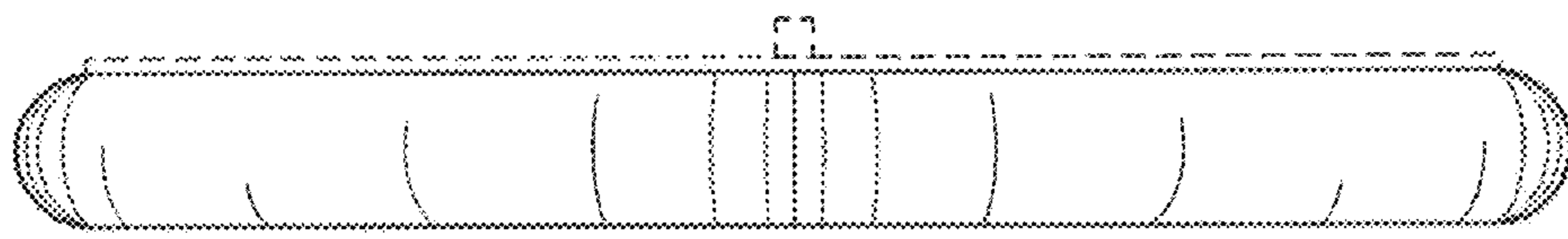

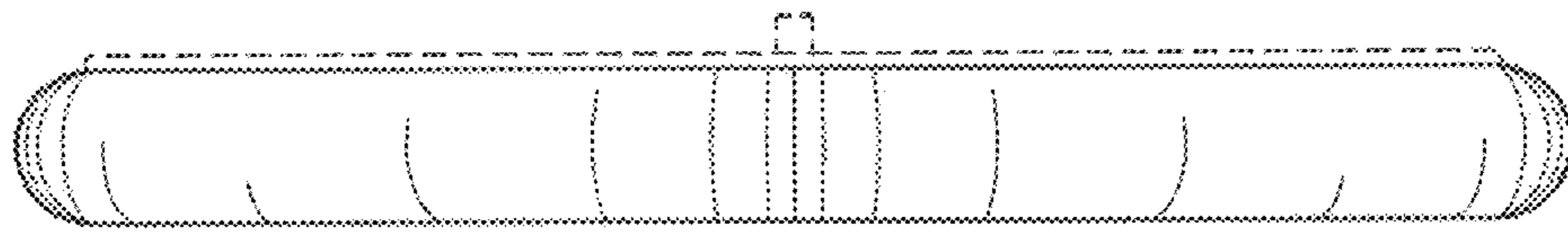

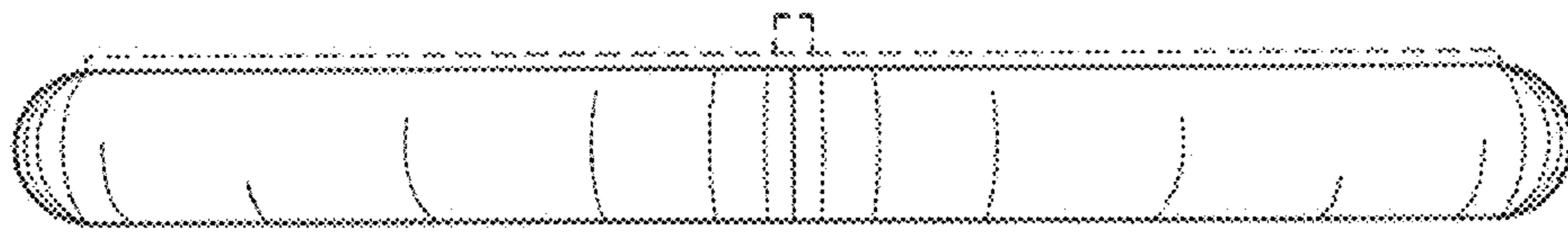

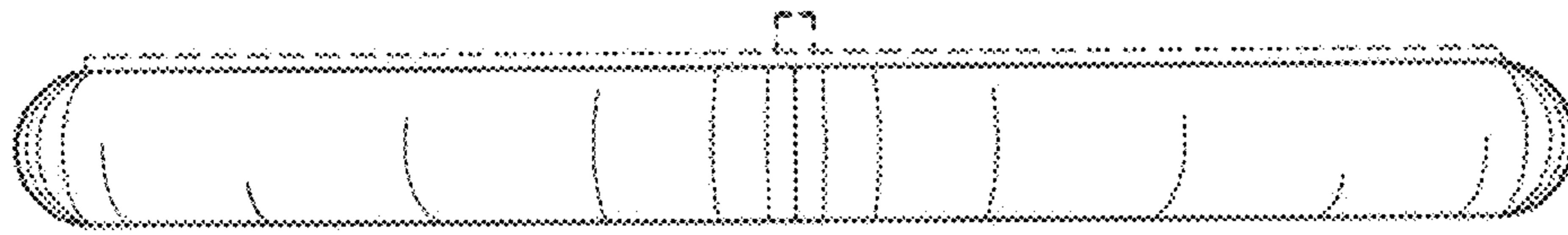
