(57) **CLAIM**

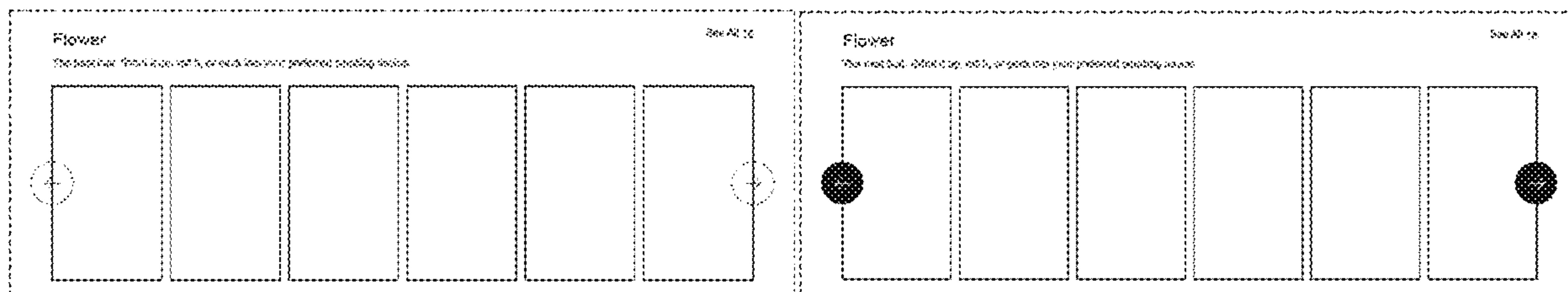
The ornamental design for a portion of a display screen with a transitional carousel graphical user interface for display of cannabis flower items, as shown and described.

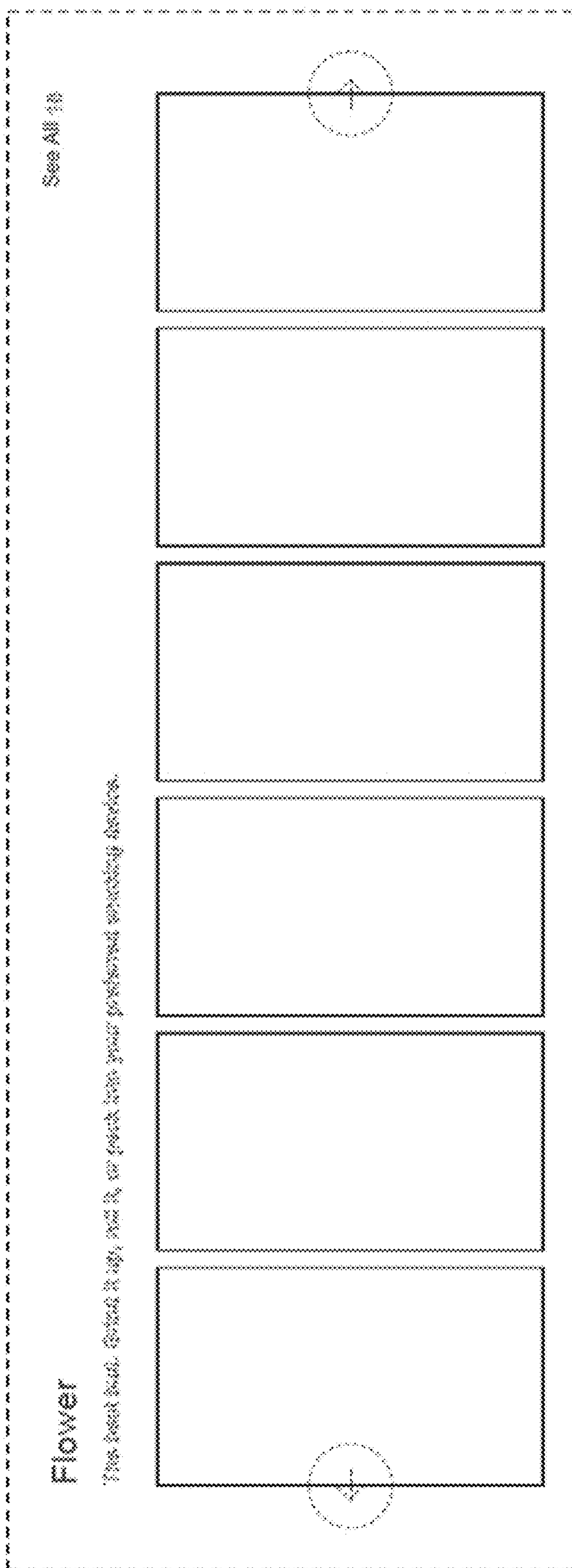

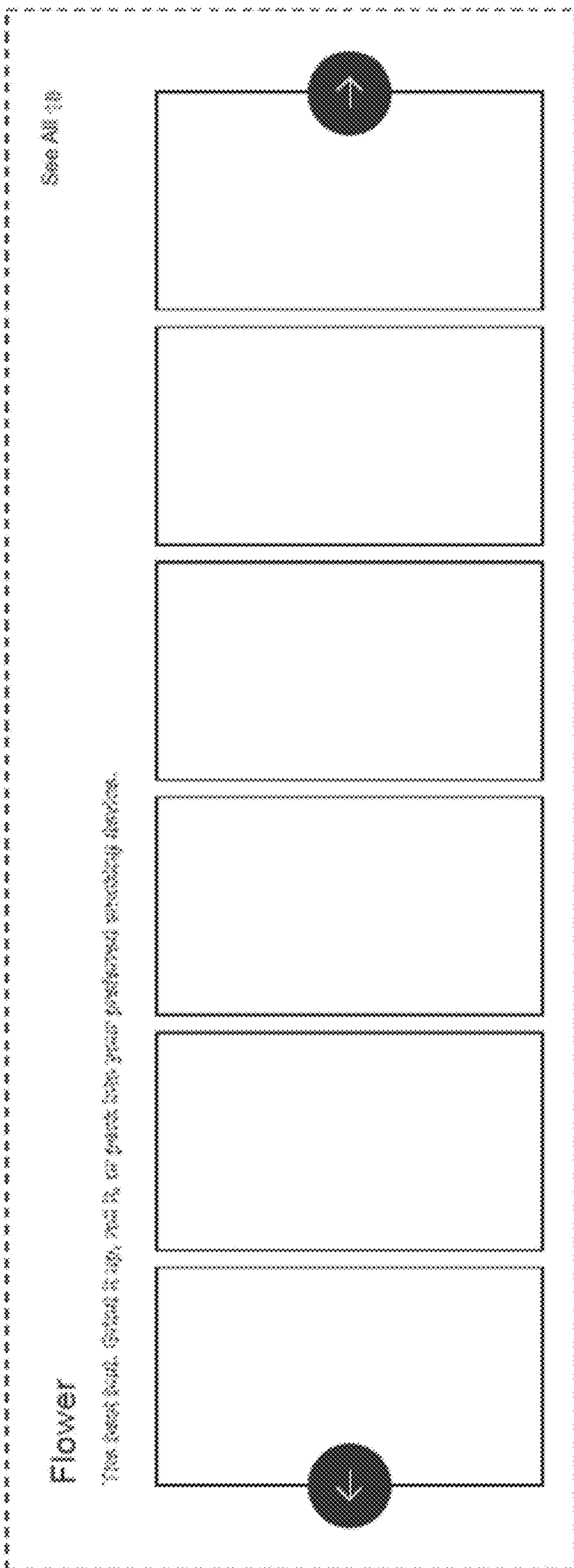
