(57) **CLAIM**

The ornamental design for a flexible feed sock, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a blank from which the flexible feed sock is formed;
FIG. 2 is a front perspective view of the blank formed into the flexible feed sock;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a front elevation view thereof;
FIG. 6 is a left side elevation view thereof;
FIG. 7 is a rear elevation view thereof; and,
FIG. 8 is a right side elevation view.

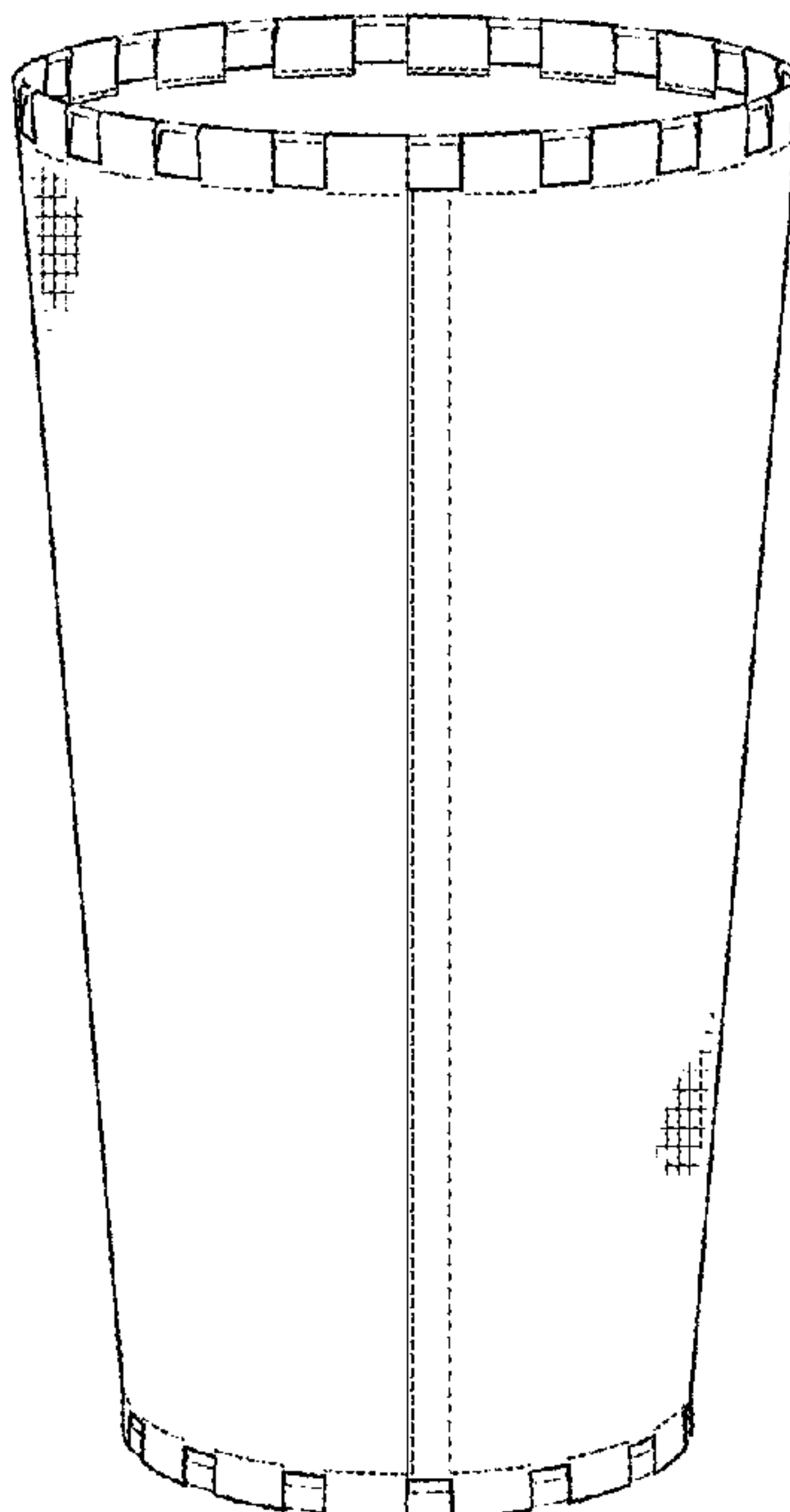
The broken line showing of the flexible feed sock is included for the purpose of illustrating support hoops and forms no part of the claimed design.

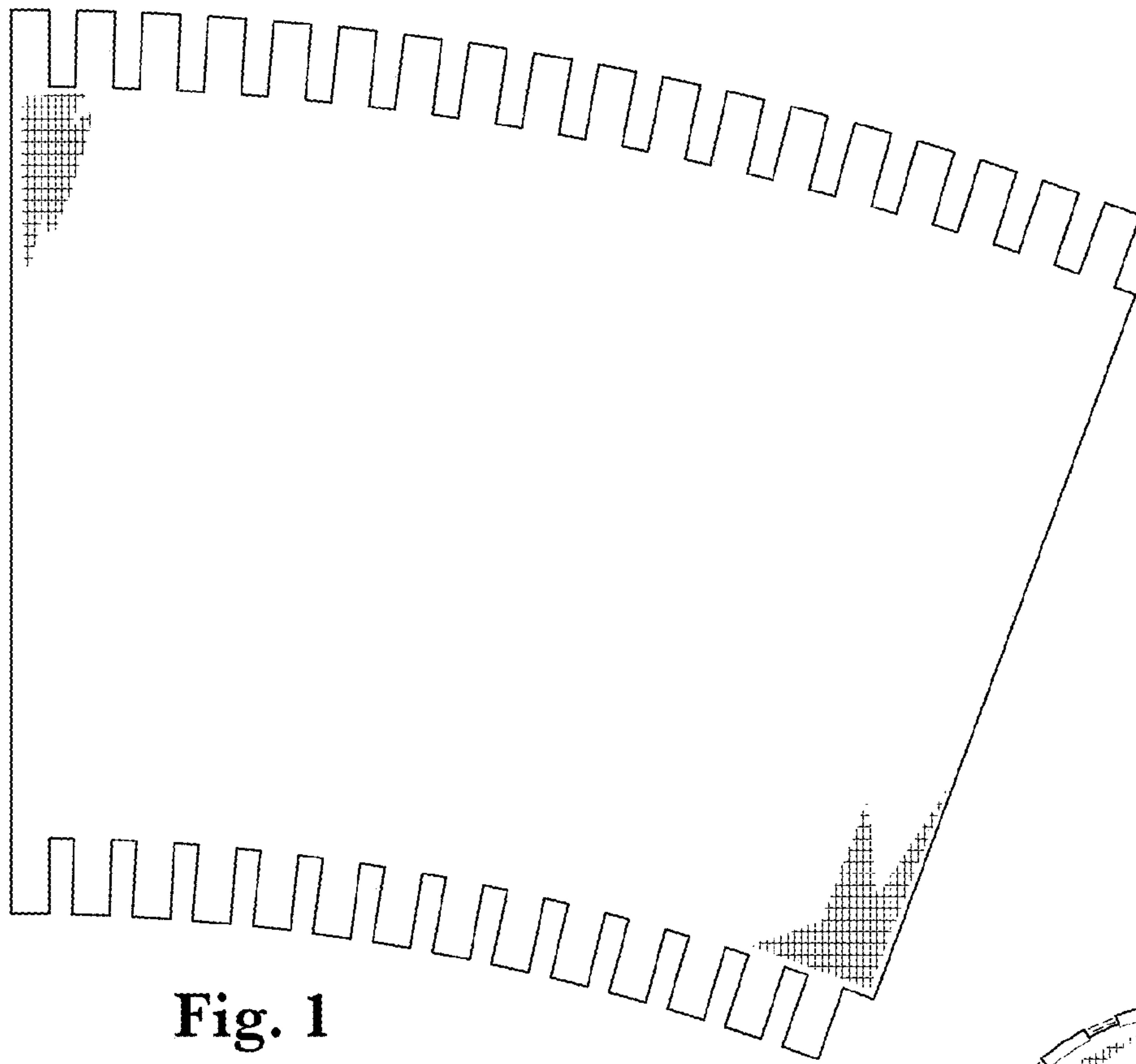

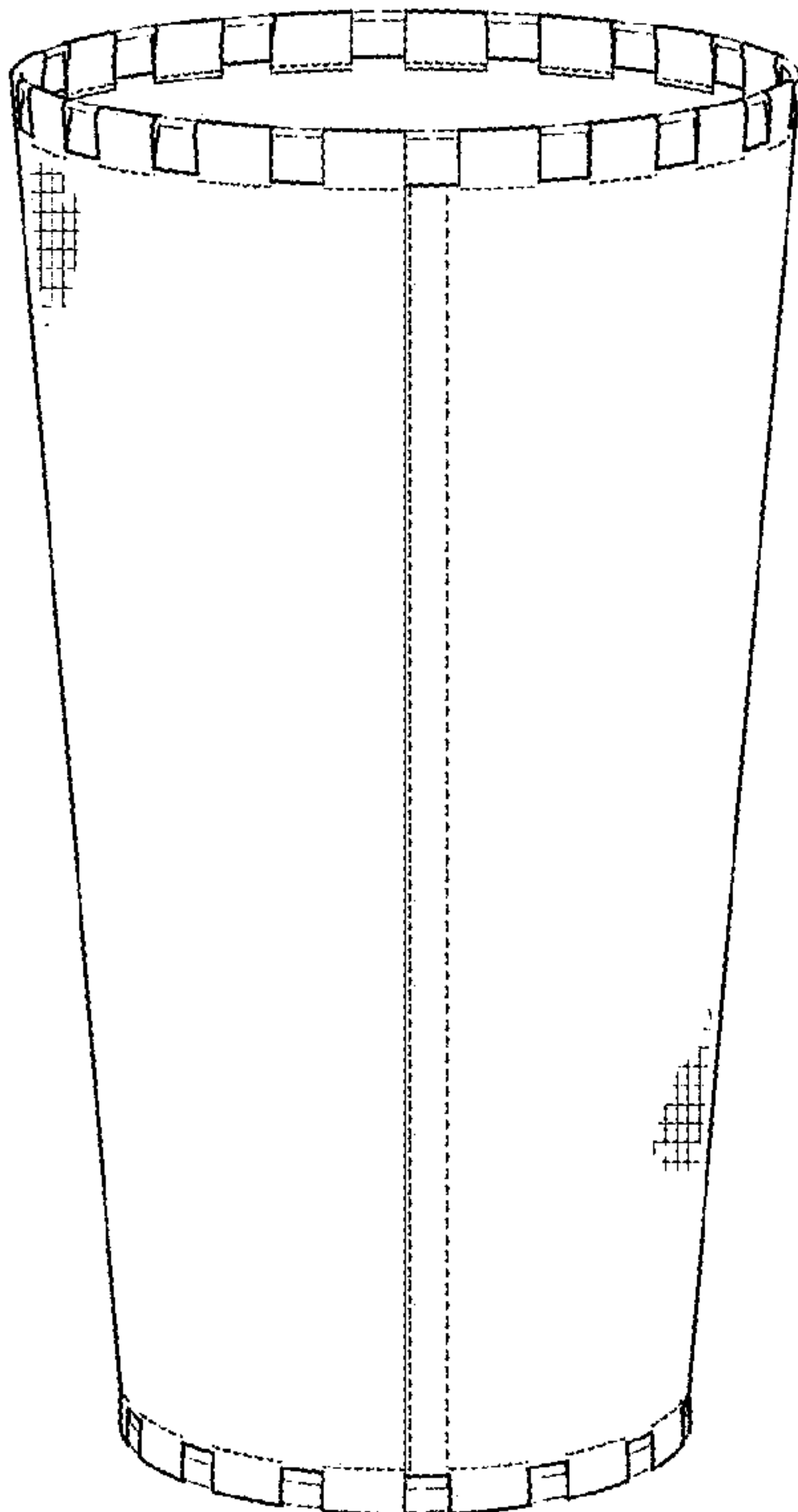

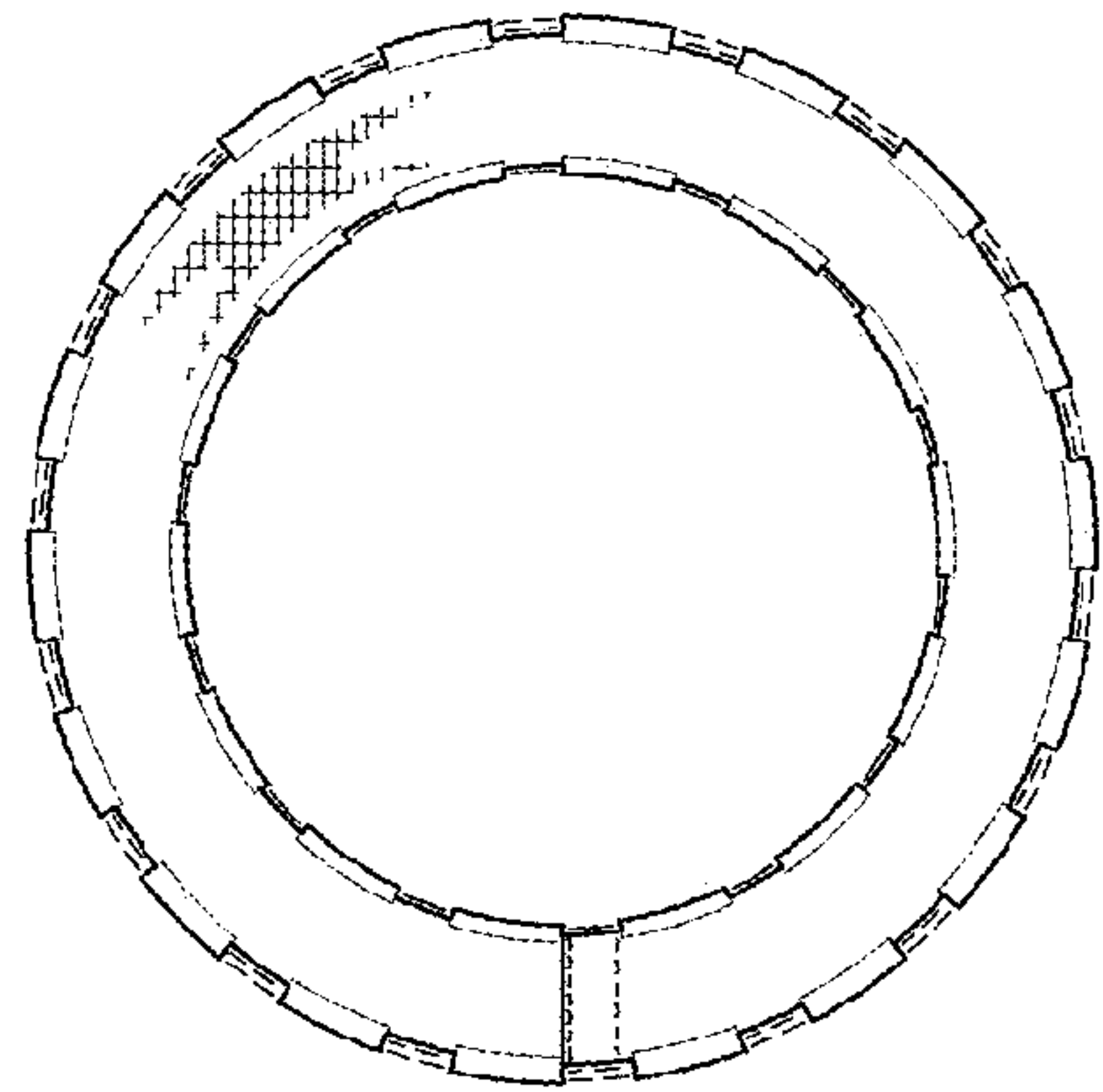

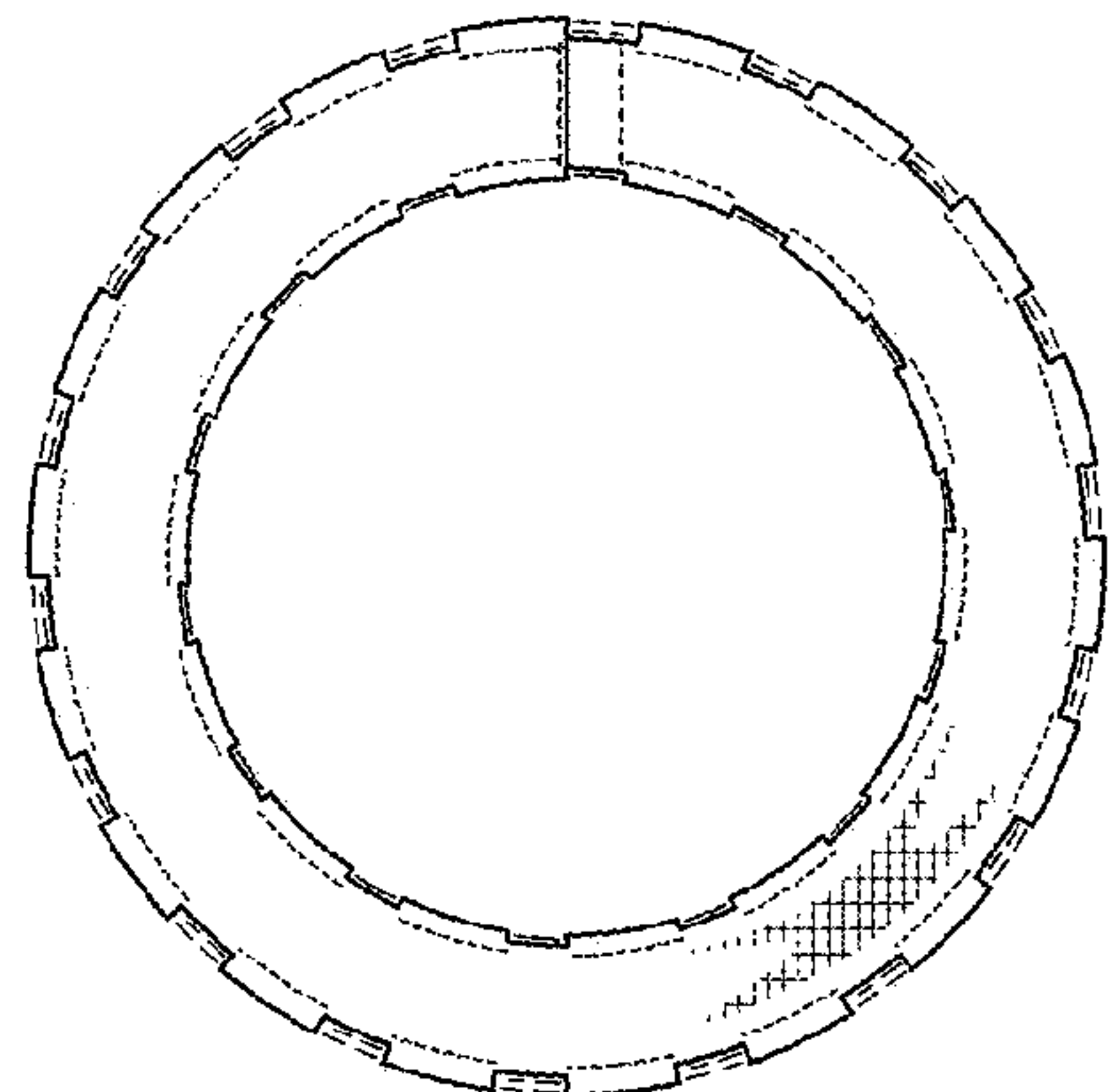

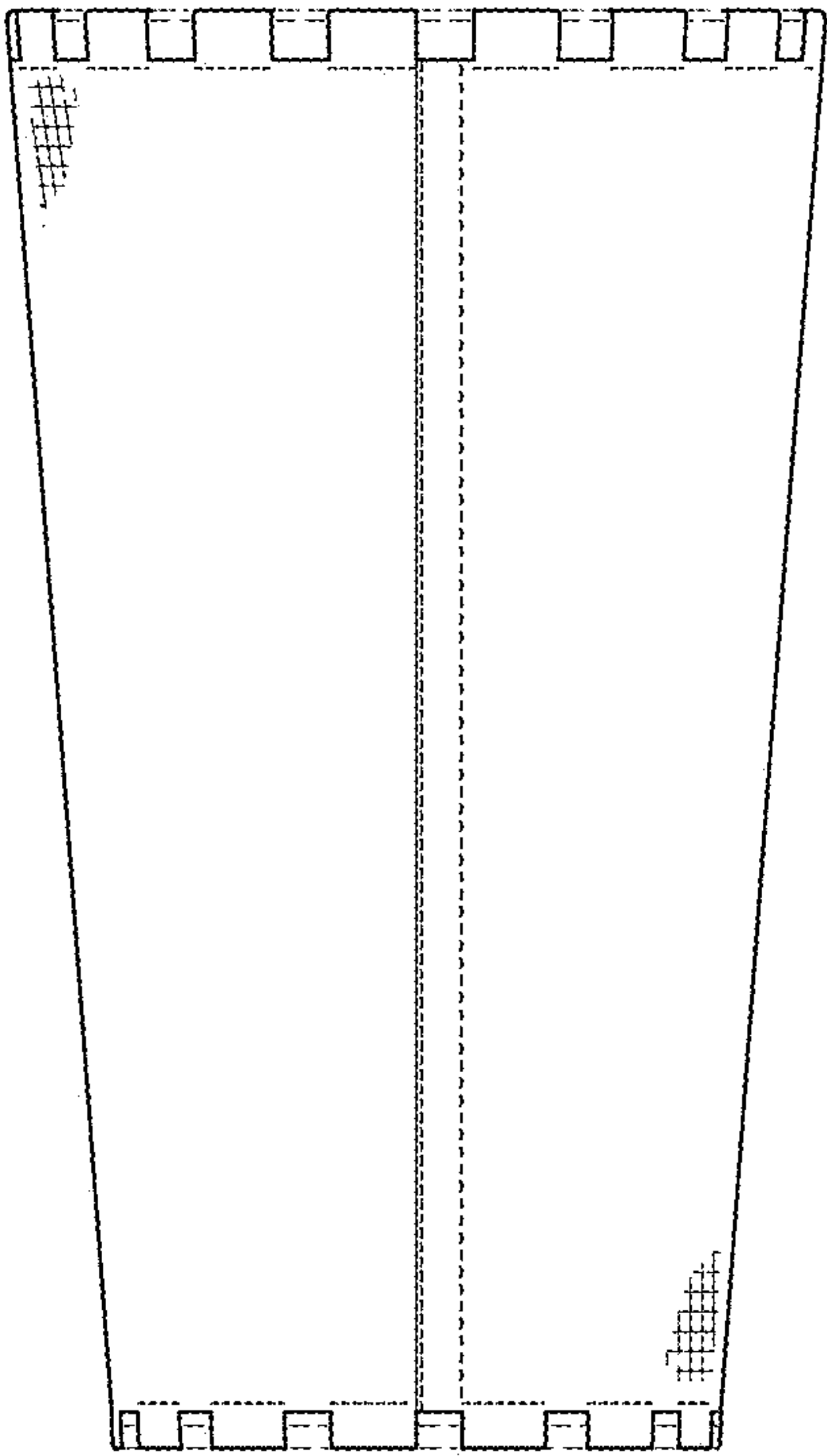

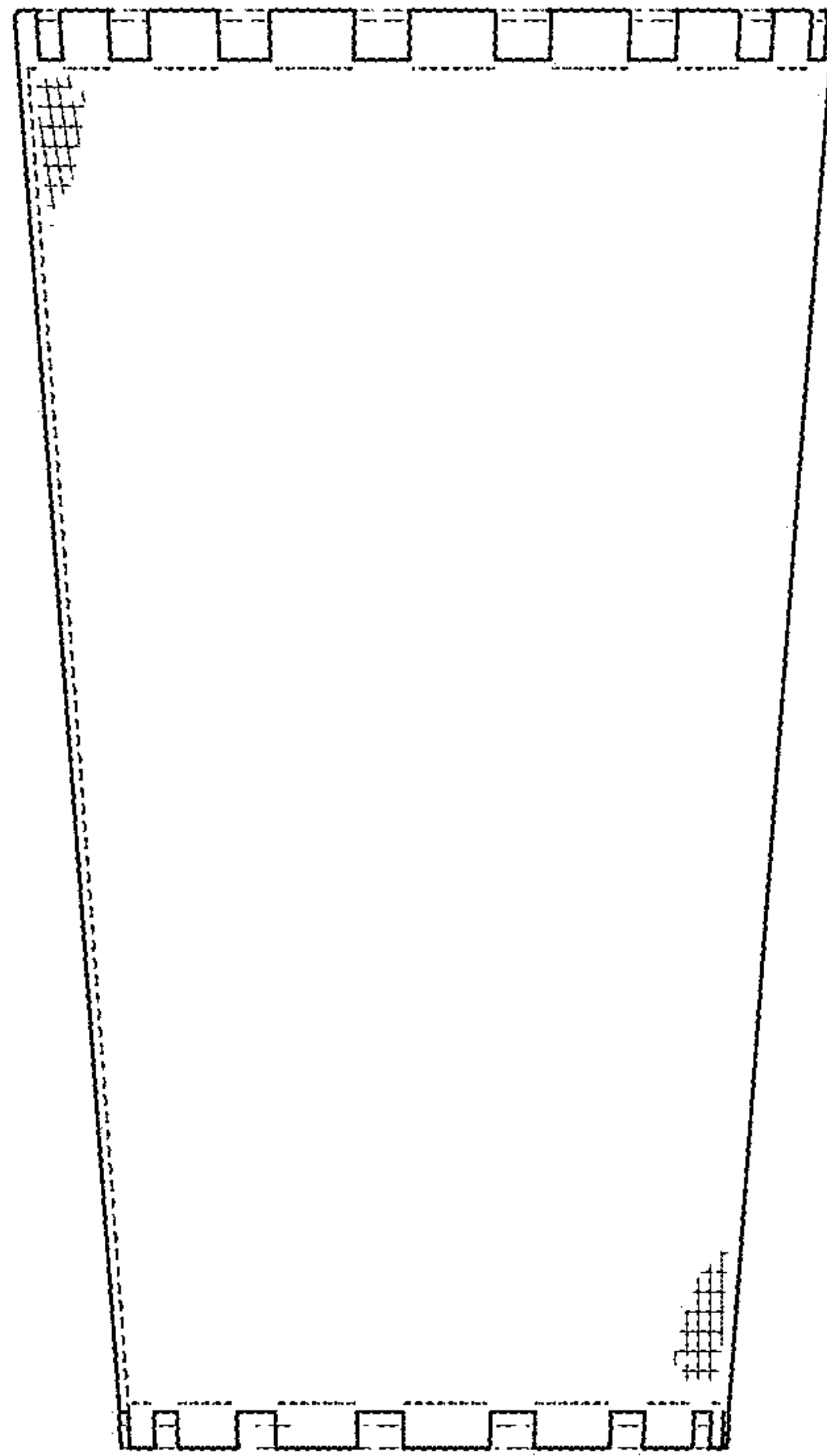

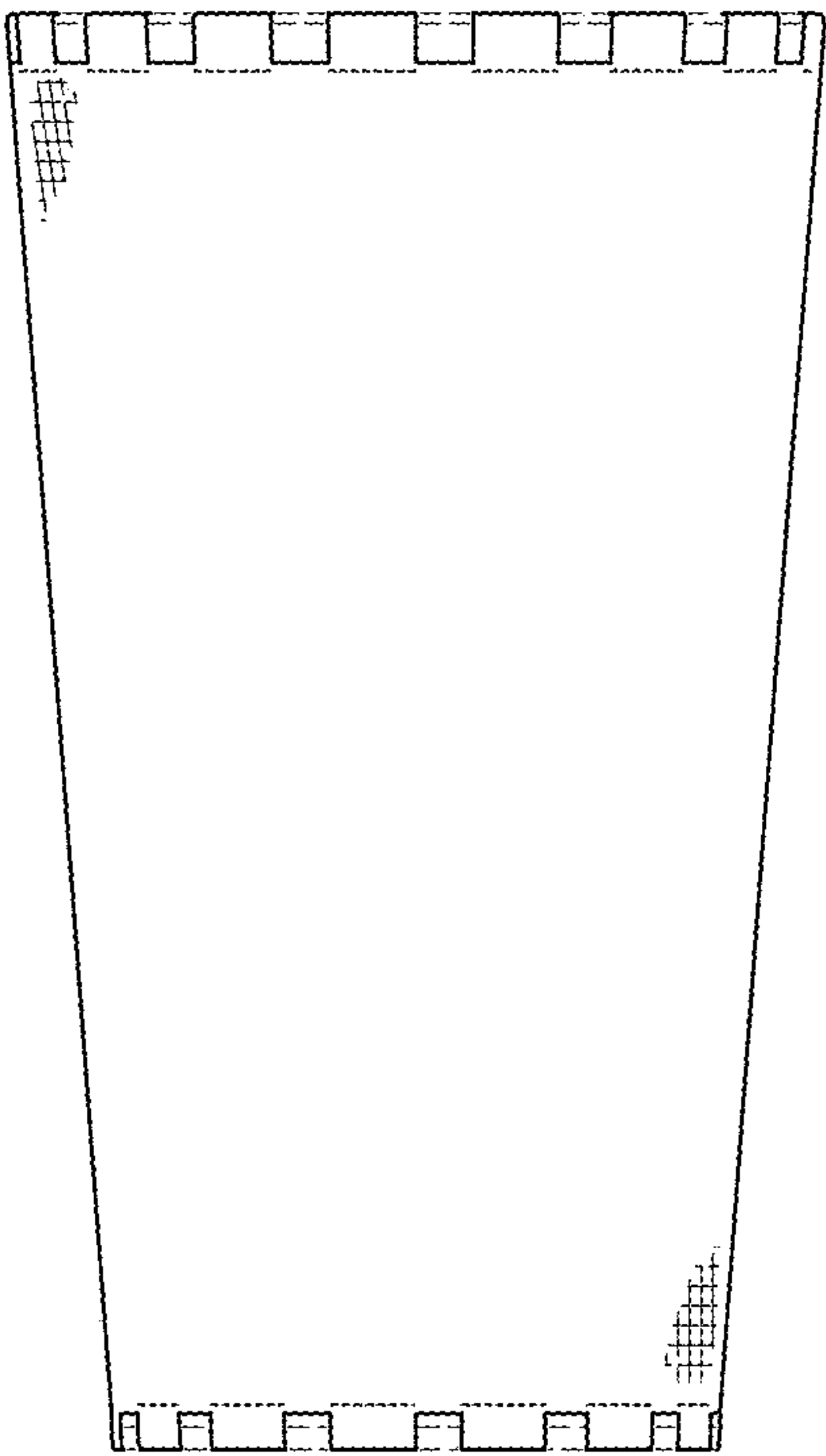

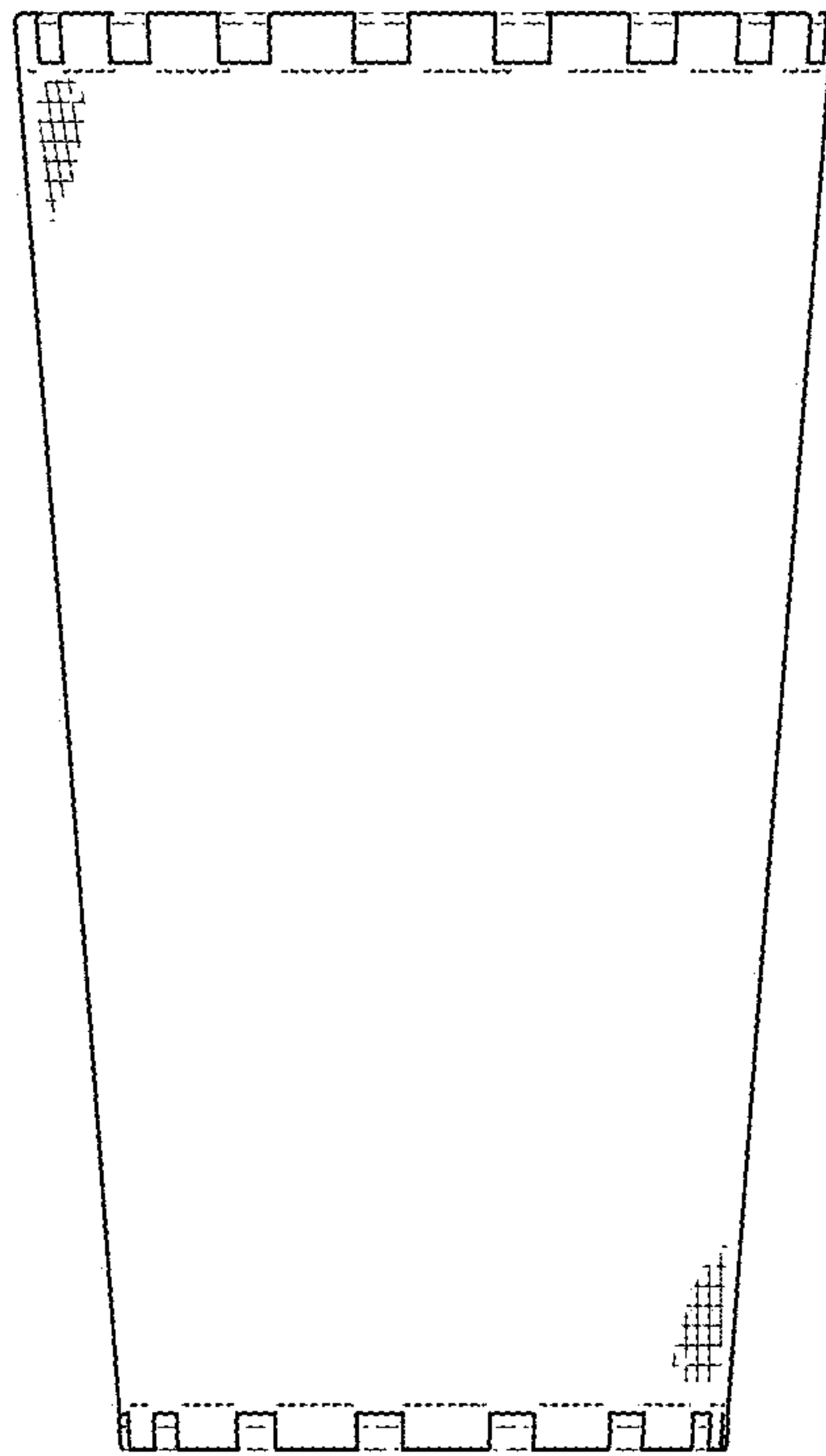
