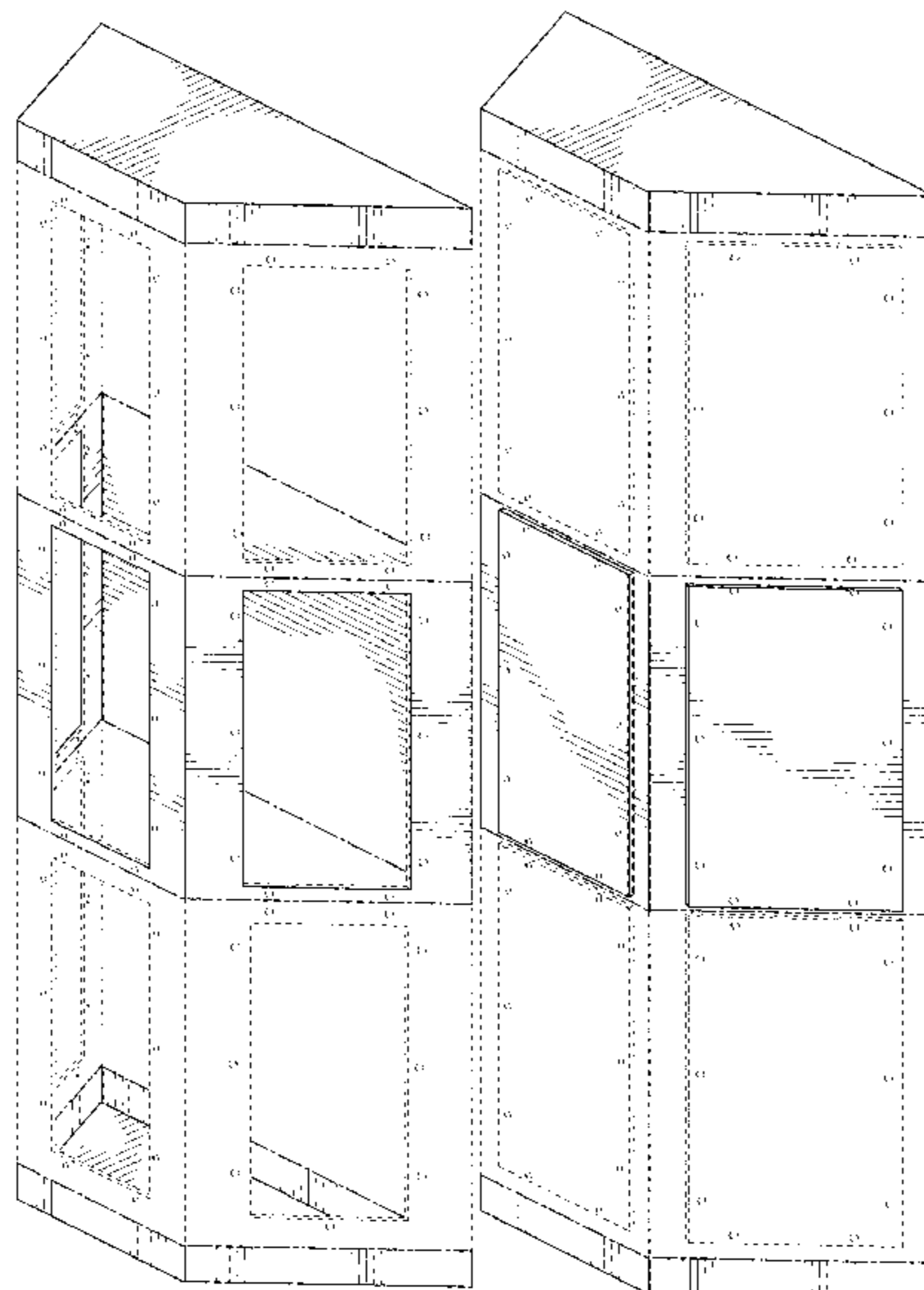
The broken lines depict portions of a housing unit for a security and surveillance apparatus in which the design is embodied that form no part of the claimed design.

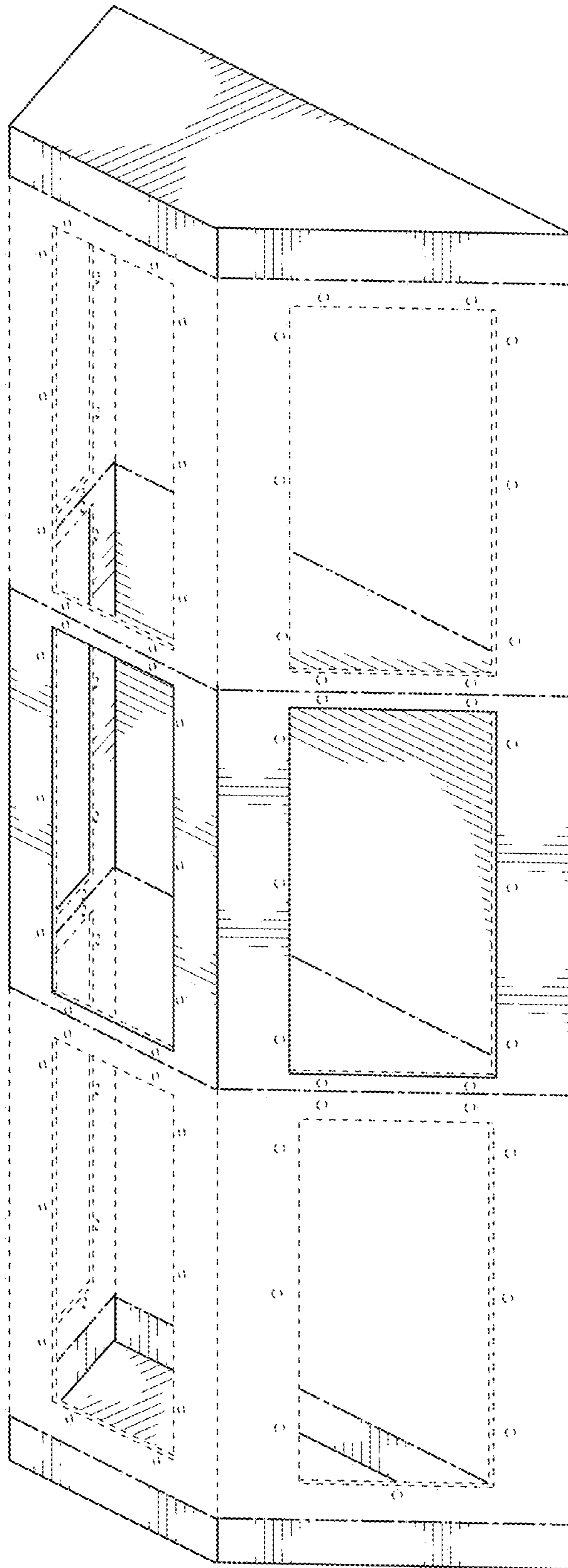

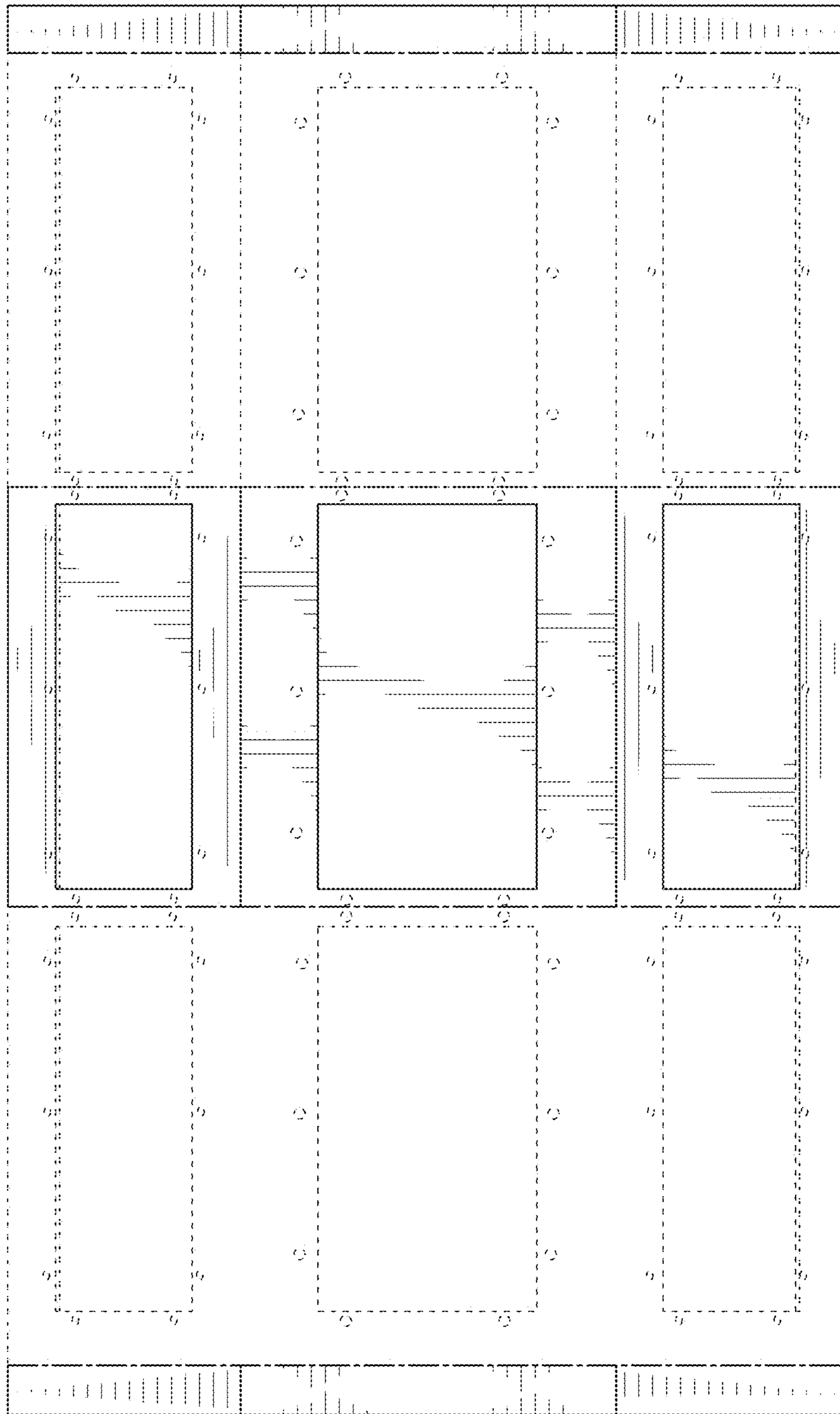

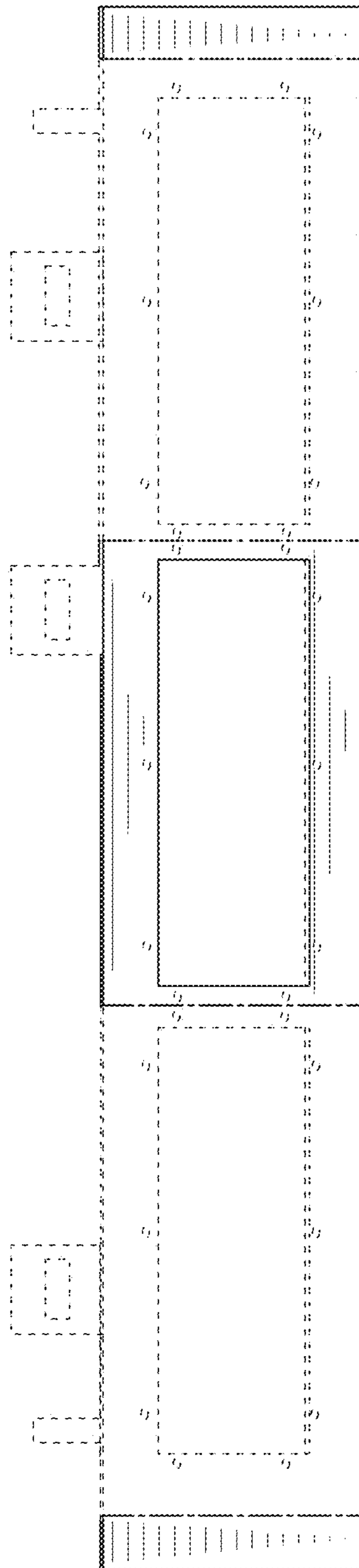
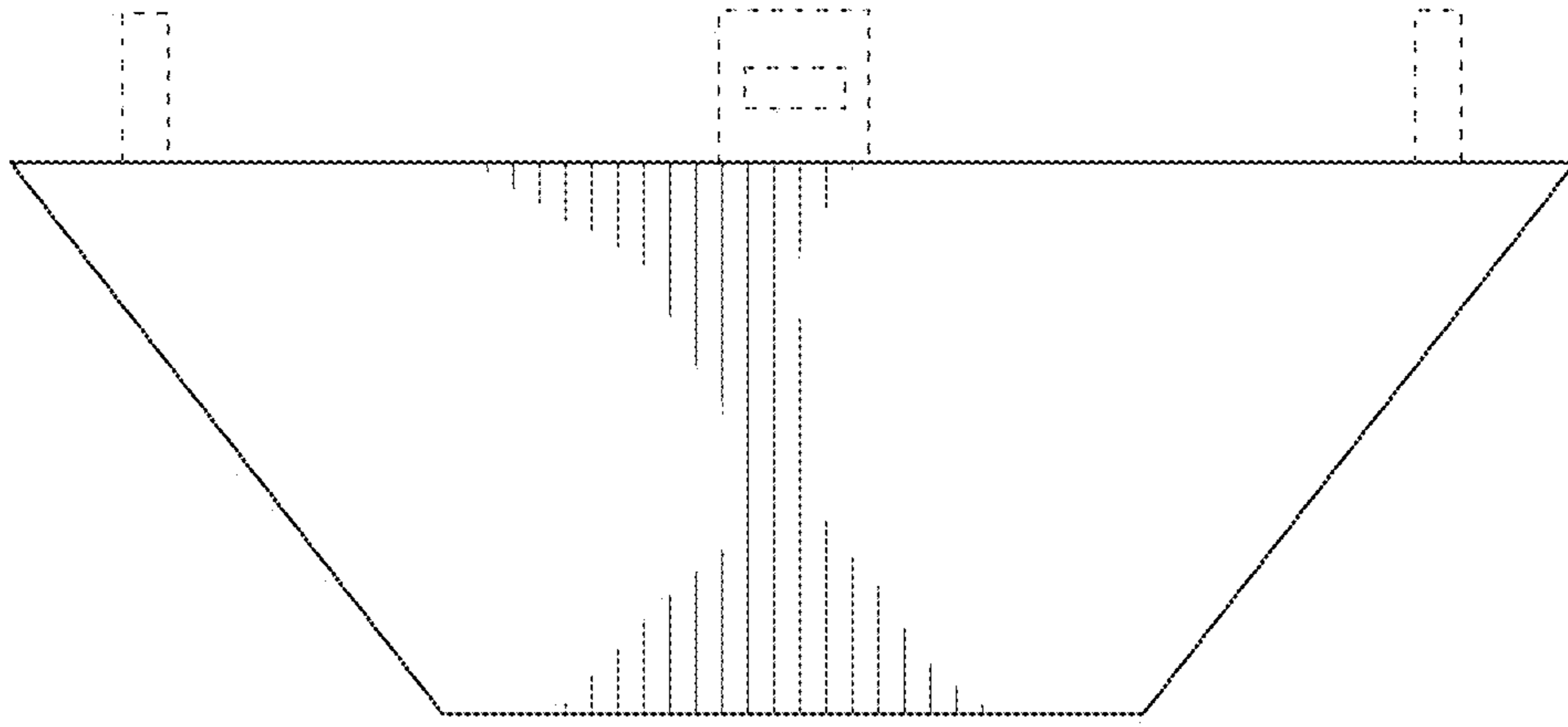
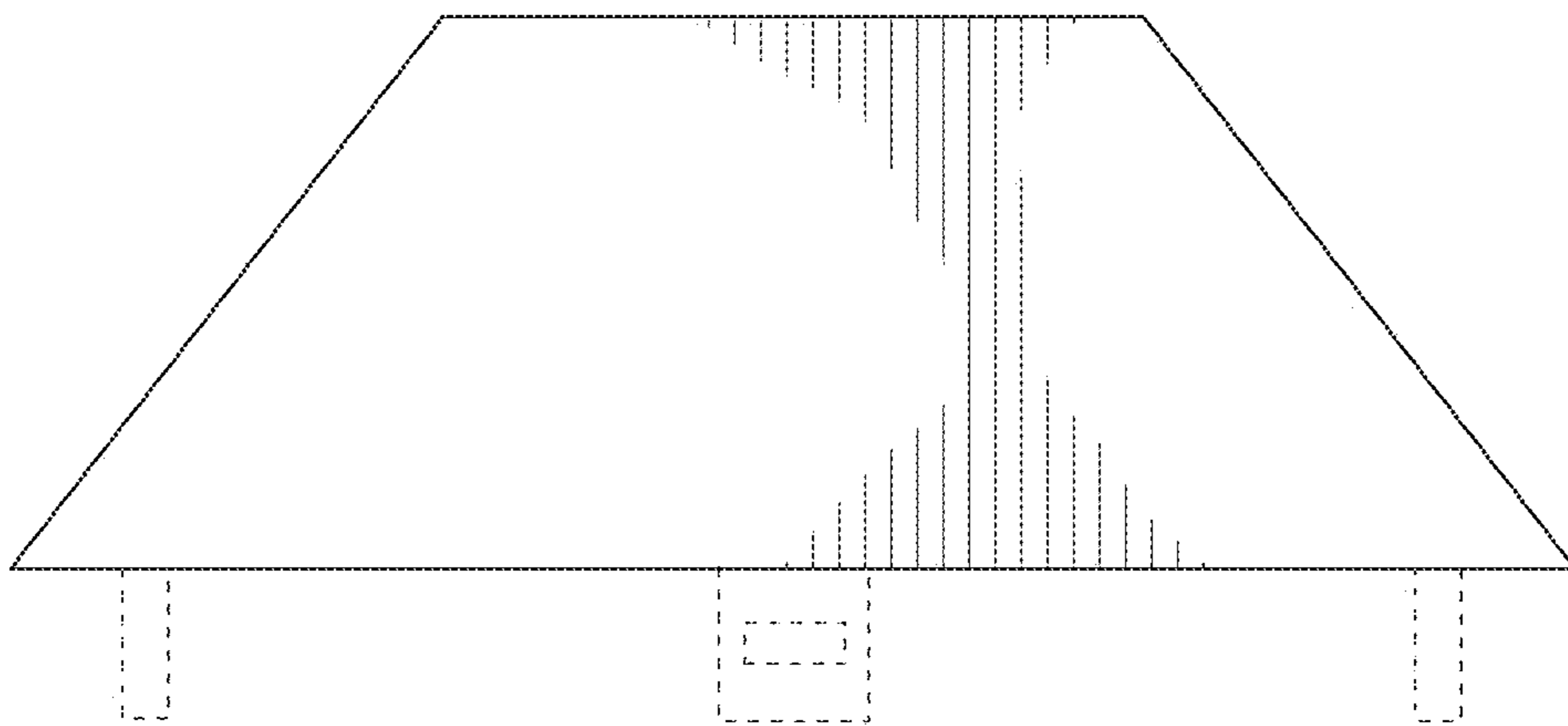

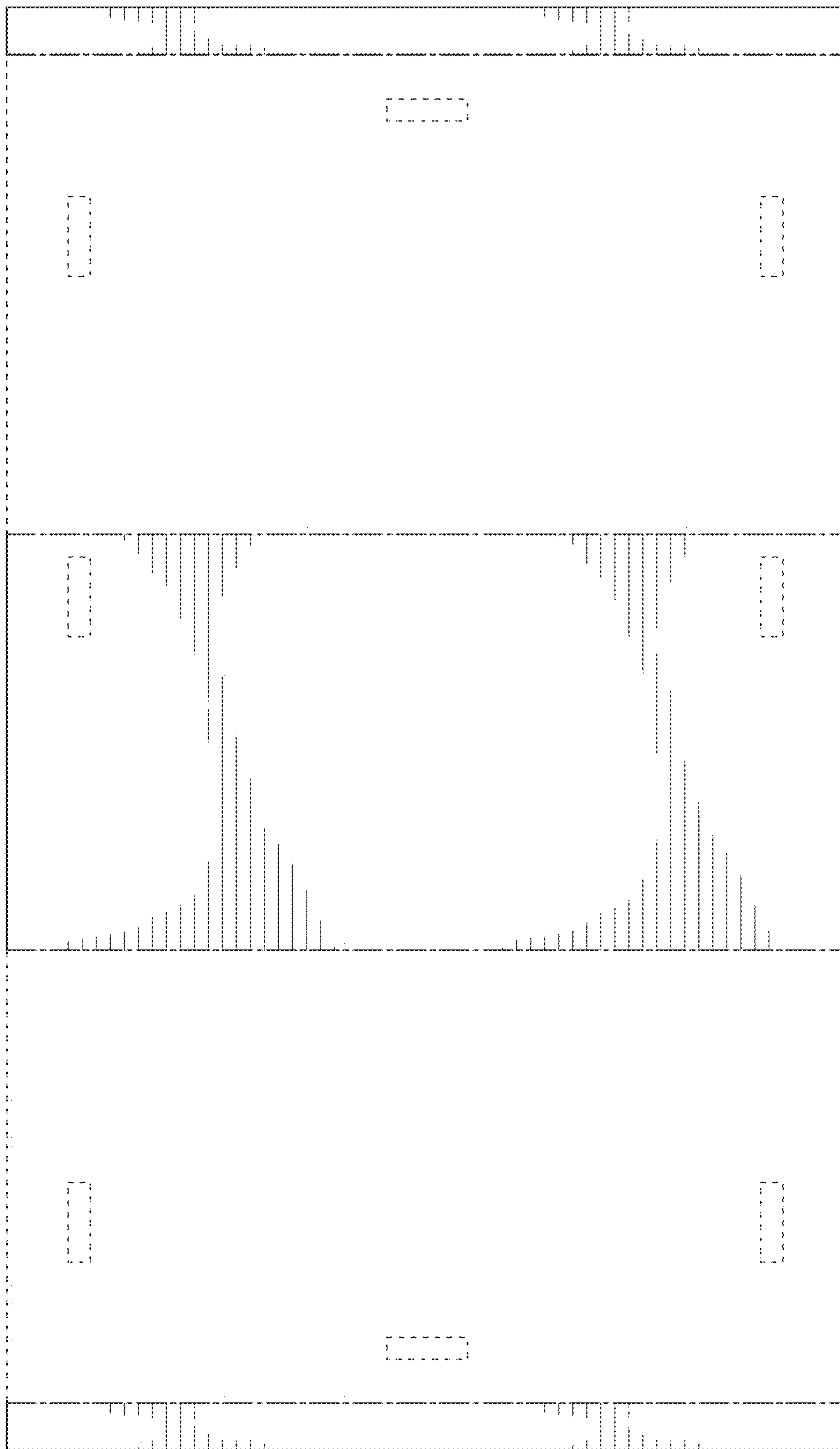

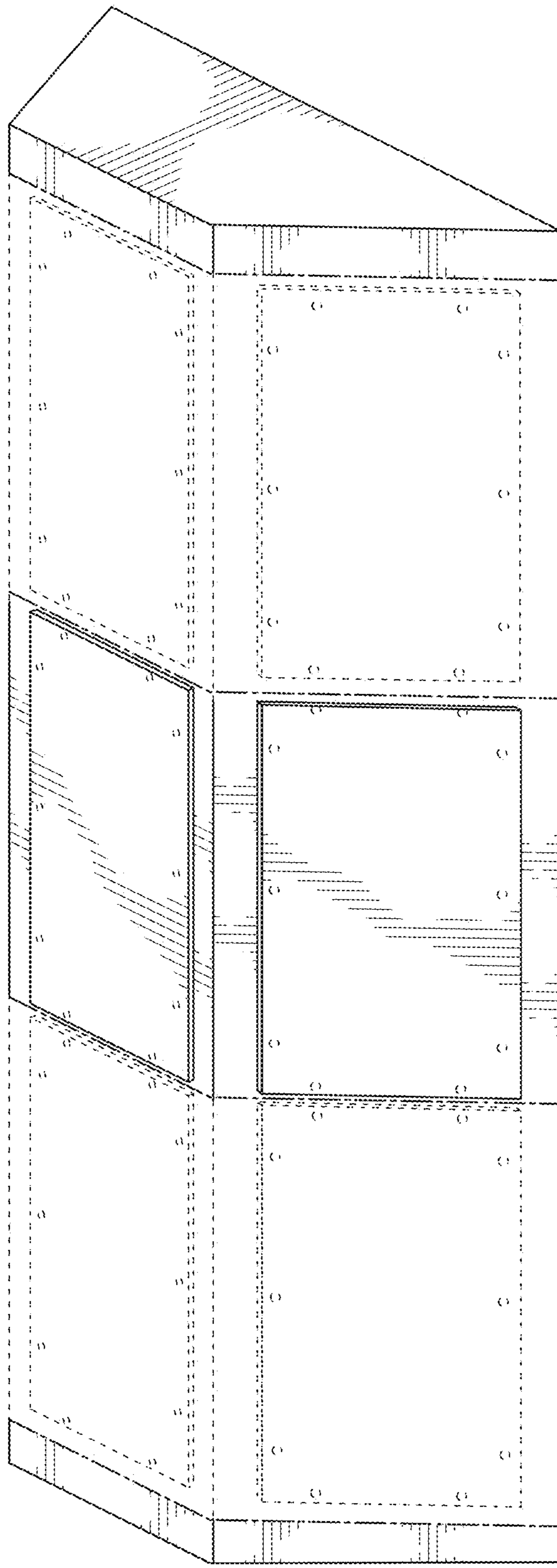

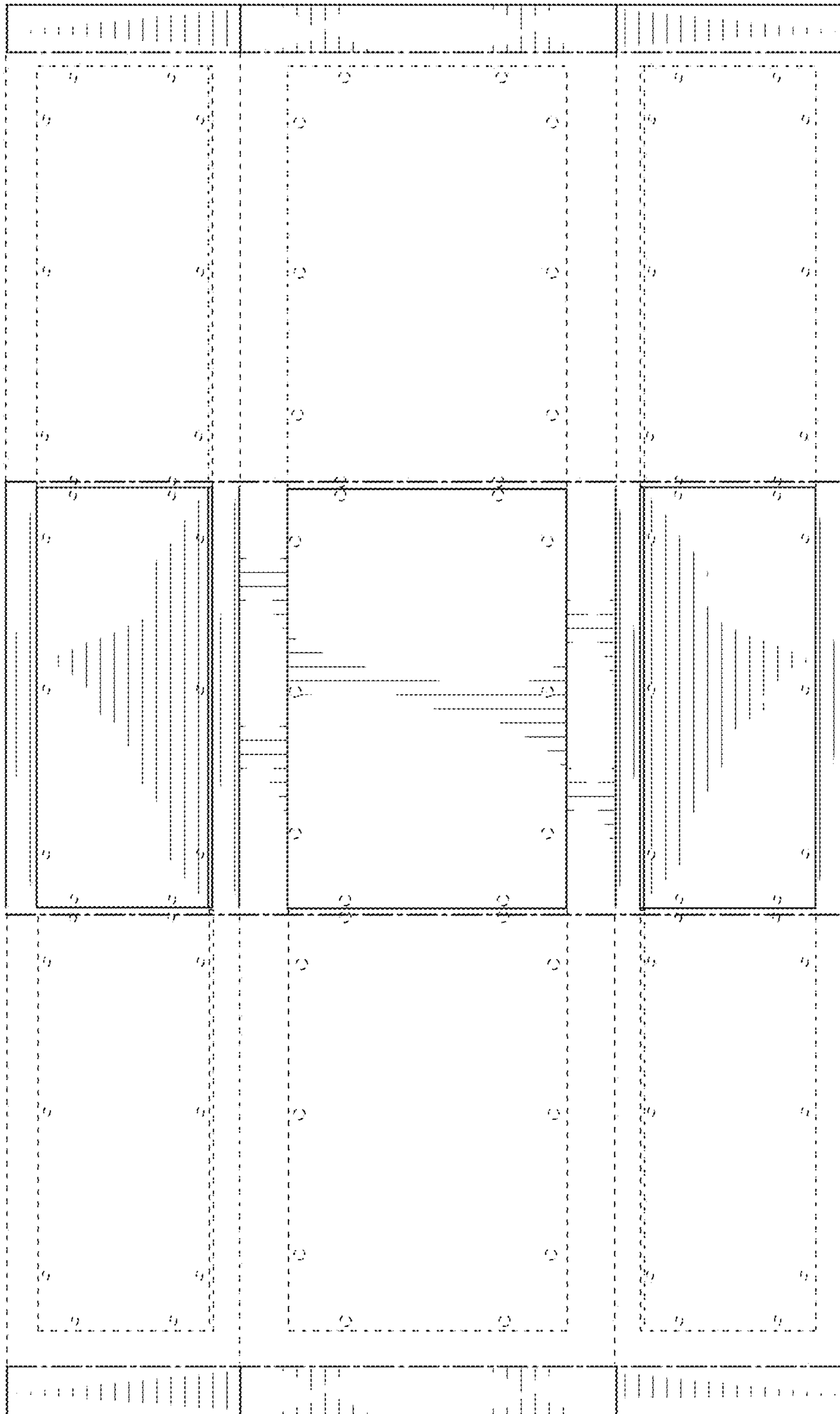

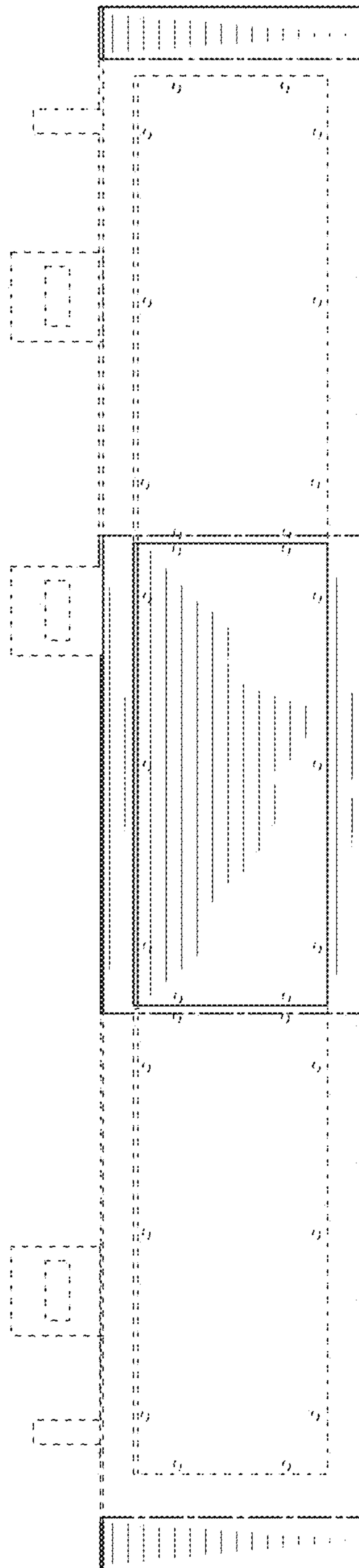

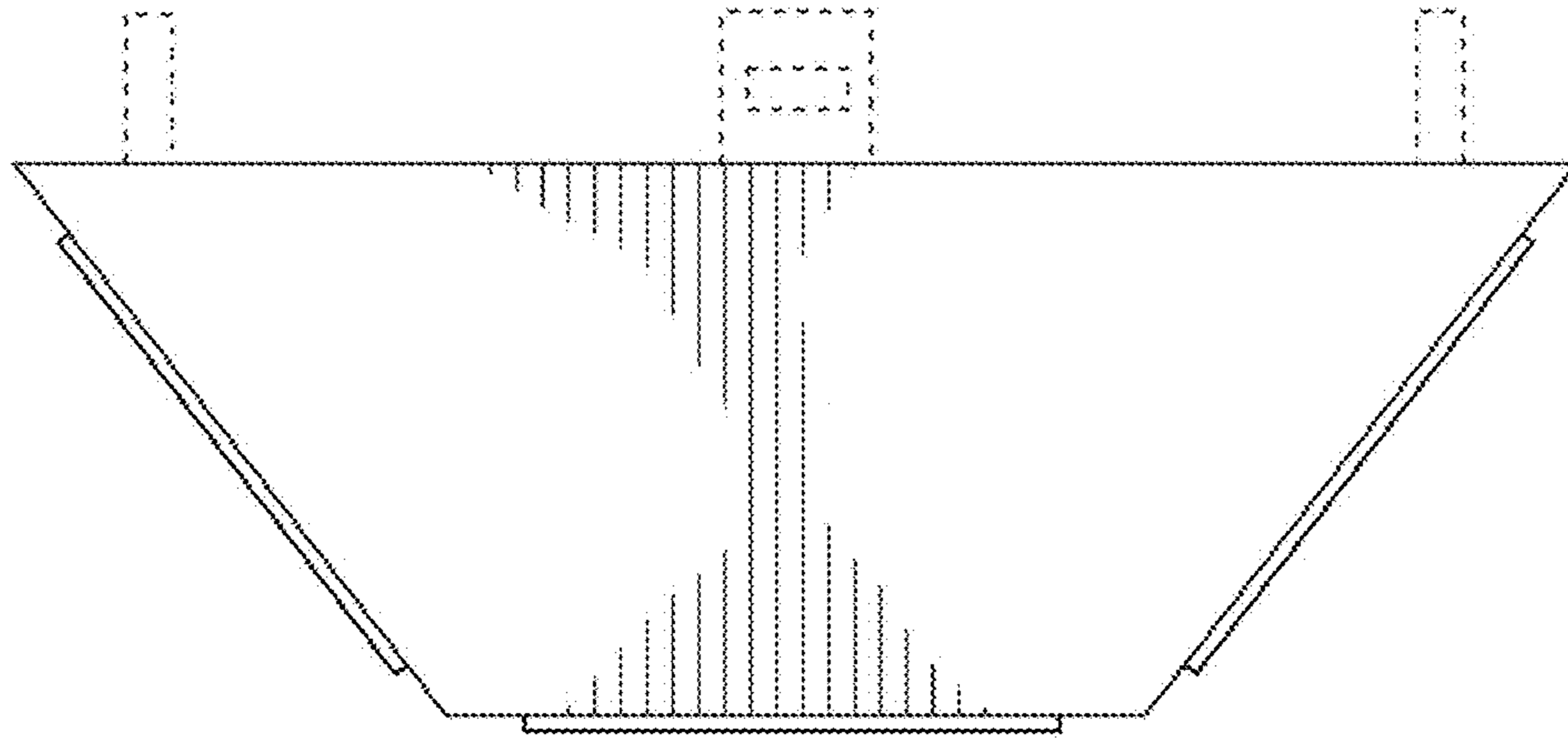

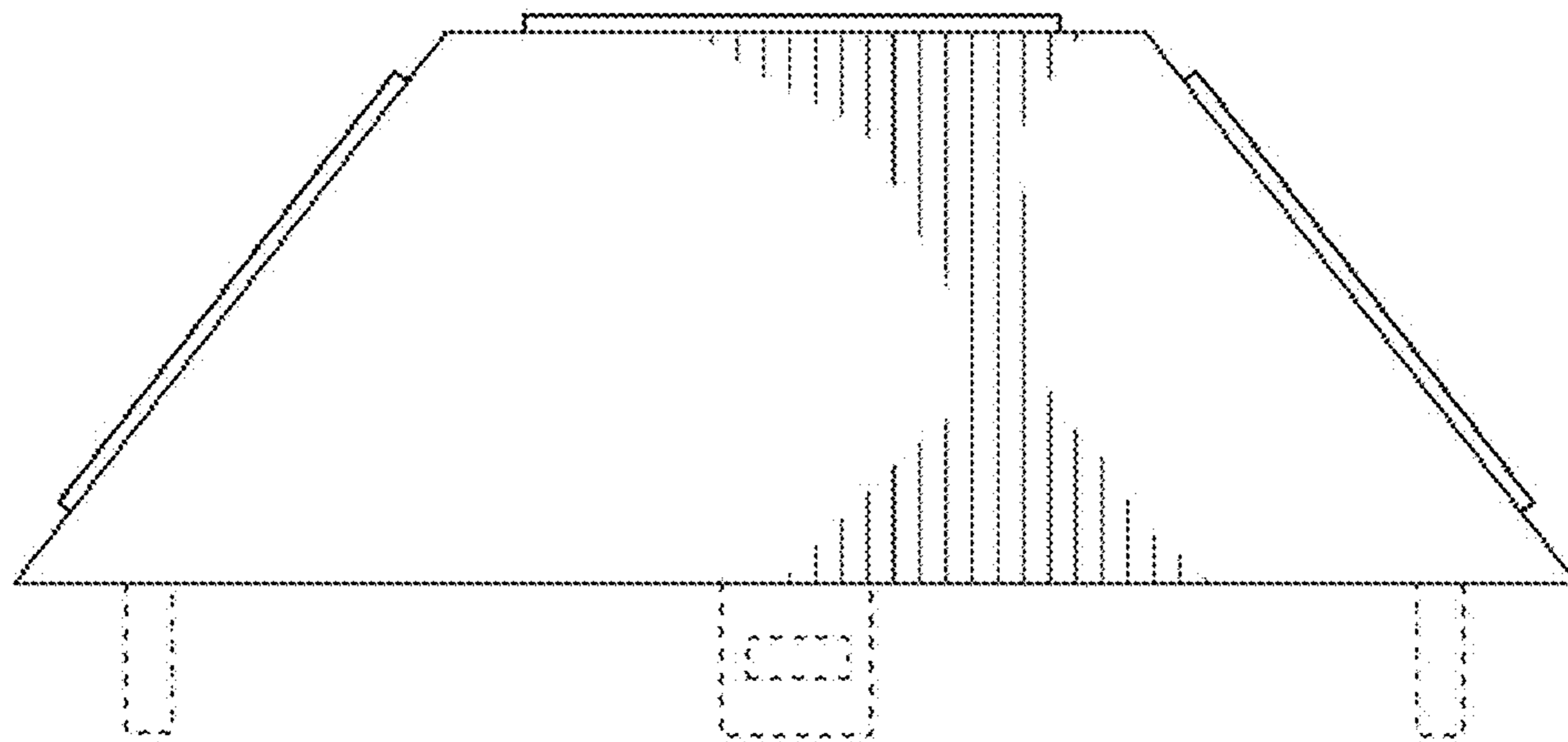

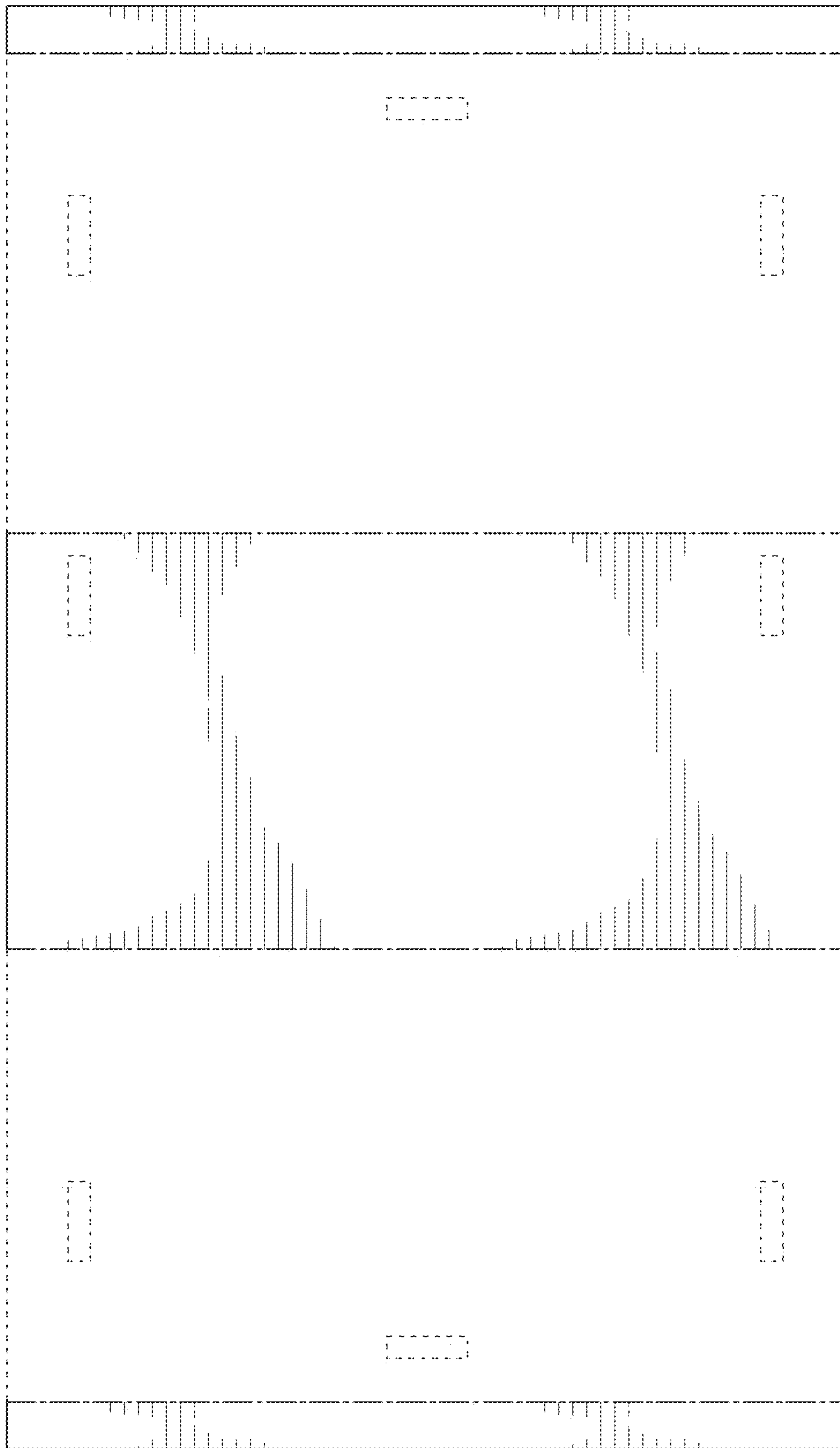
