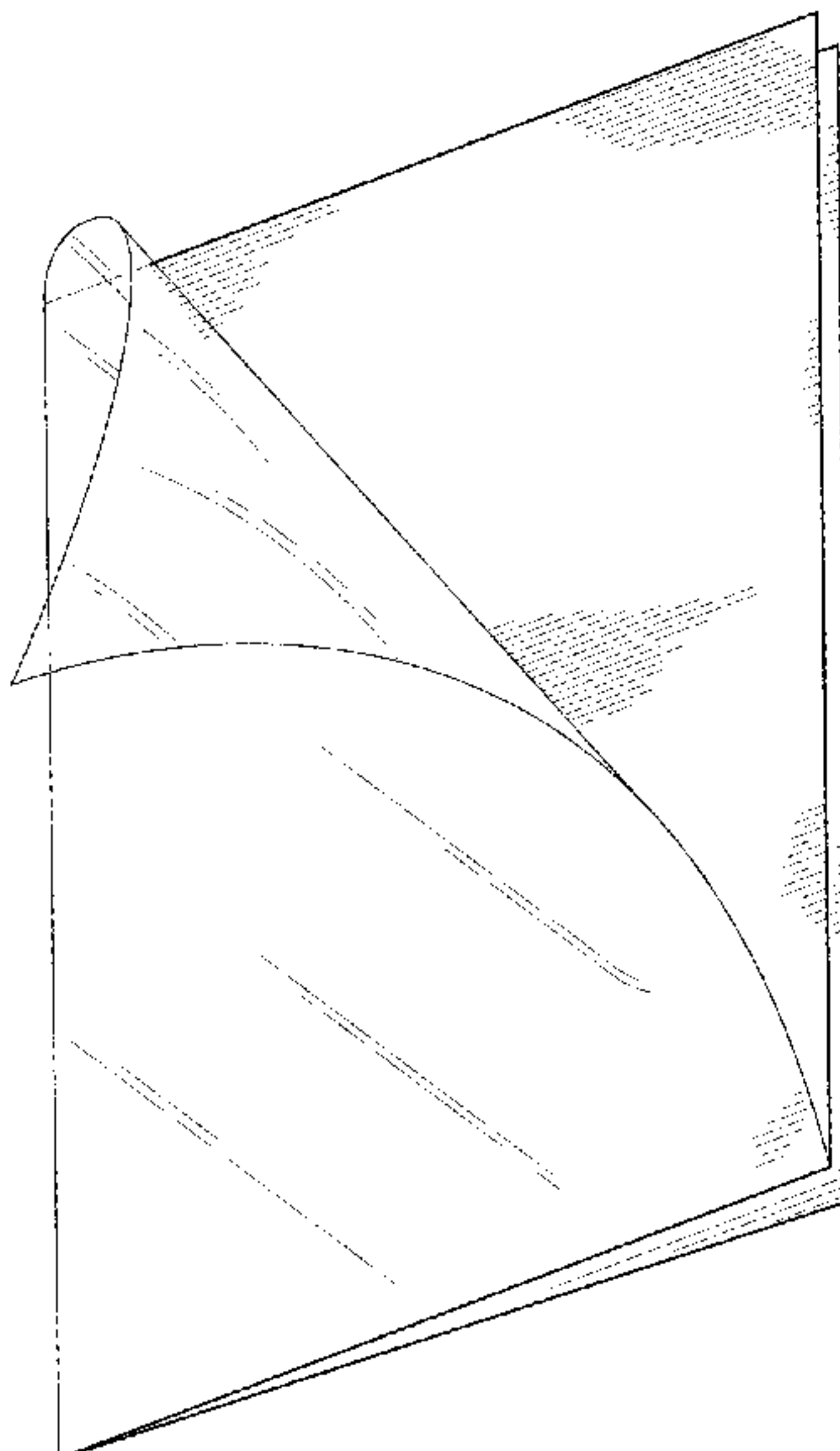
(57) **CLAIM**

I claim the ornamental design for a folder, as shown and described.

DESCRIPTION

FIG. 1 is a front/right/bottom perspective view of a folder, shown with the front surface curled from upper right to lower left;
 FIG. 2 is a front/right/bottom perspective view of the folder;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a left side elevational view thereof.
 FIG. 6 is a right side elevational view thereof;
 FIG. 7 is a top plan view thereof;
 FIG. 8 is a bottom plan view thereof; and,
 FIG. 9 is a view of the folder in an open configuration.

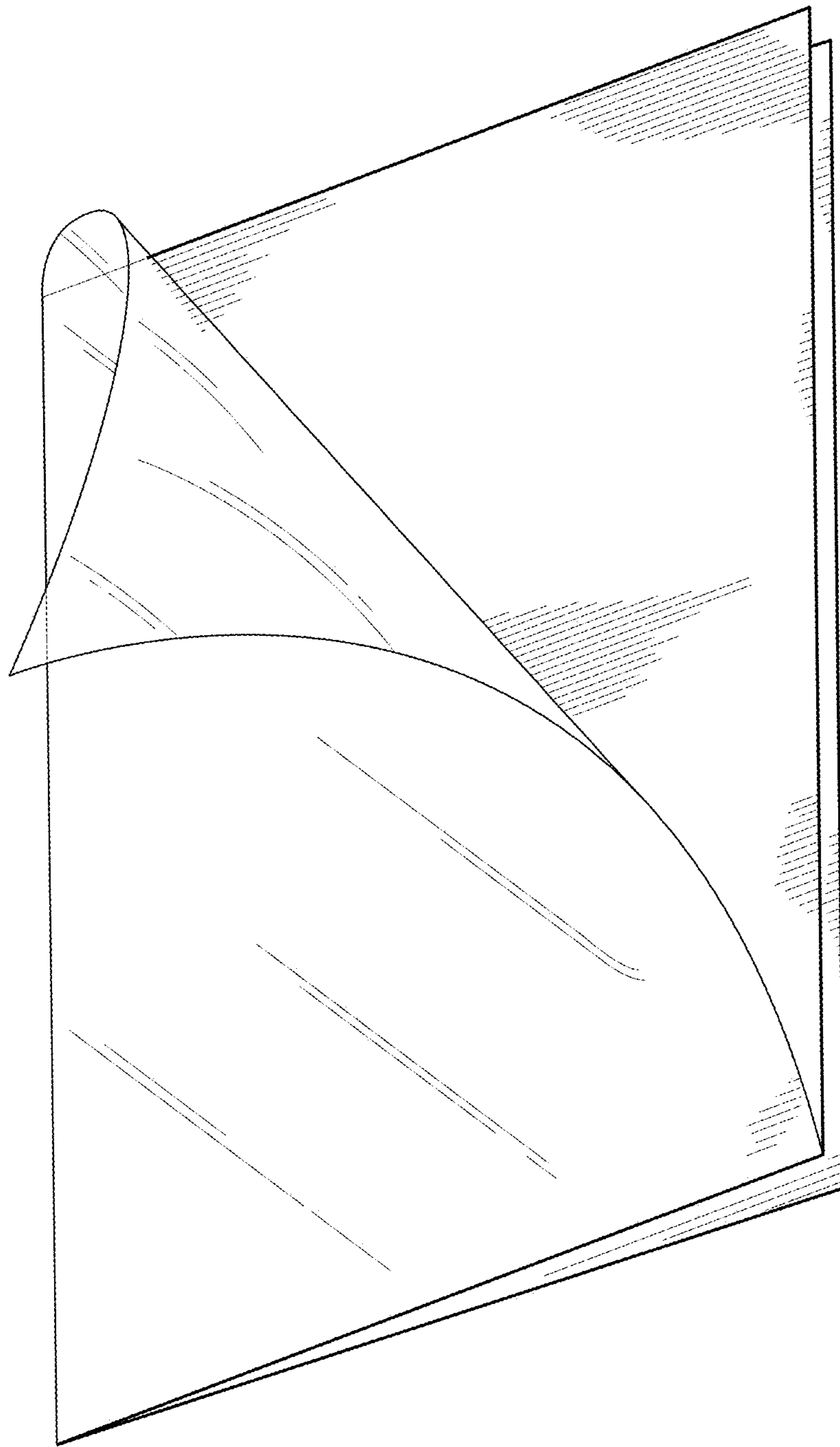

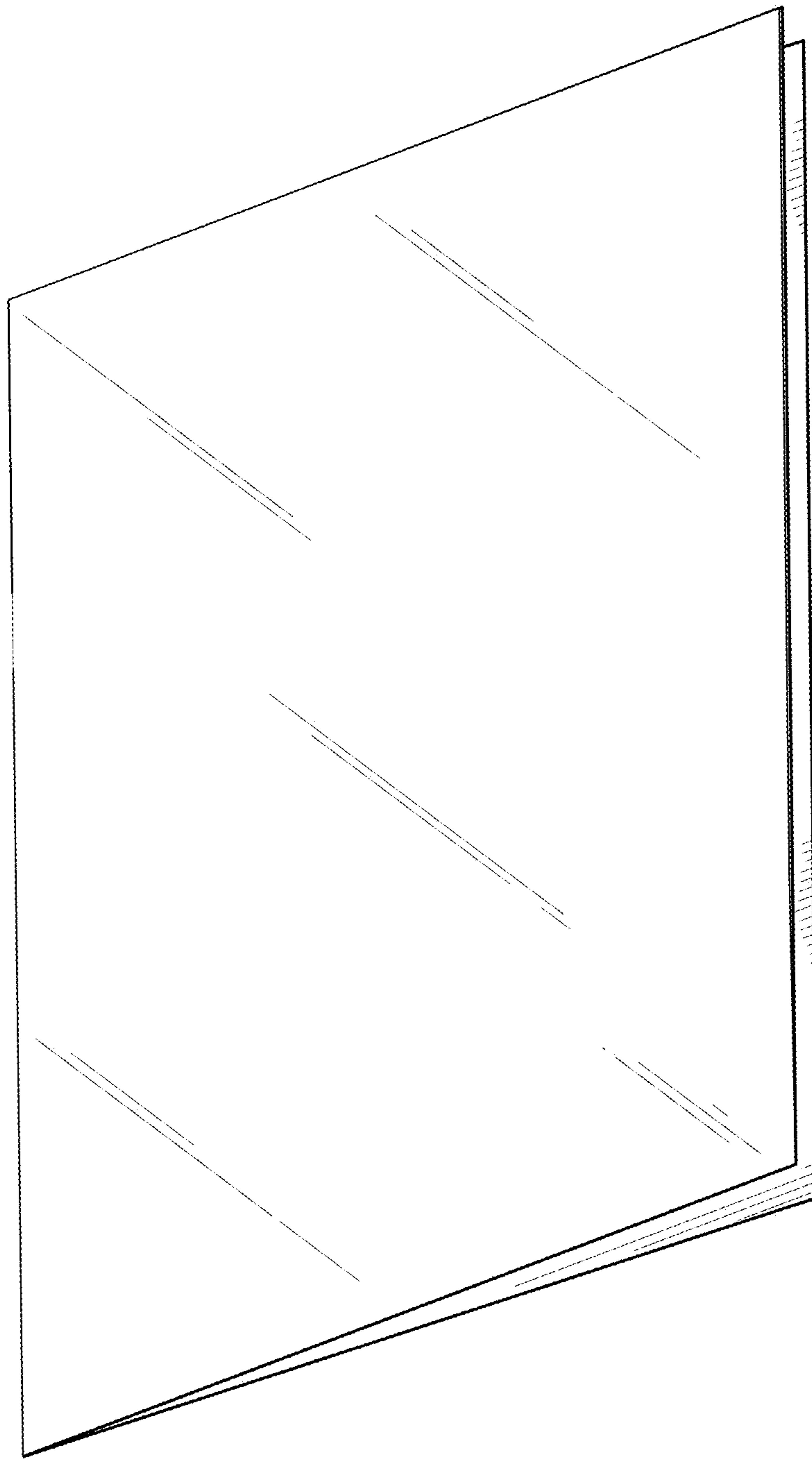

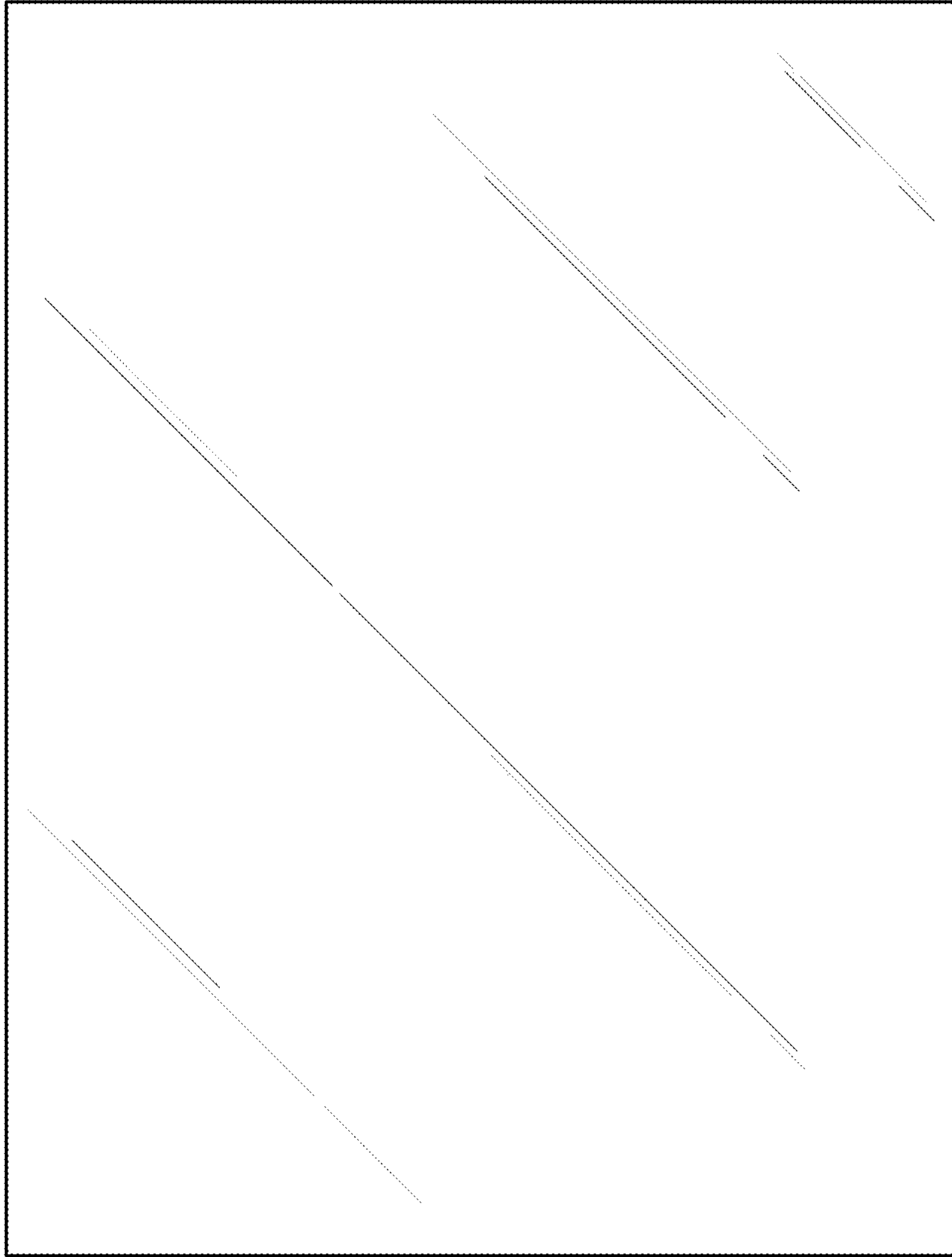

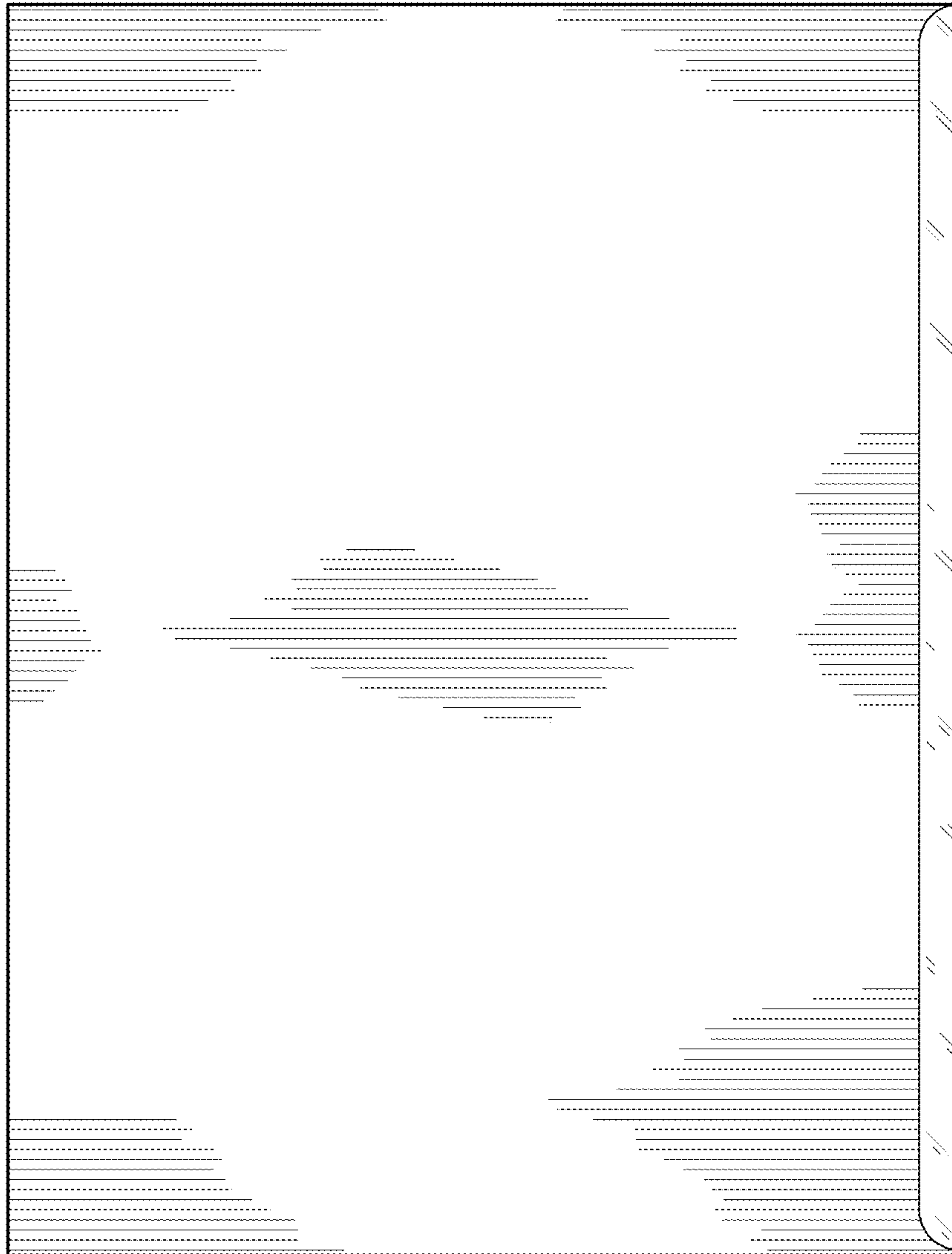

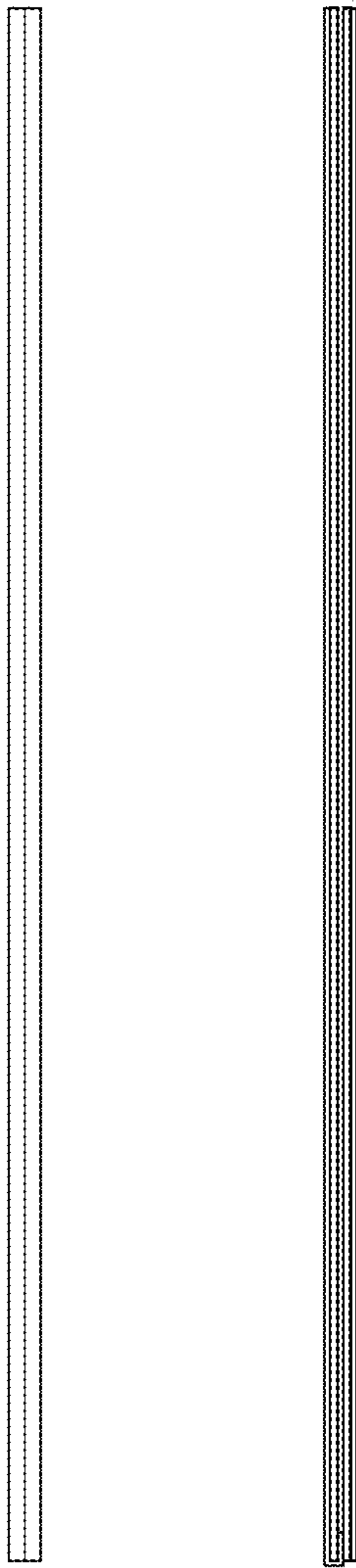

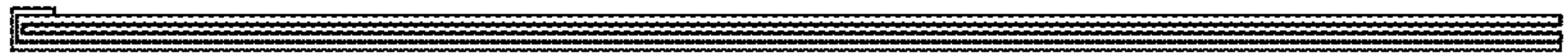

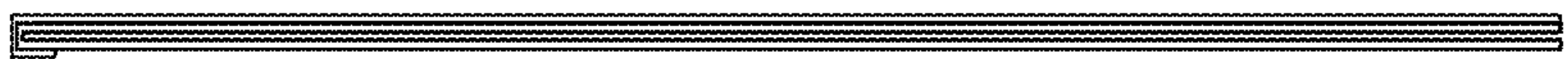

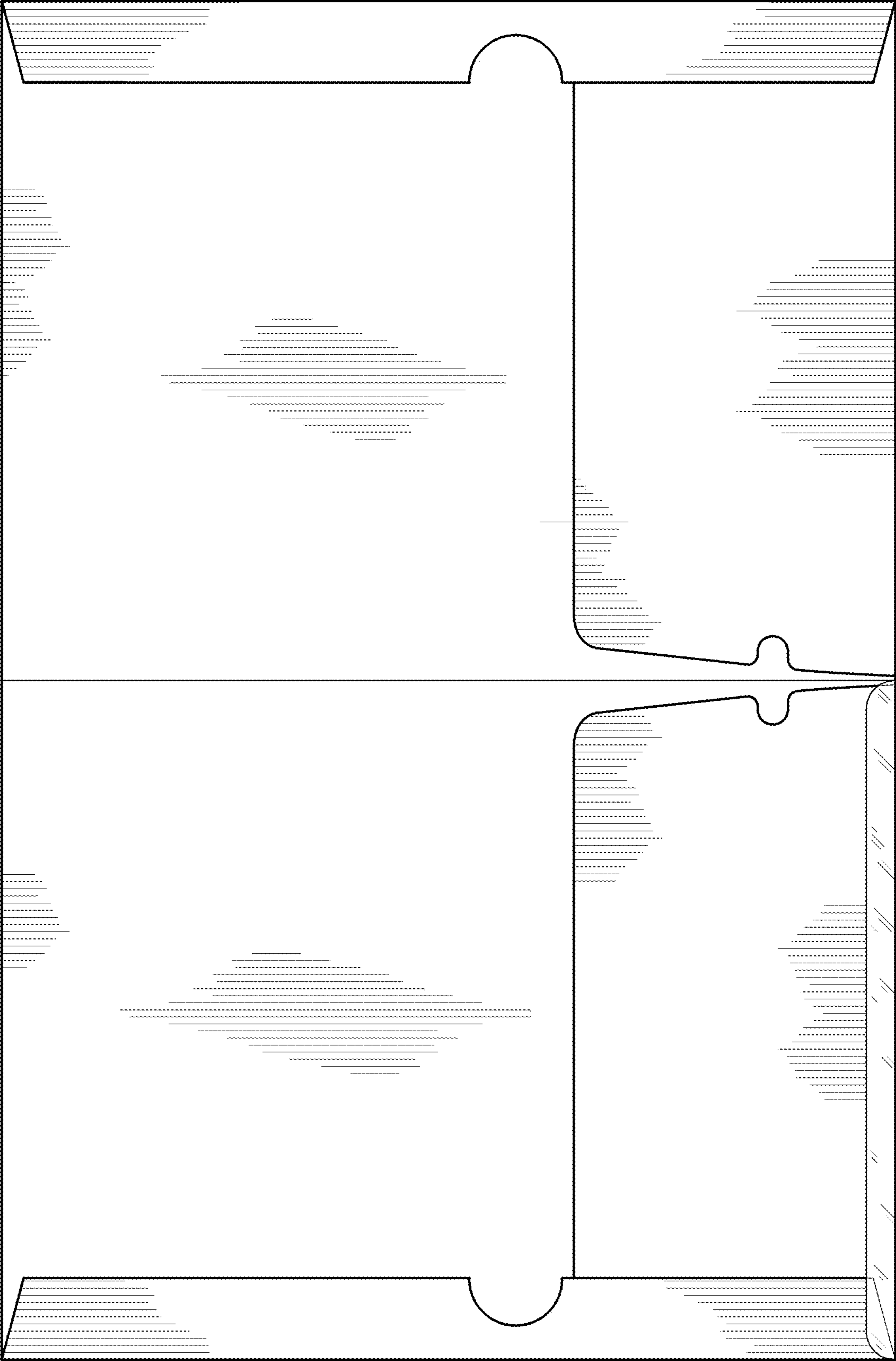
