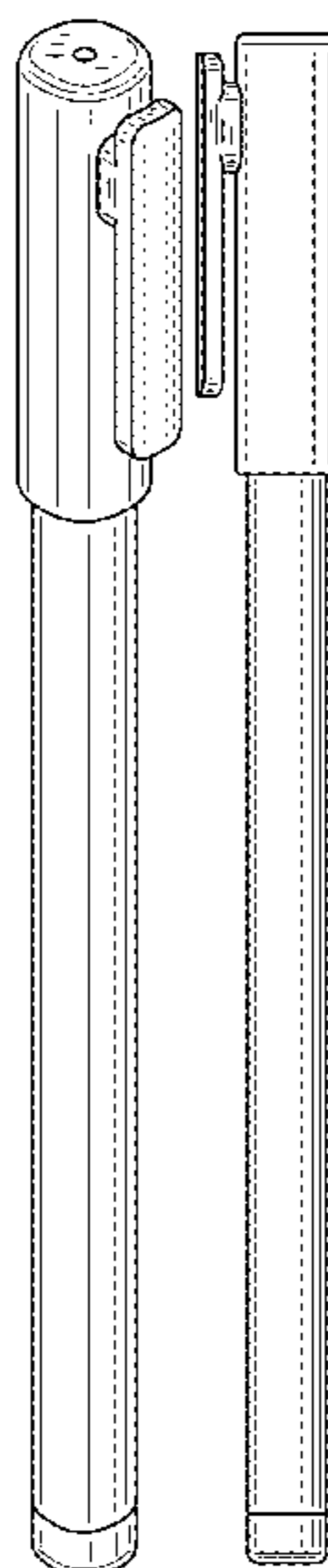
(57) **CLAIM**

The ornamental design for the writing instrument, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a writing instrument; FIG. 2 is a front elevation view thereof; FIG. 3 is a right elevation view thereof, the left elevation view is a mirror image thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a perspective view of a writing instrument according to another embodiment; FIG. 8 is a front elevation view of the writing instrument of FIG. 7; FIG. 9 is a right elevation view of the writing instrument of FIG. 7, the left elevation view of the writing instrument of FIG. 7 is a mirror image thereof; FIG. 10 is a rear elevation view of the writing instrument of FIG. 7; FIG. 11 is a top plan view of the writing instrument of FIG. 7; and, FIG. 12 is a bottom plan view of the writing instrument of FIG. 7.

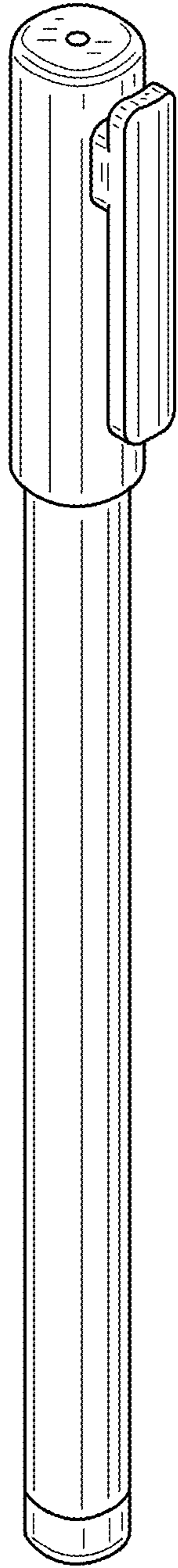

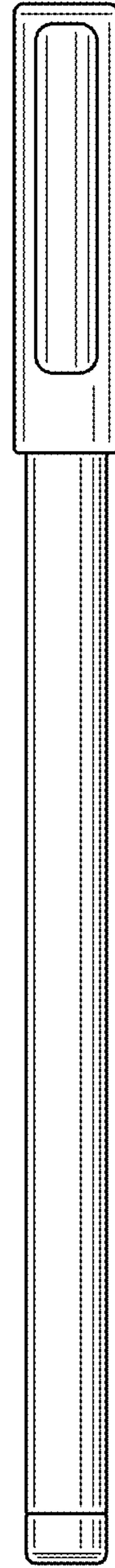

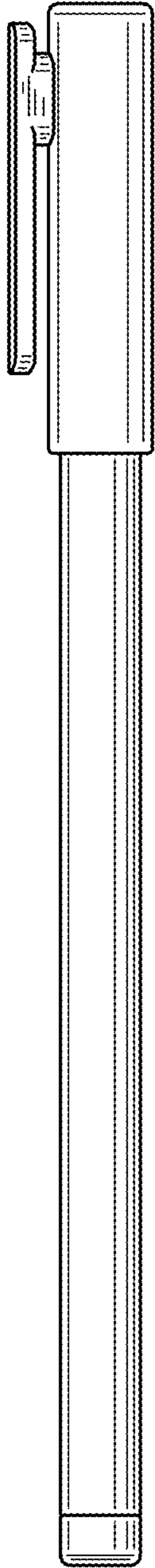

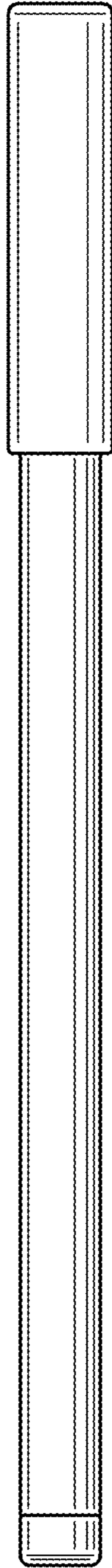

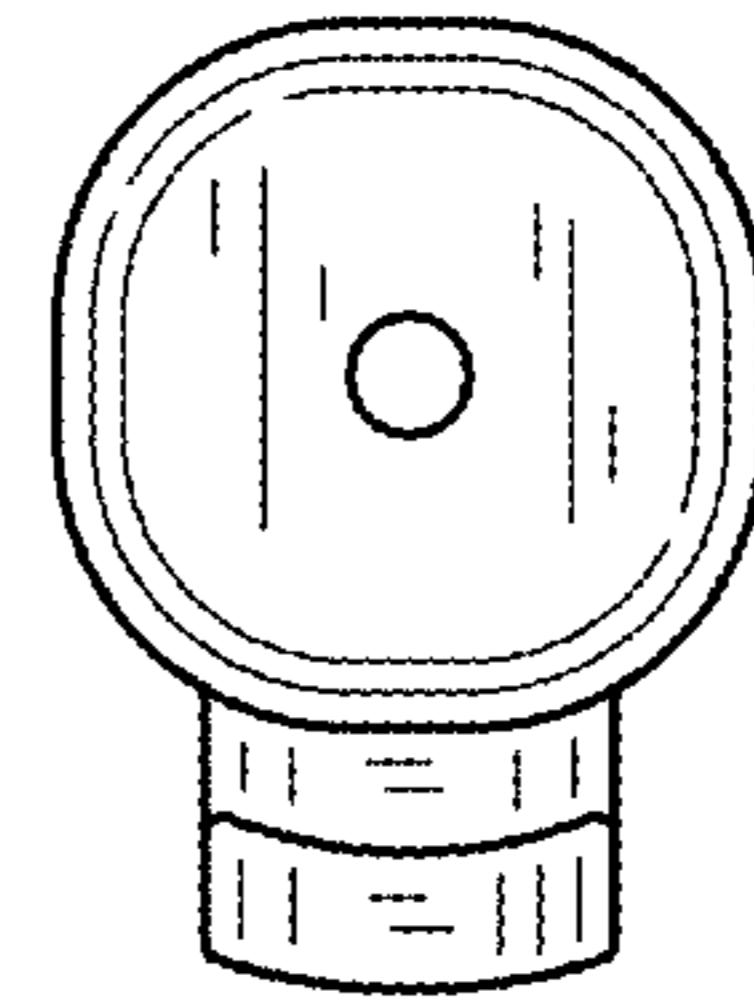

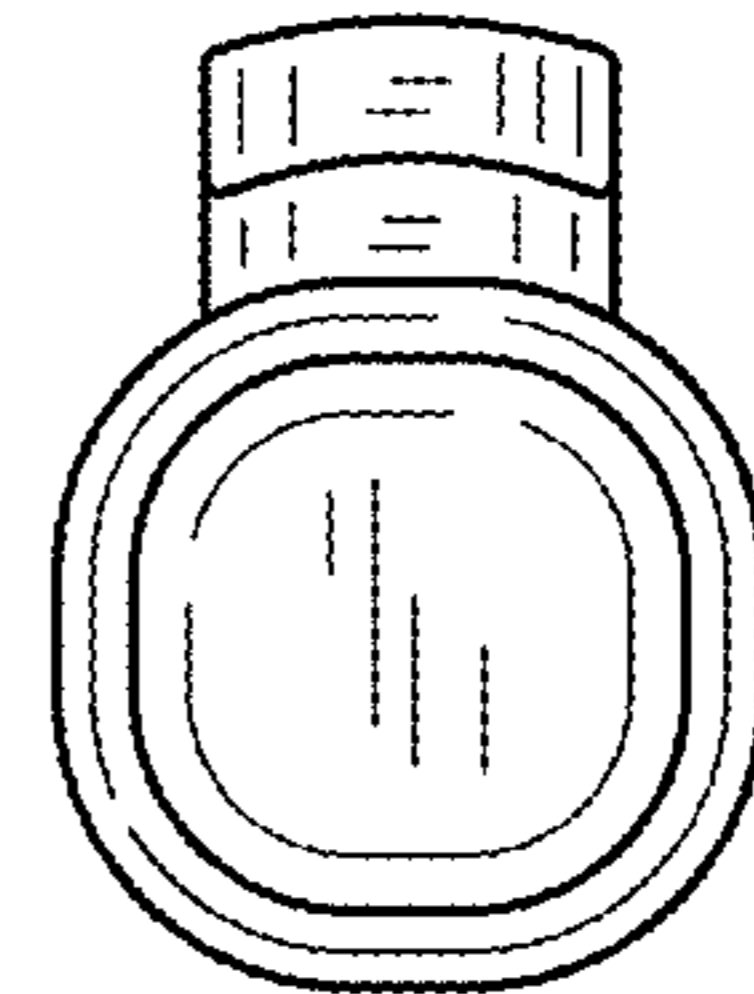

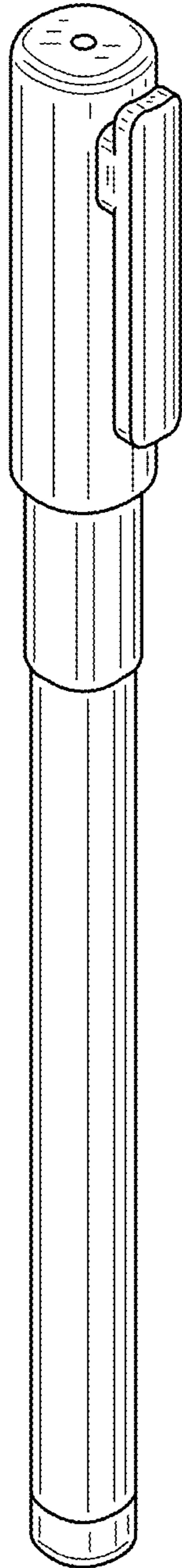

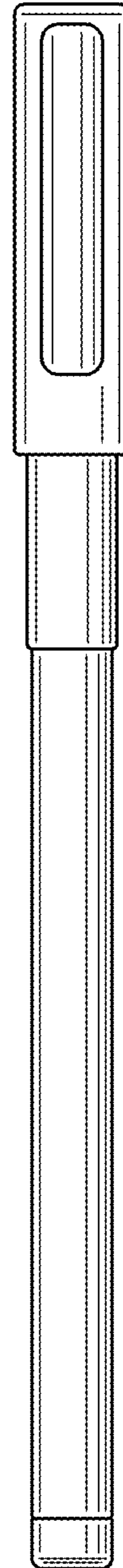

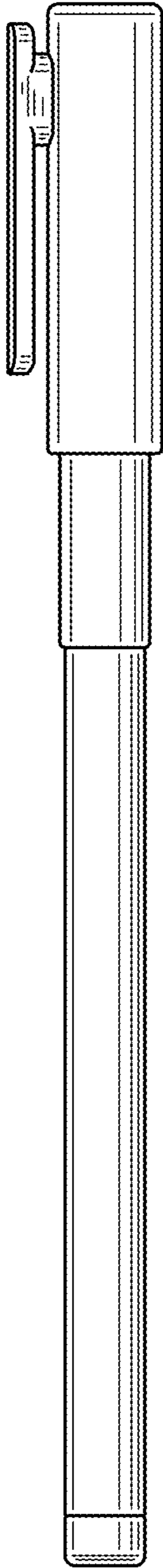

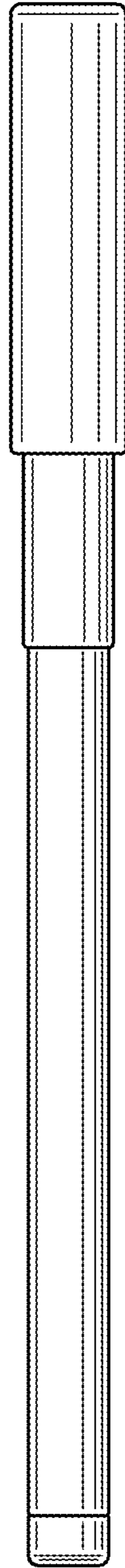

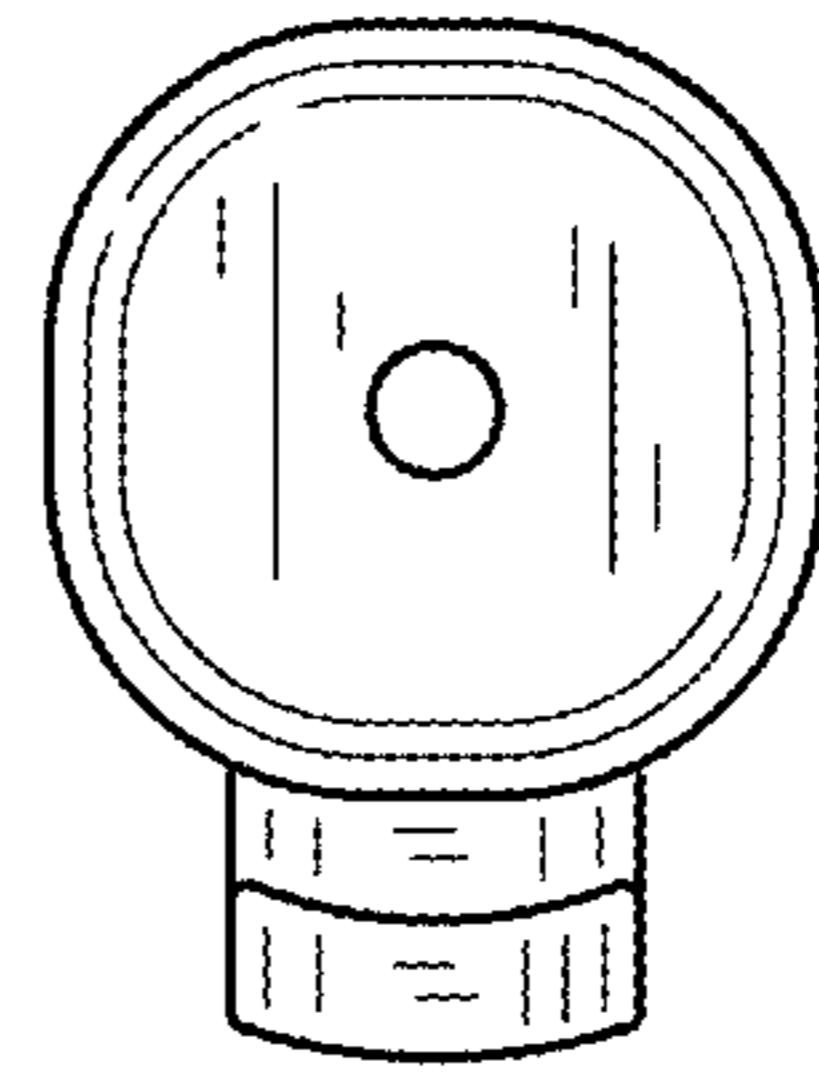

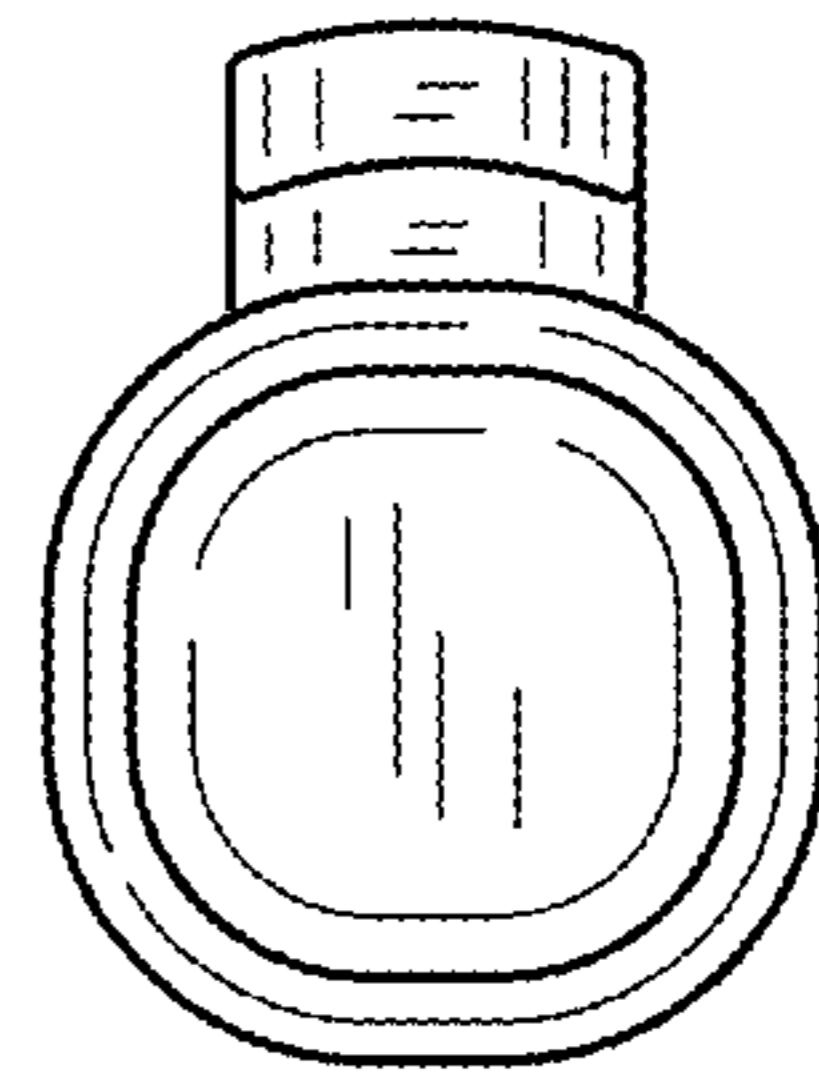
