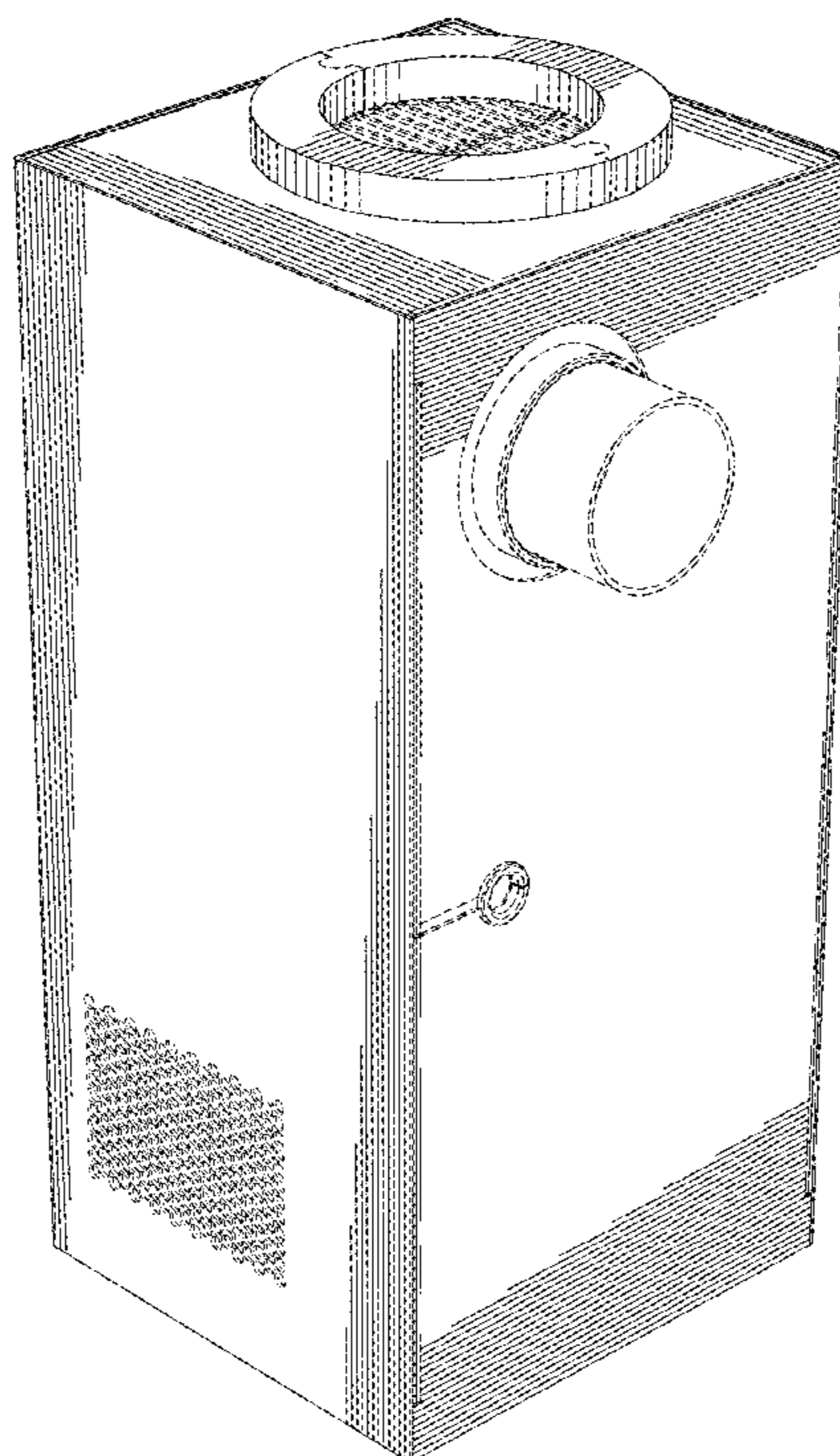
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a tridimensional view of a blower showing a first embodiment of my new design;
FIG. 2 is front elevation view of the embodiment of FIG. 1;
FIG. 3 is first side view of the embodiment of FIG. 1;
FIG. 4 is a second side view of the embodiment of FIG. 1, opposite the first side;
FIG. 5 is a top plan view of the embodiment of FIG. 1;

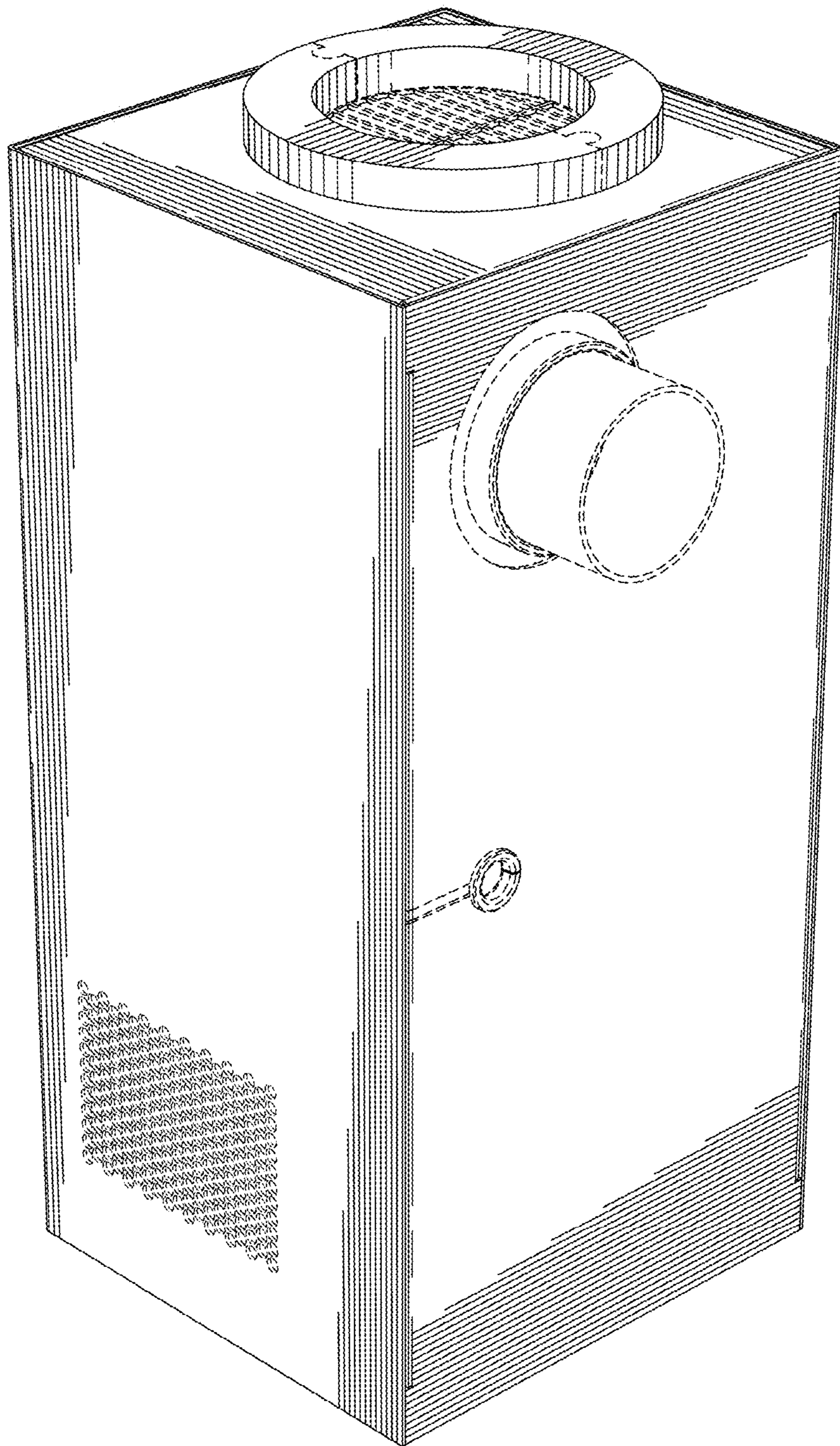

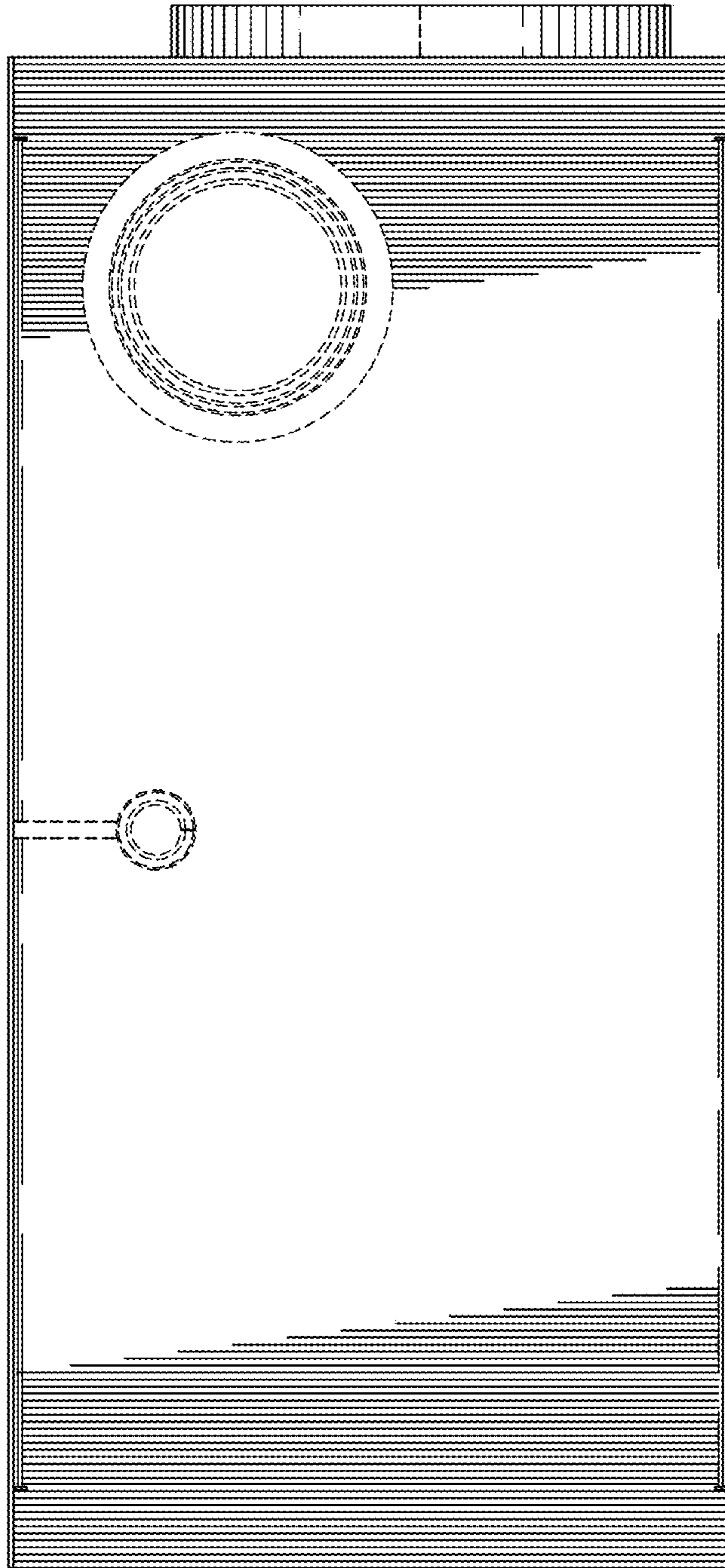

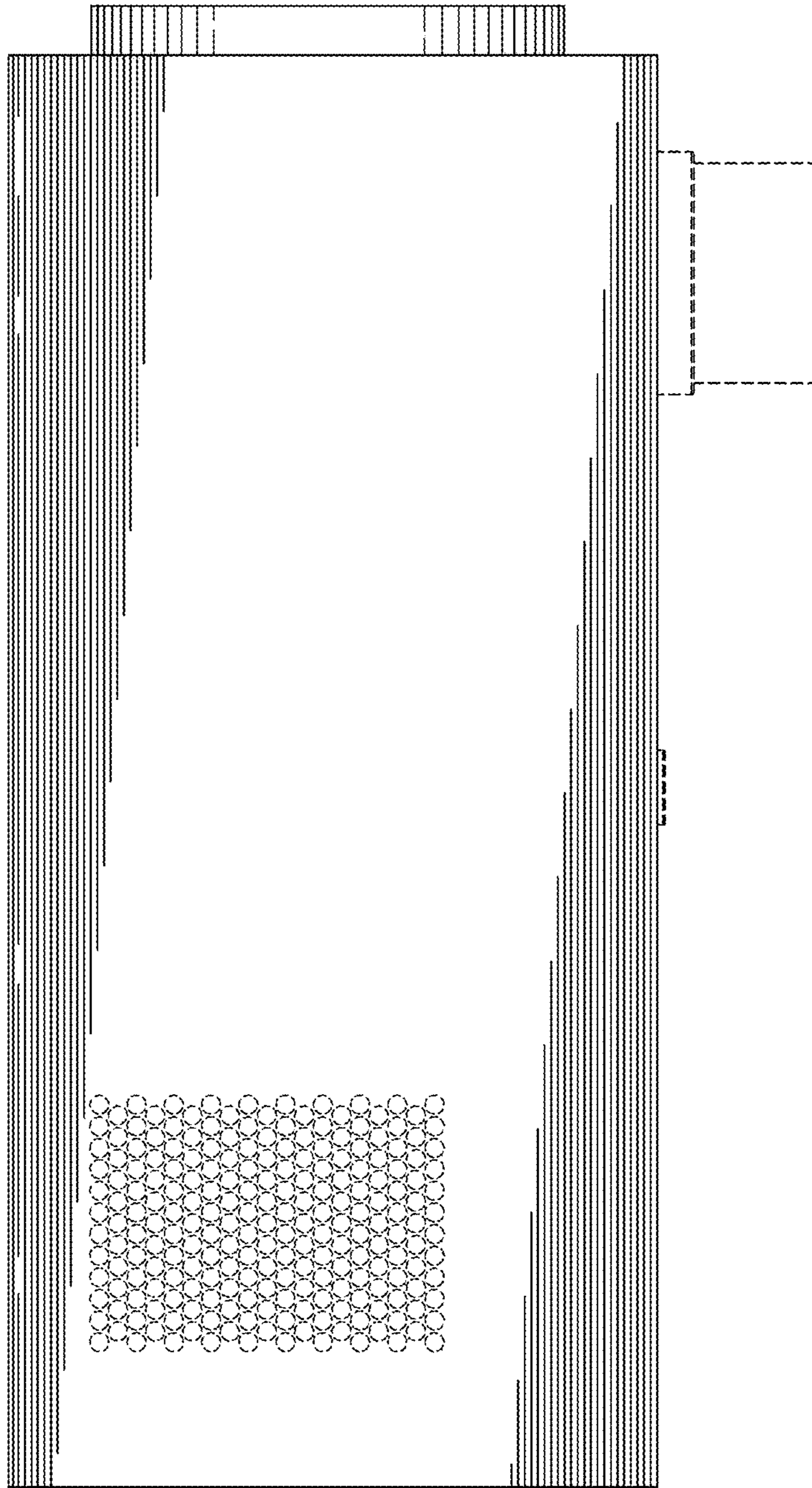

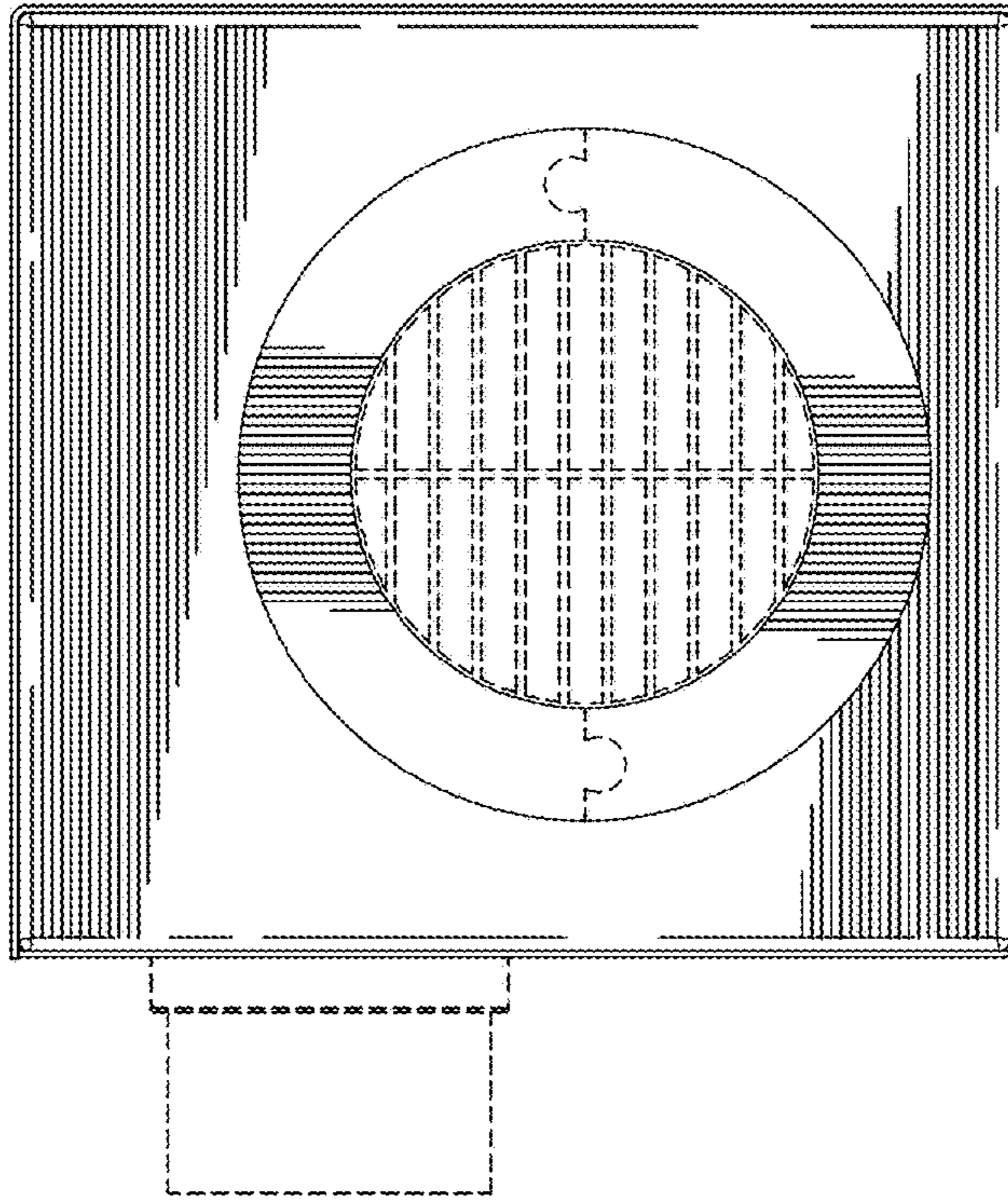

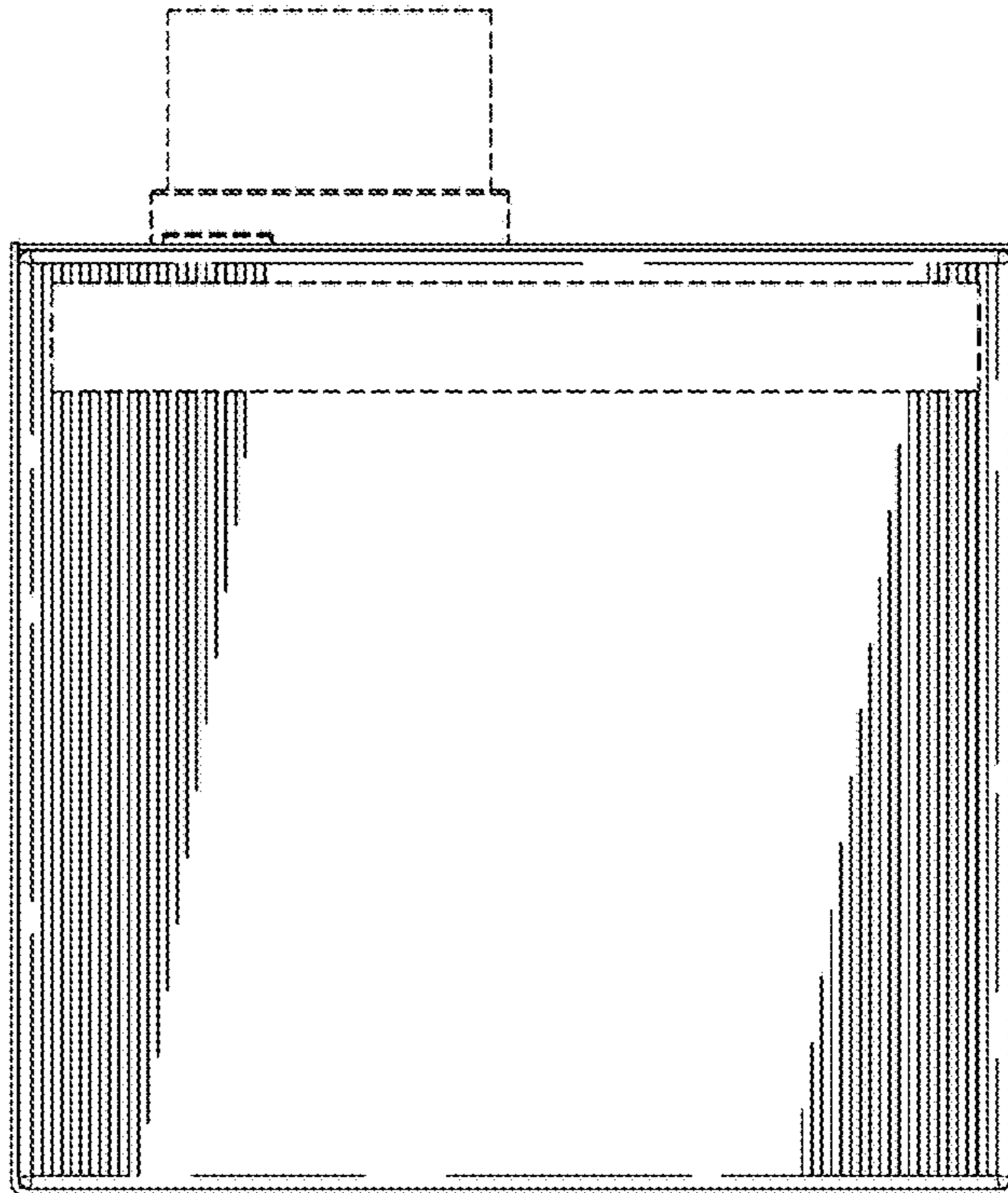

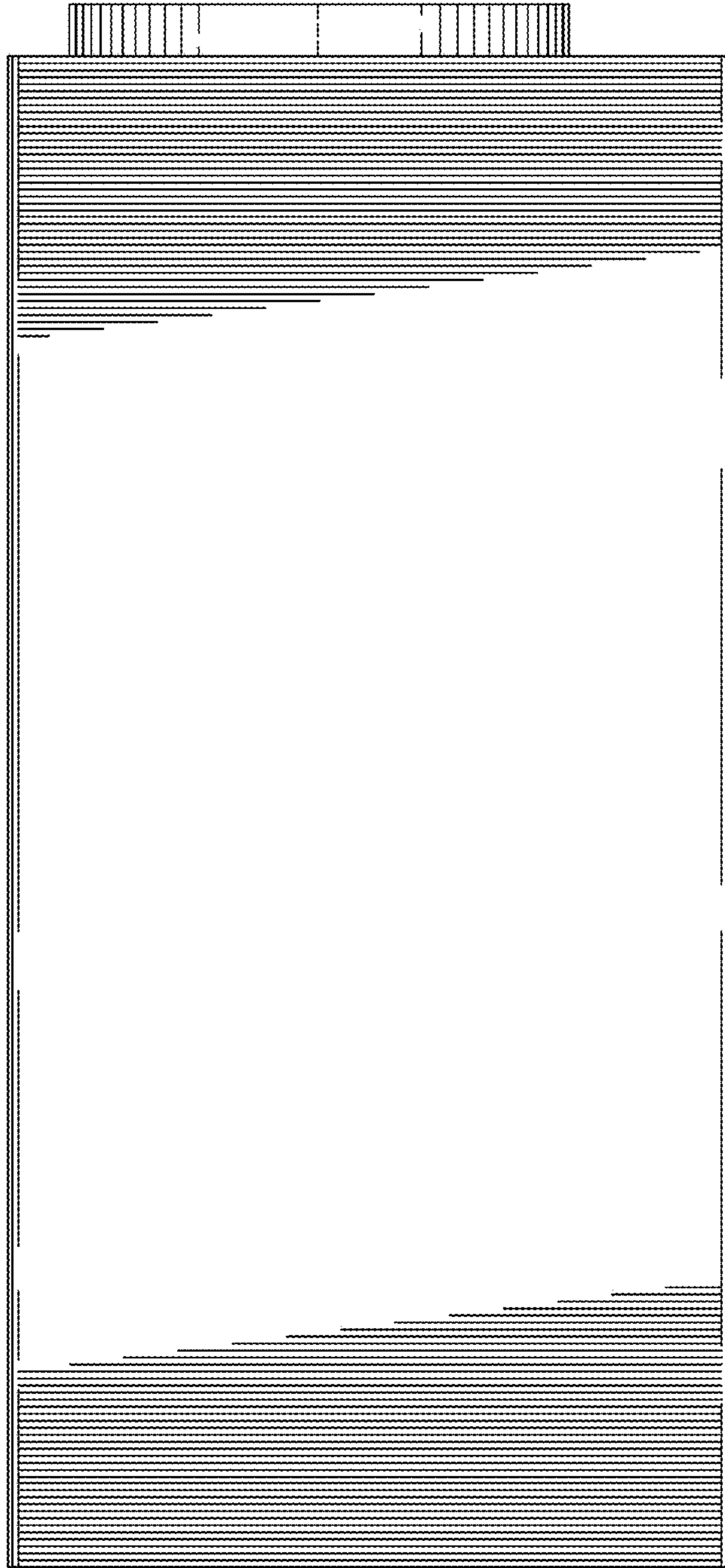
