1.4 : Perspective

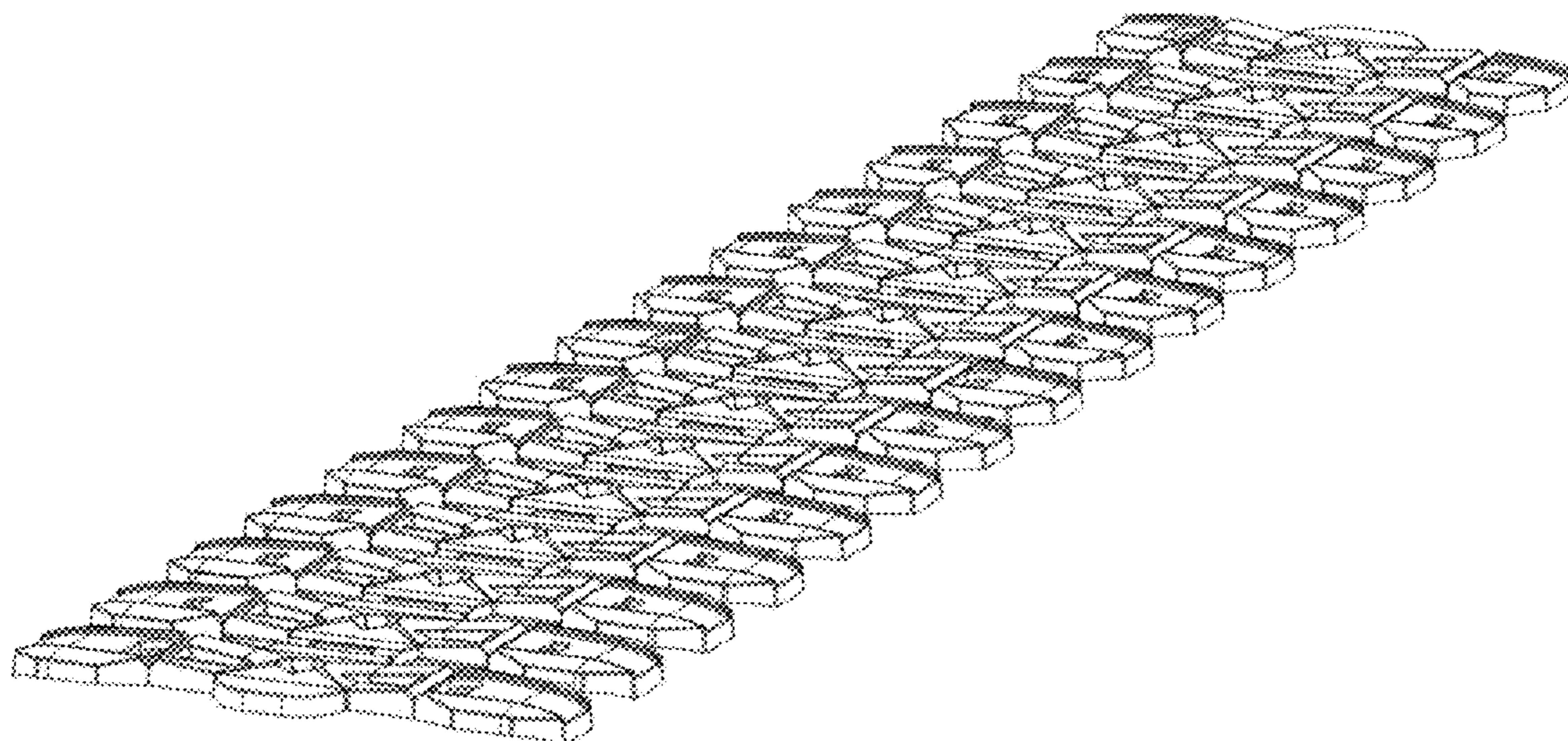
1.5 : Bottom

1.6 : Right

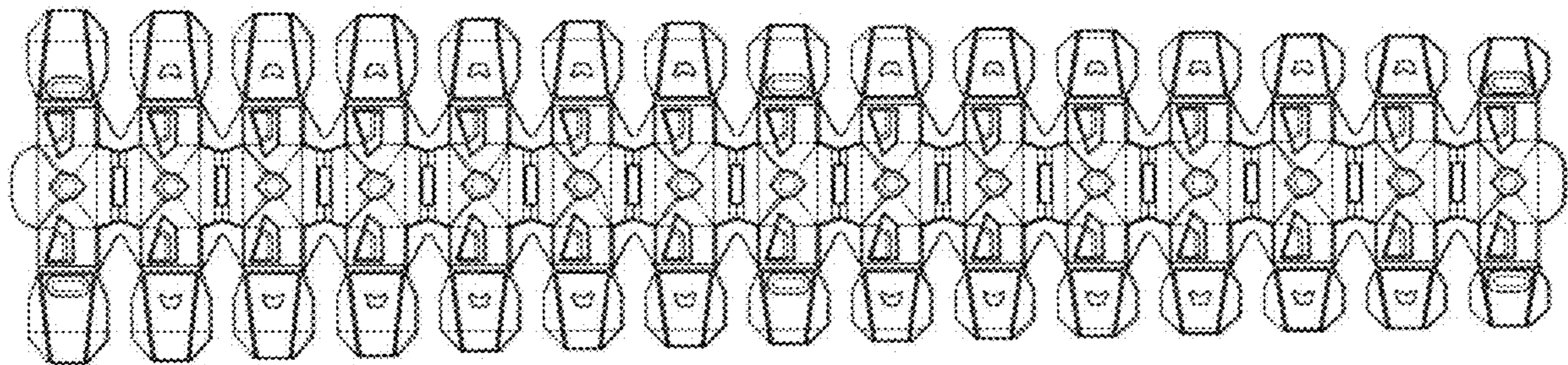
1.7 : Back

Views 1.2 and 1.7 are identical opposite views.

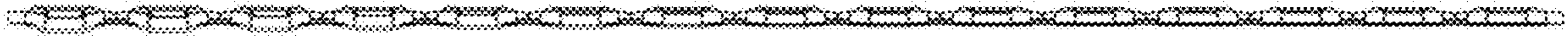

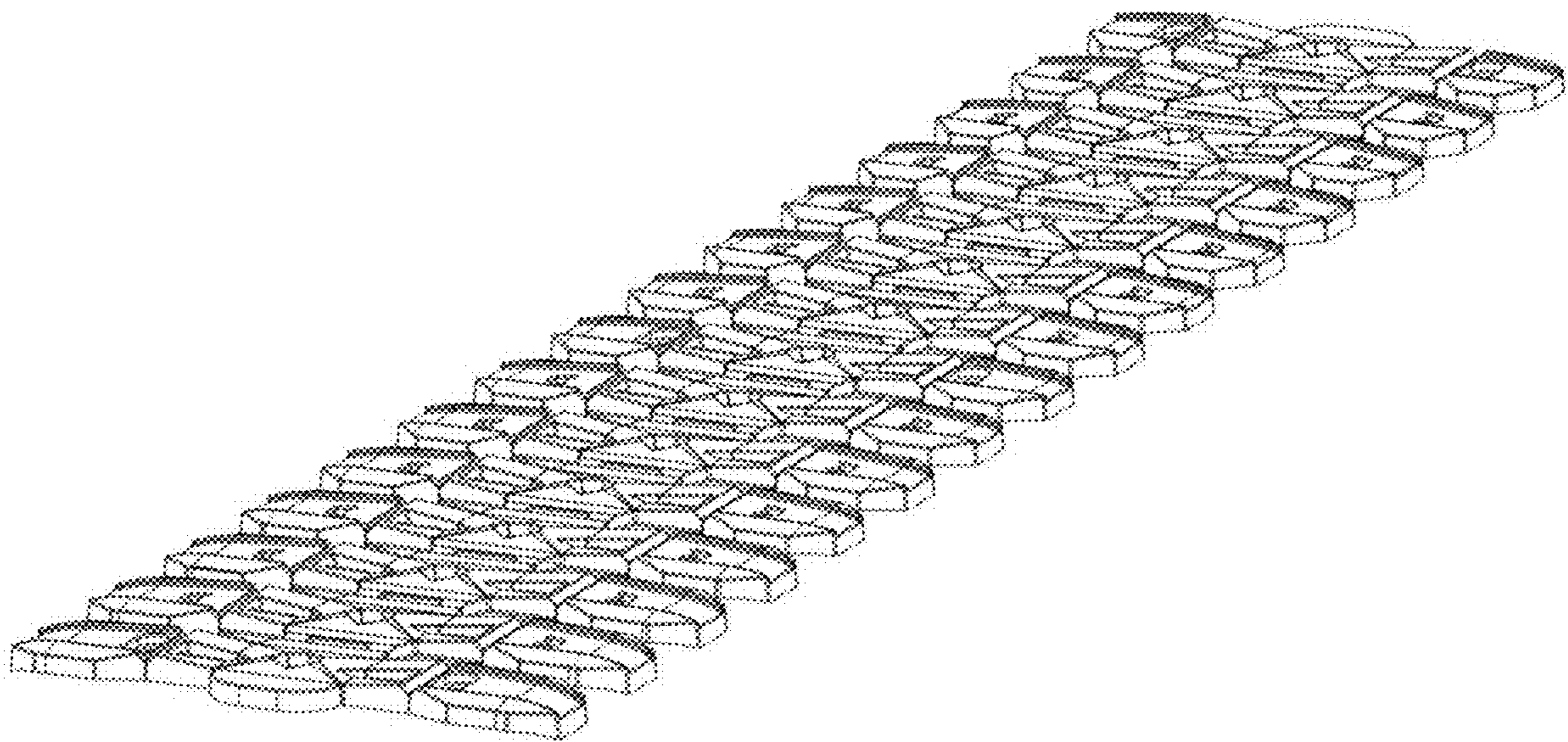

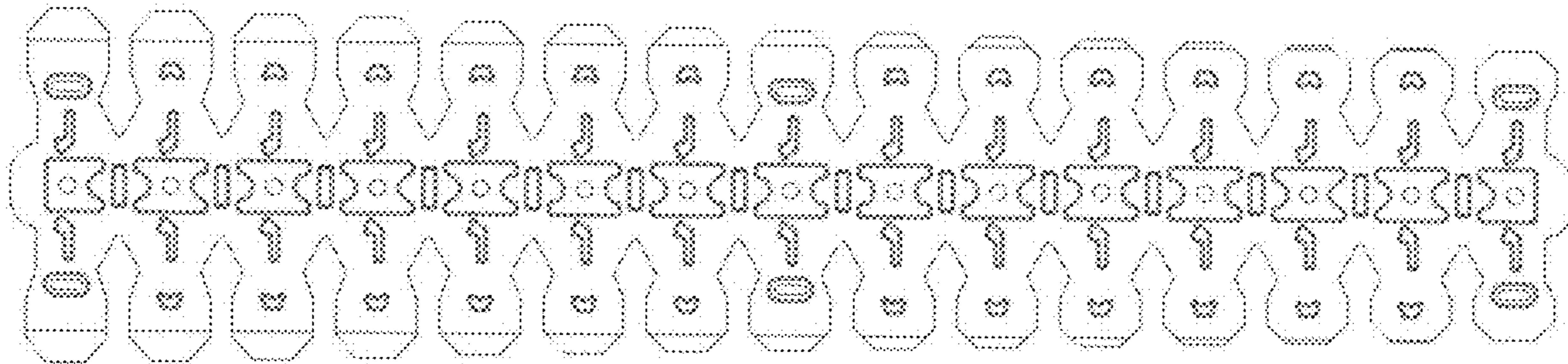

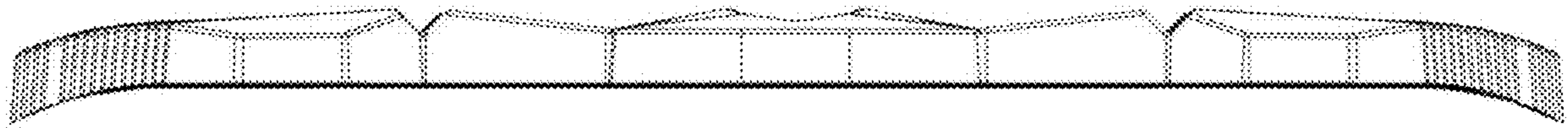
