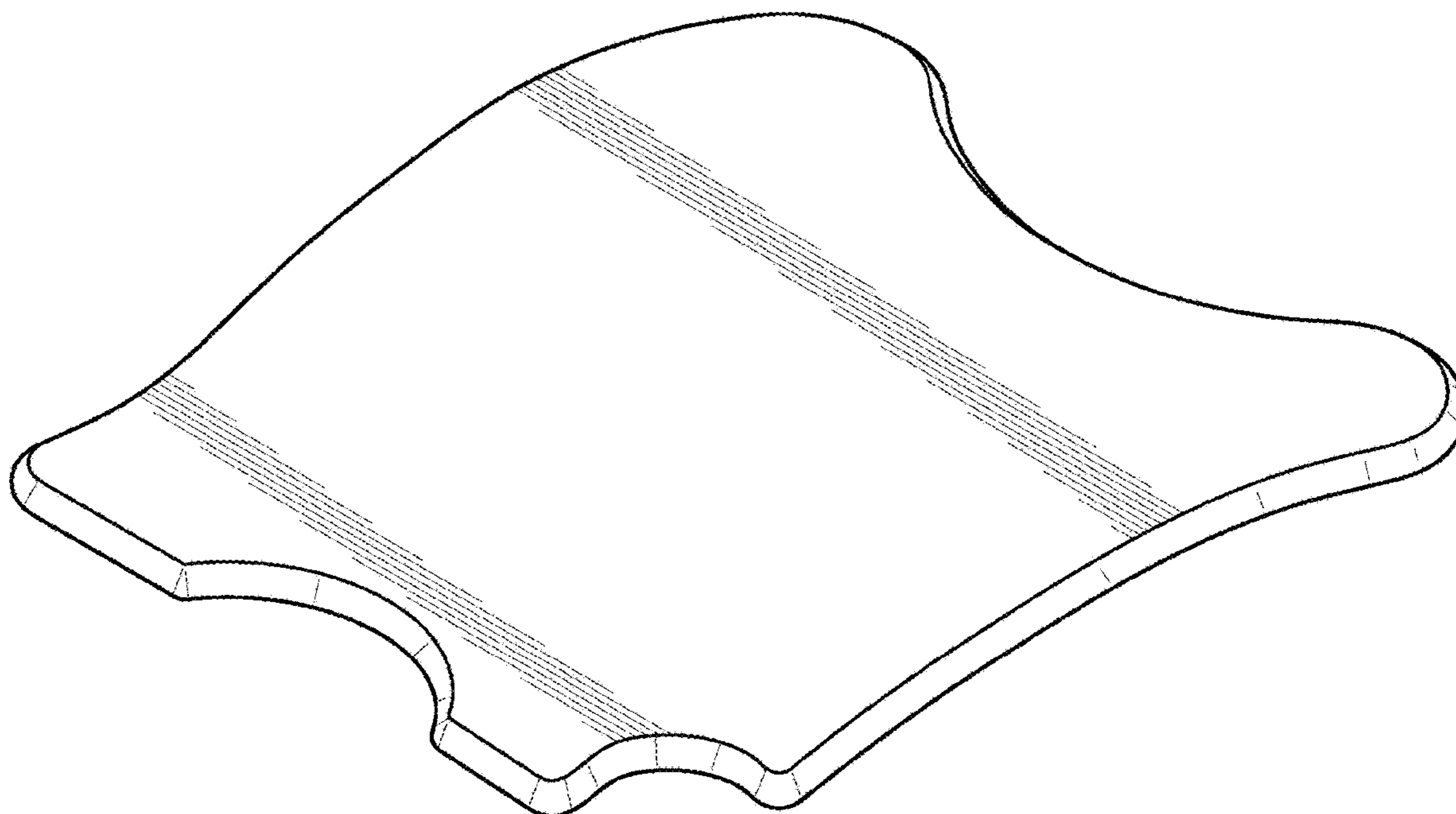

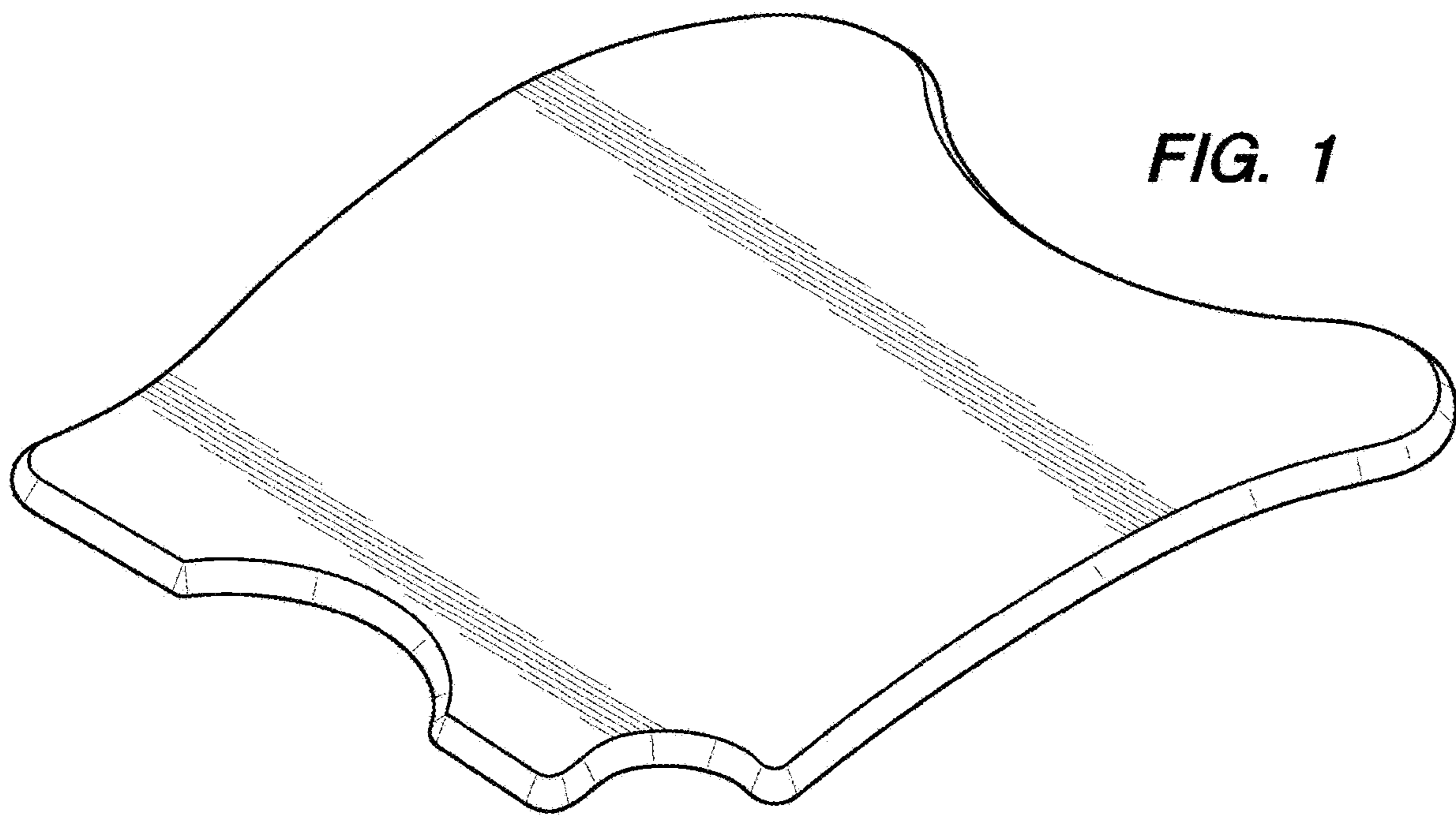
The ornamental design for a therapy blade, as shown and described.

**DESCRIPTION**

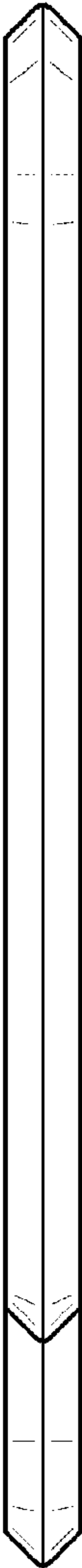
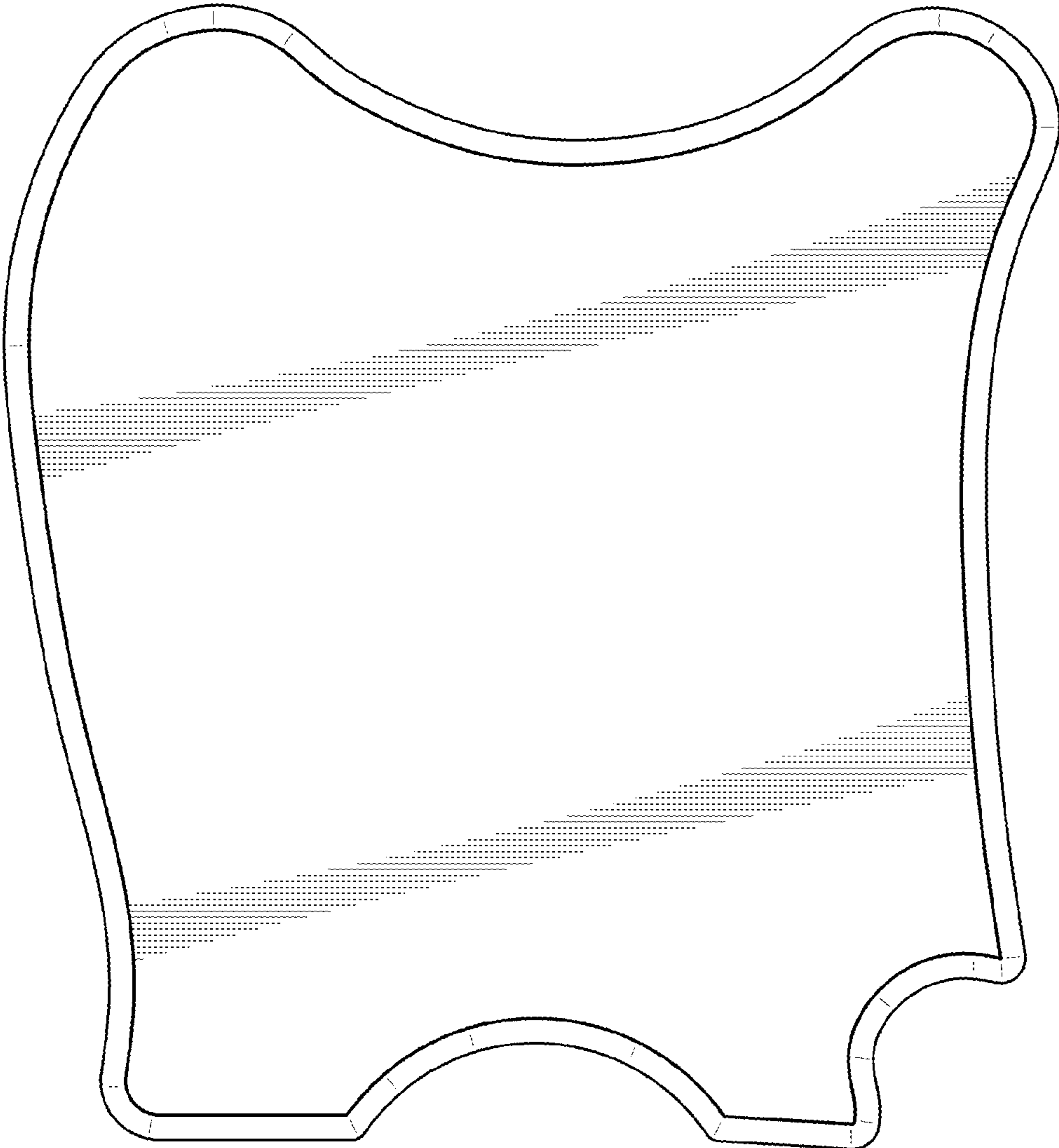
FIG. 1 is a perspective view of a therapy blade;

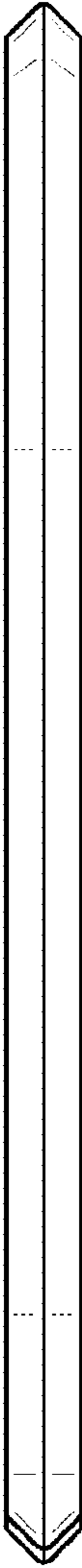
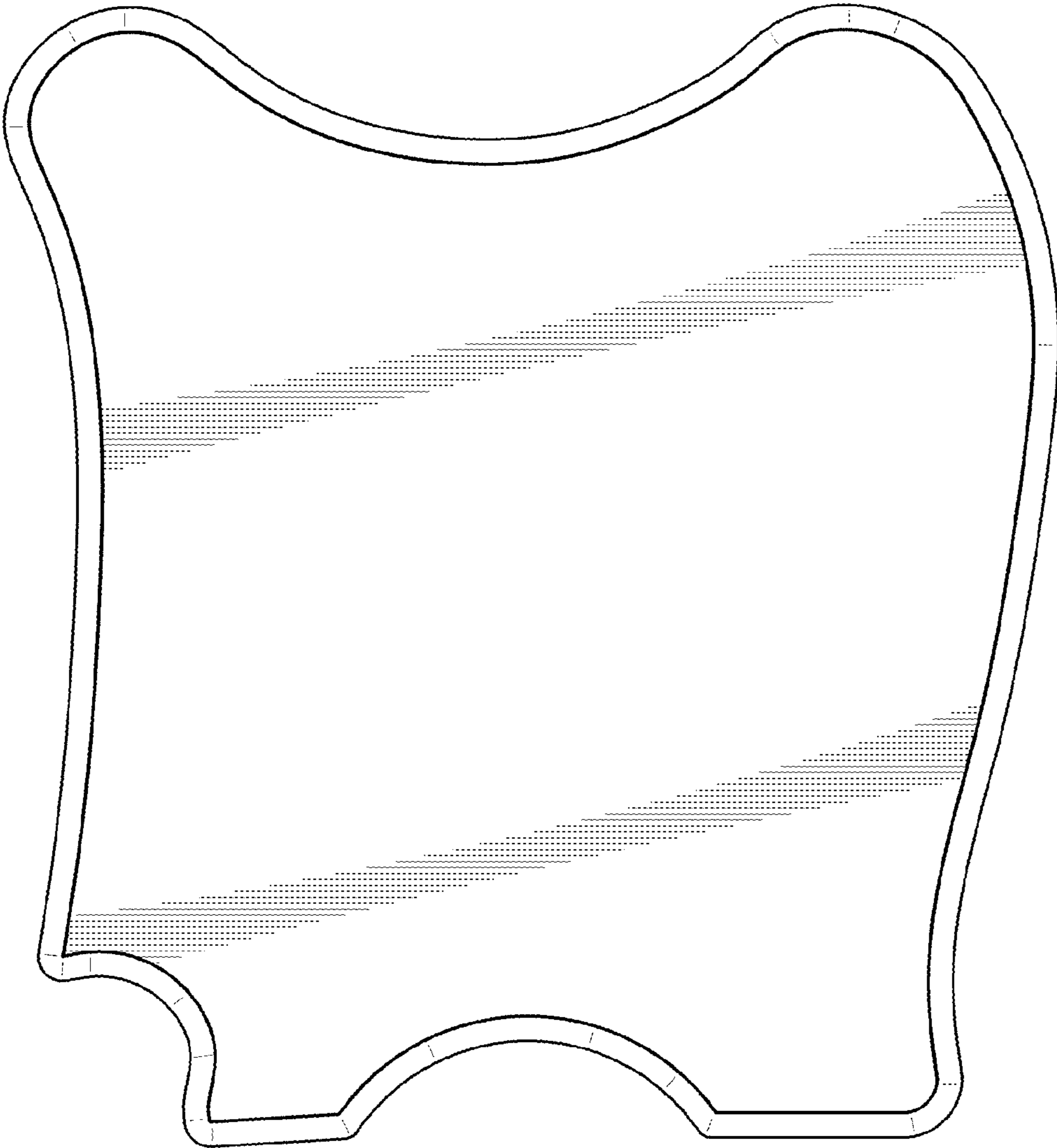

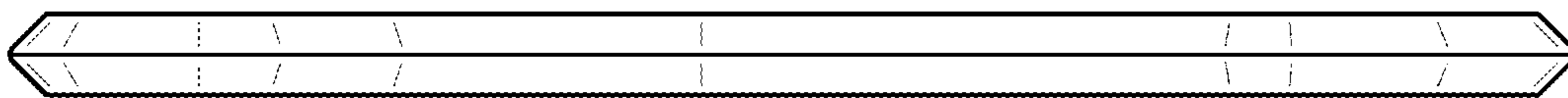
