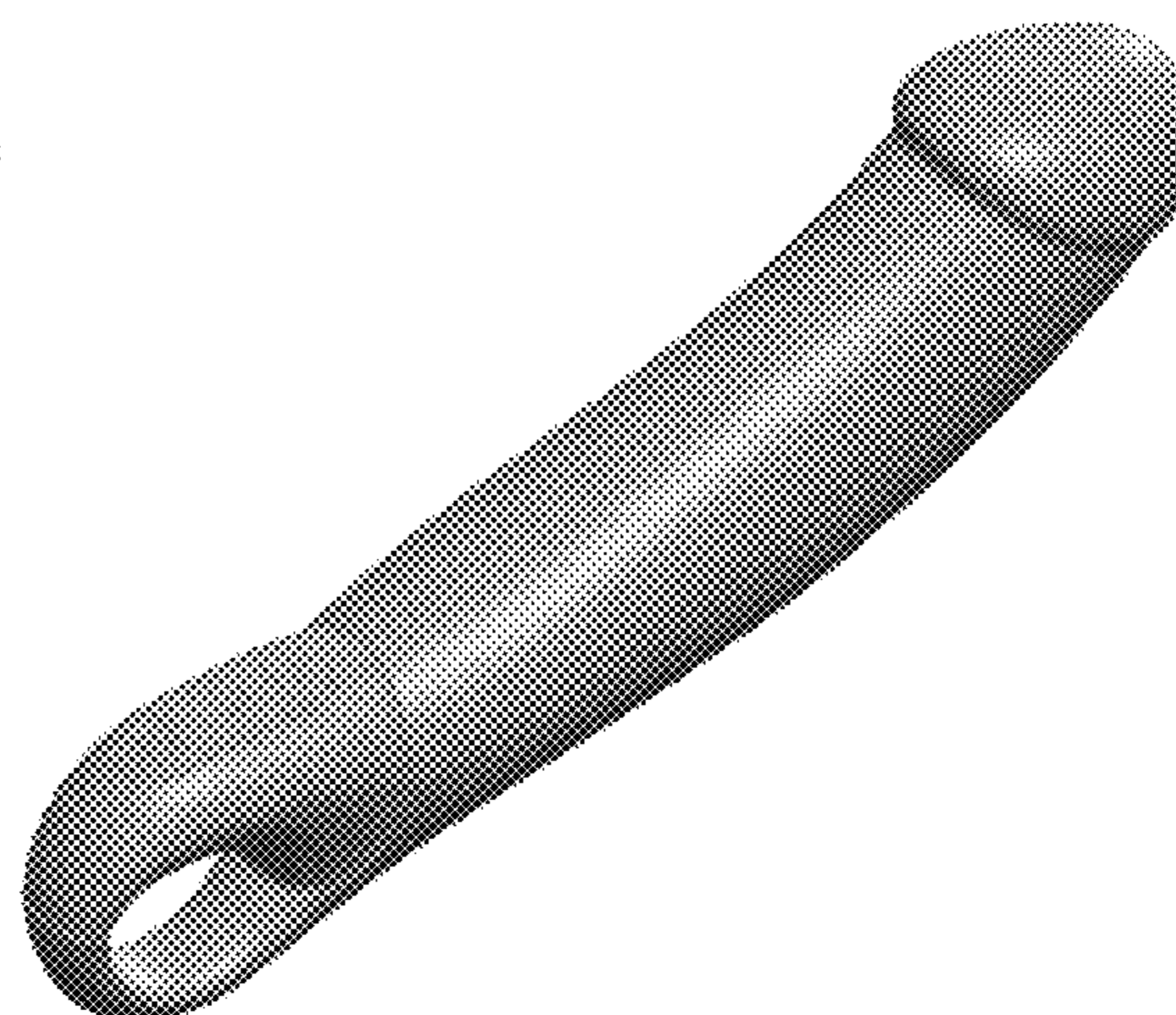
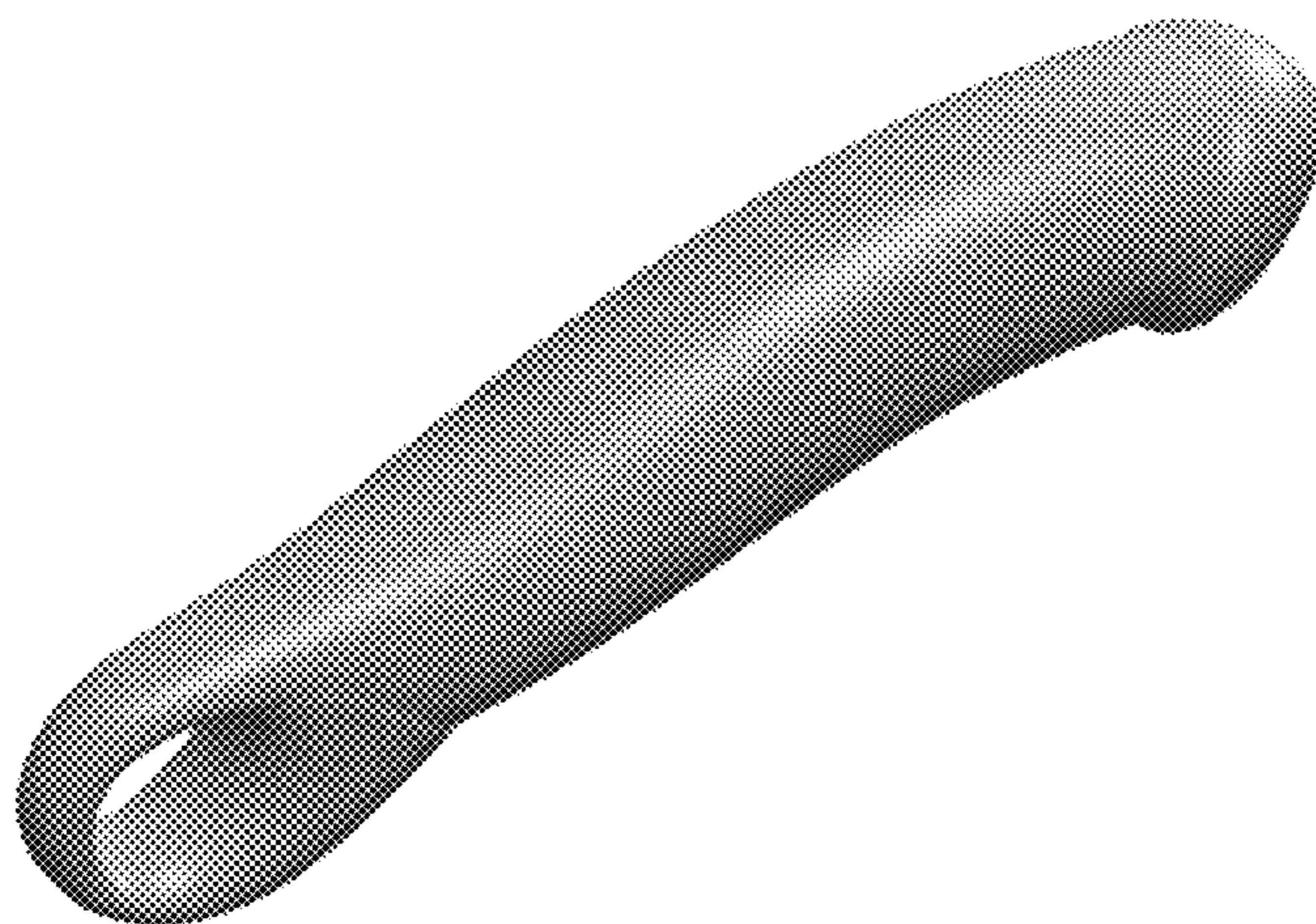

The ornamental design for sex toy, as shown and described.

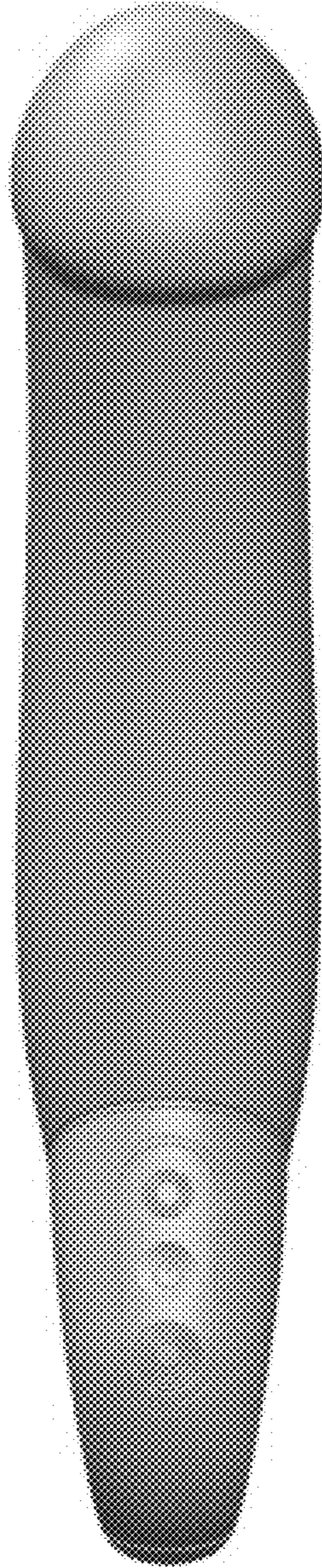

Figure 49.5 is another perspective view thereof.

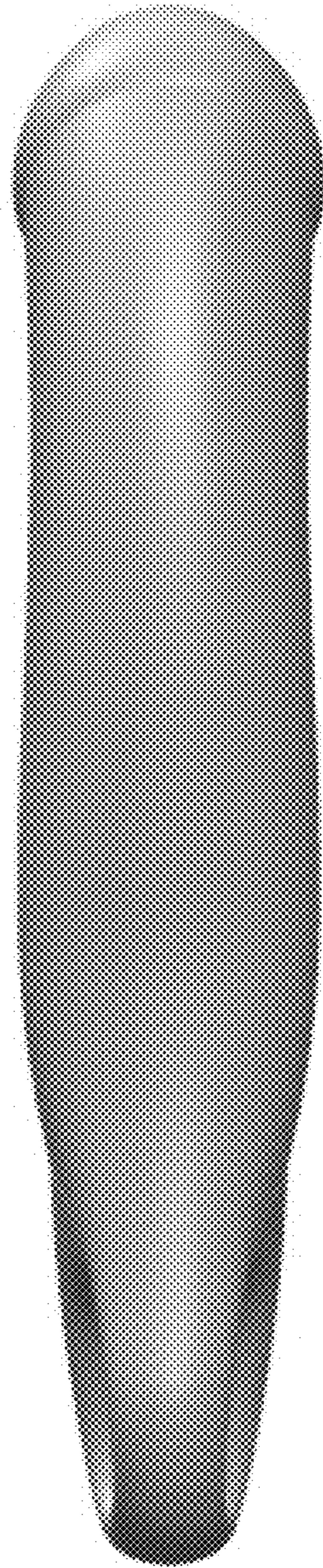

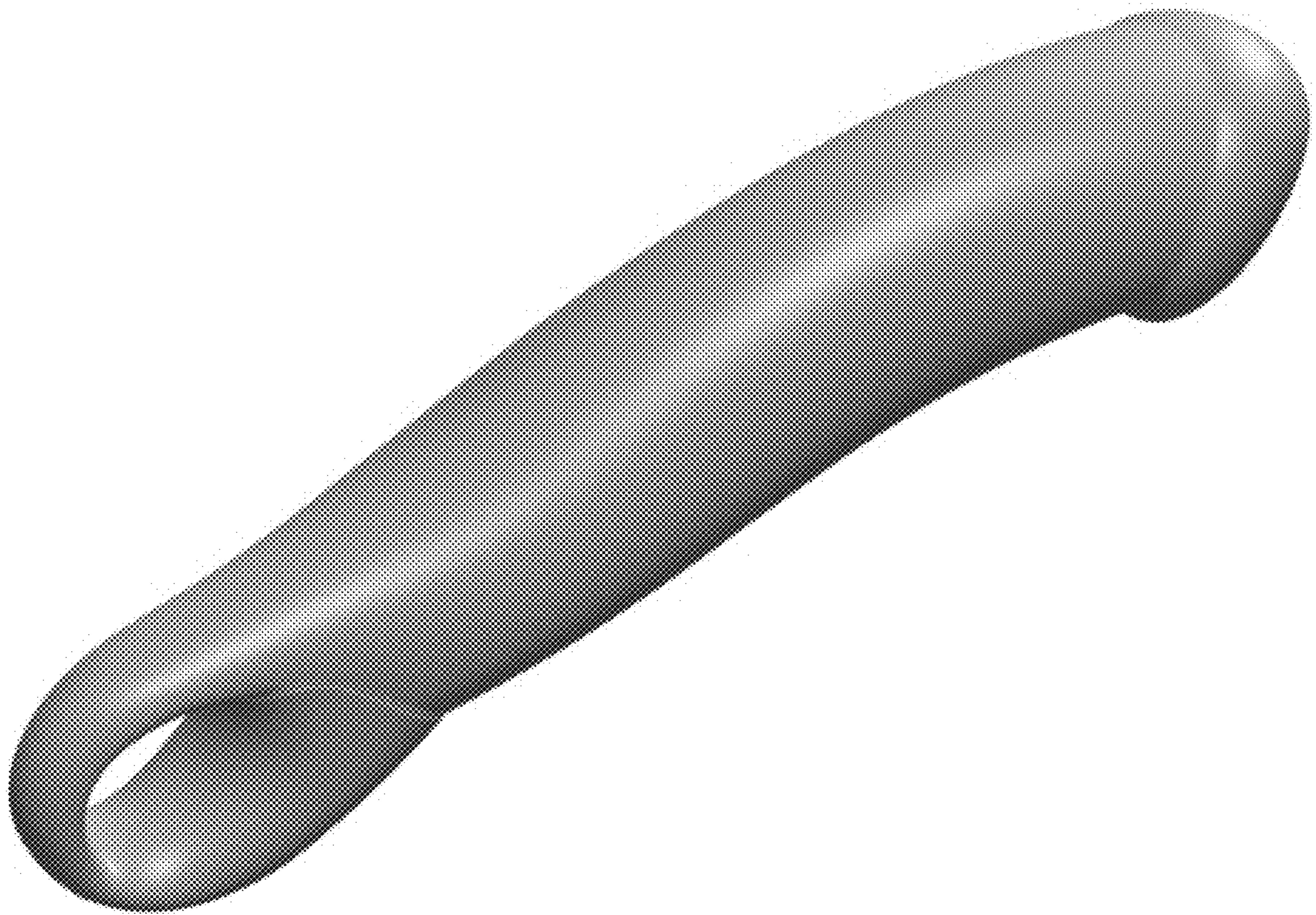

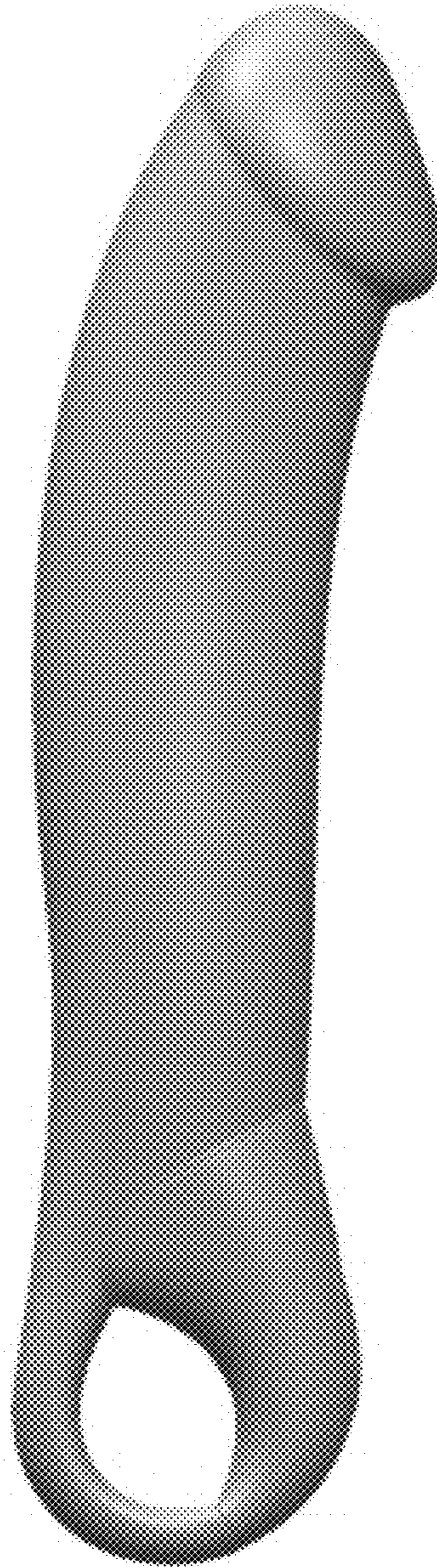

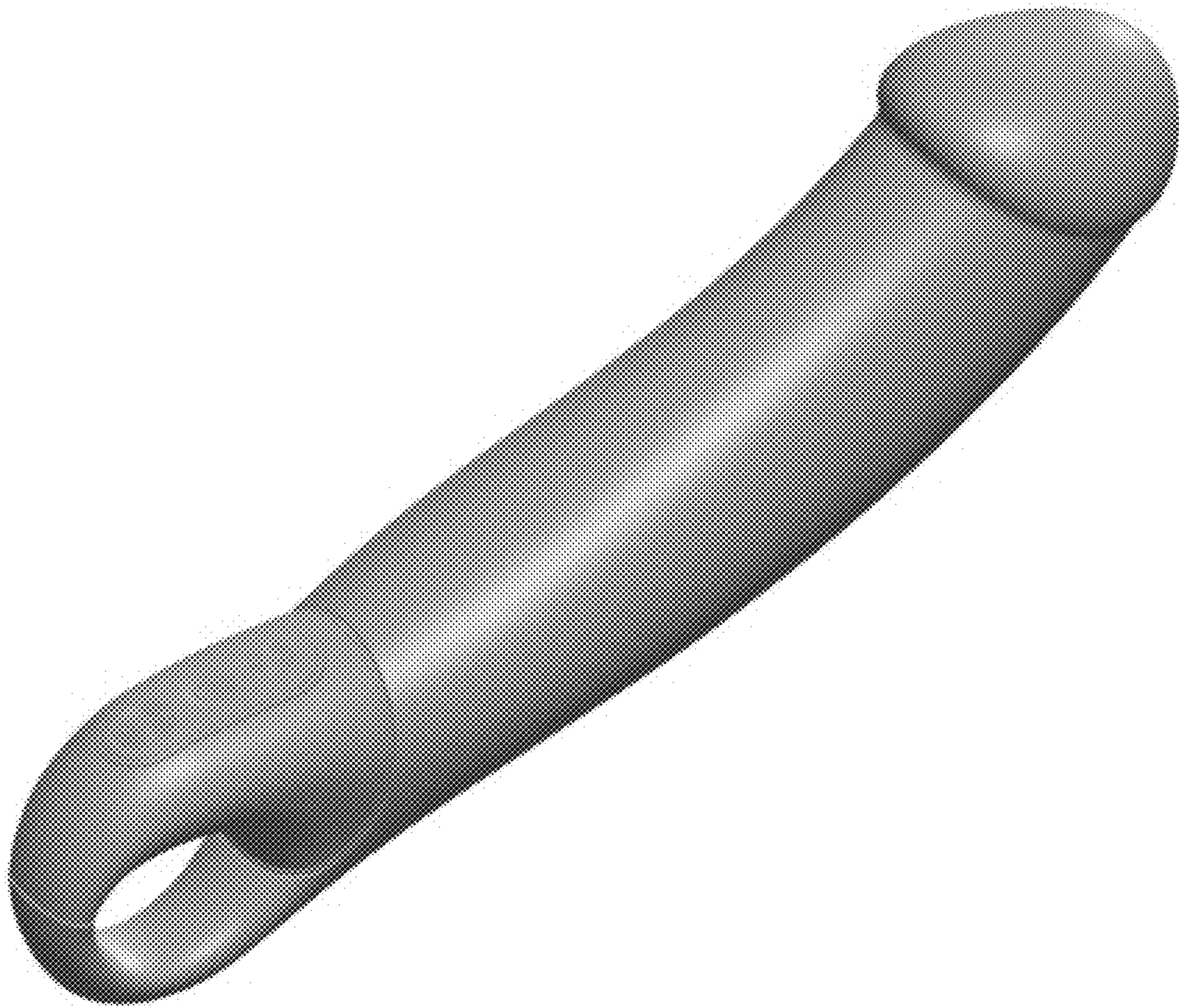

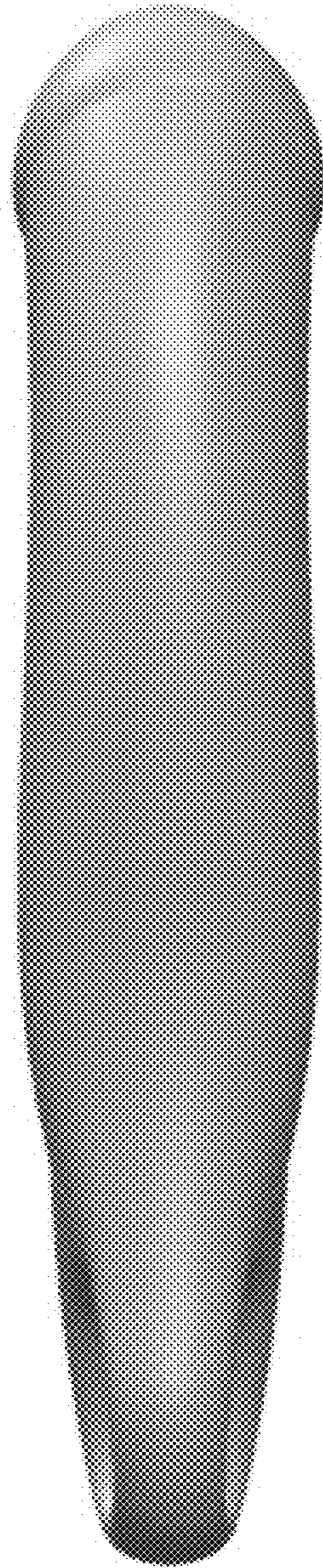

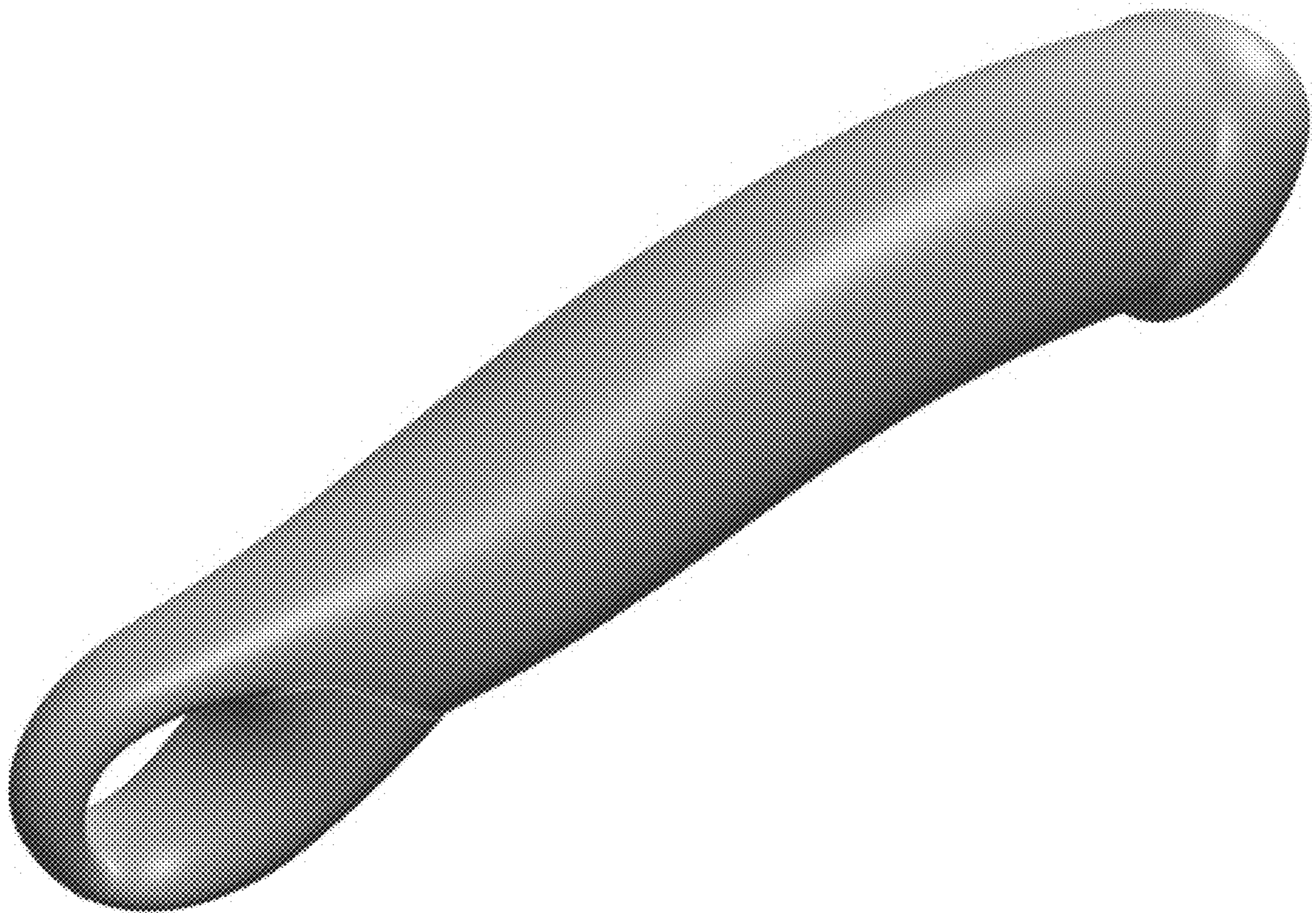

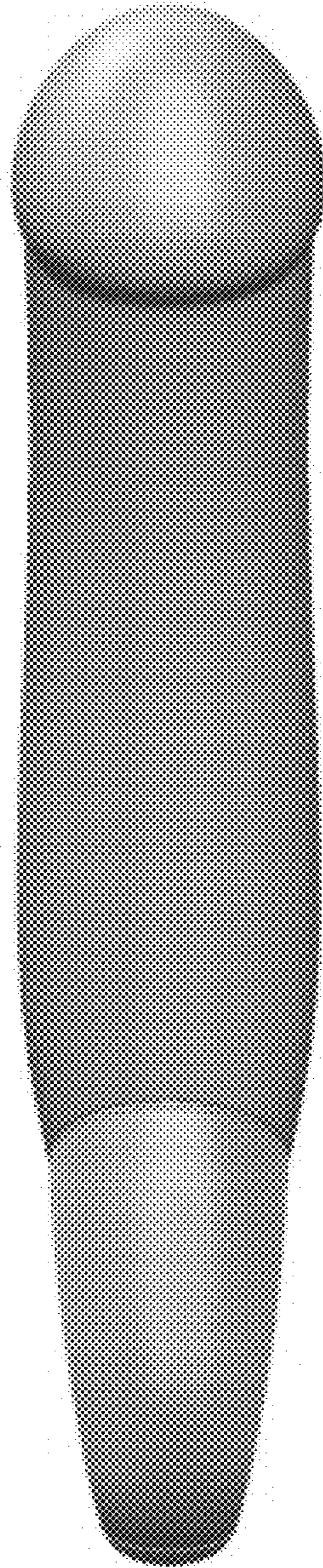

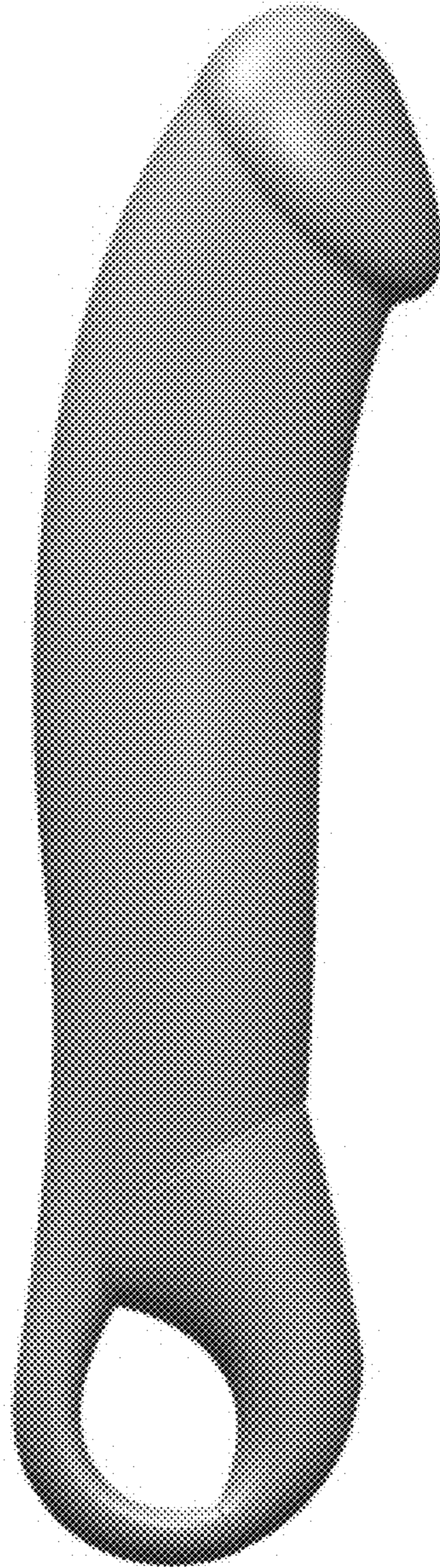
