in FIG. 1;

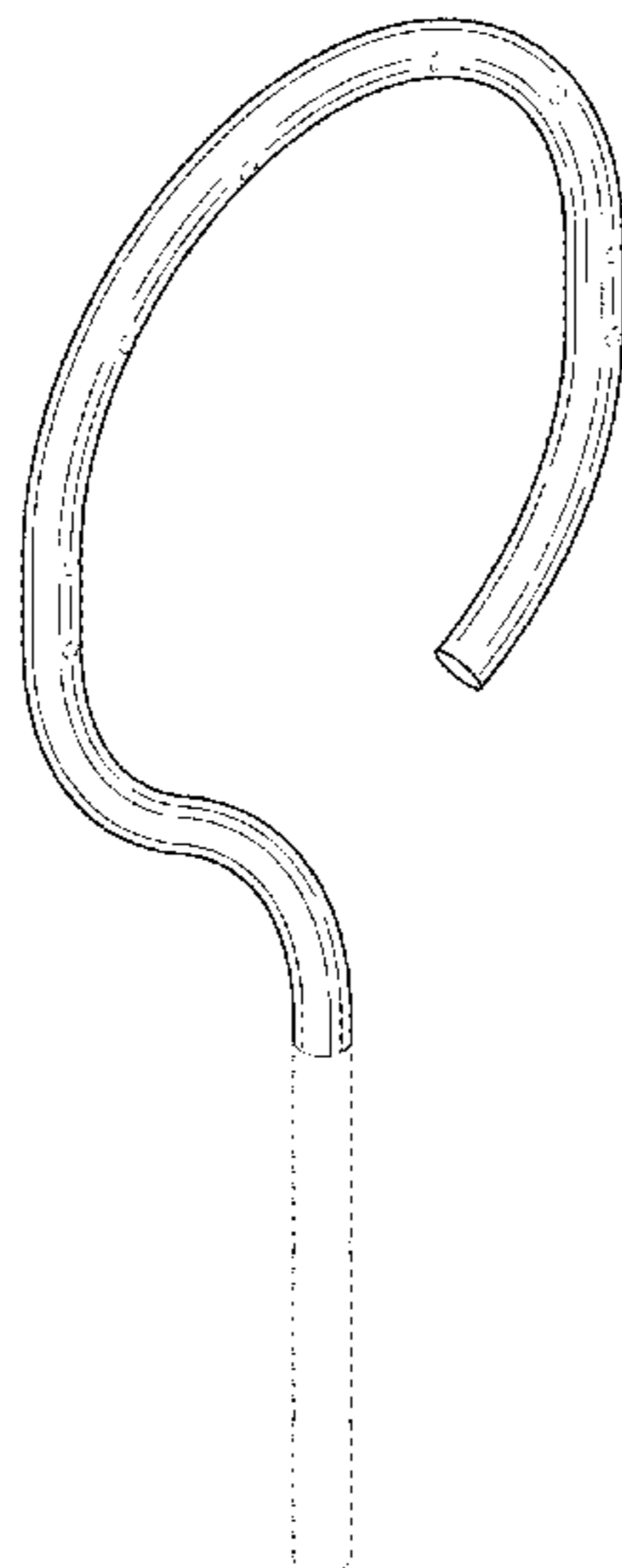
FIG. 6 is a right side elevation view of the trellis illustrated

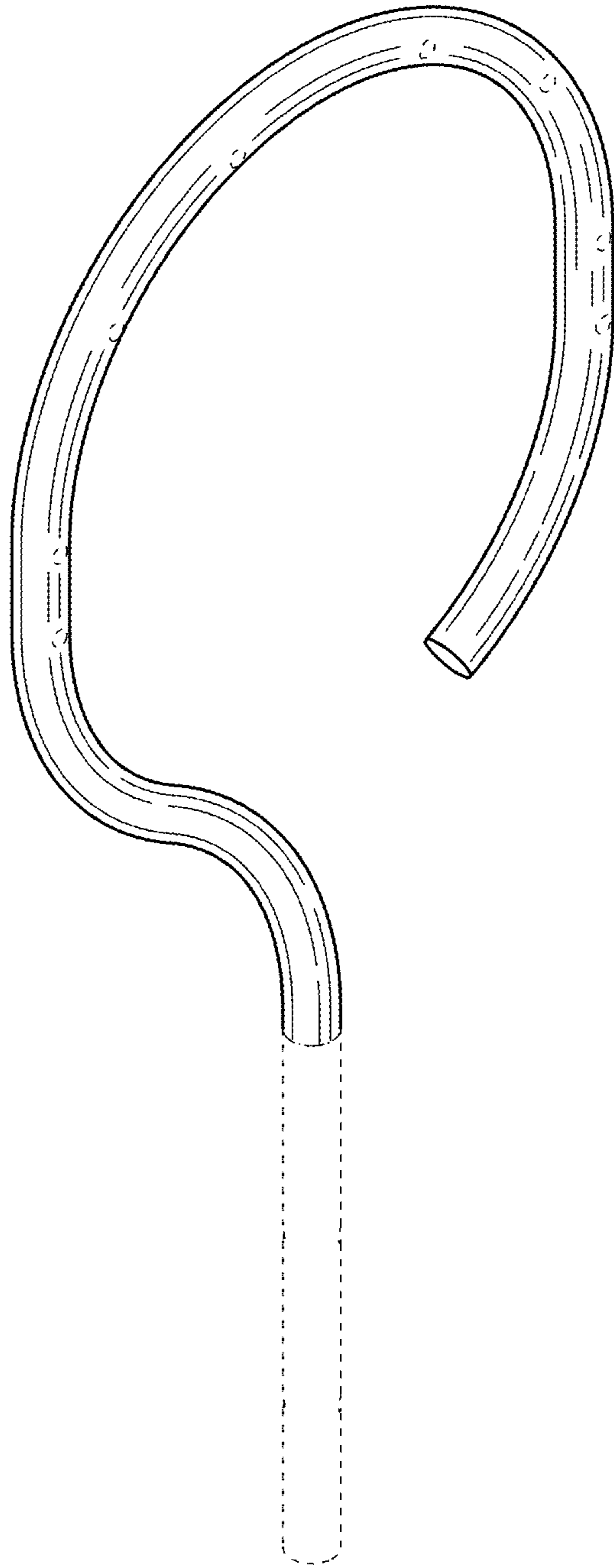

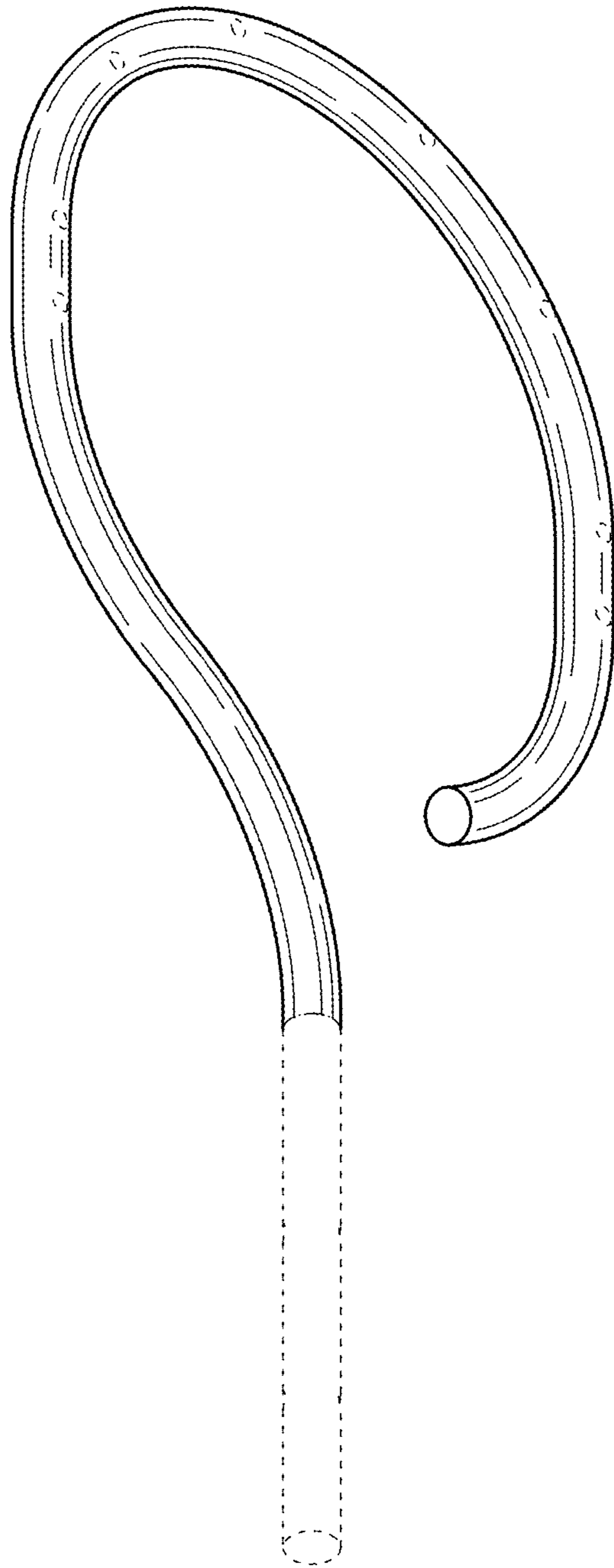

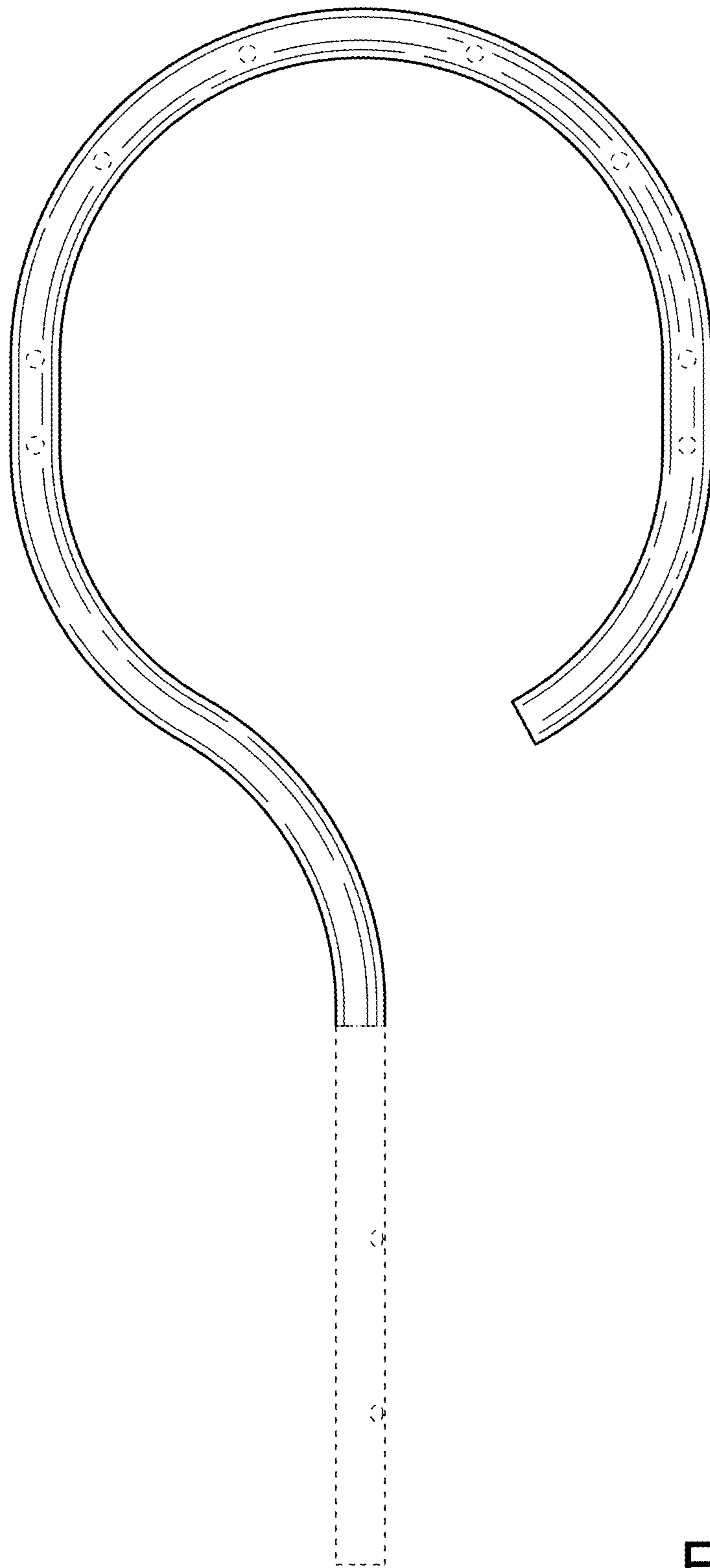

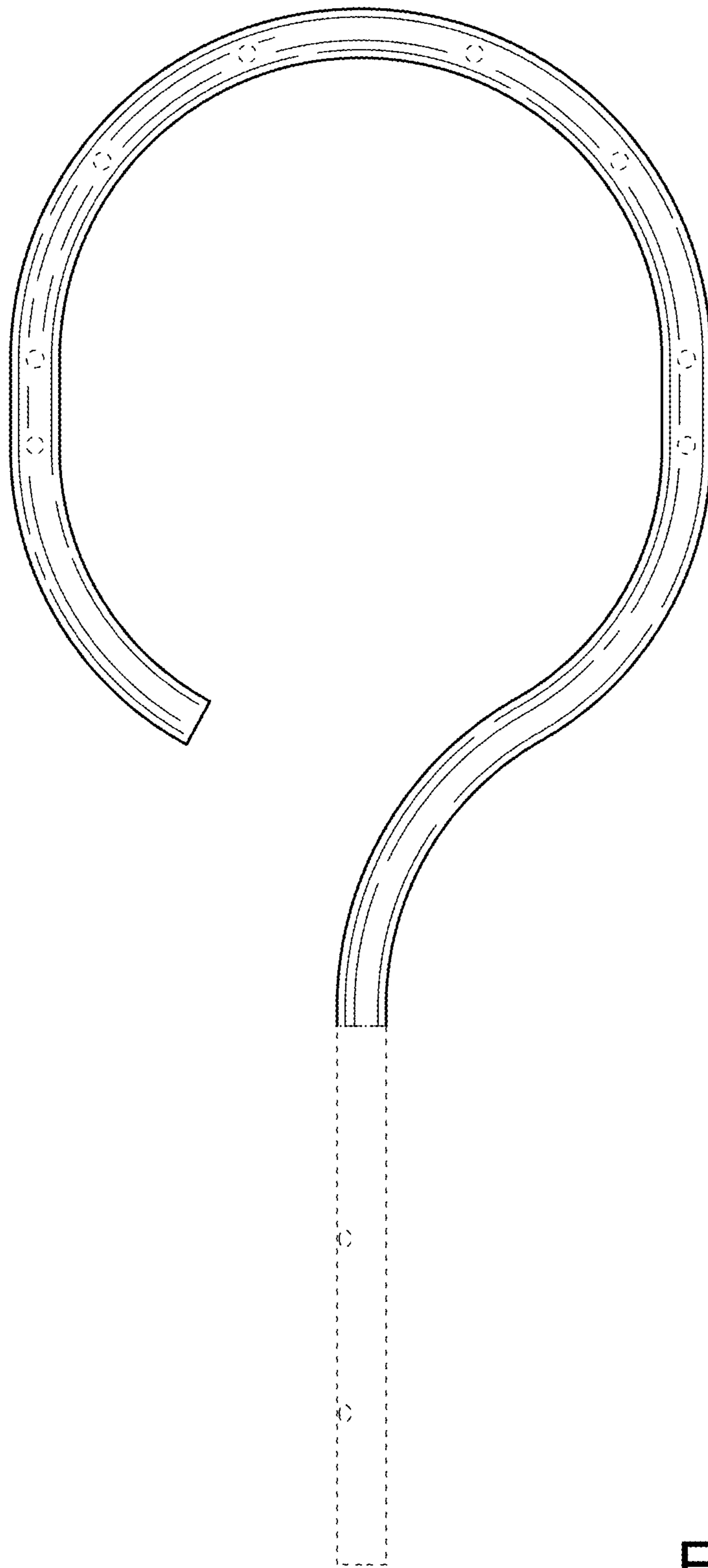

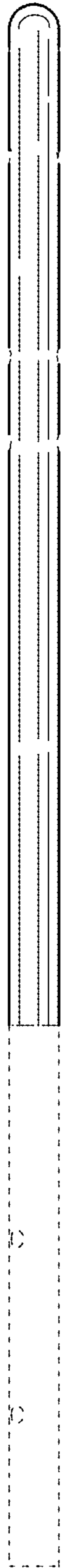
