DESCRIPTION

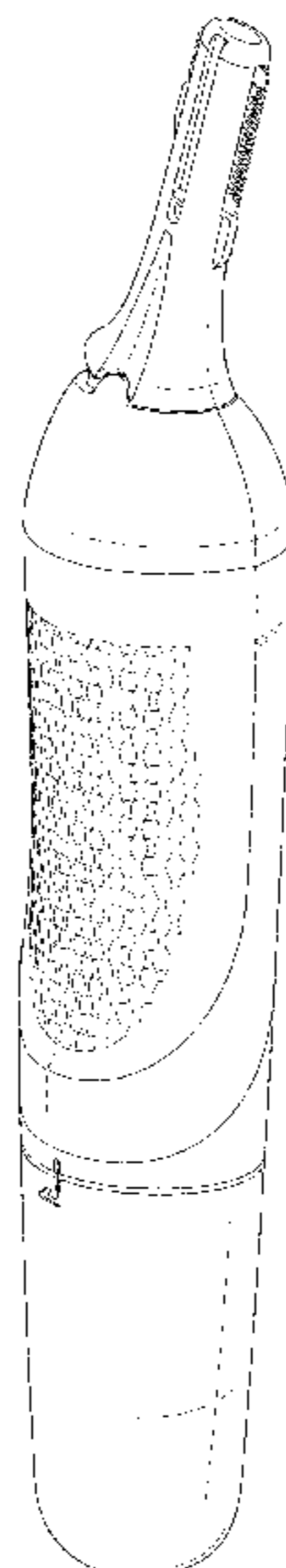
FIG. 1 is a perspective view of the hair trimmer device showing our new design;

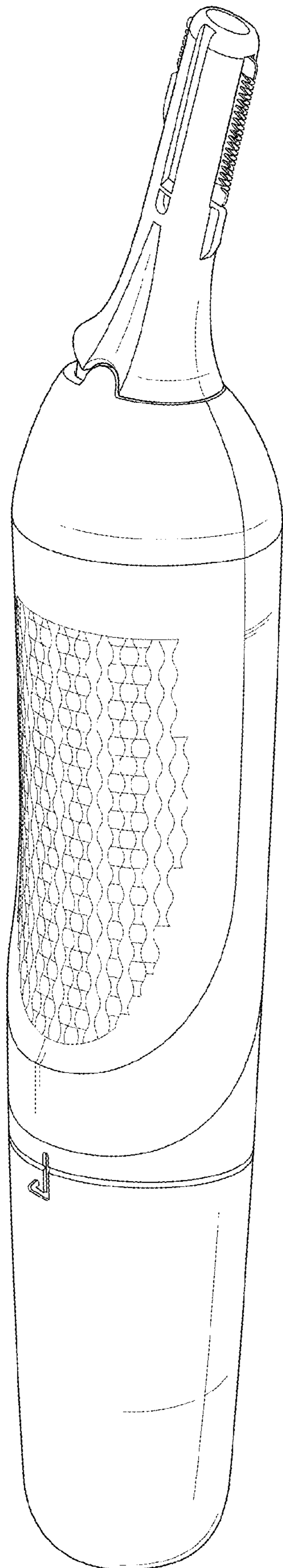

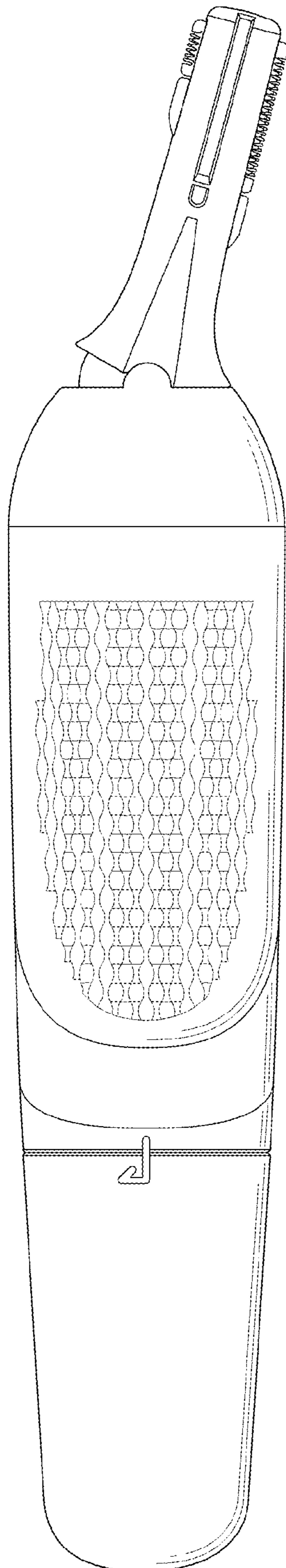

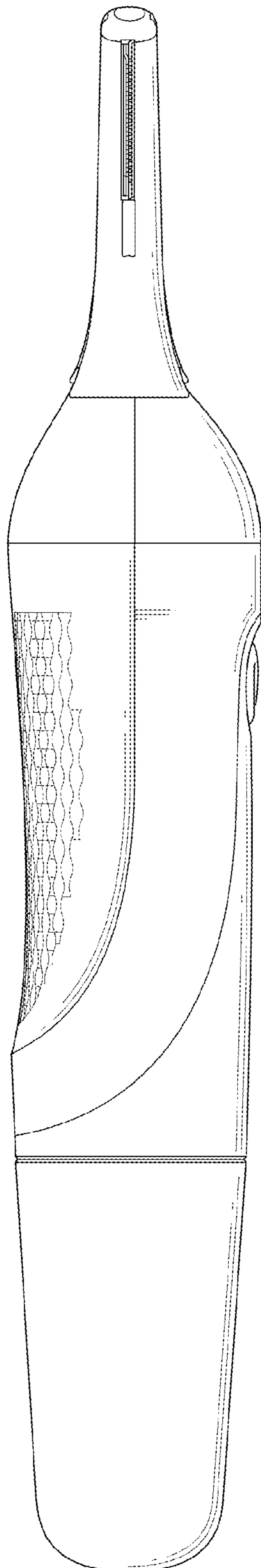

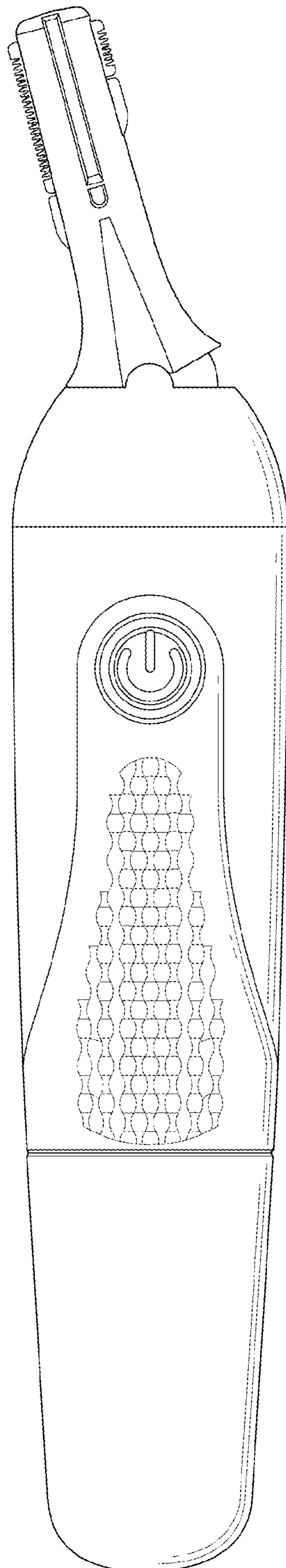

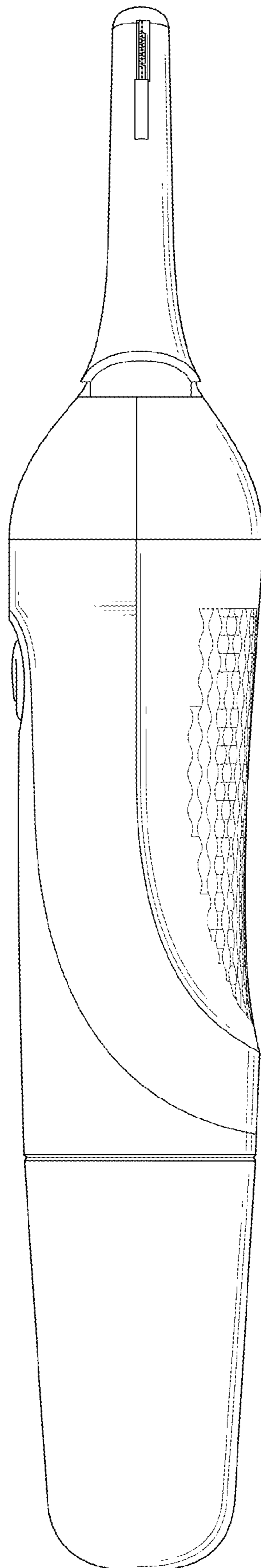

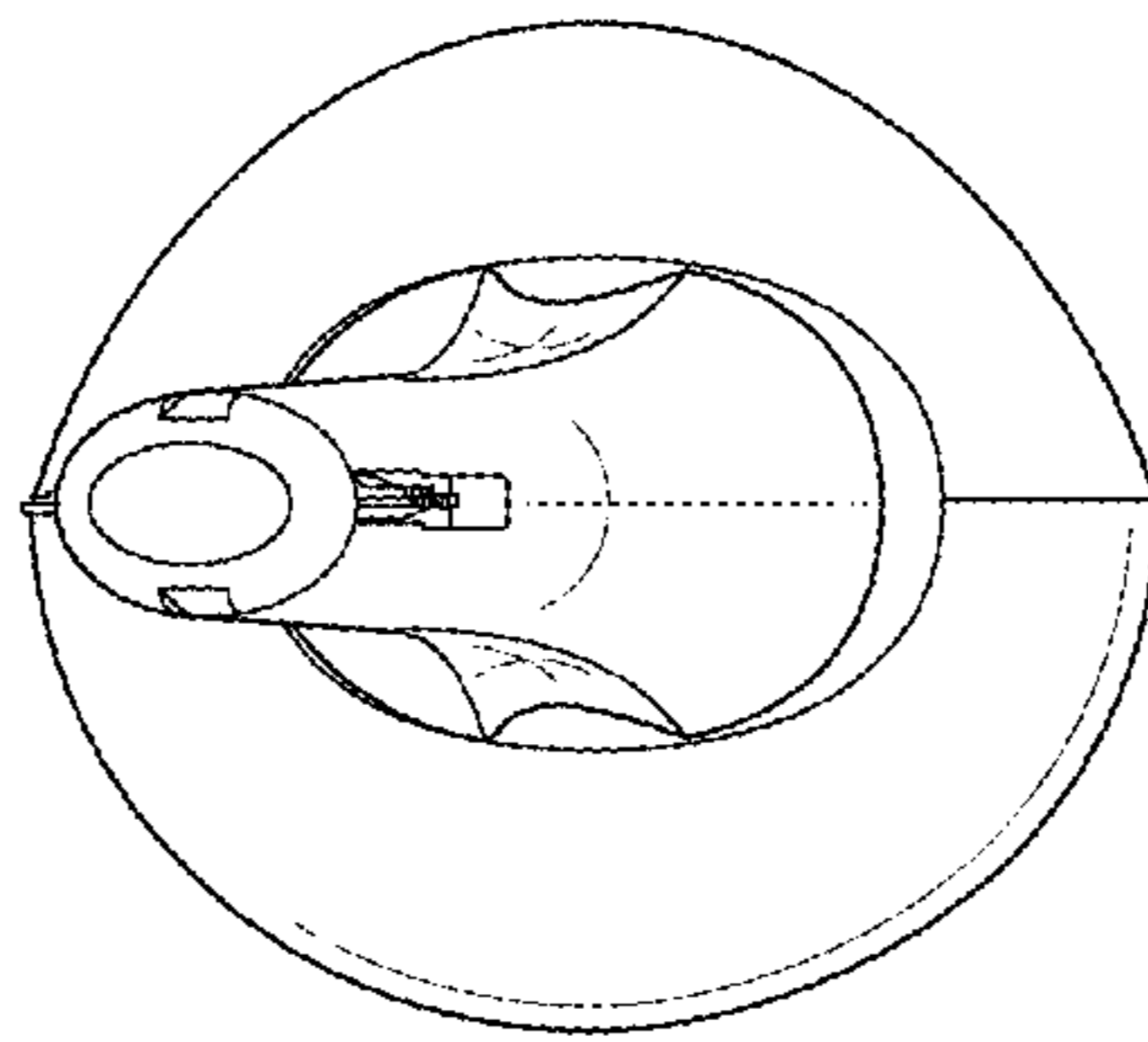

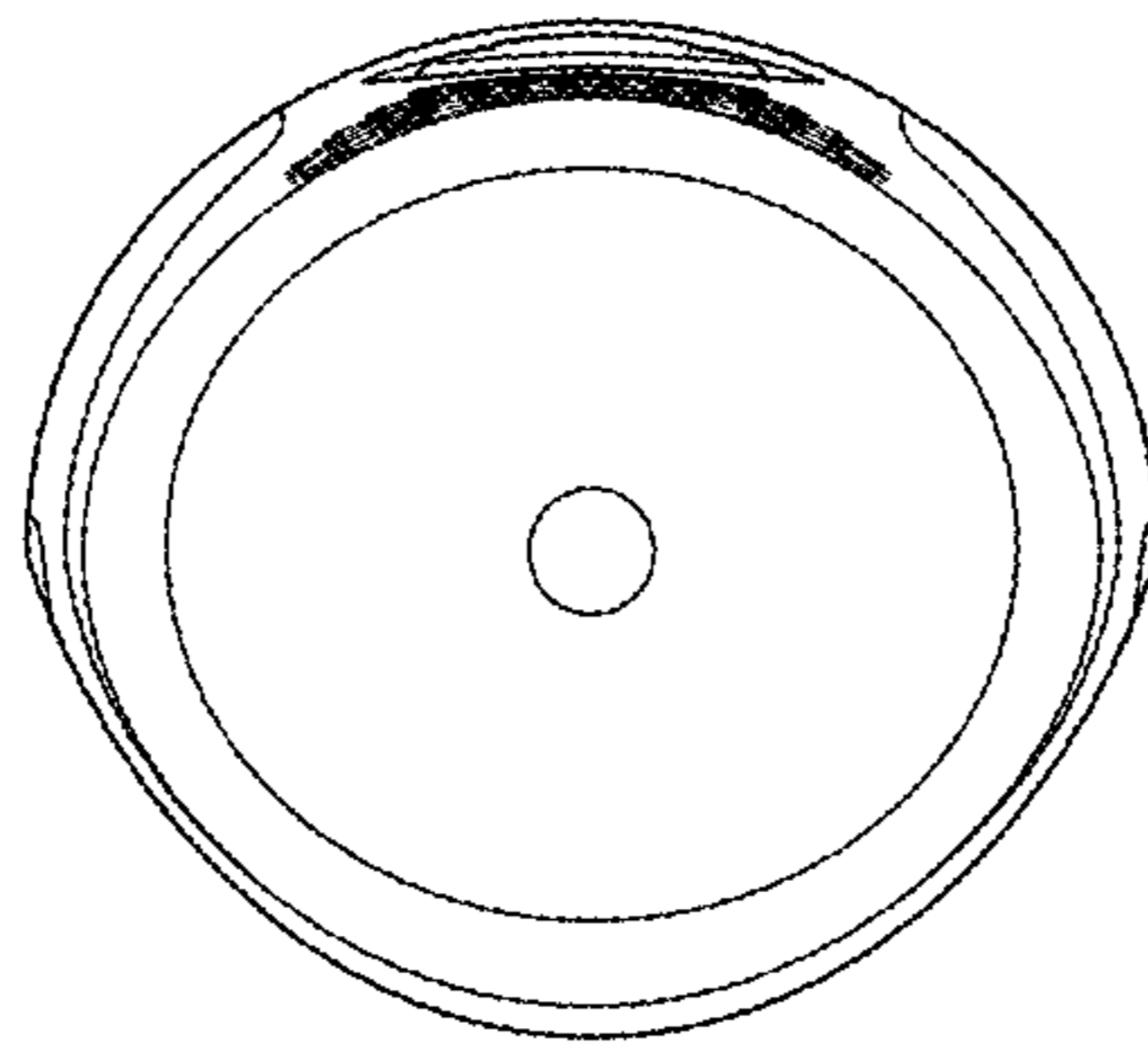
