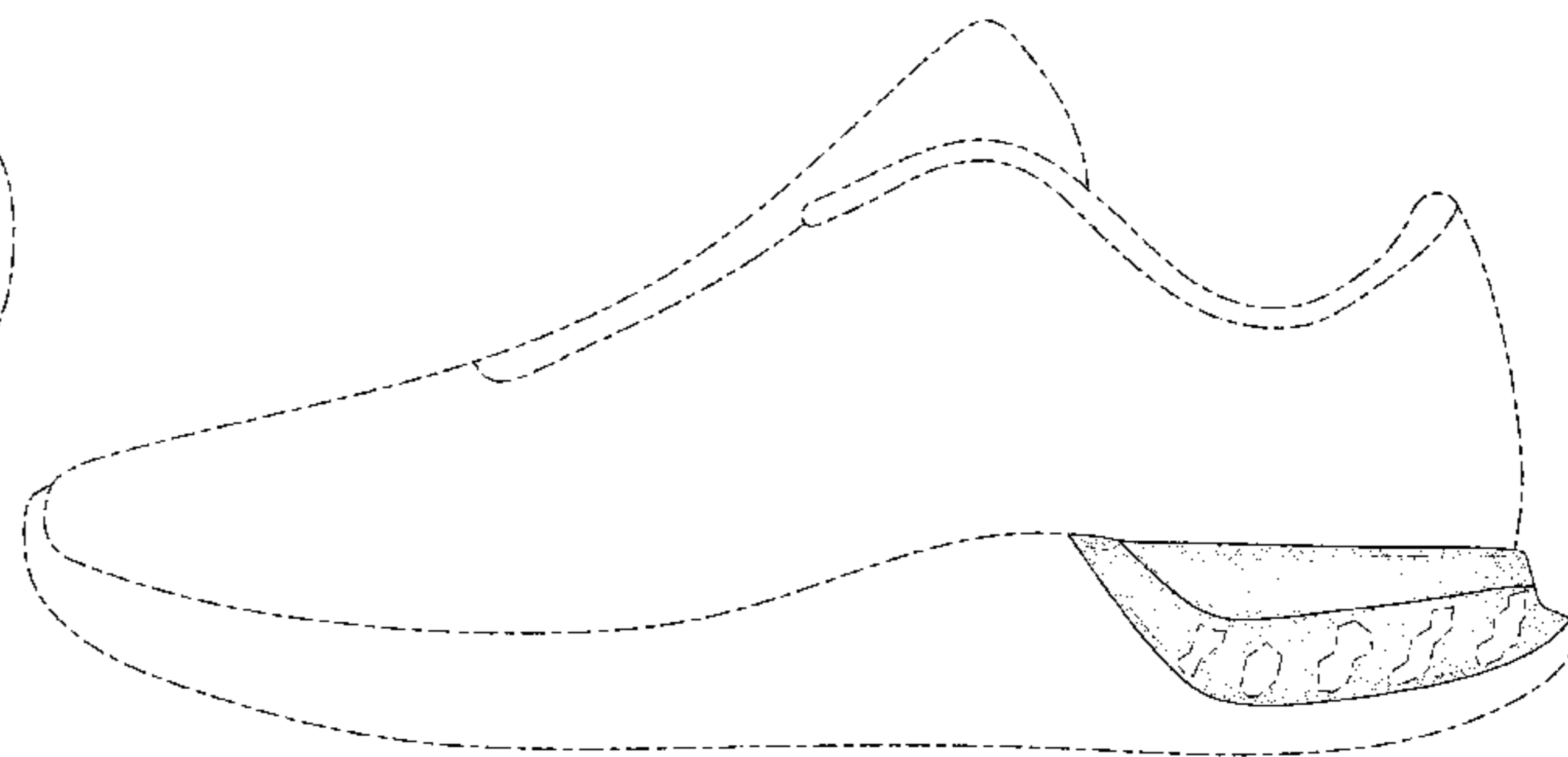
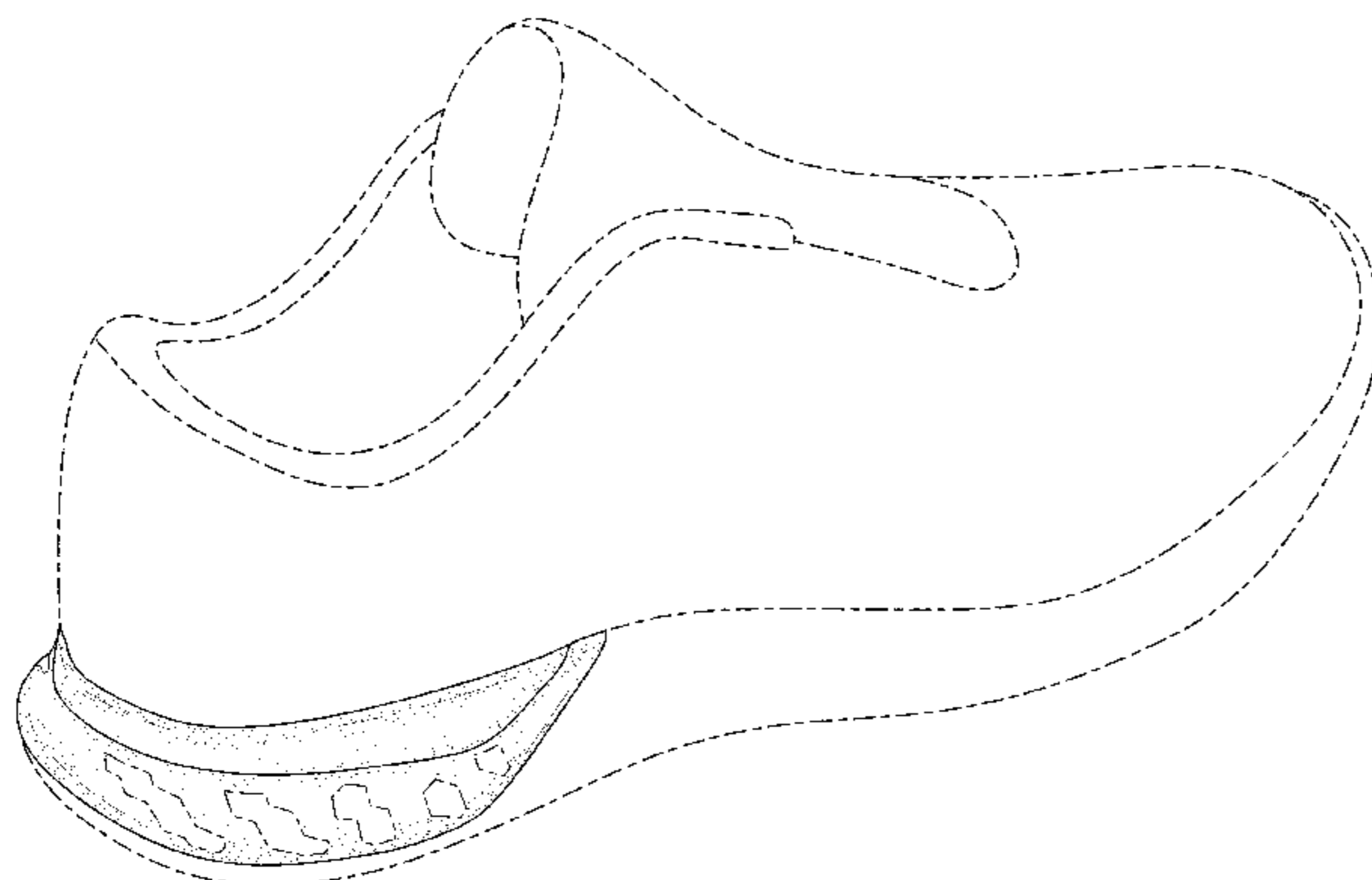
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a shoe showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is an opposite side view thereof; and,
FIG. 4 is an opposite side perspective view thereof.
The ten unshaded polygonal regions within the shaded area demarcated by broken lines form no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

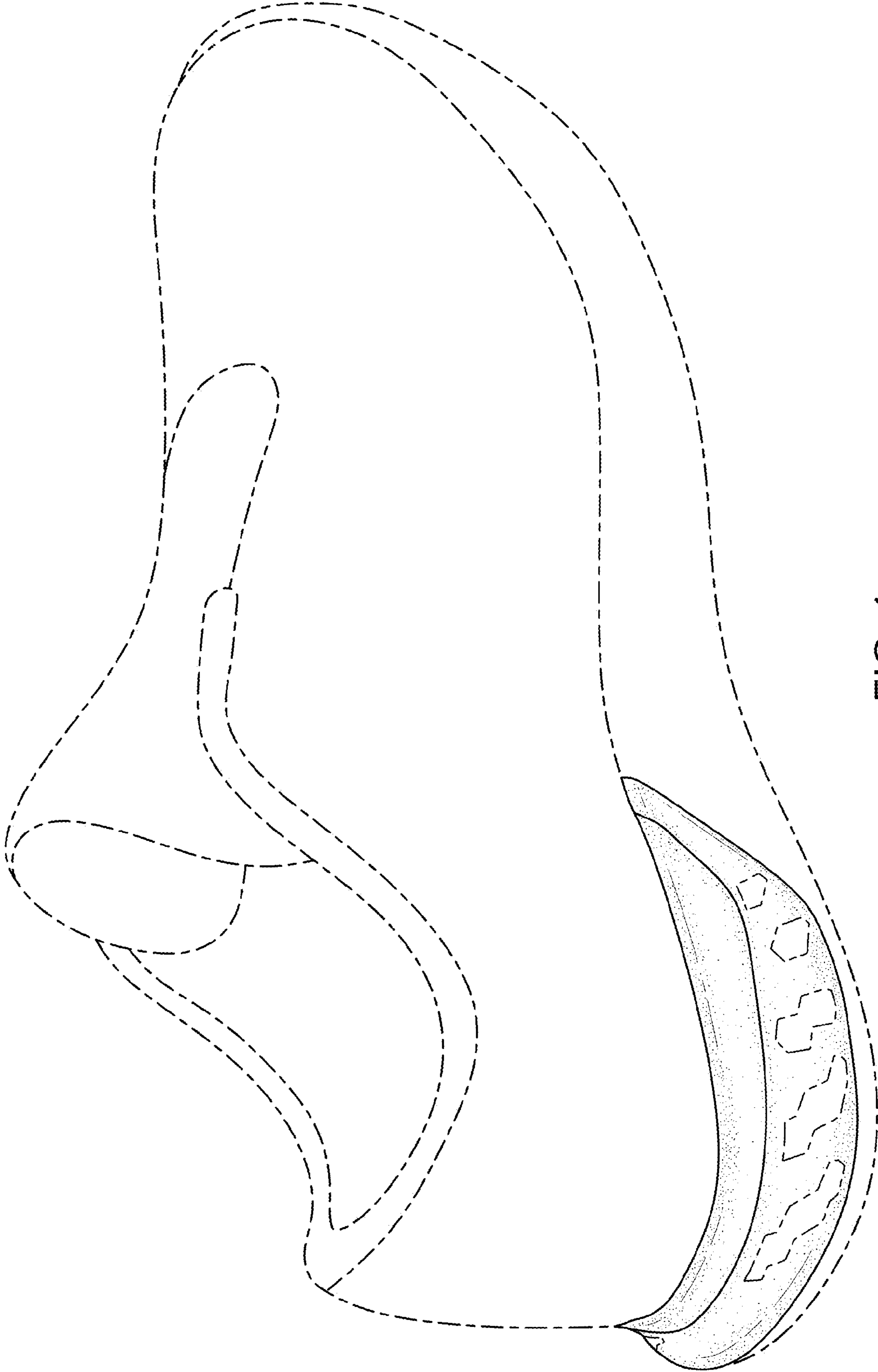

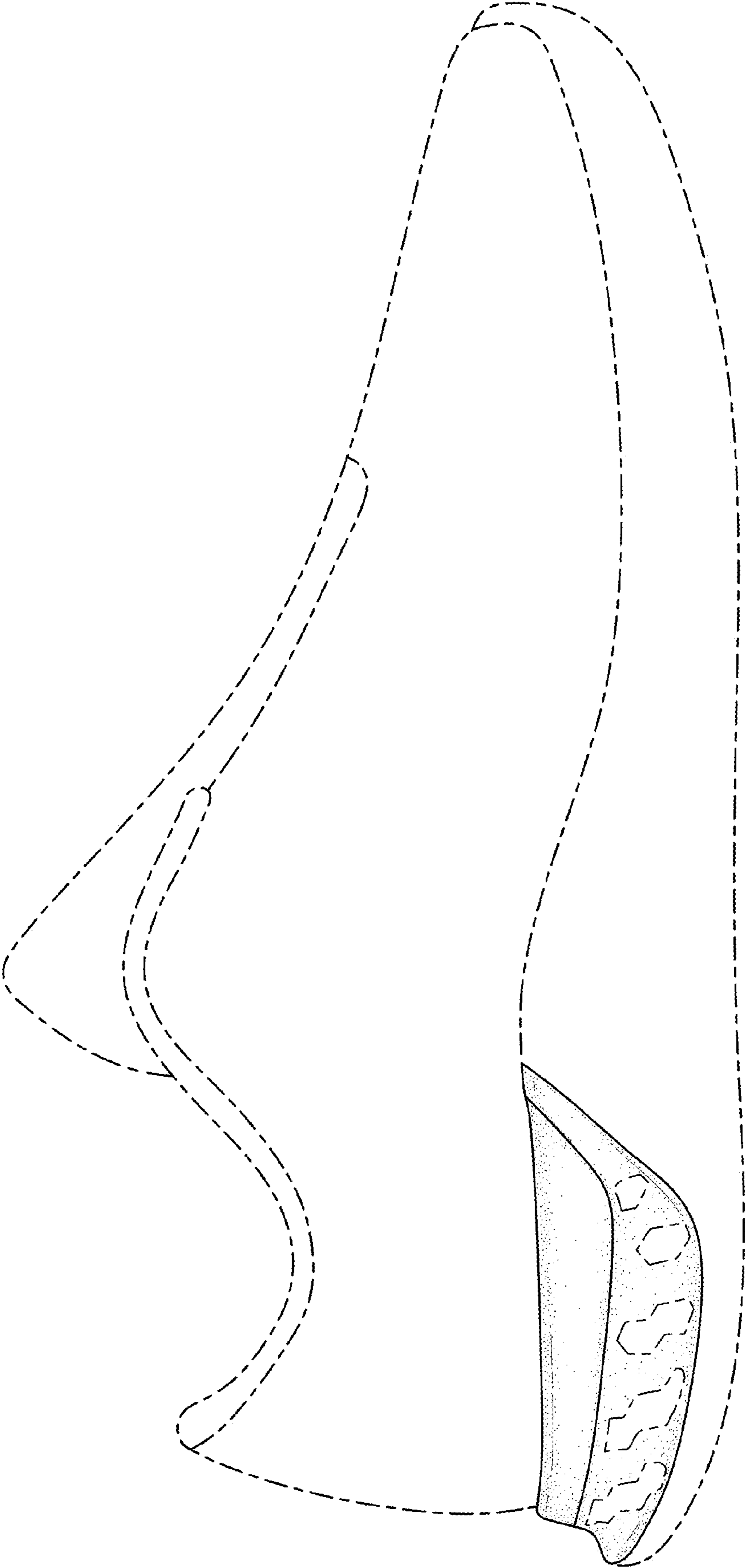

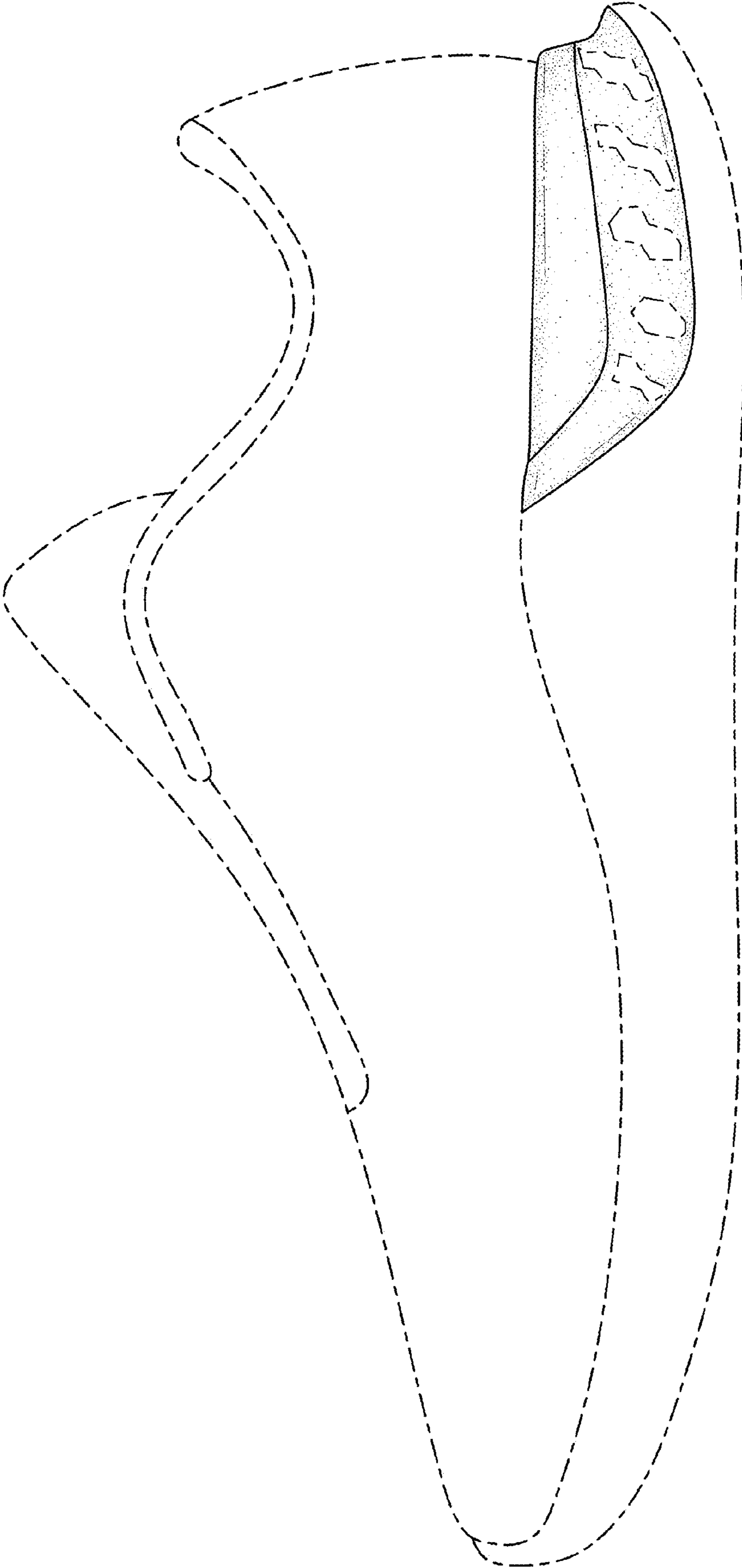

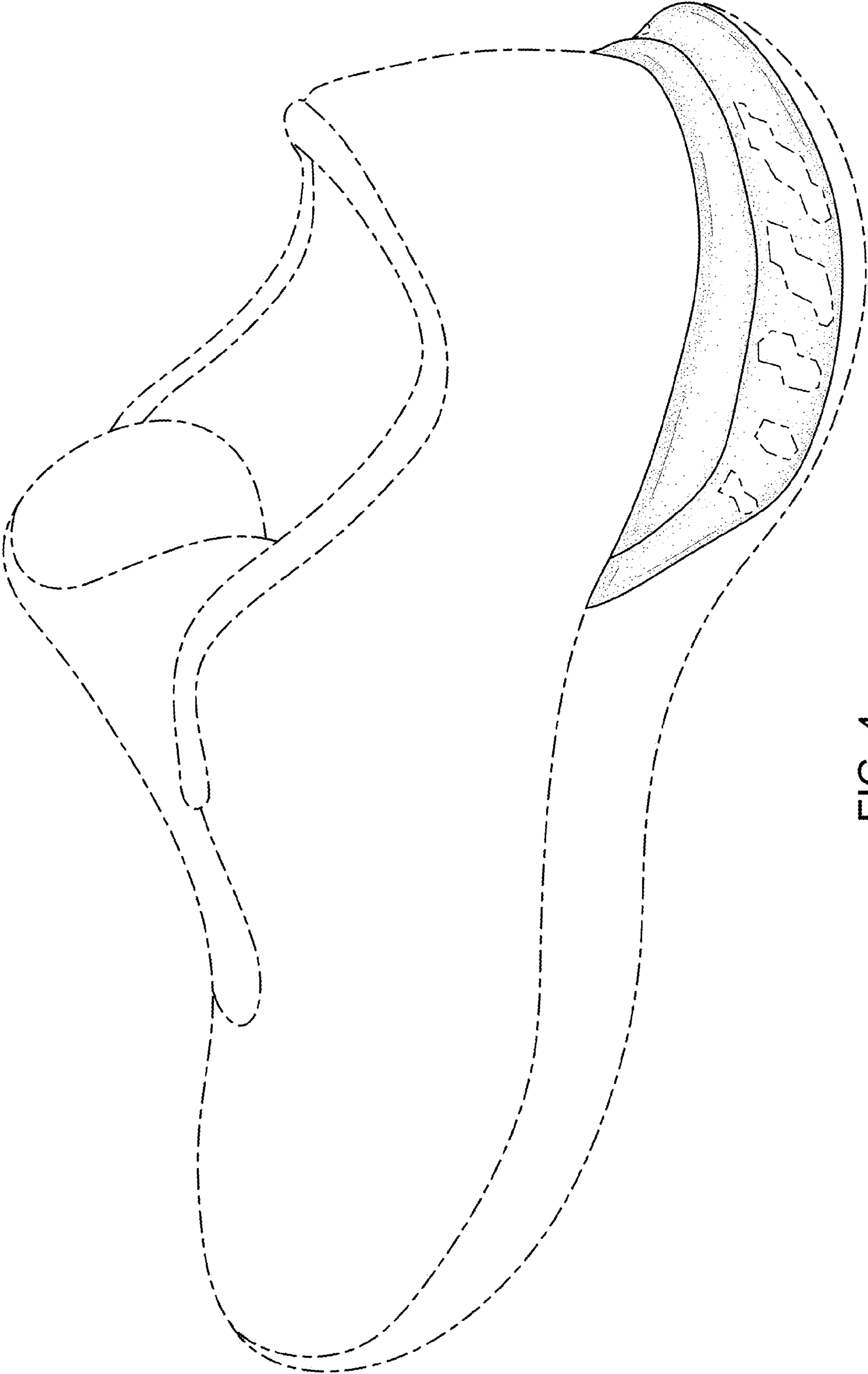
