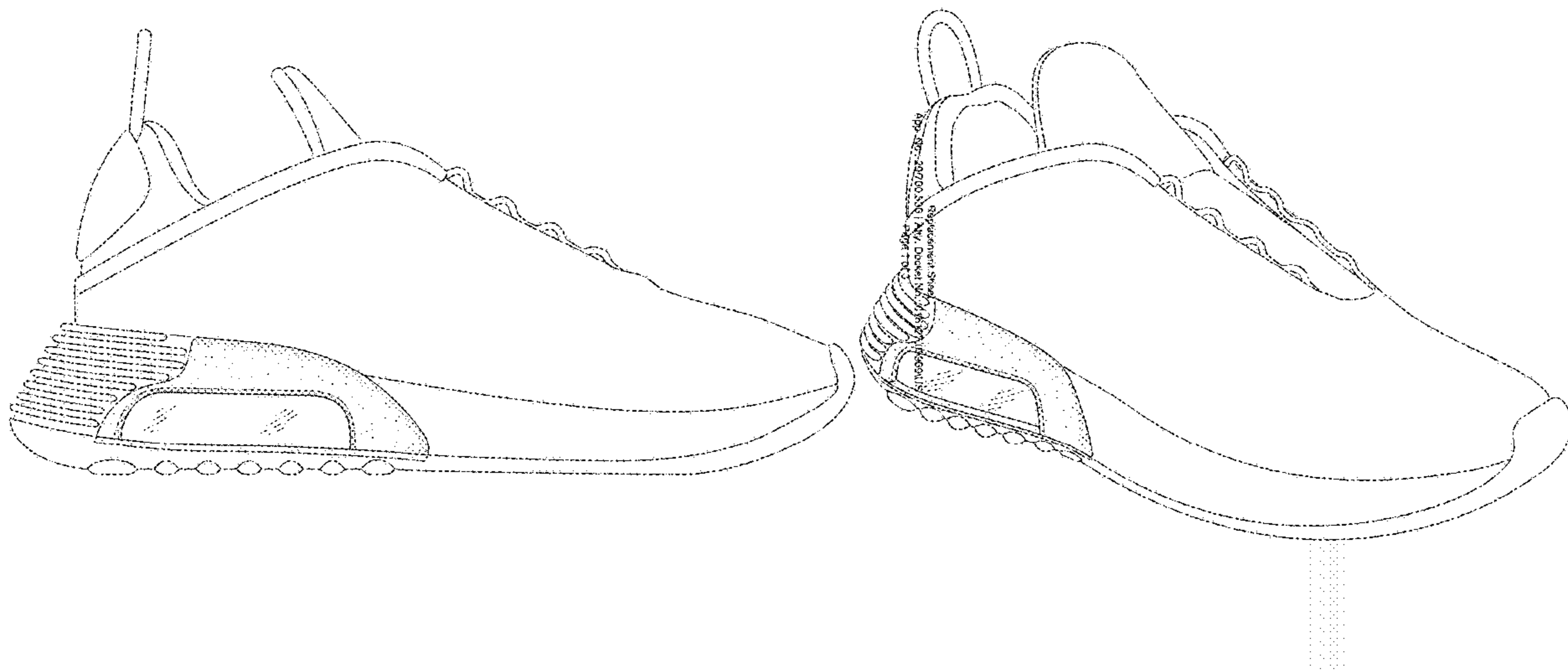
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a side view of a shoe showing my new design; FIG. 2 is a front perspective view thereof; and, FIG. 3 is a rear perspective view thereof. The broken lines immediately adjacent to the bottom and rear of the shaded area define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

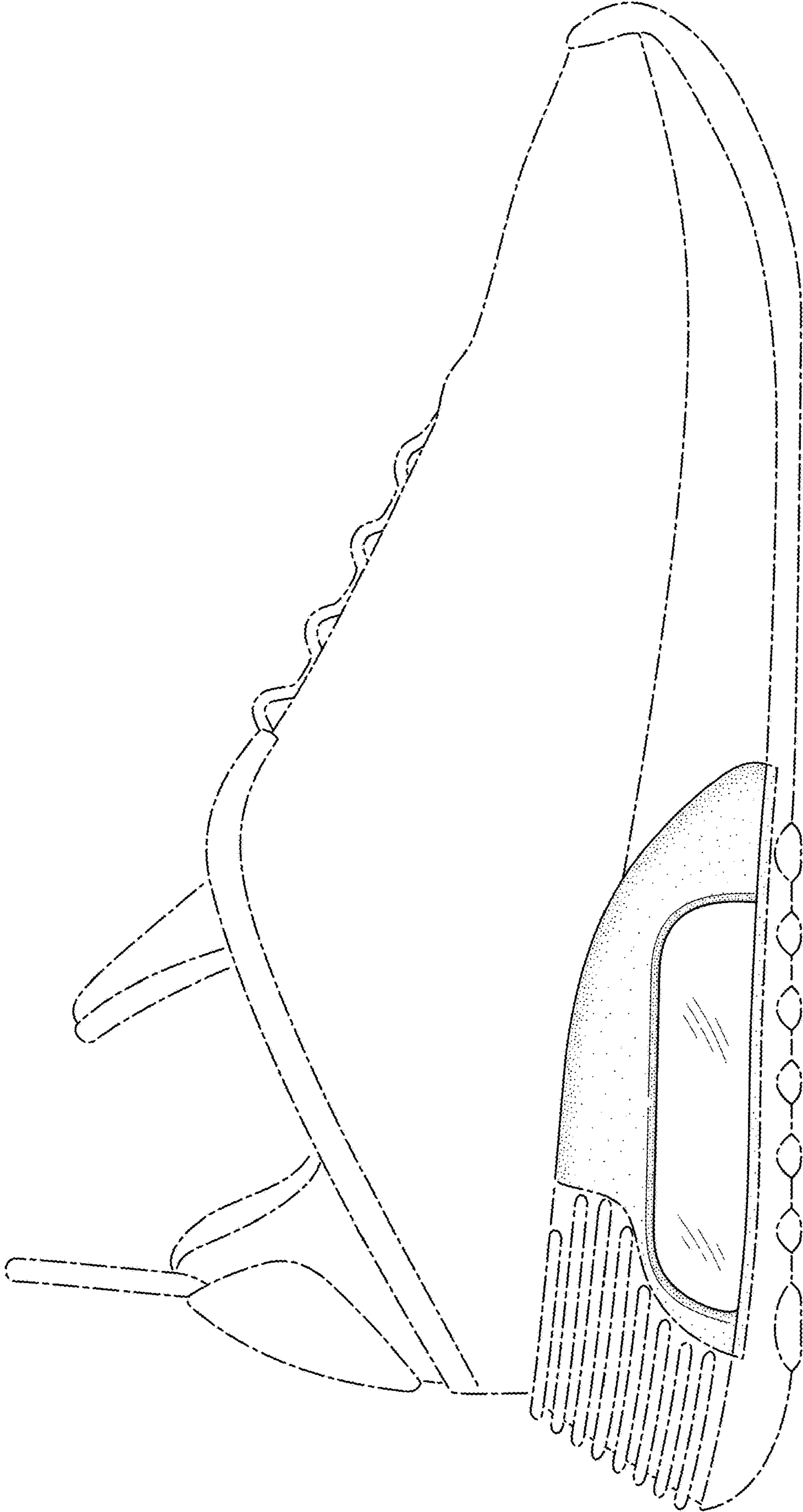

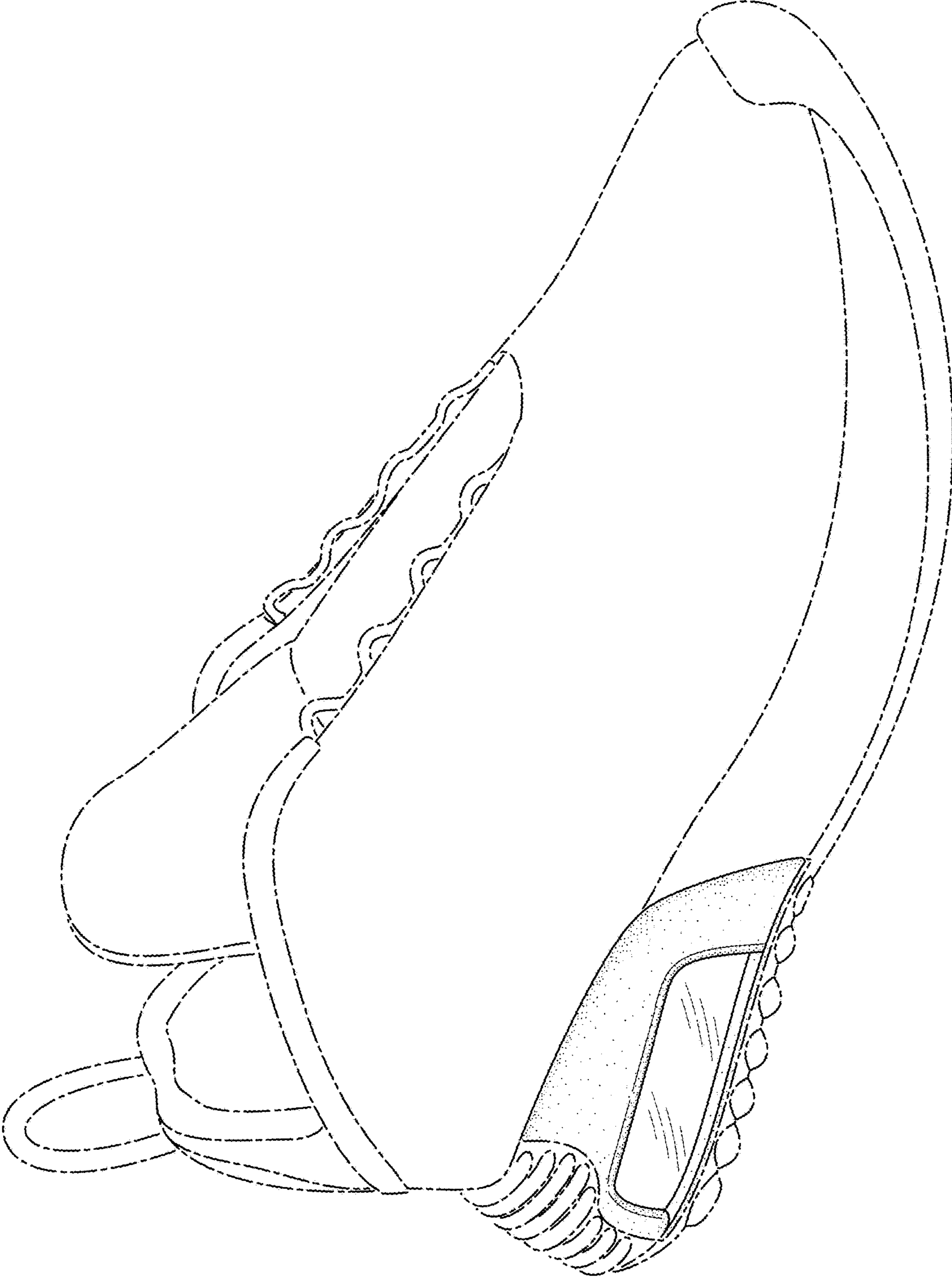

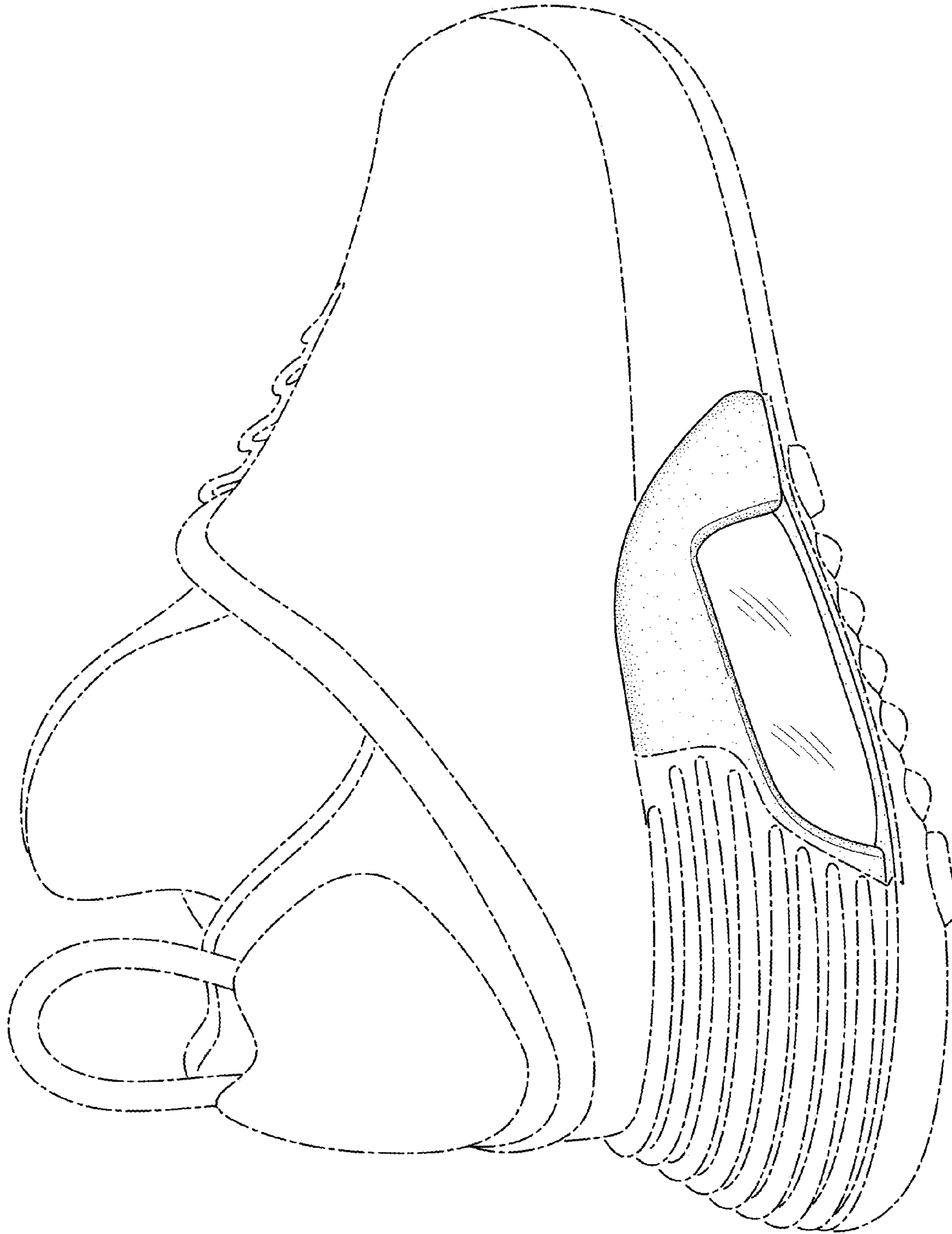
