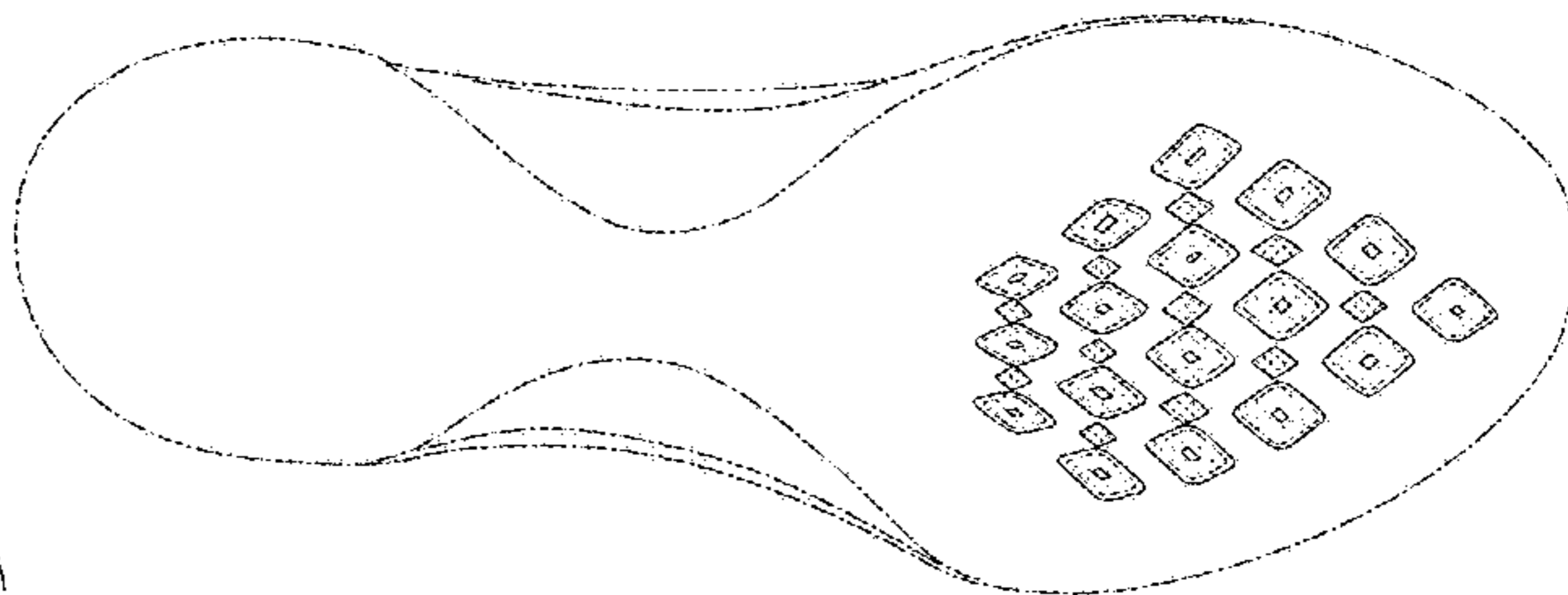
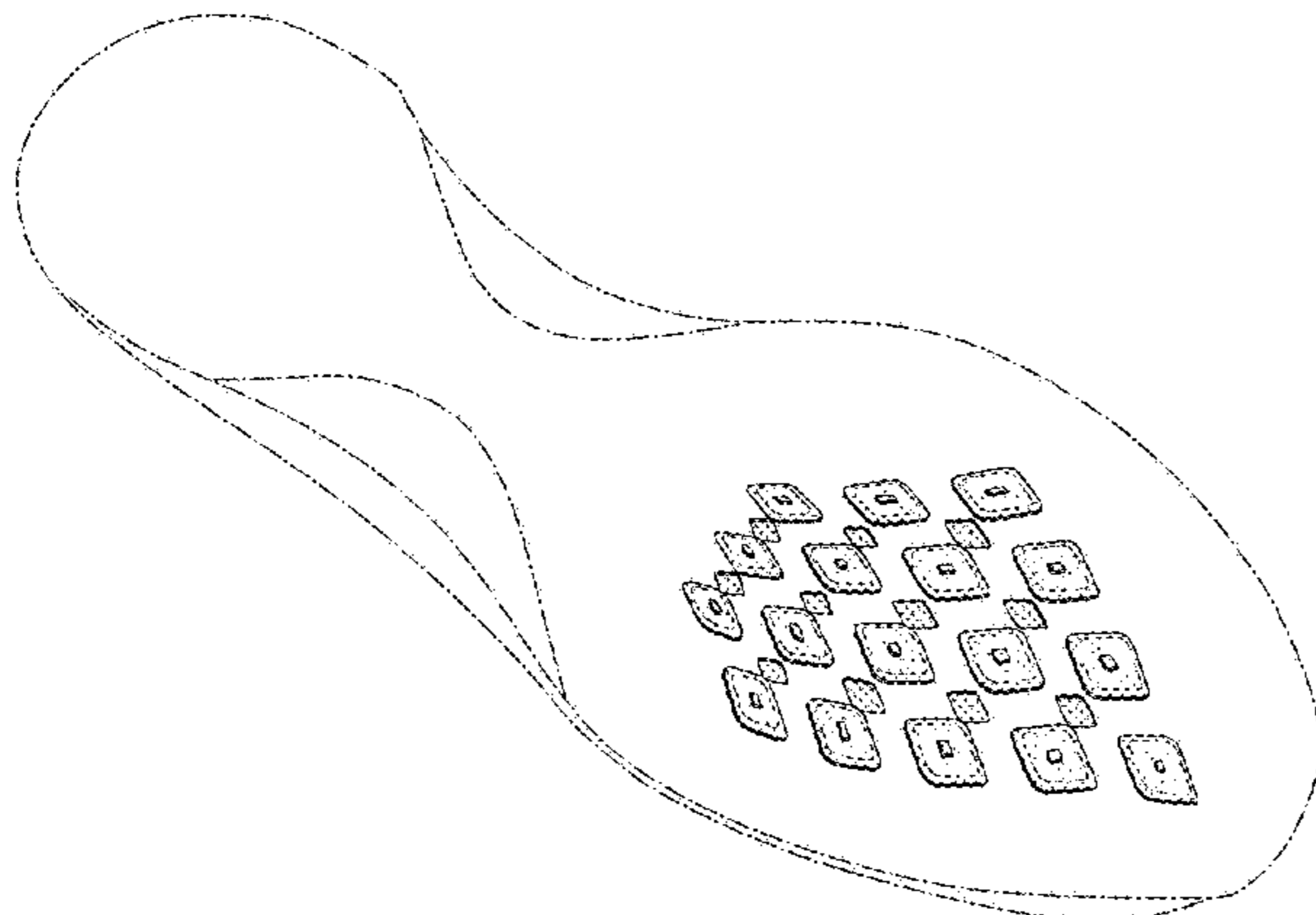
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front bottom perspective view of a shoe showing my new design;
FIG. 2 is a bottom view thereof; and,
FIG. 3 is a second front bottom perspective view thereof.
The unshaded regions not formed by the diamond shape tread elements or the diamond shaped recesses are for environmental purposes only and form no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

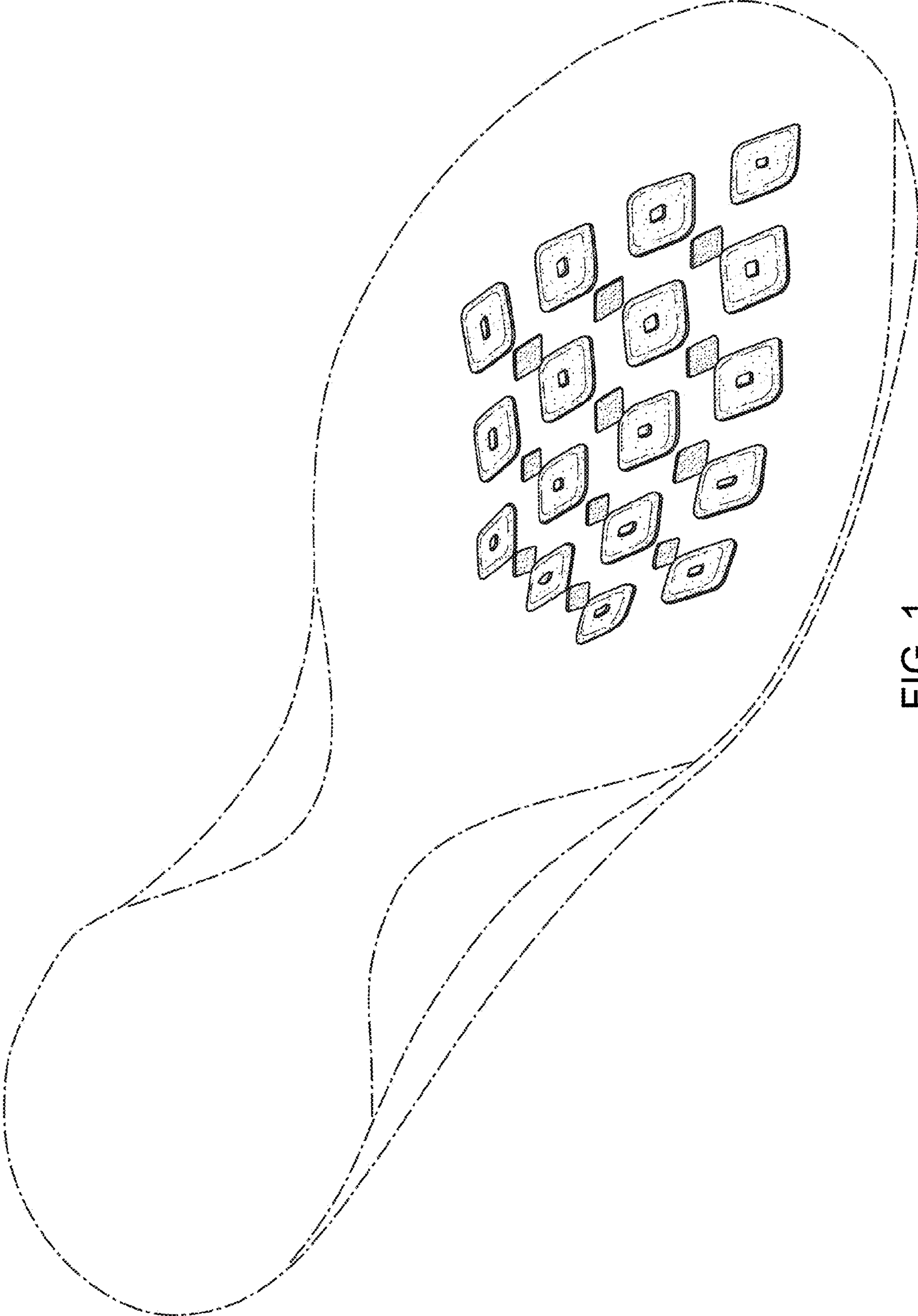

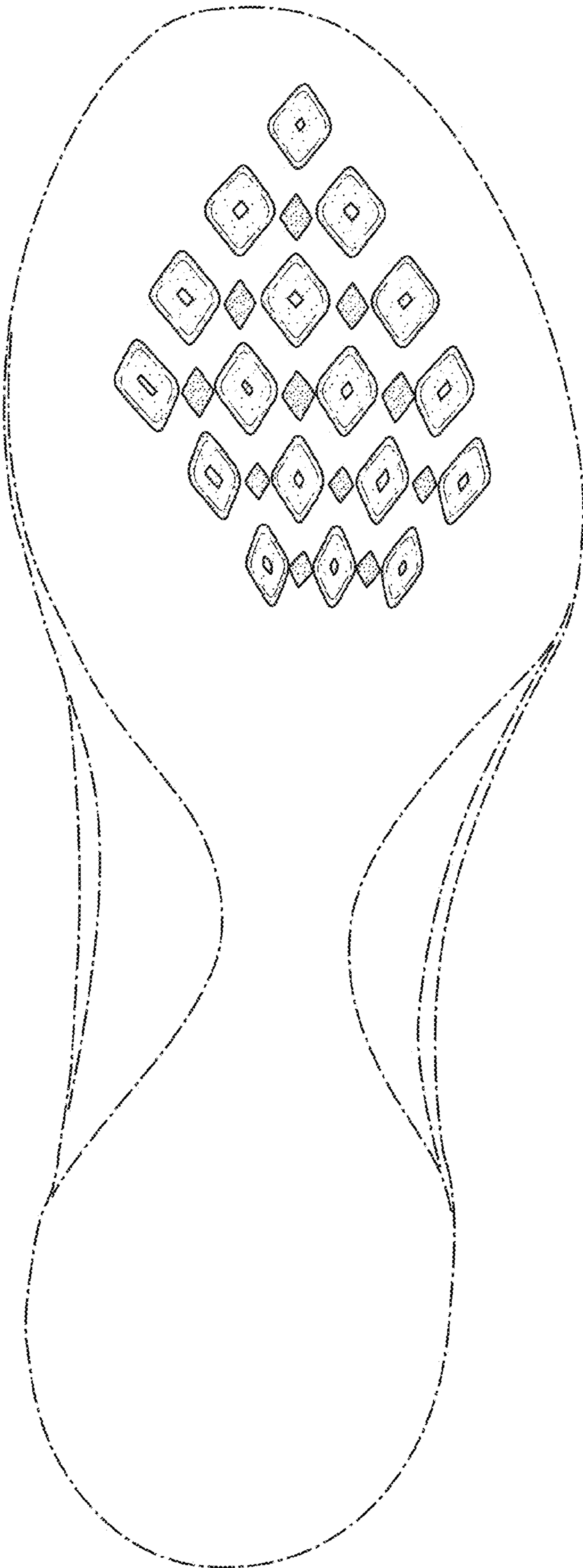

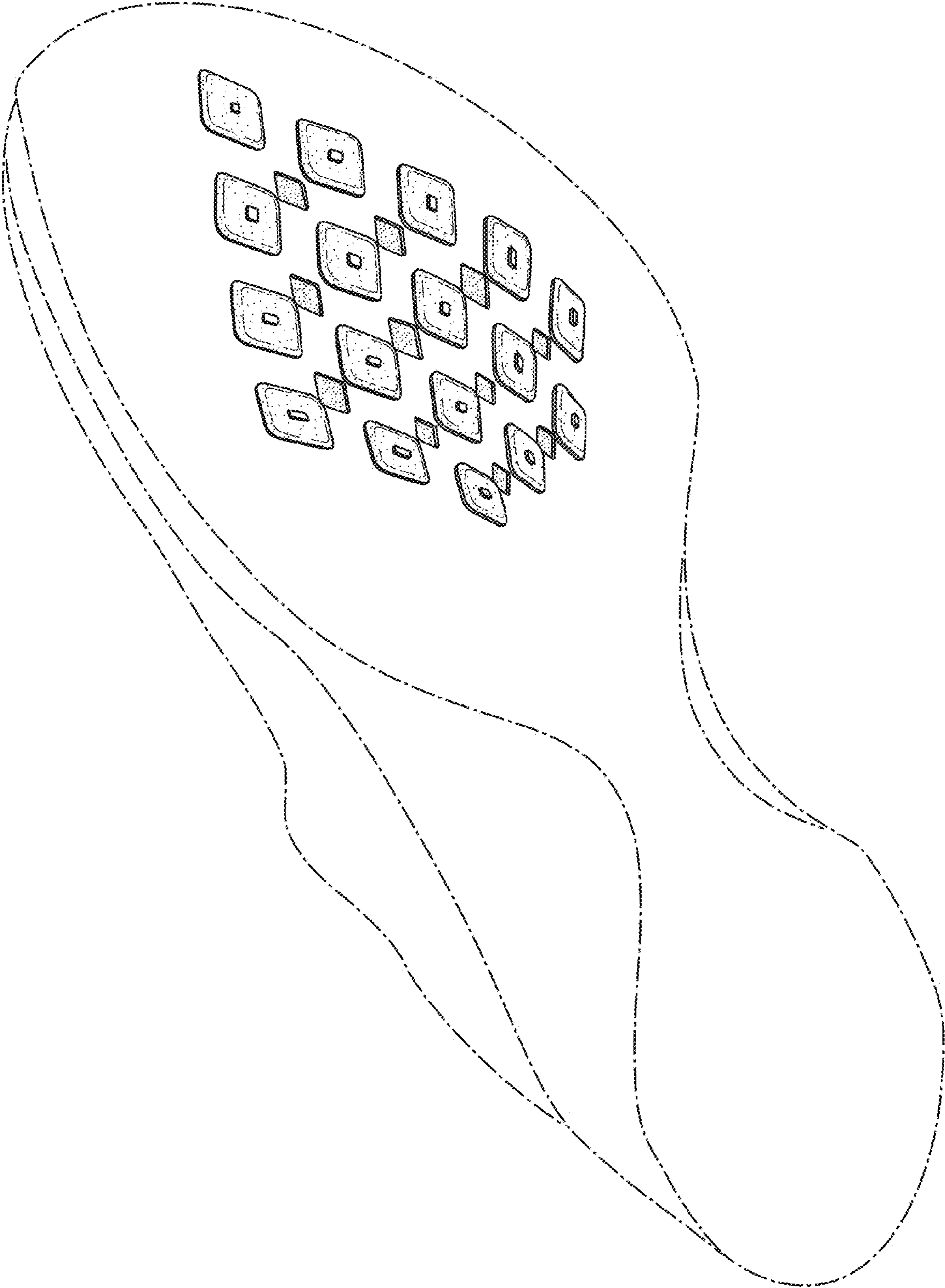
