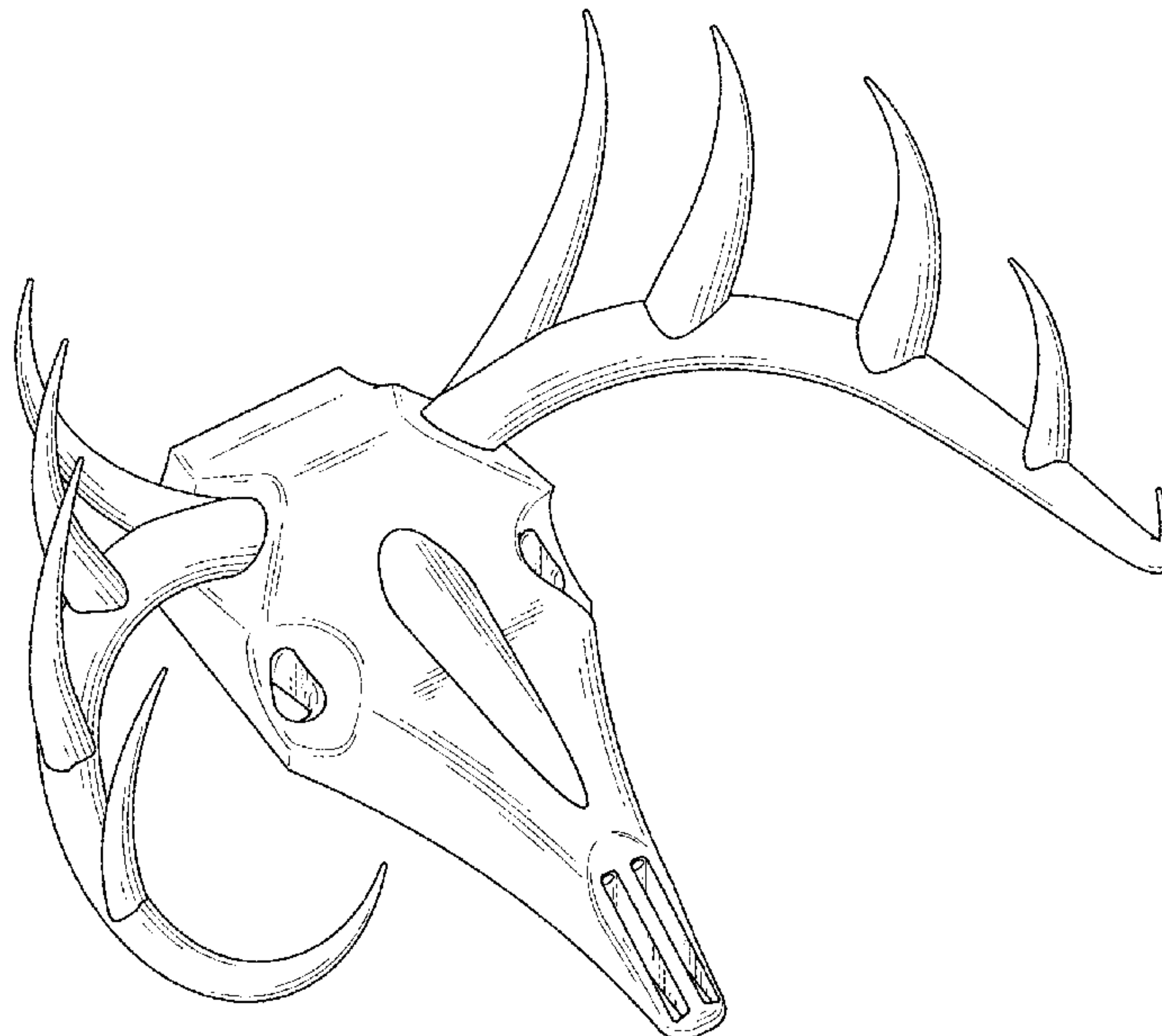

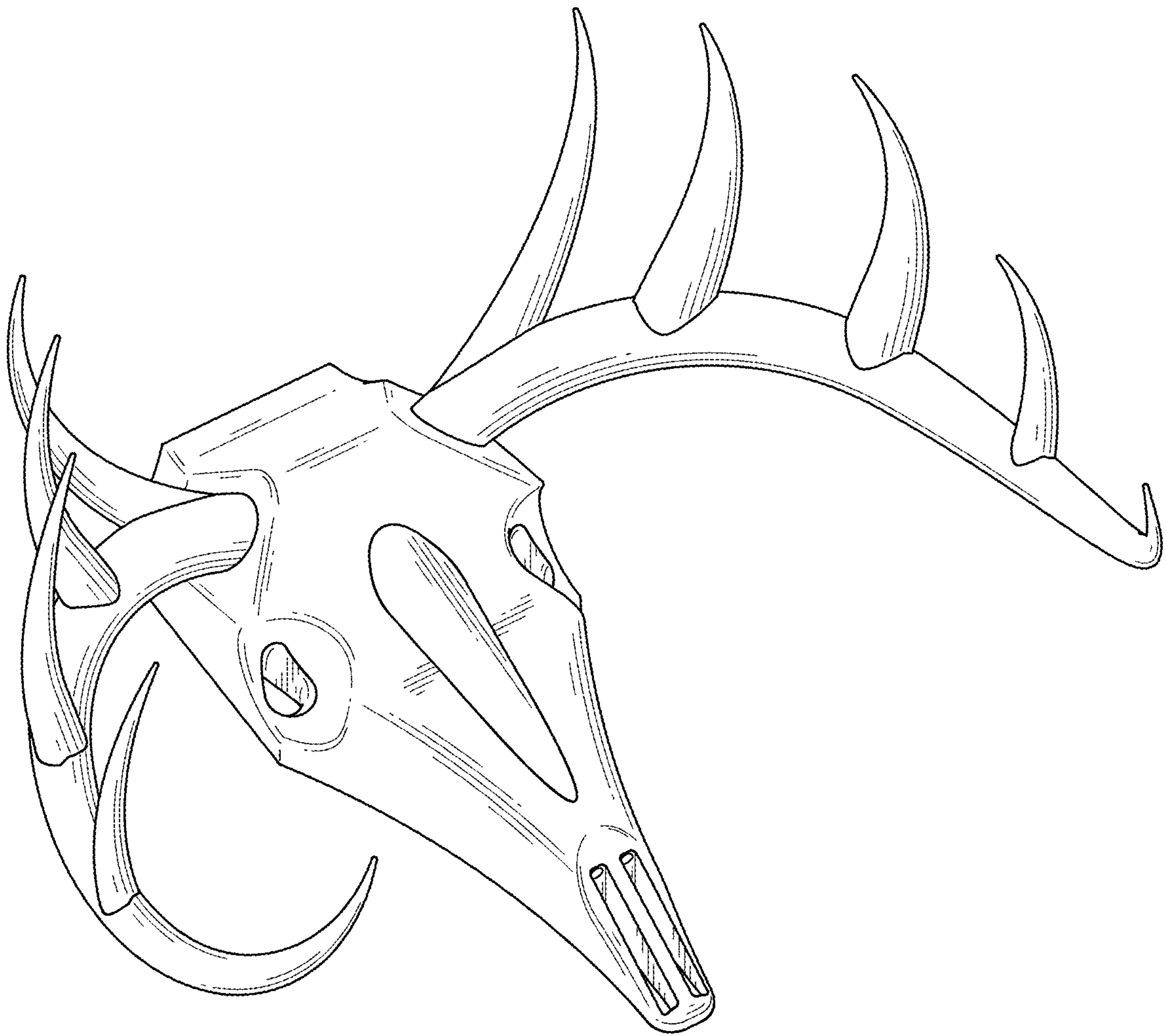
The ornamental design for a meat rack for smoker or grill,

**DESCRIPTION**

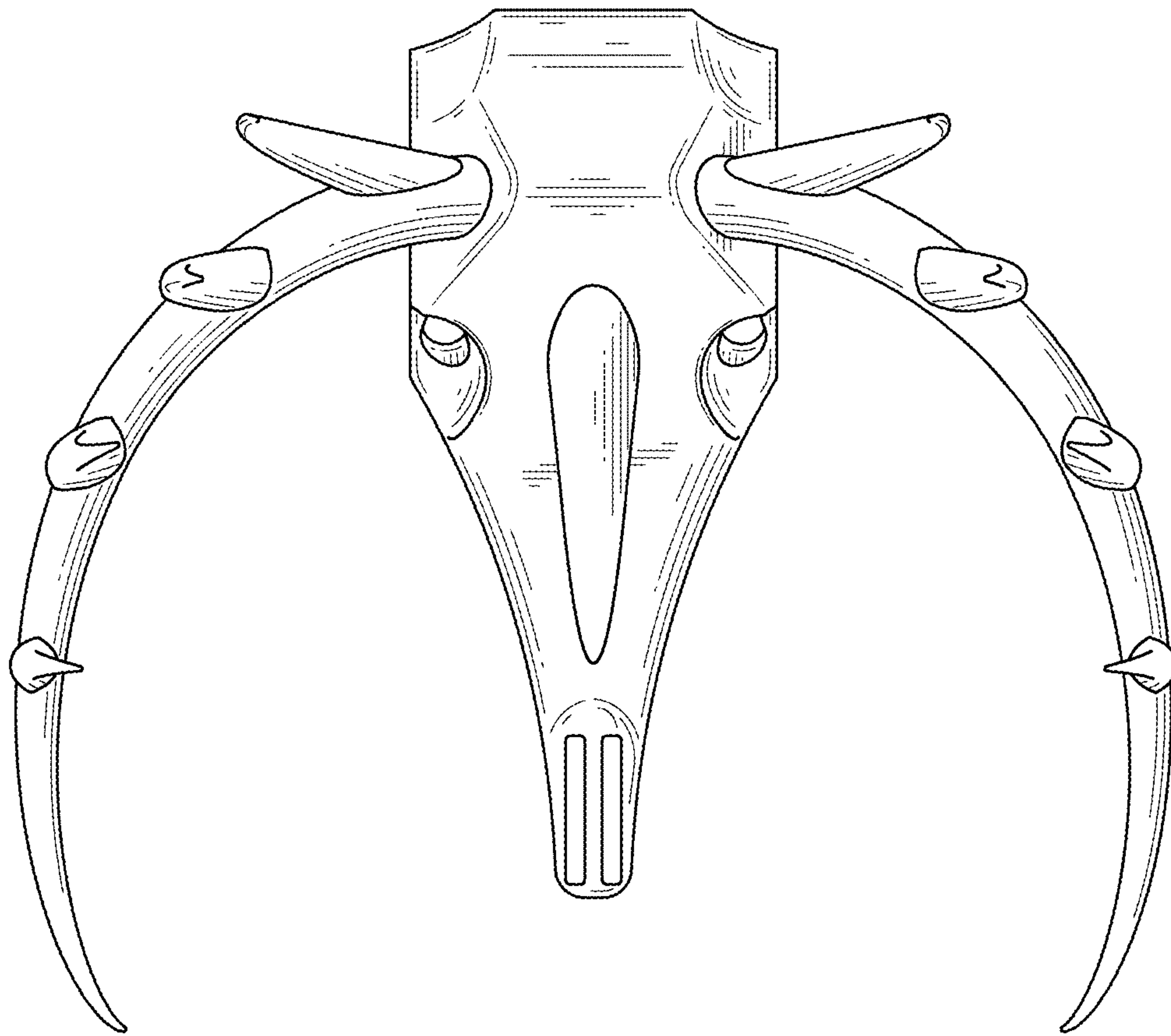
FIG. 1 is a perspective view of the meat rack for smoker or grill;

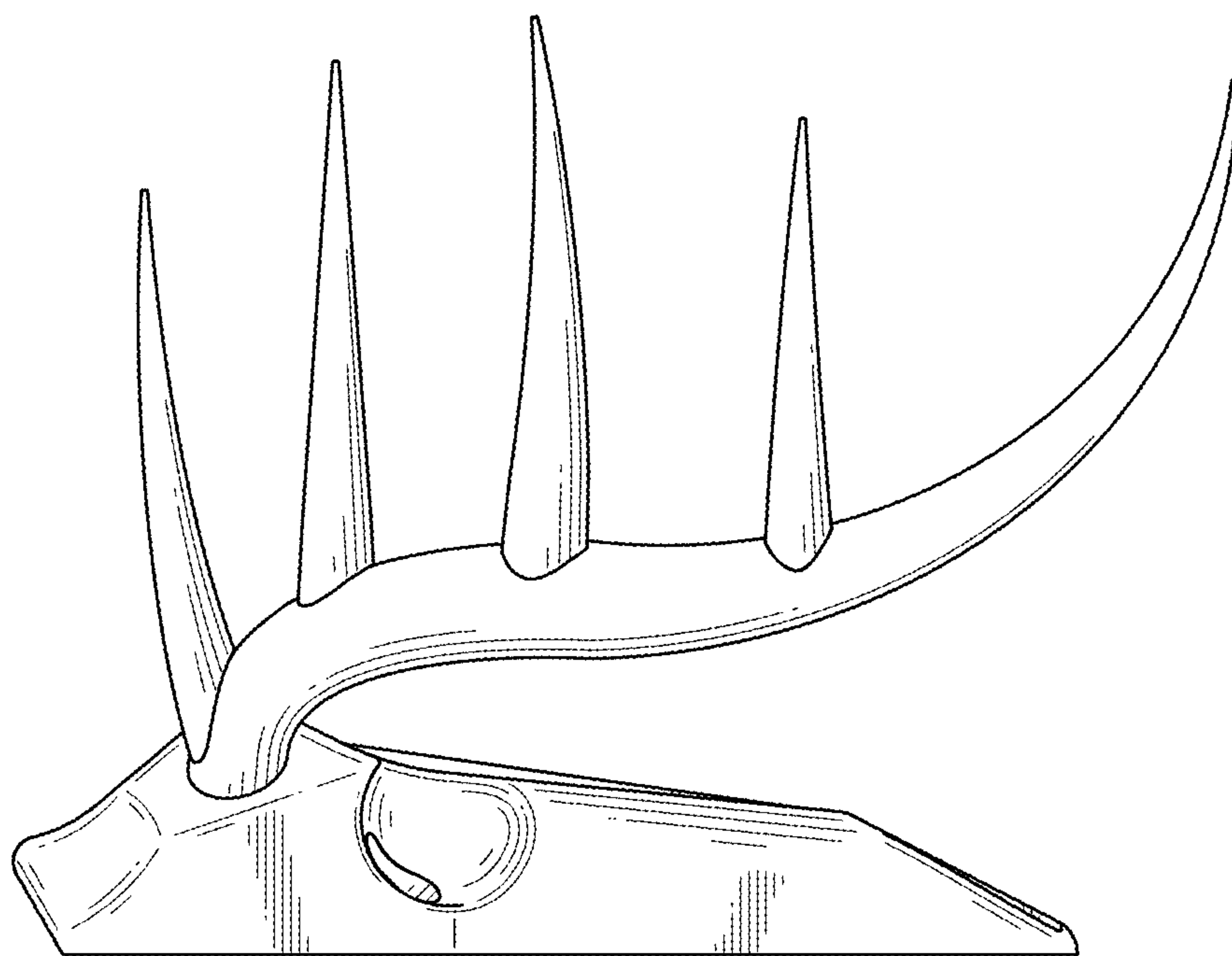




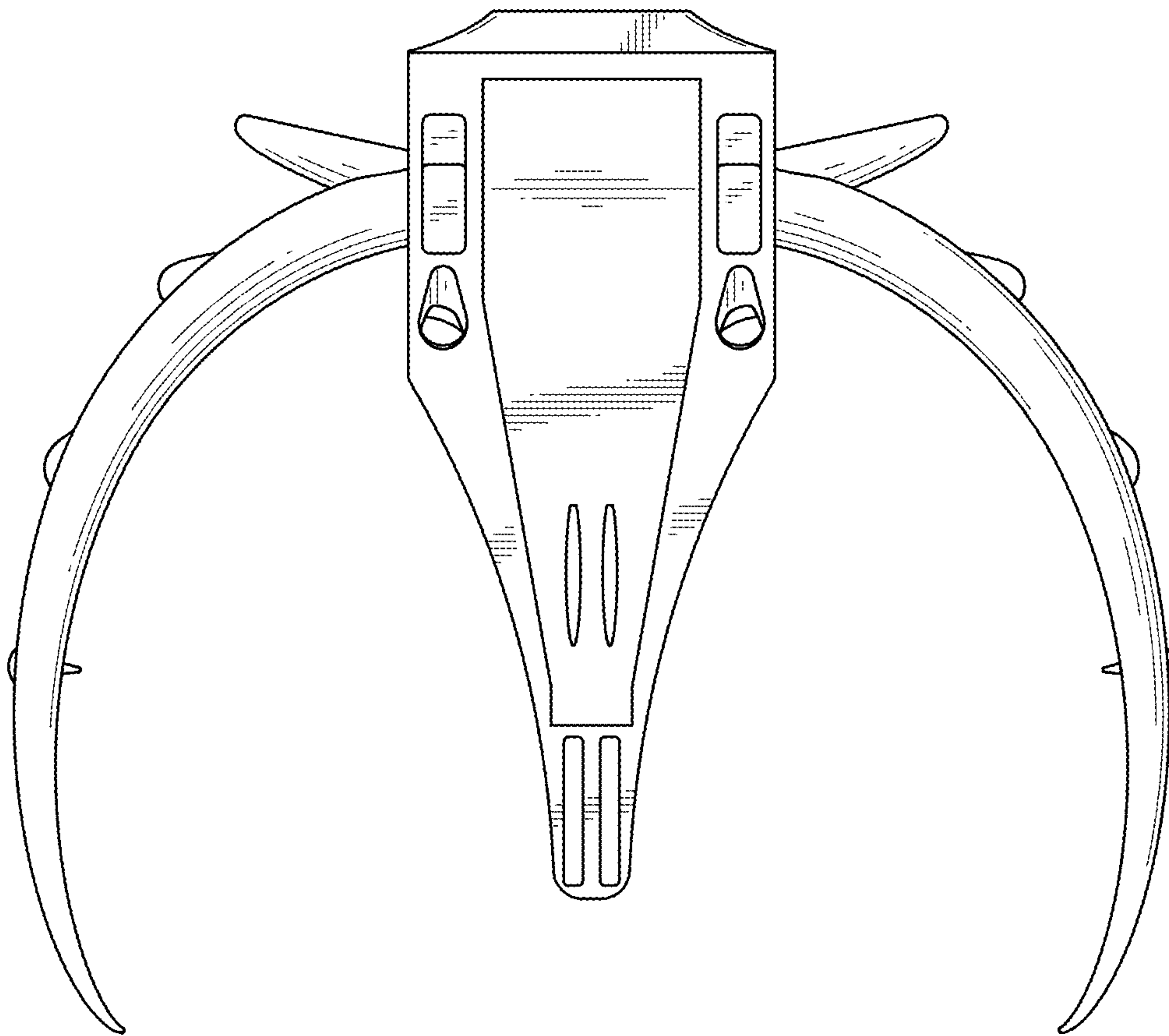

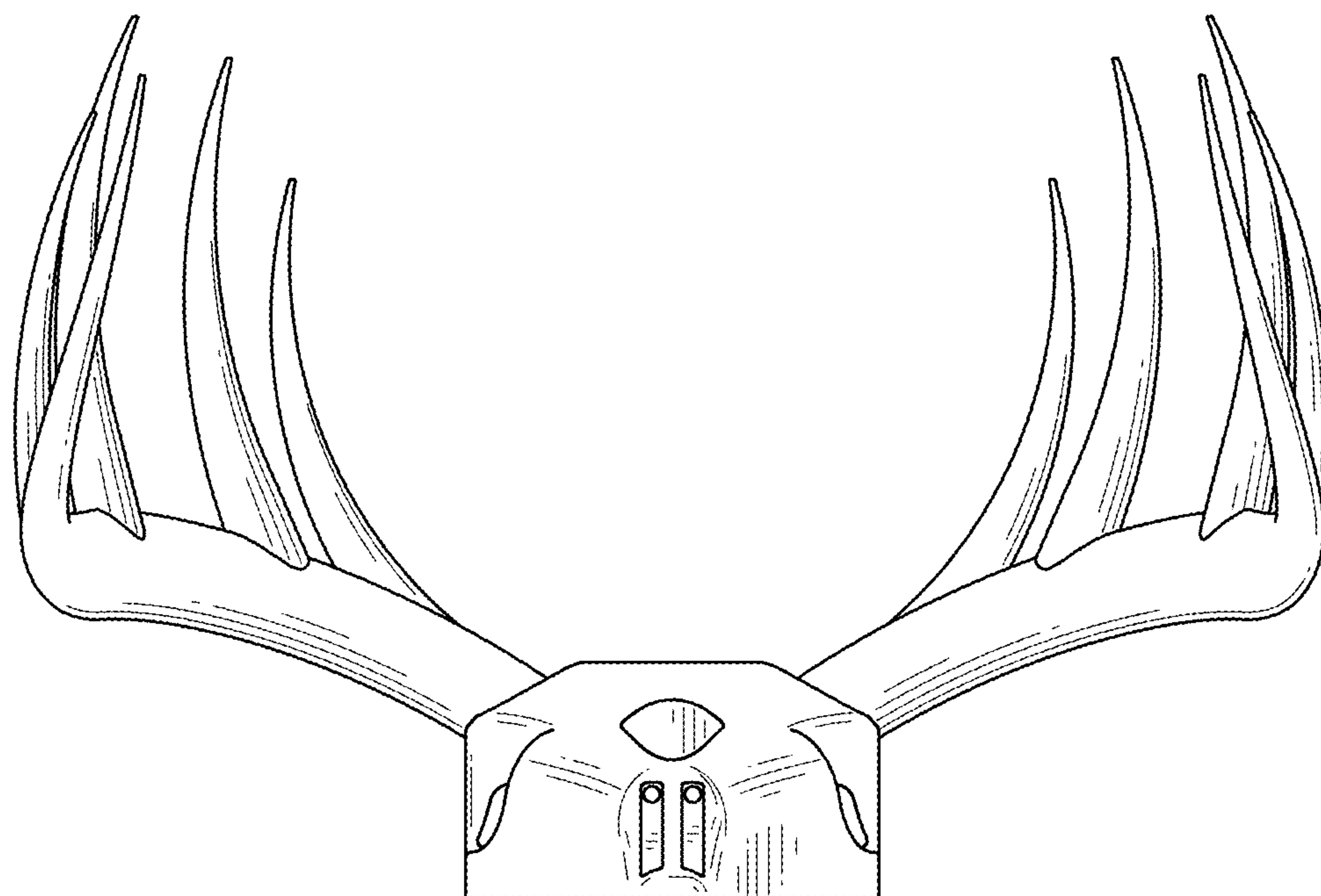

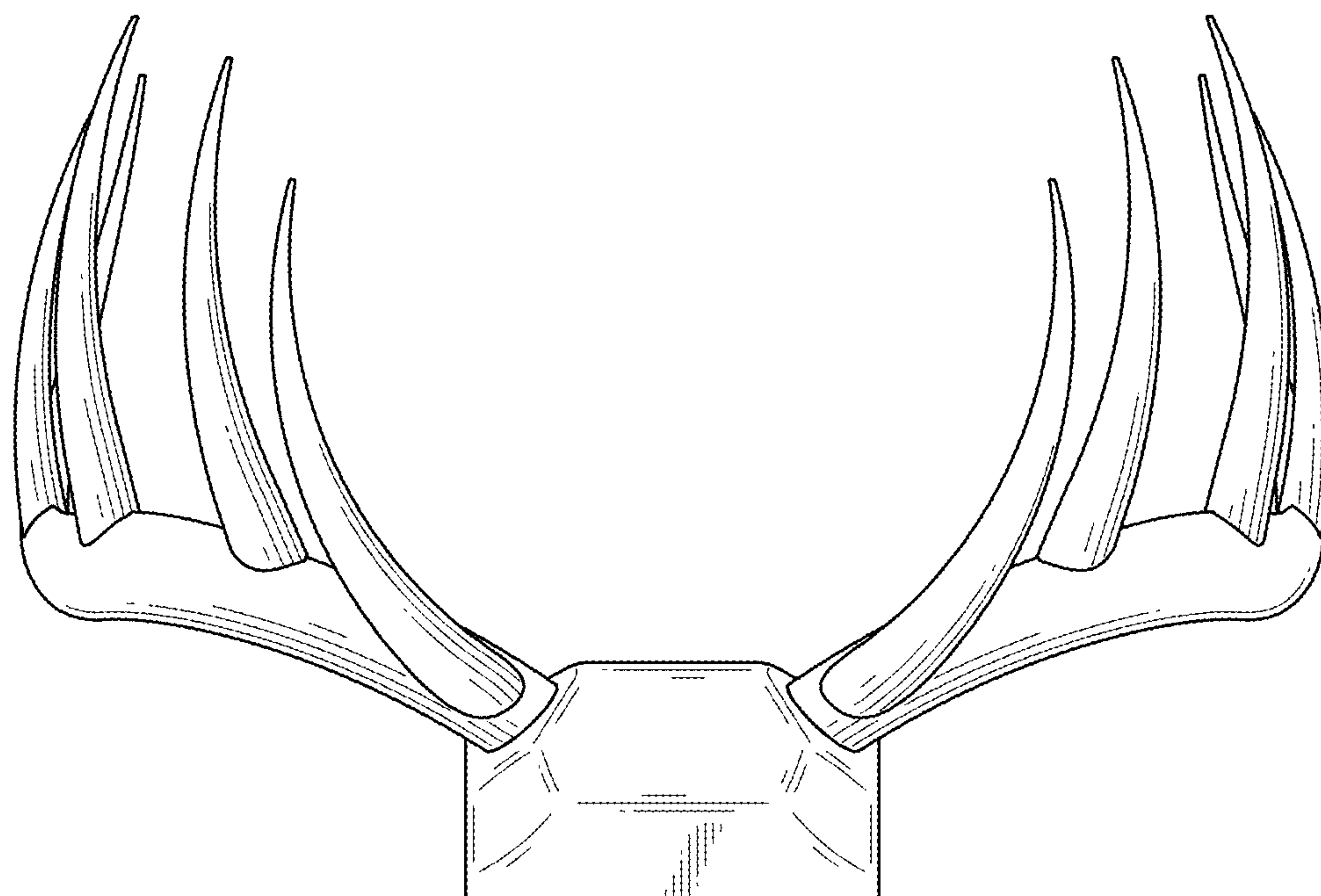
