(57) **CLAIM**
I claim, the ornamental design for a glass with saucer, as shown and described.

DESCRIPTION
FIG. 1 is a perspective view of a glass with saucer, showing my new design;
FIG. 2 is a side view thereof, all other sides being a mirror image hereof;
FIG. 3 is a top view thereof;
FIG. 4 is a bottom view thereof;
FIG. 5 is a side view thereof showing an upper portion detached from a lower portion; and,
FIG. 6 is a top view of the lower portion with the upper portion removed.

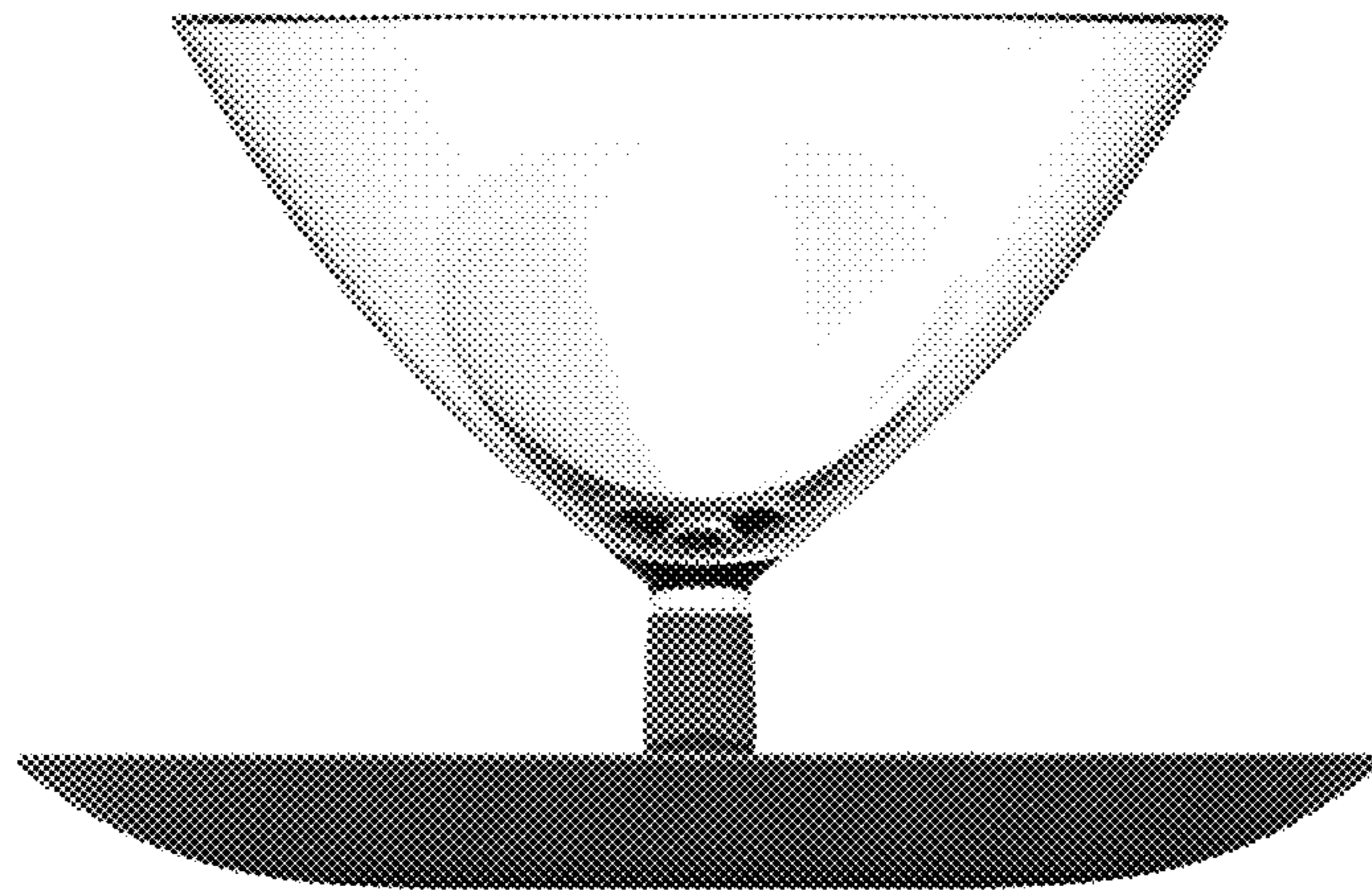

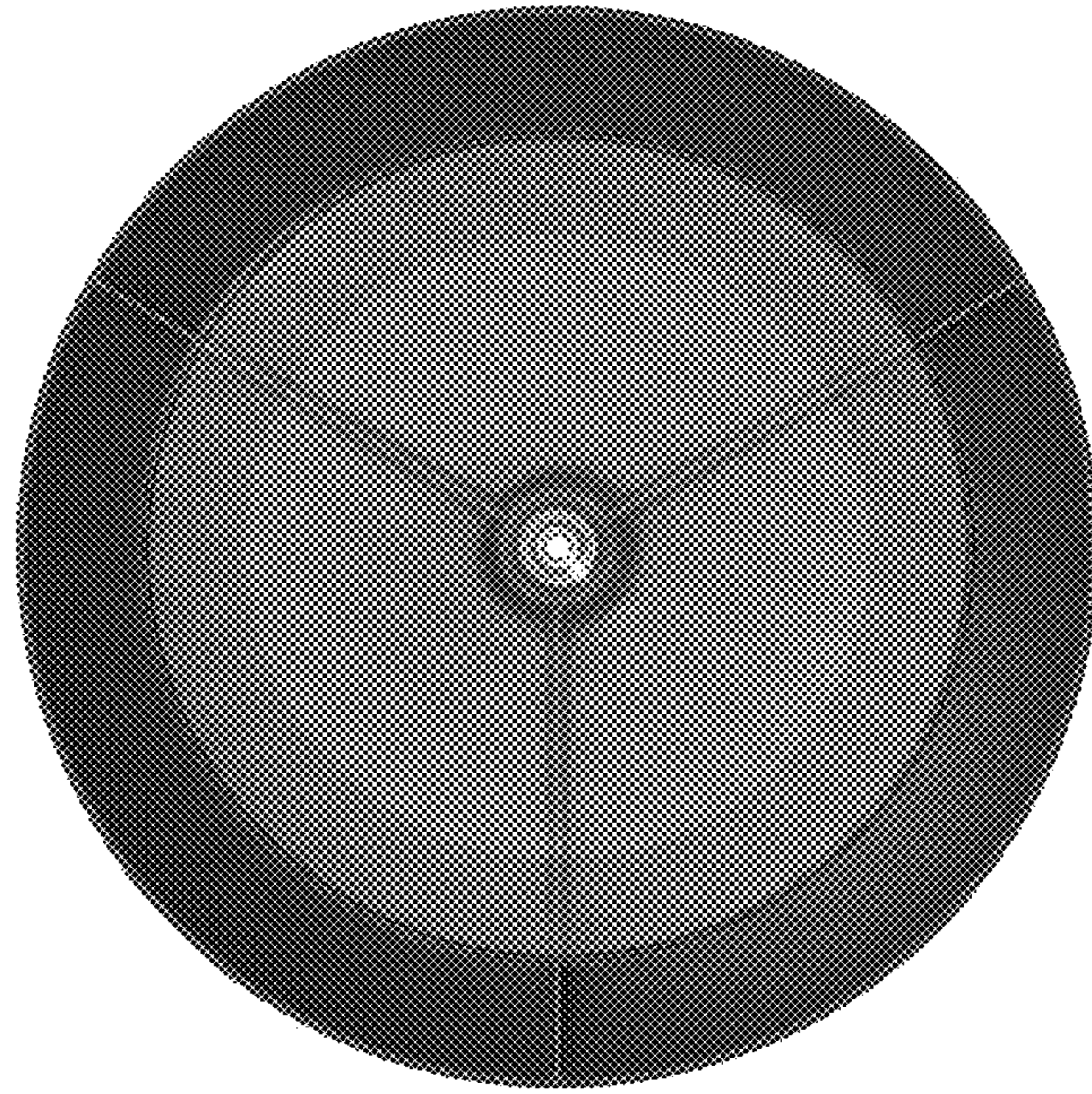

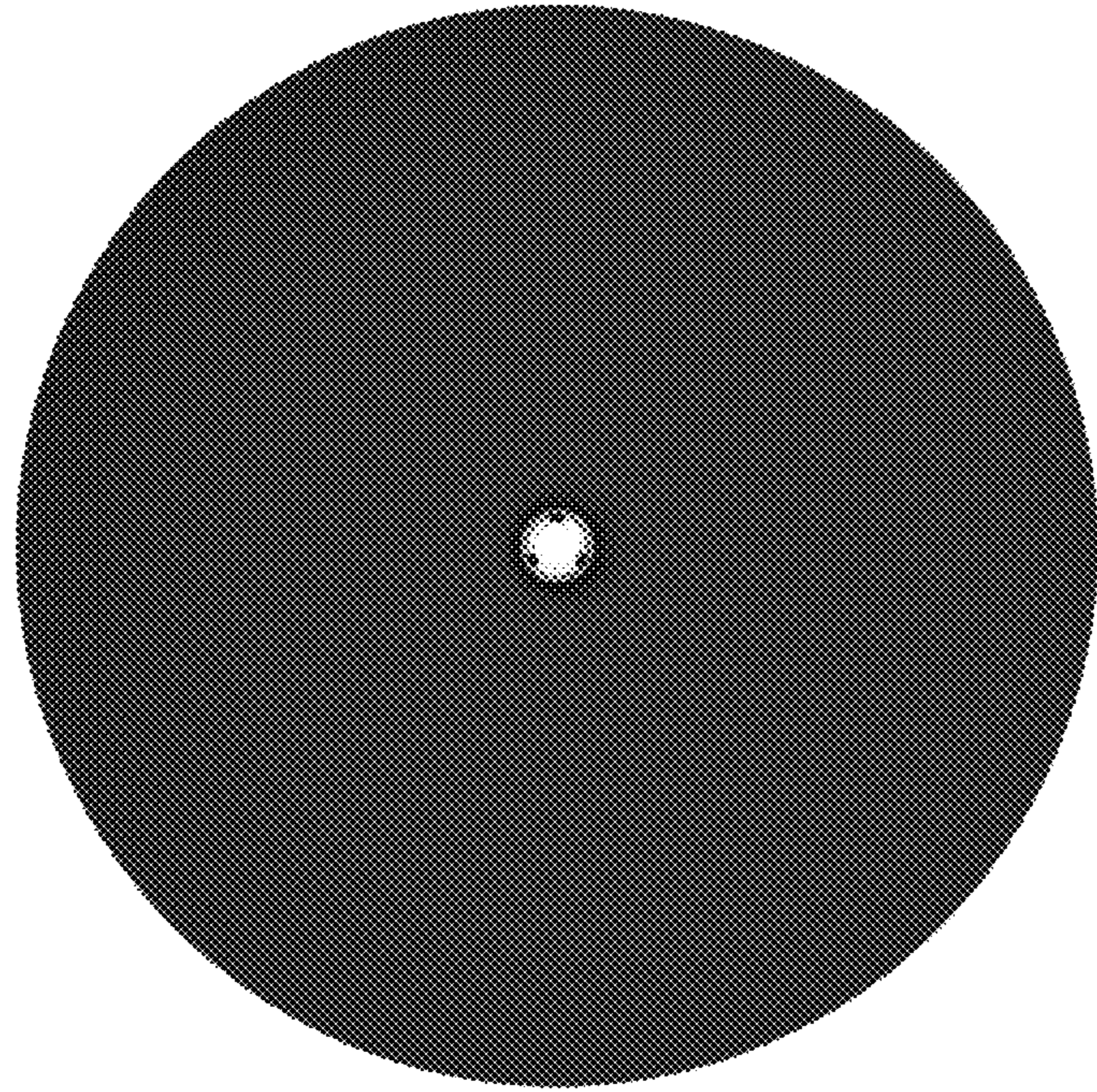

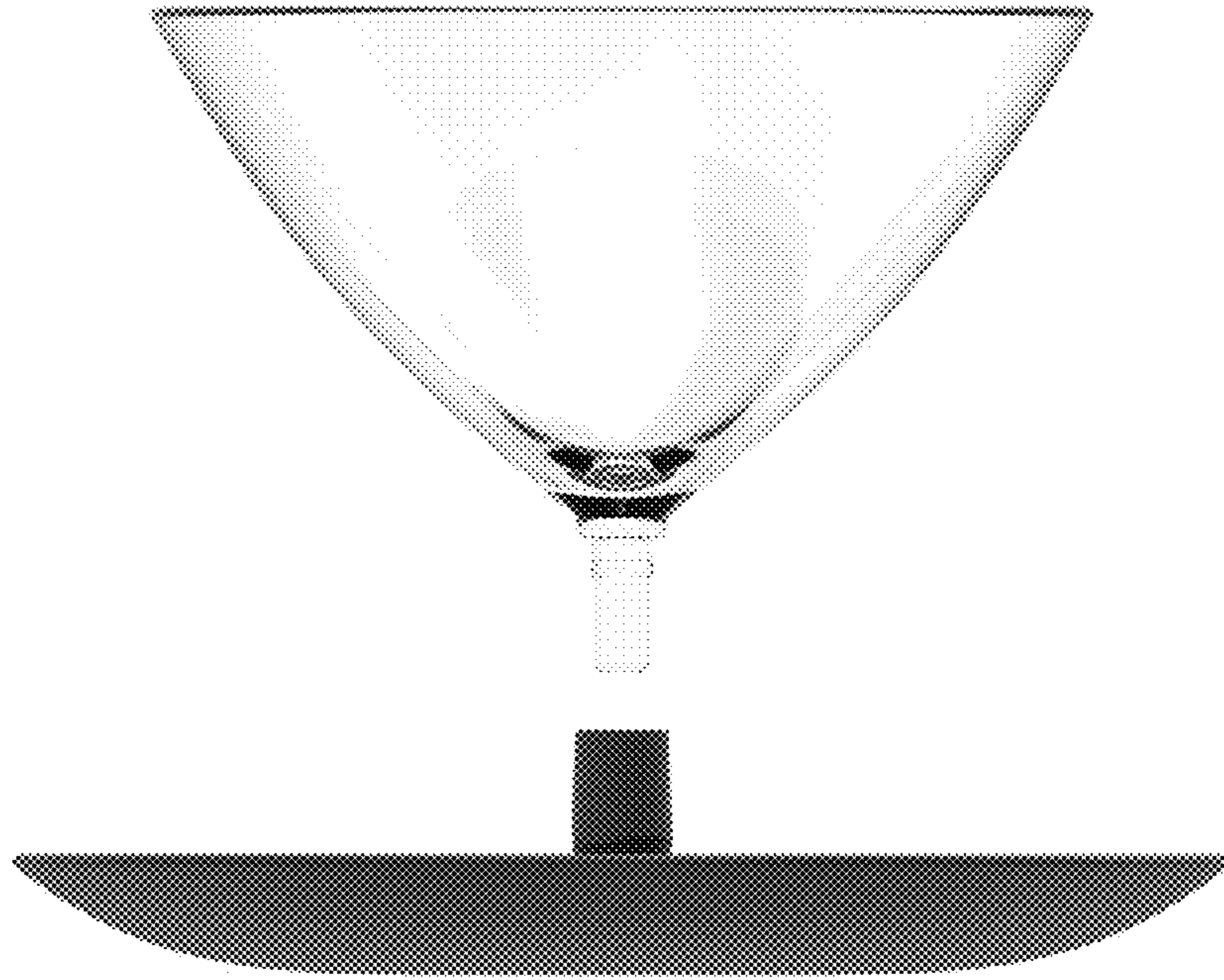

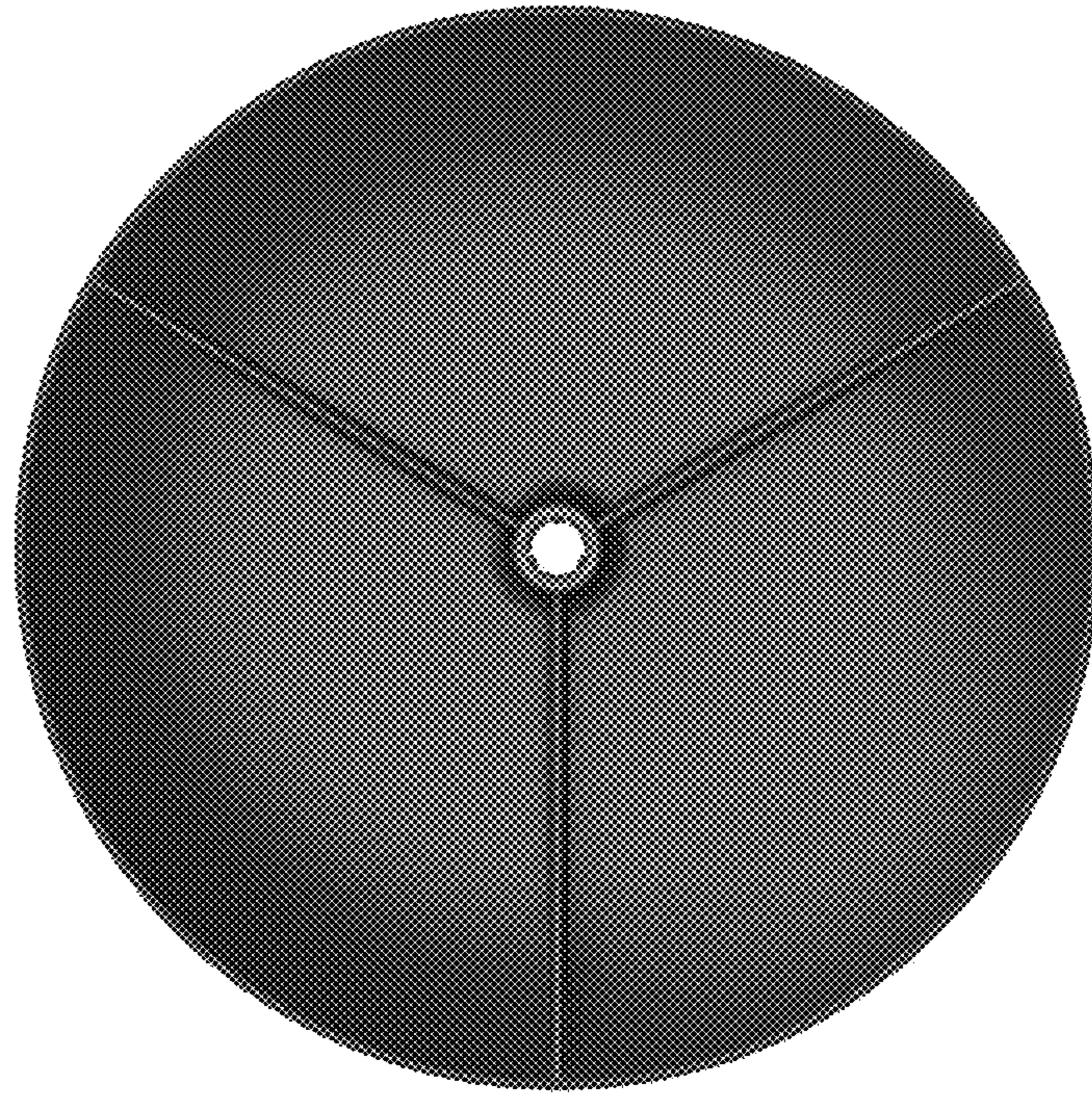
