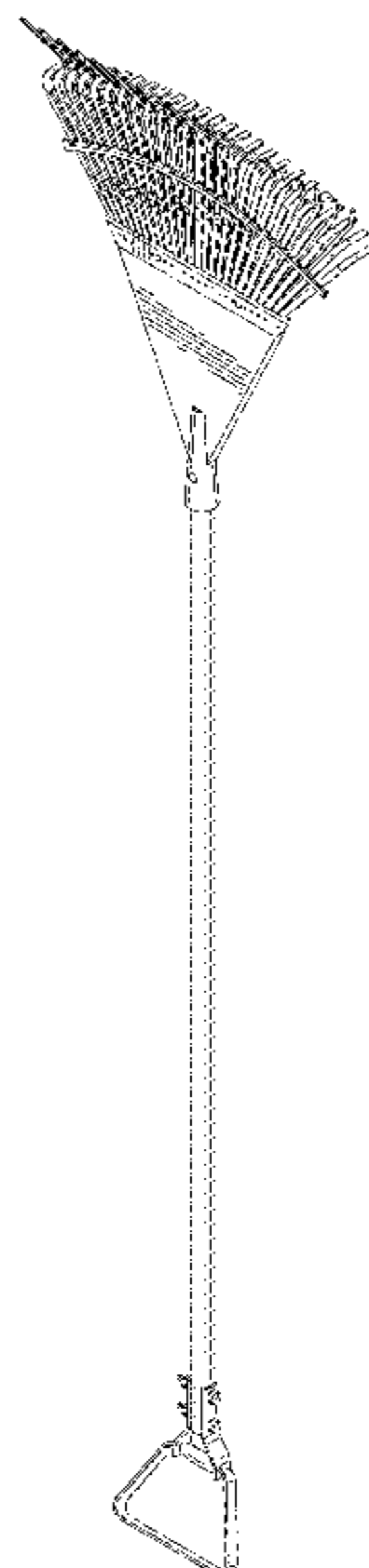
(57) **CLAIM**

The ornamental design for a dual tined rake, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a dual tined rake showing my new design;
FIG. 2 is a rear view of the dual tined rake;
FIG. 3 is a right side view of the dual tined rake;
FIG. 4 is a detailed right side view of the dual tined rake according to the circle 4 in FIG. 3;
FIG. 5 is a left side view of the dual tined rake;
FIG. 6 is a detailed left side view of the dual tined rake according to the circle 6 in FIG. 5;
FIG. 7 is a top view of the dual tined rake;
FIG. 8 is a bottom view of the dual tined rake; and,
FIG. 9 is a top front side perspective view of the dual tined rake.

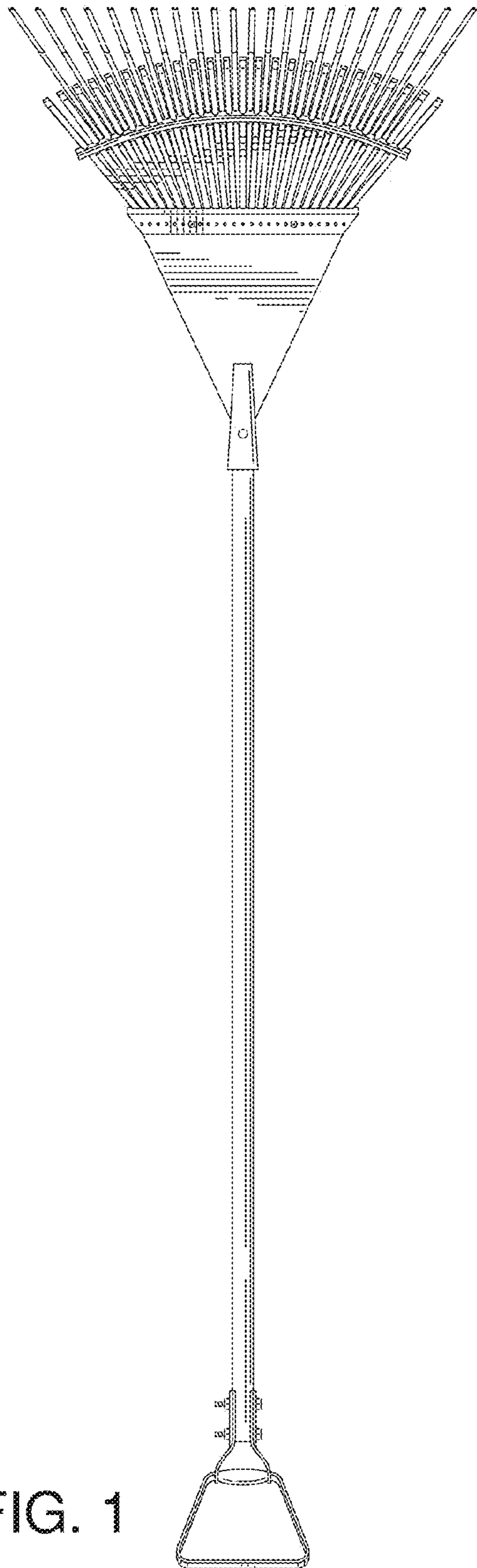

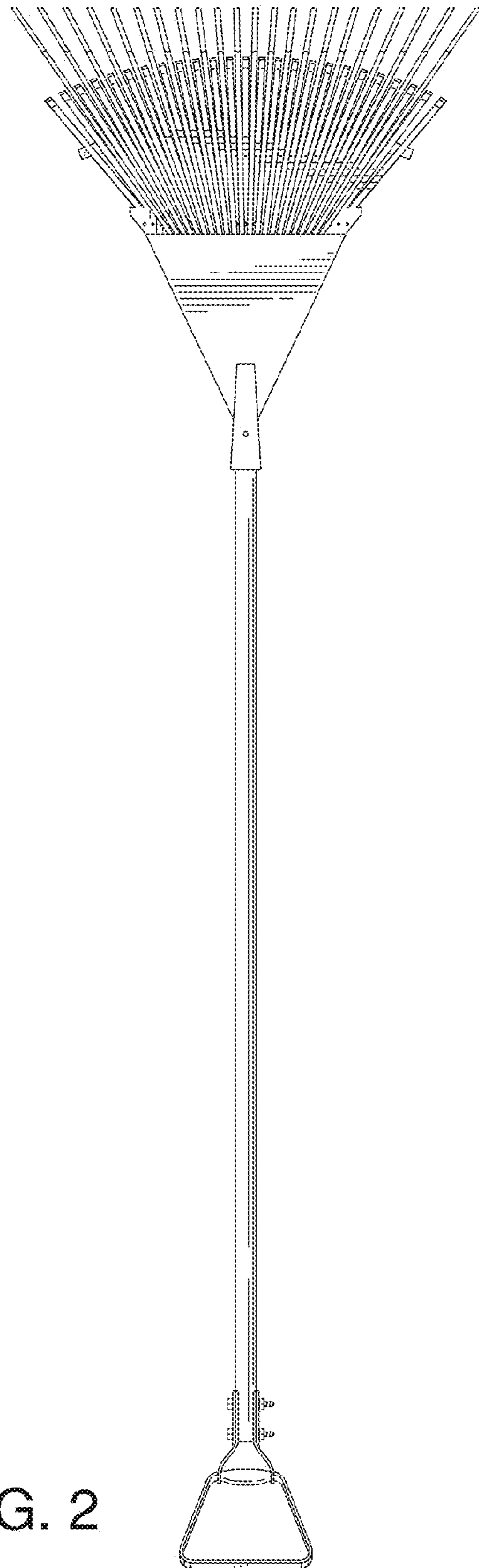
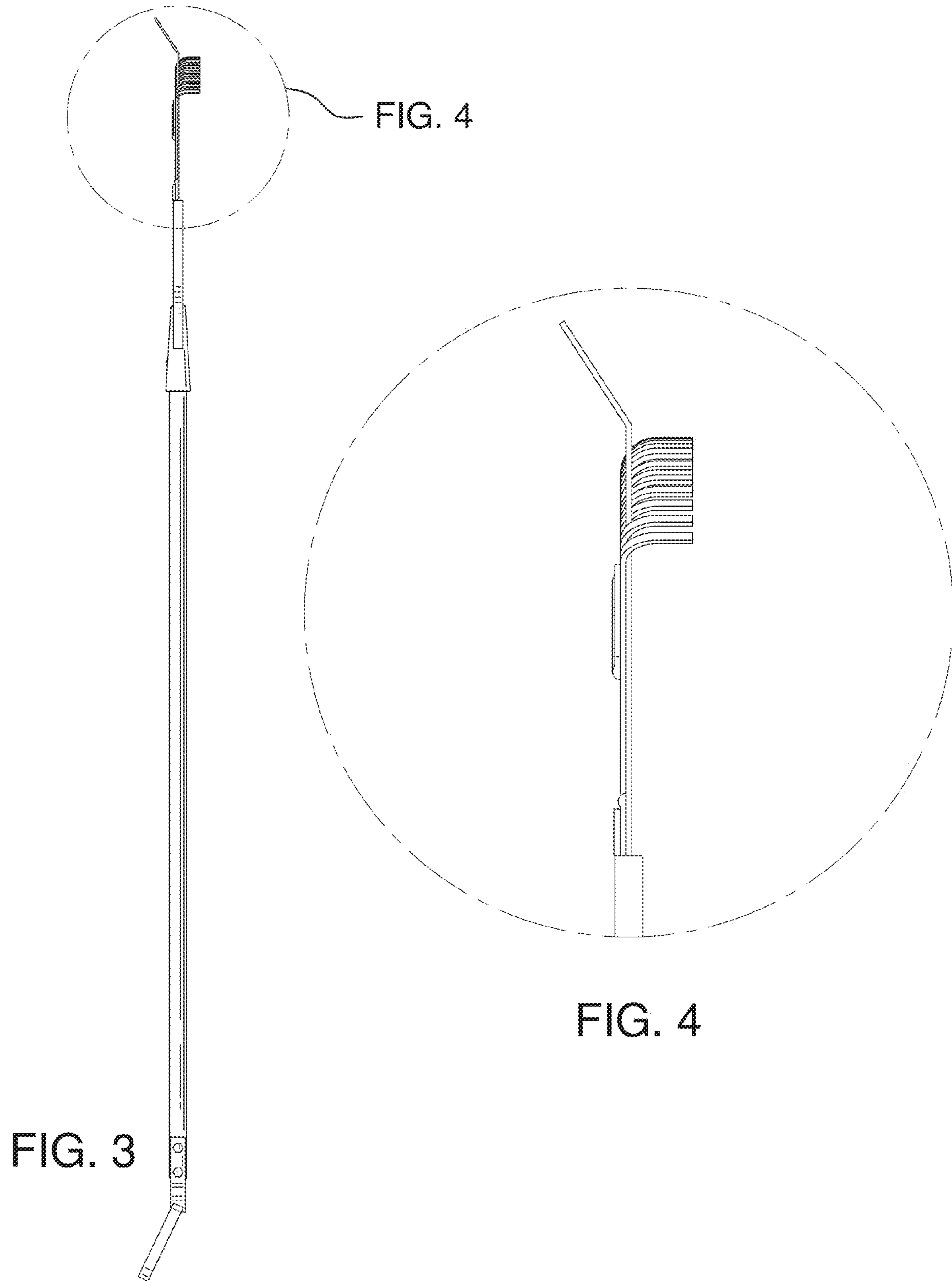
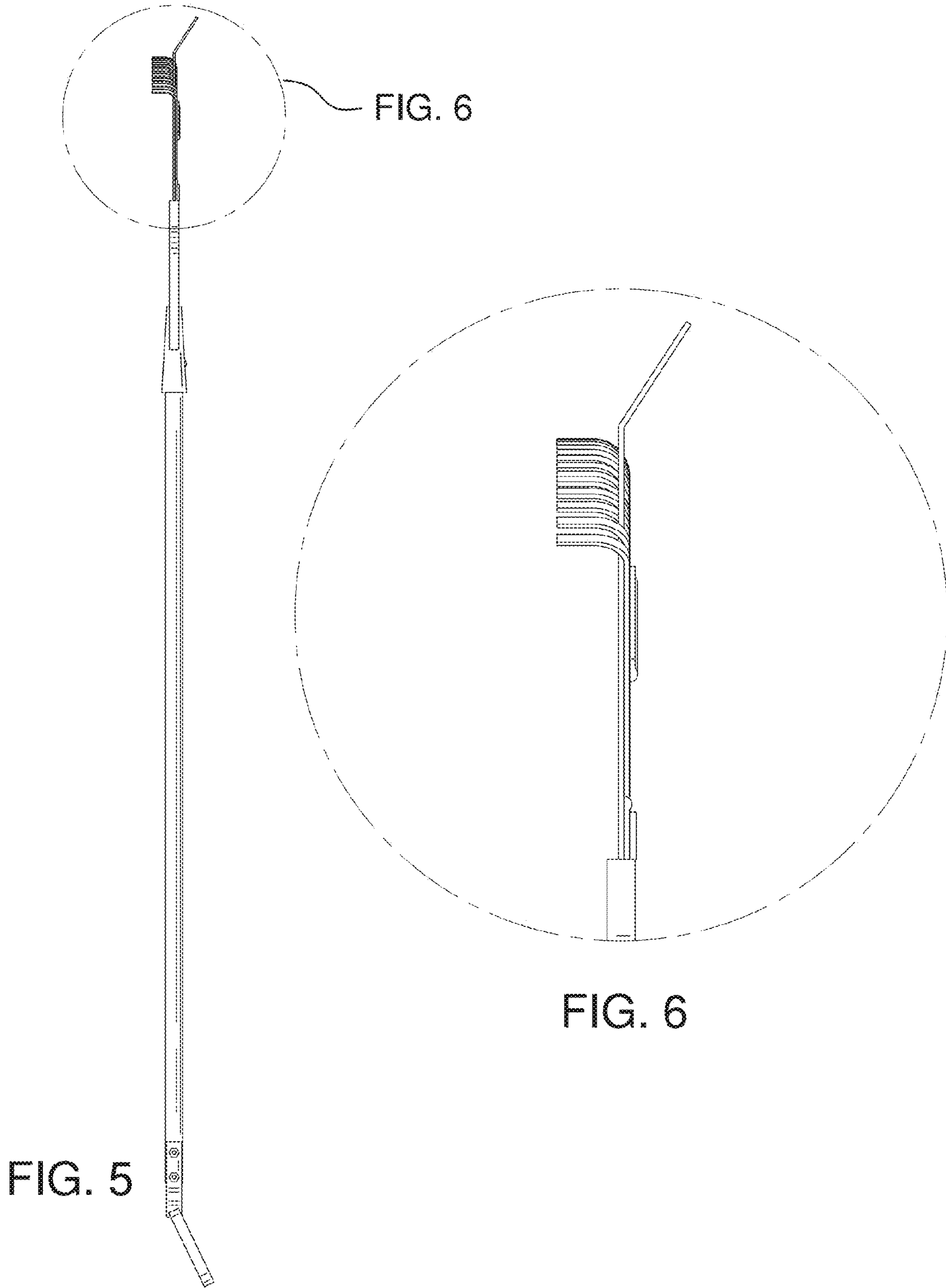

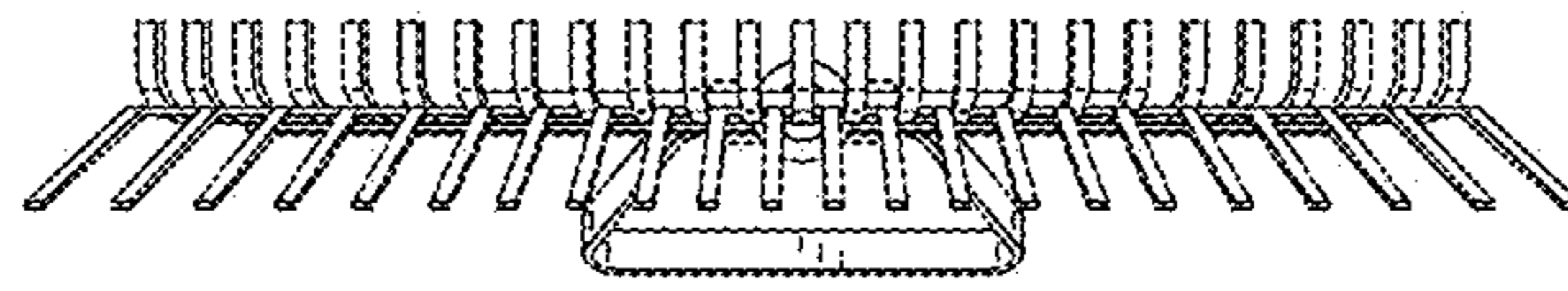

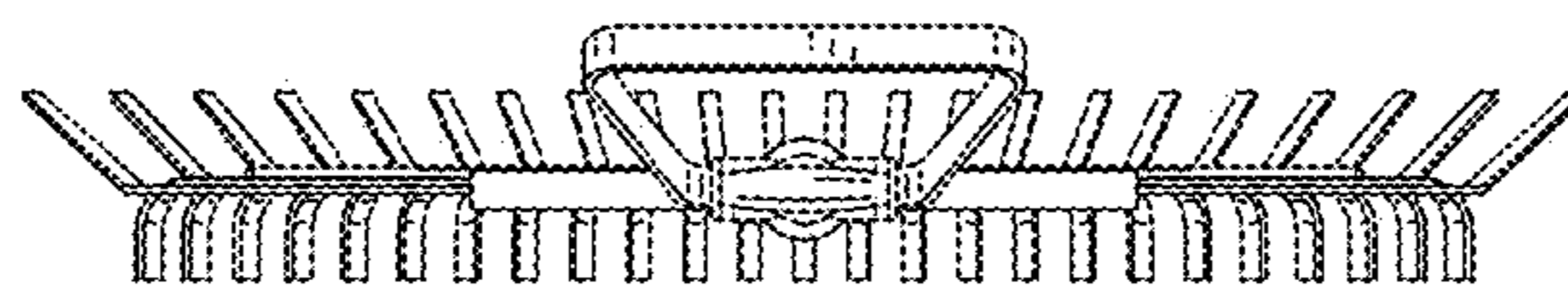
