FIG. 10 depict an exploded view of the vacuum shroud attachment assembly from directly below.

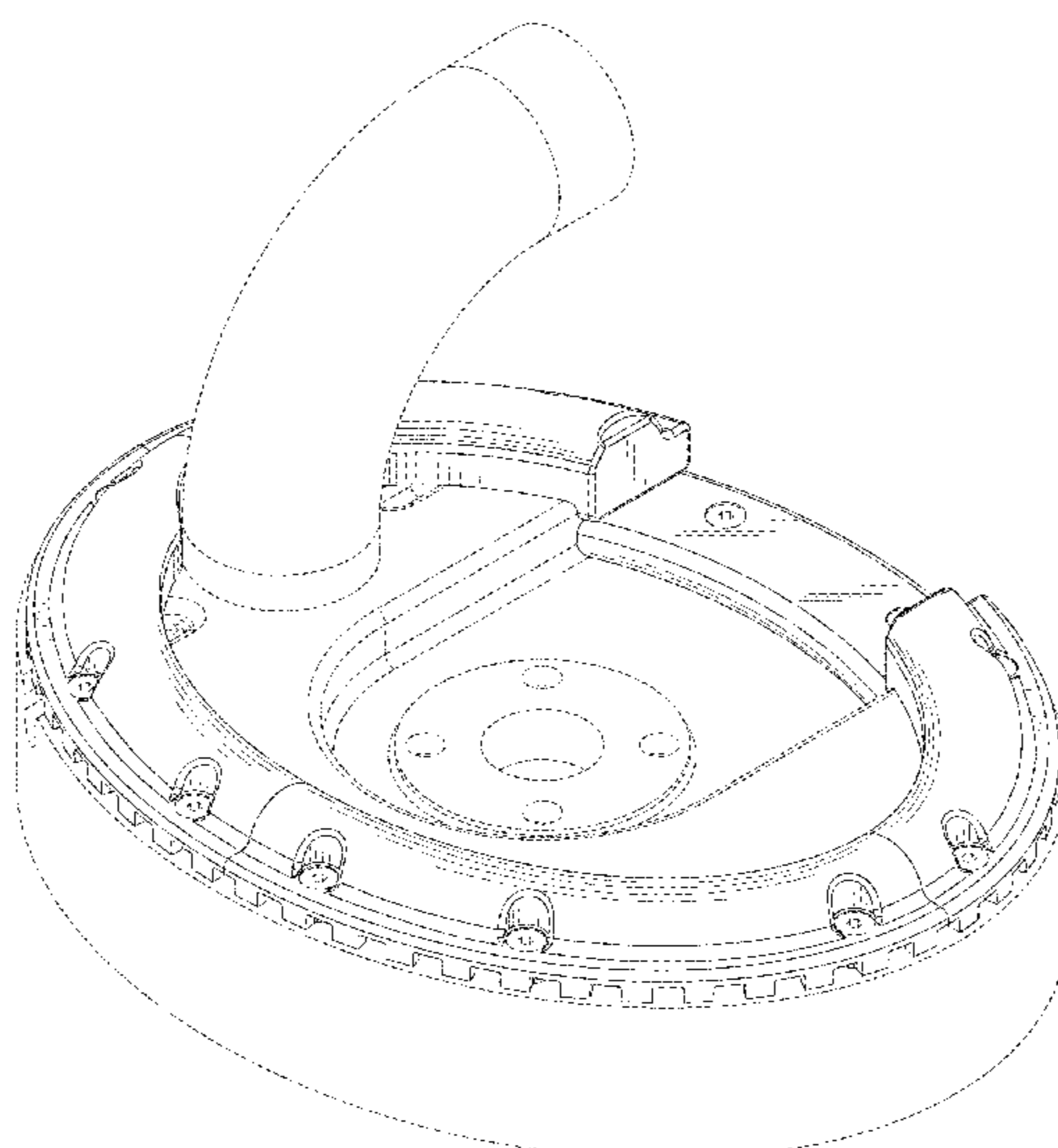

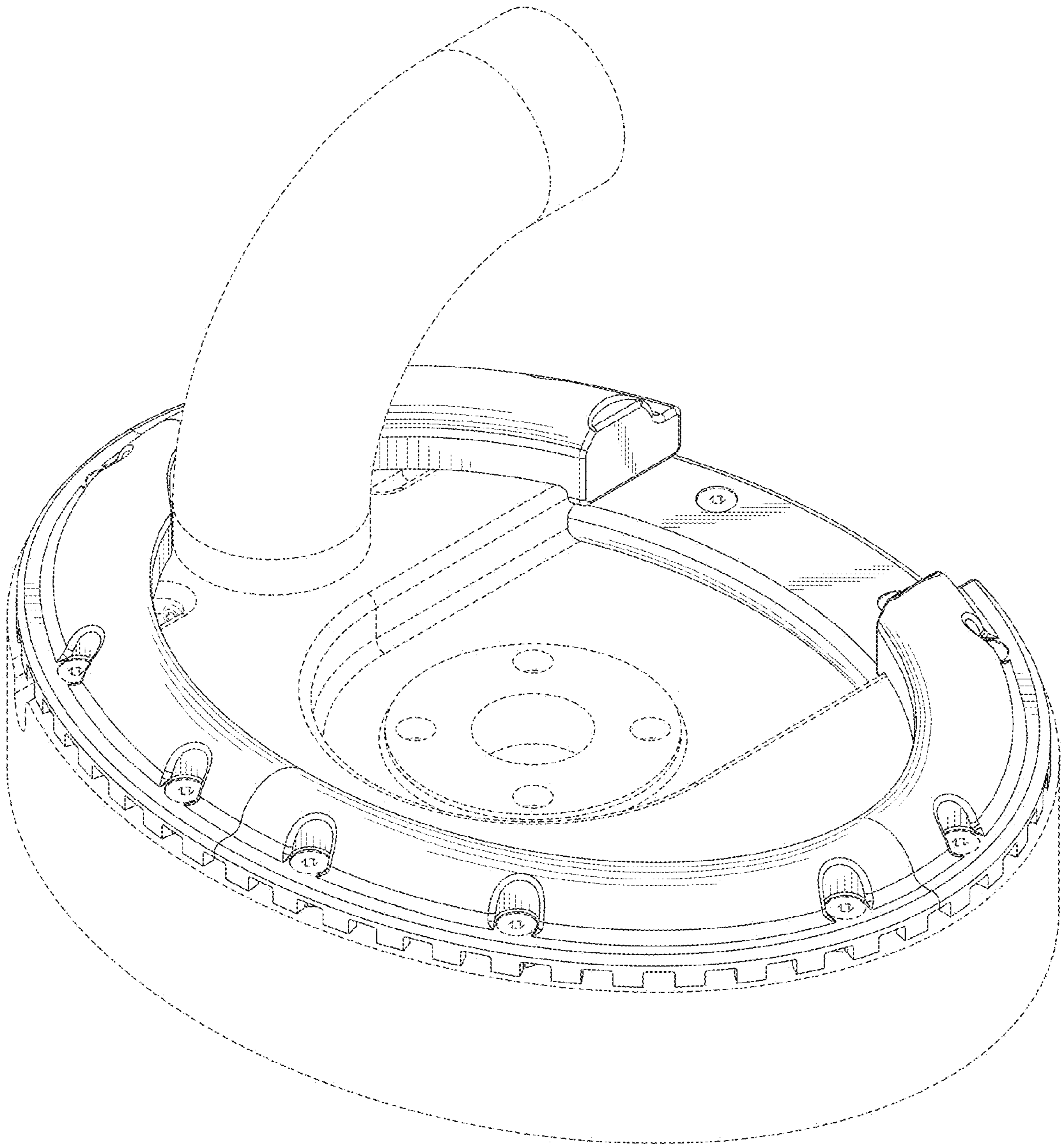

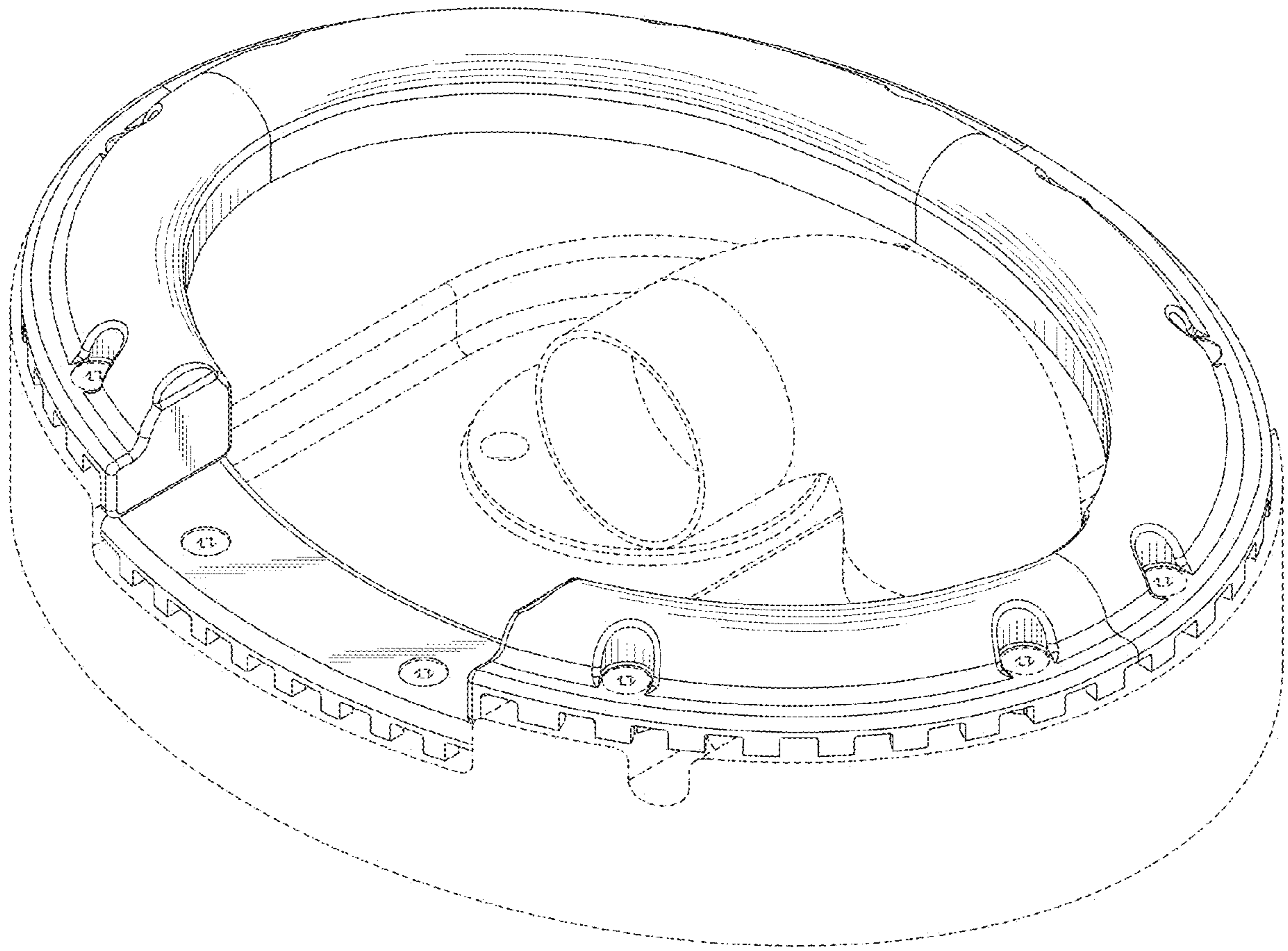

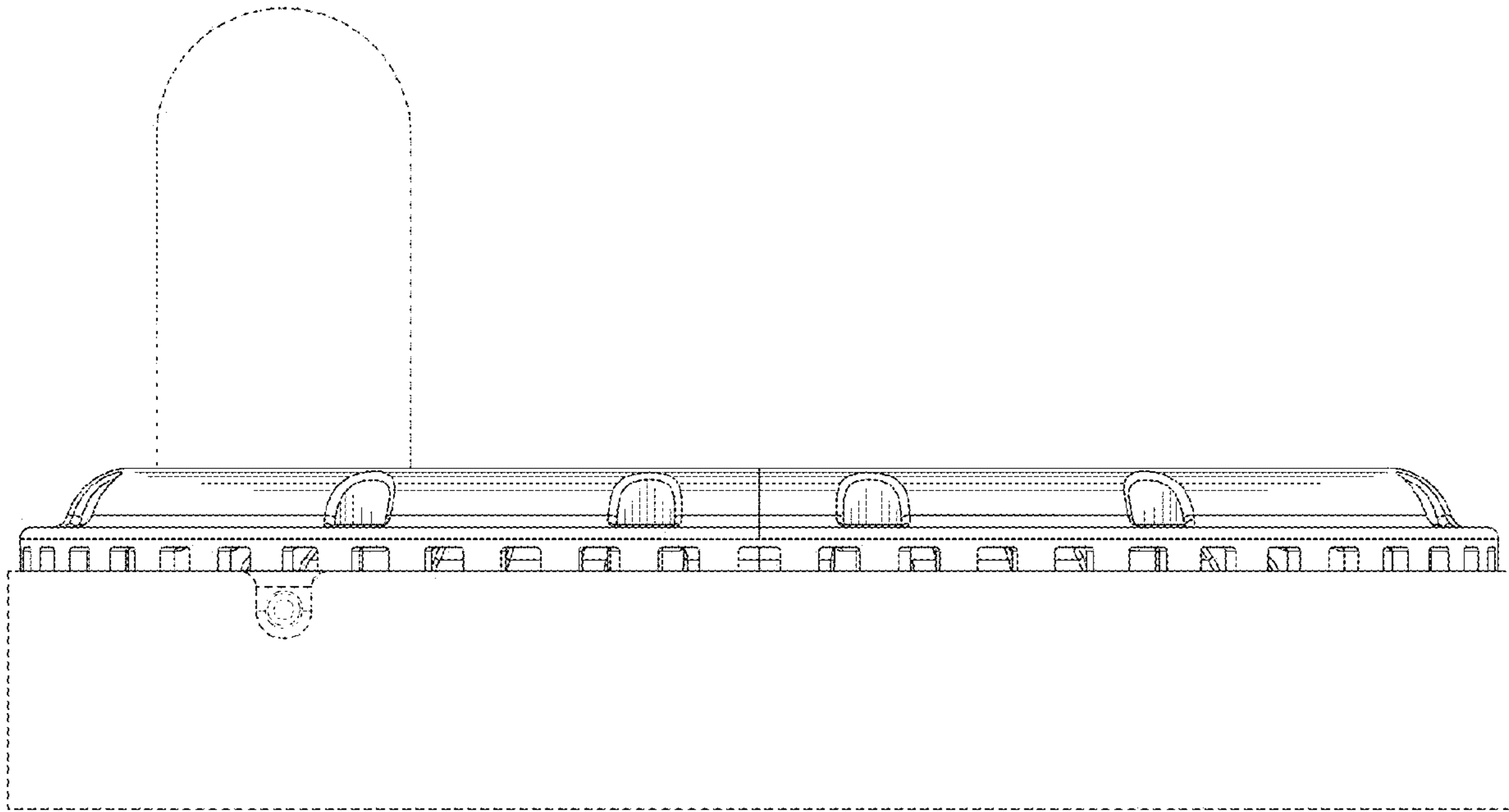

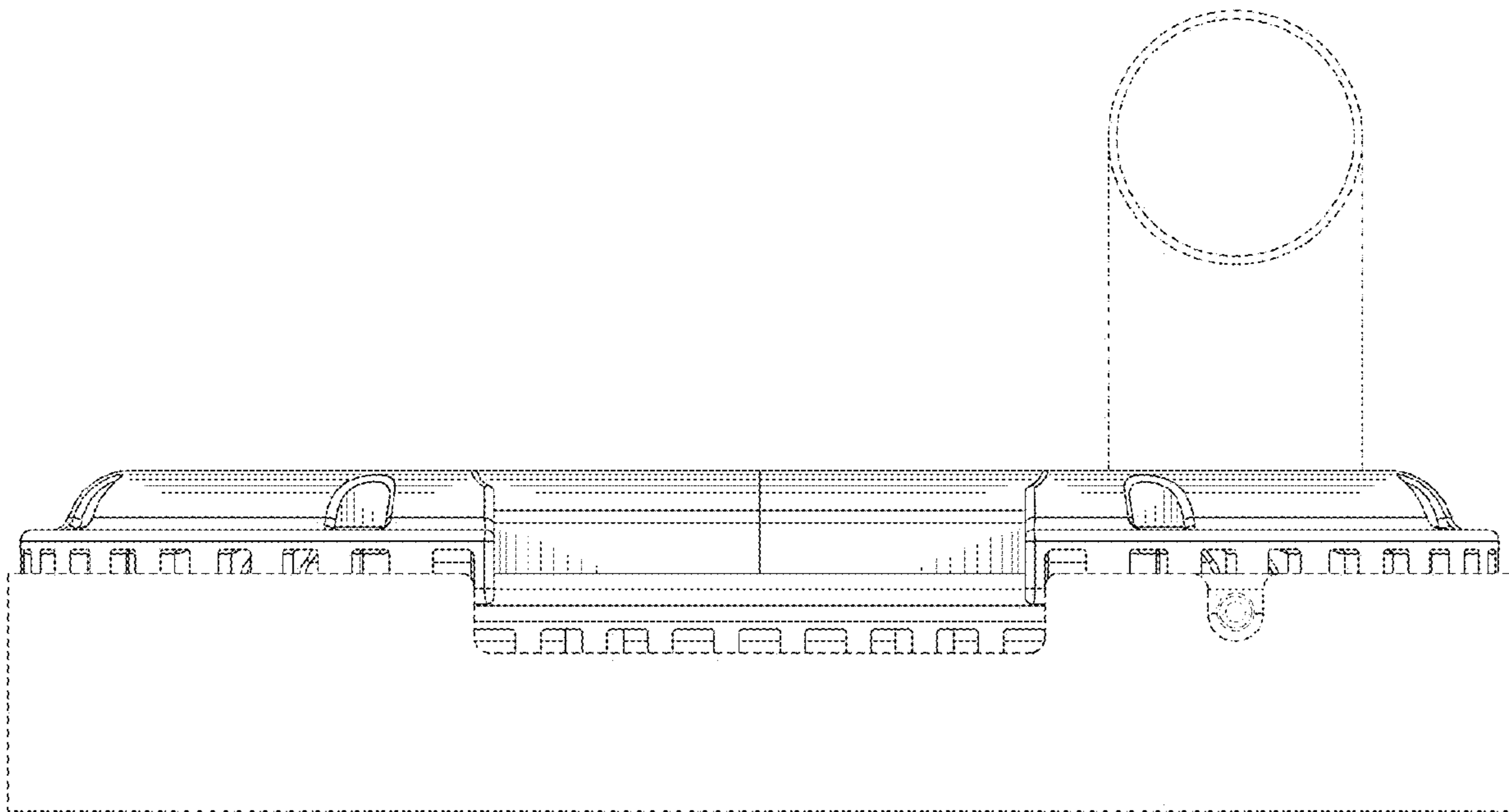

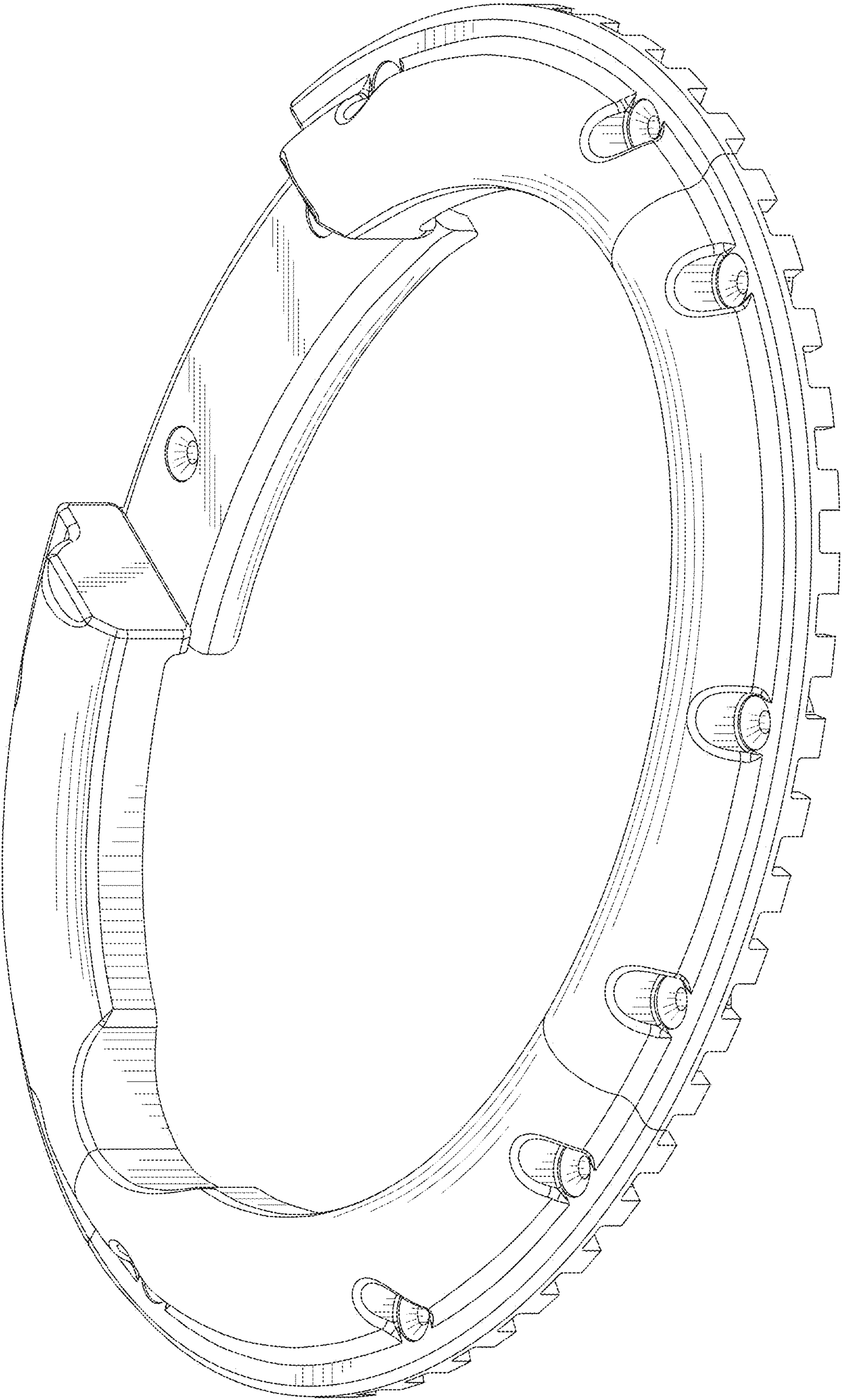

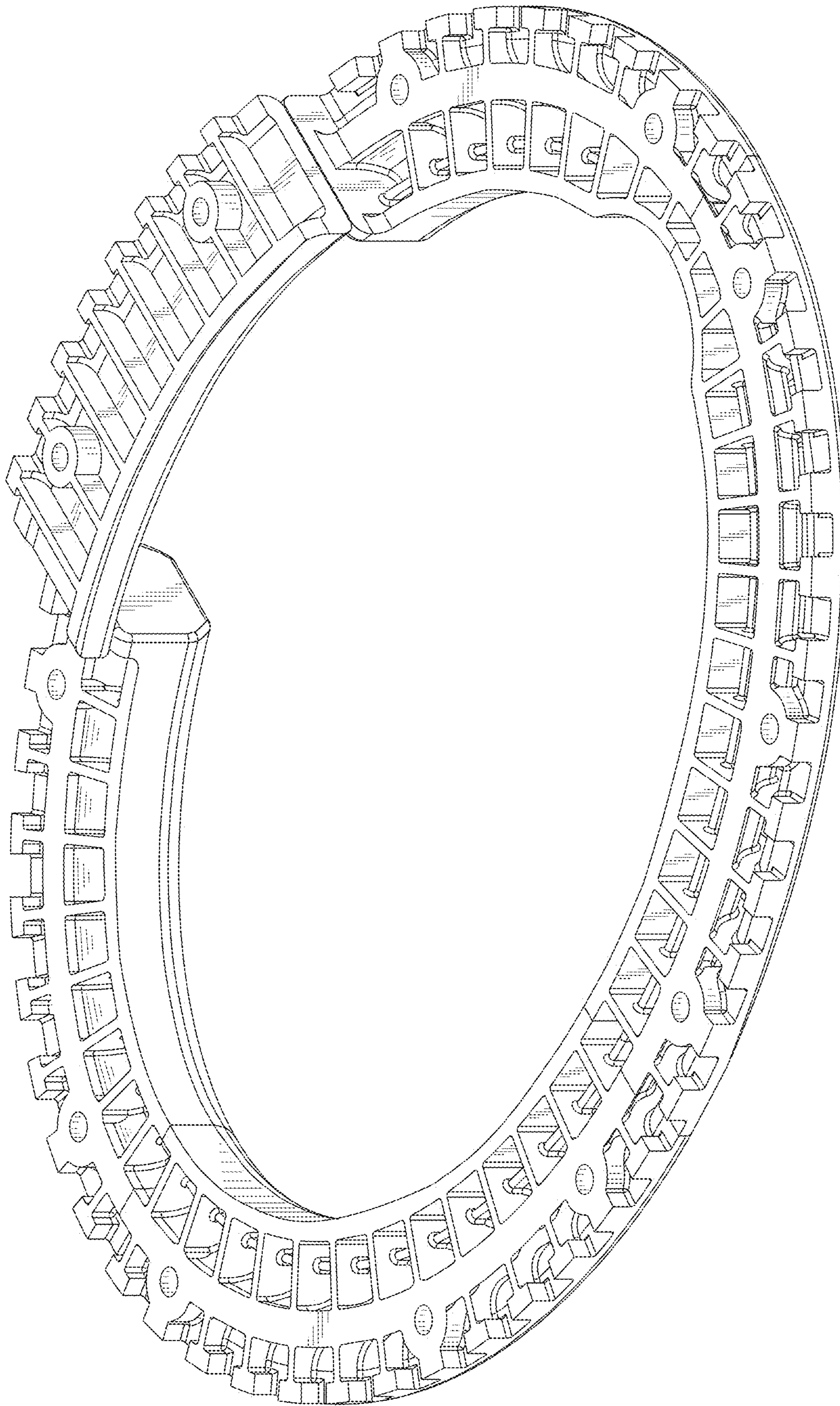

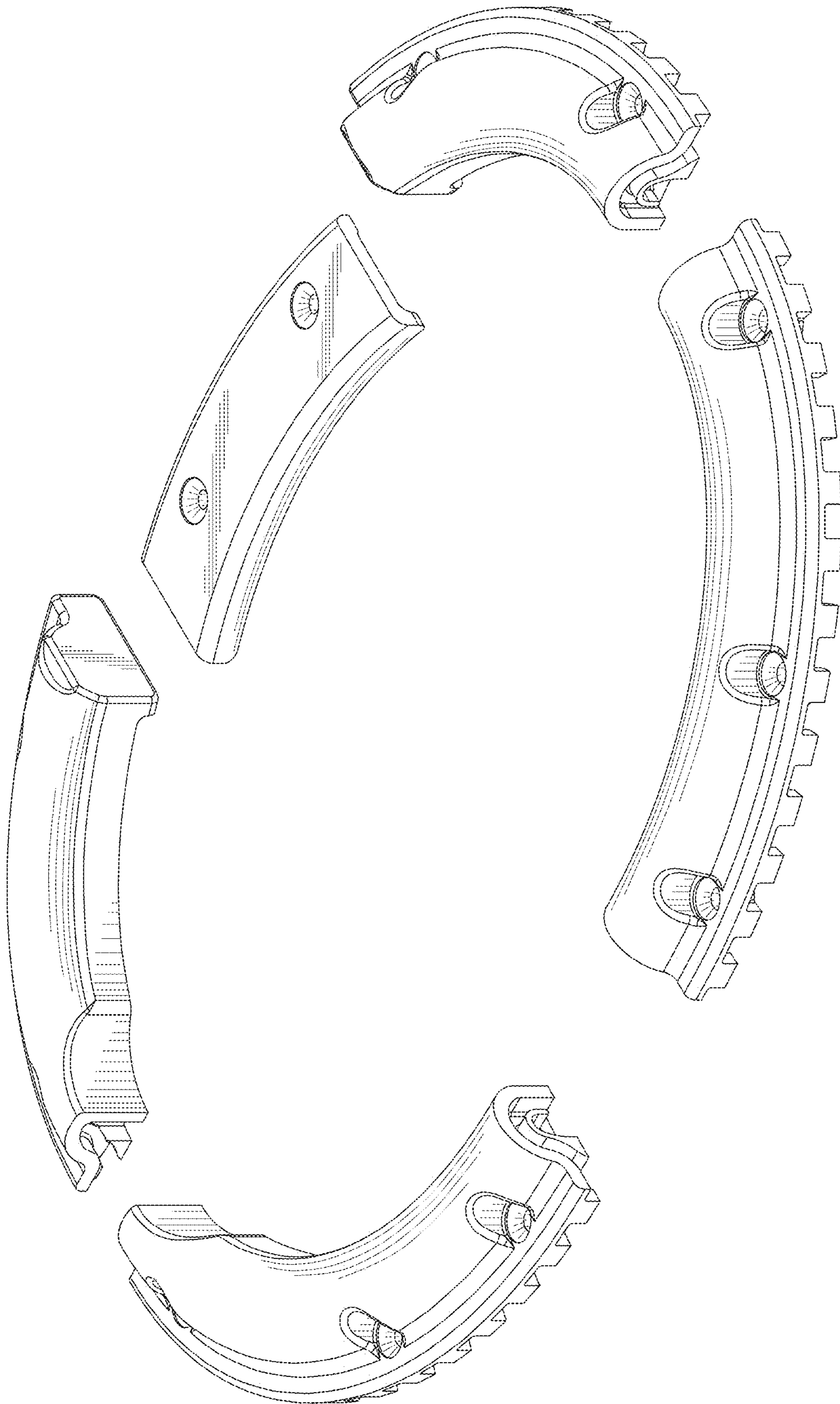

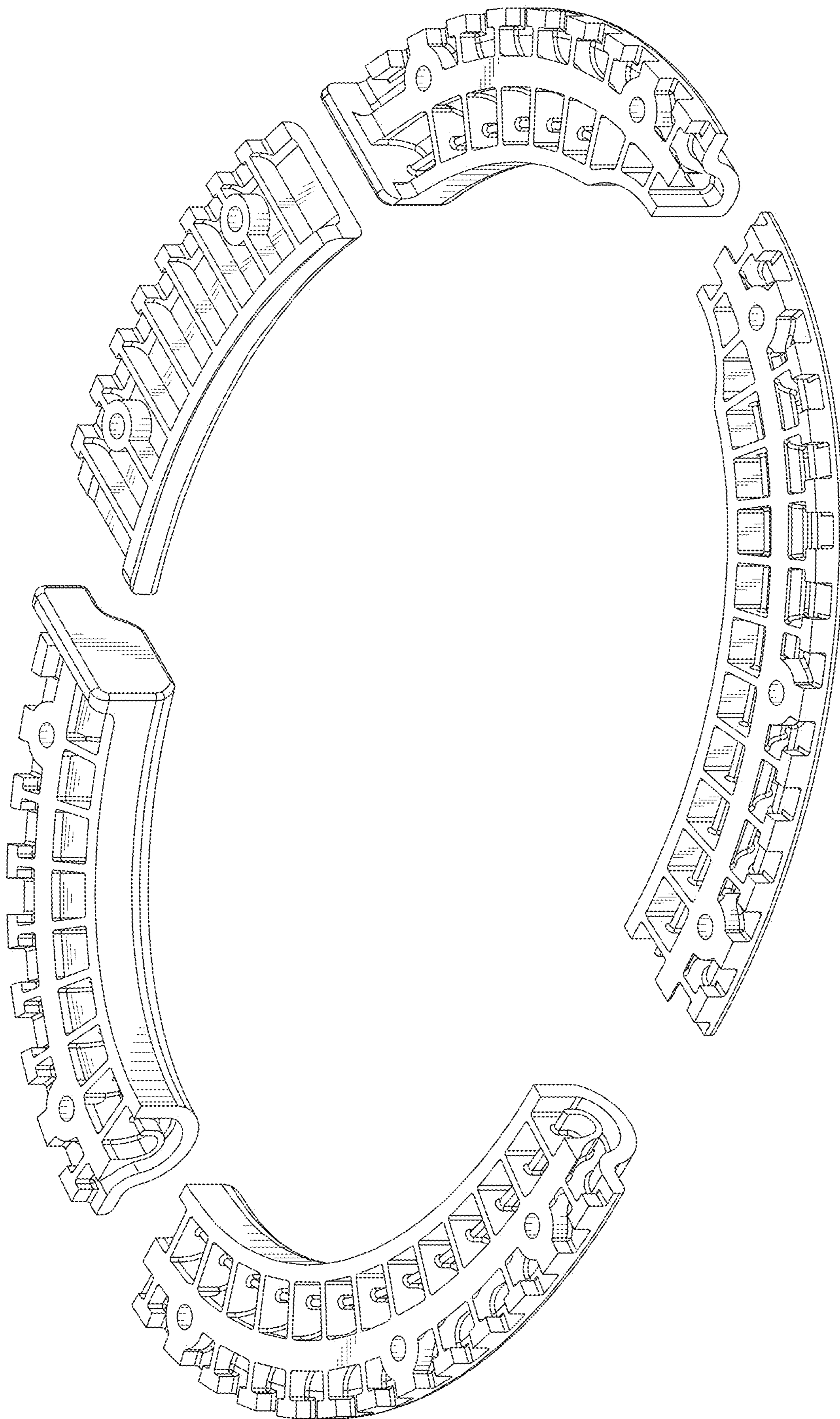

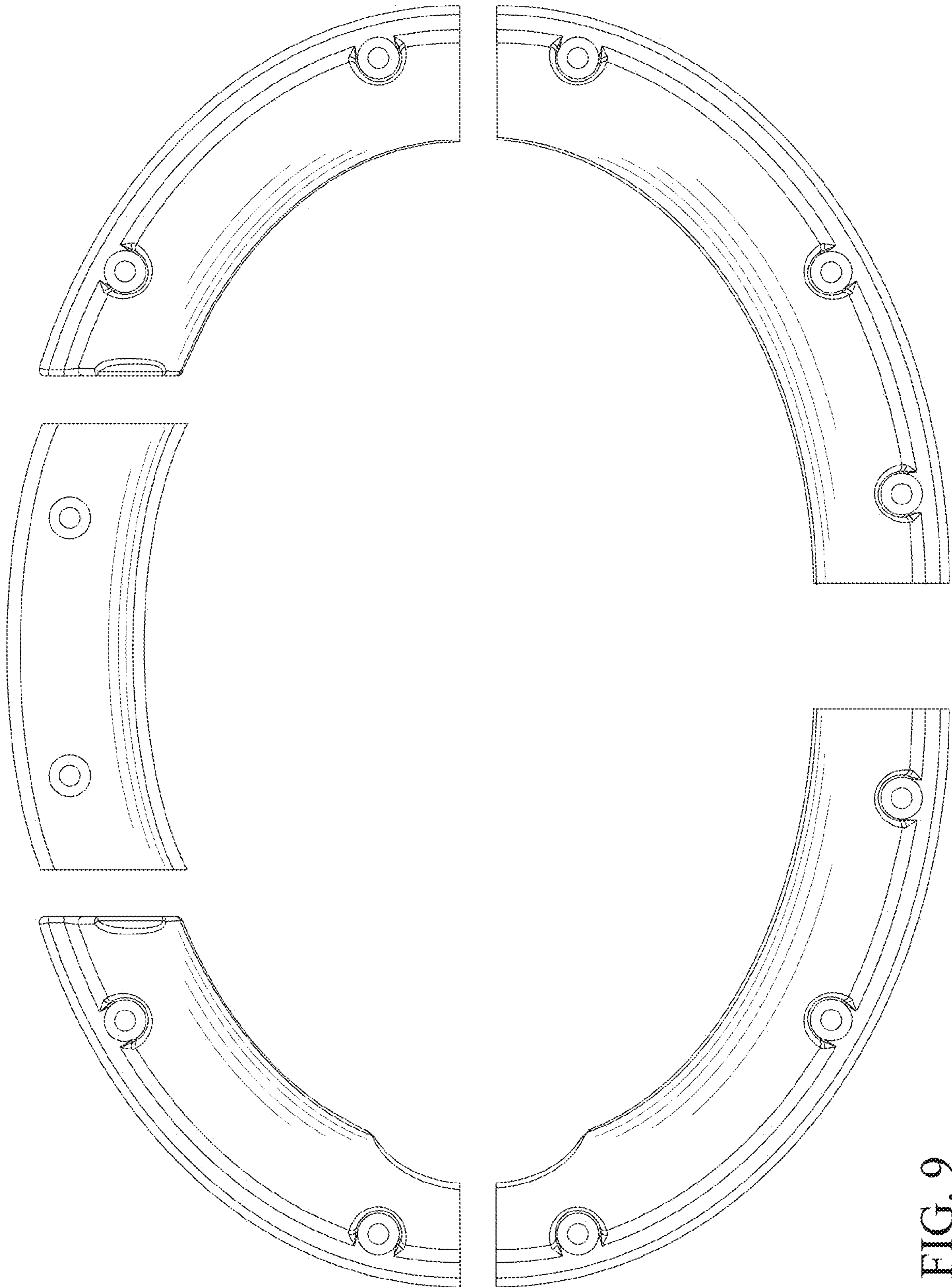

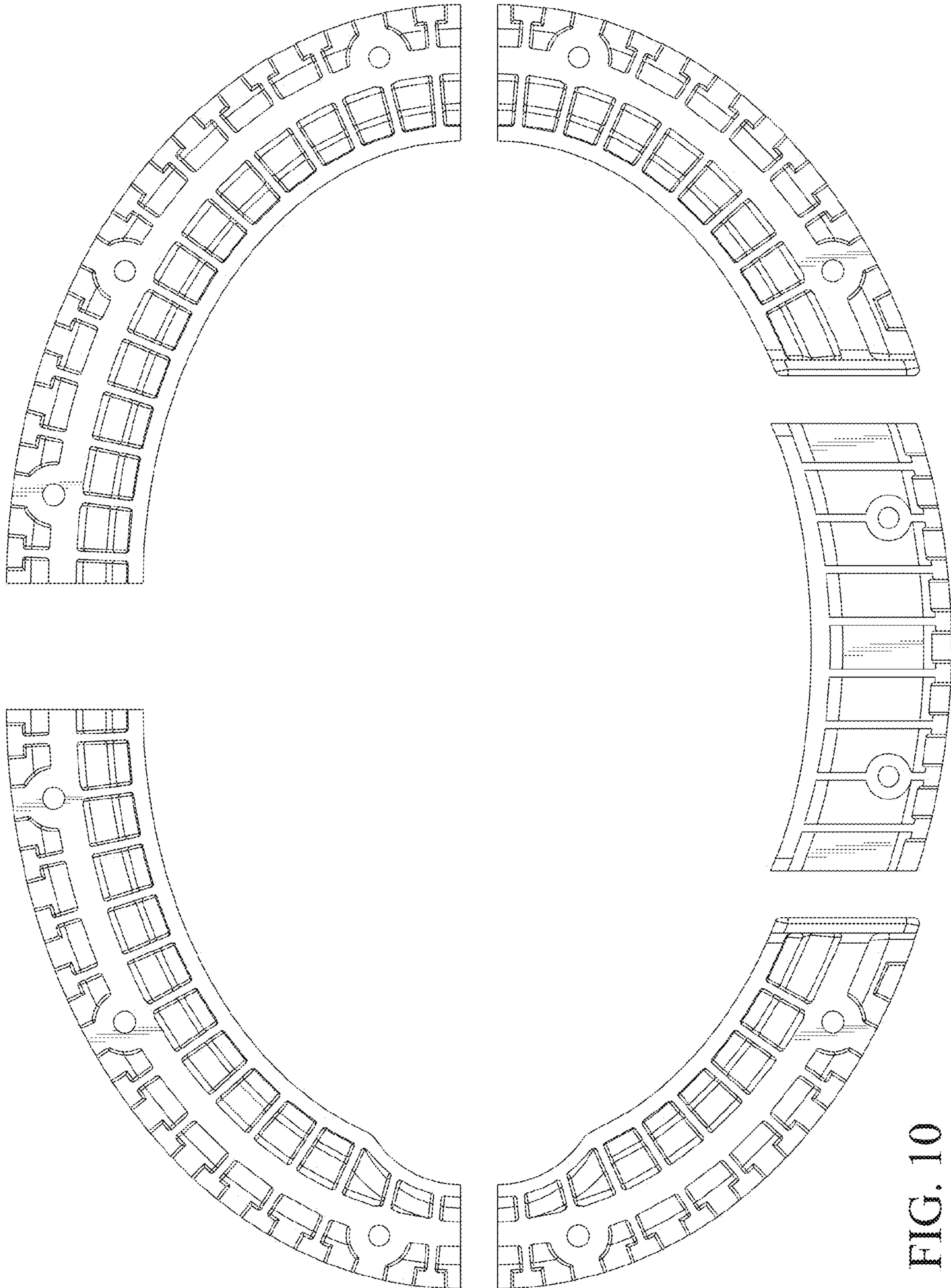
