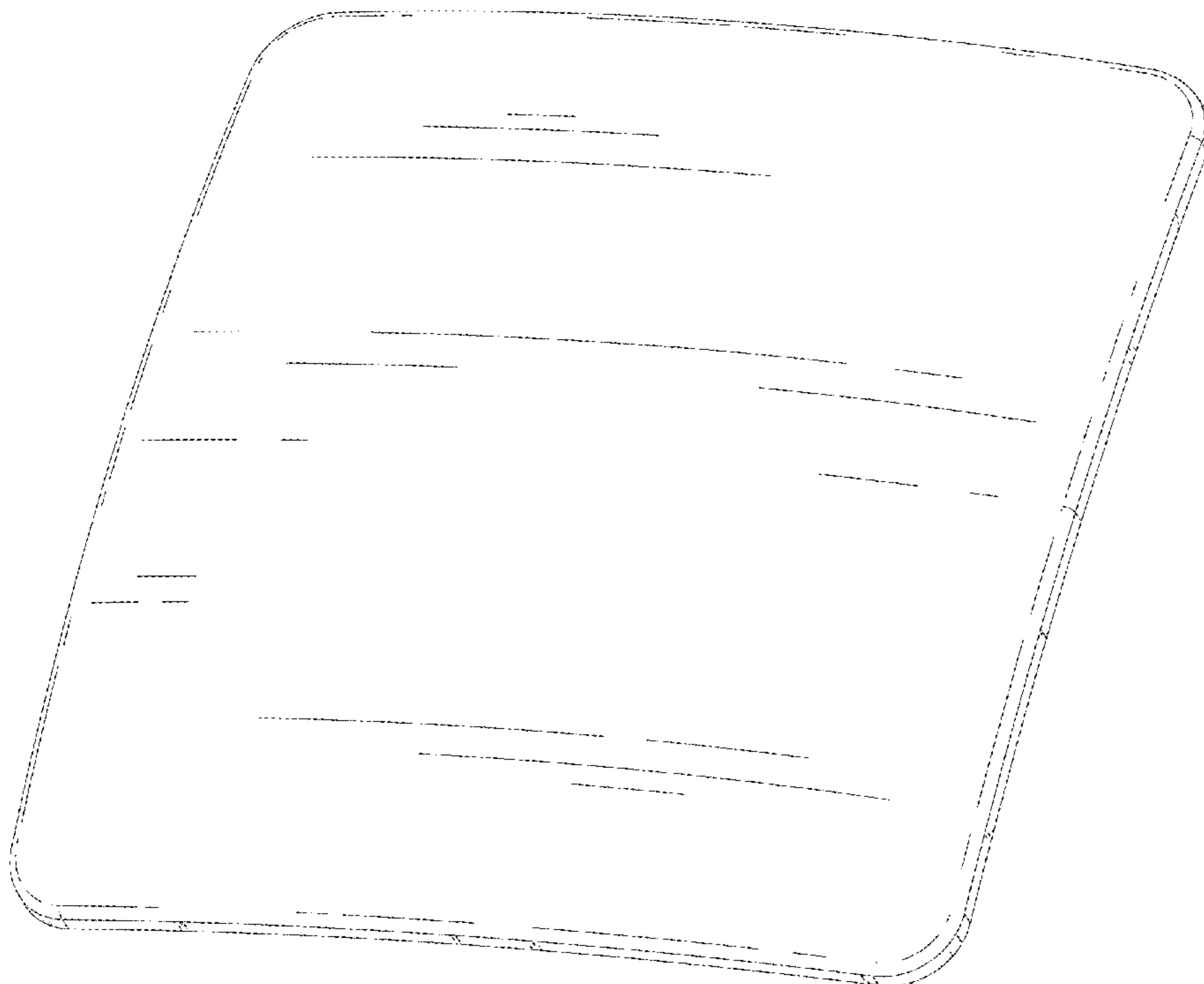
(57) **CLAIM**

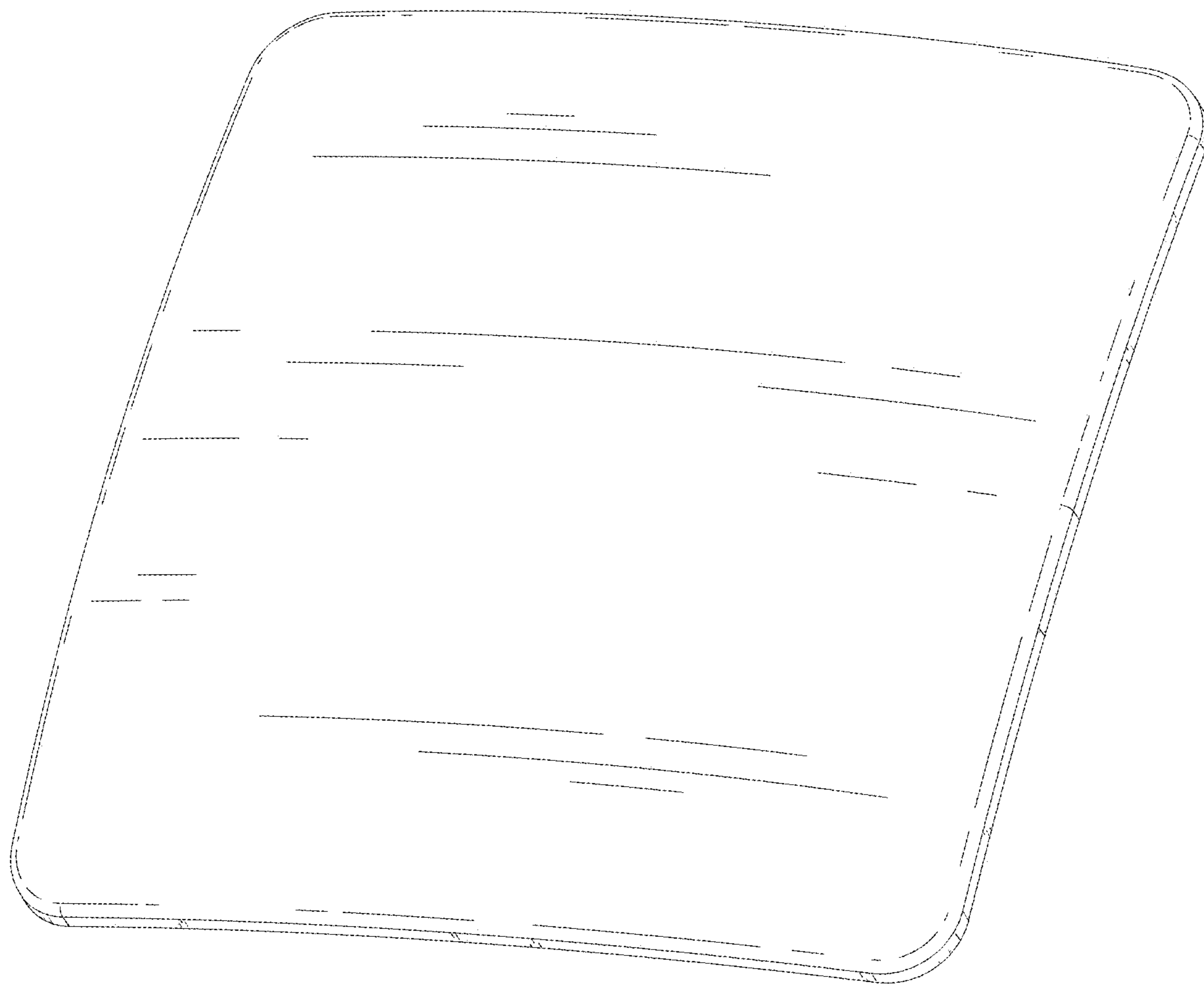
The ornamental design for a cover for ventilation housing, as shown and described.

**DESCRIPTION**

FIG. 1 is an axonometric top, front, right view a cover for ventilation housing showing my new design.

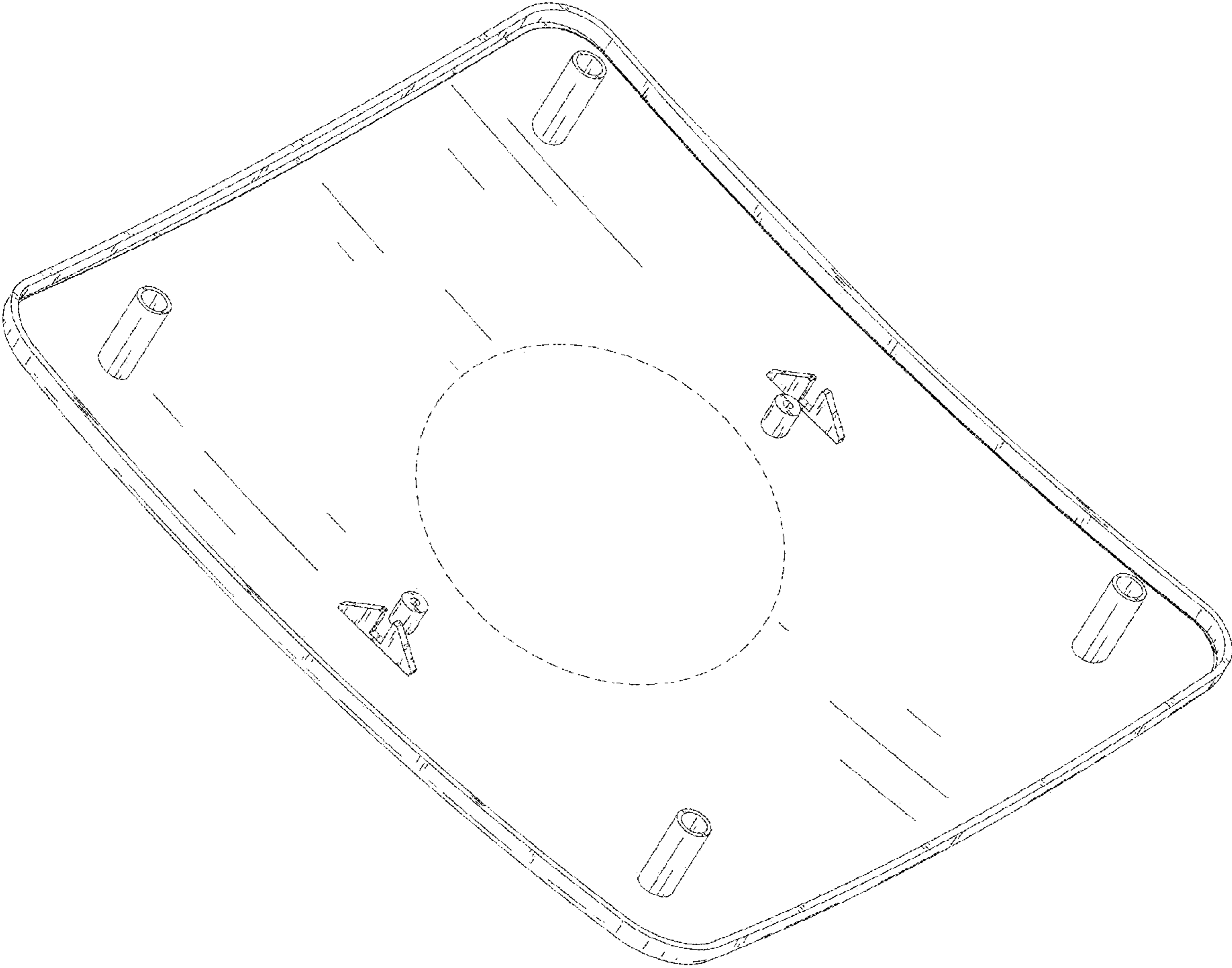
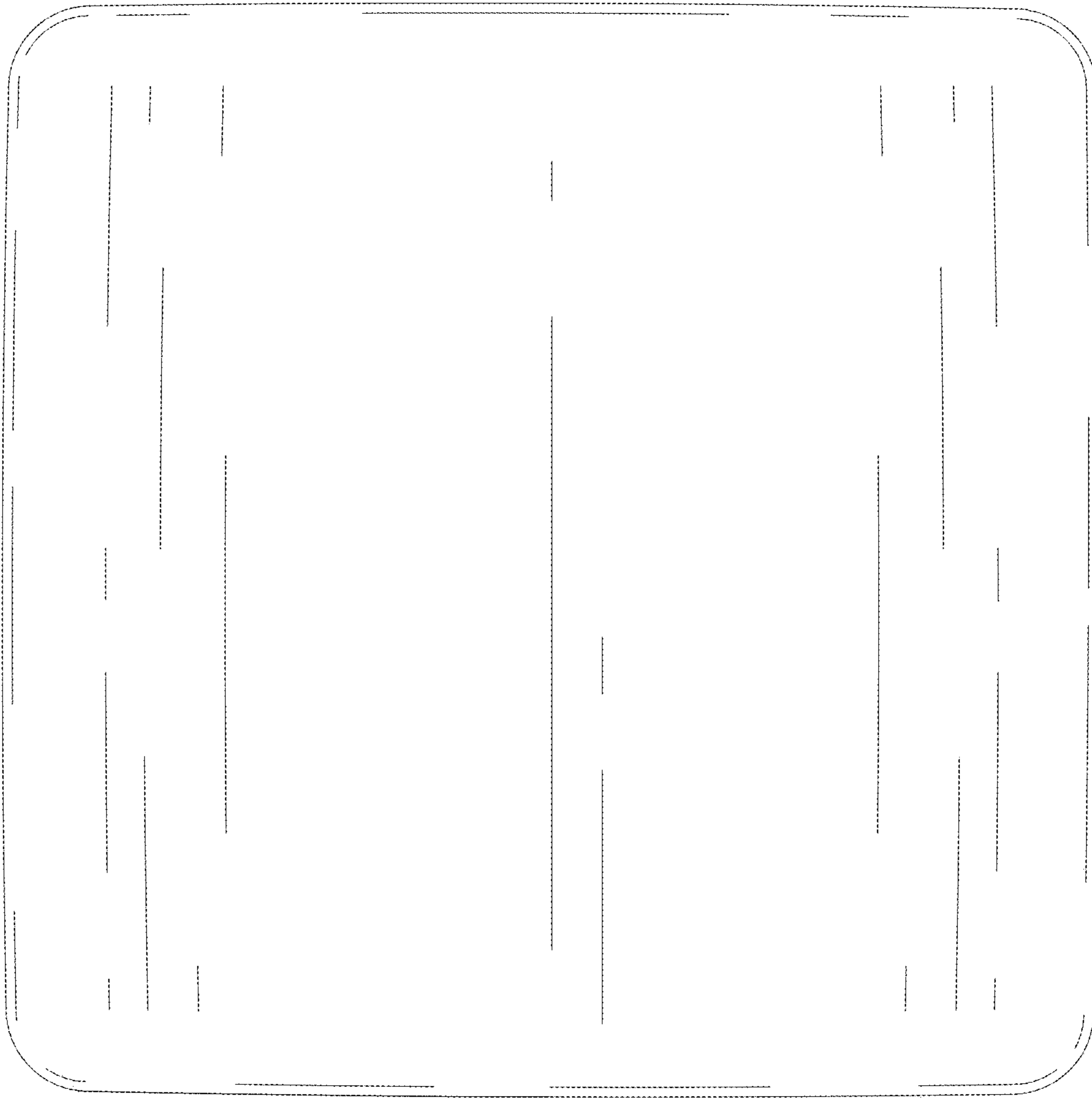
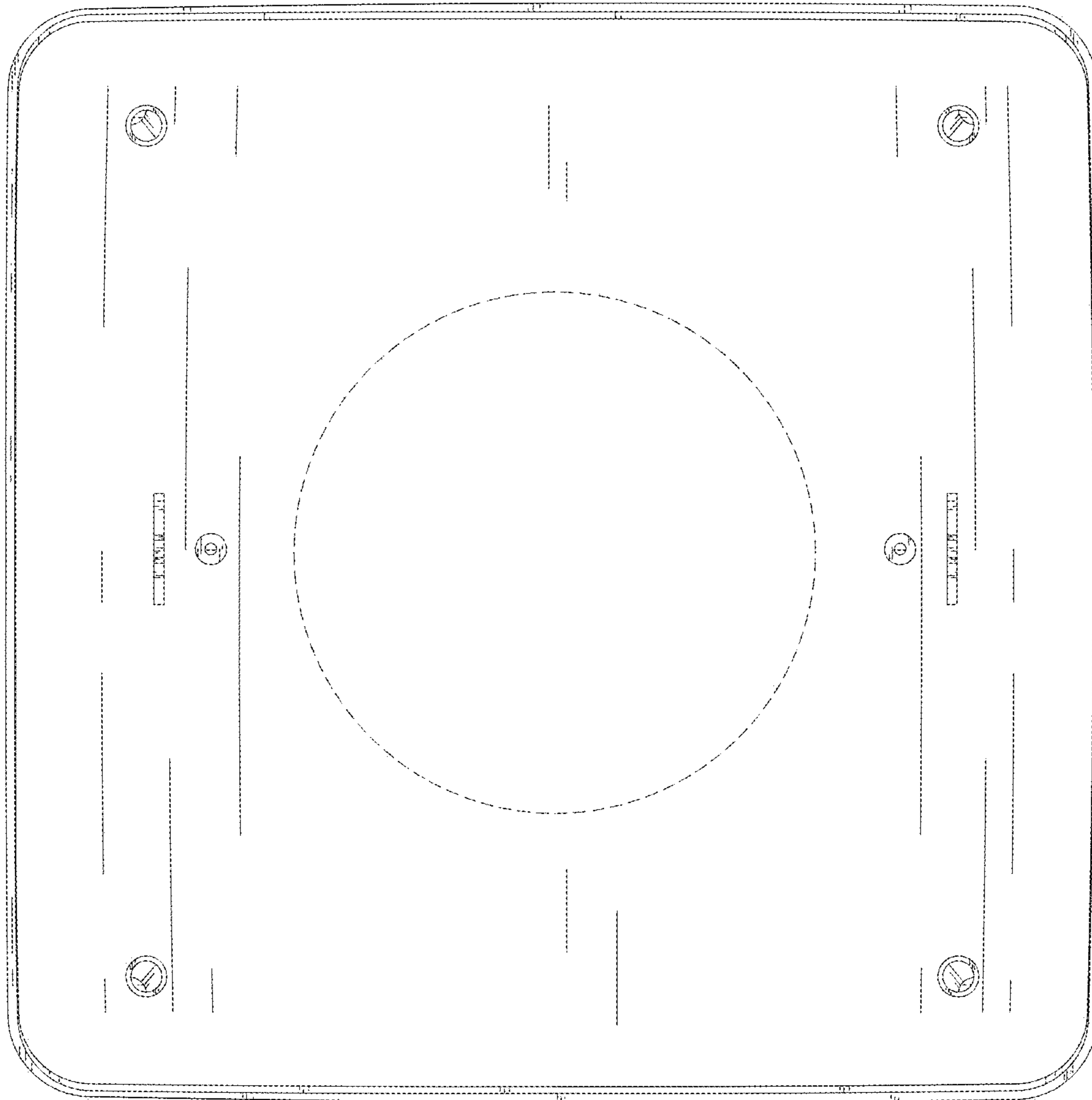


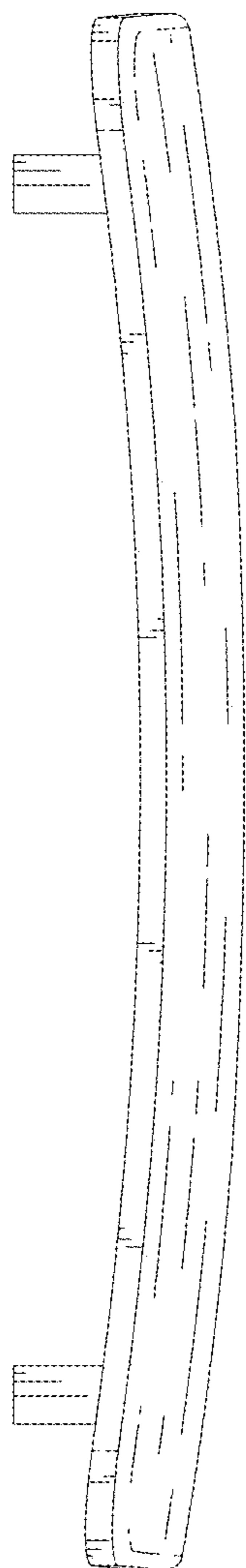

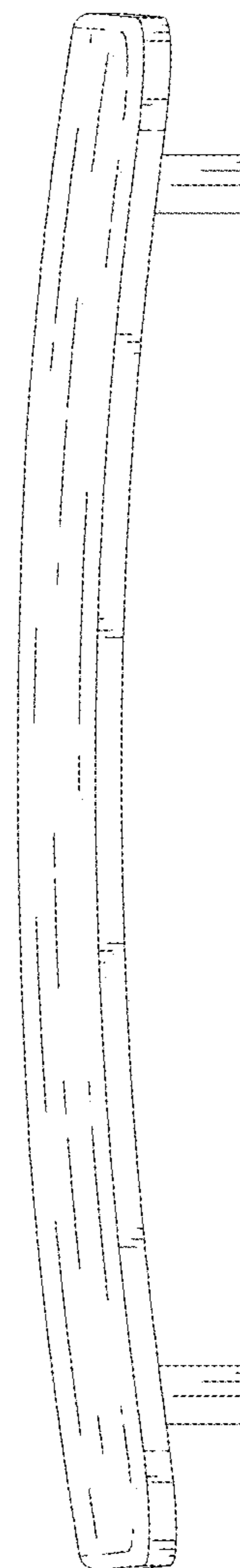

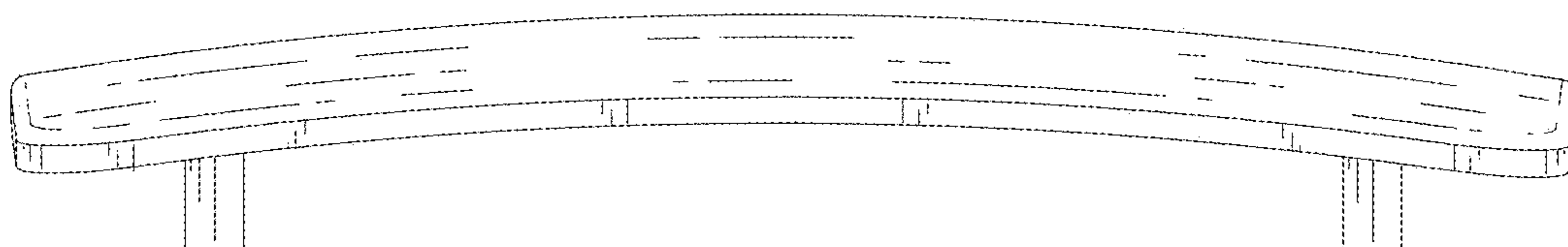

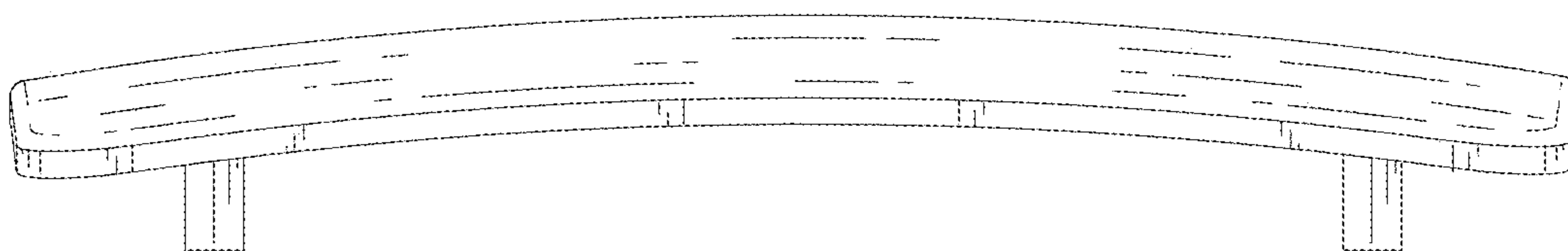
