The ornamental design for a feminine hygiene article pack-  
age, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a first embodiment of a feminine hygiene article package embodying the new design;

FIG. 2 is a front view of the design shown in FIG. 1;

FIG. 3 is a right side view of the design shown in FIG. 1;

FIG. 4 is a back view of the design shown in FIG. 1;

FIG. 5 is a left side view of the design shown in FIG. 1;

FIG. 6 is a top view of the design in FIG. 1; and

FIG. 7 is a bottom view of the design in FIG. 1.

FIG. 8 is a front perspective view of another embodiment of a feminine hygiene article package embodying the new design;

FIG. 9 is a front view of the design shown in FIG. 8;

FIG. 10 is a right side view of the design shown in FIG. 8;

FIG. 11 is a back view of the design shown in FIG. 8;

FIG. 12 is a left side view of the design shown in FIG. 8;

FIG. 14 is a bottom view of the design in FIG. 8.

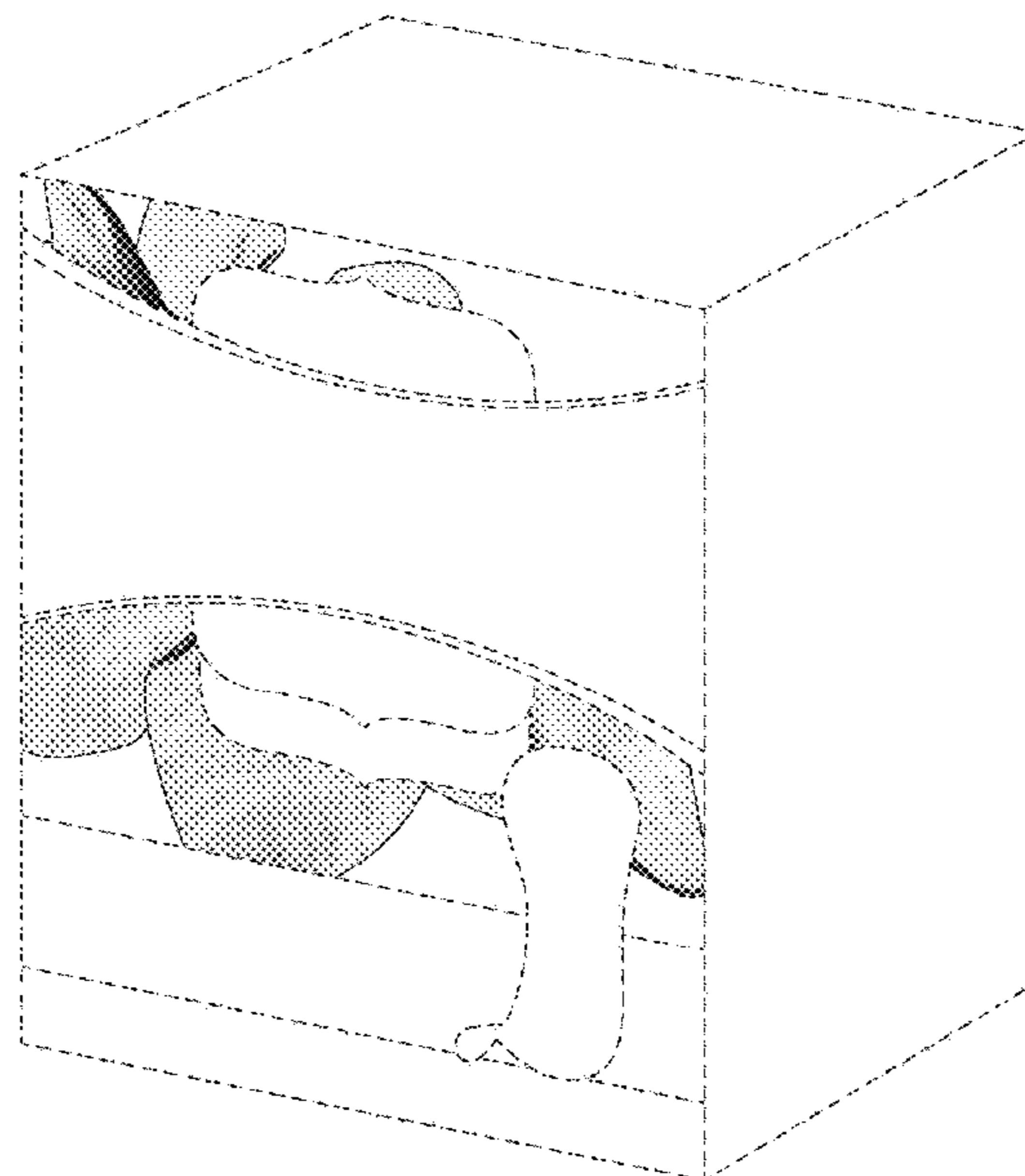

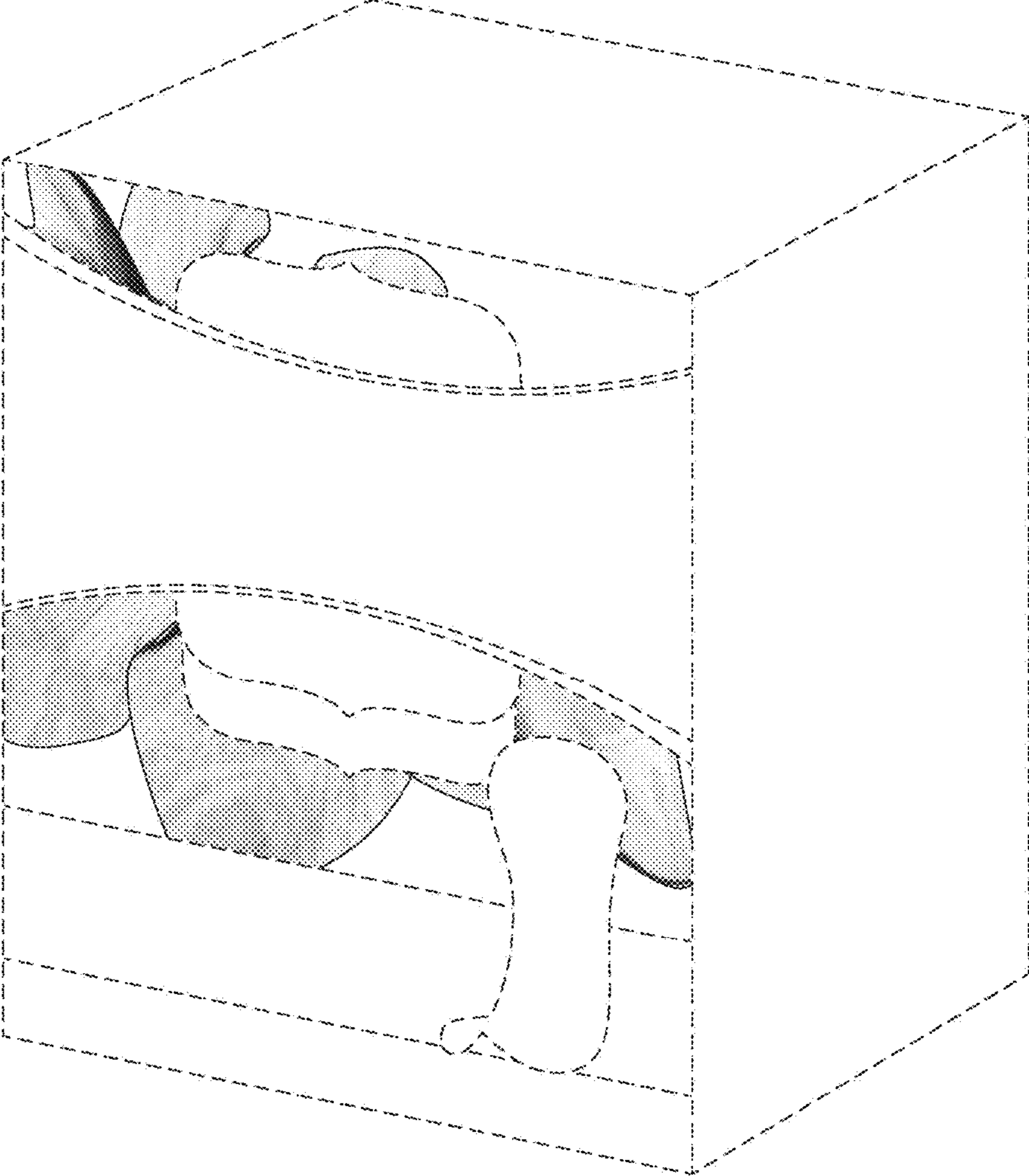

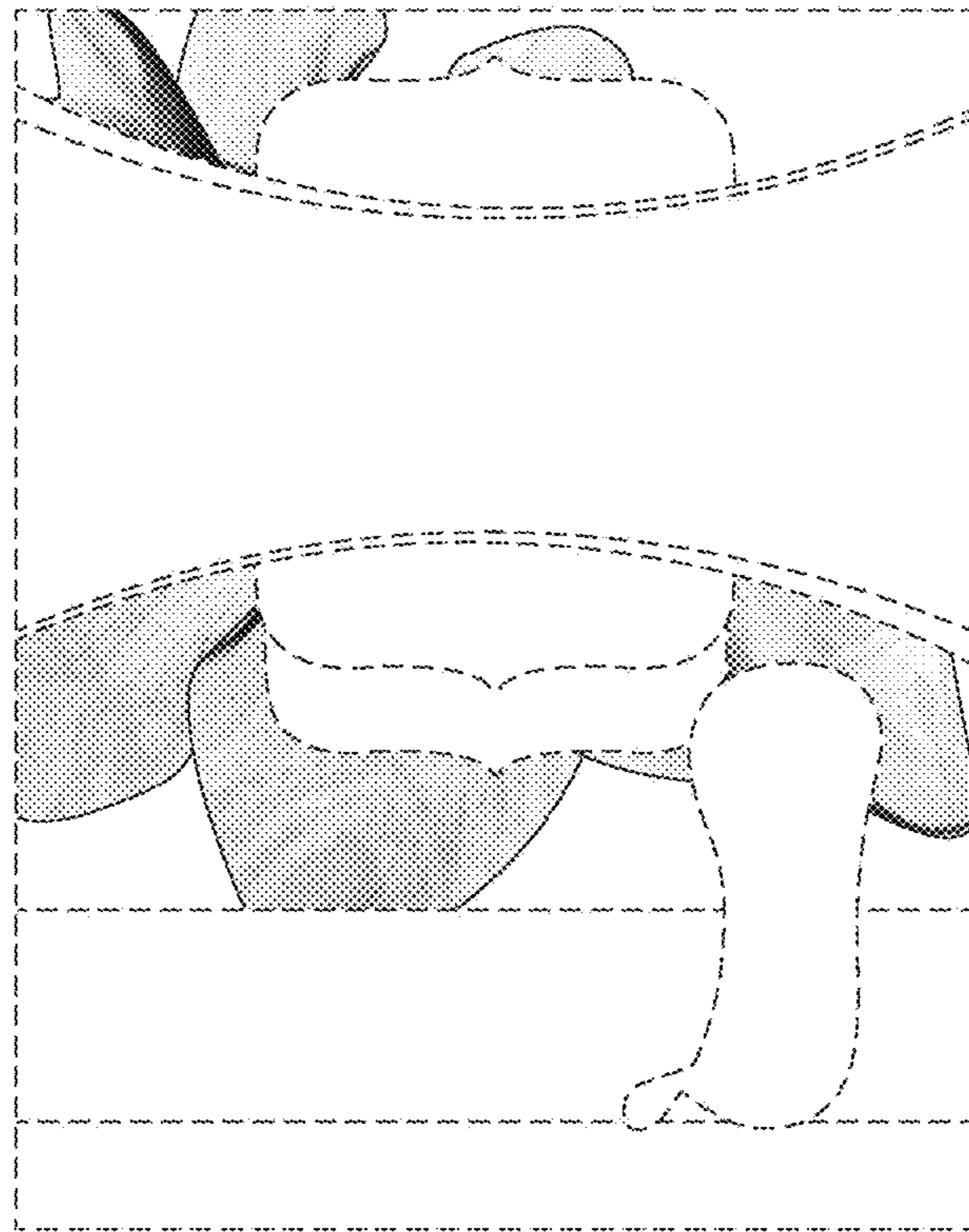

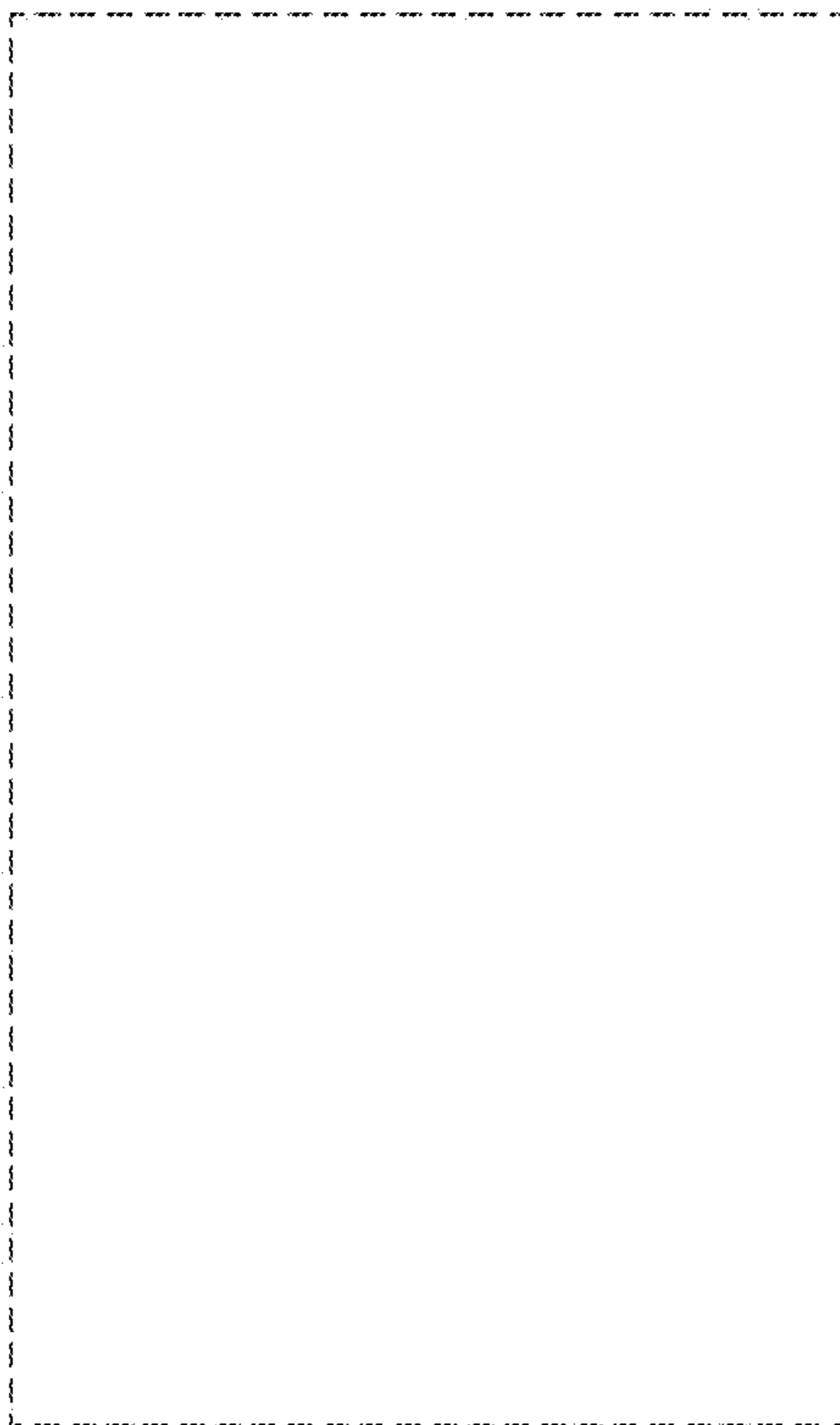

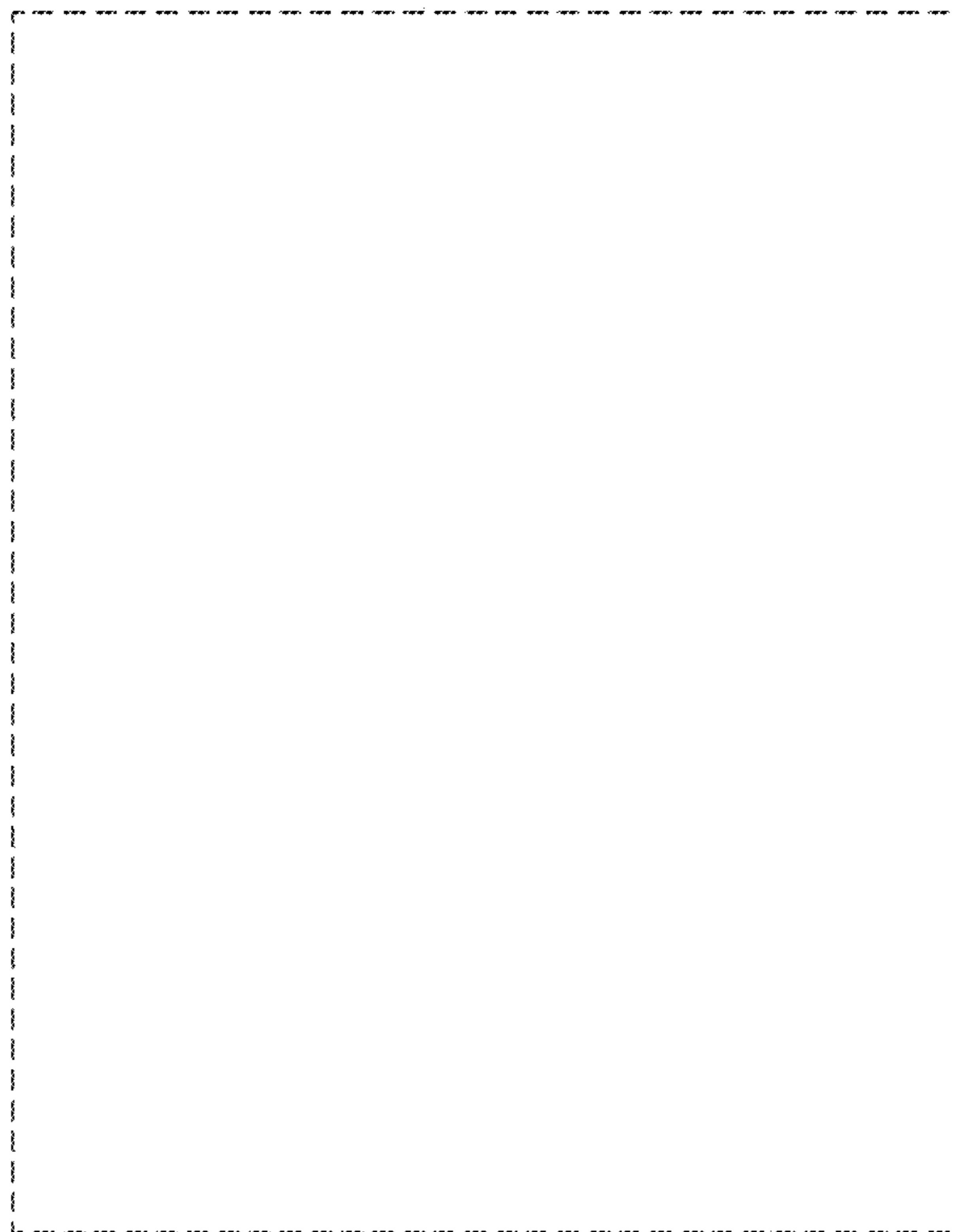

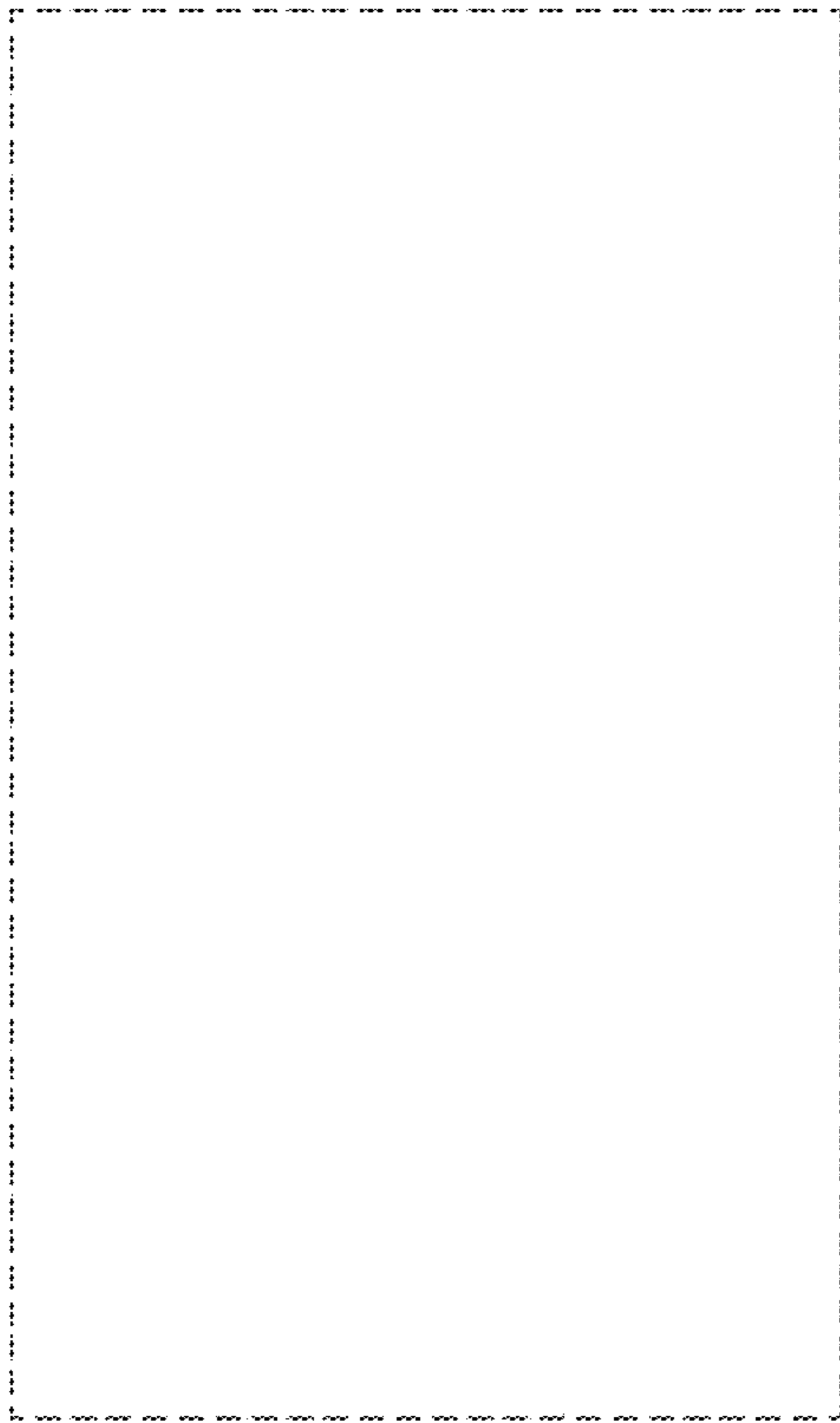

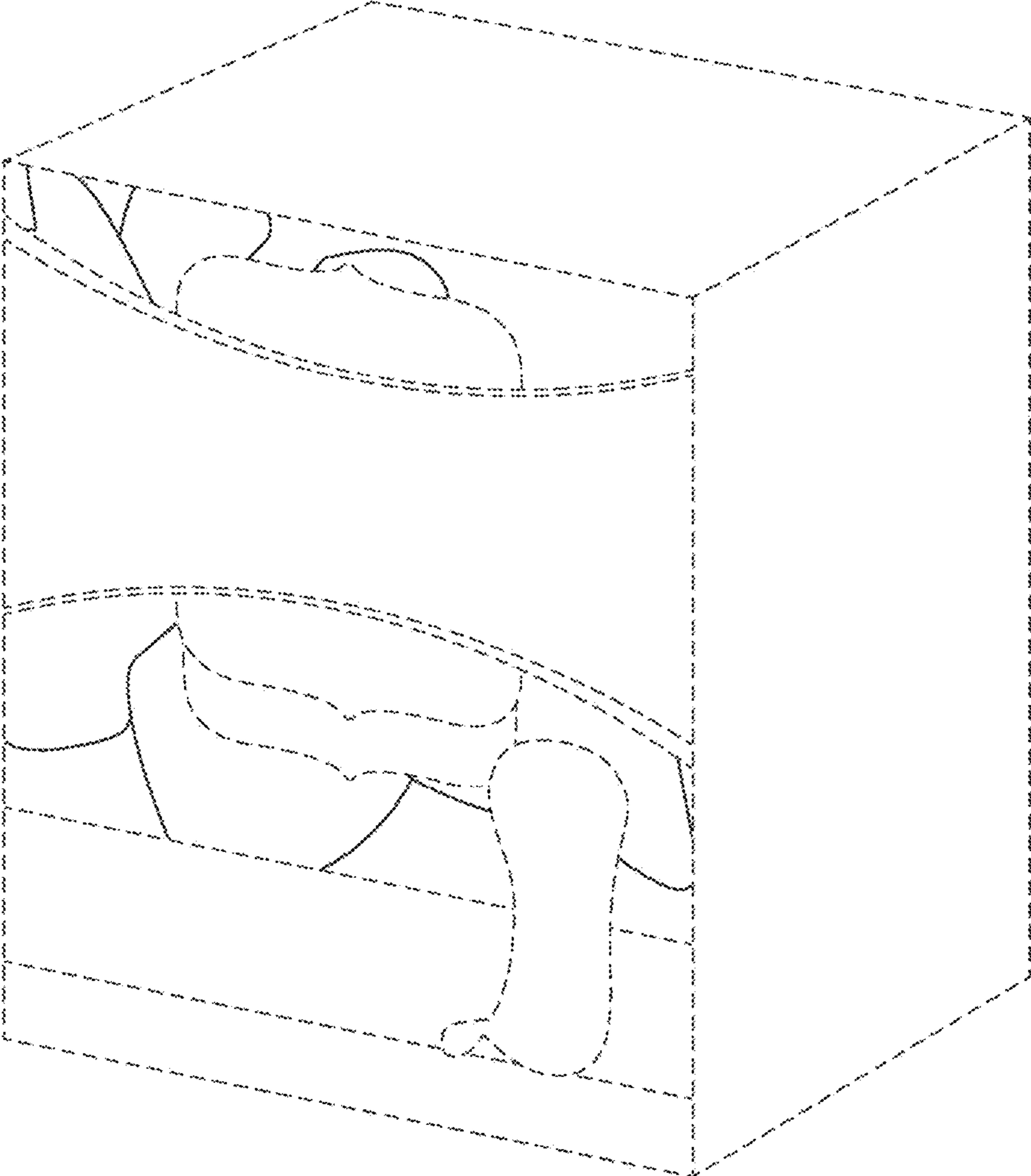

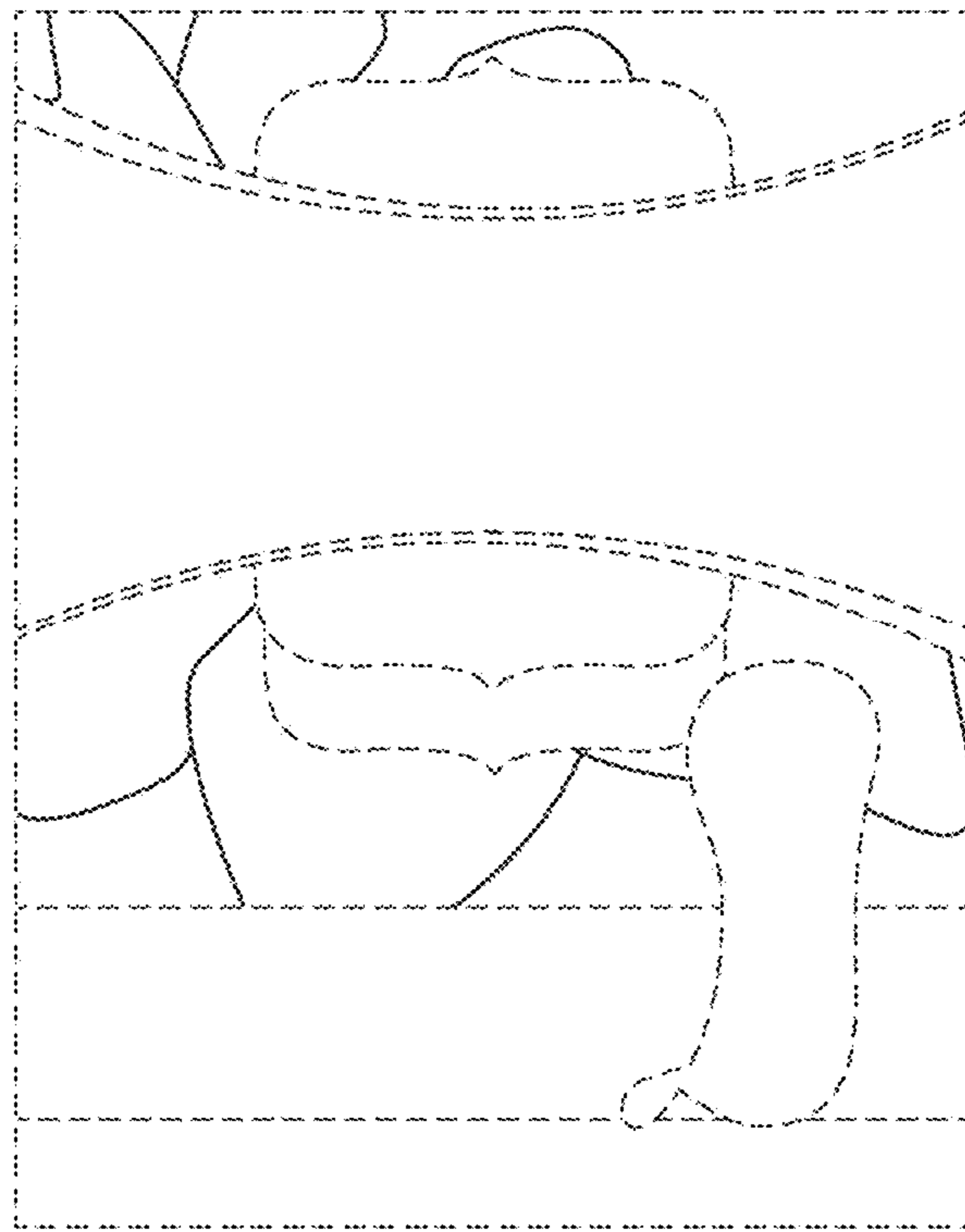

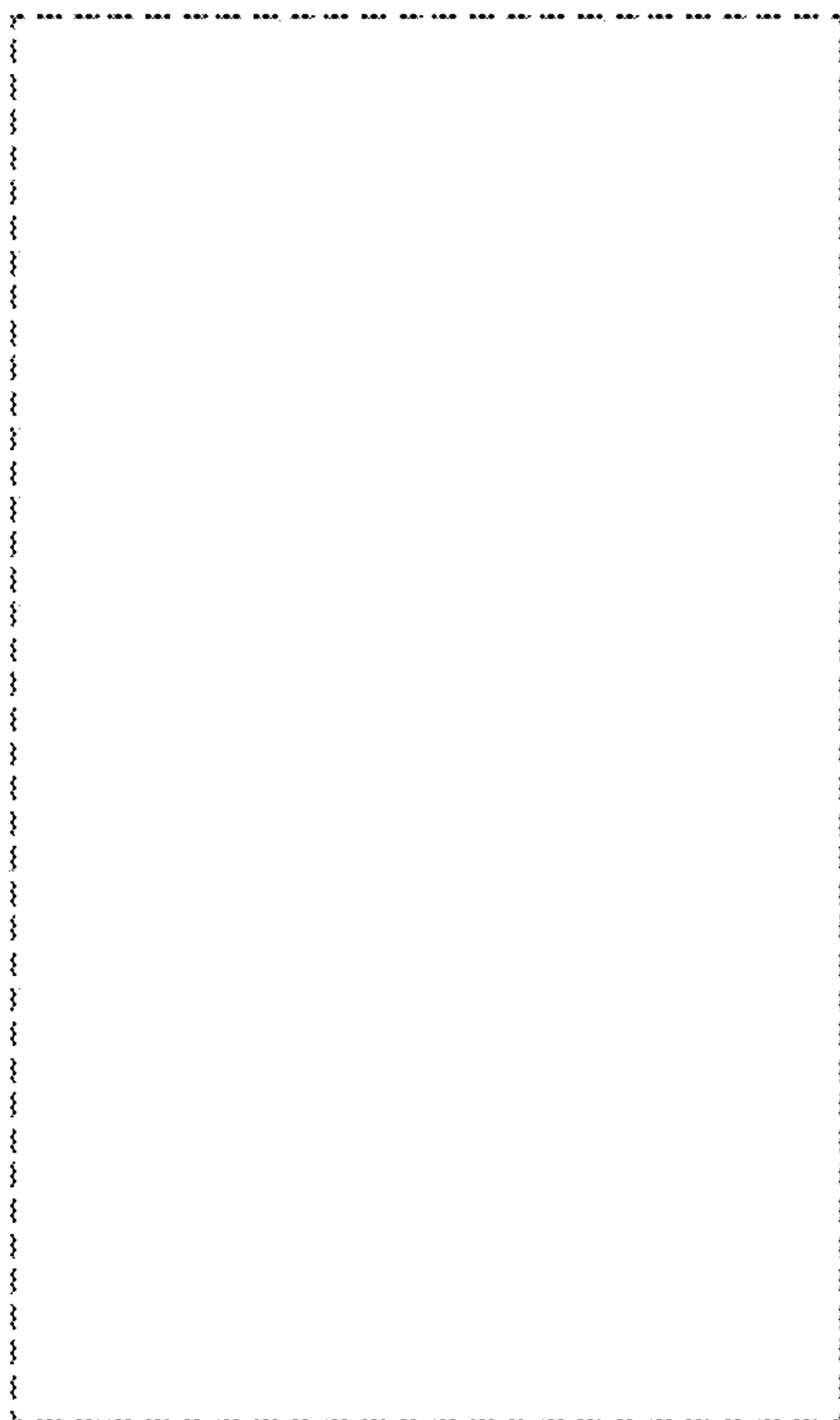

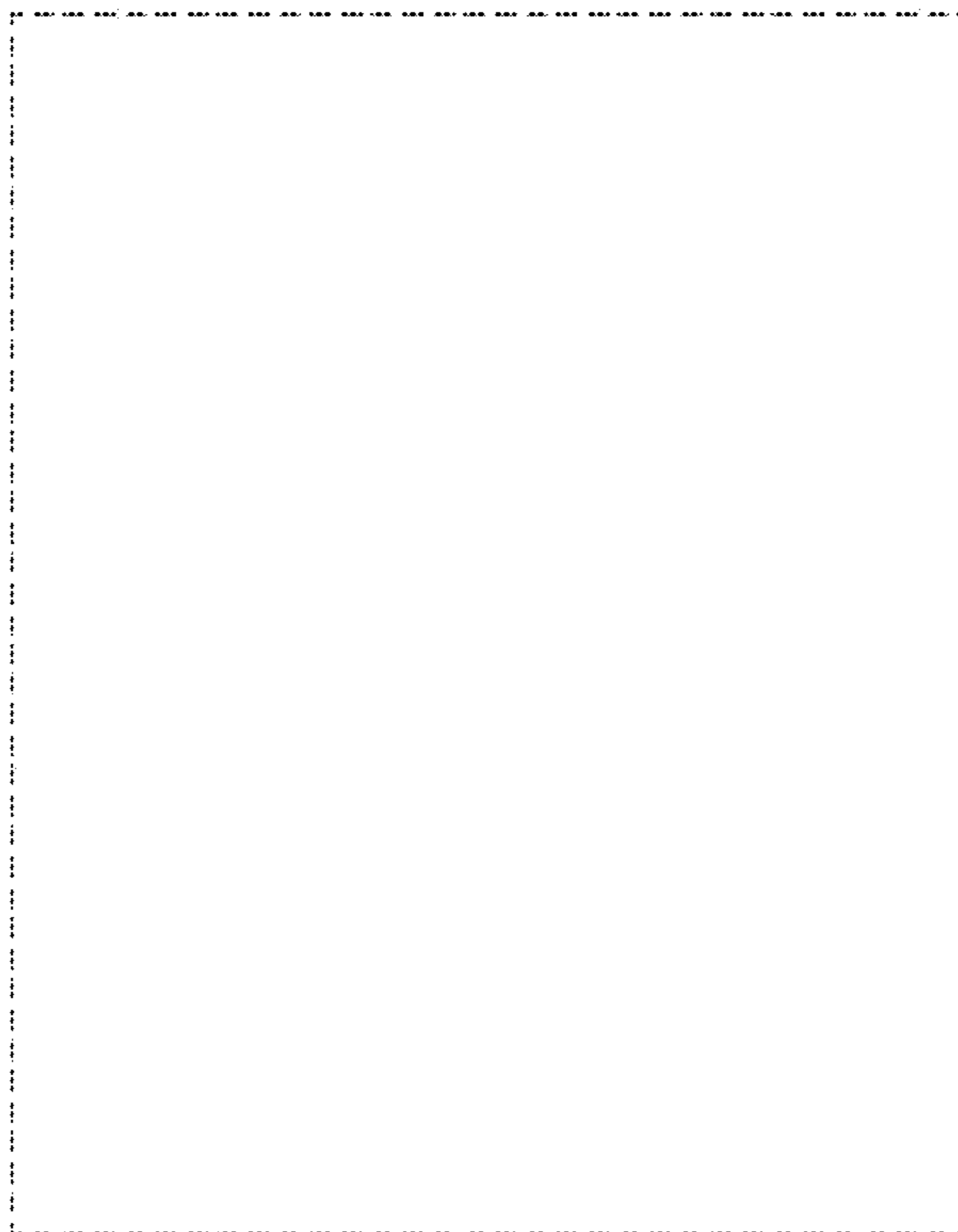

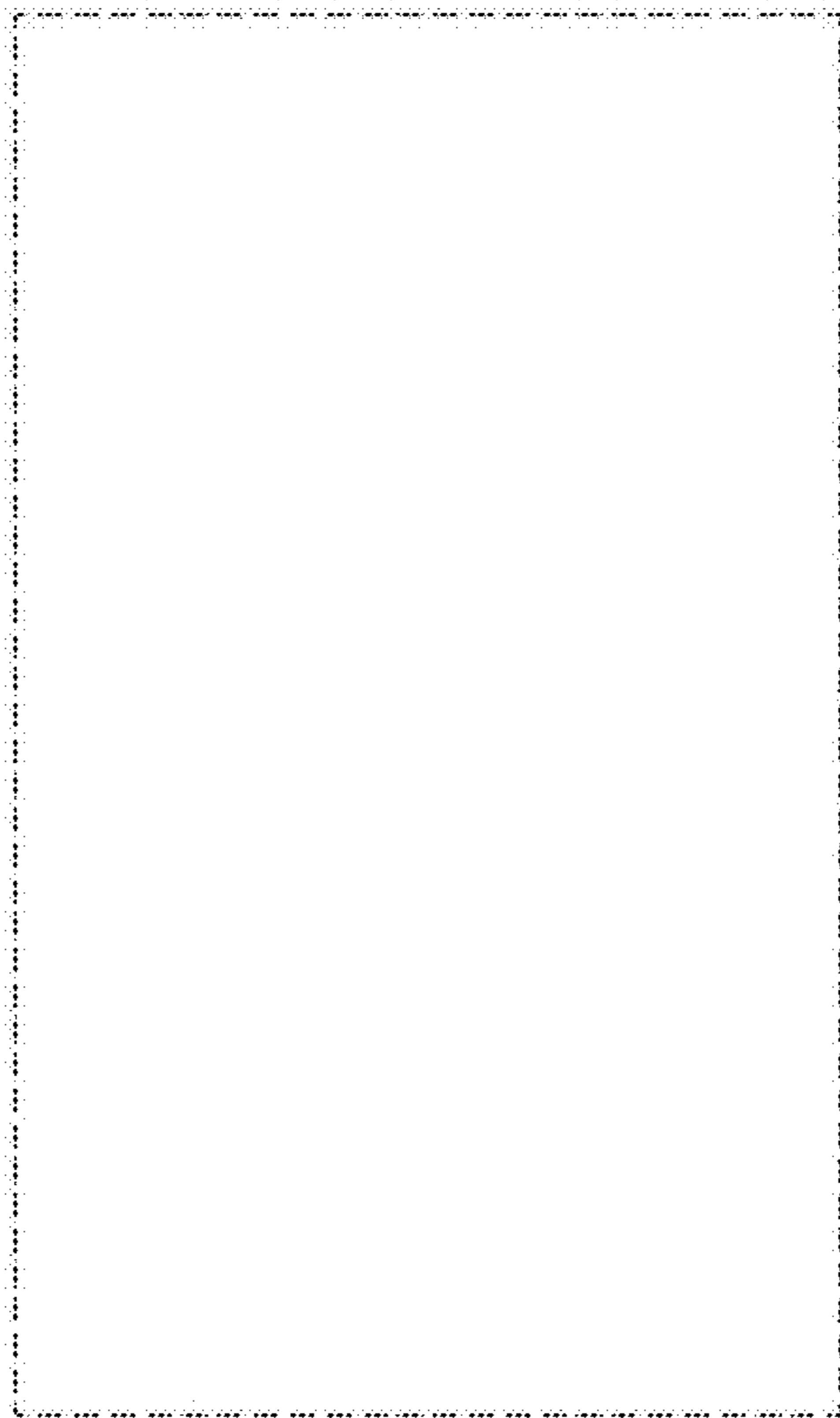
