(57) **CLAIM**

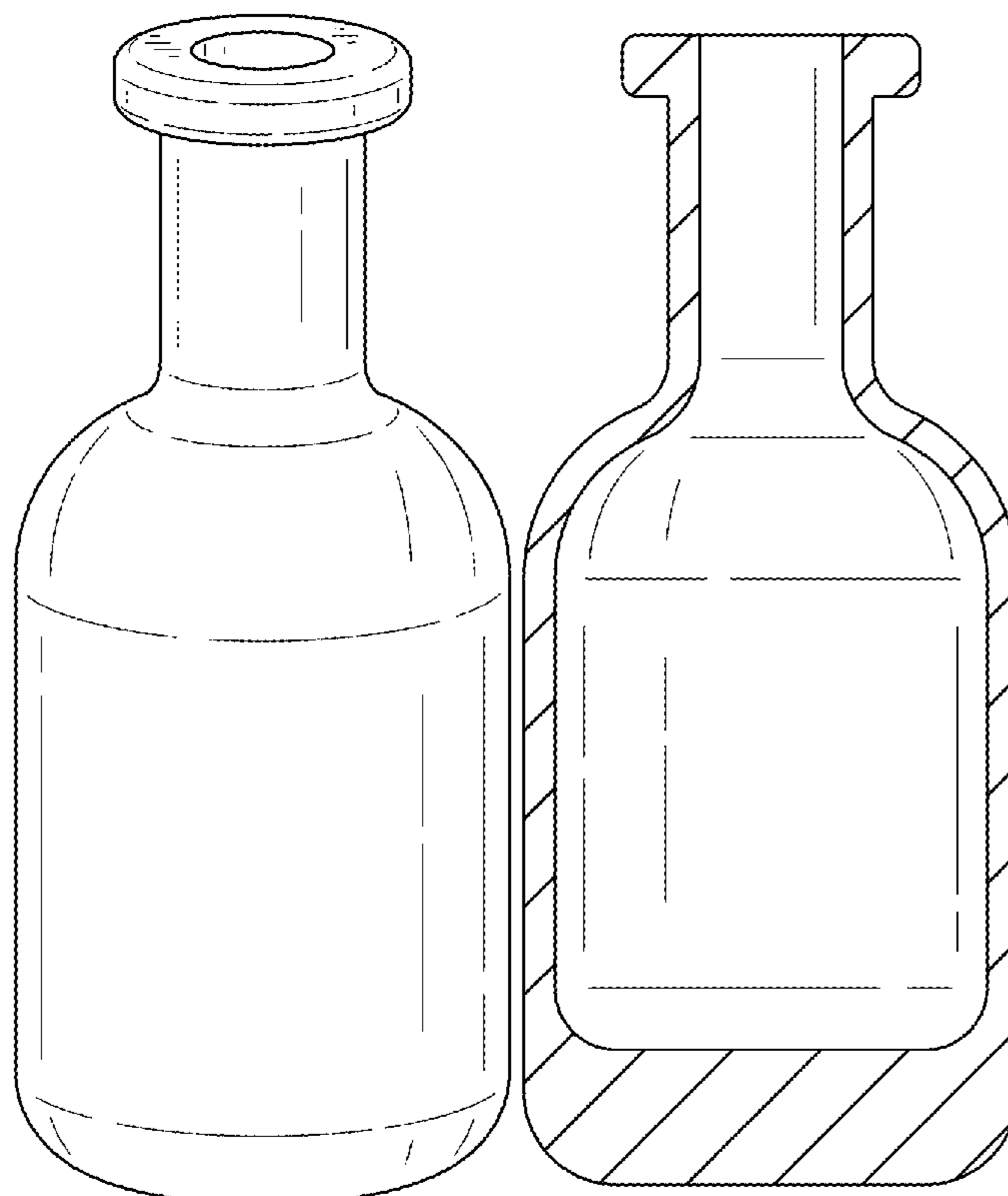
The ornamental design for a thick walled wine bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the thick walled wine bottle showing my new design; FIG. 2 is a front elevation view thereof, the rear elevation view, left side elevation view, and right side elevation view being identical images thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; and, FIG. 5 is a cross-sectional view taken on line 5-5 of FIG. 2.

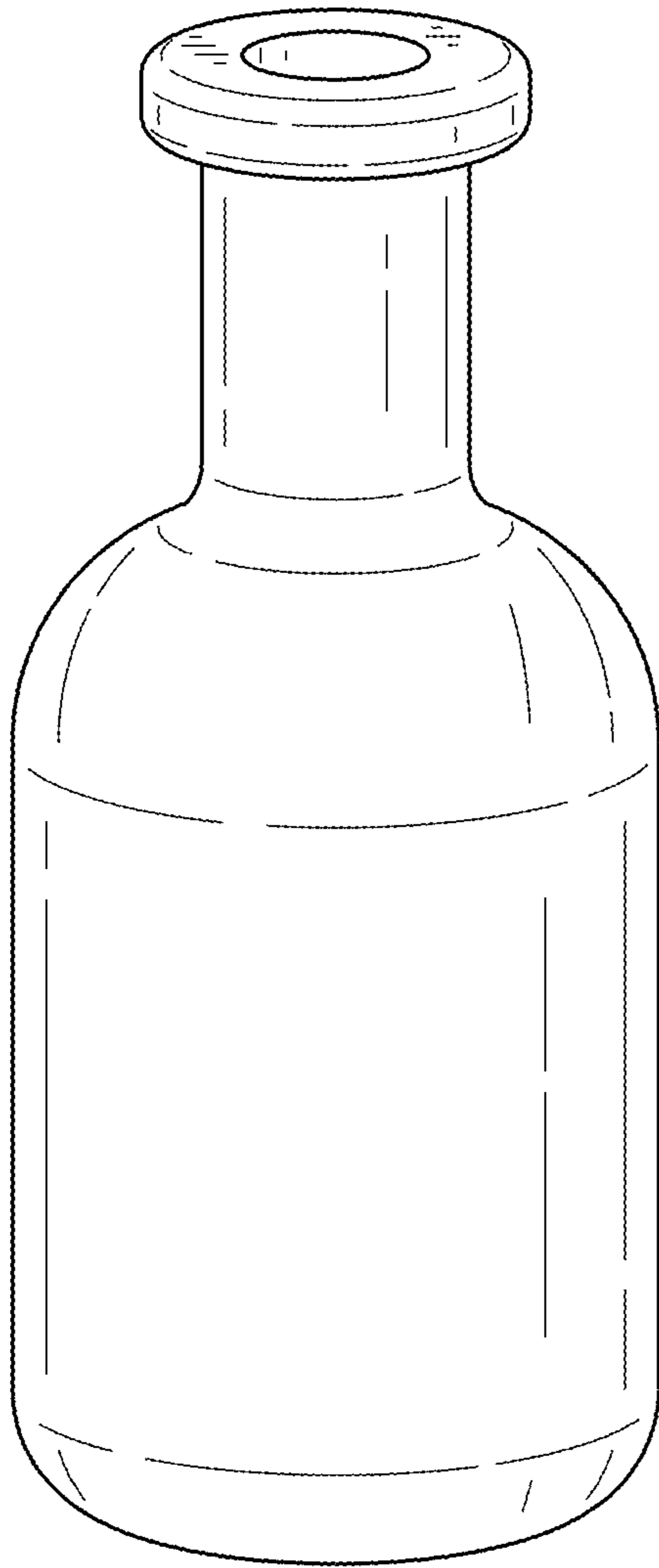

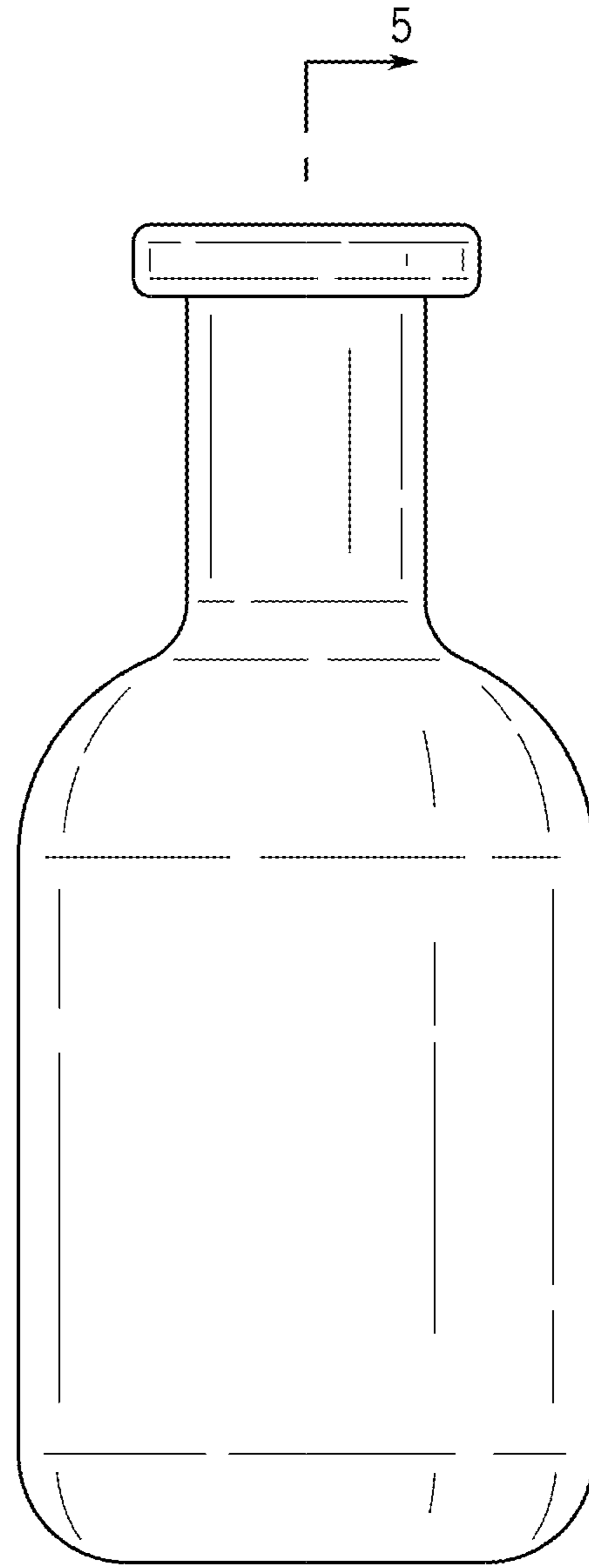

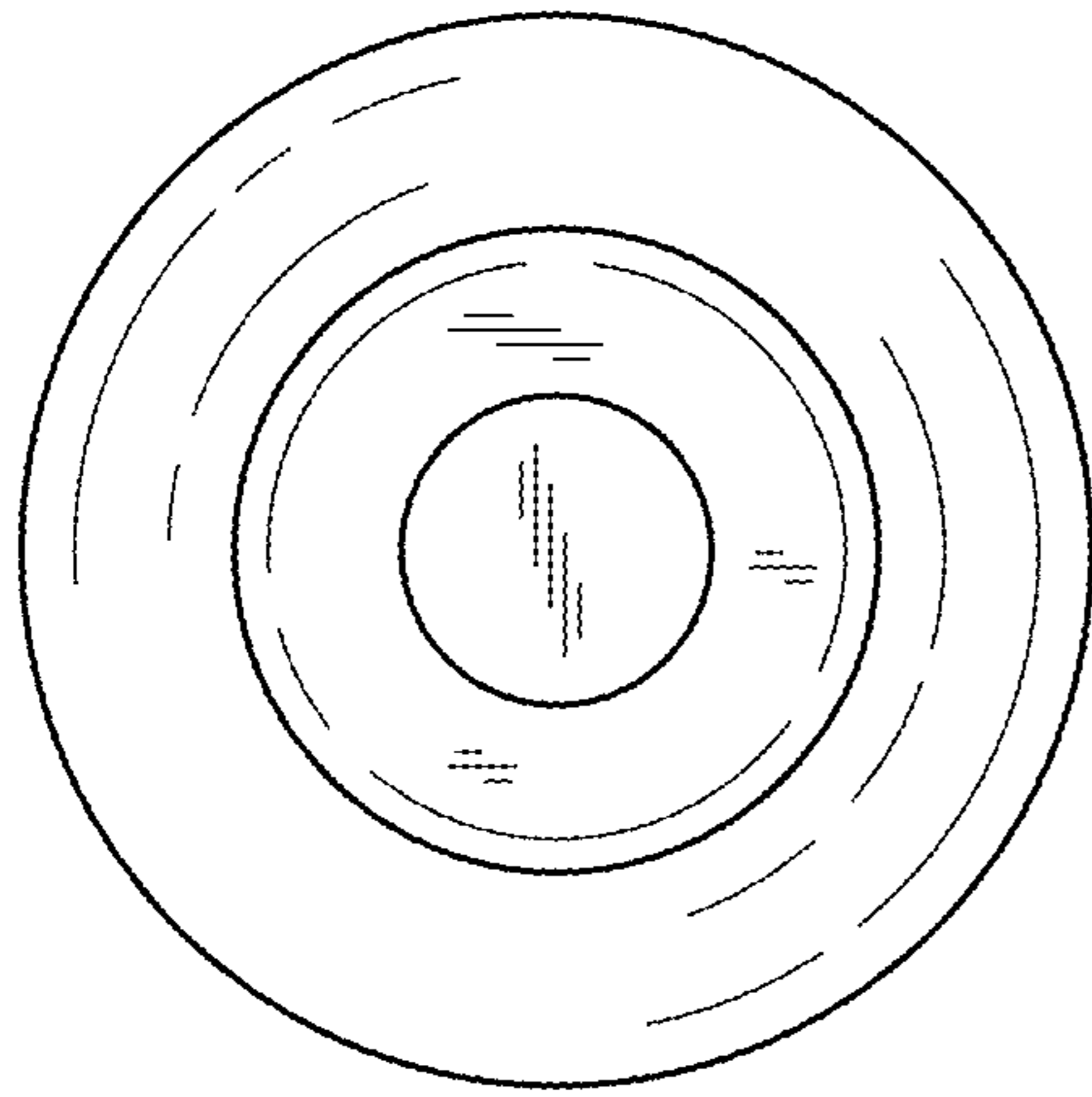

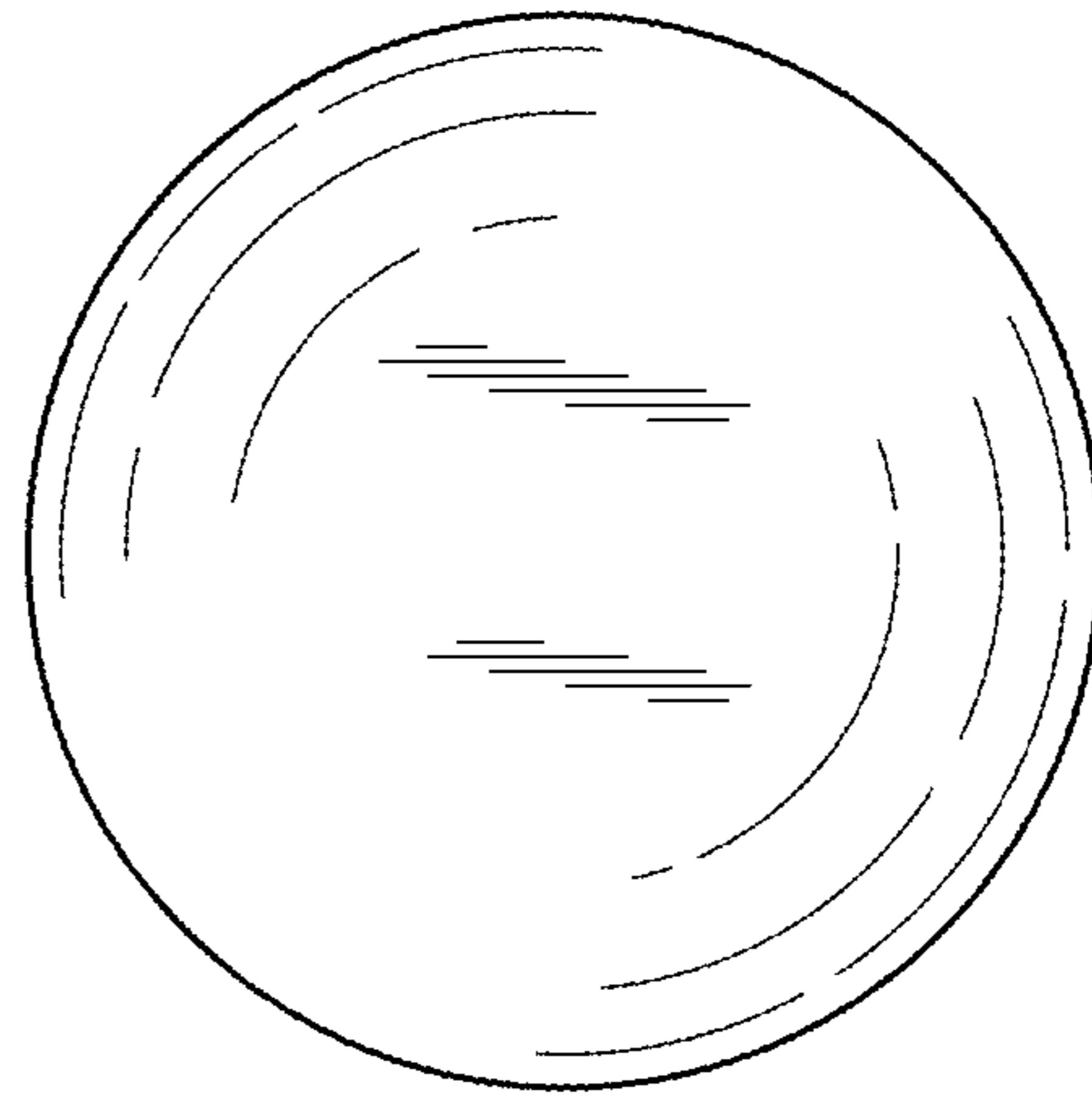

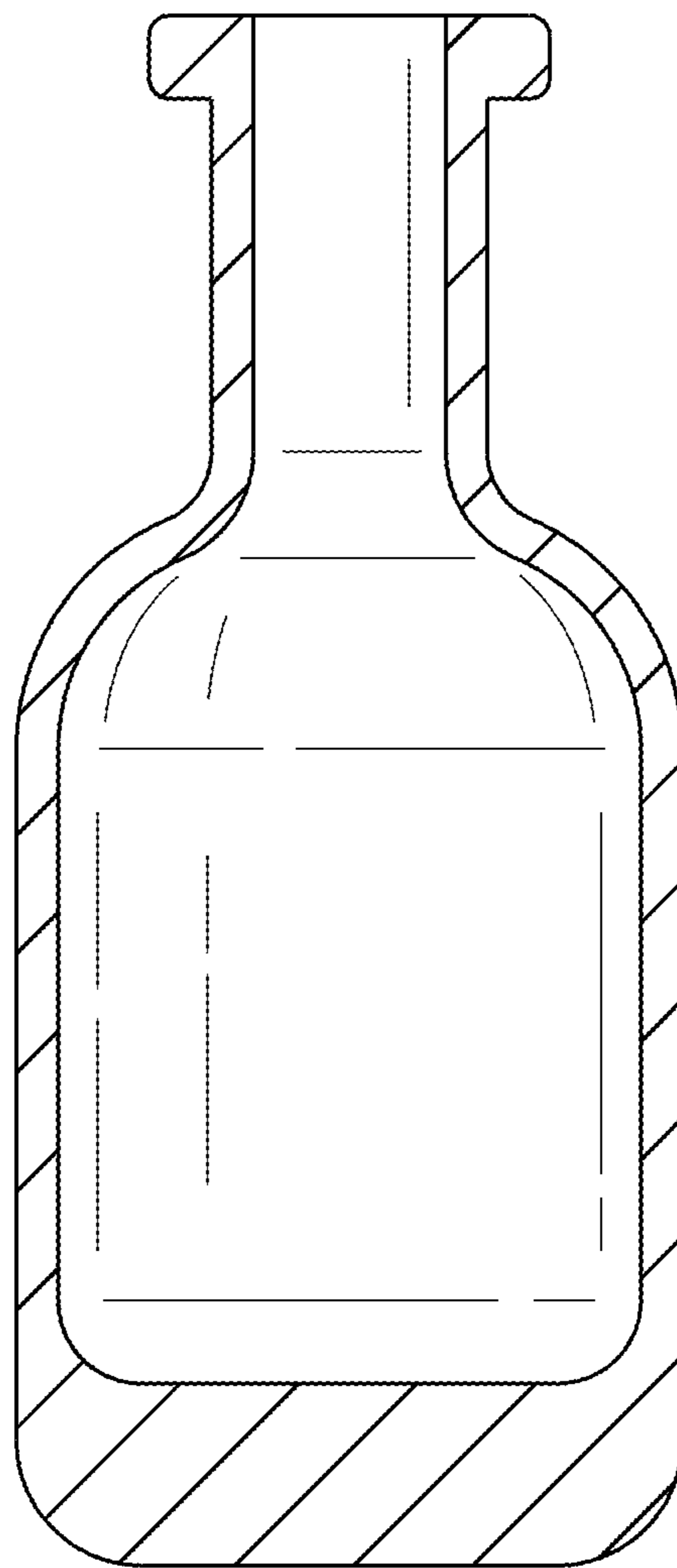
