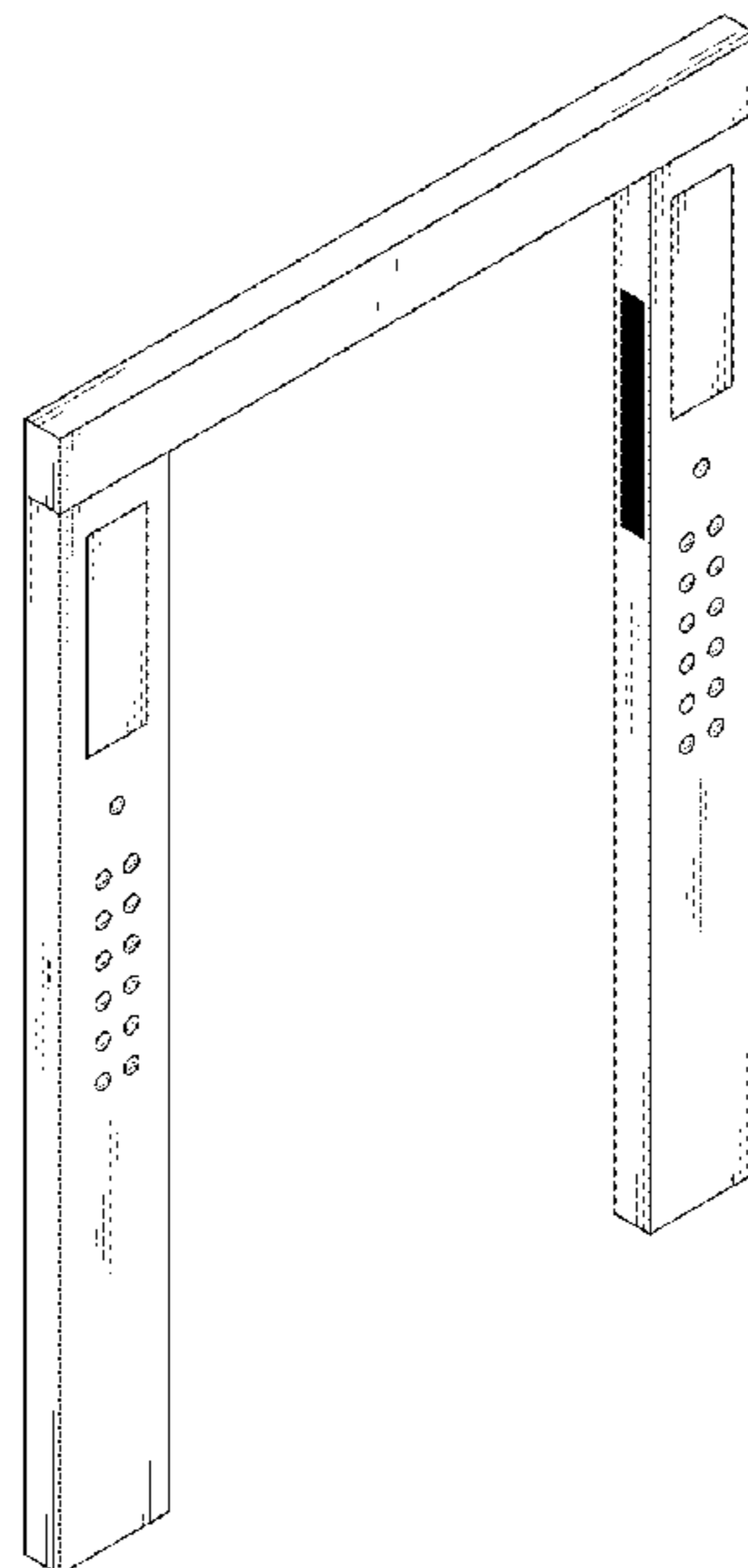
(57) **CLAIM**

The ornamental design for a frame with elevator indicator, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and left side view of a frame with elevator indicator showing our new design;
FIG. 2 is a front, top and right side view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is a cross-sectional view taken along and in the direction of line 8-8 in FIG. 3; and,
FIG. 9 is a cross-sectional view taken along and in the direction of line 9-9 in FIG. 3.
The broken lines illustrate portions of the frame with elevator indicator that form no part of the claimed design. The left side view is omitted because it is identical to the right side view.

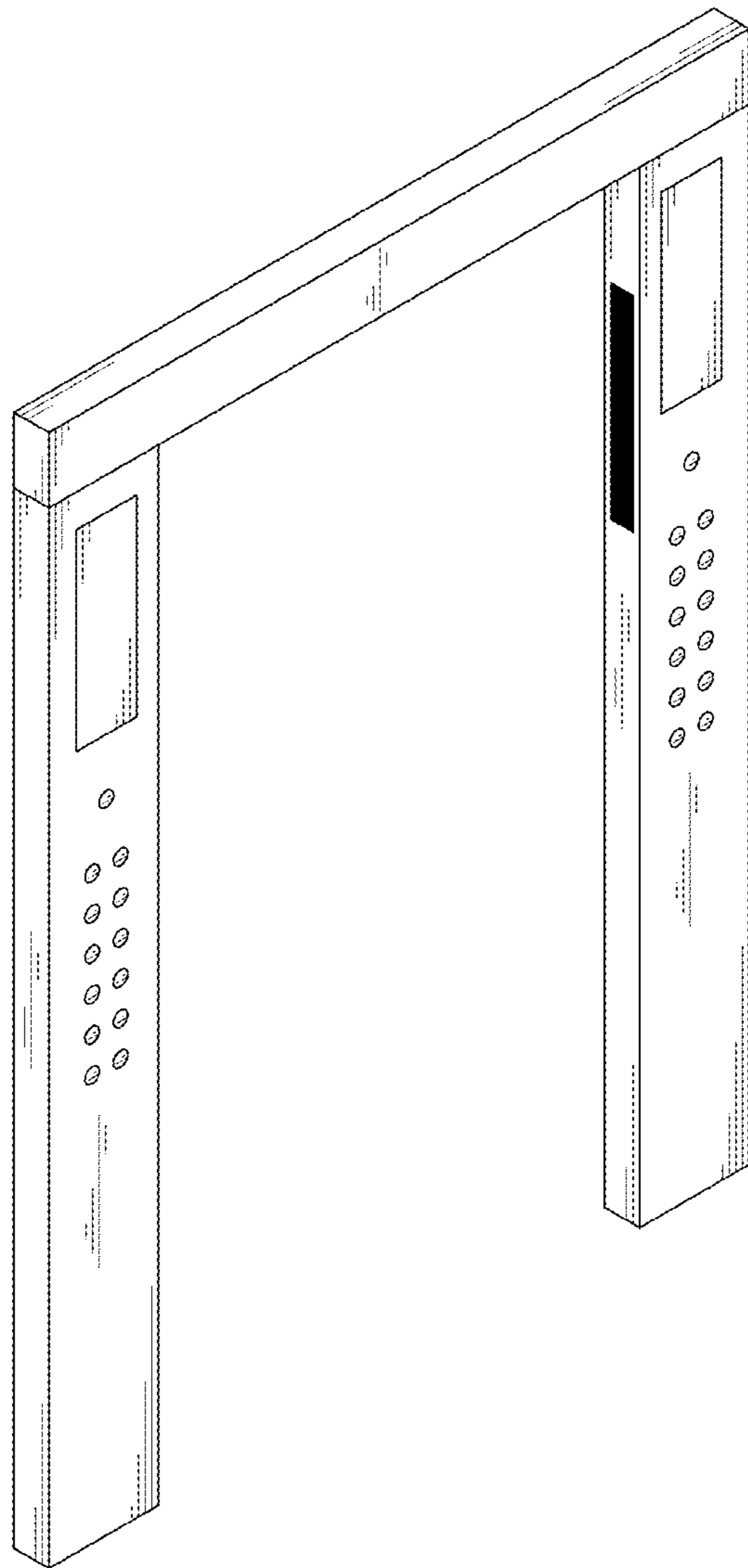

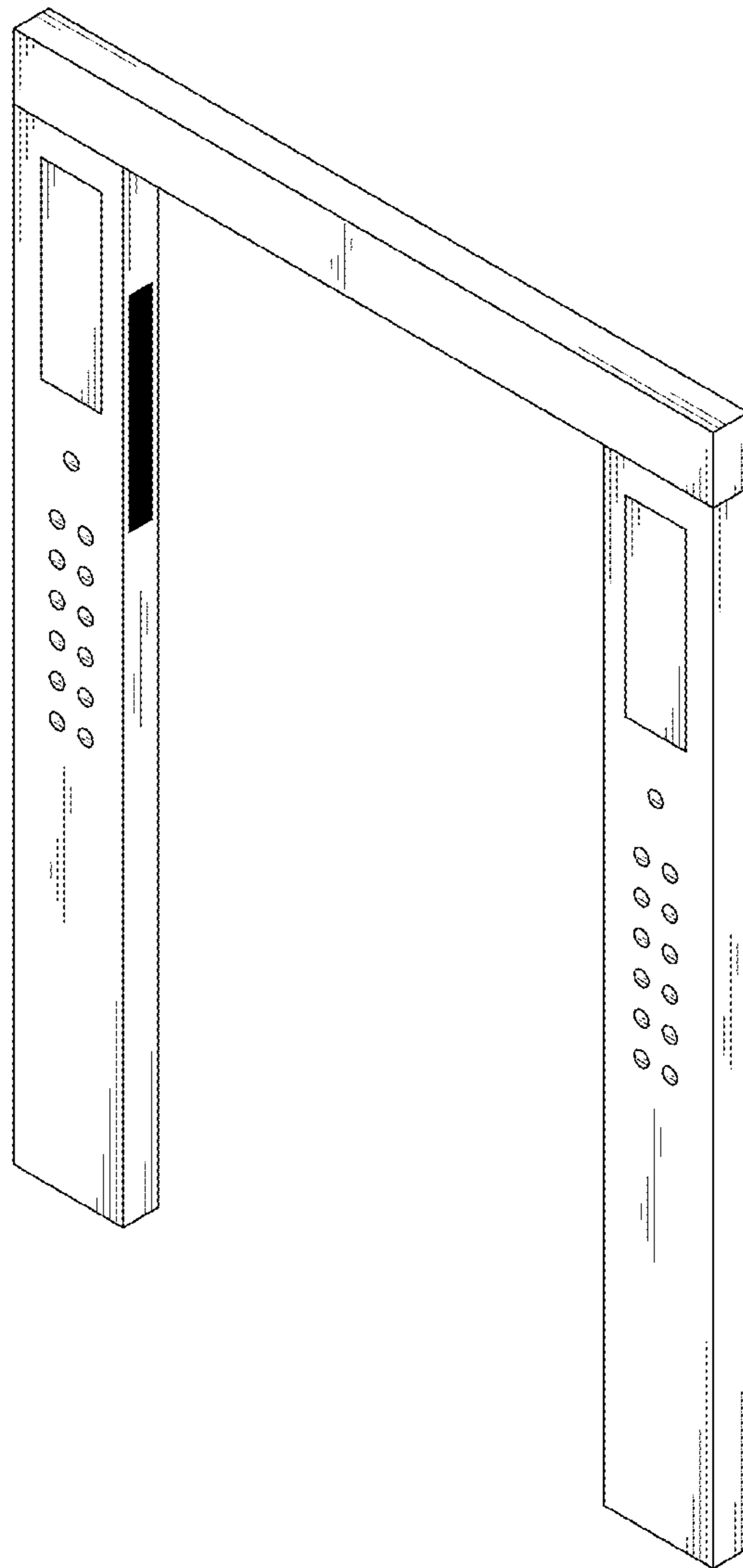

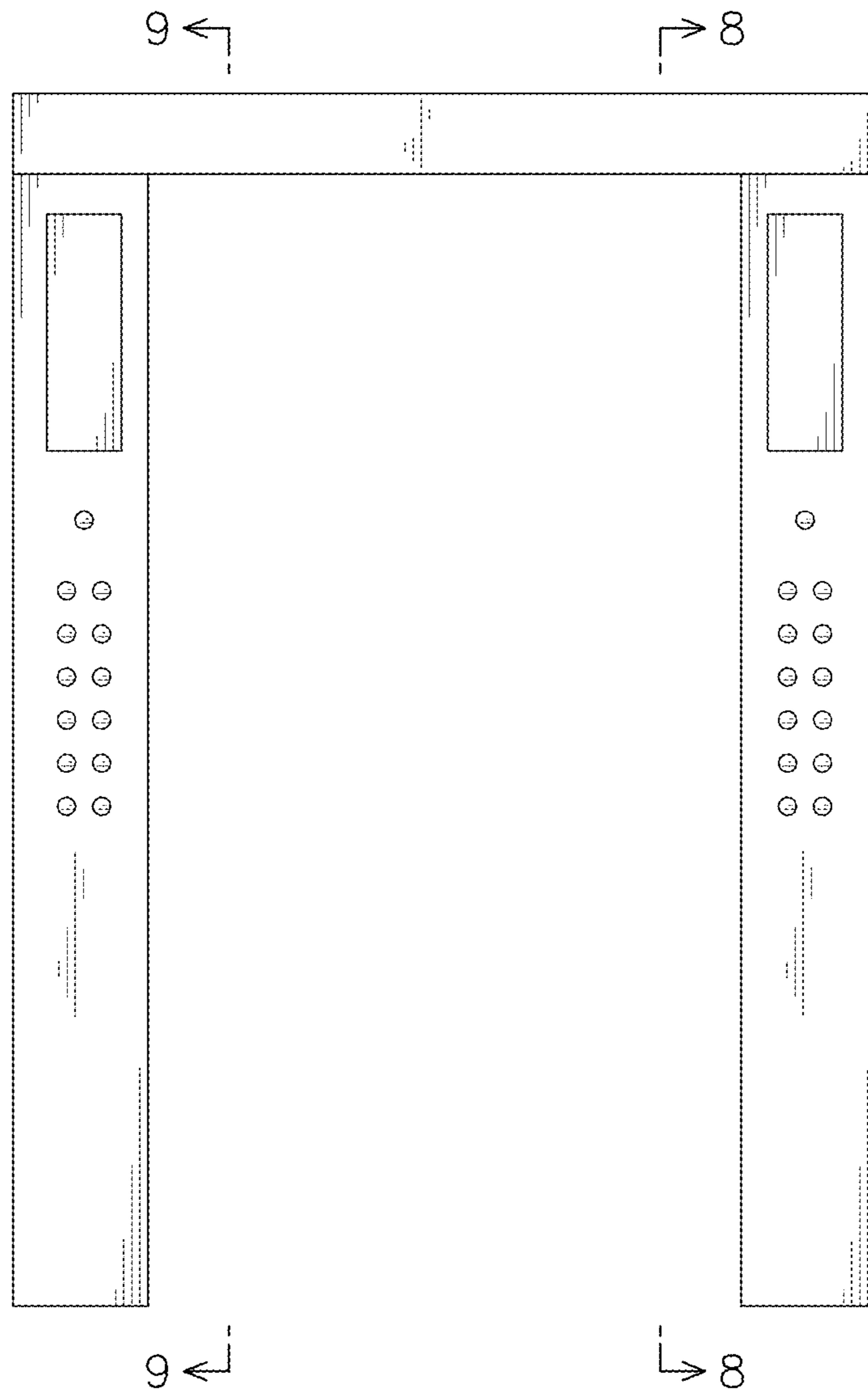

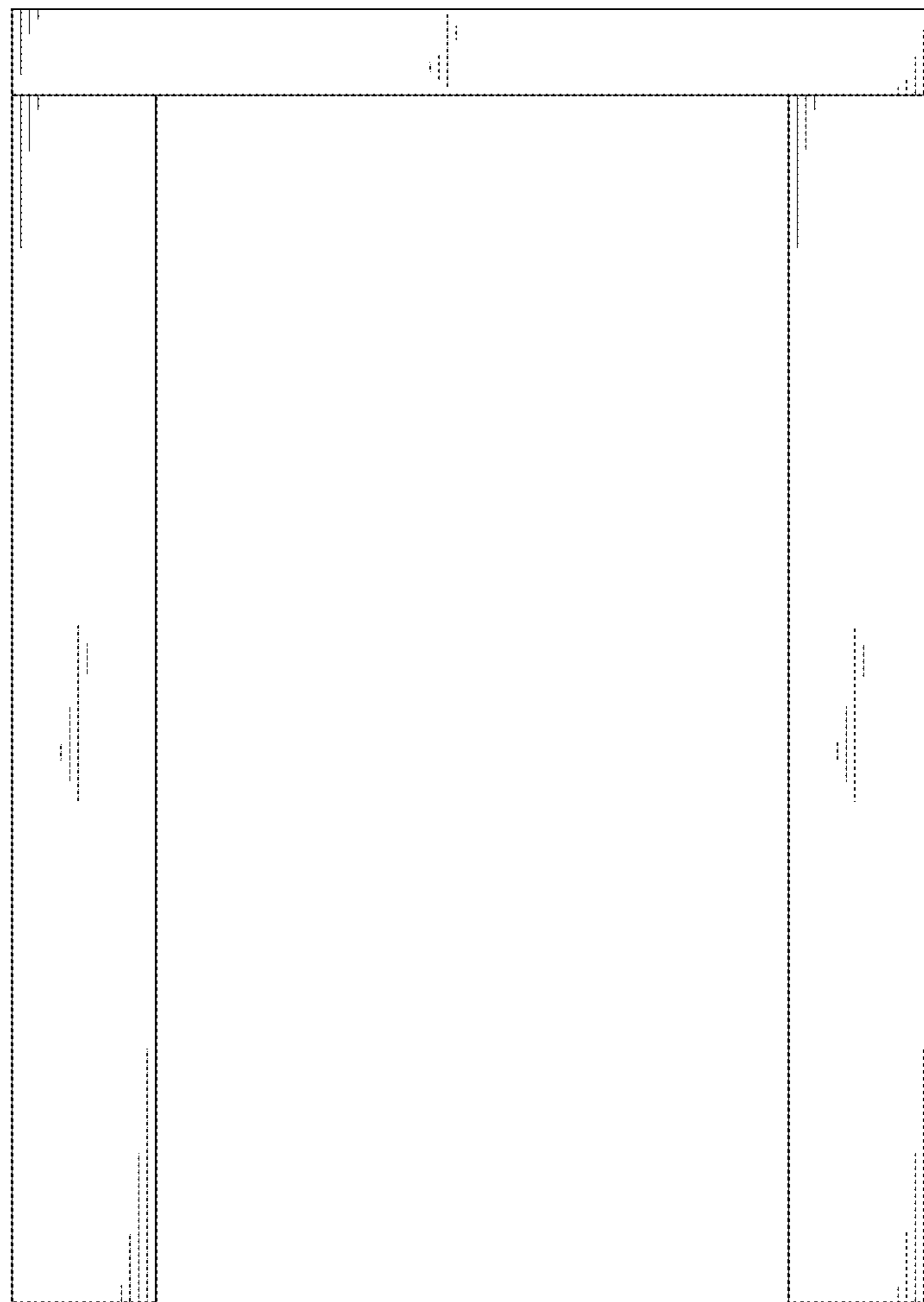

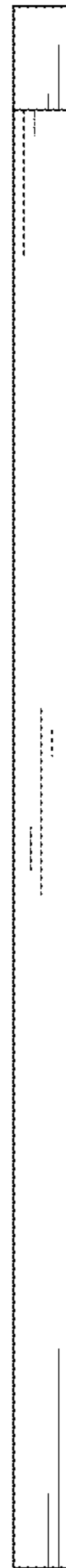

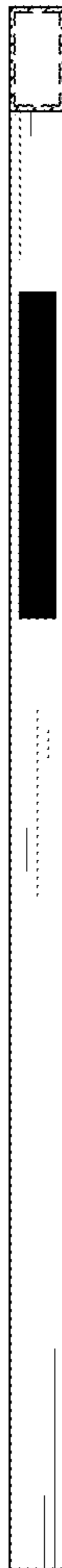
