The ornamental design for a wheel sock, as shown and described.

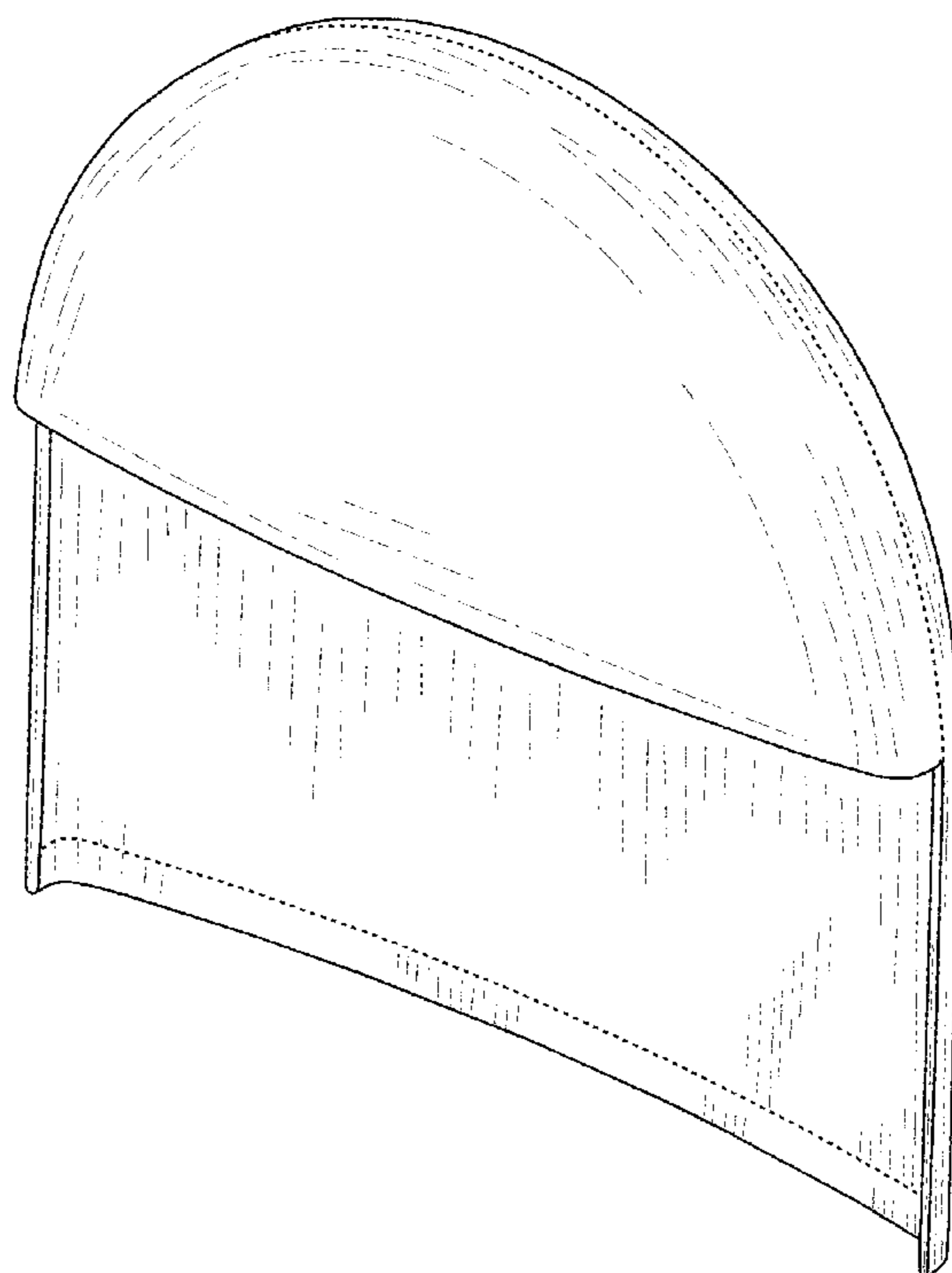
**DESCRIPTION**

FIG. 1 is a top perspective view of a wheel sock showing my new design;  
FIG. 2 is a bottom perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a right elevational view thereof, the left elevational view being mirrored thereto;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof; and,  
FIG. 8 is a cross sectional view taken along line 8-8 in FIG. 3.

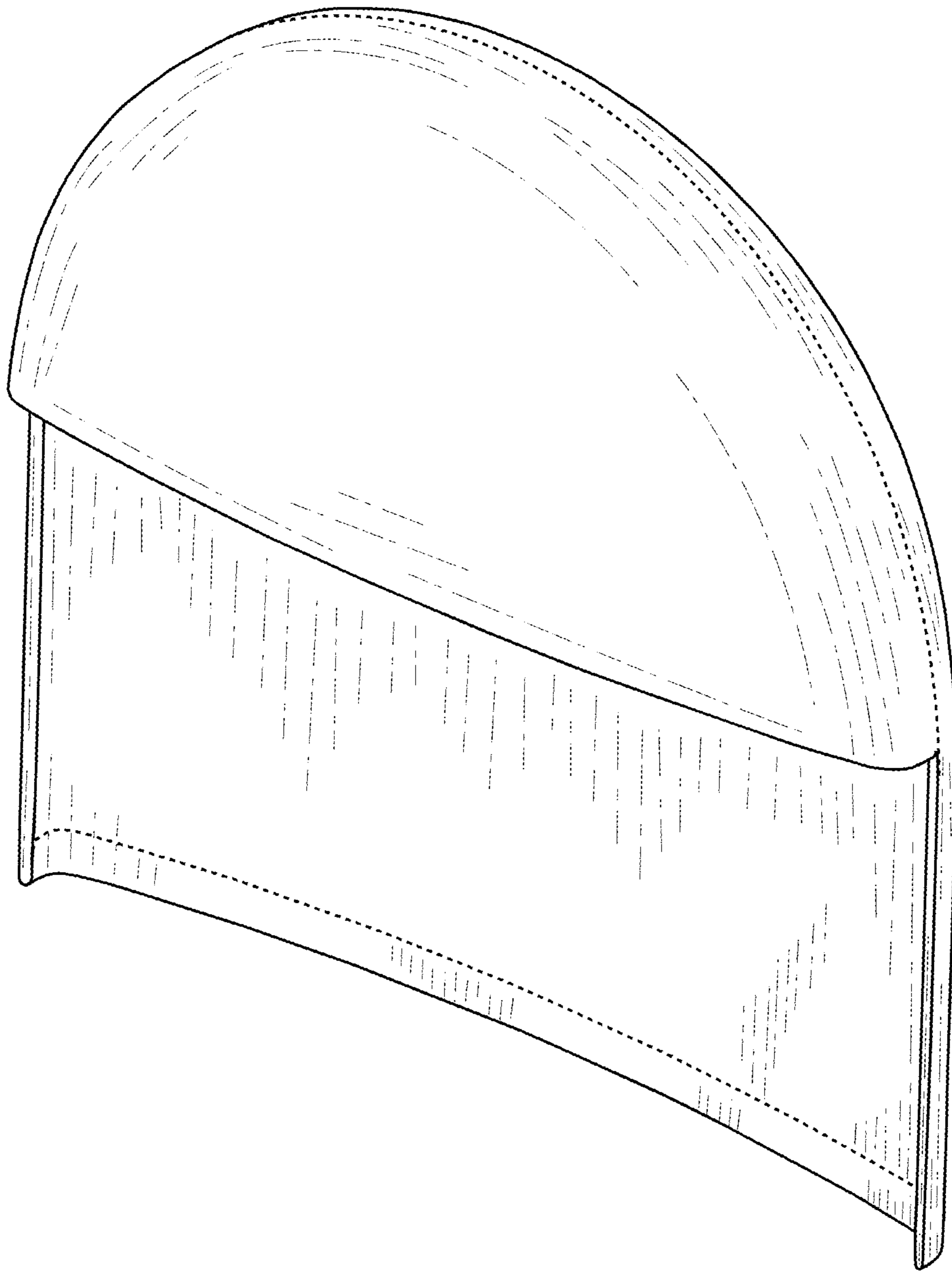

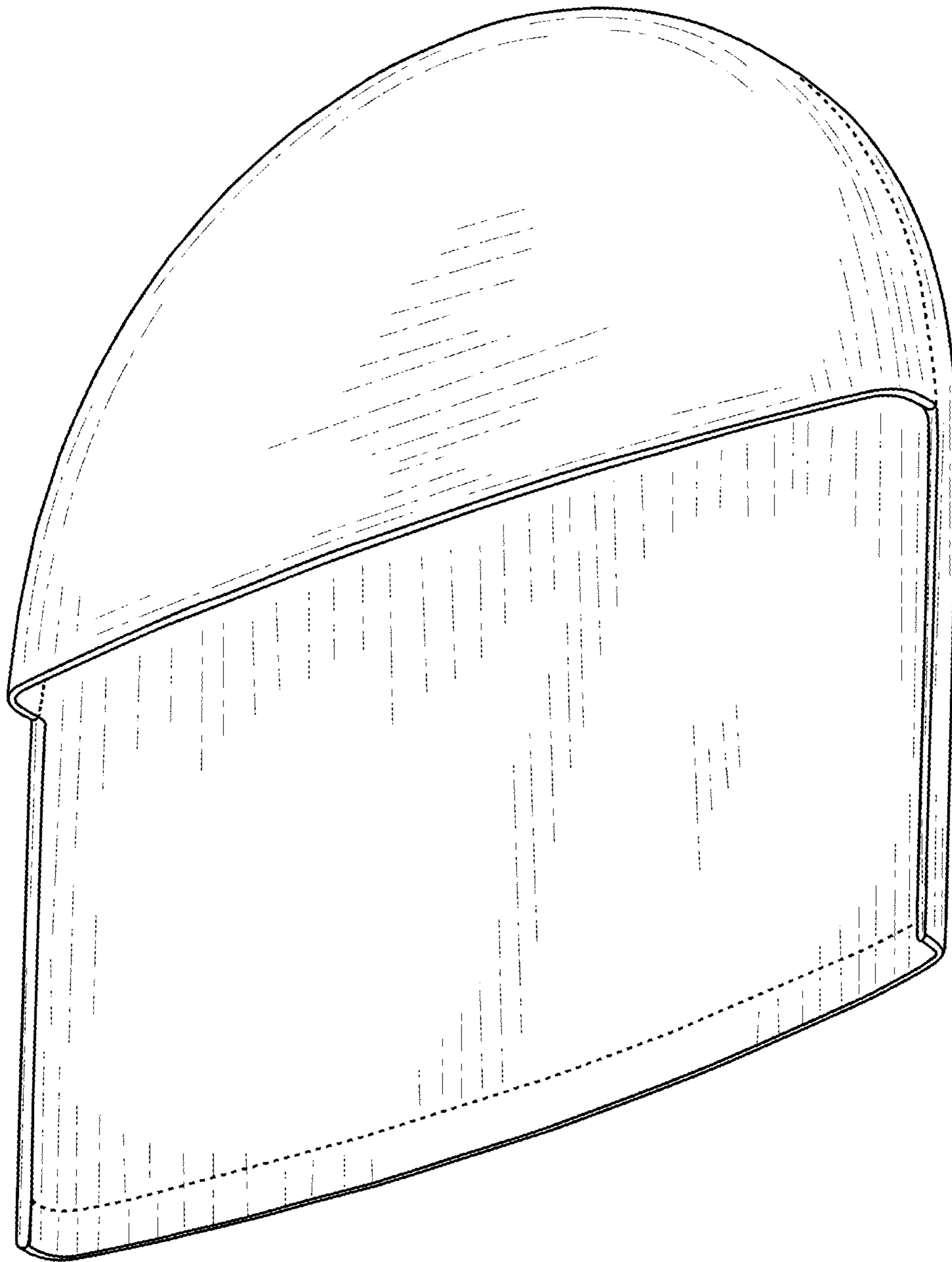

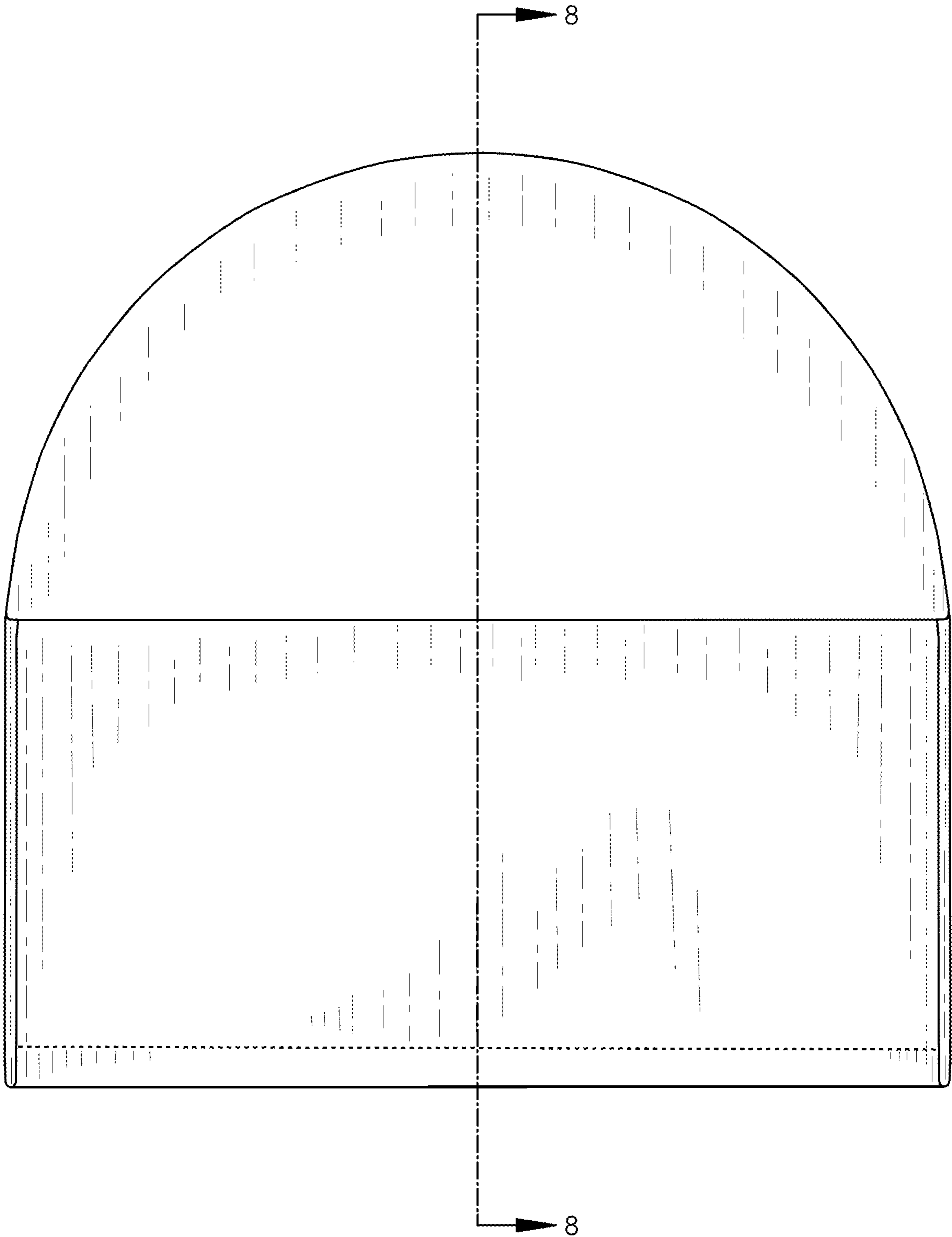

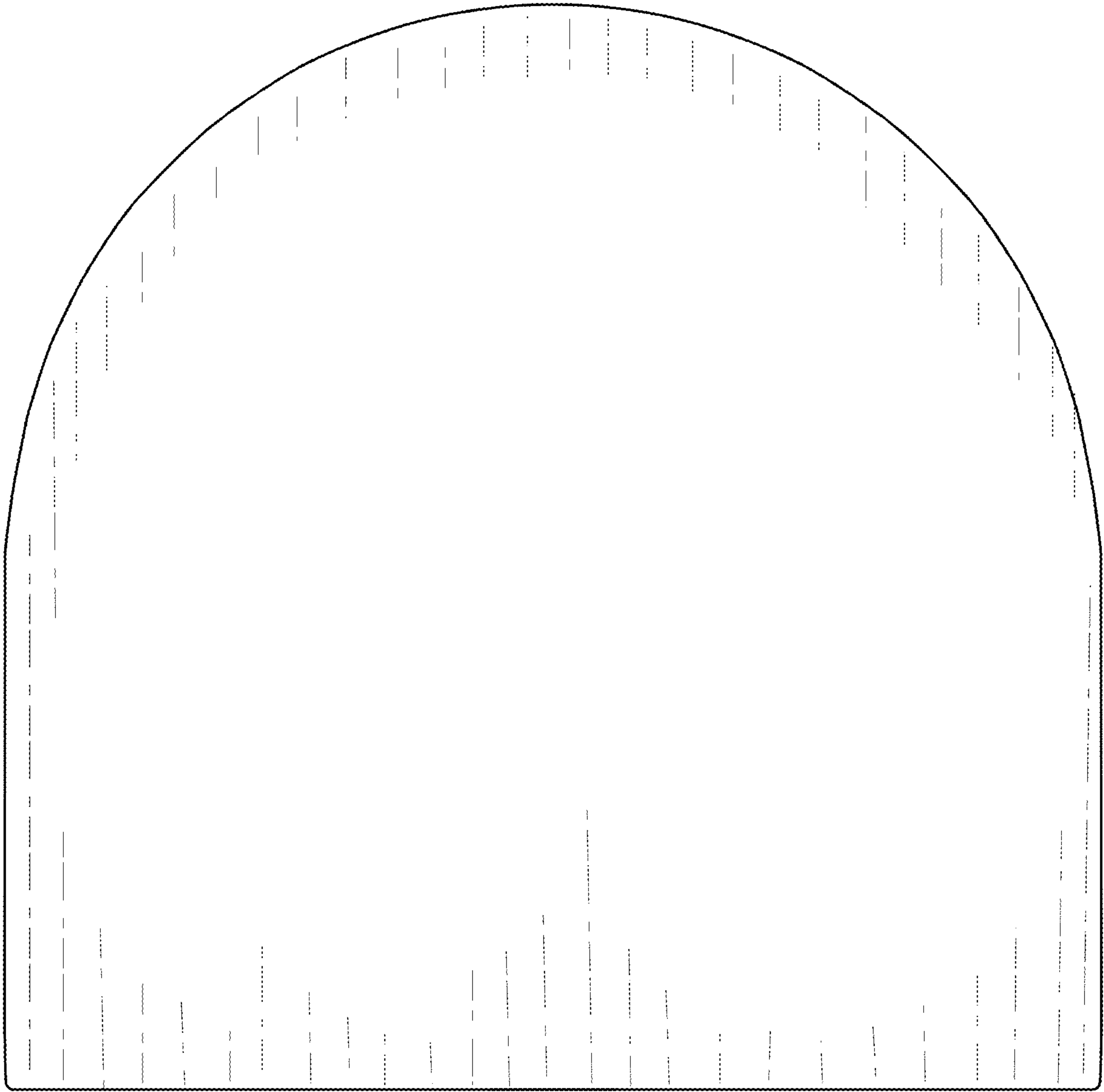

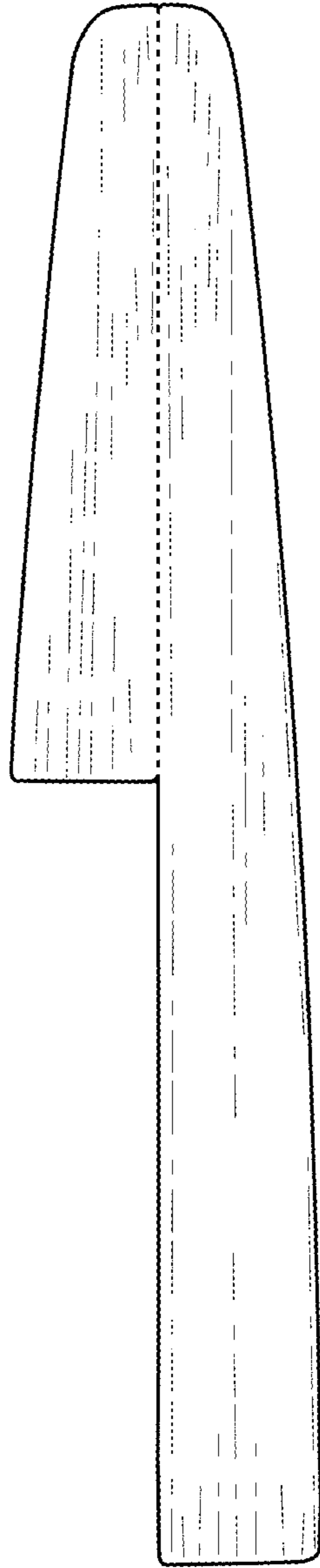

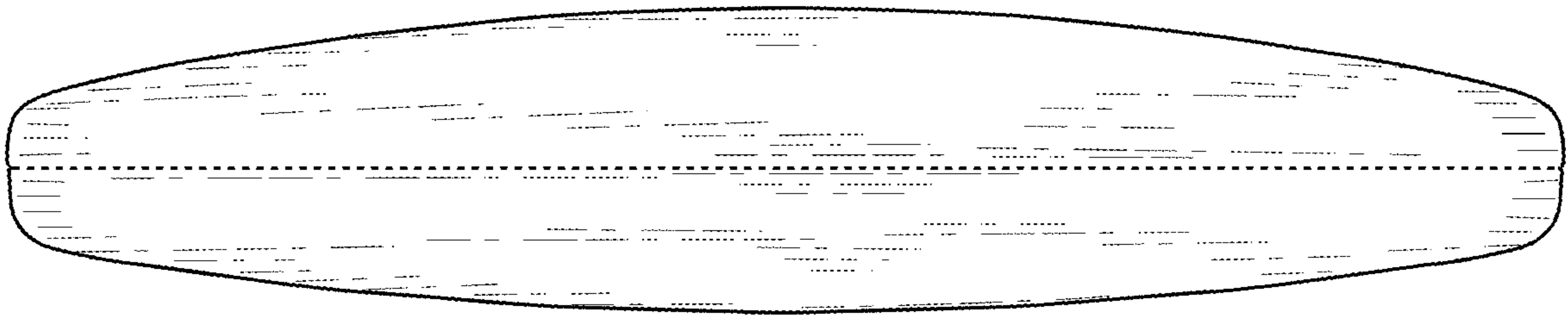

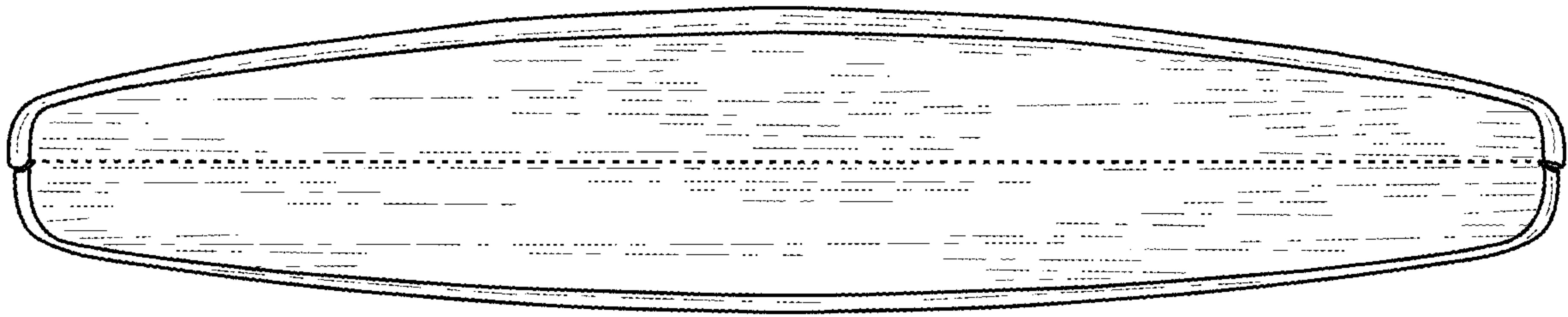

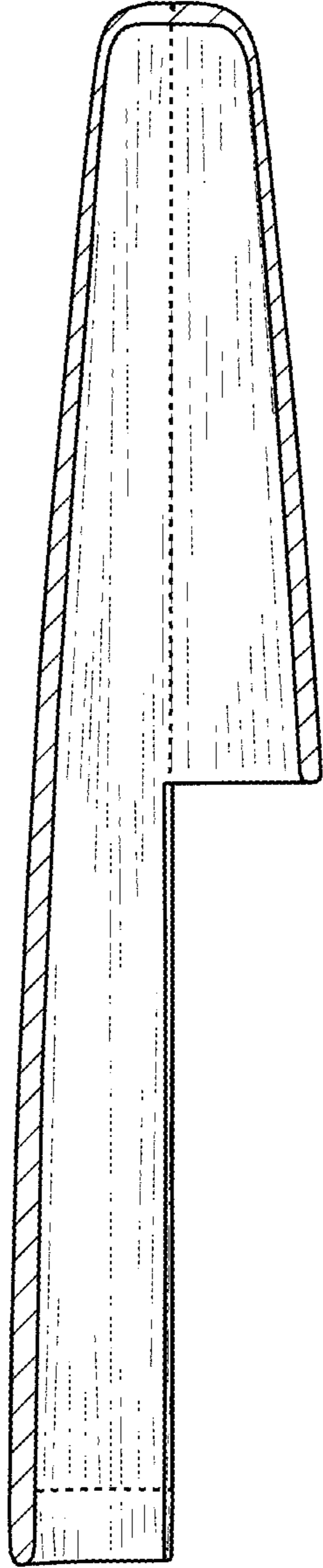
