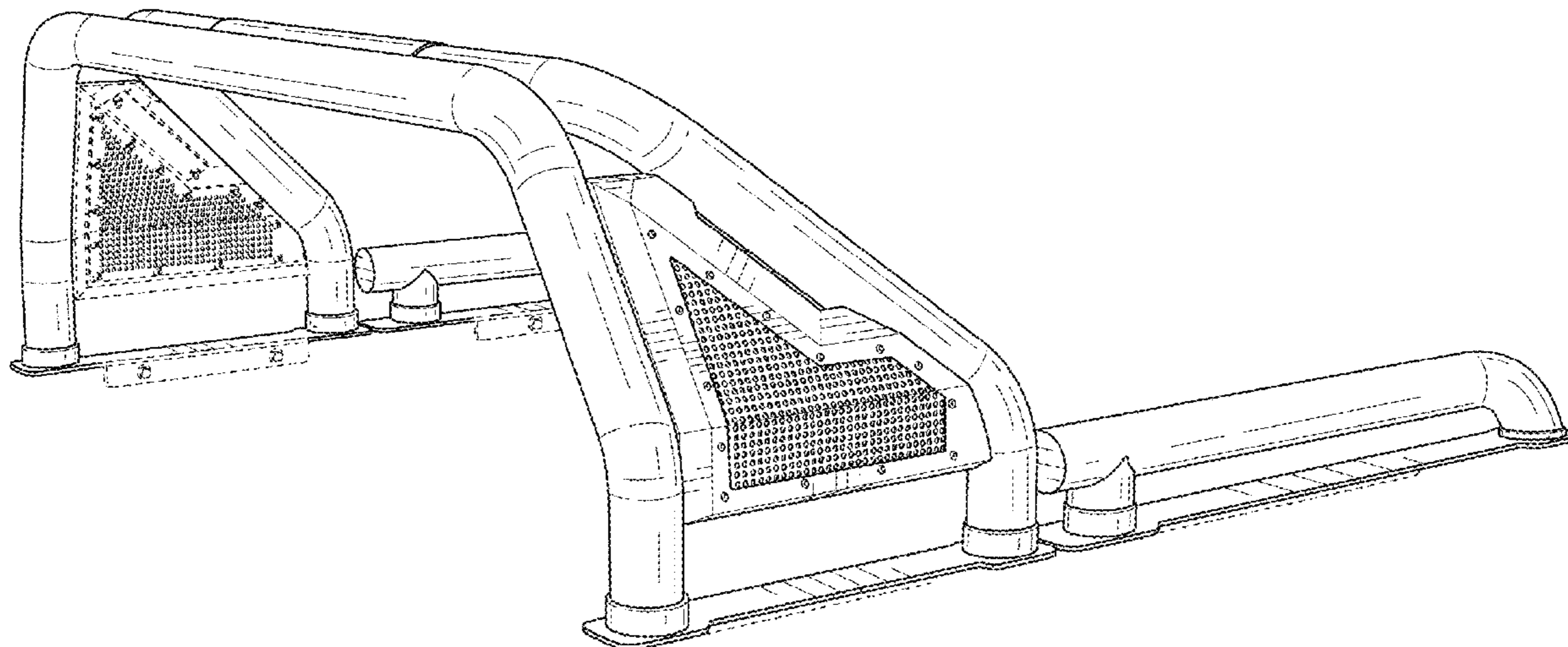

new design;

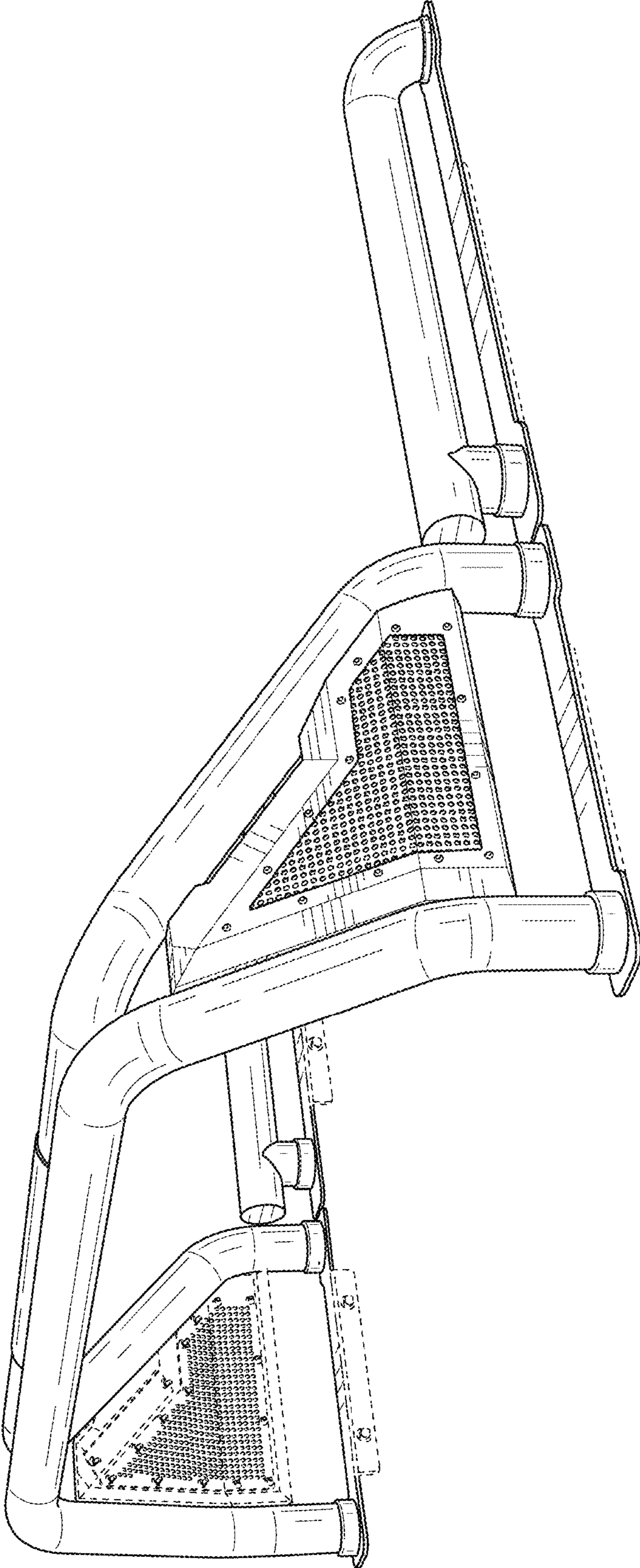

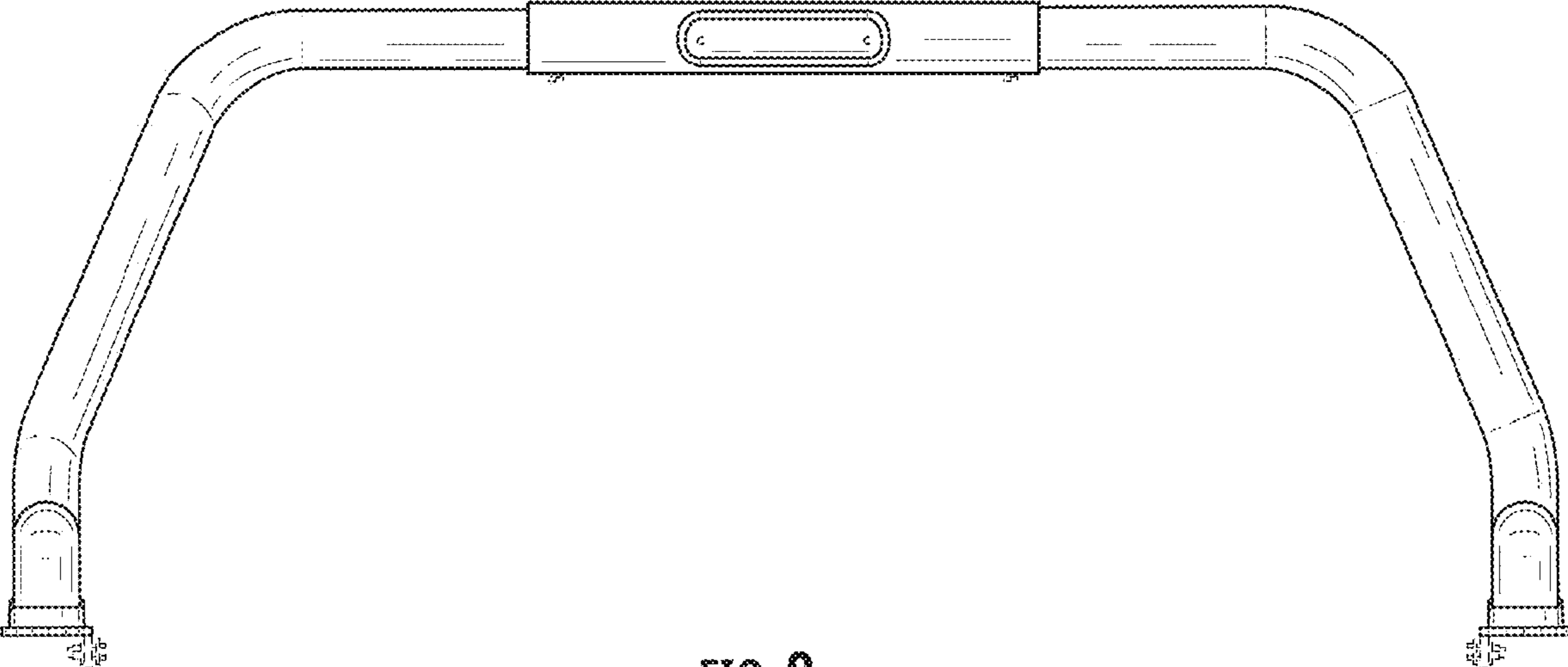

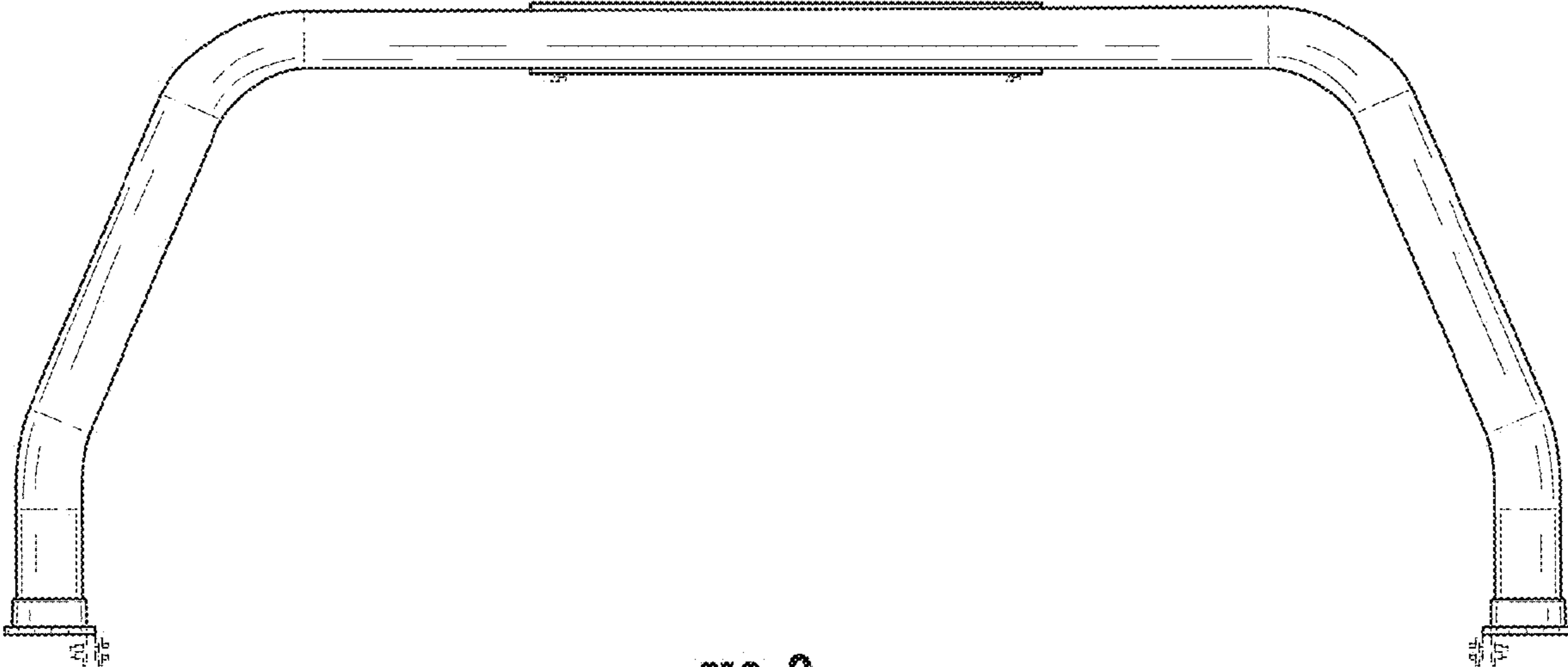

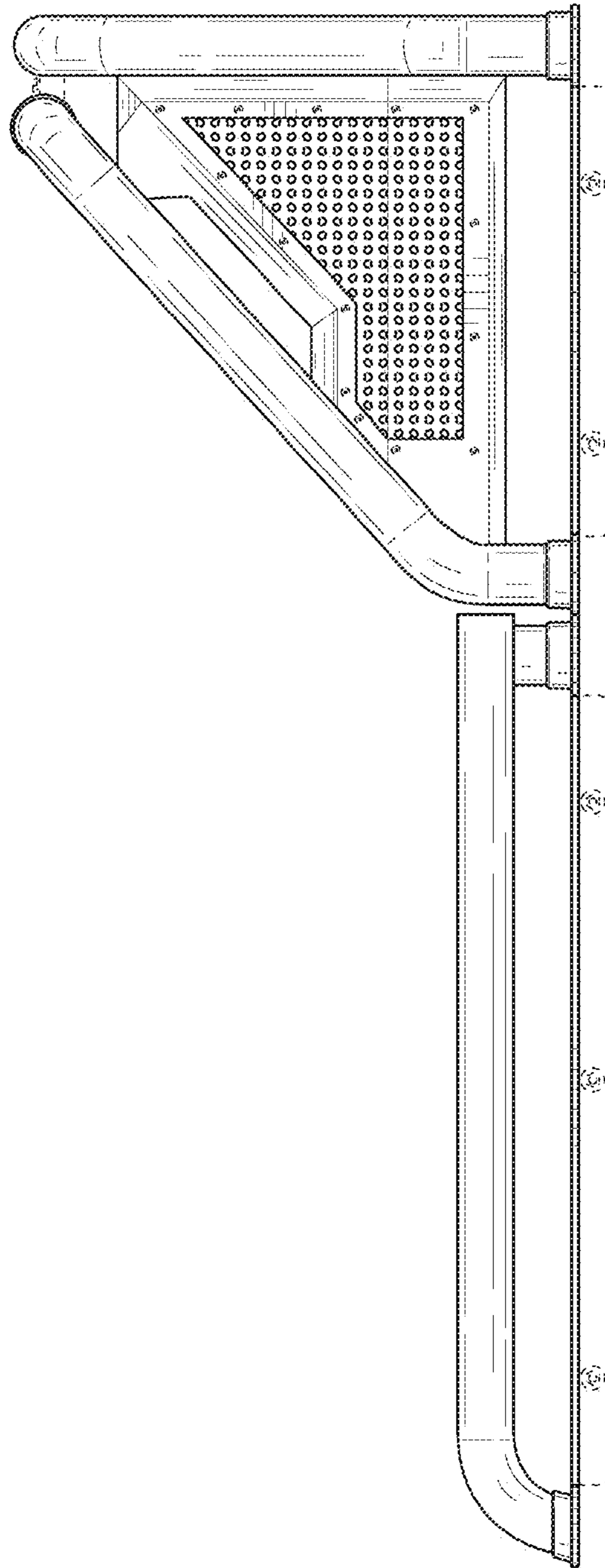

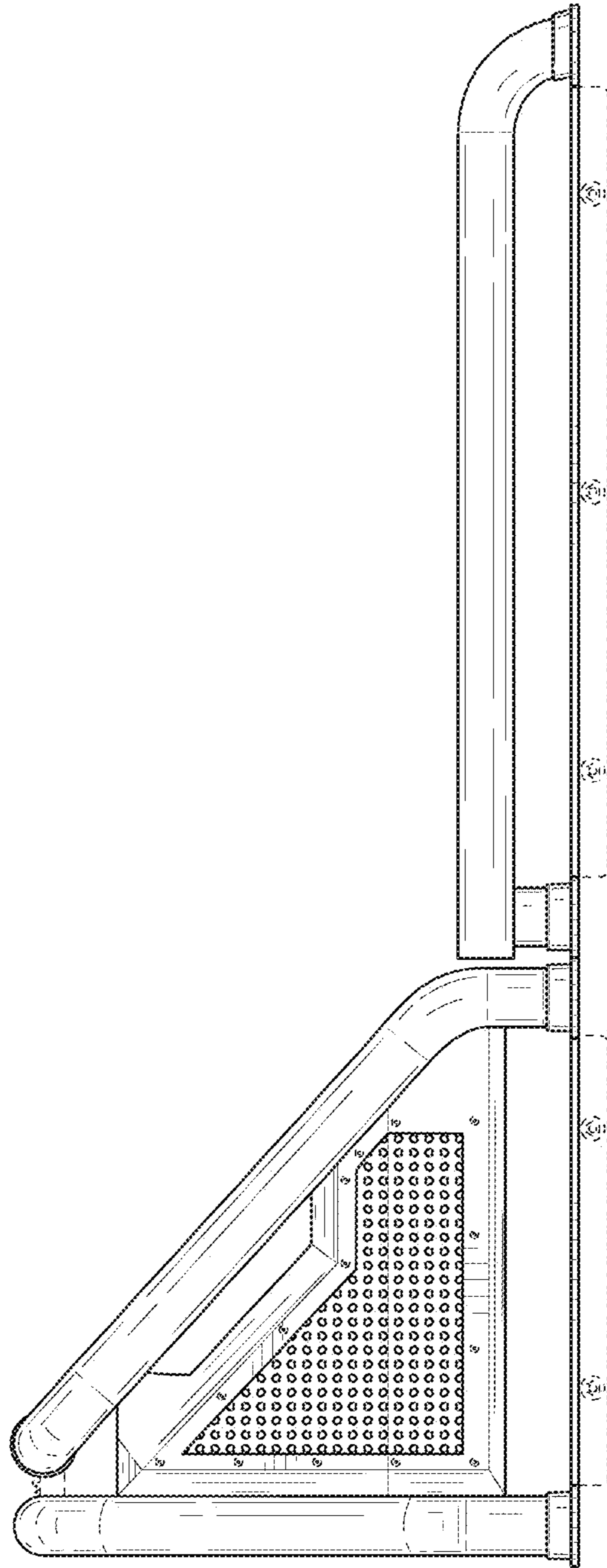

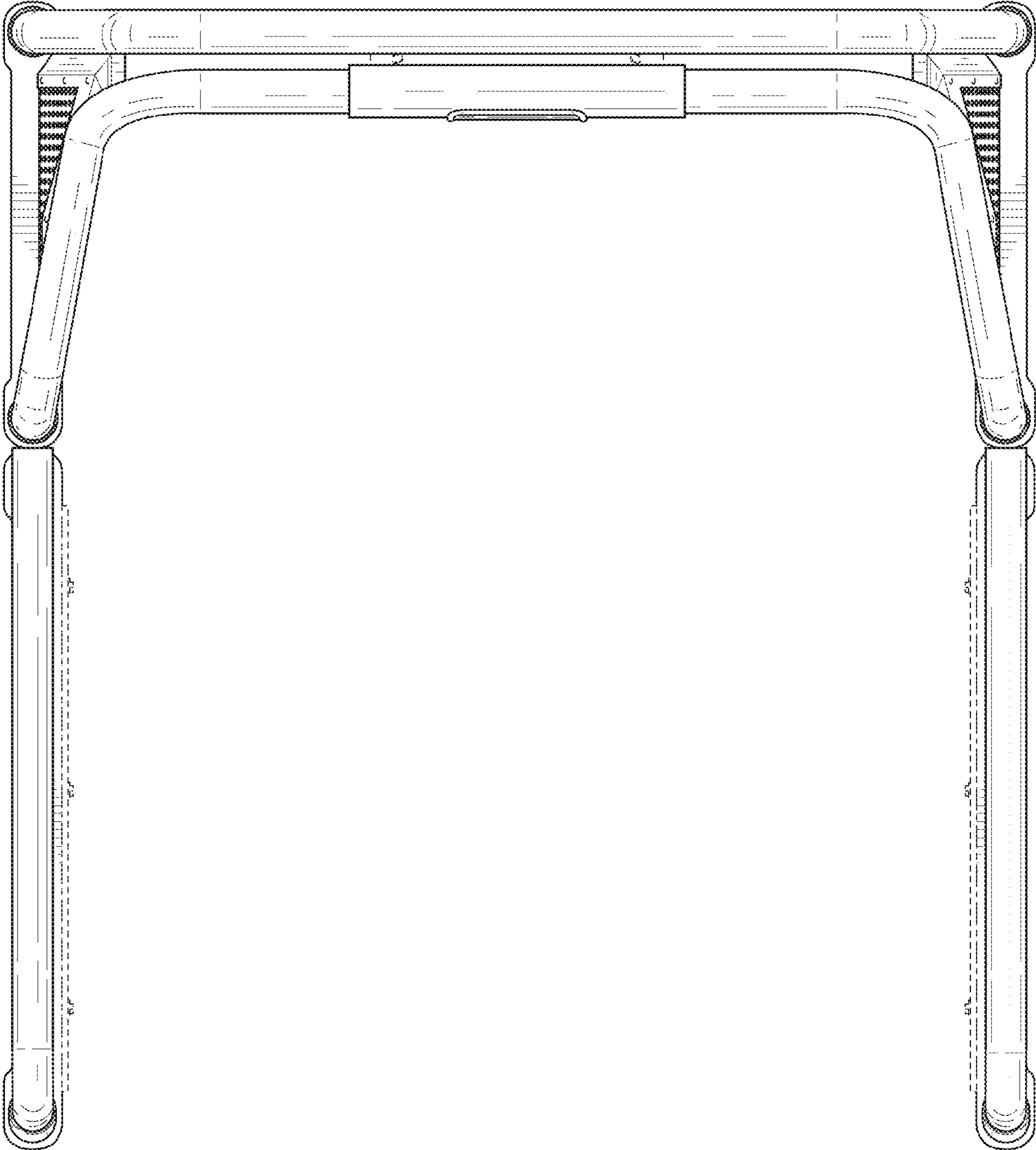

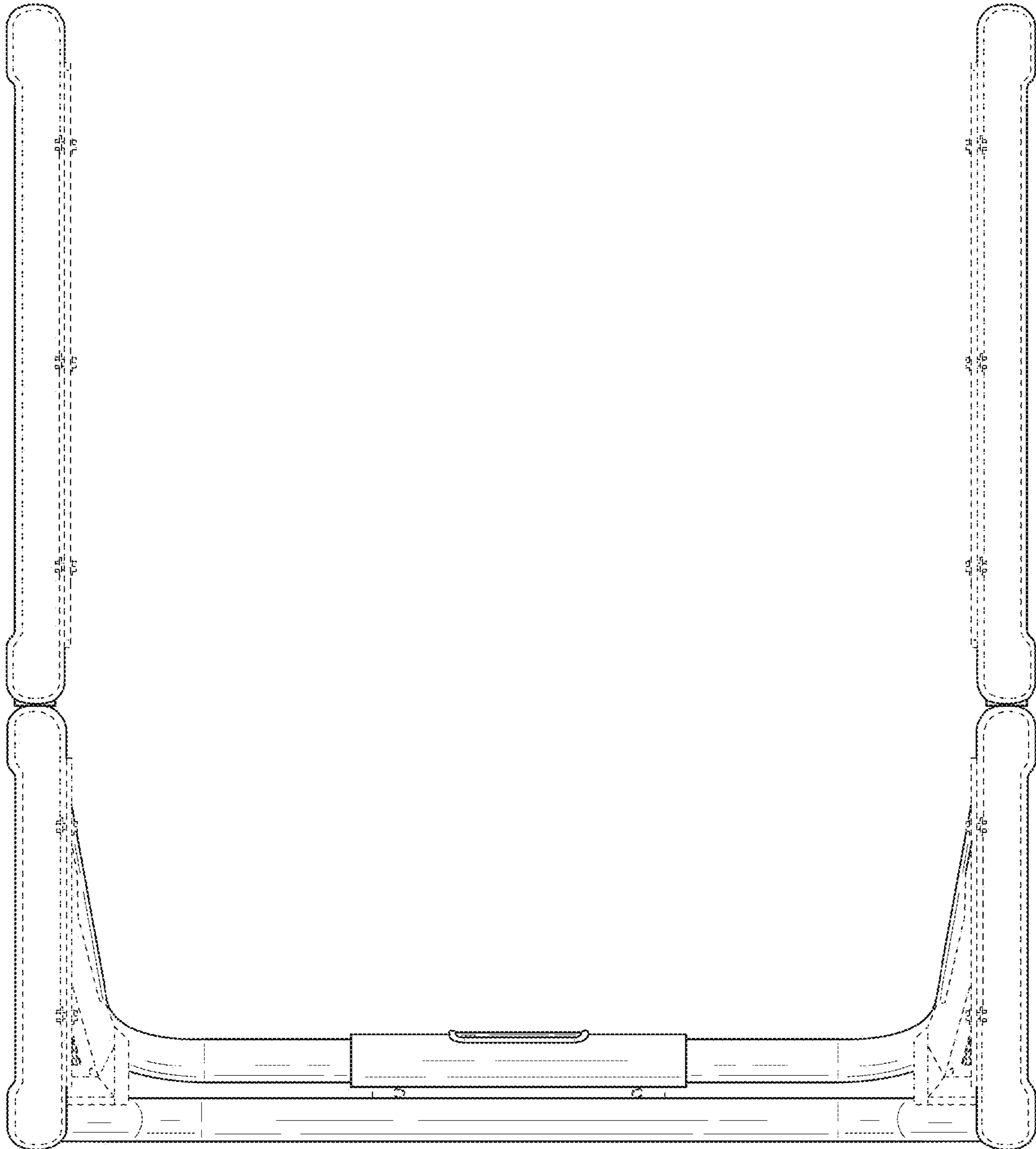
