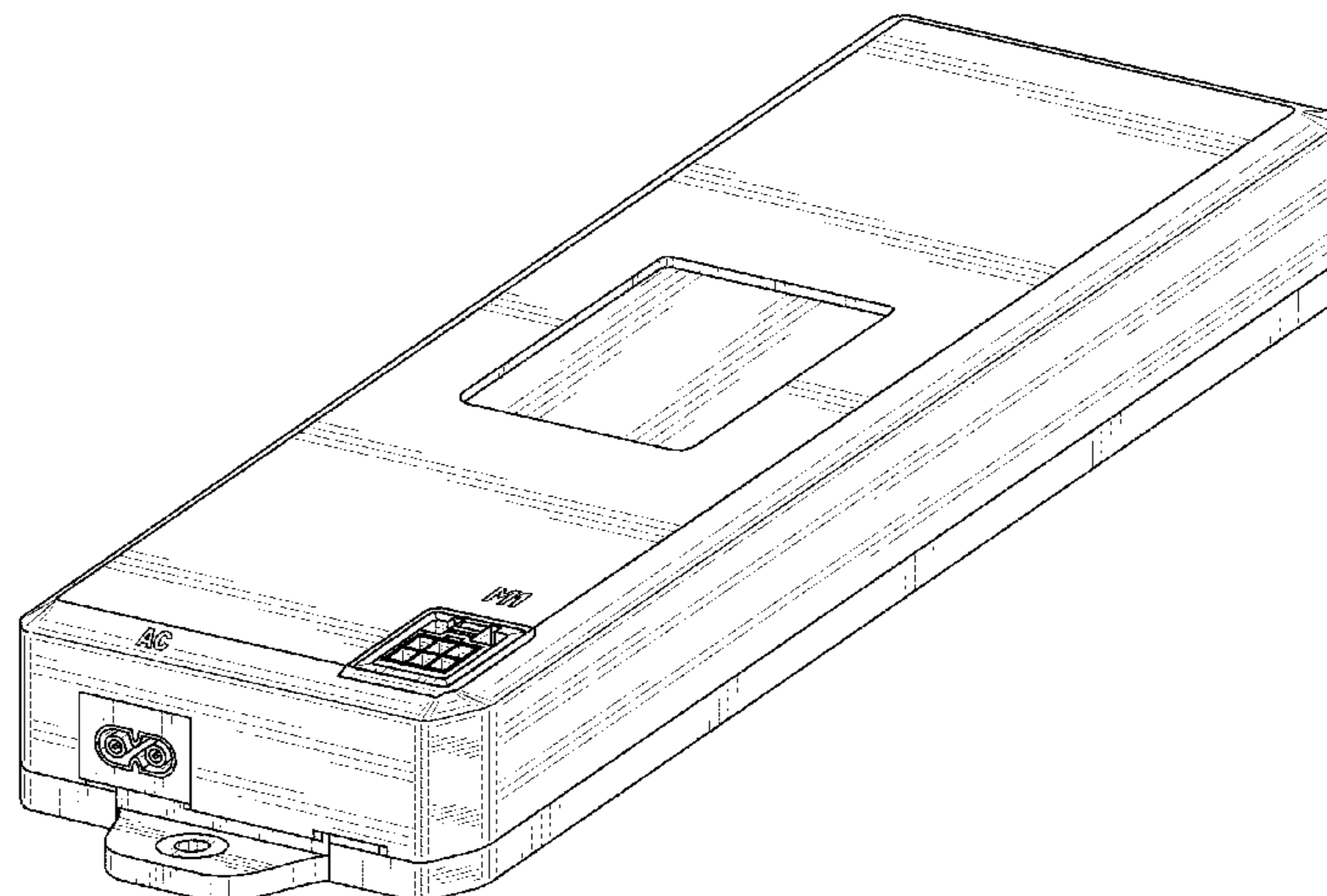
(57) **CLAIM**

**DESCRIPTION**

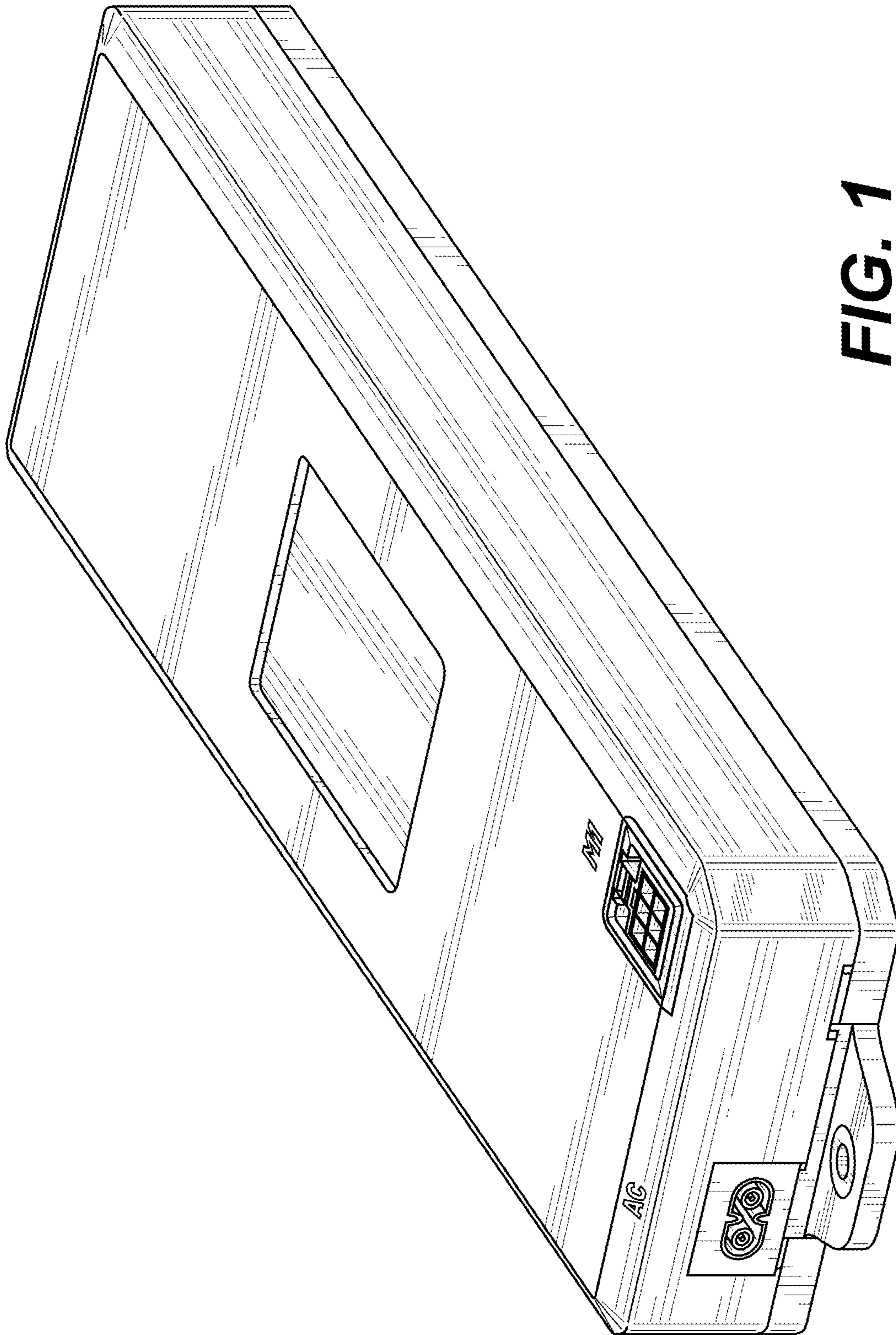
FIG. 1 is a perspective view of a control box showing my new design;

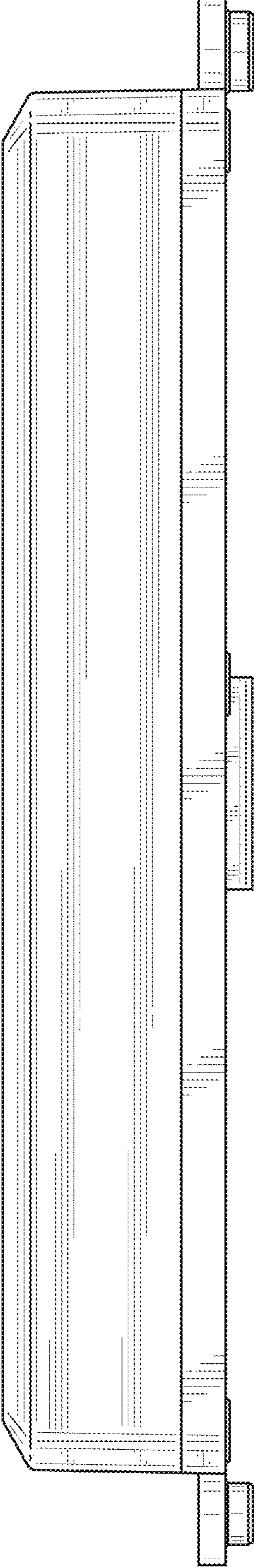


The broken lines illustrate portions of the control box which form no part of the claimed design.

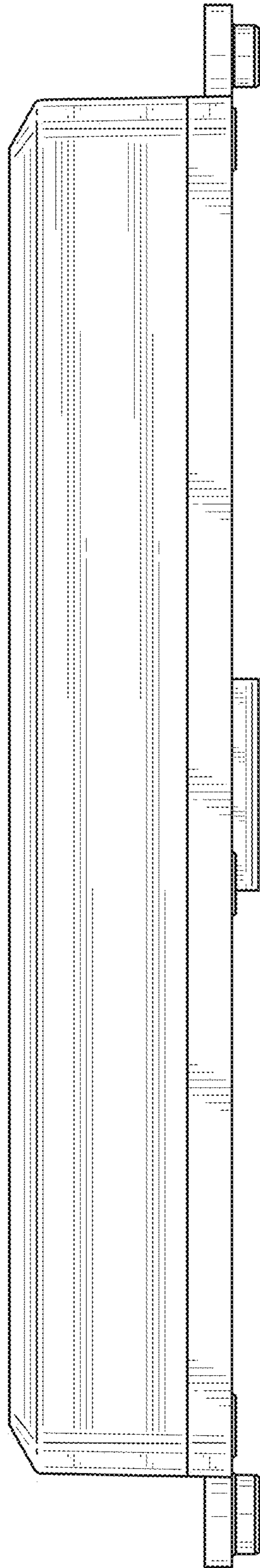

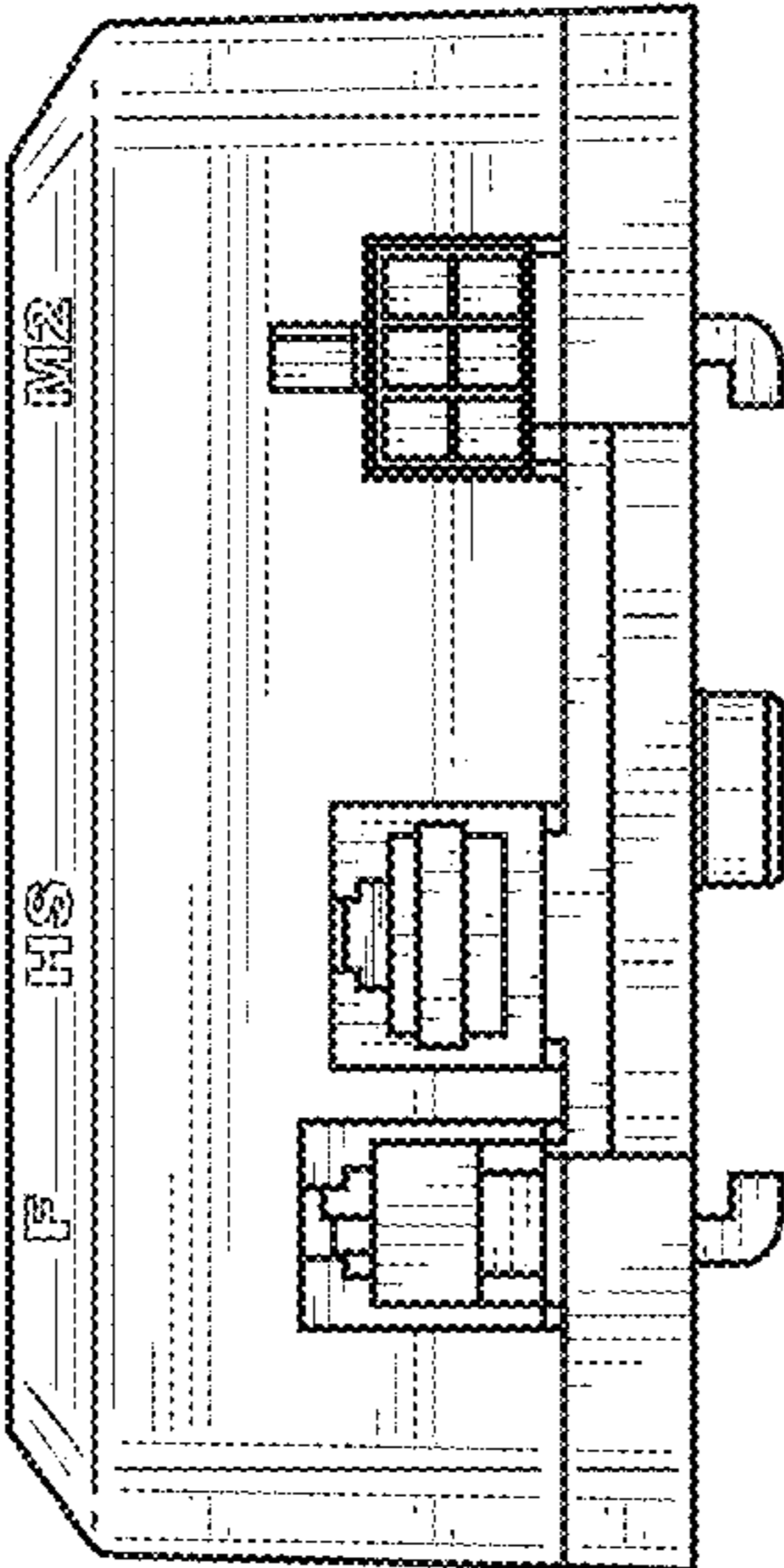

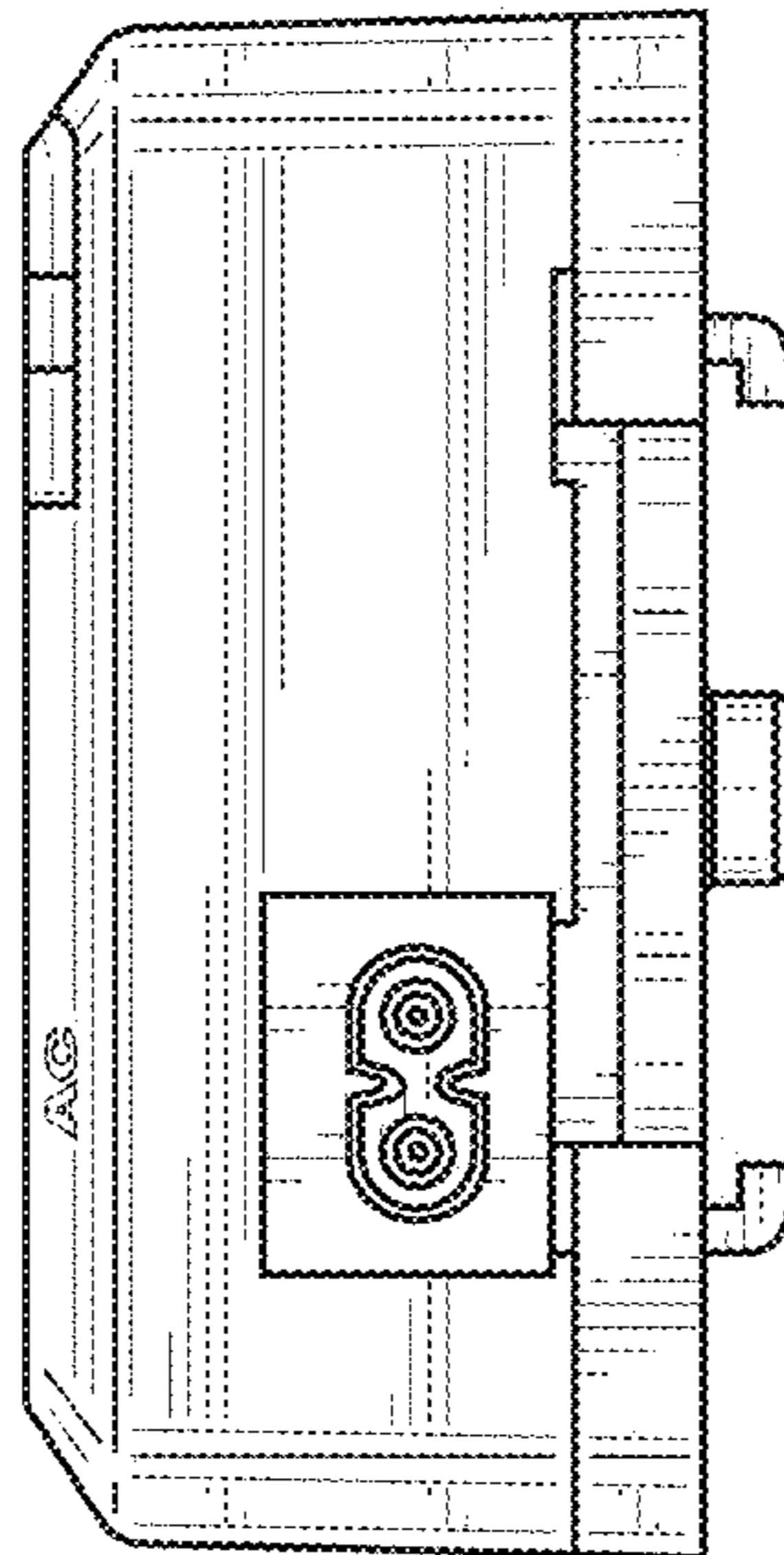

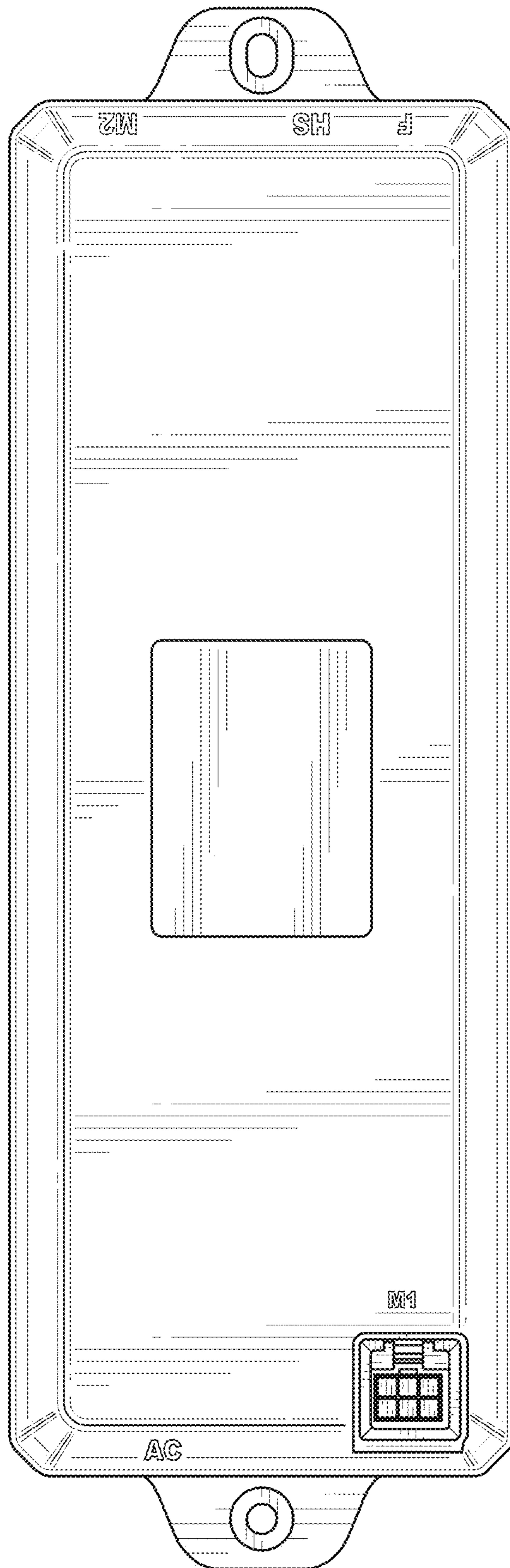

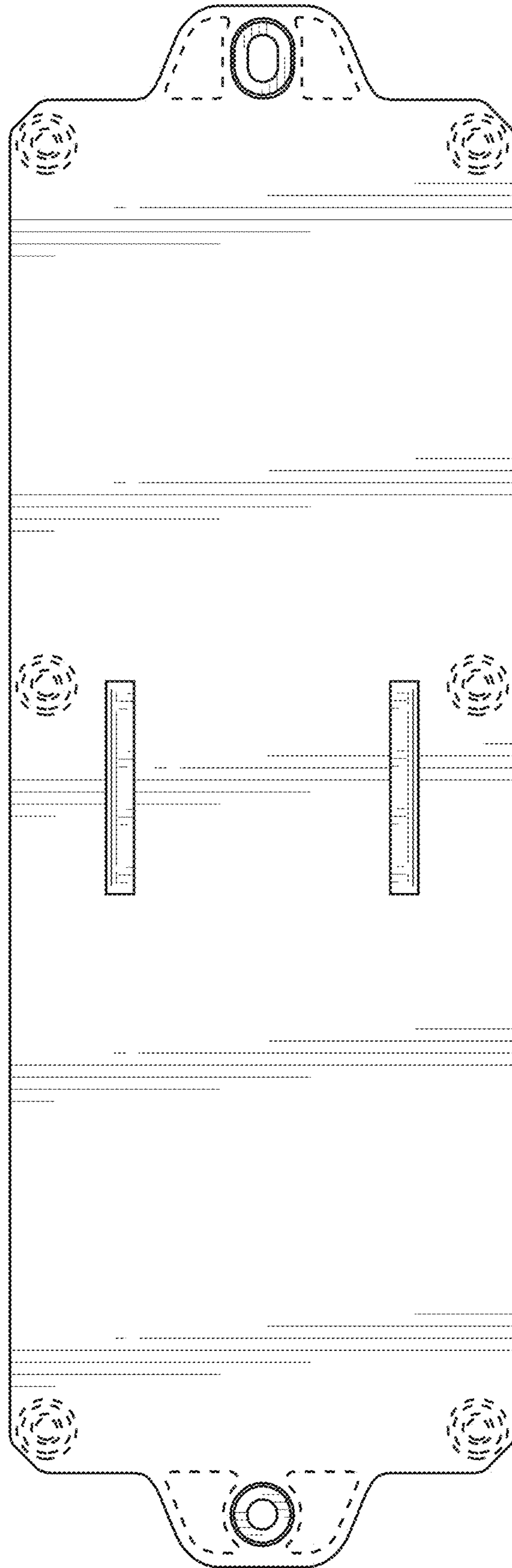

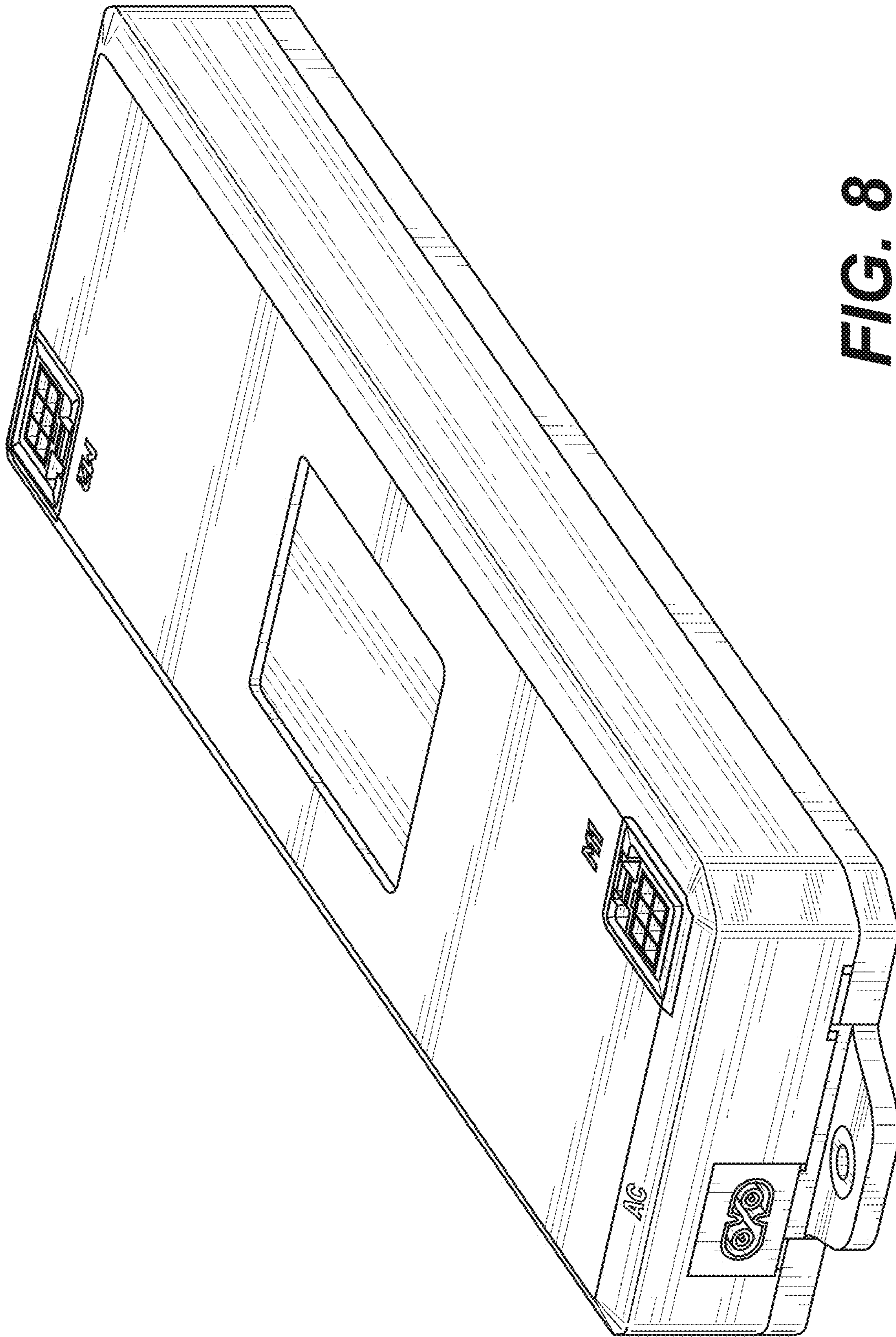
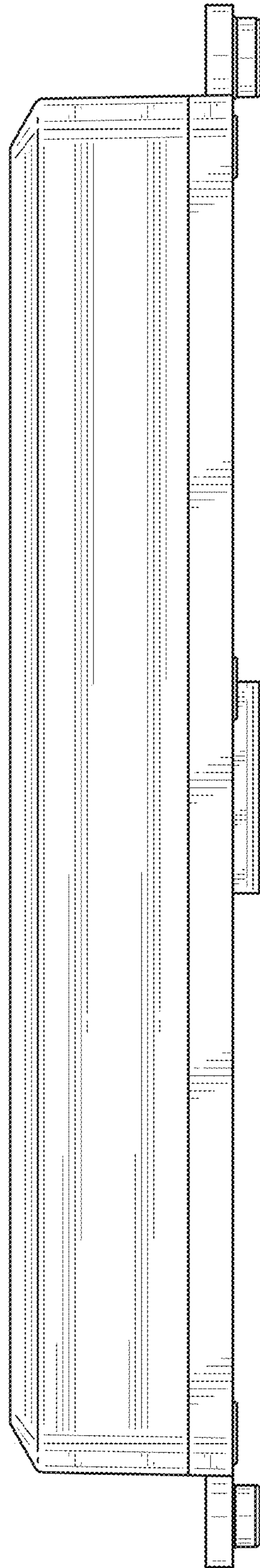
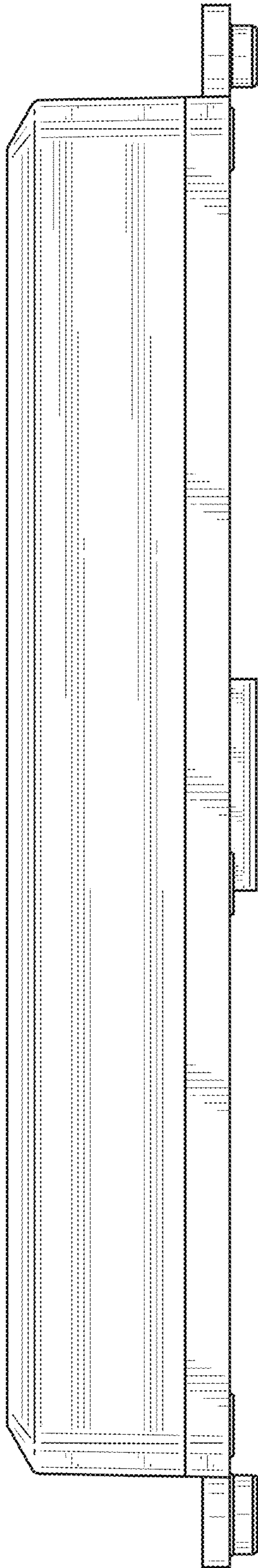


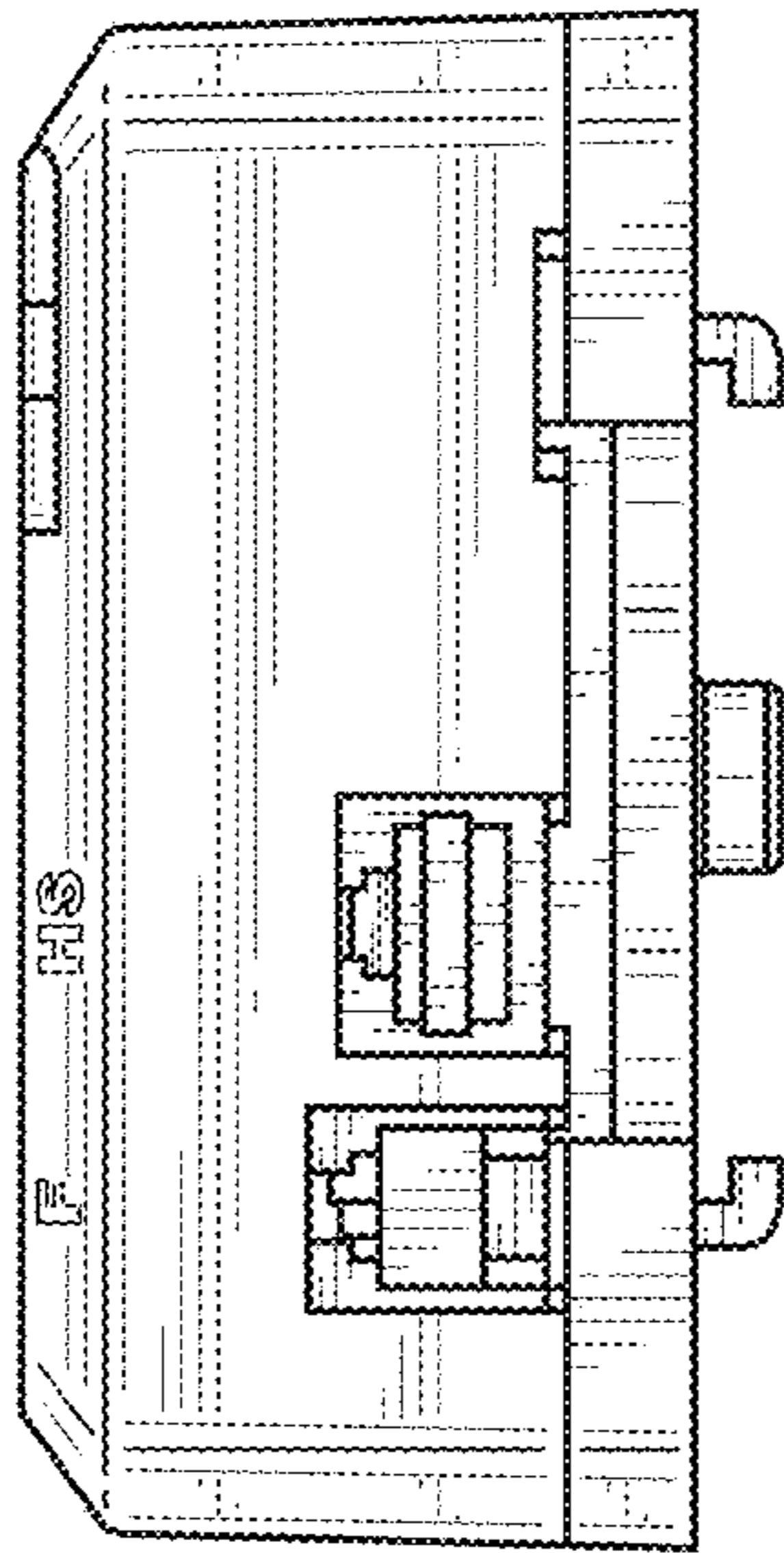

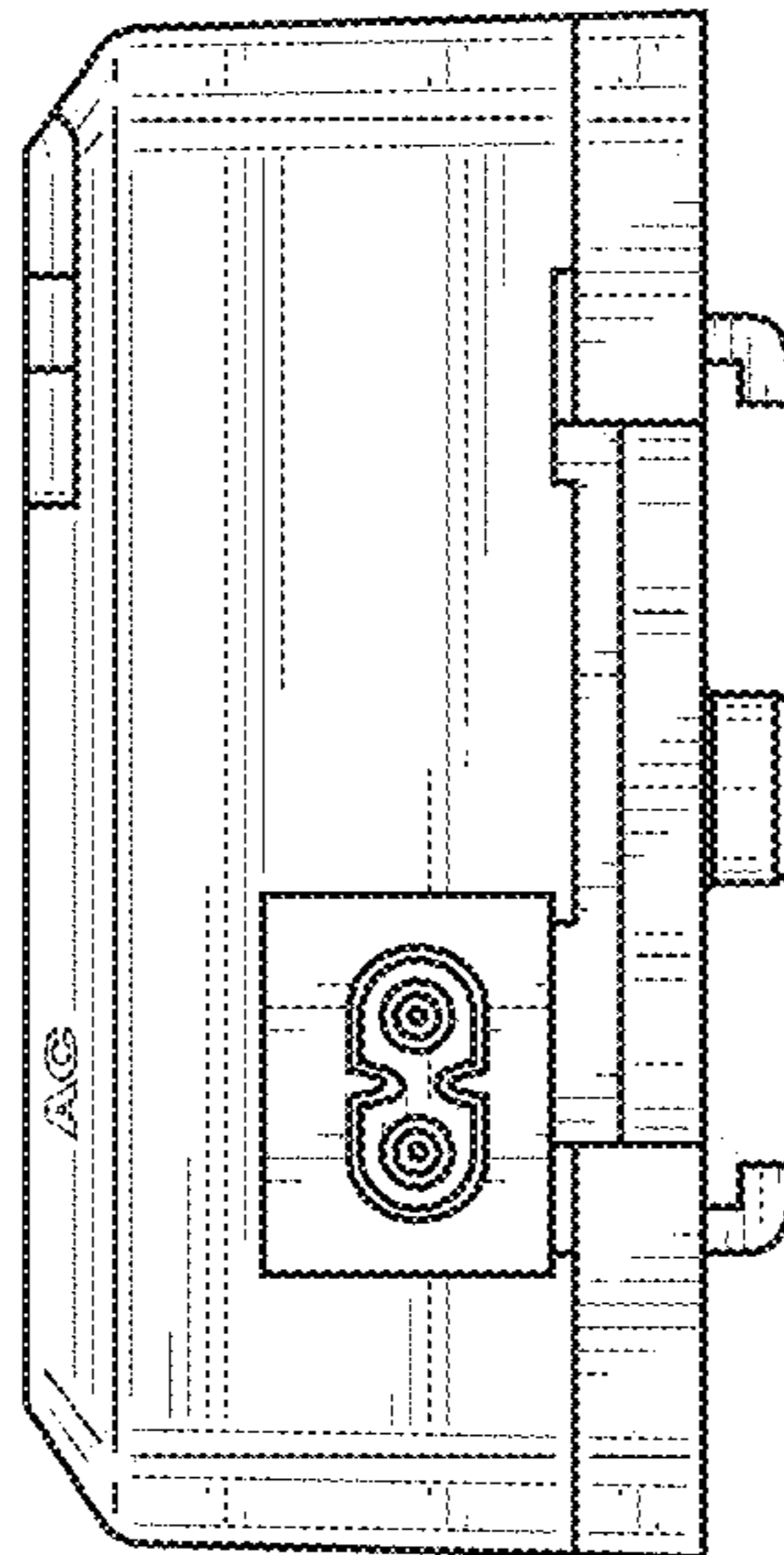

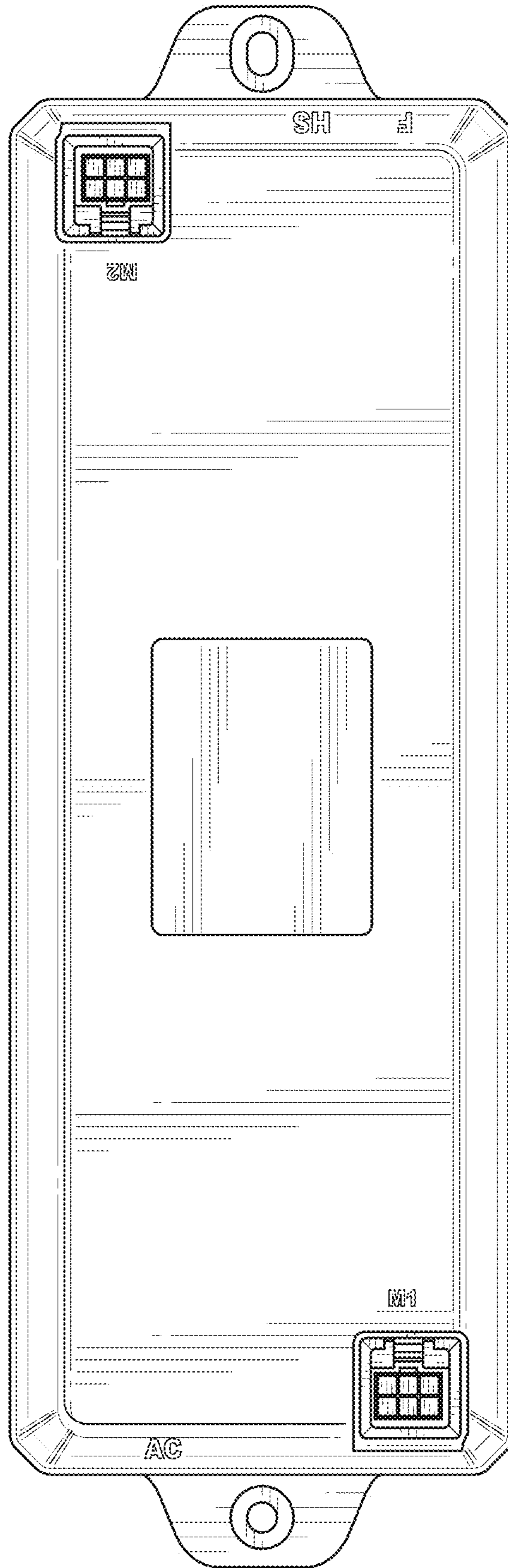

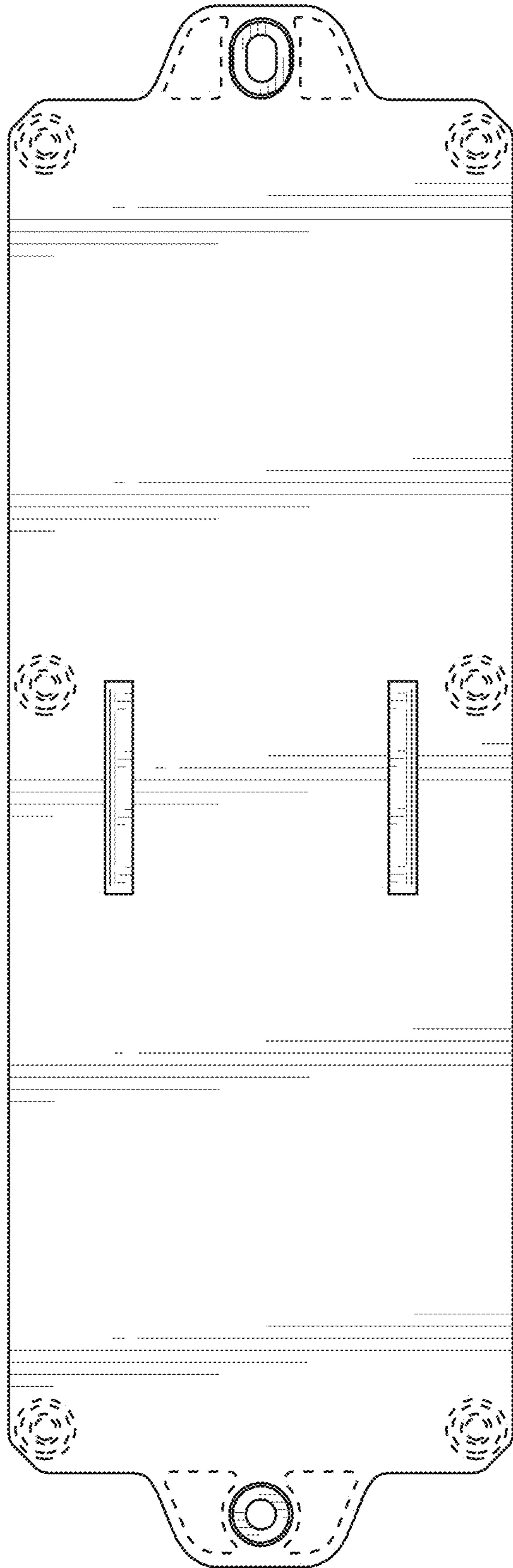
