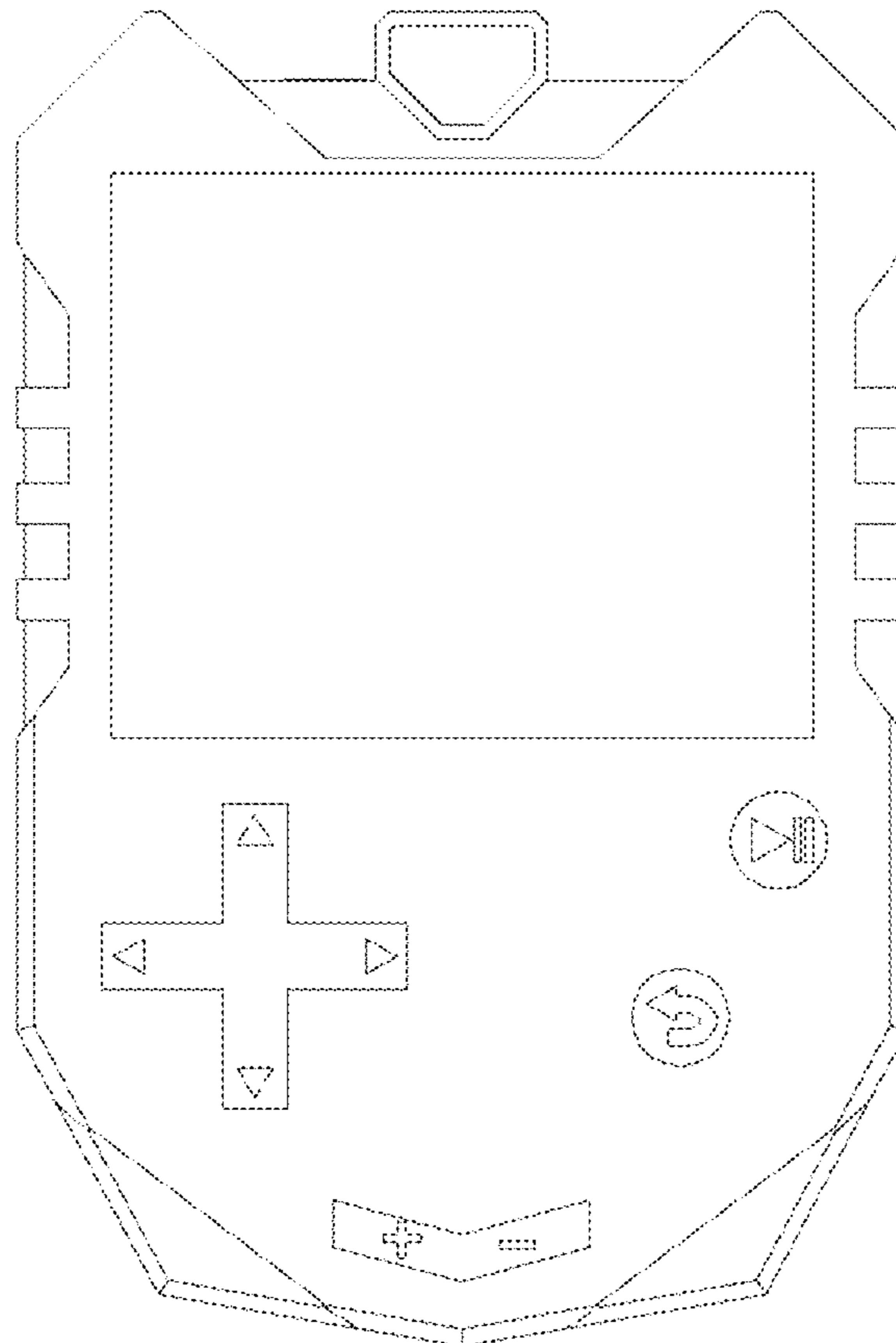
FIG. 1 is a perspective view of a portable music player showing my new design;

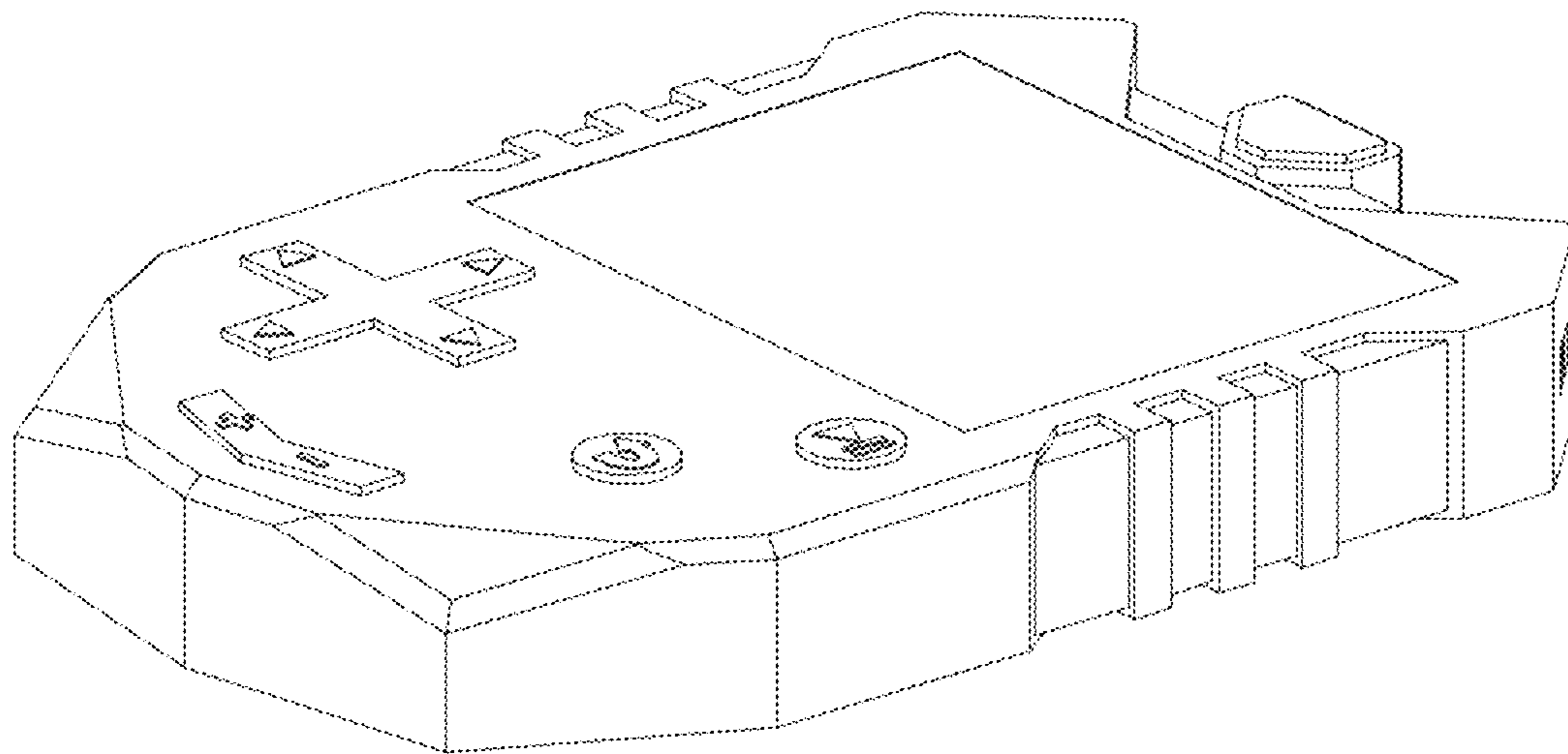

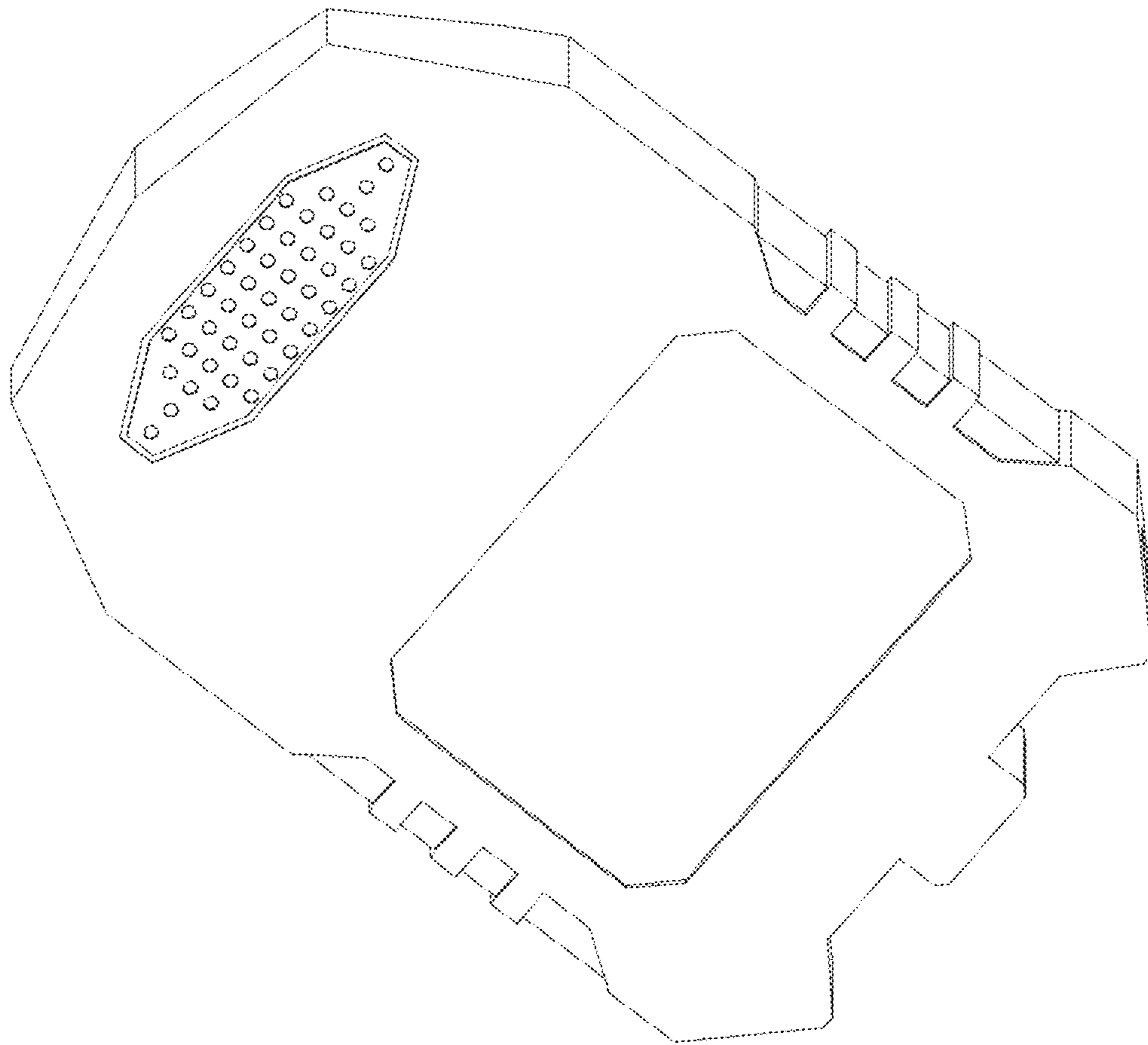

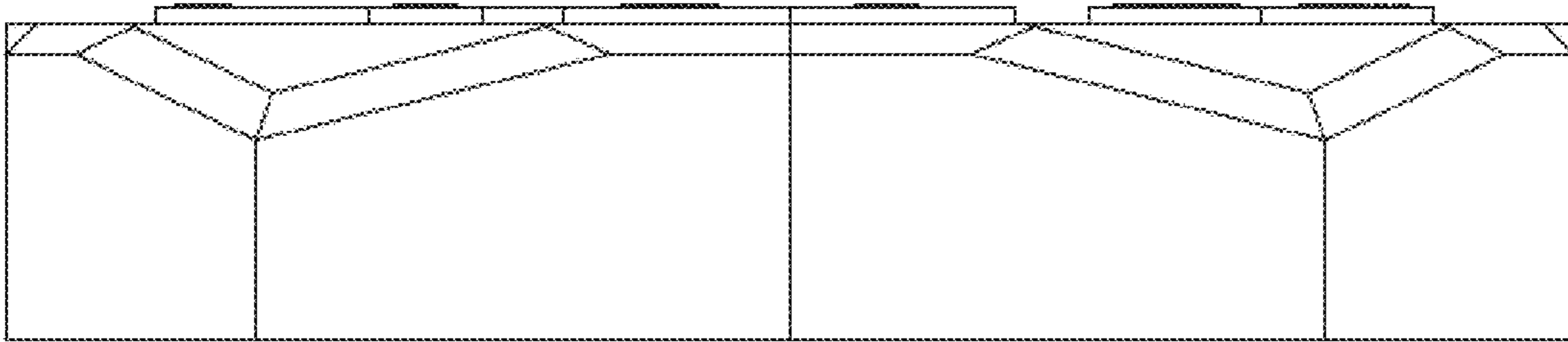

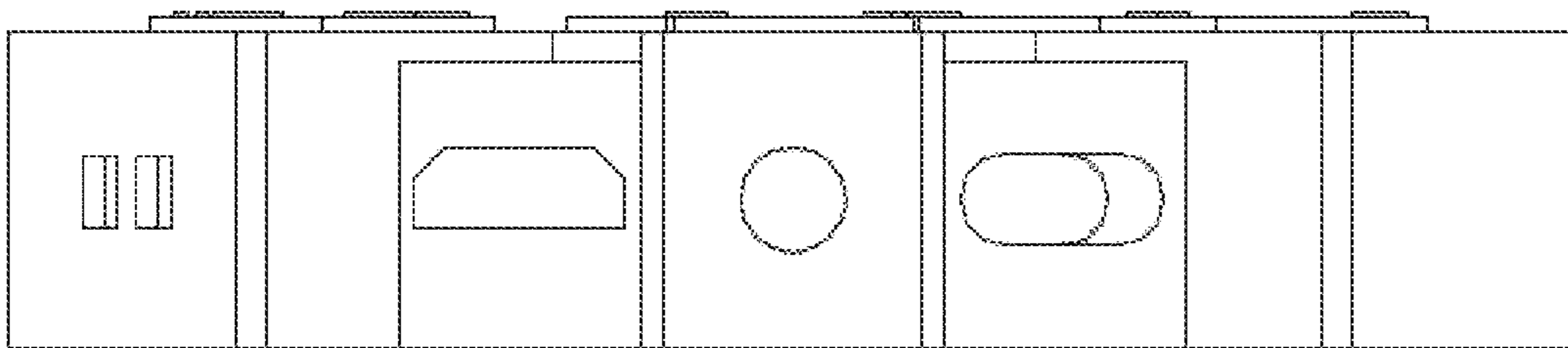

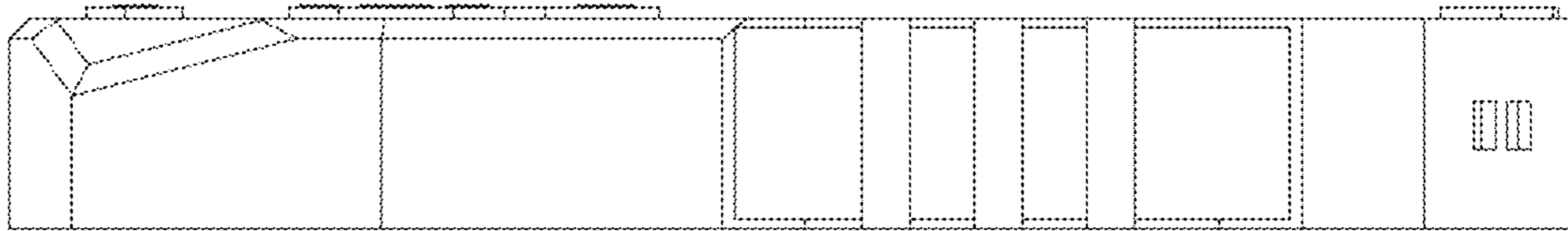

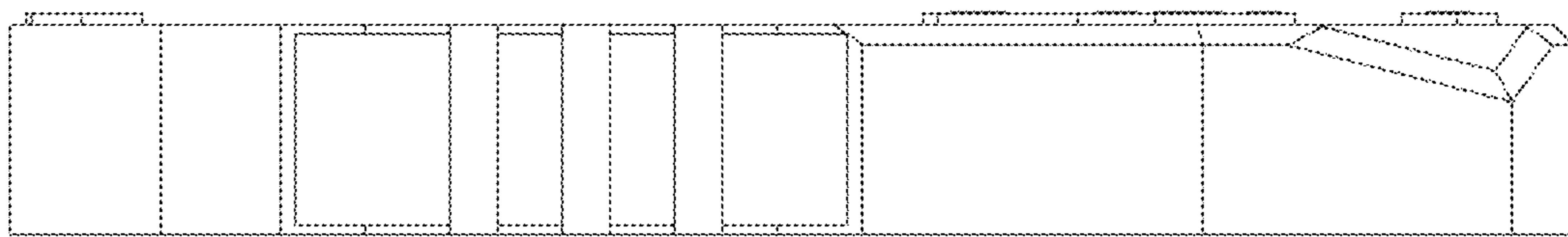

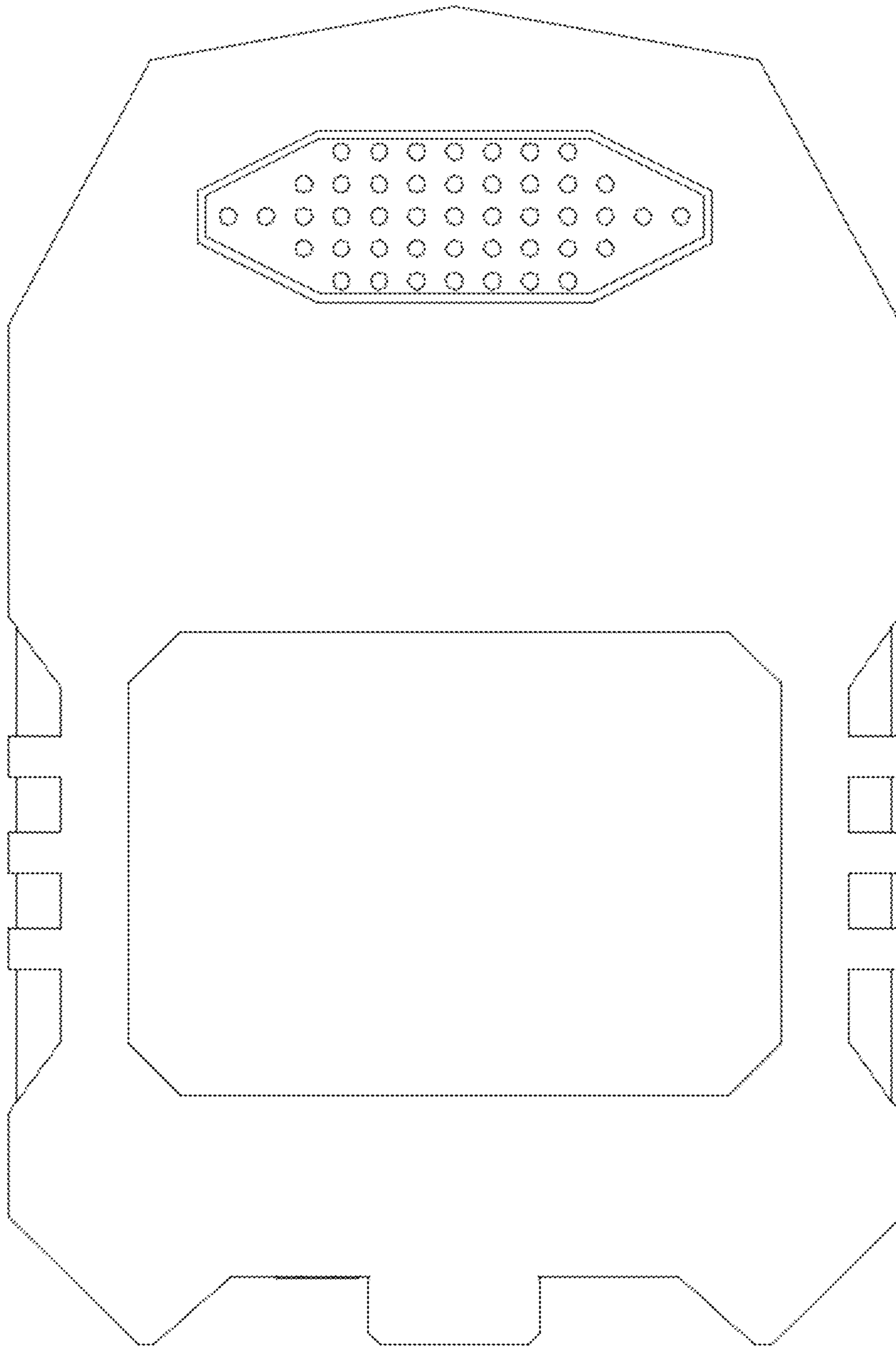

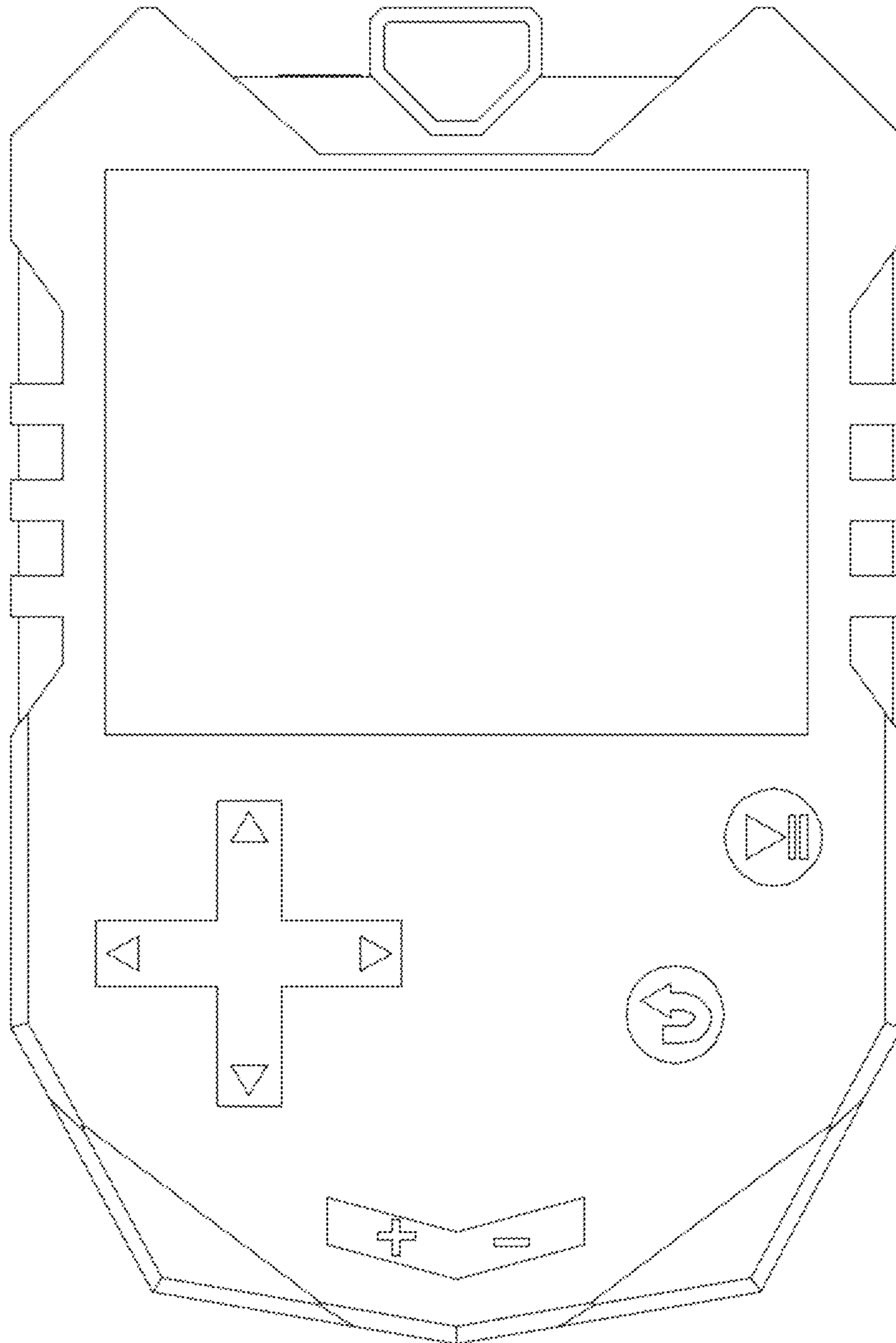
