DESCRIPTION

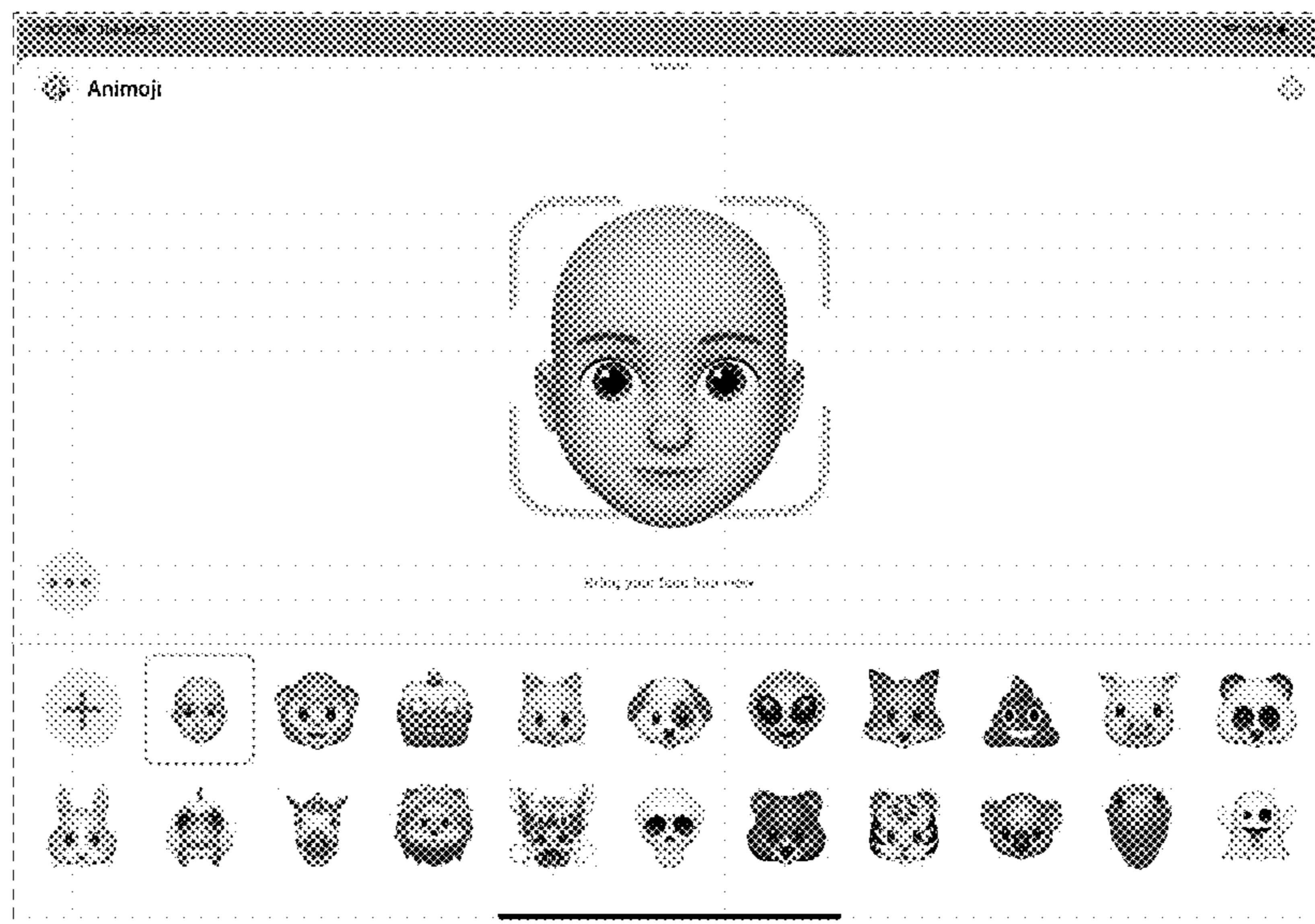

FIG. 1 is a front view of an electronic device with graphical user interface showing a first embodiment of the claimed design;

FIG. 2 is another embodiment thereof; and, FIG. 3 is a front view of an alternate electronic device showing the graphical user interface of FIG. 1 applied thereto. The graphical user interface design of FIG. 2 may be similarly applied thereto.

The outer broken lines in the figures show an electronic device having a display screen, or an alternate electronic device having a display screen, and form no part of the claimed design.

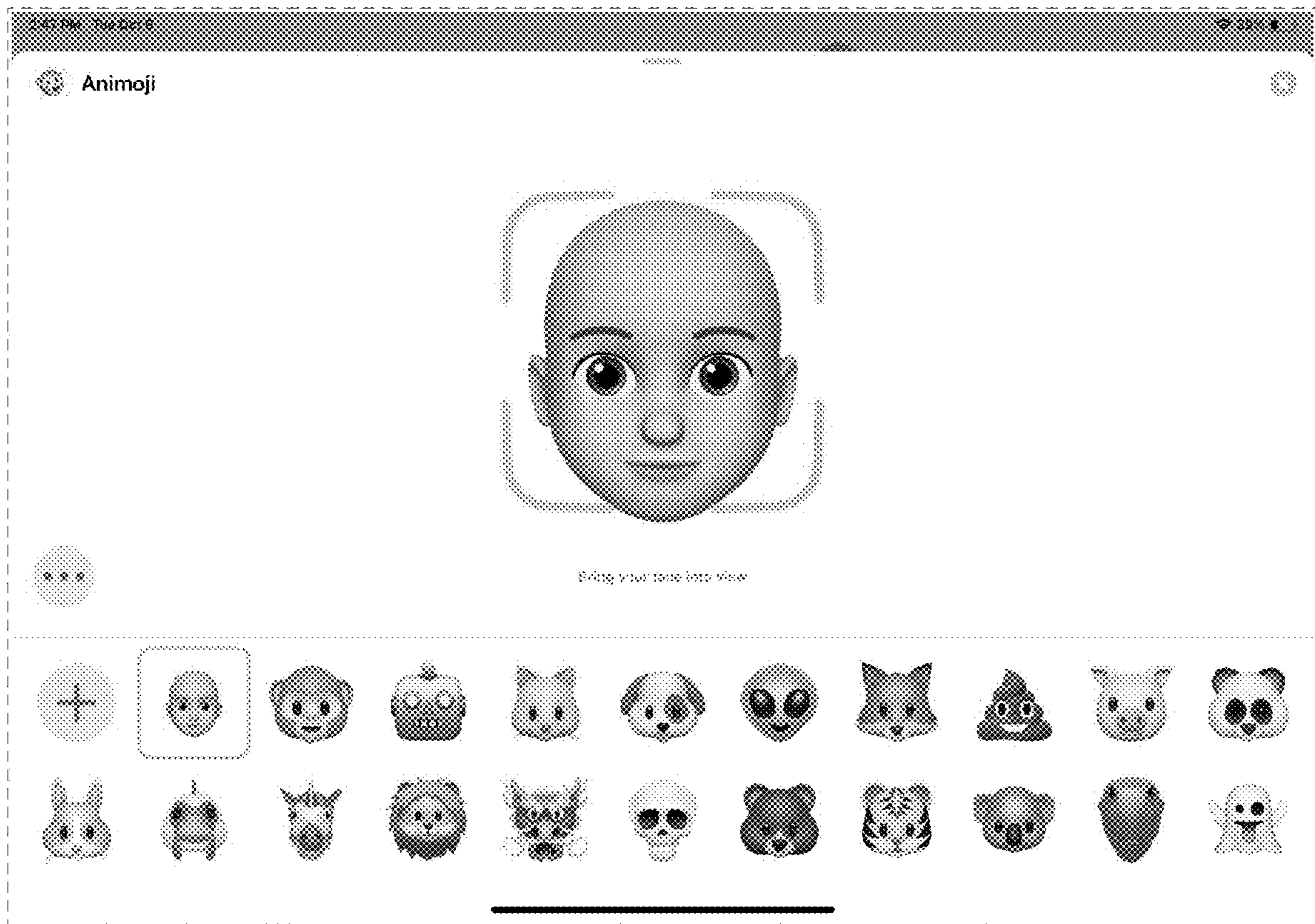

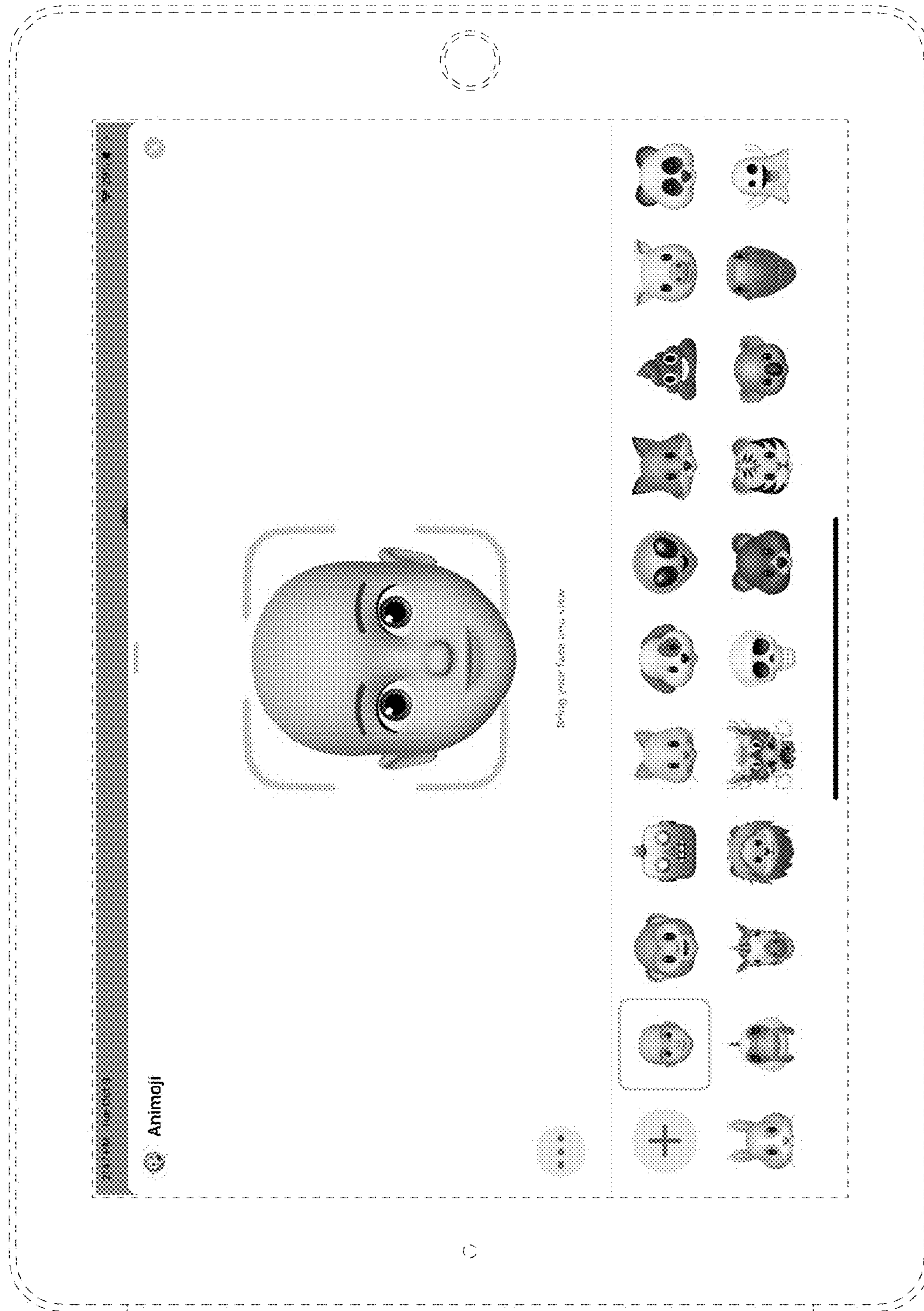
