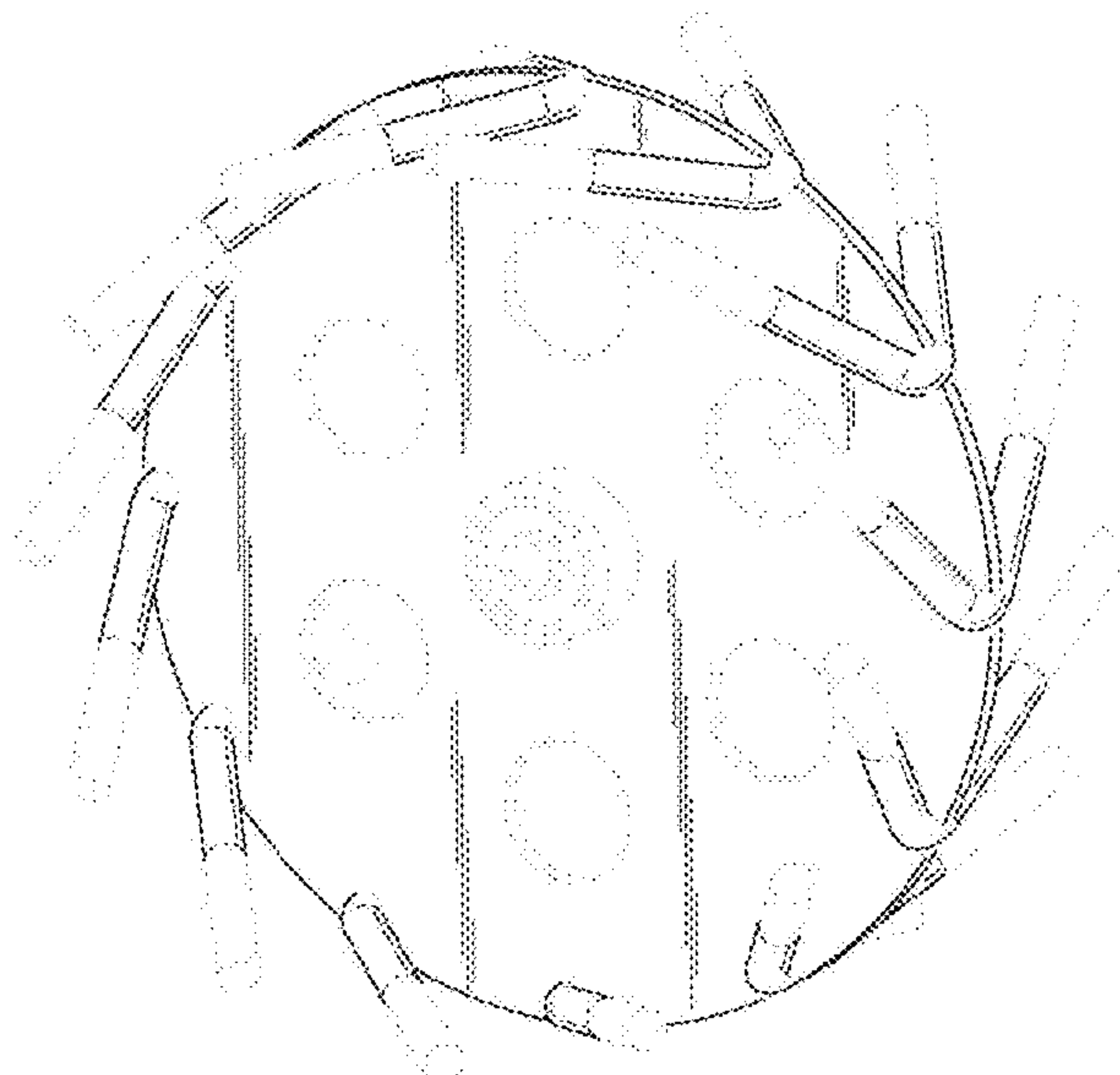
(57) **CLAIM**

The ornamental design for a press wheel, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a press wheel with environment shown in broken lines; FIG. 2 is a front view of FIG. 1; FIG. 3 is a back view of FIG. 1; FIG. 4 is a top view of FIG. 1; and, FIG. 5 is a bottom view of FIG. 1, with left and right view omitted as being the same as the top and bottom views. The dashed lines in FIGS. 1-1 are provided for illustrative purposes only, and form no part of the claimed design. The dash dot lines shown in FIGS. 1-5 illustrate the boundary between claimed and unclaimed subject matter.

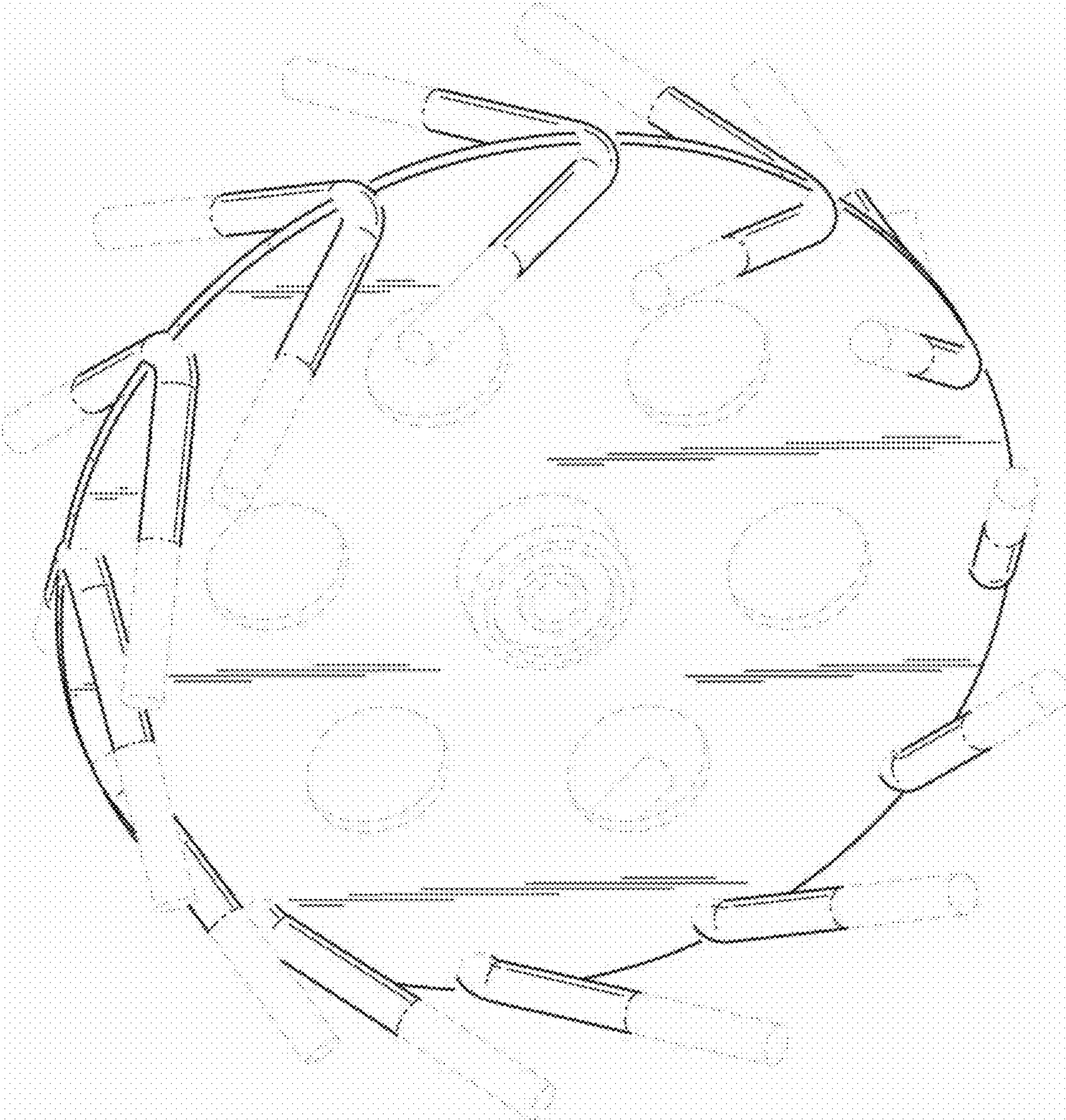

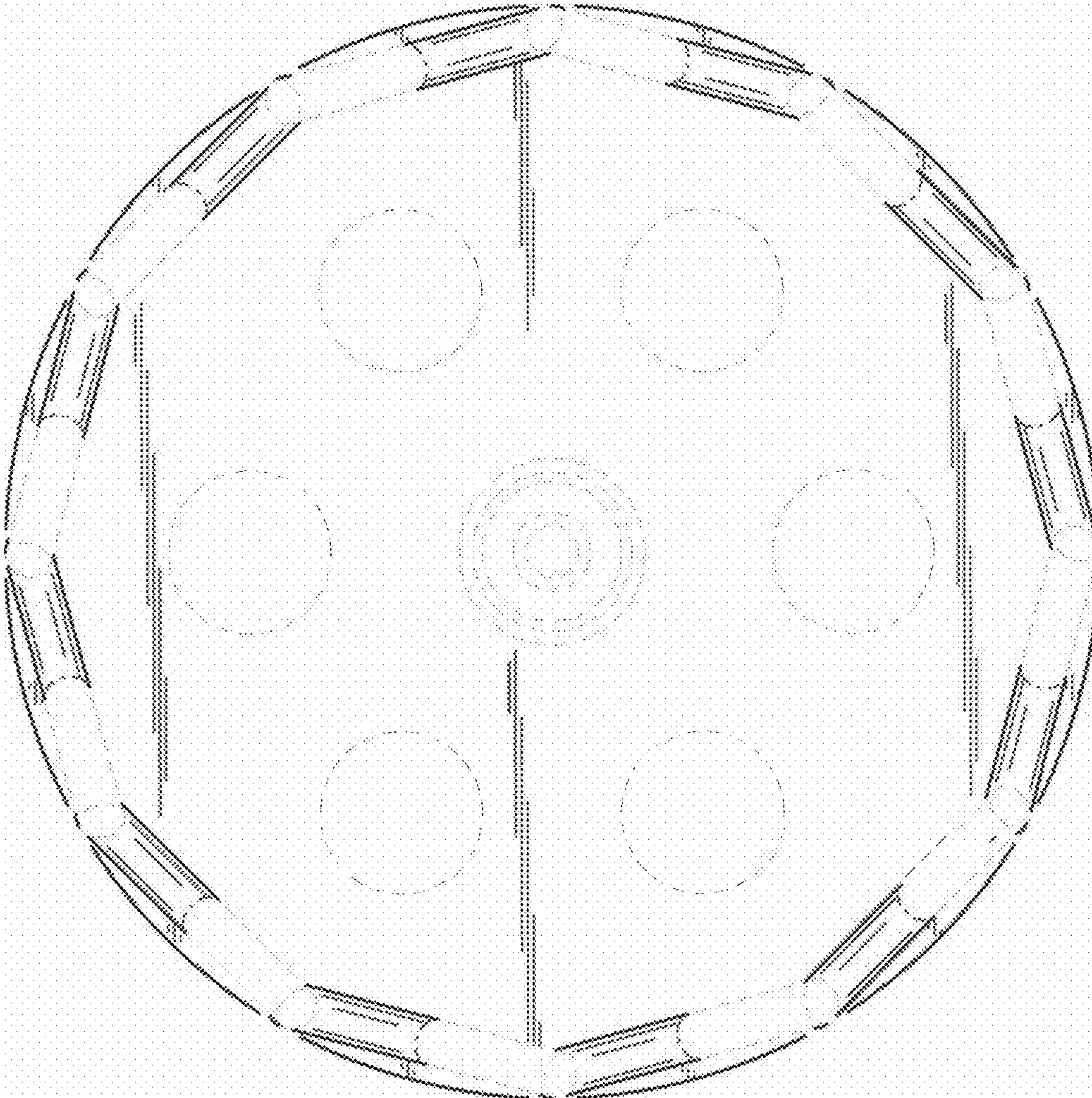

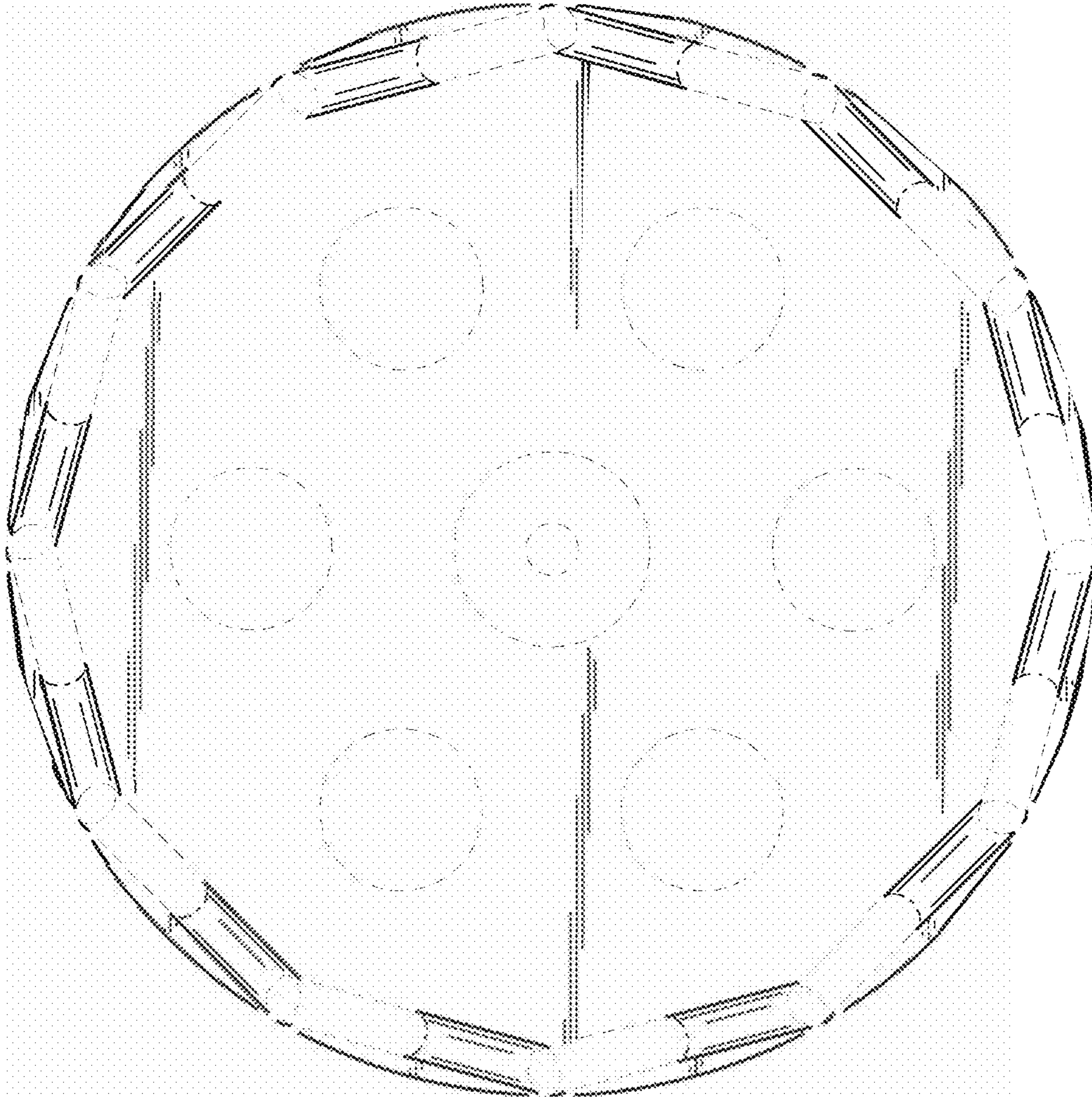

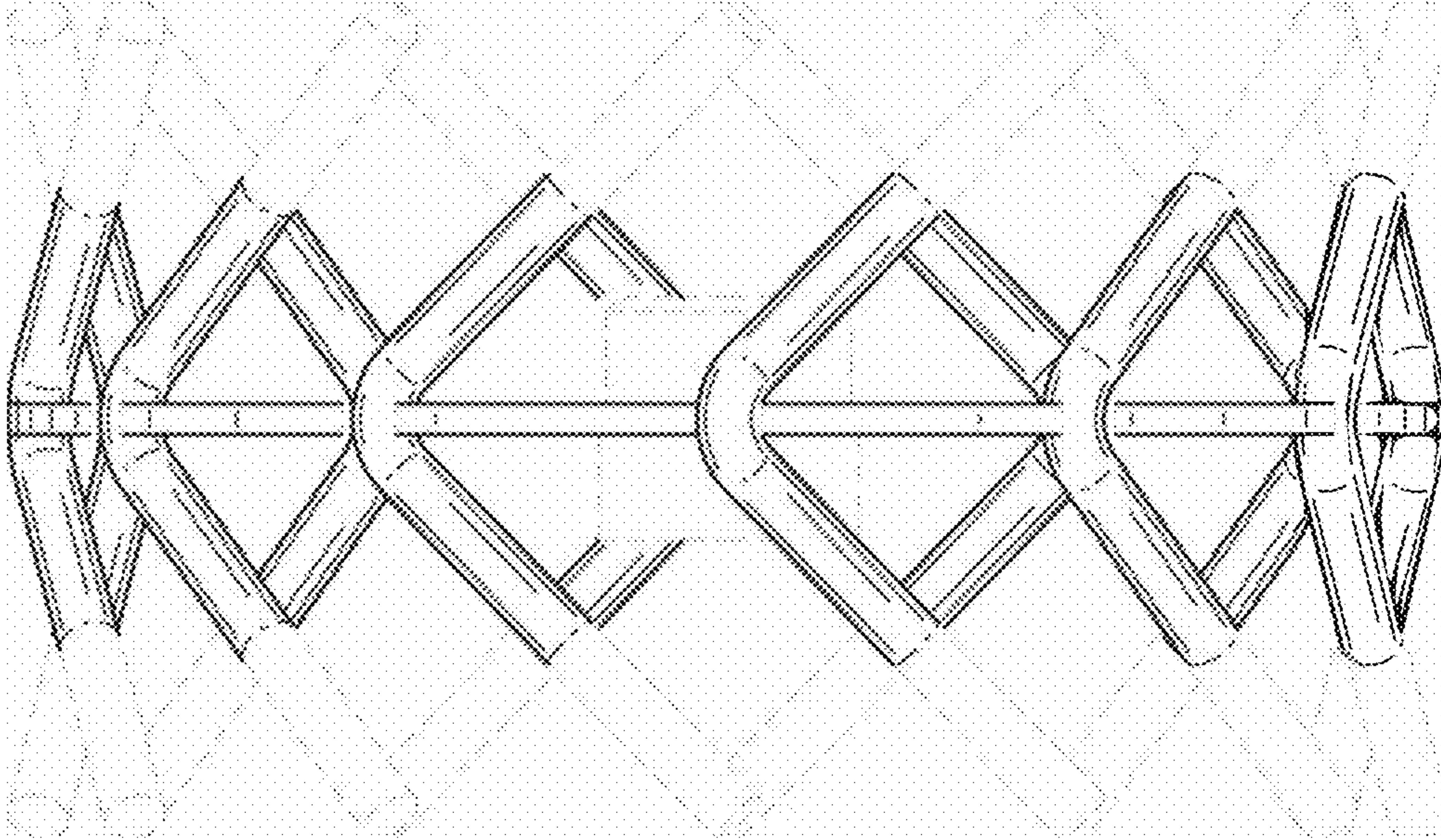

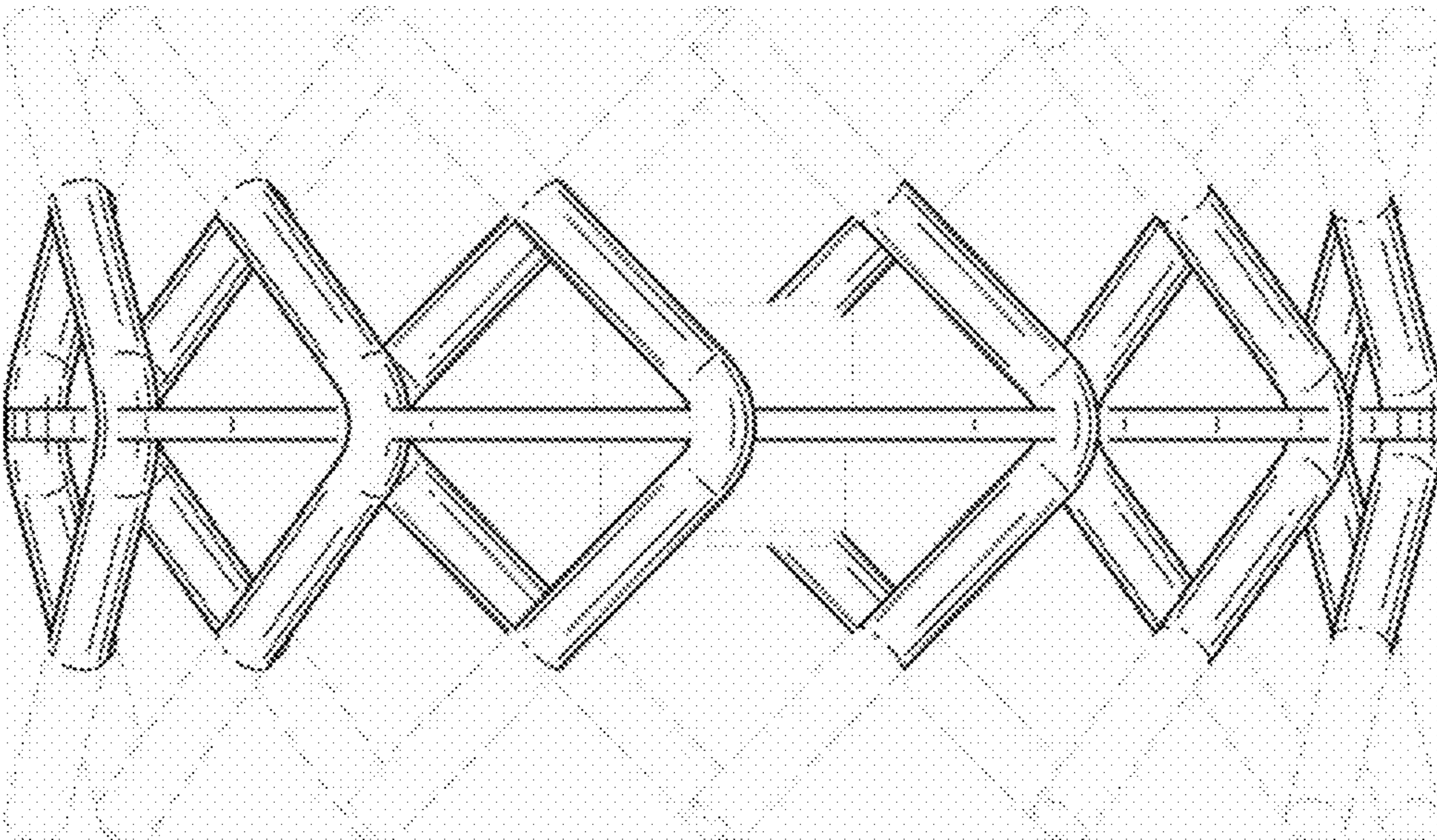
