(57) **CLAIM**

The ornamental design for a robotic end effector, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a robotic end effector;
FIG. 2 is a front elevational view of the robotic end effector of FIG. 1;
FIG. 3 is a rear elevational view of the robotic end effector of FIG. 1;
FIG. 4 is a side elevational view of the robotic end effector of FIG. 1, as seen from what is the left side when viewed from the front;
FIG. 5 is a side elevational view of the robotic end effector of FIG. 1, as seen from what is the right side when viewed from the front;
FIG. 6 is a top plan view of the robotic end effector of FIG. 1; and,
FIG. 7 is a bottom plan view of the robotic end effector of FIG. 1.

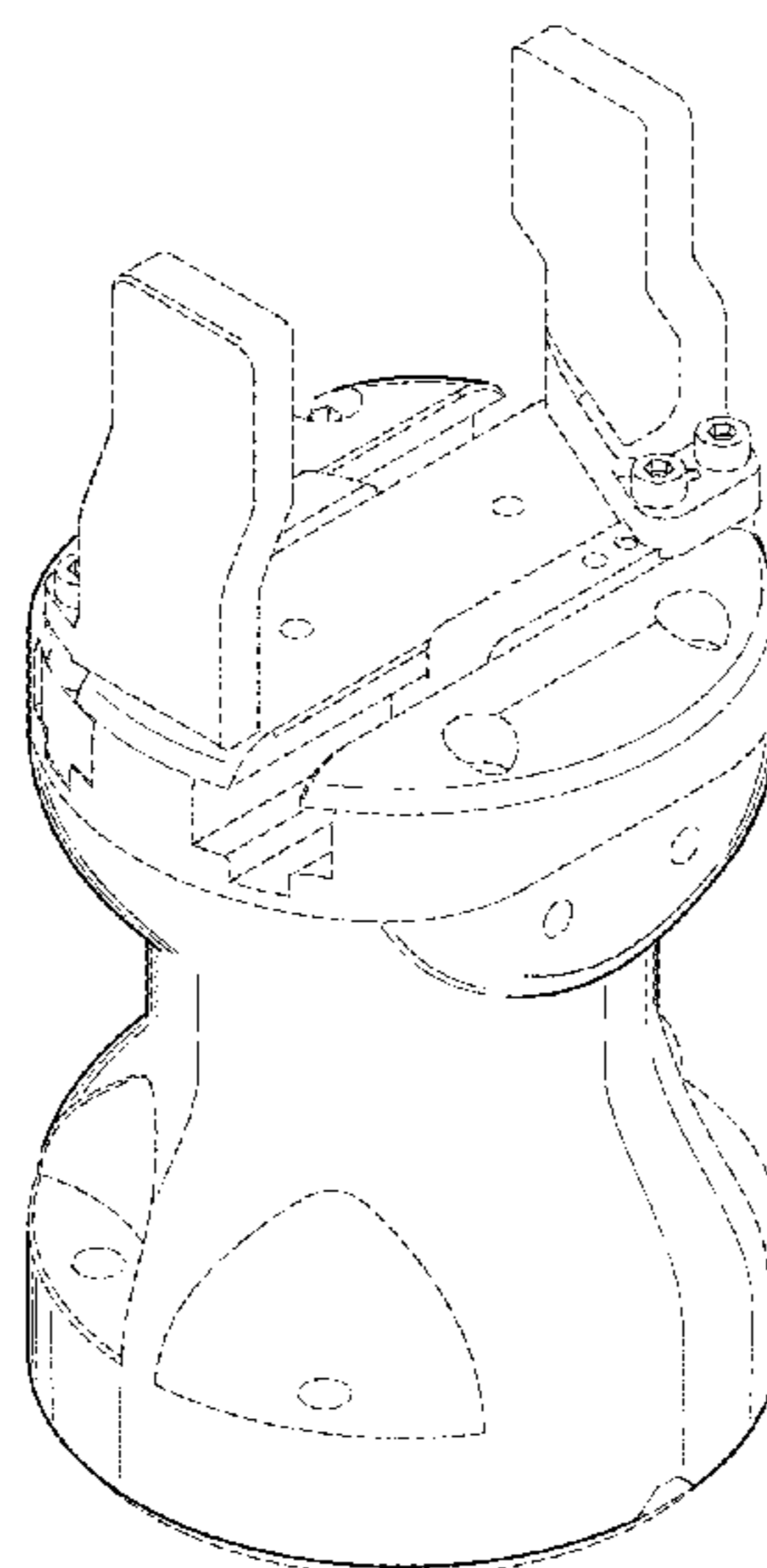

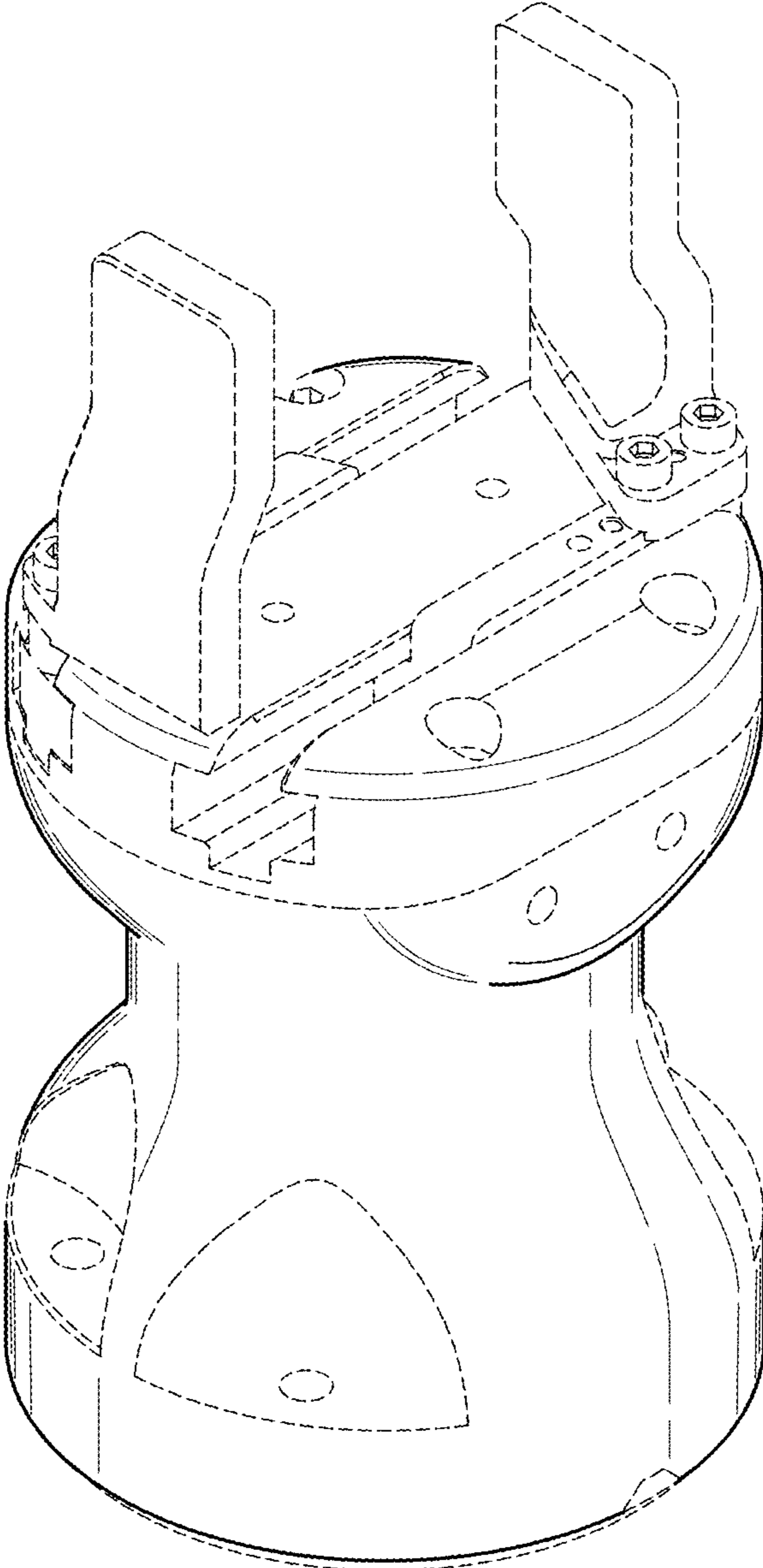

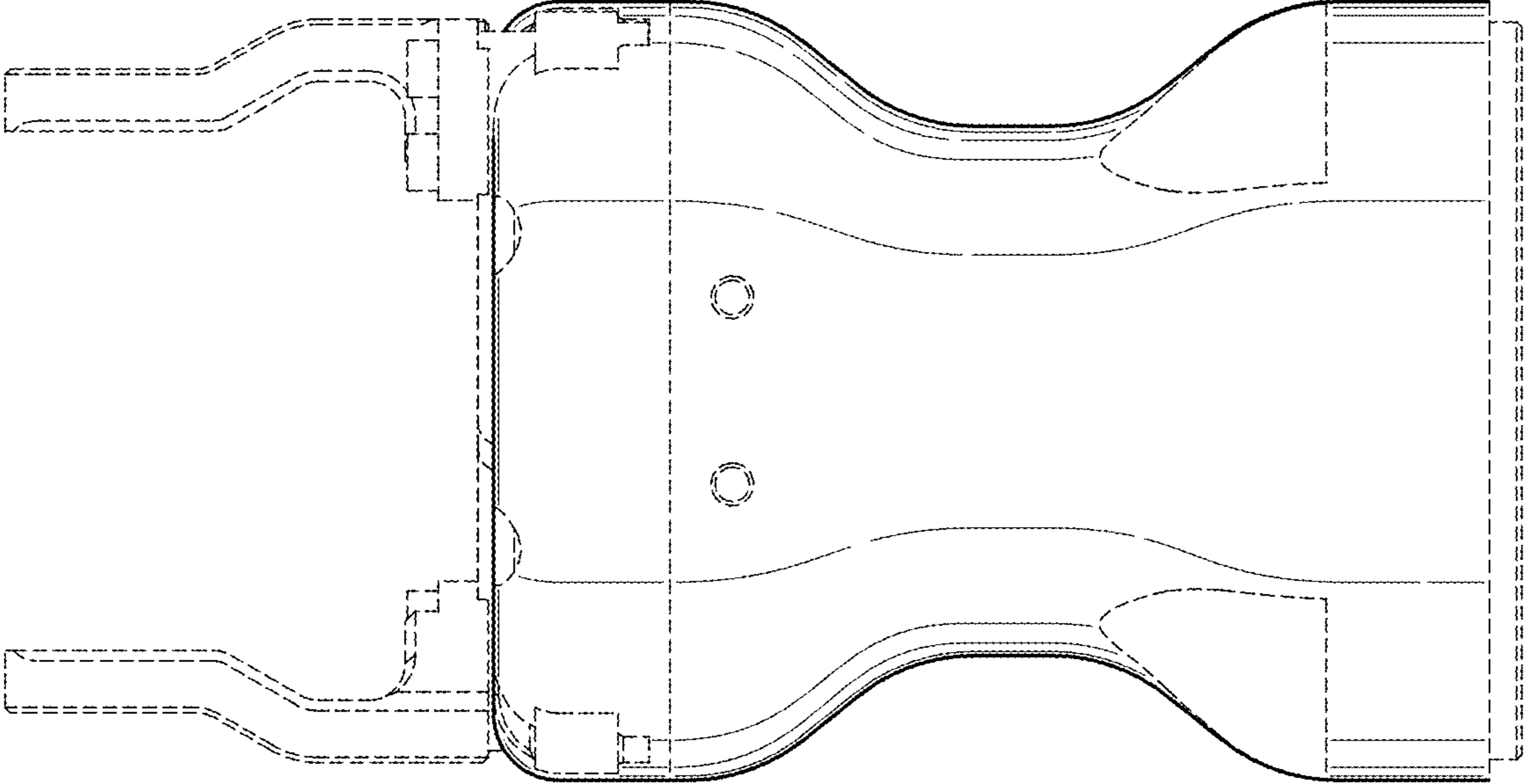

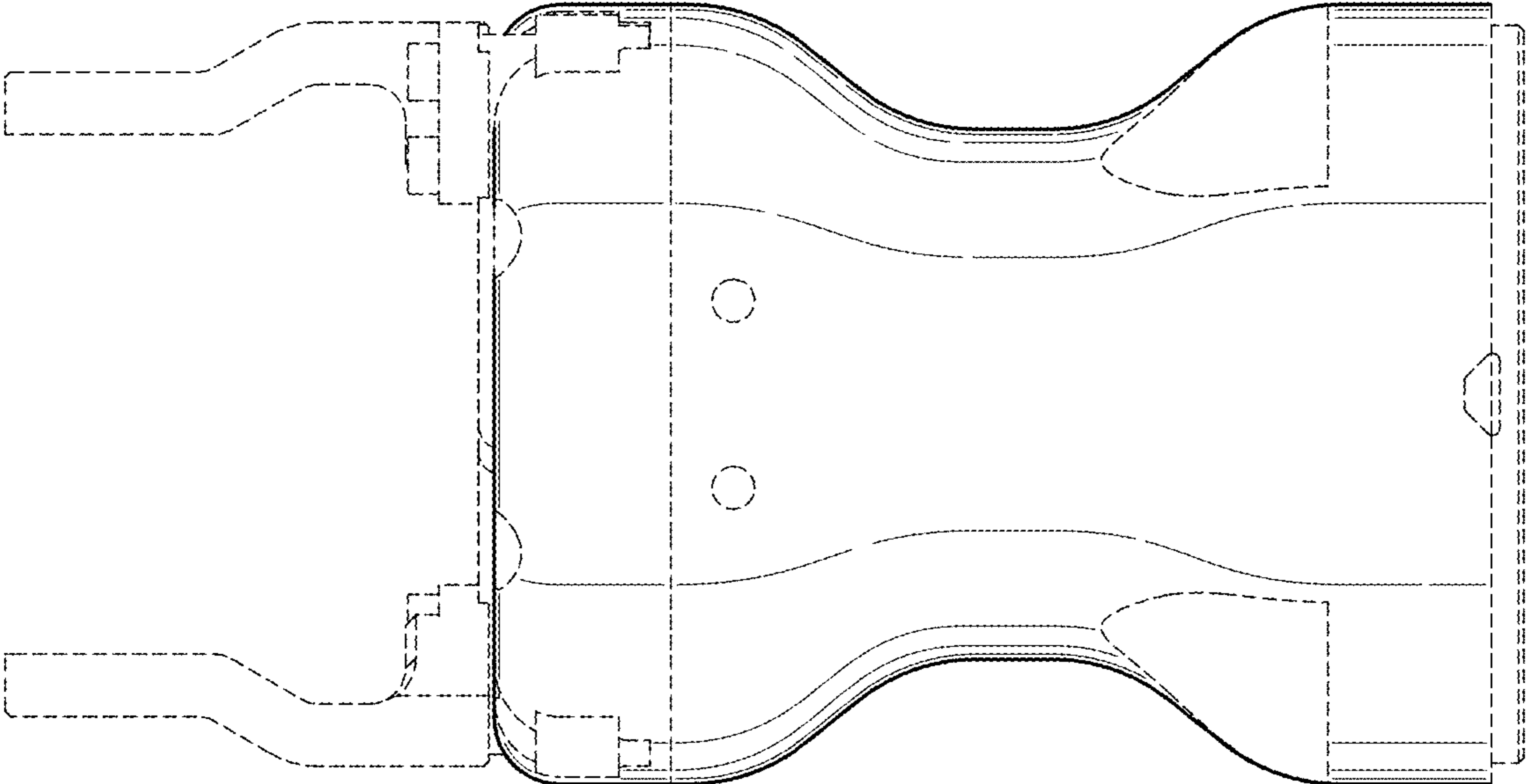

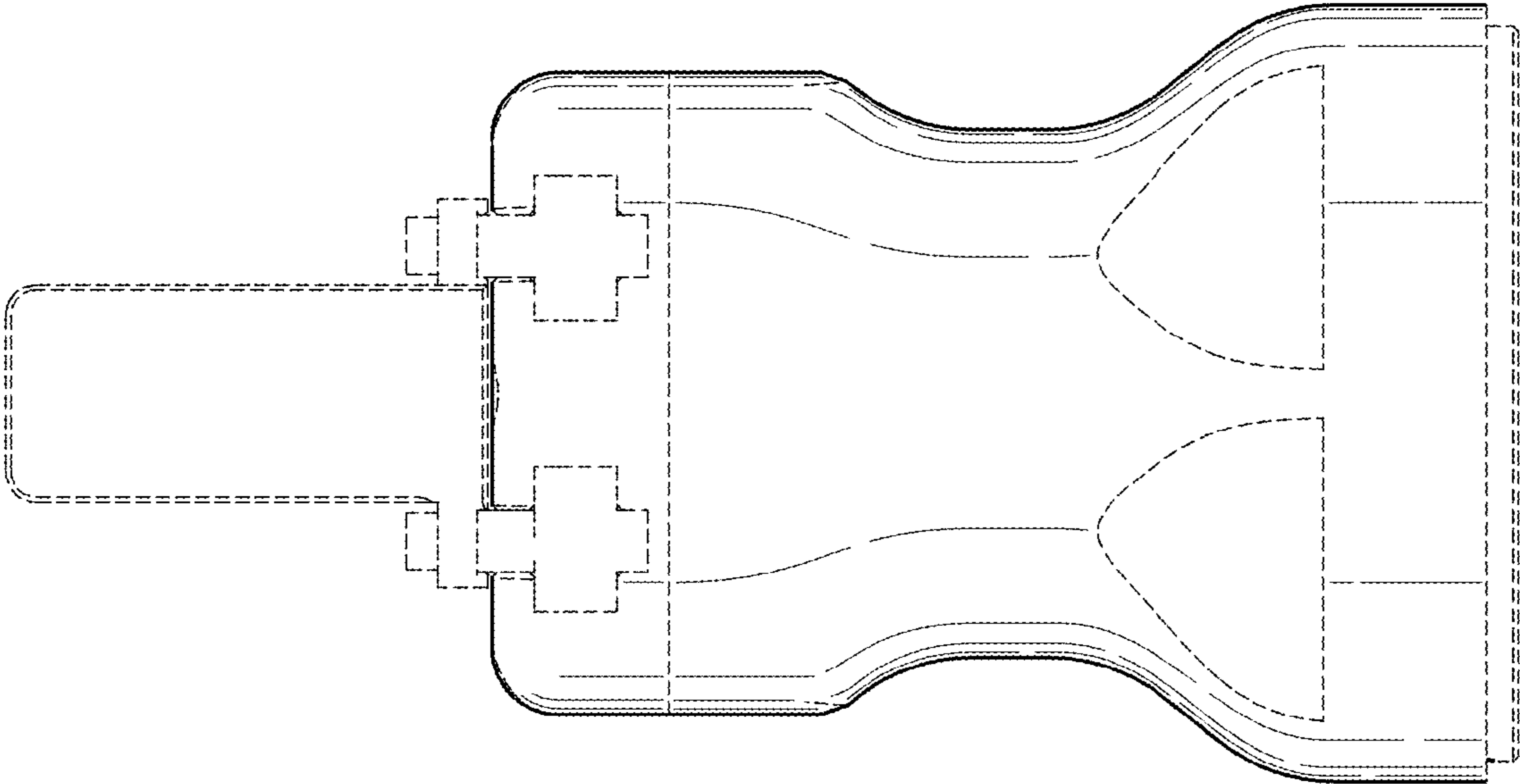

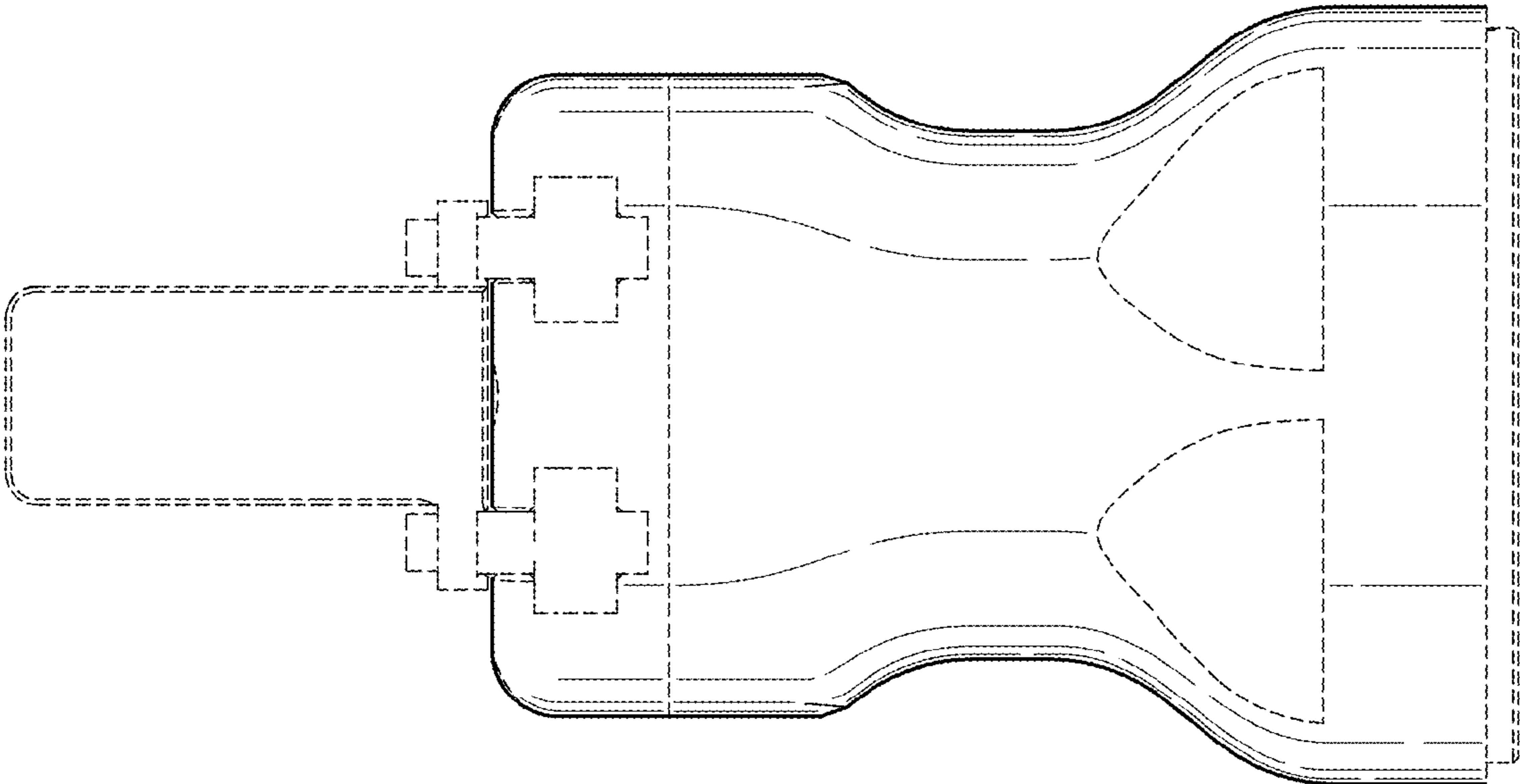

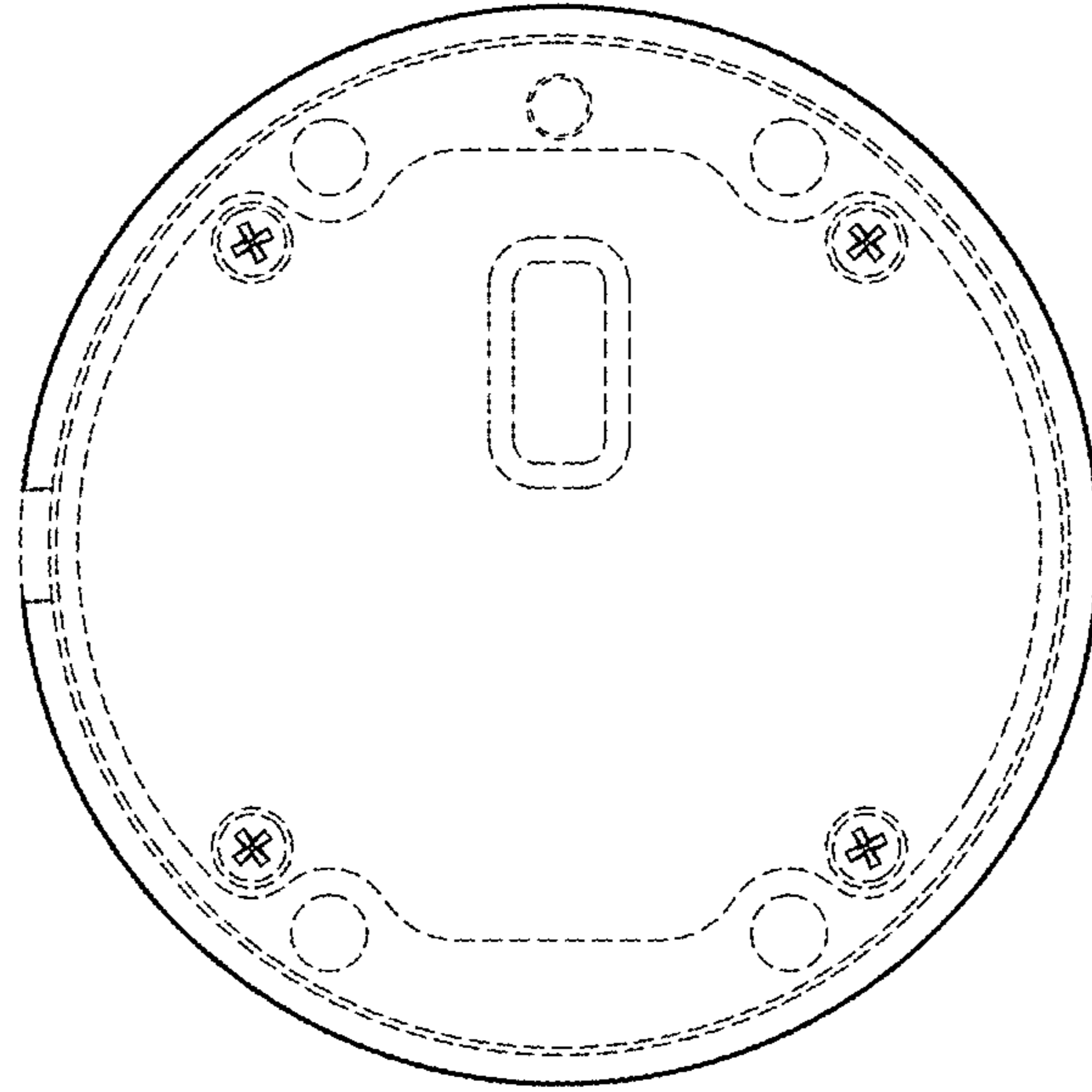

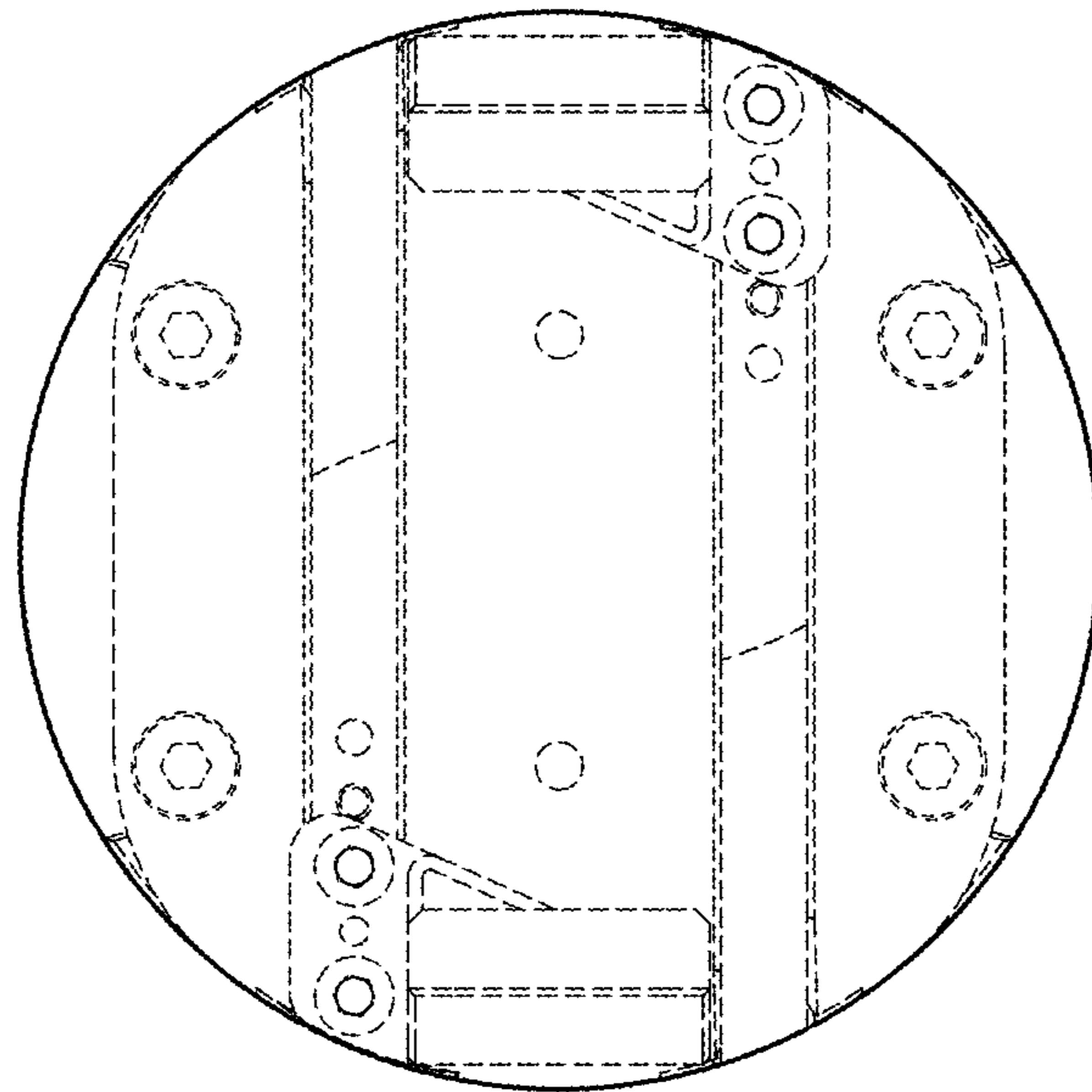
