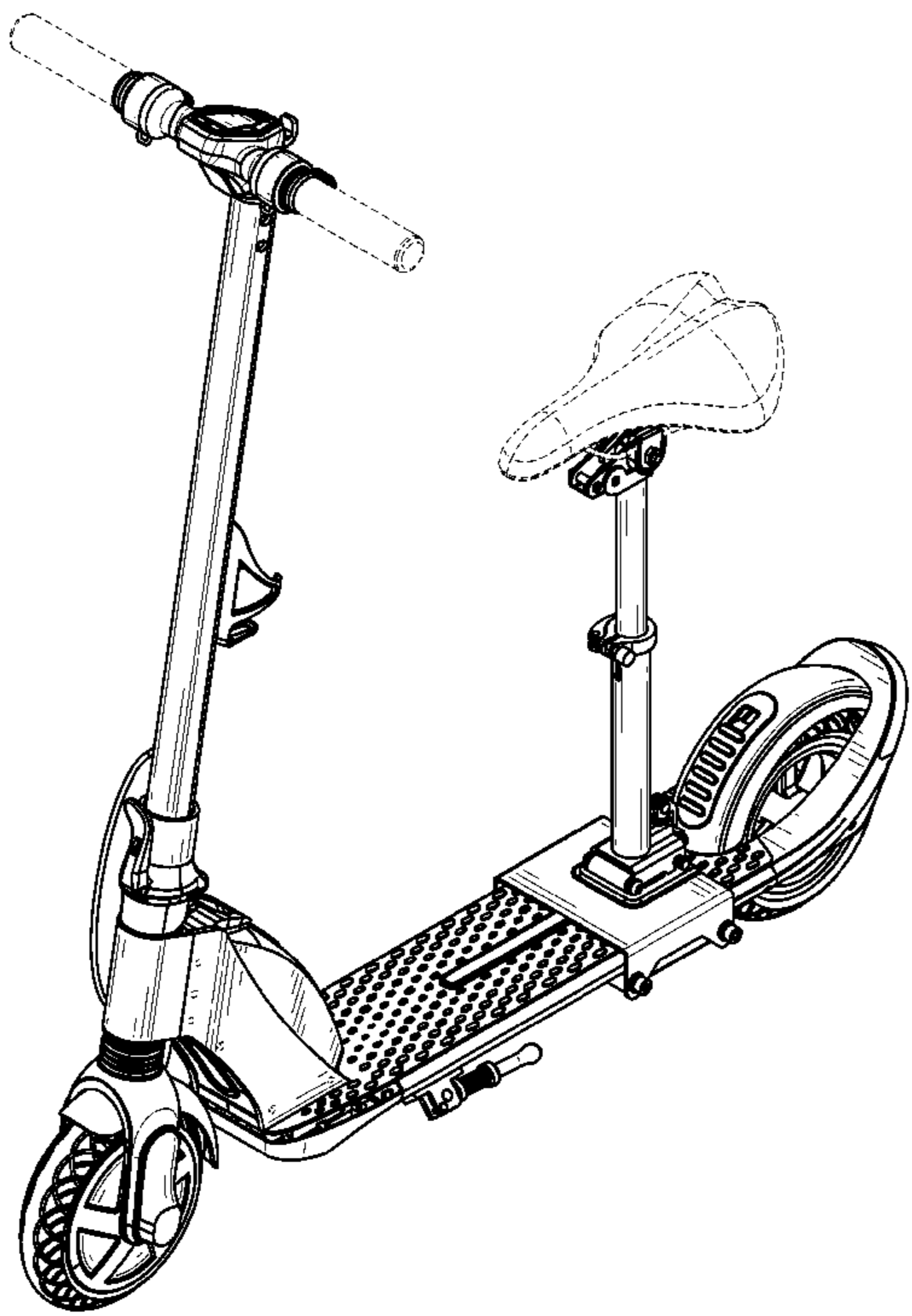

(57) **CLAIM**
The ornamental design for an electric scooter, as shown and described.

DESCRIPTION
FIG. 1 is a front and top perspective view of an electric scooter, showing my new design;
FIG. 2 is a rear and bottom perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof;
FIG. 9 is a partial enlarged view of the handlebar in FIG. 1;
FIG. 10 is a partial enlarged view of the kickstand area in FIG. 2; and,
FIG. 11 is a partial enlarged view of the front suspension area in FIG. 5.
The dash-dot broken lines represent the boundaries of the enlarged partial views of FIGS. 9-11 and form no part of the claimed design.

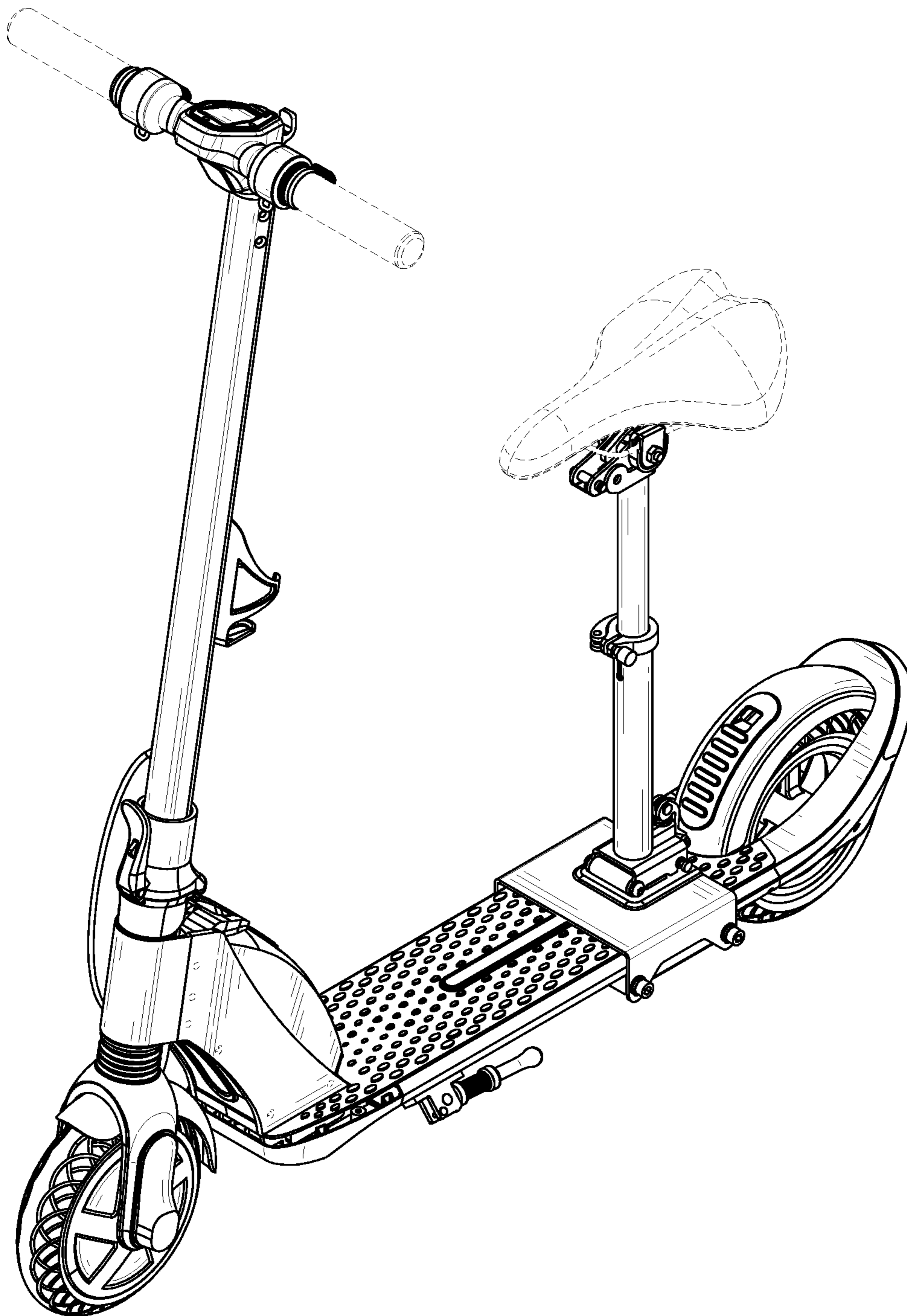

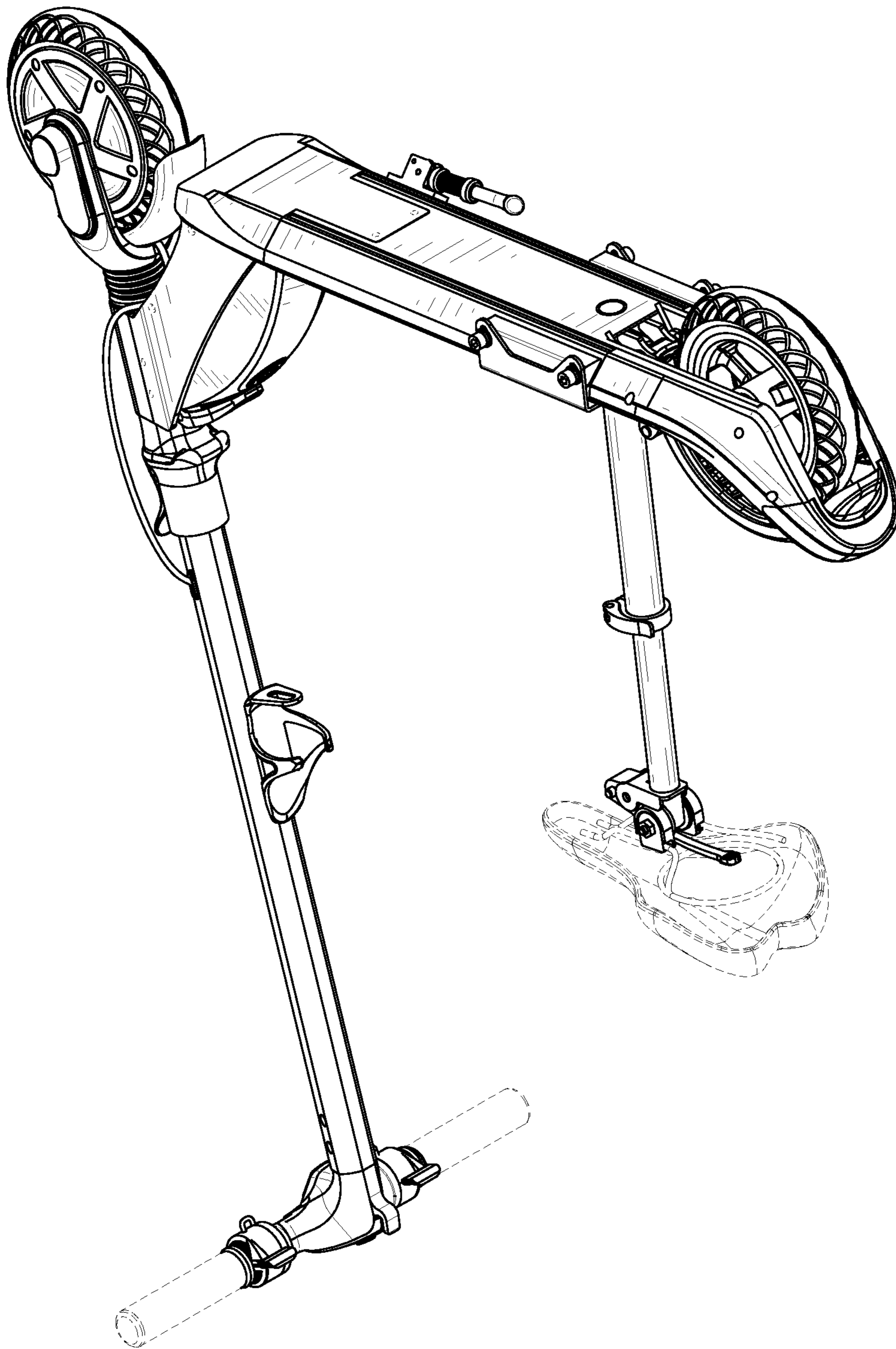

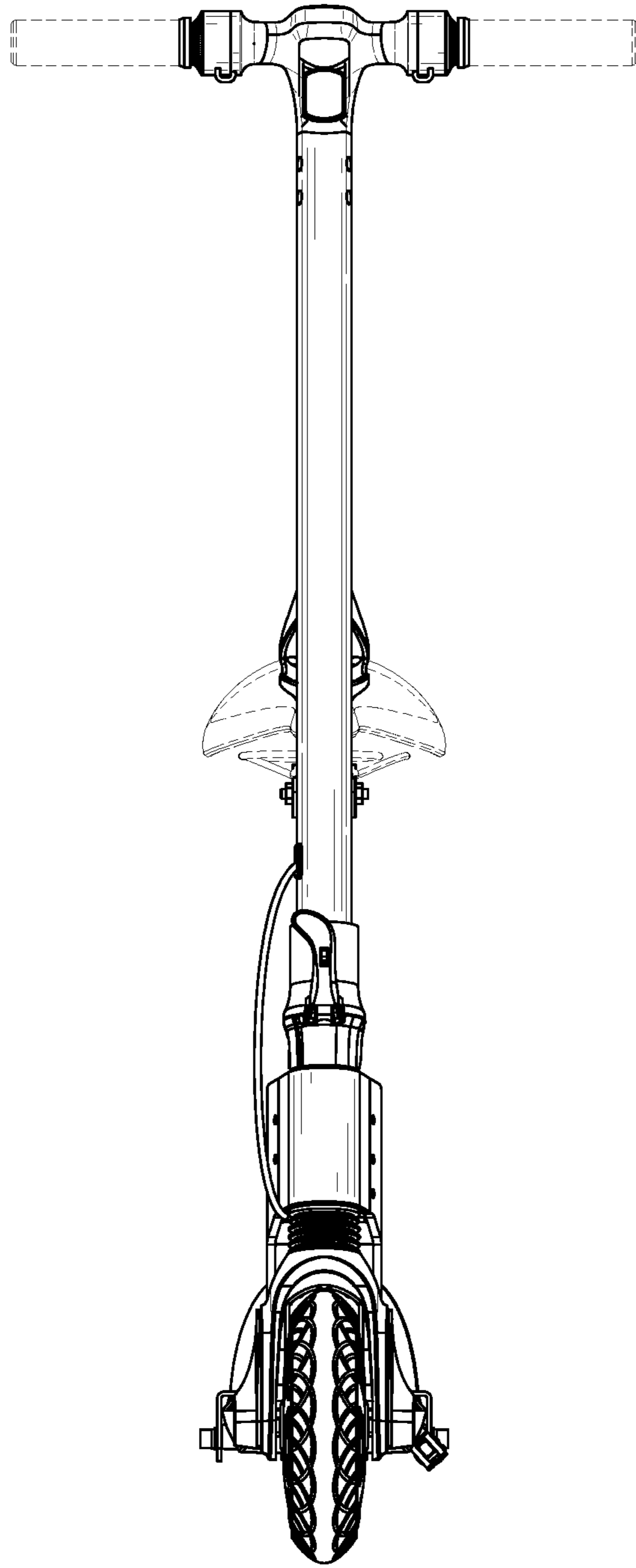

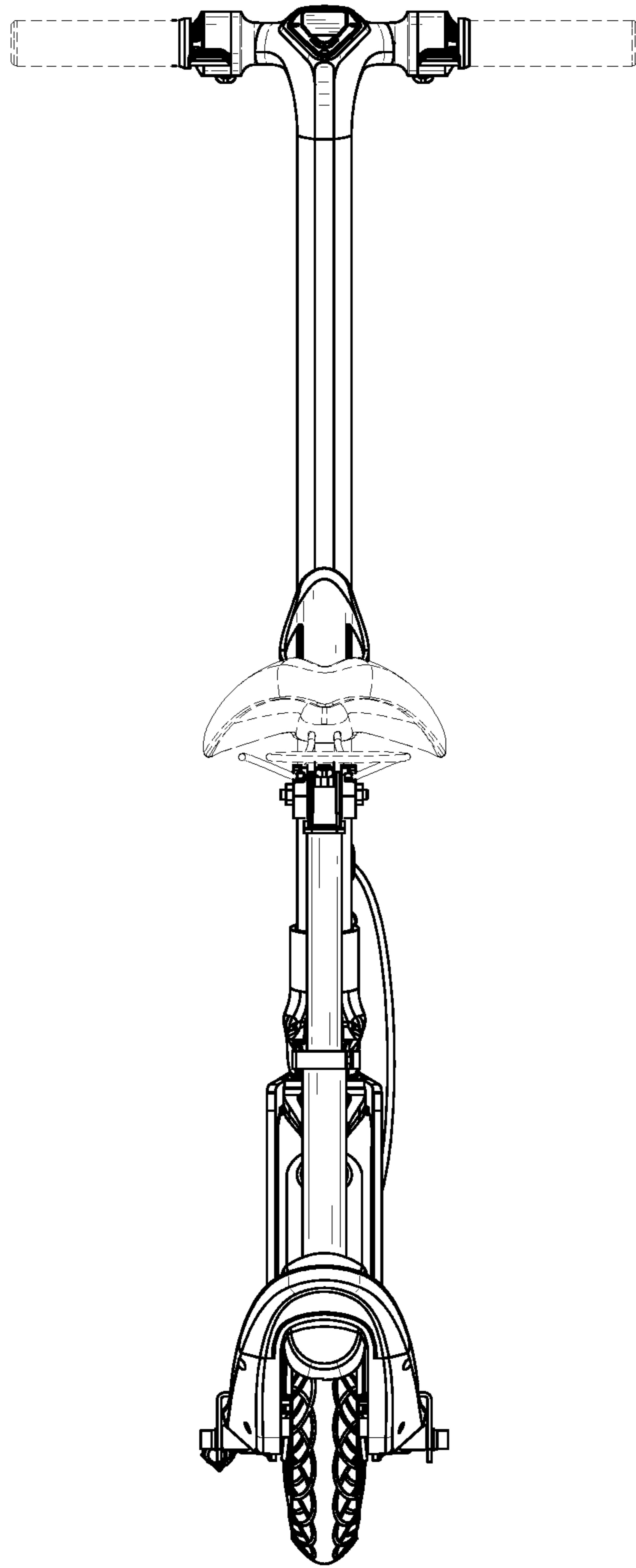

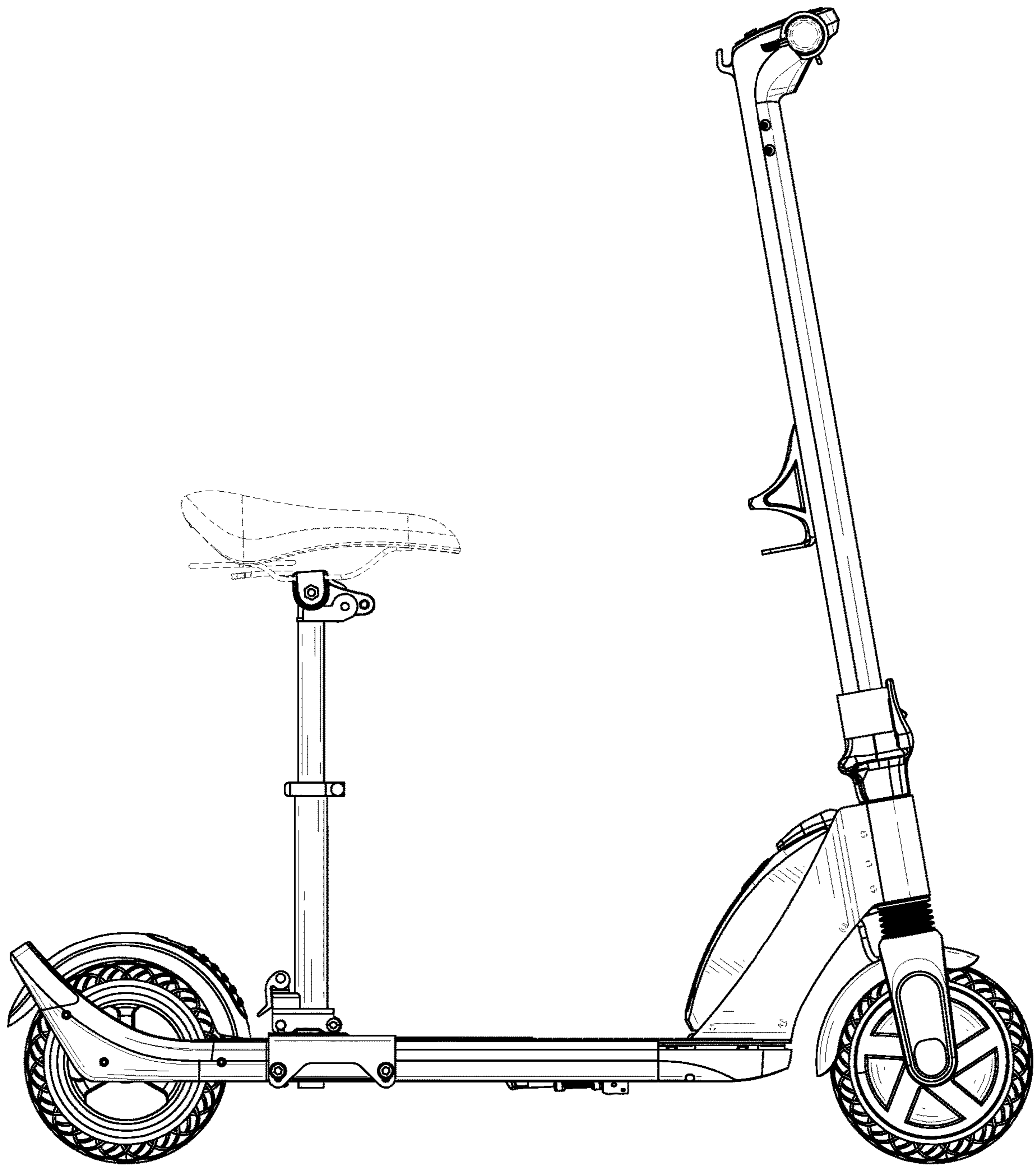

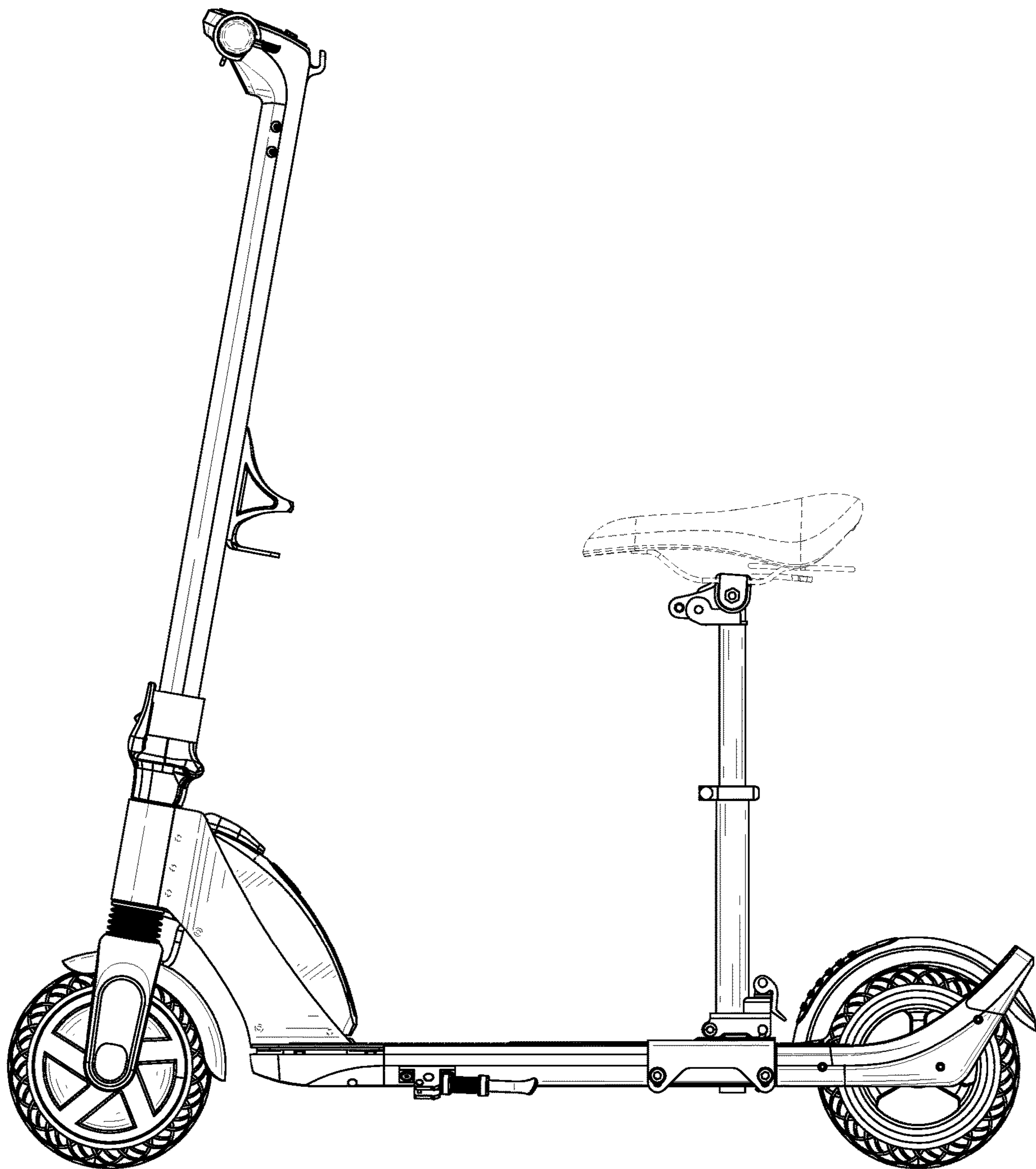

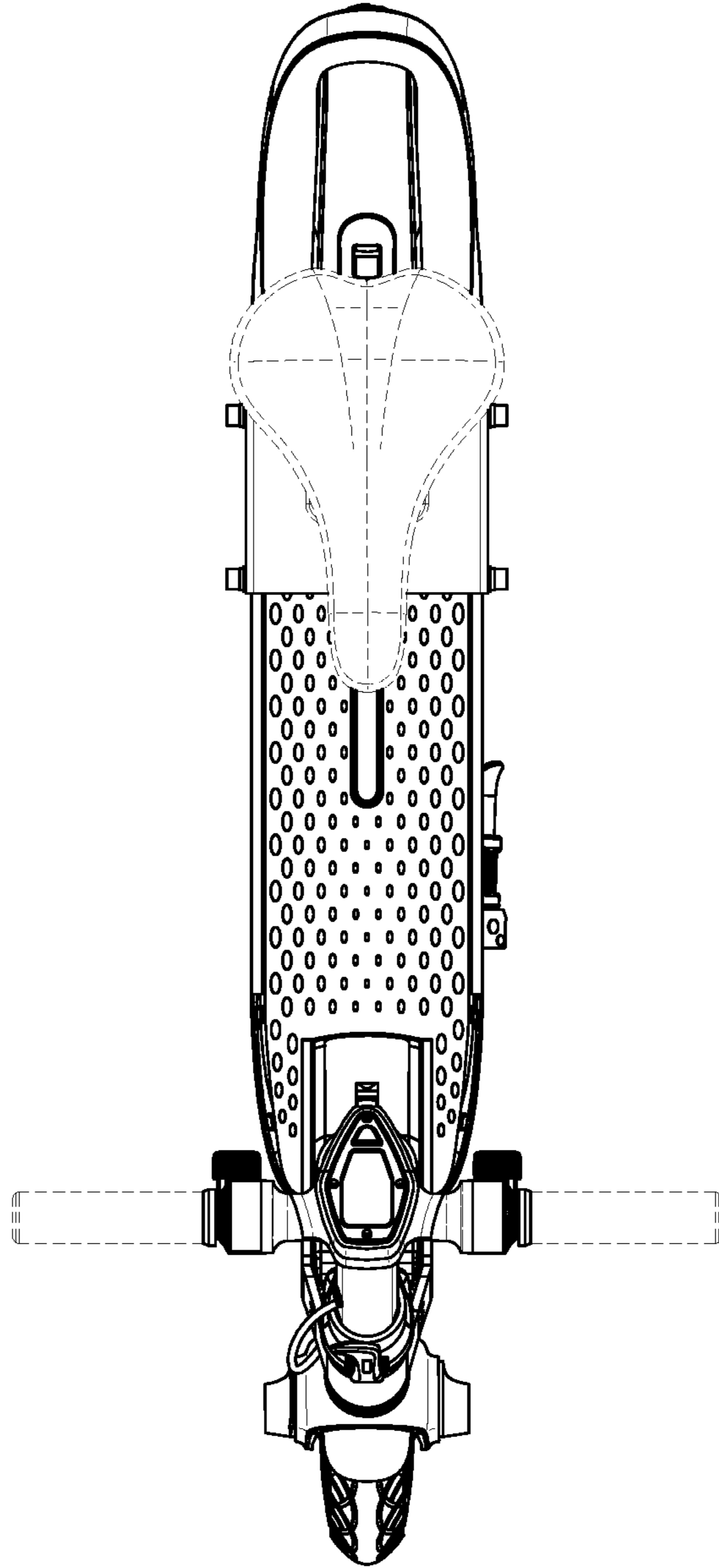

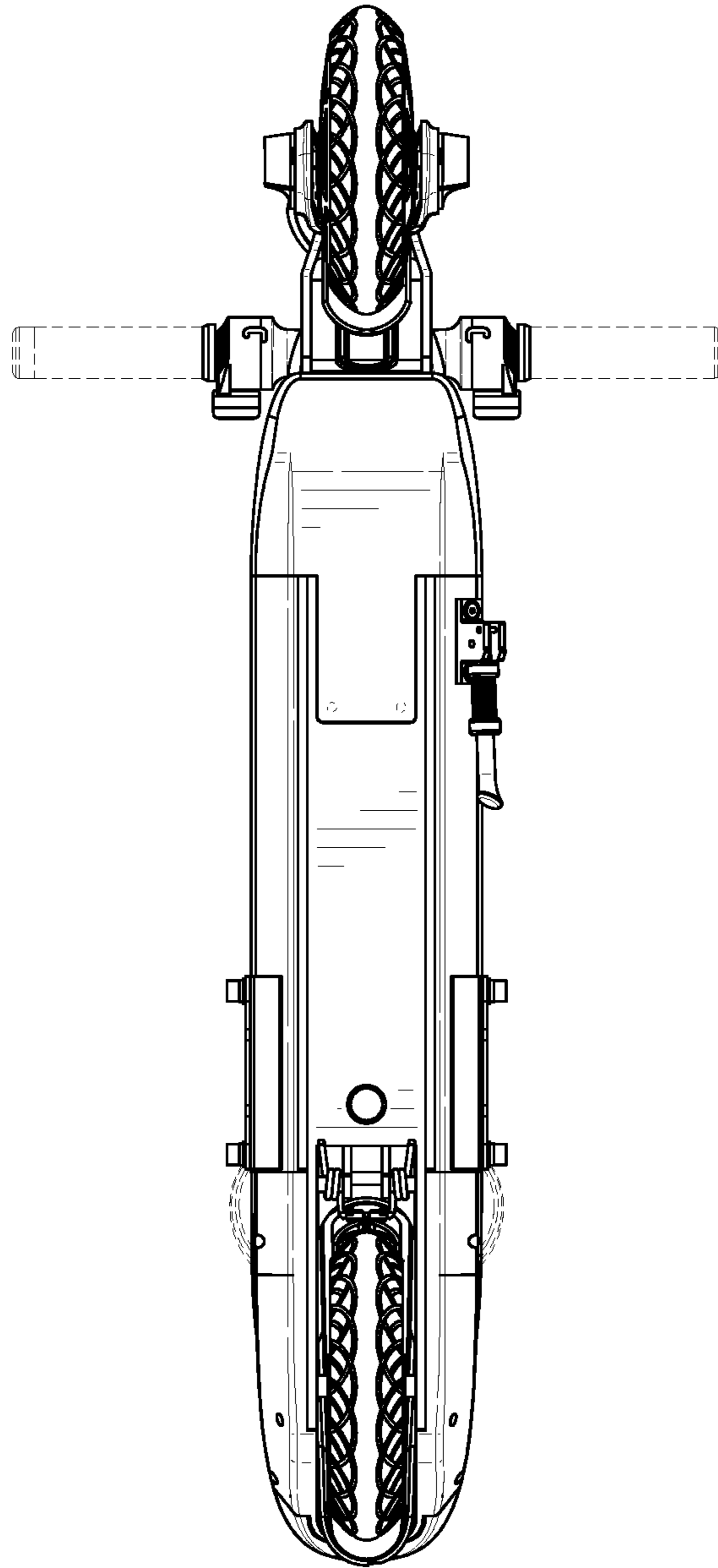

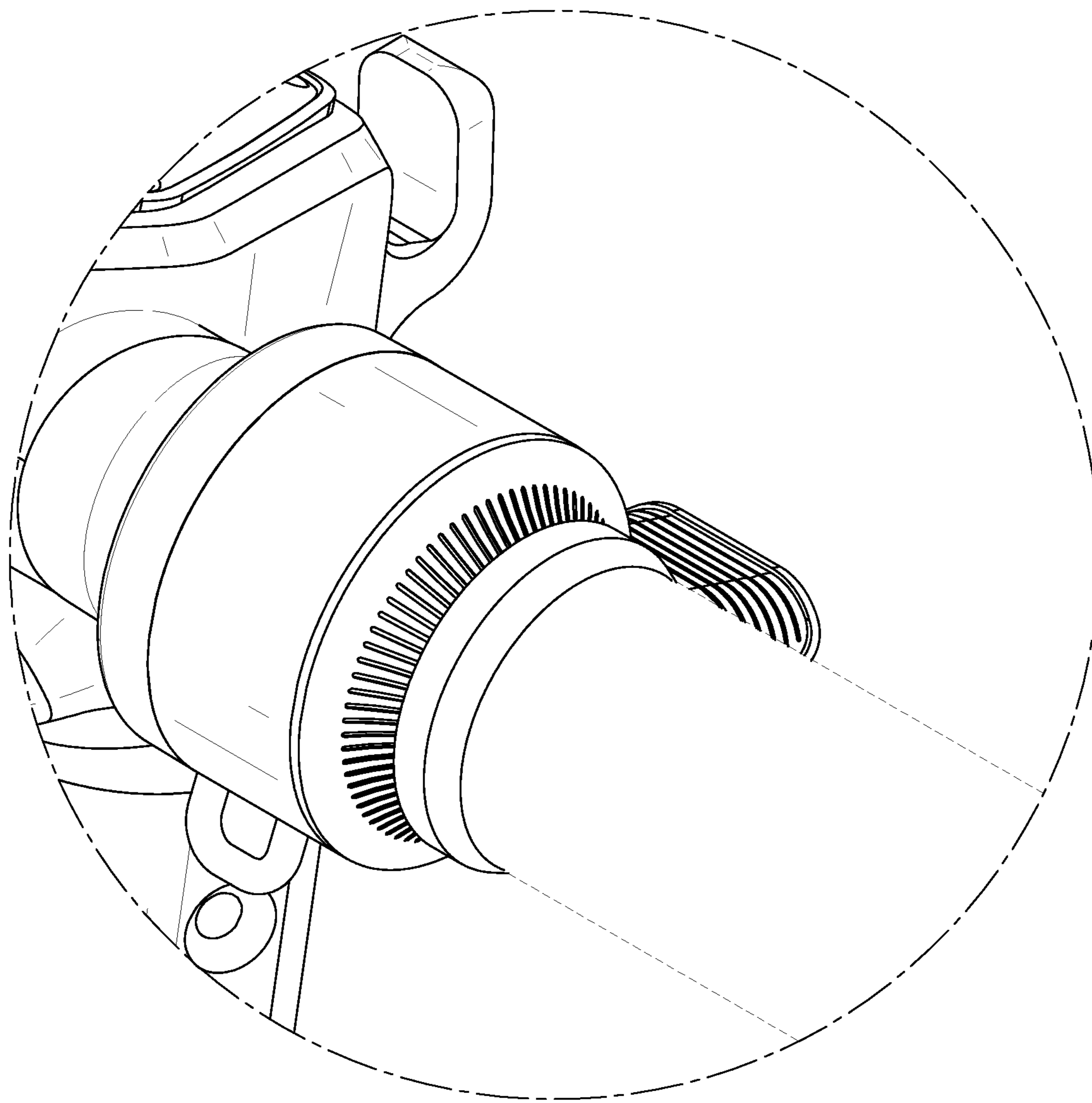

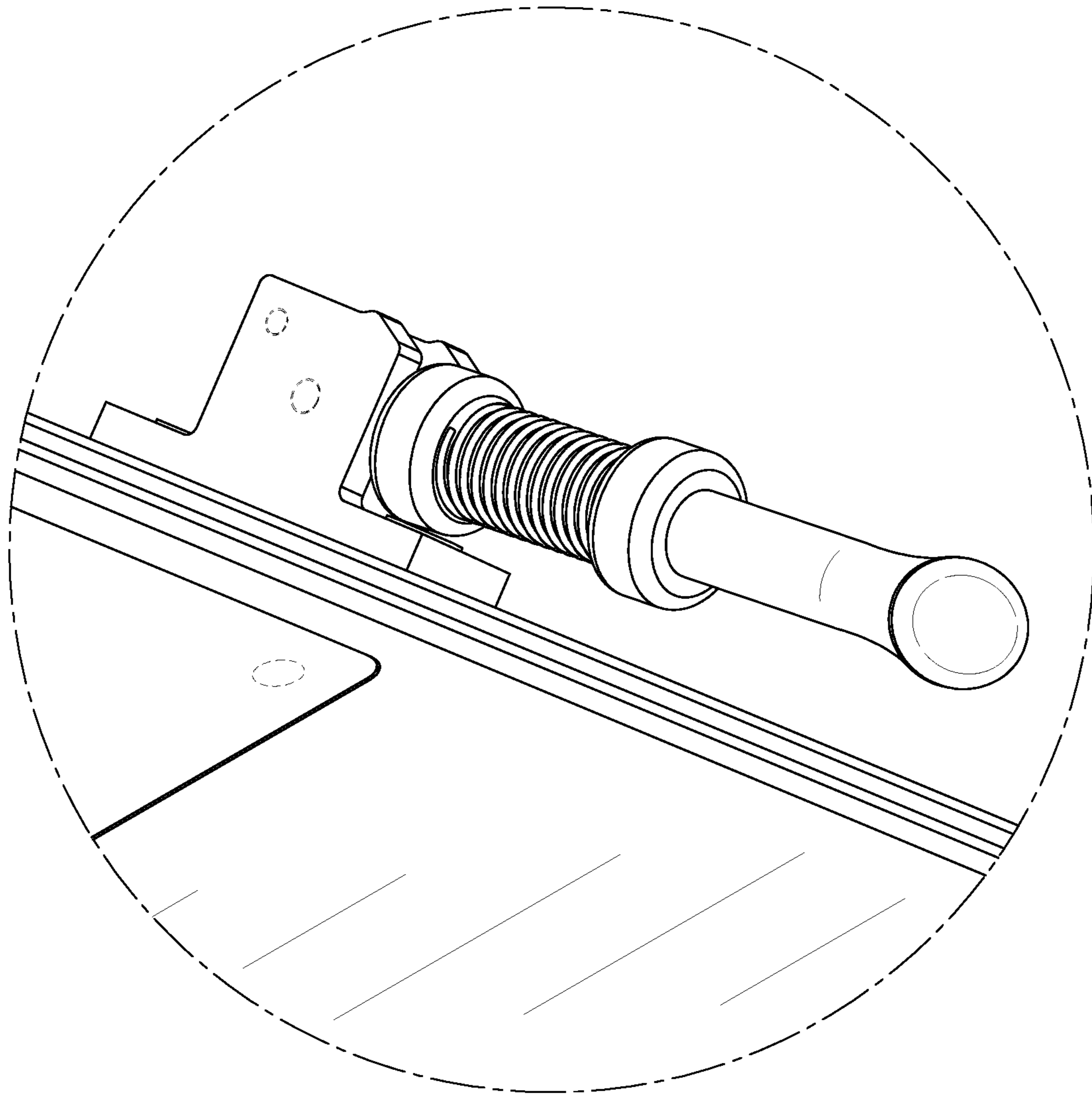

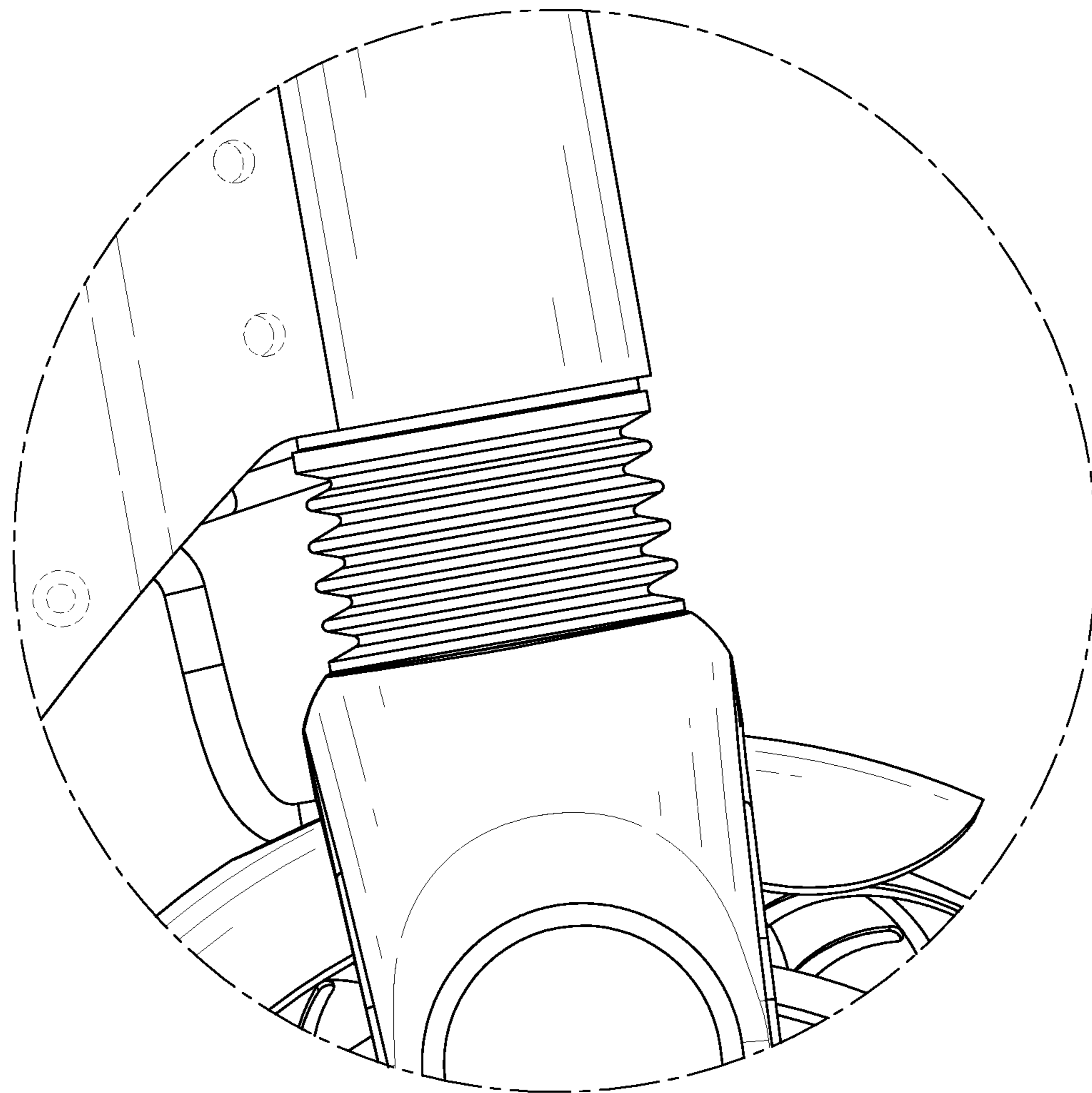
