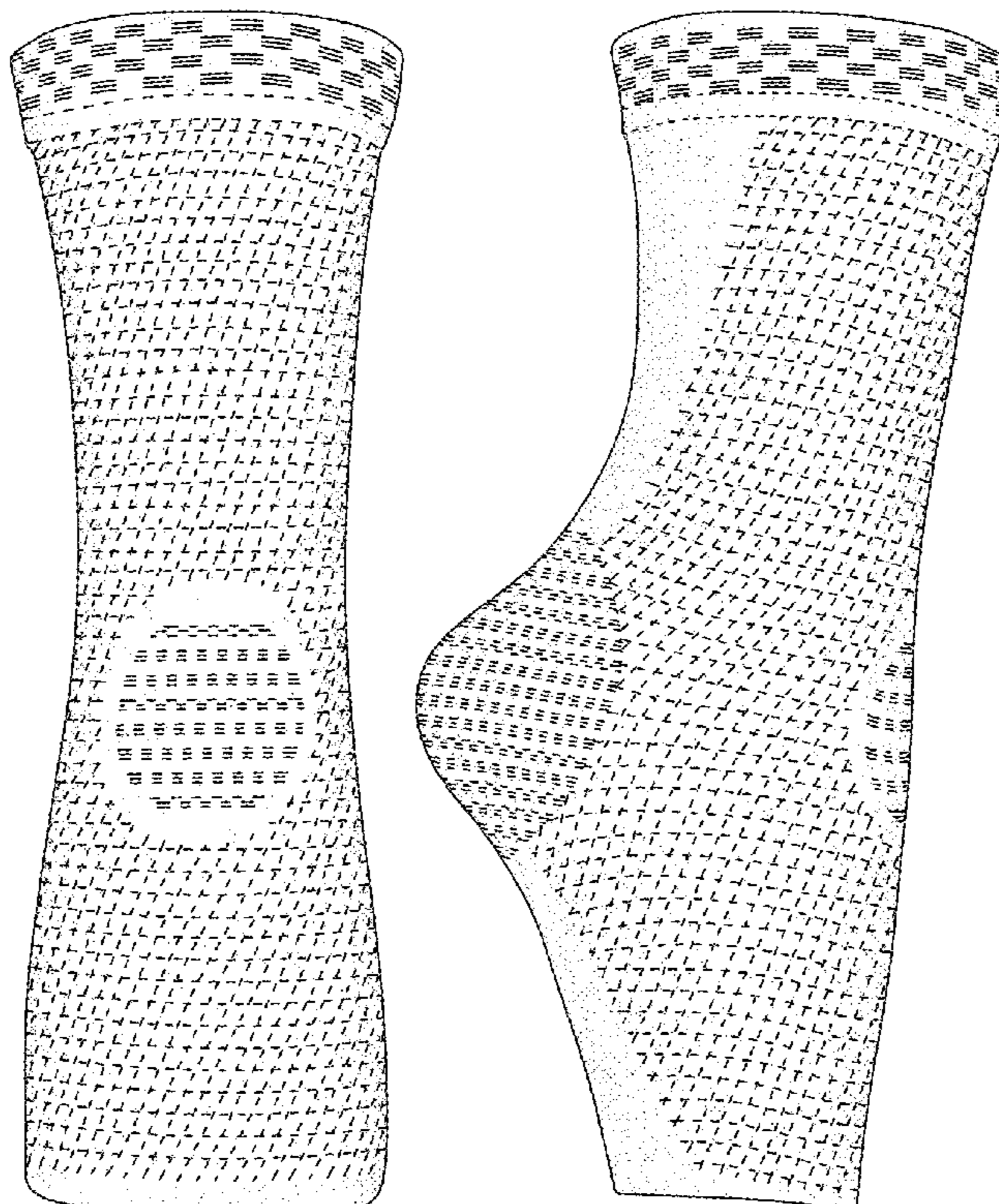
(57) **CLAIM**

The ornamental design for an ankle support, as shown and
described.

DESCRIPTION

FIG. 1 is a front view of an ankle support according to one
embodiment of the claimed design;
FIG. 2 is a first side view thereof;
FIG. 3 is a second side view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a first side in a position of use view thereof;

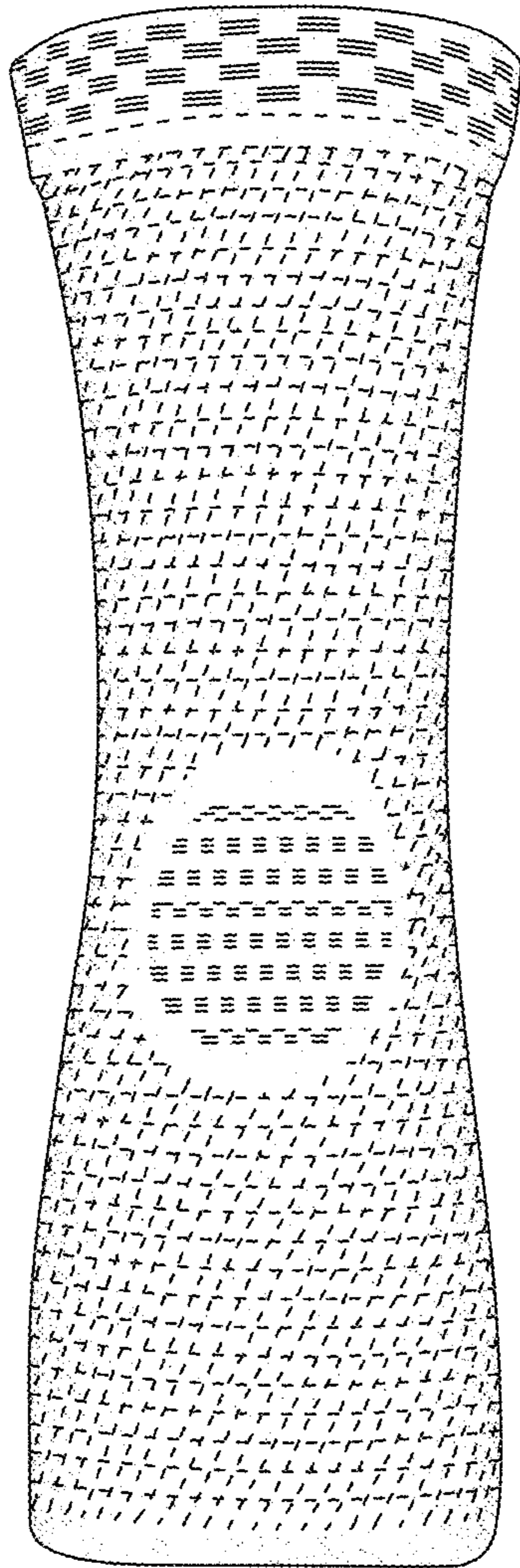

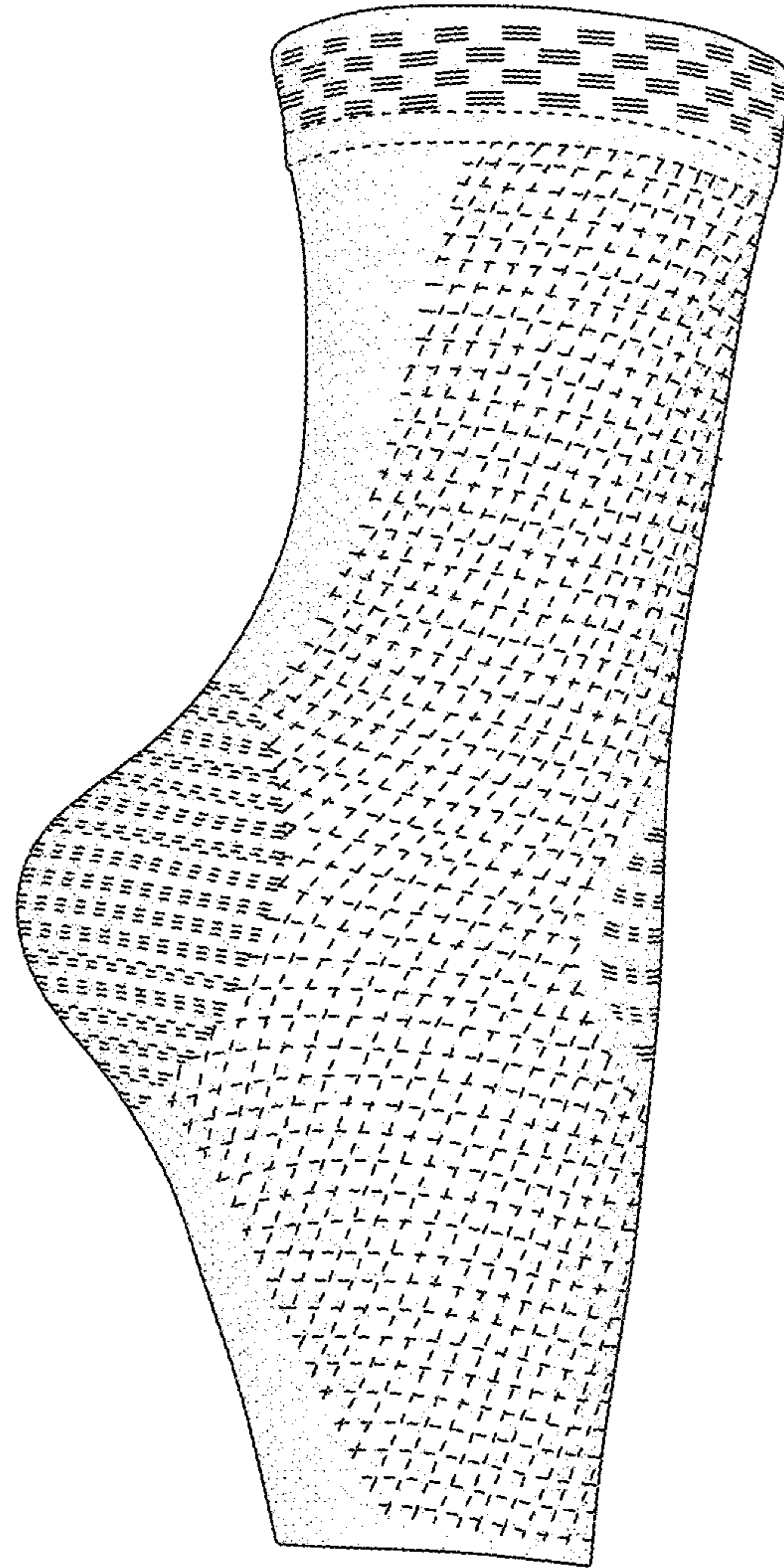

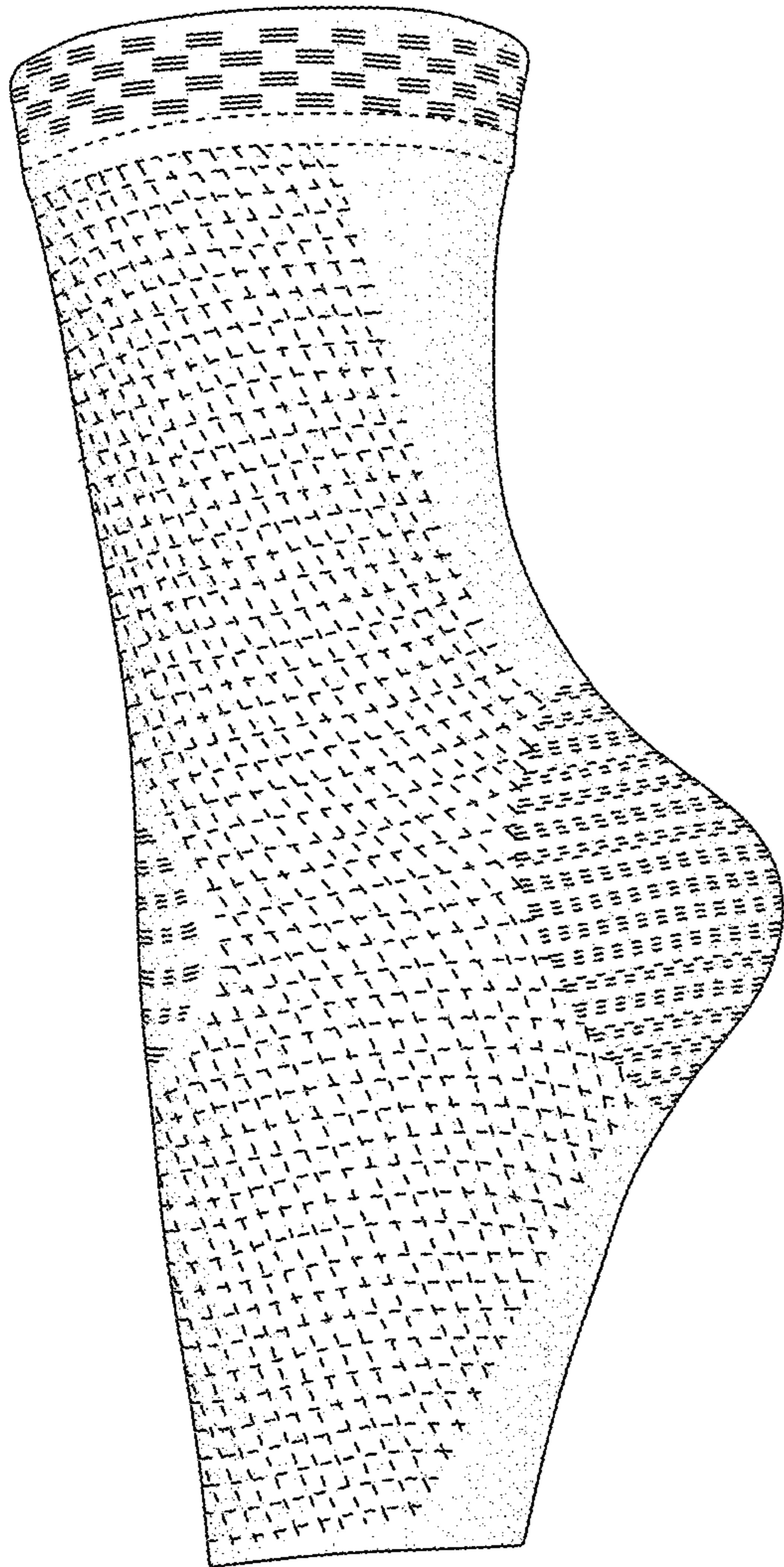

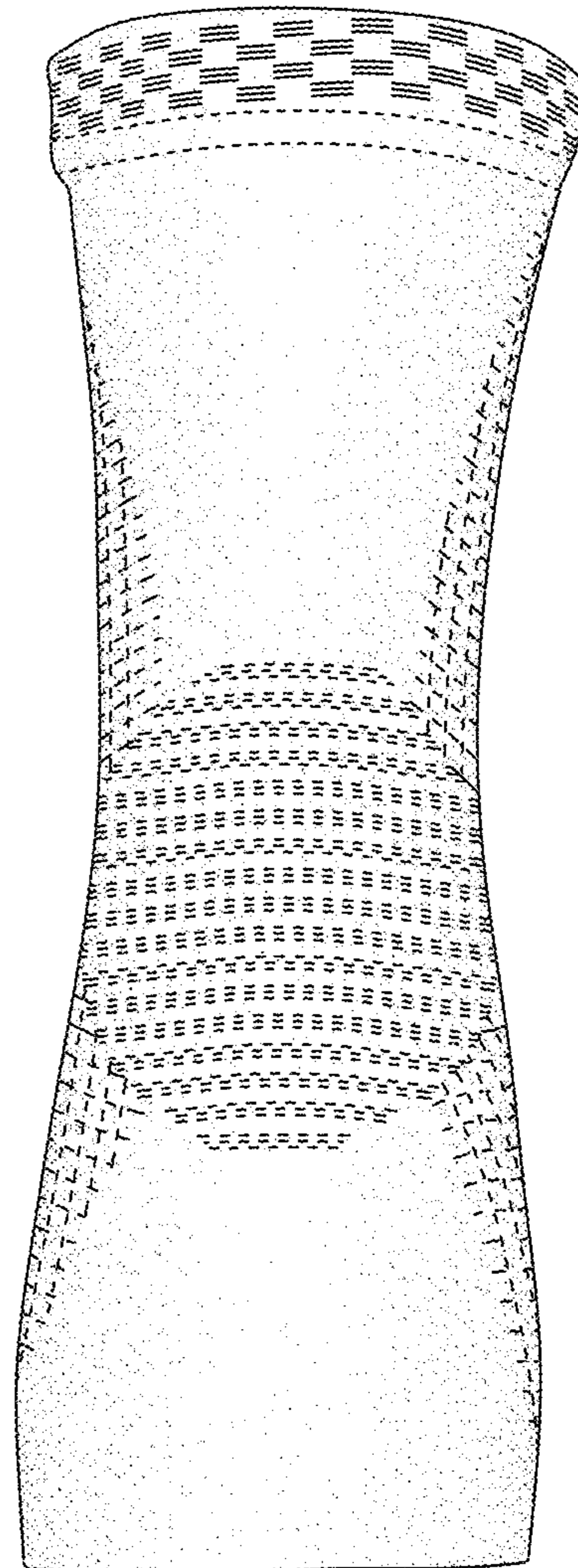

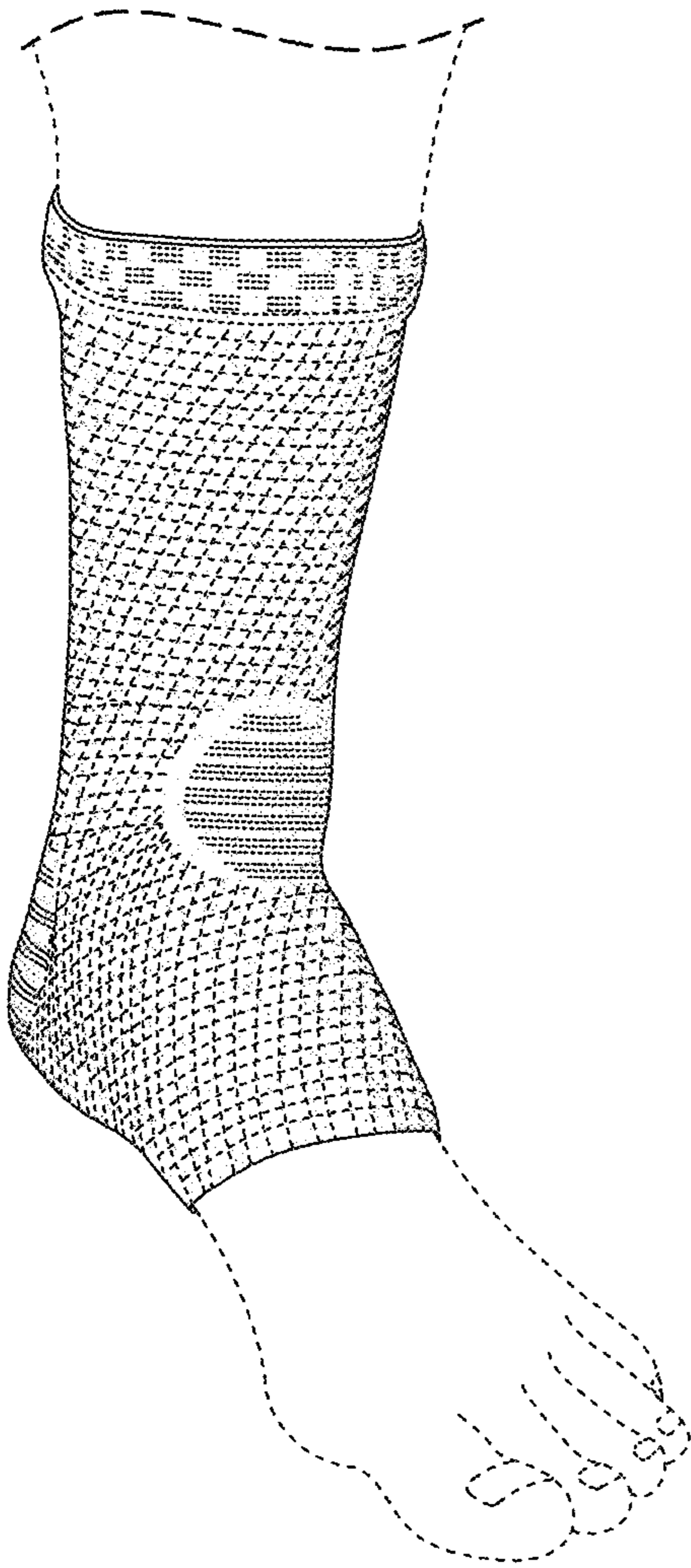

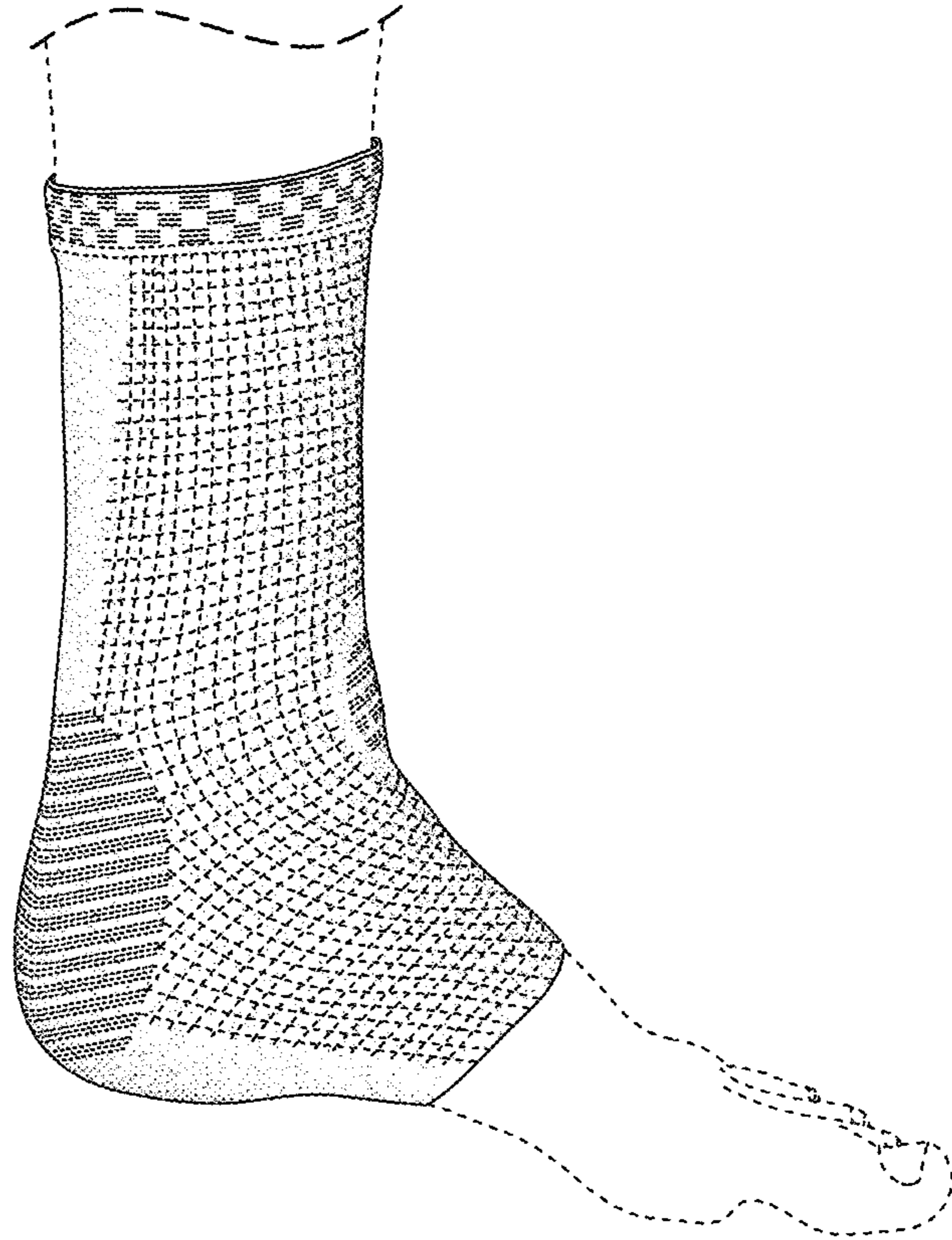

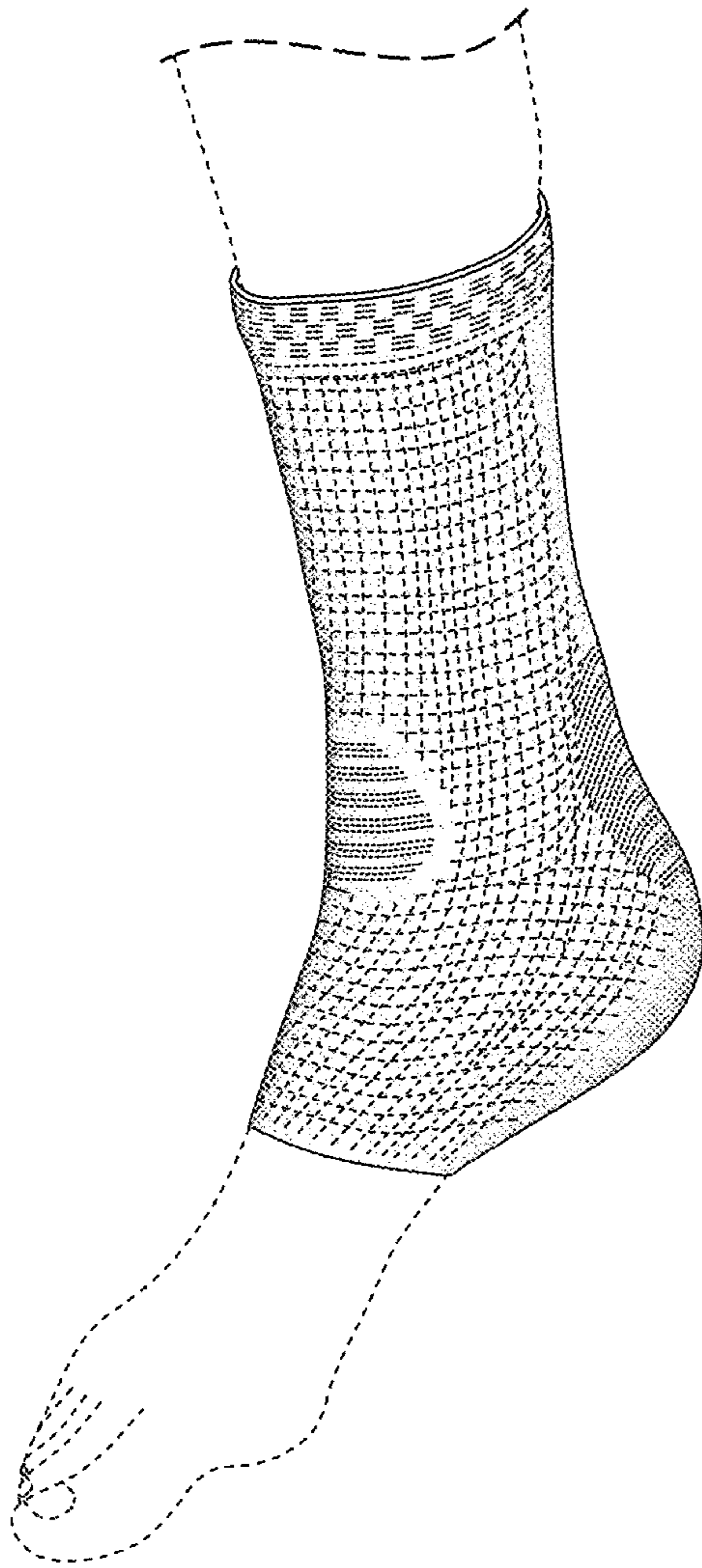

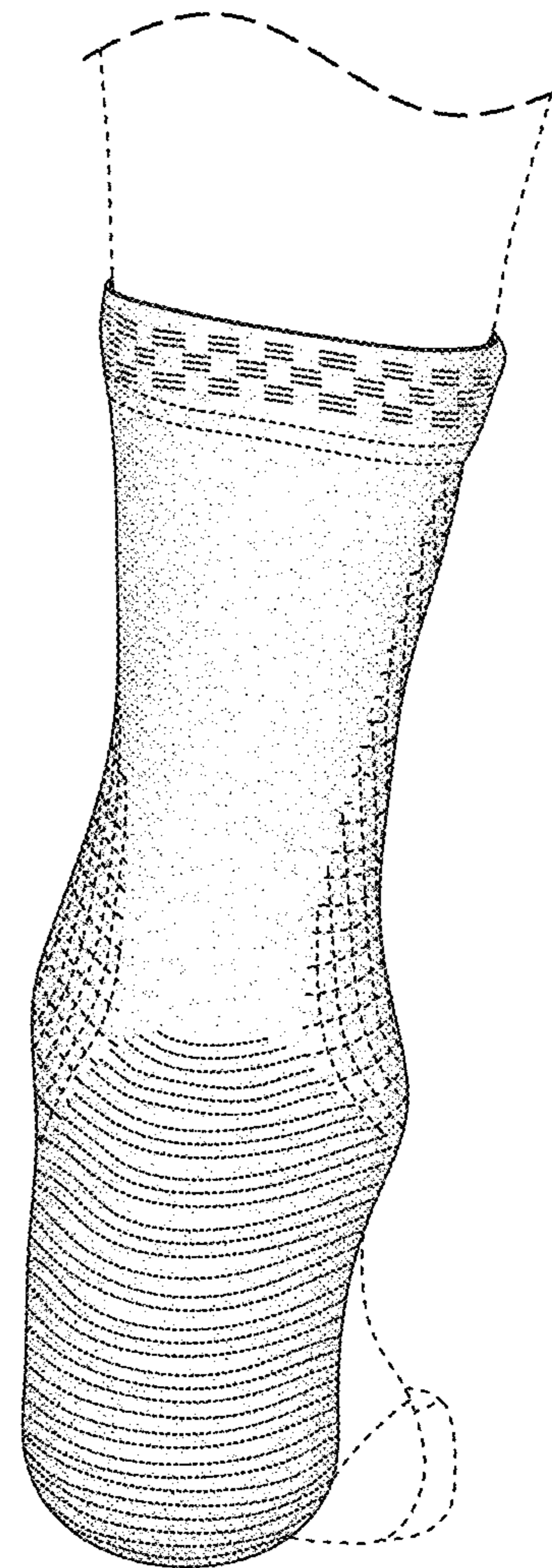
