The ornamental design for bi-fold door facing, as shown and described.

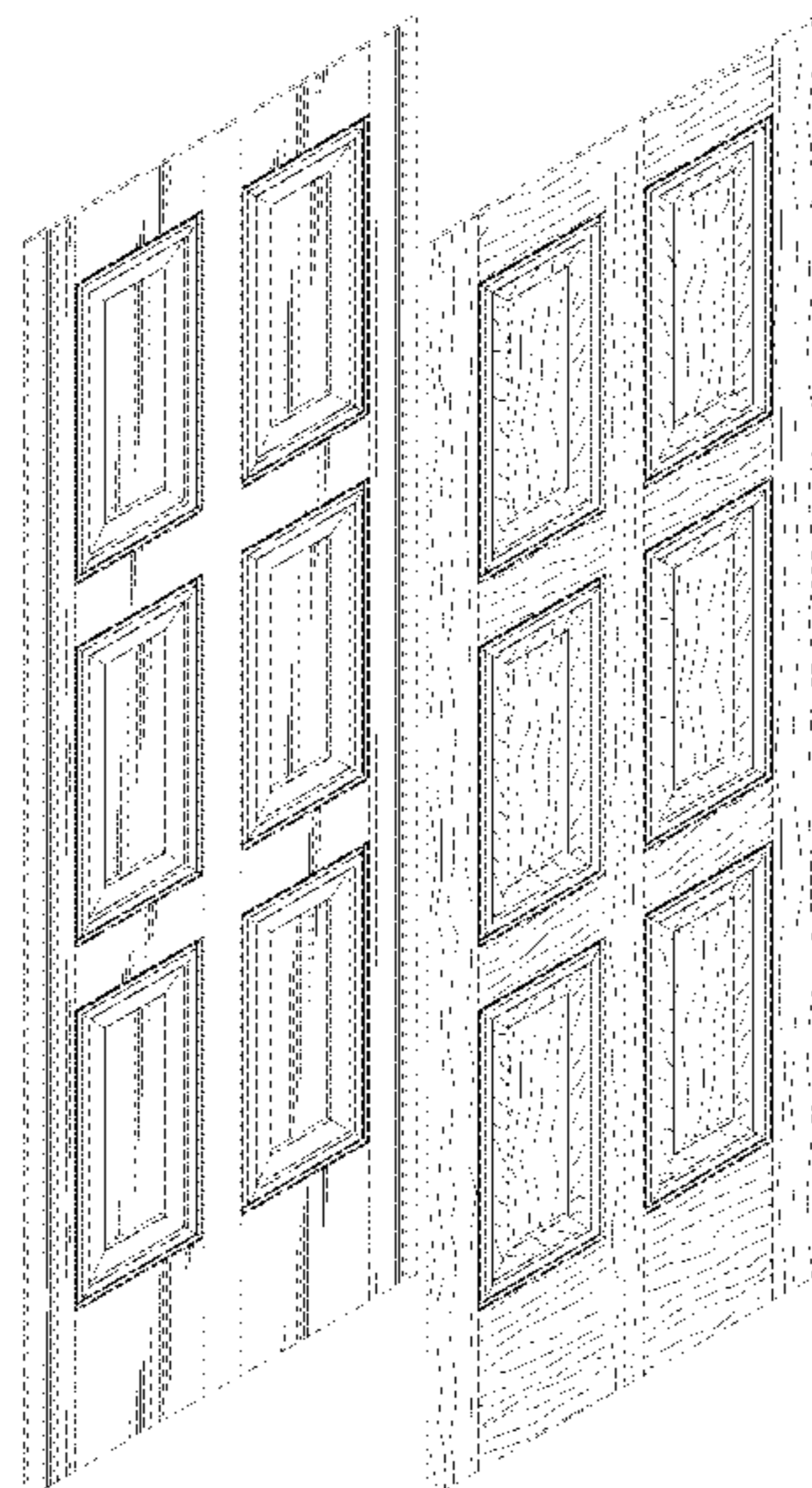
DESCRIPTION

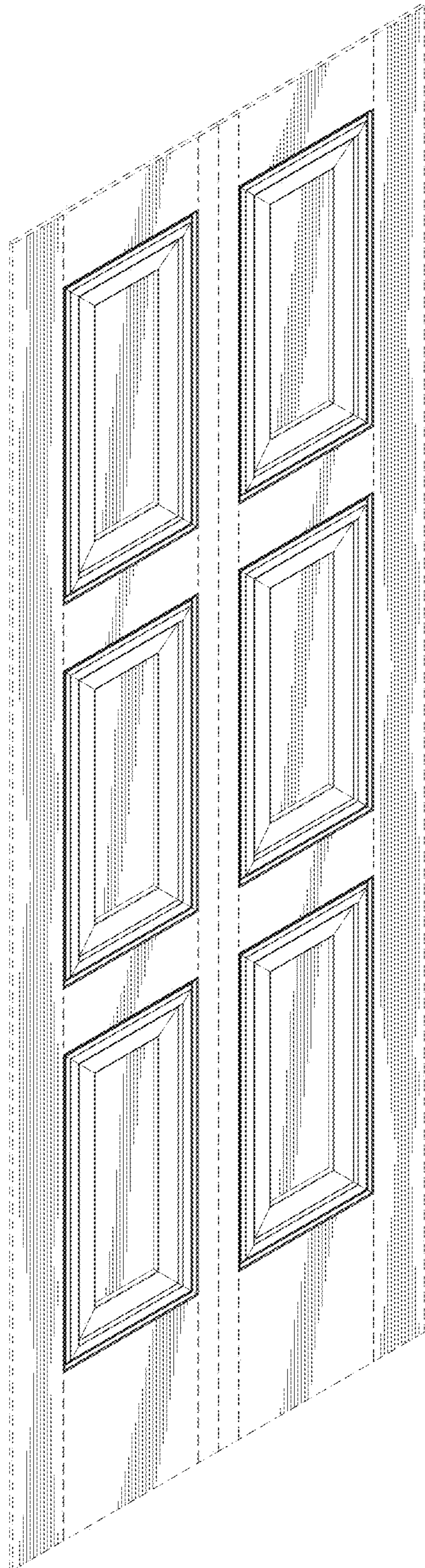

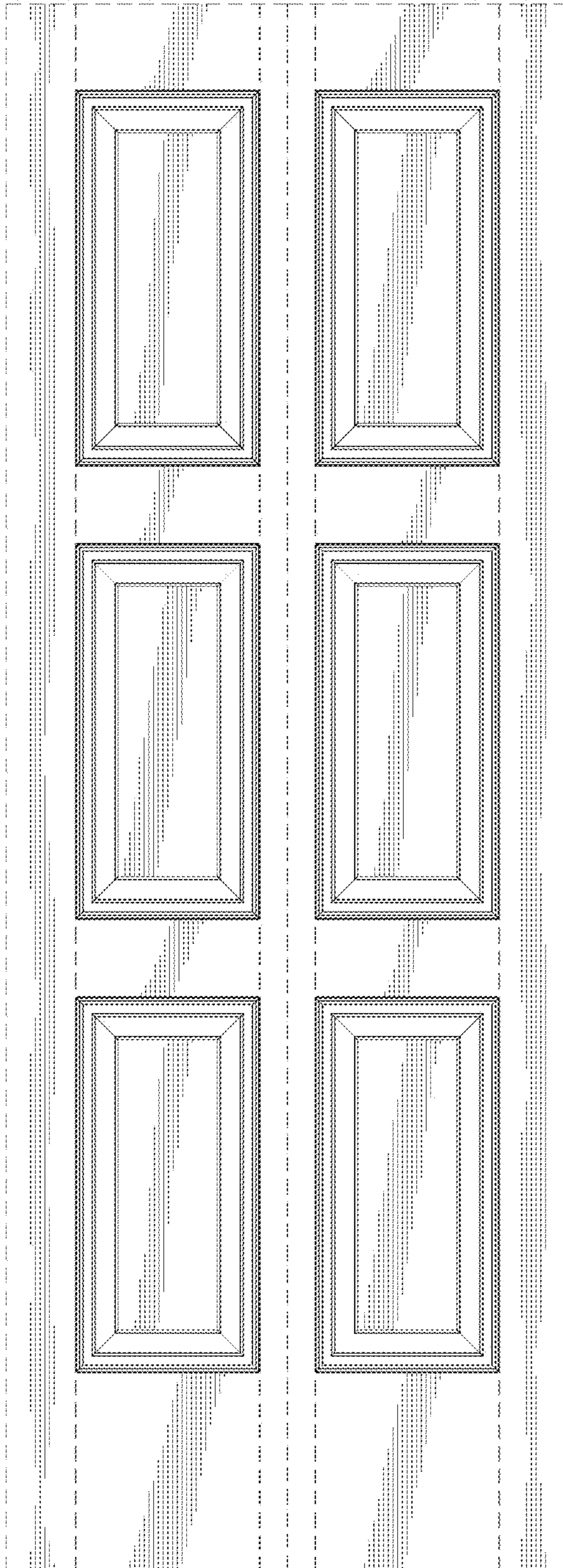

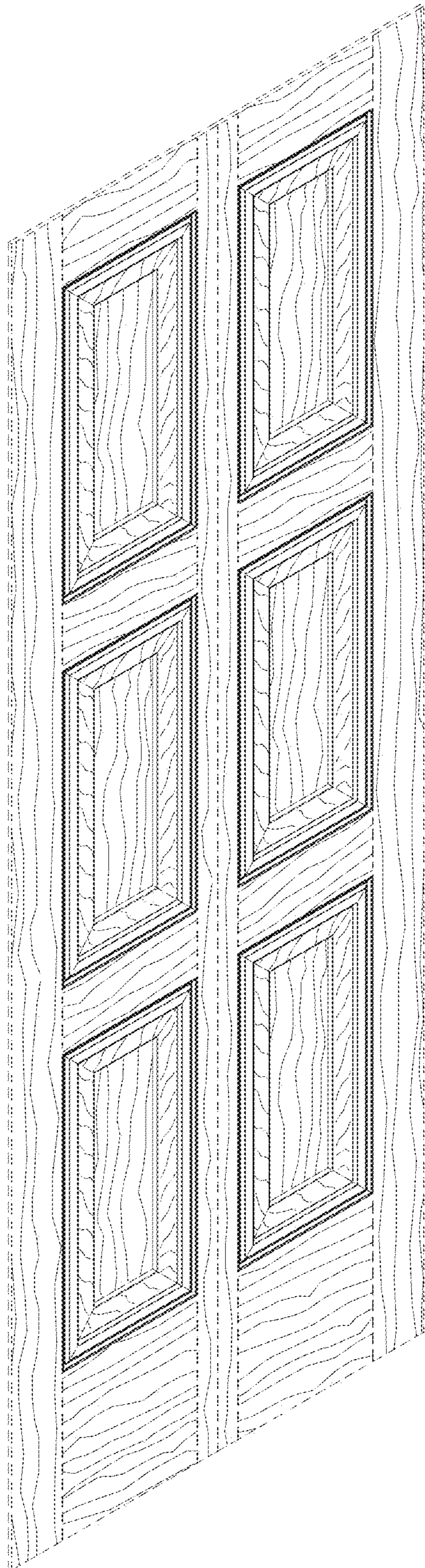
