FIG. 1 is a perspective view of an automobile headlight; FIG. 2 is a front view thereof; and, FIG. 3 is a side view thereof.

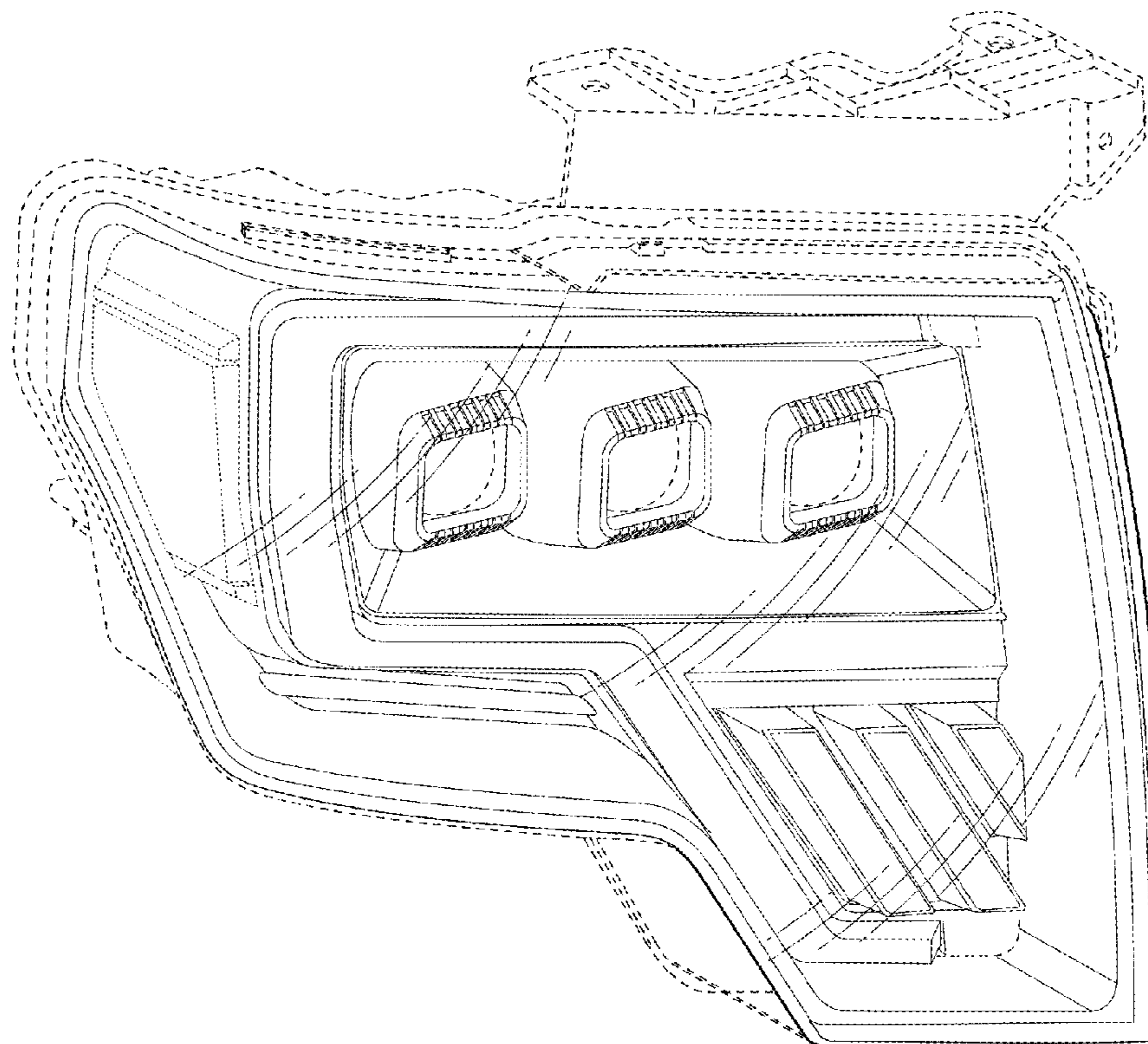

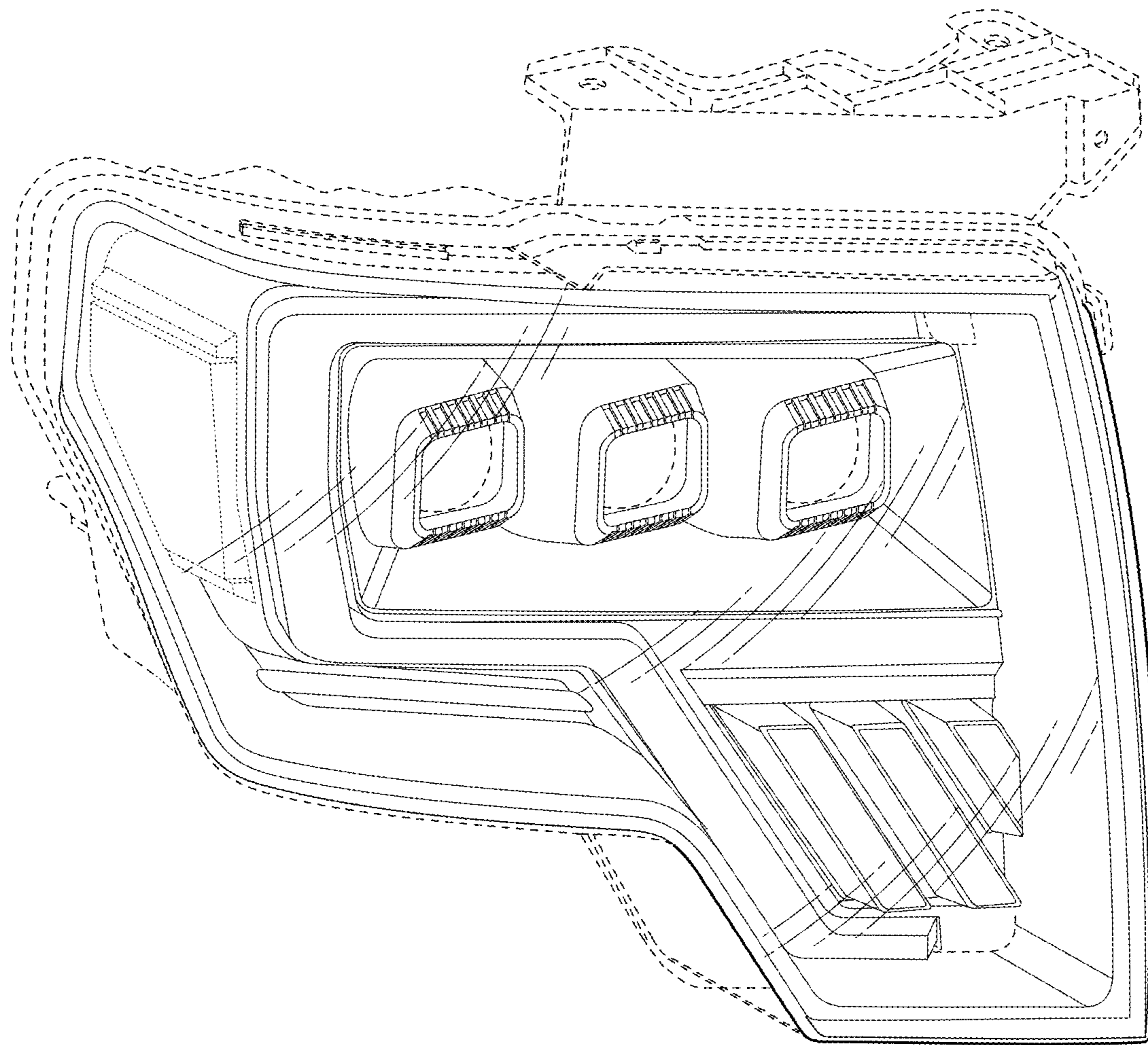

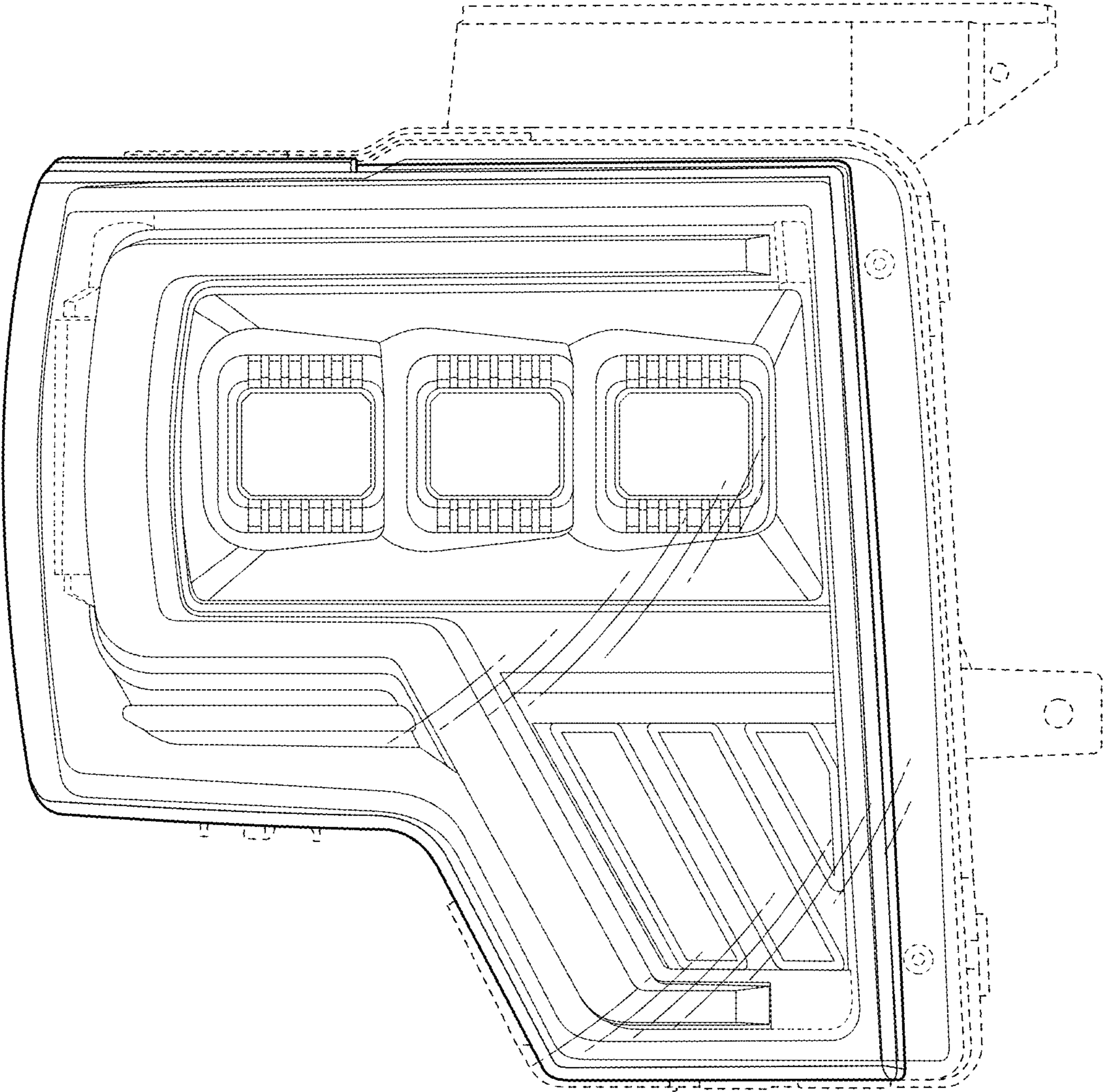

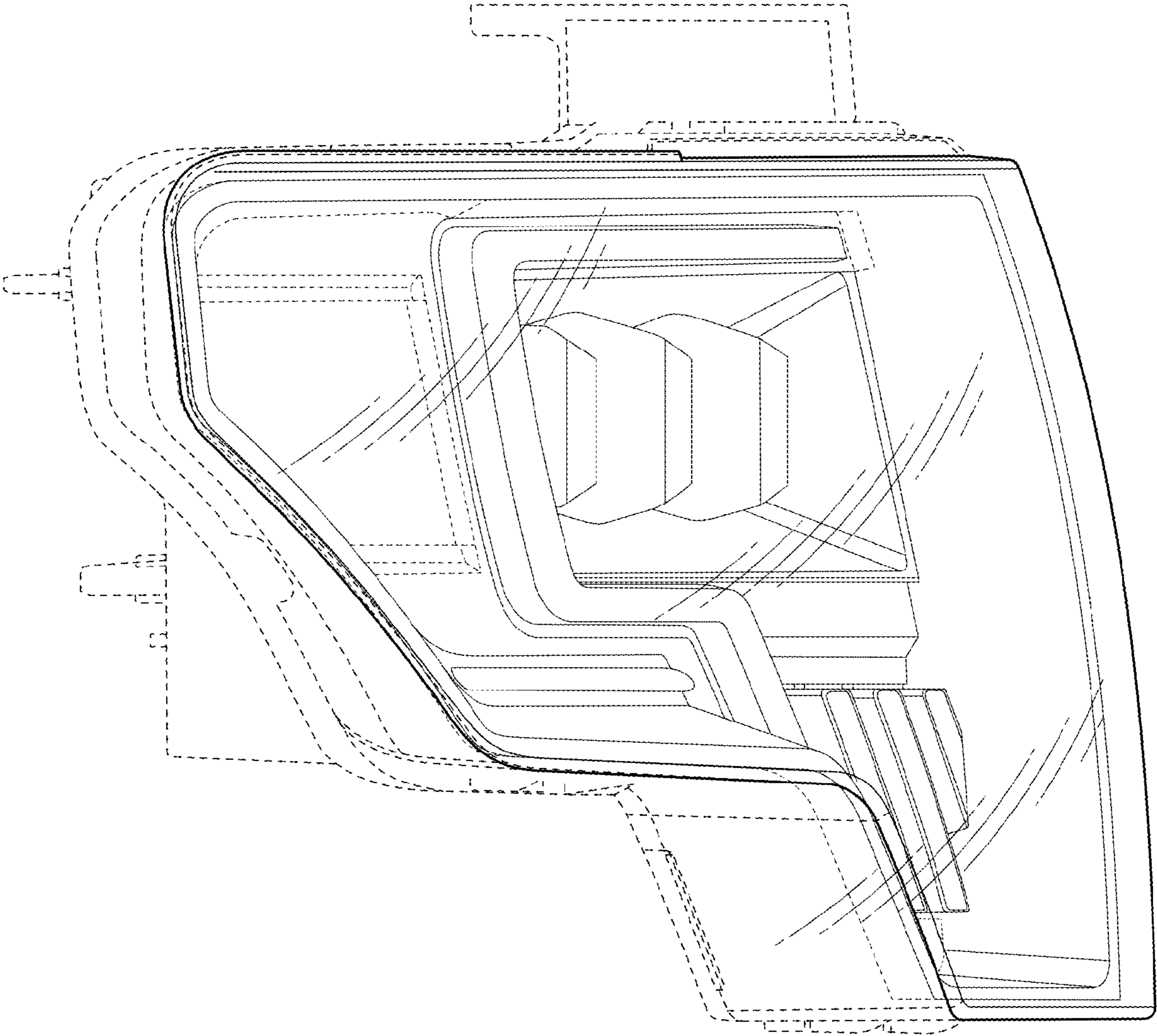
