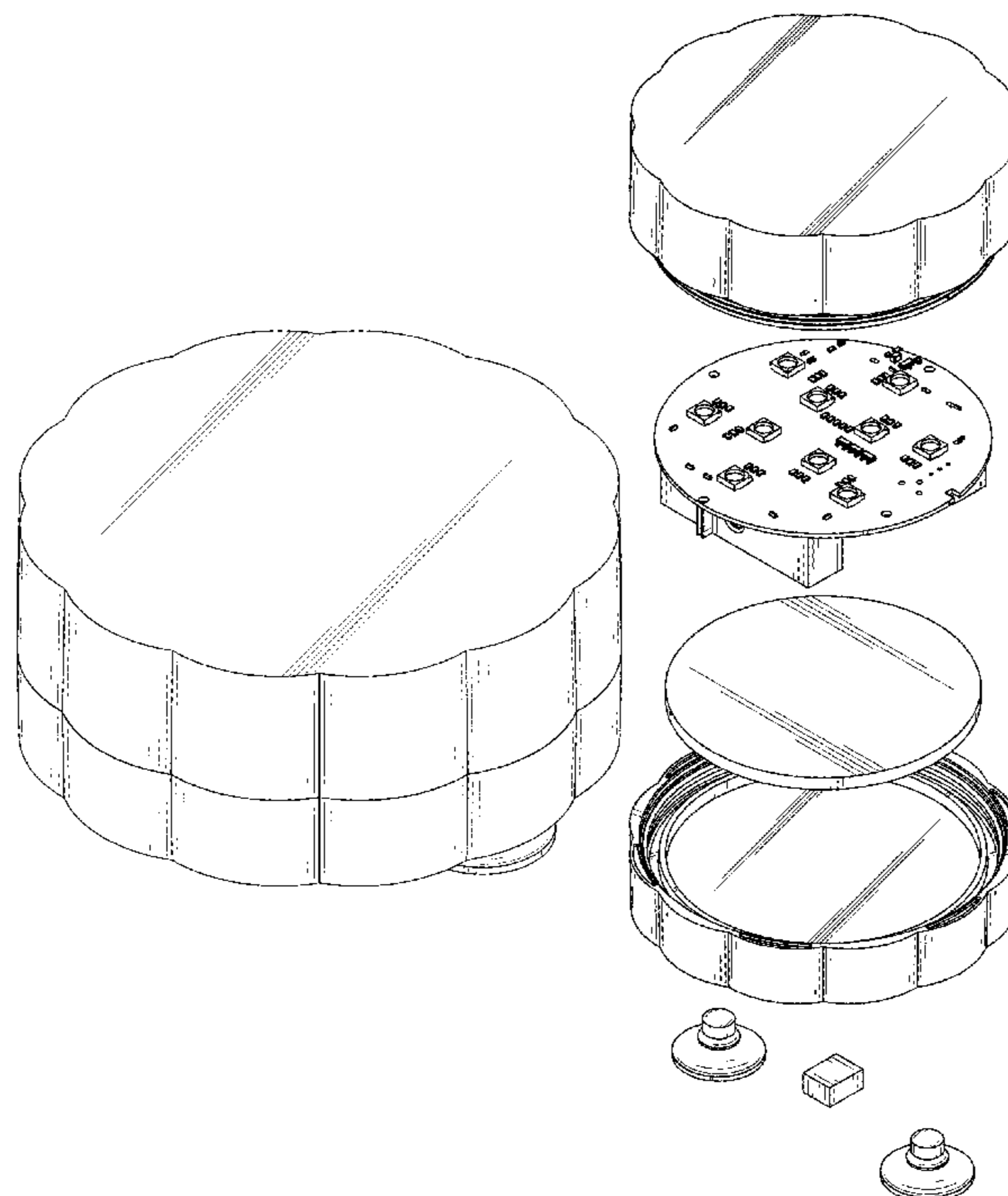
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front right side top perspective view of the waterproof LED light showing my new design;

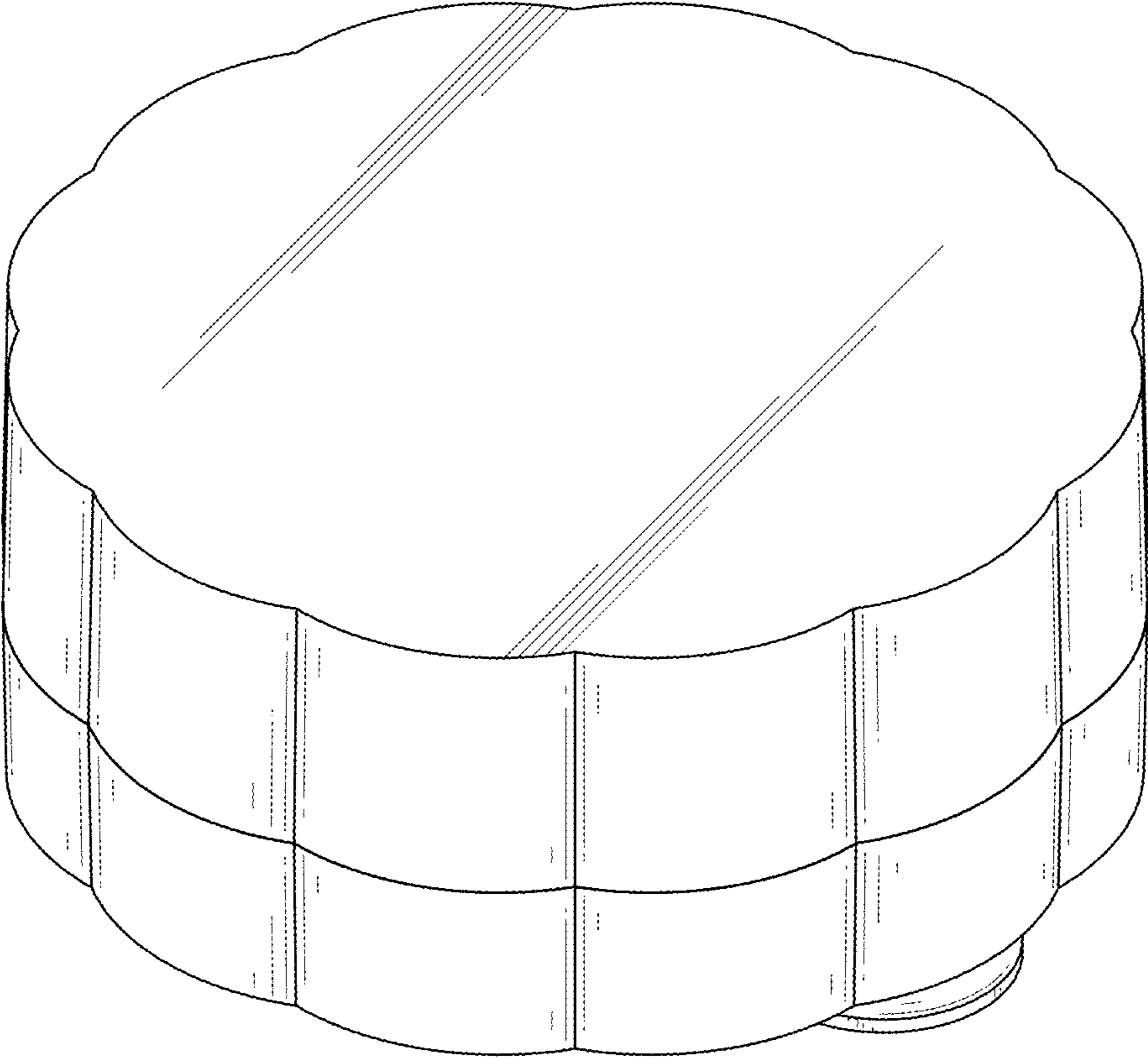

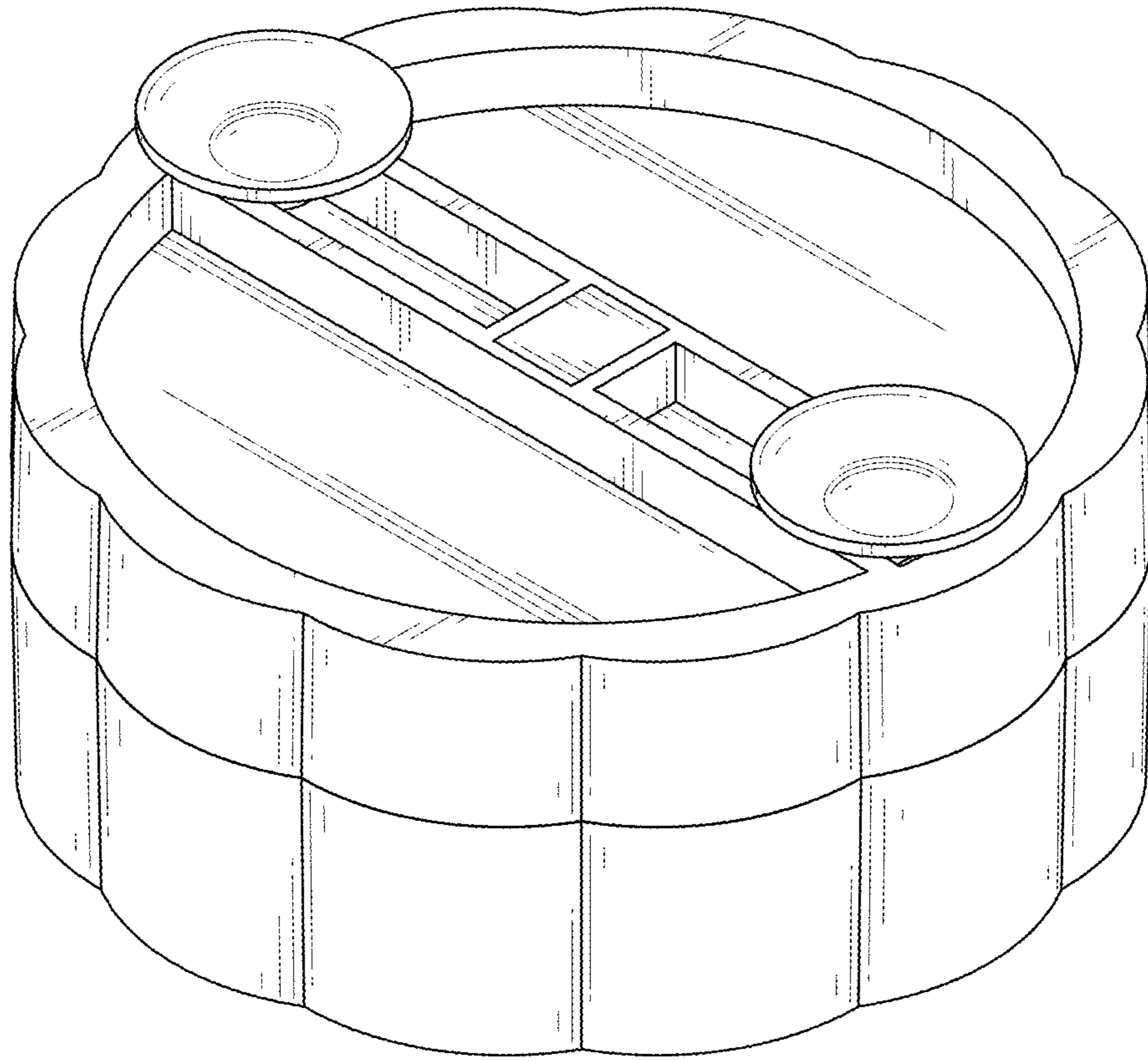

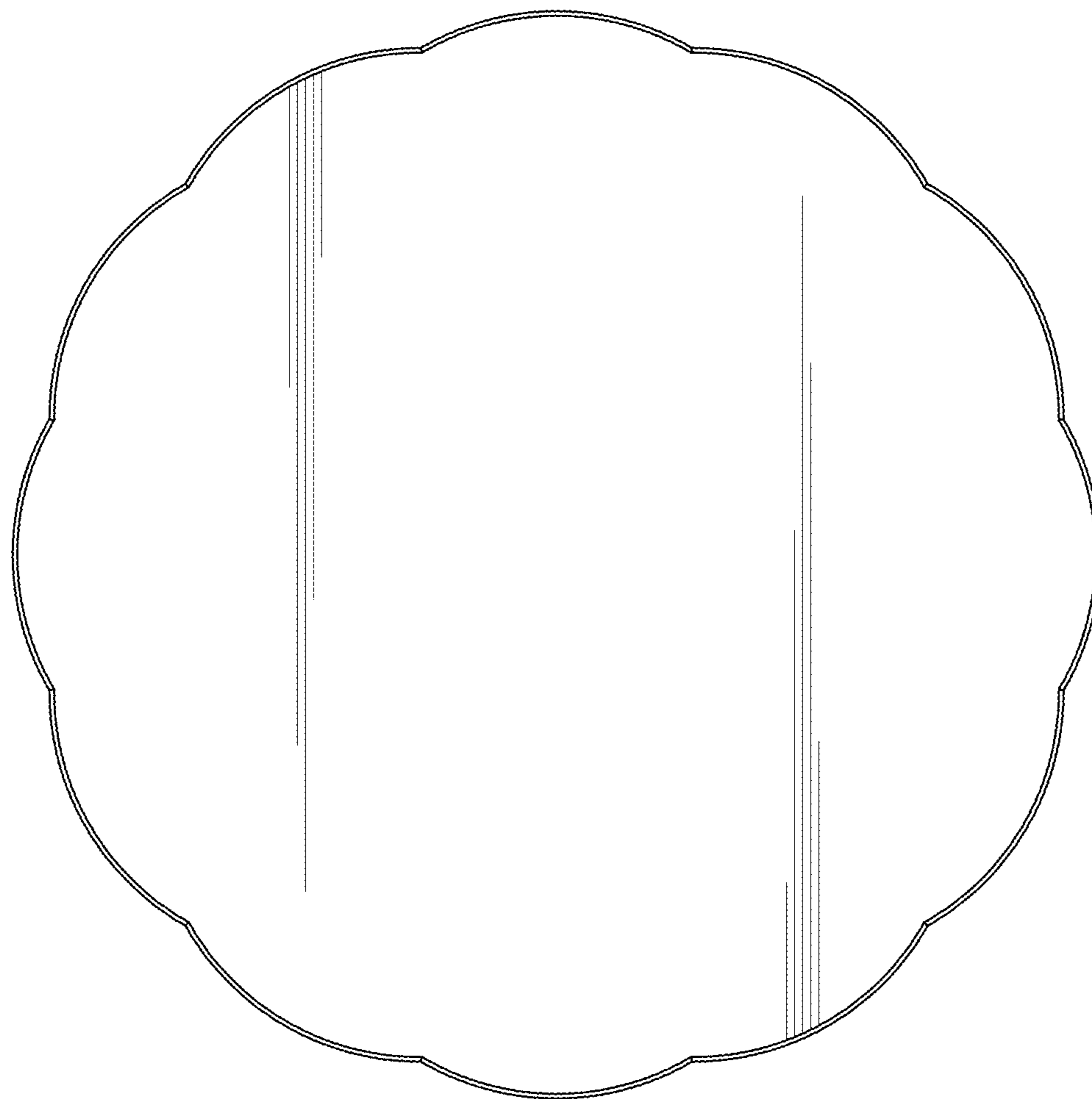

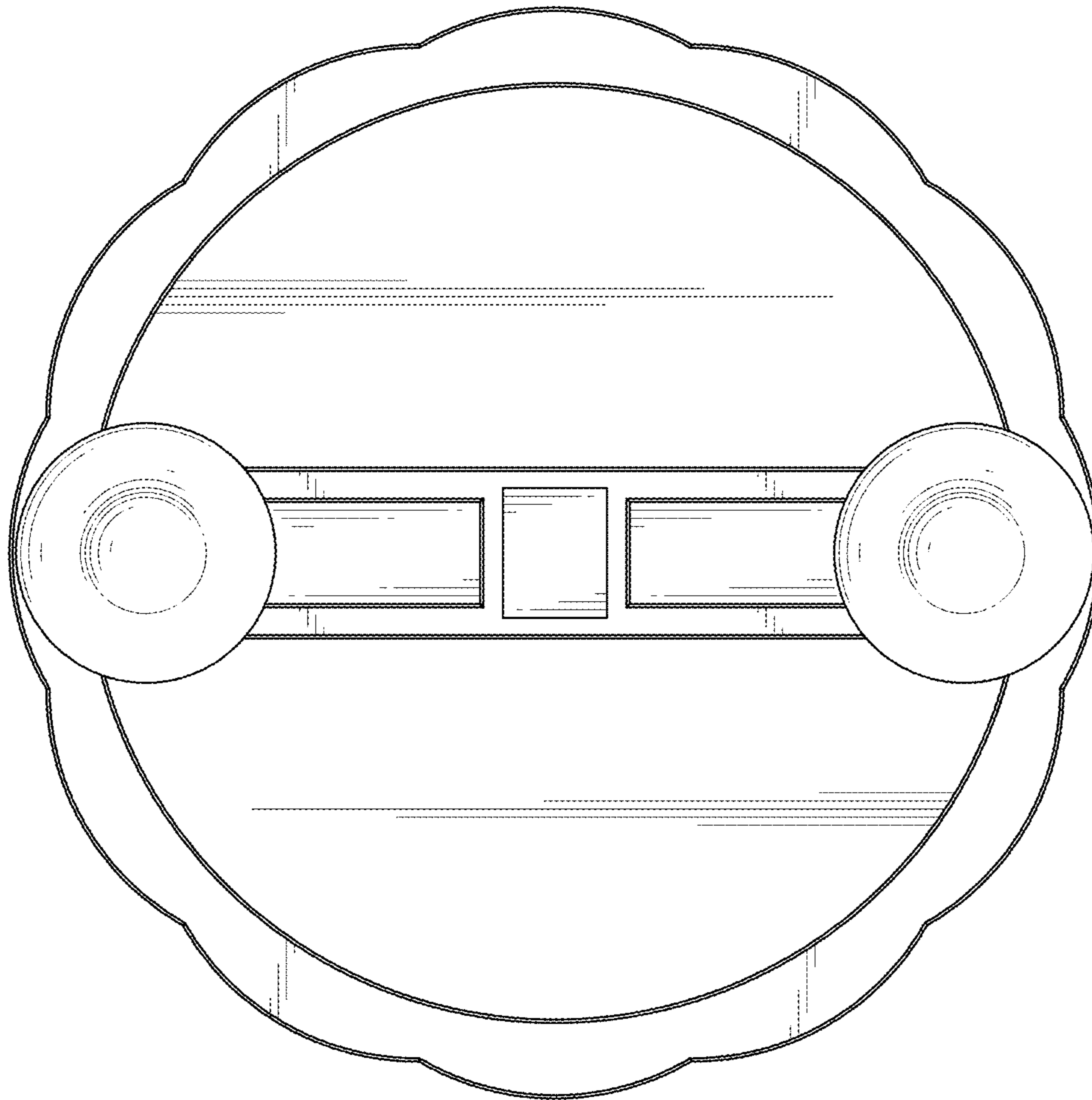

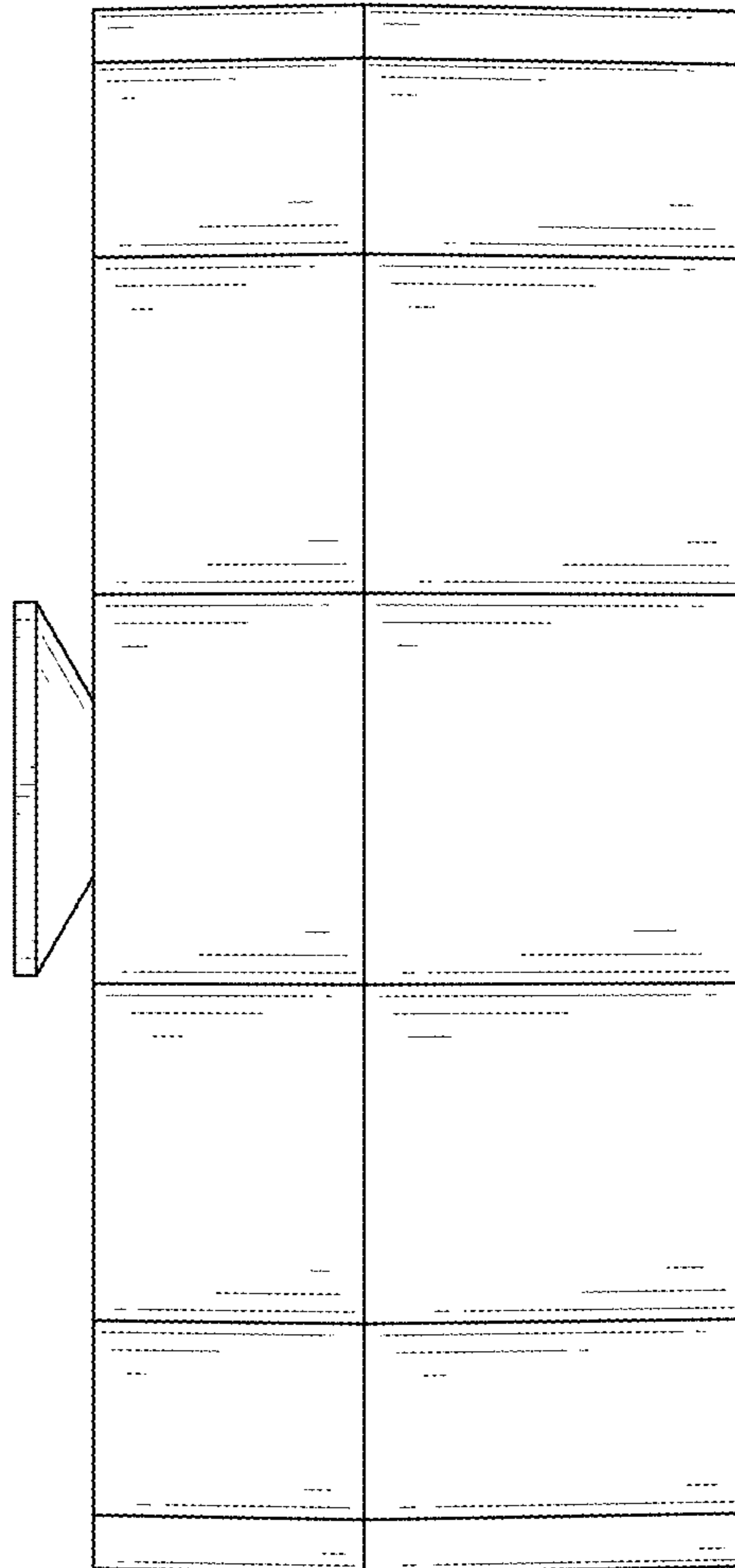

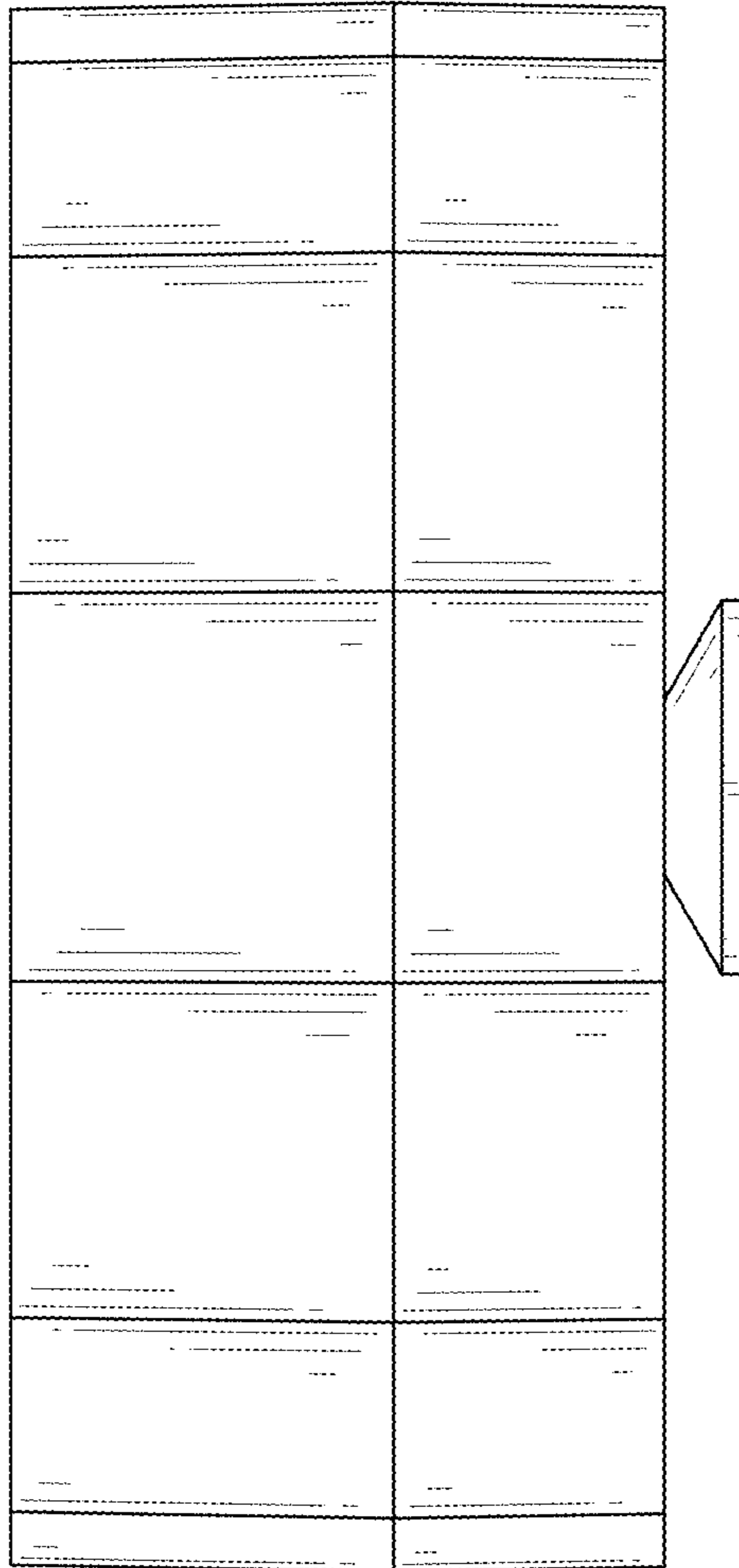

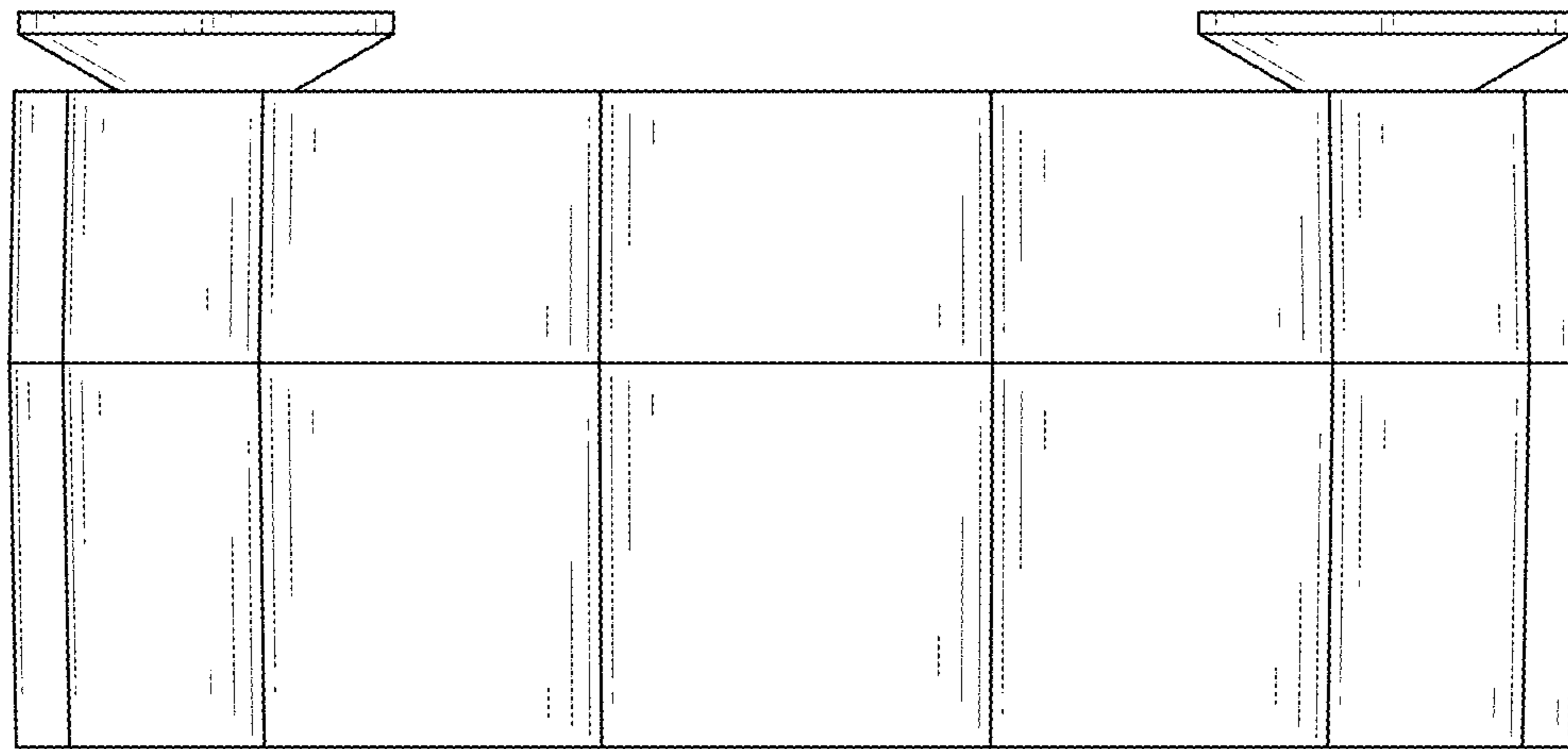

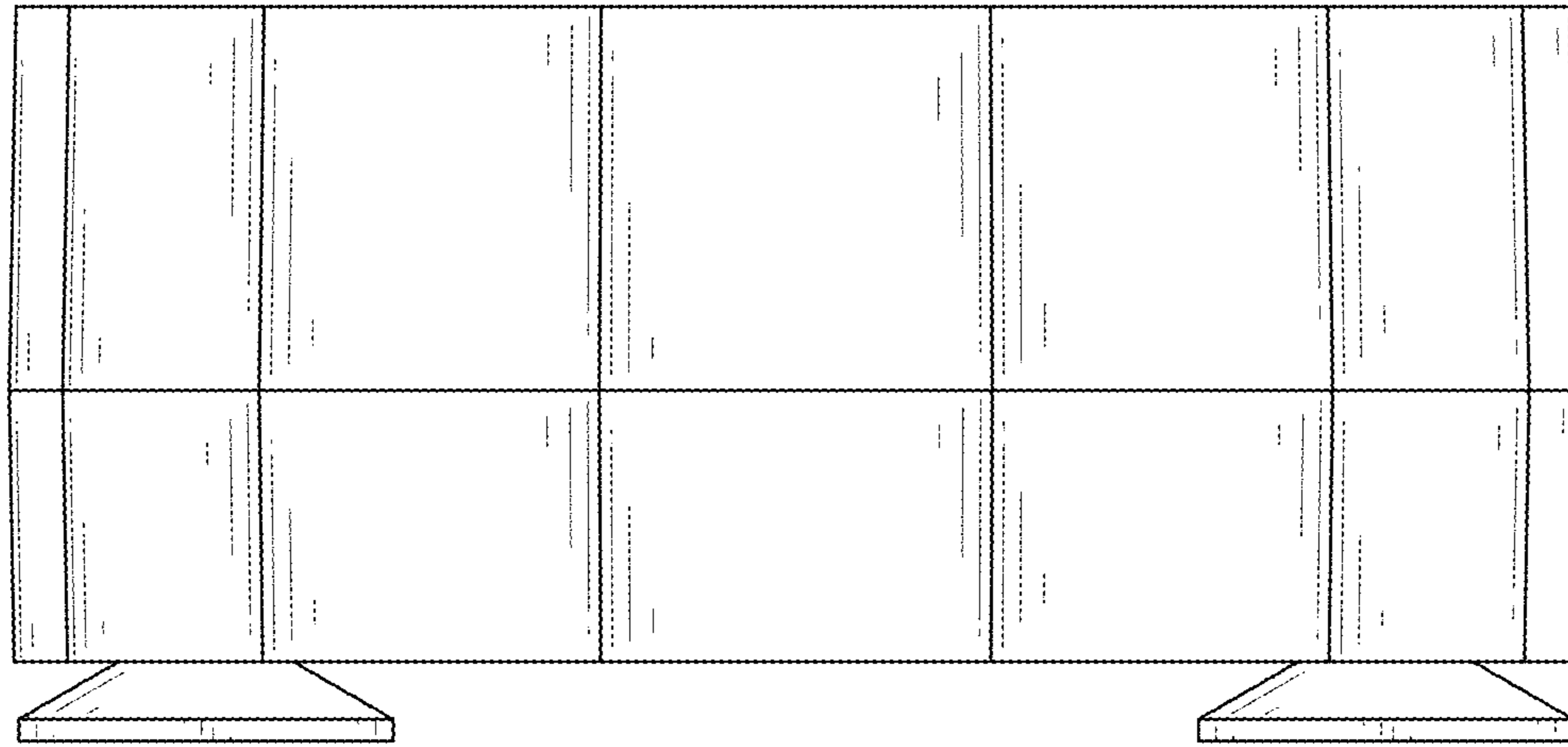

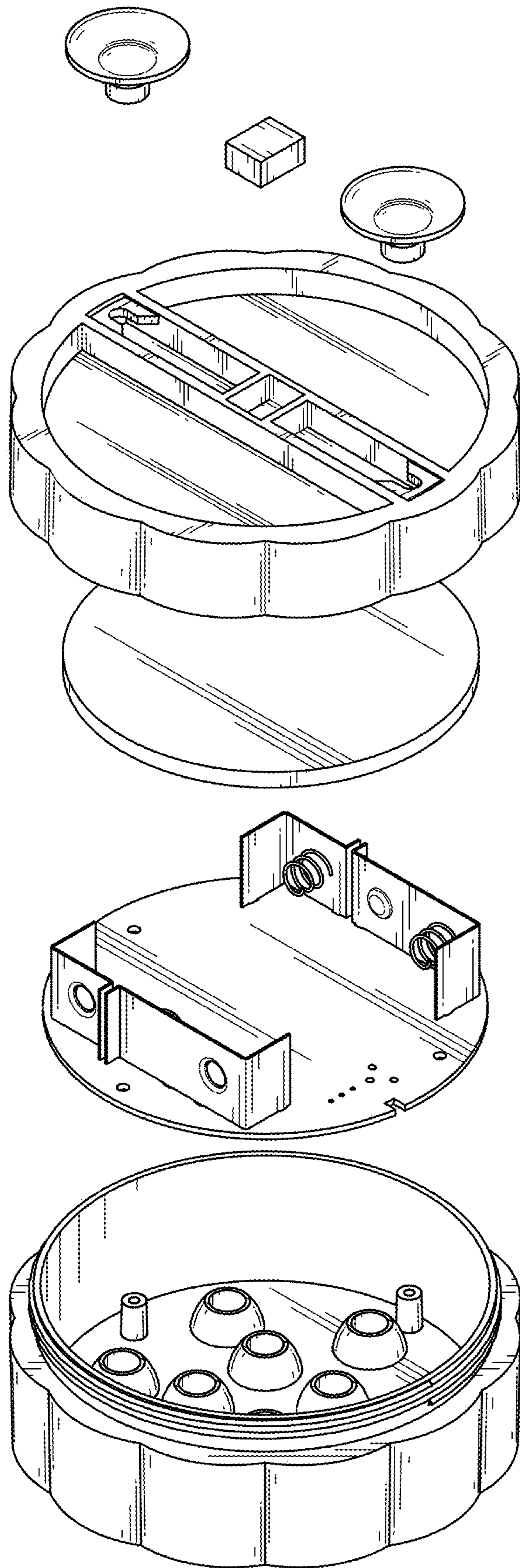

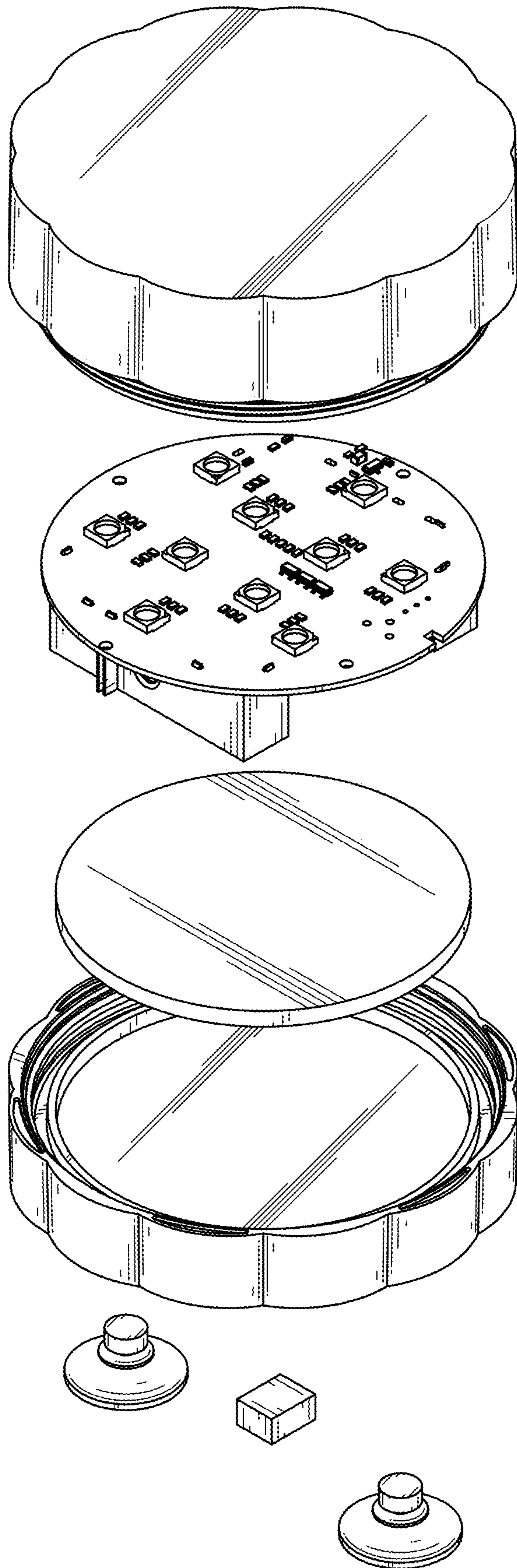
