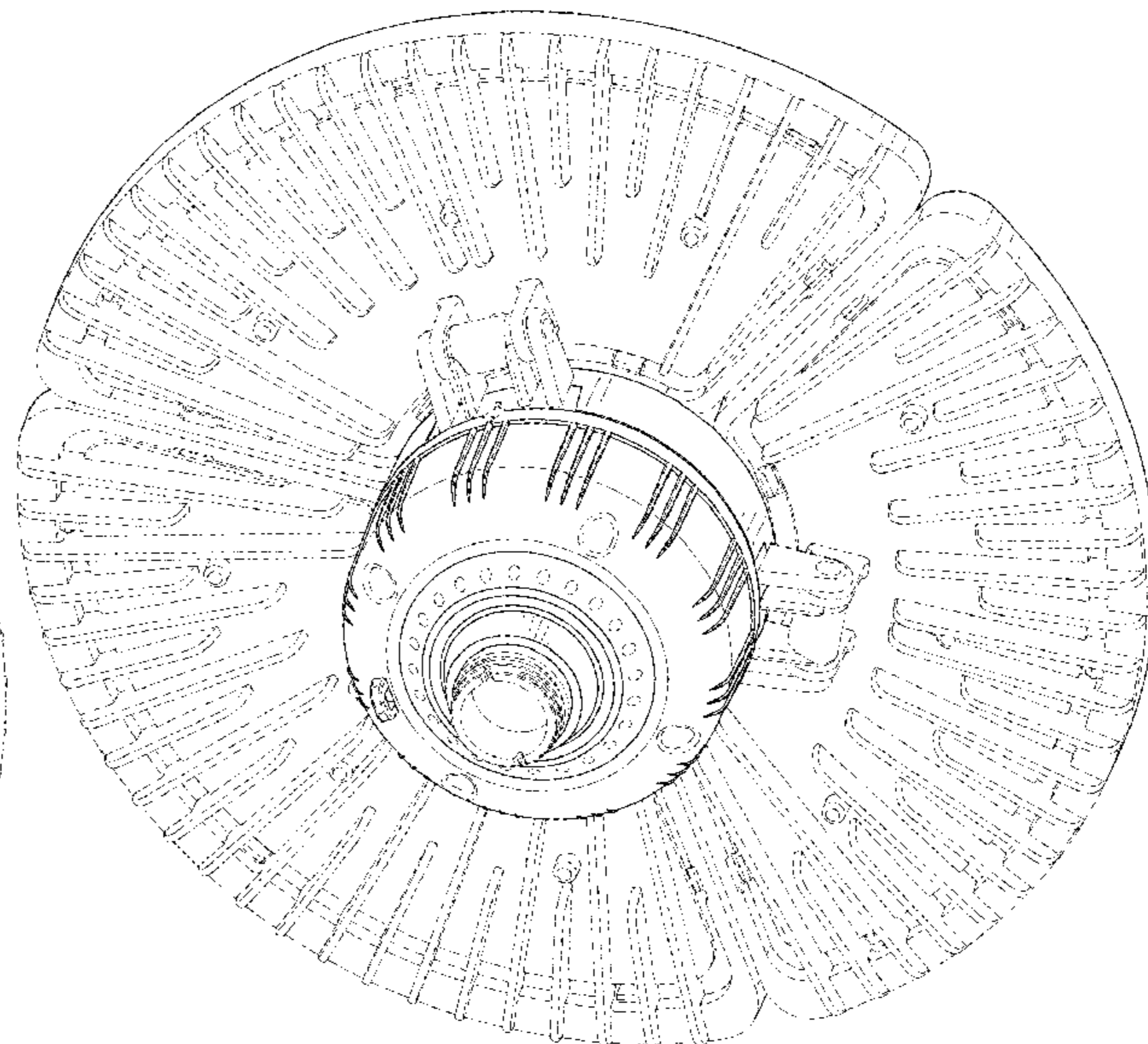
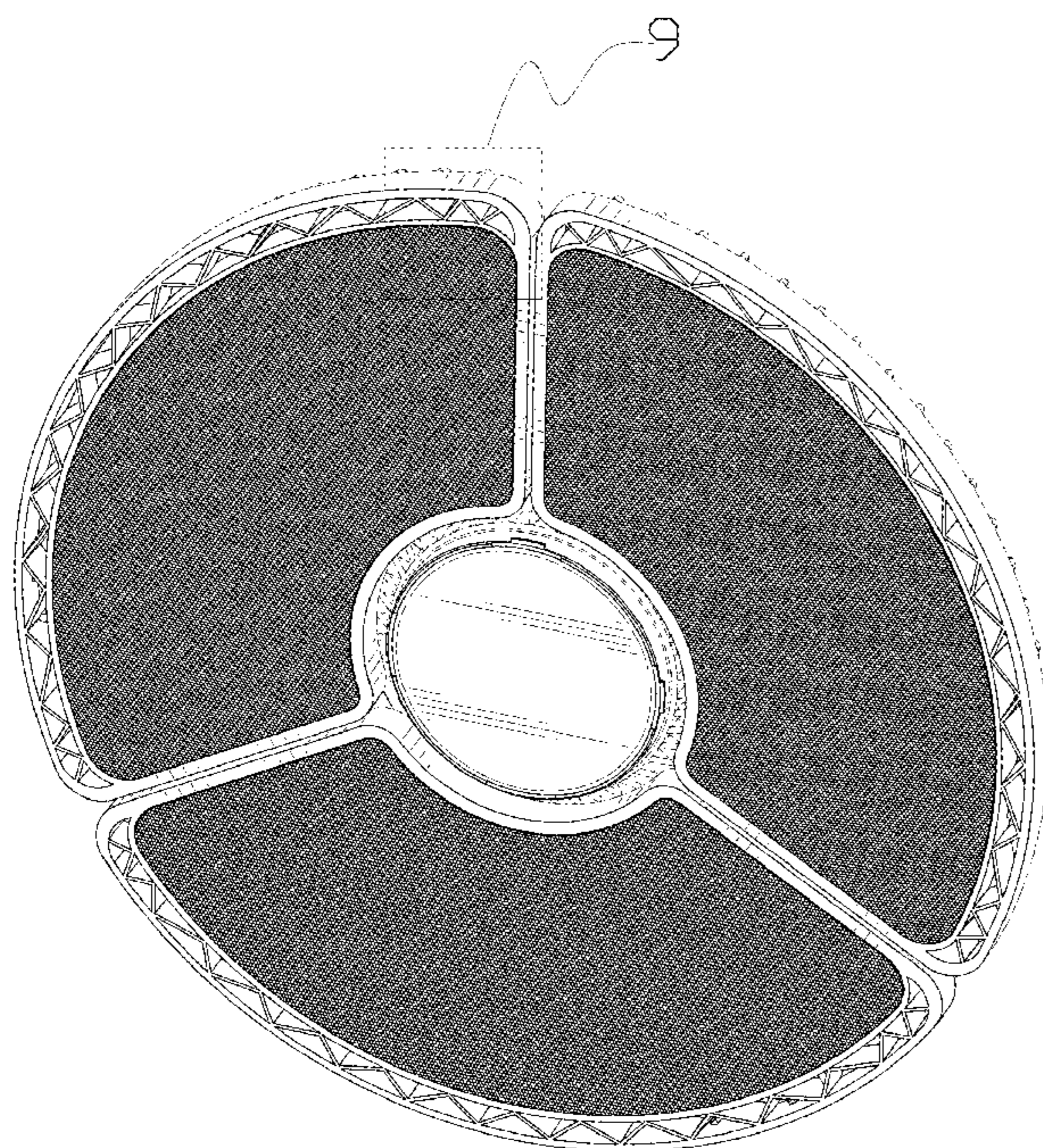
(57) **CLAIM**

The ornamental design for an LED garage light, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an LED garage light showing my new design;  
FIG. 2 is another perspective view thereof;

FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a left side elevational view thereof;

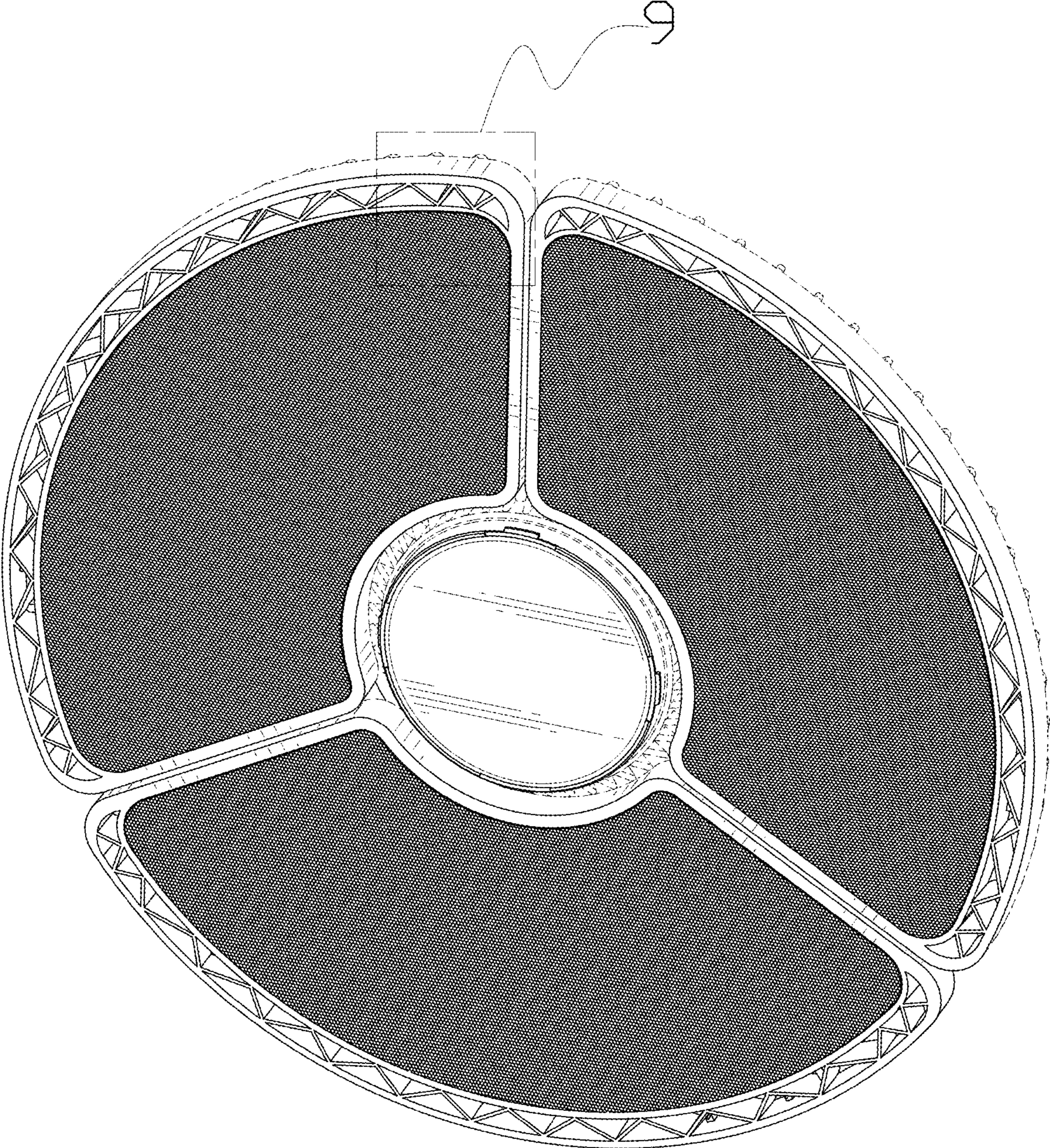

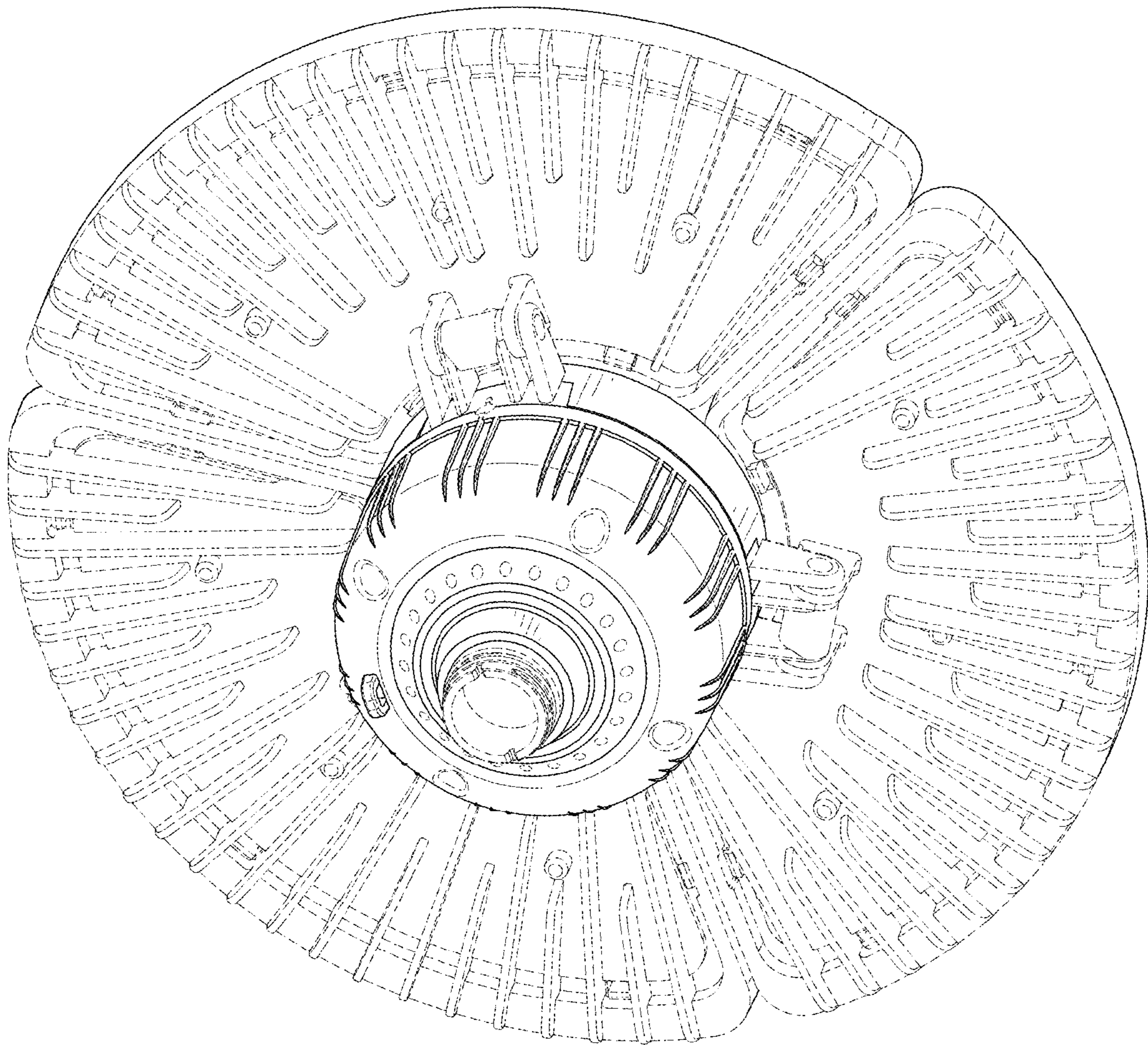

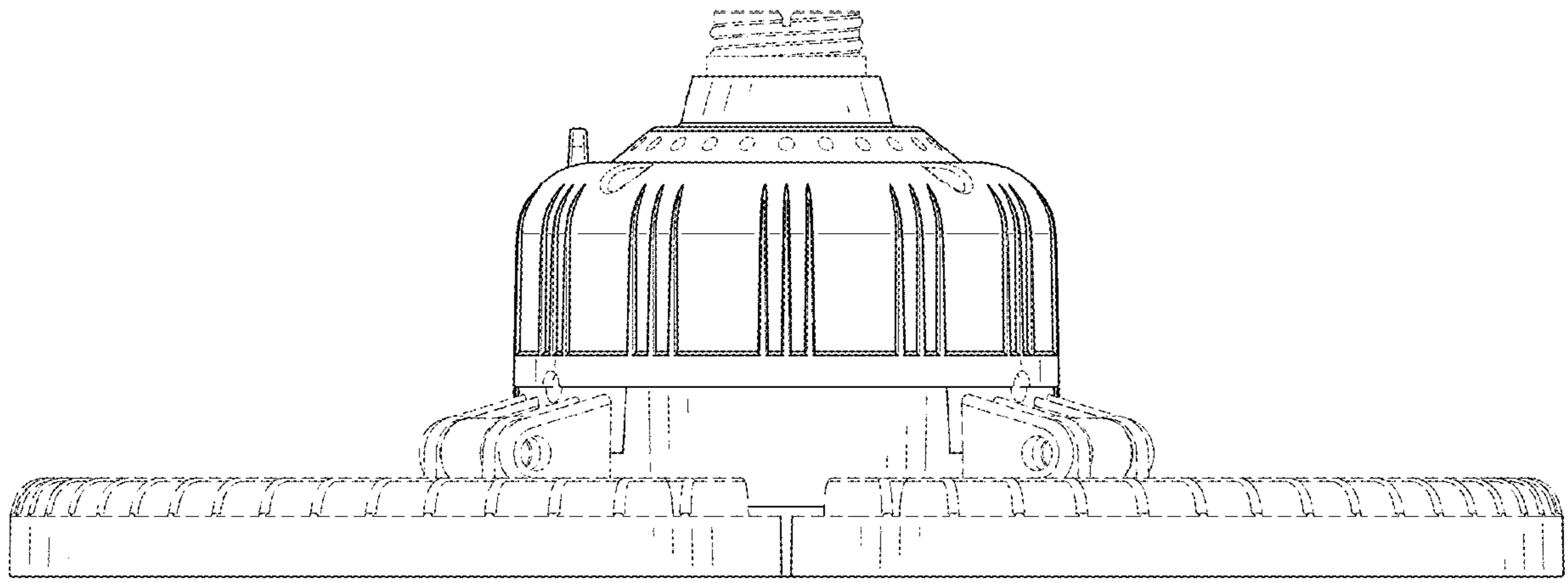

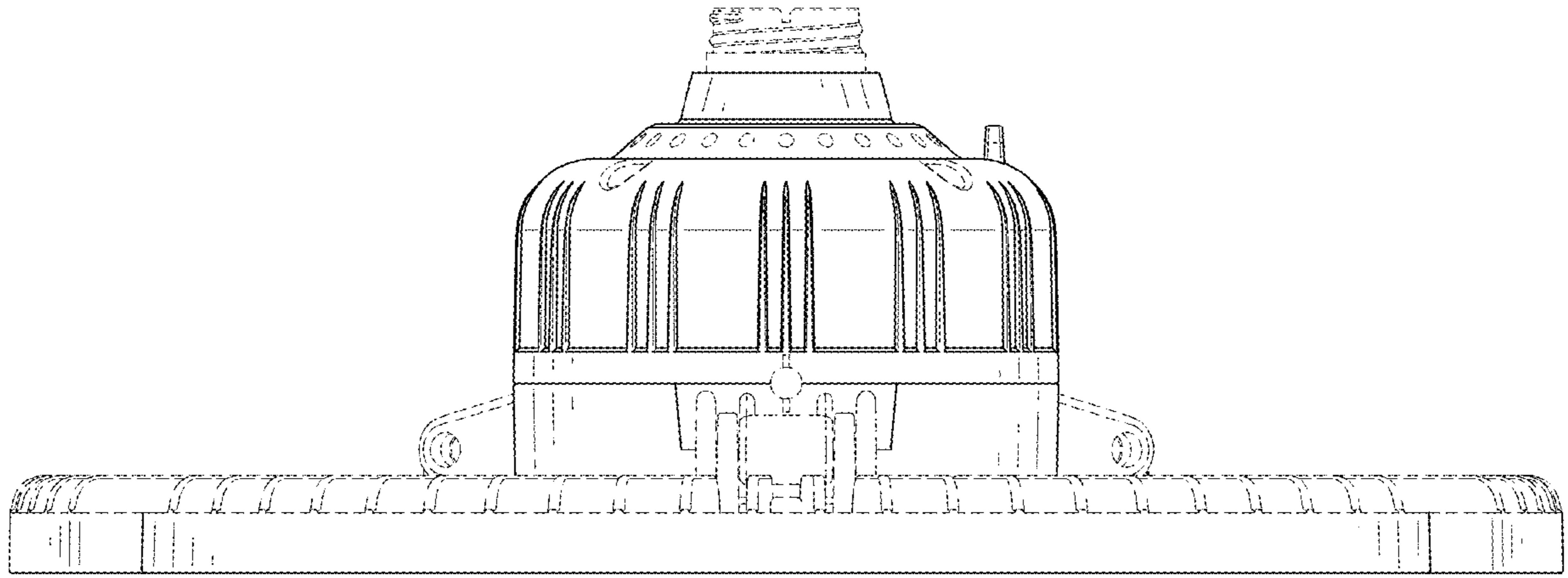

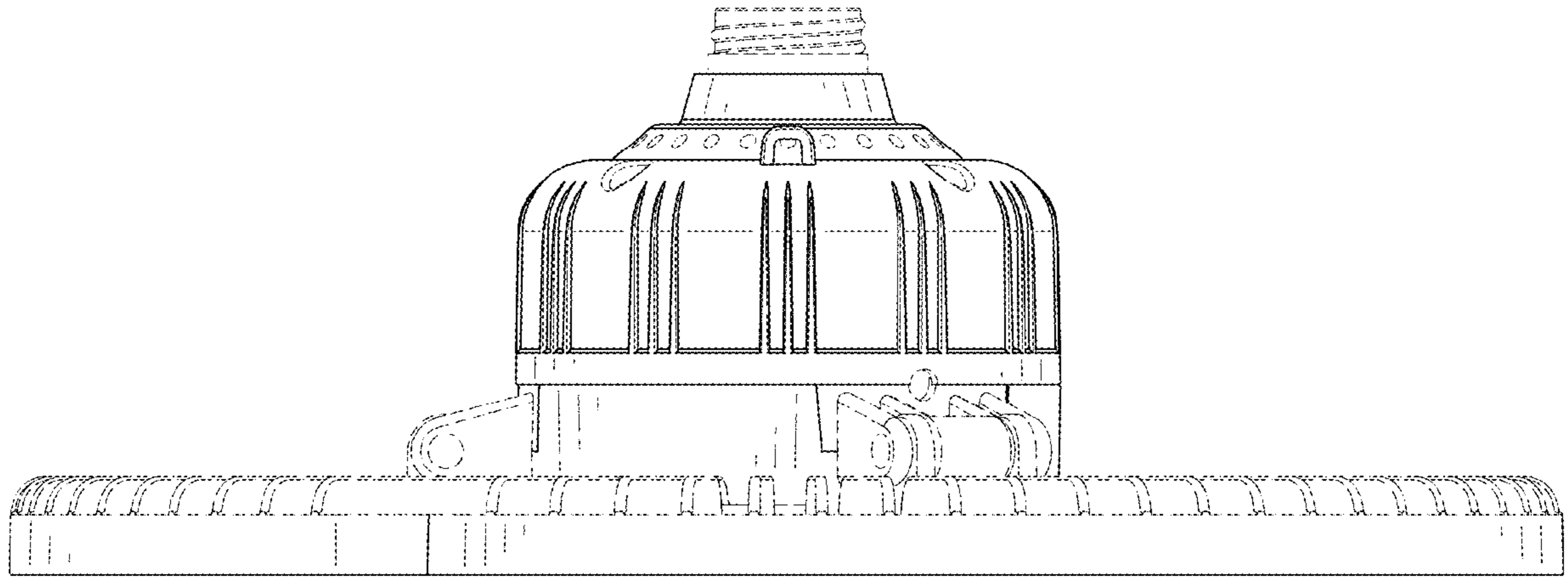

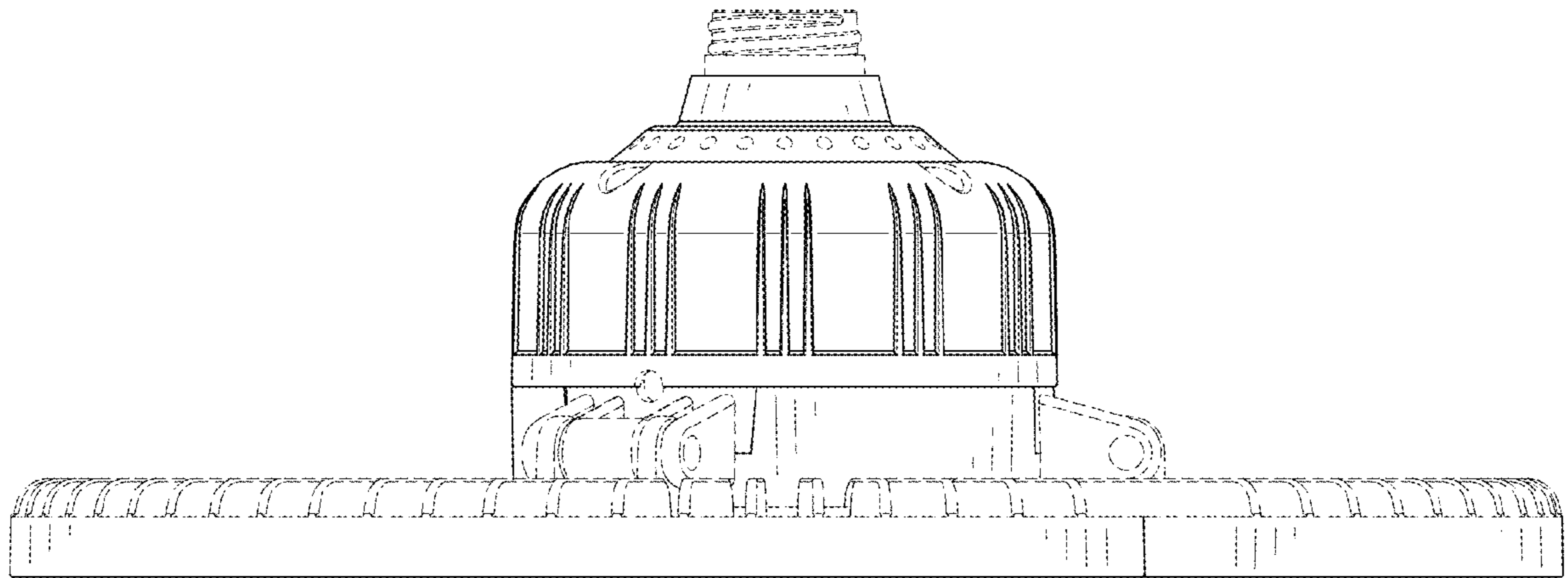

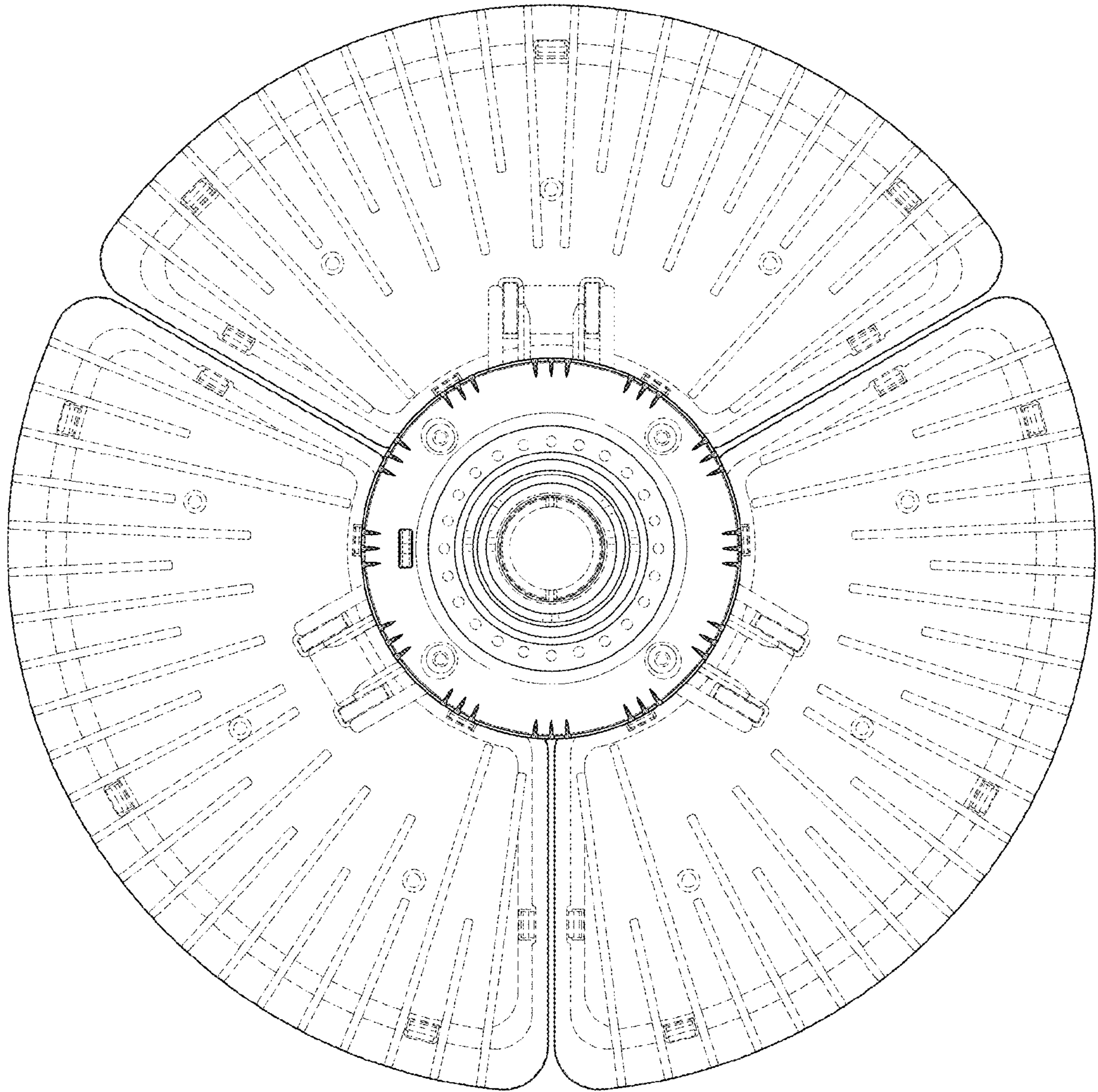

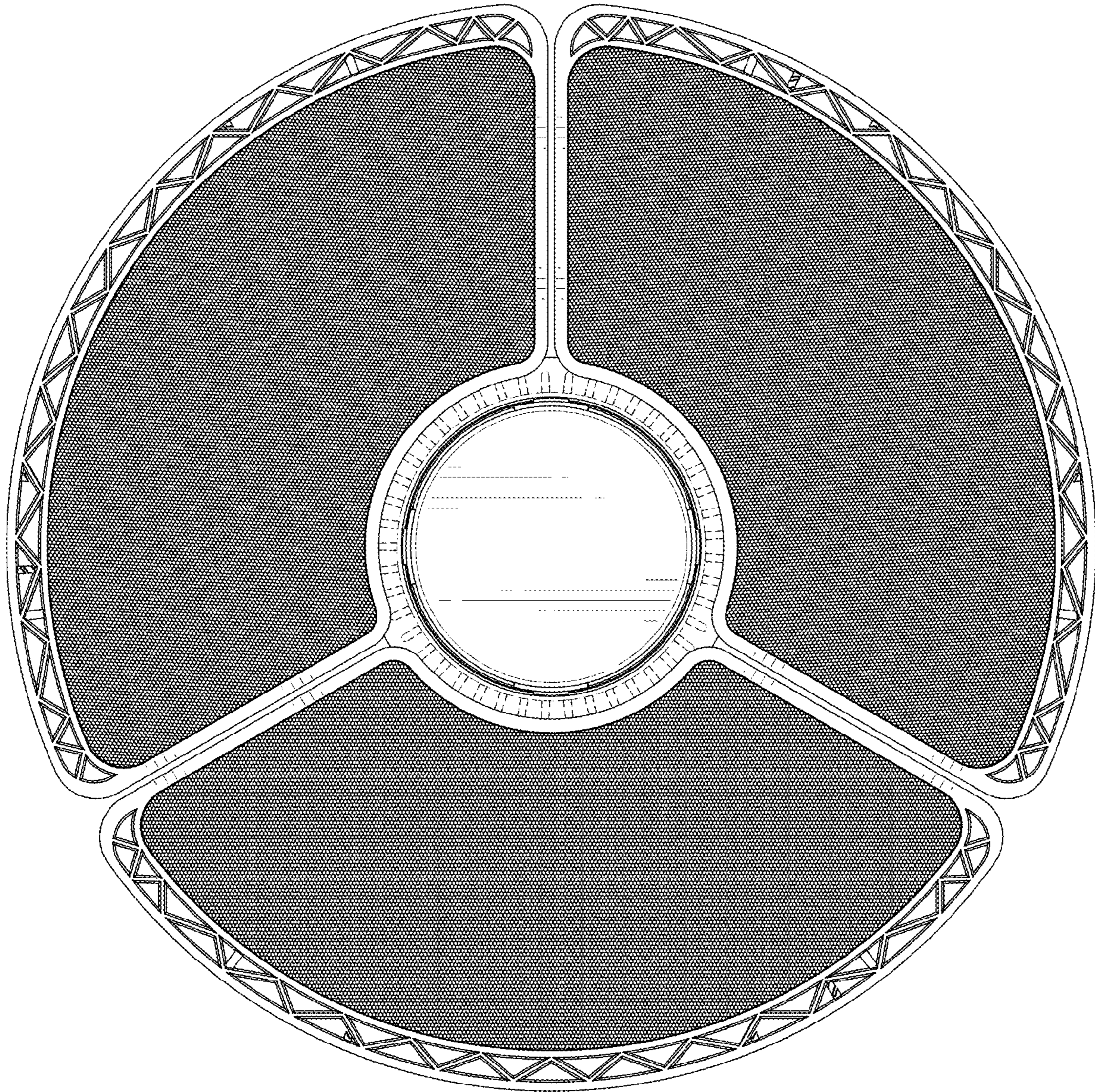

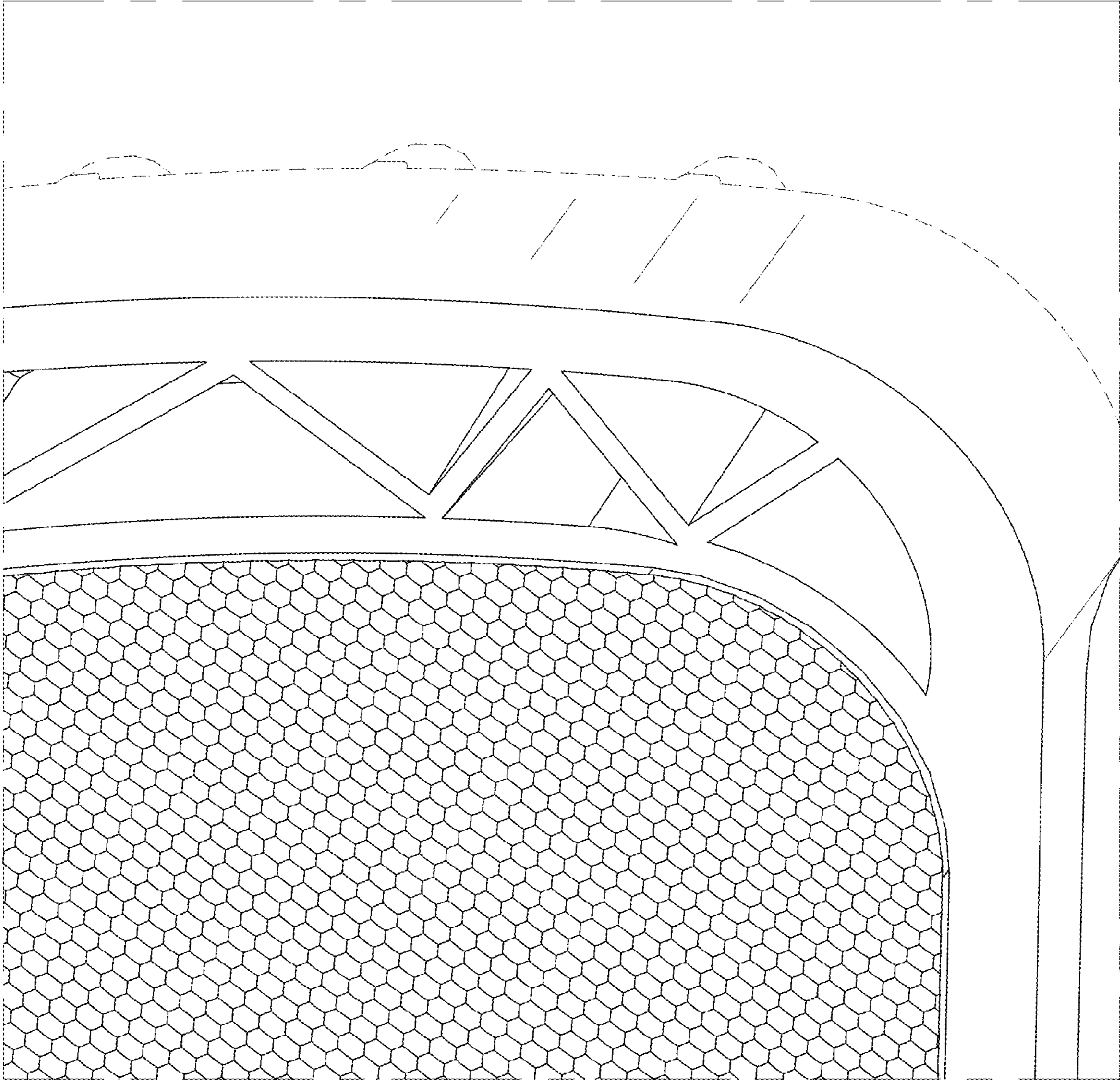
