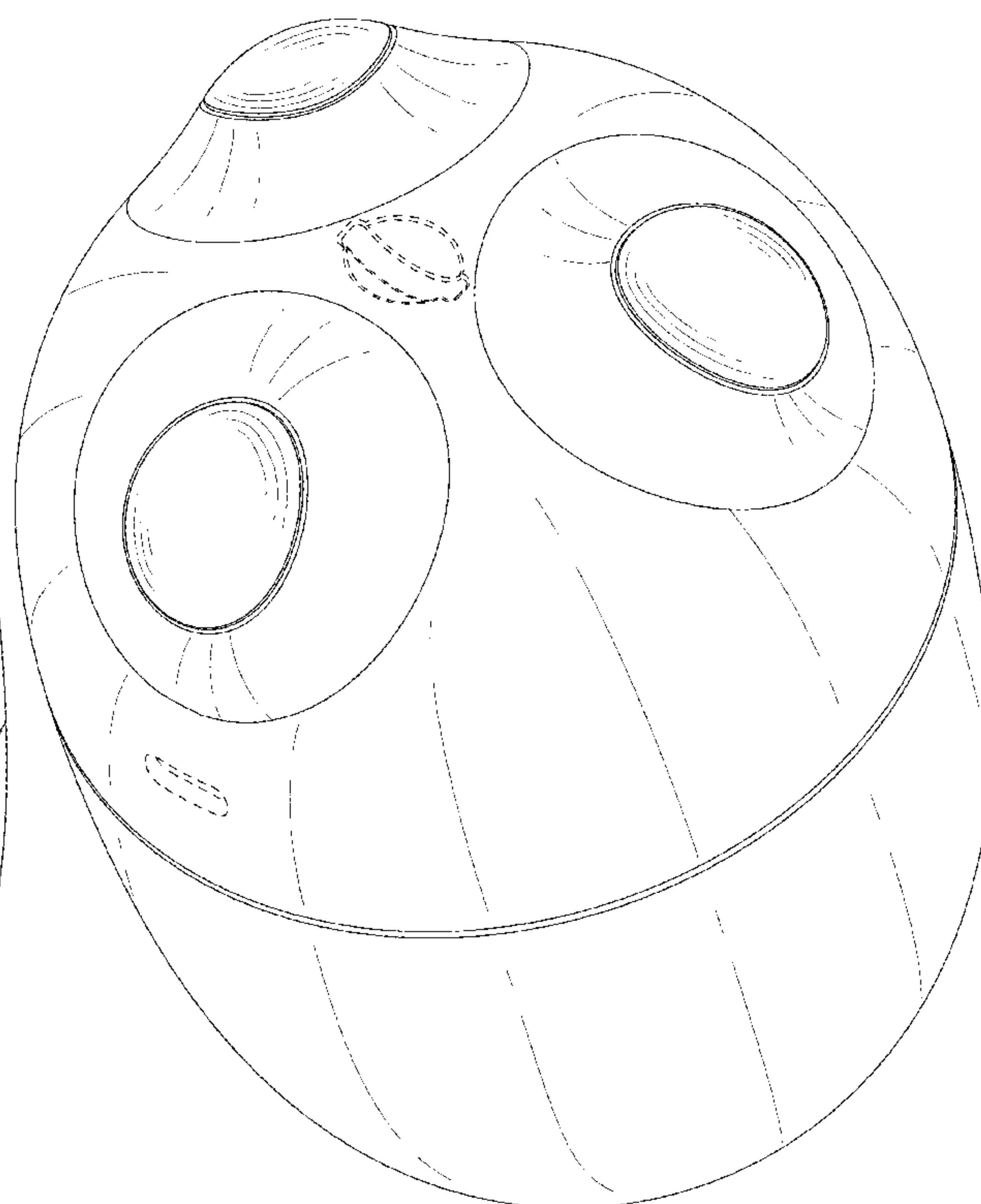
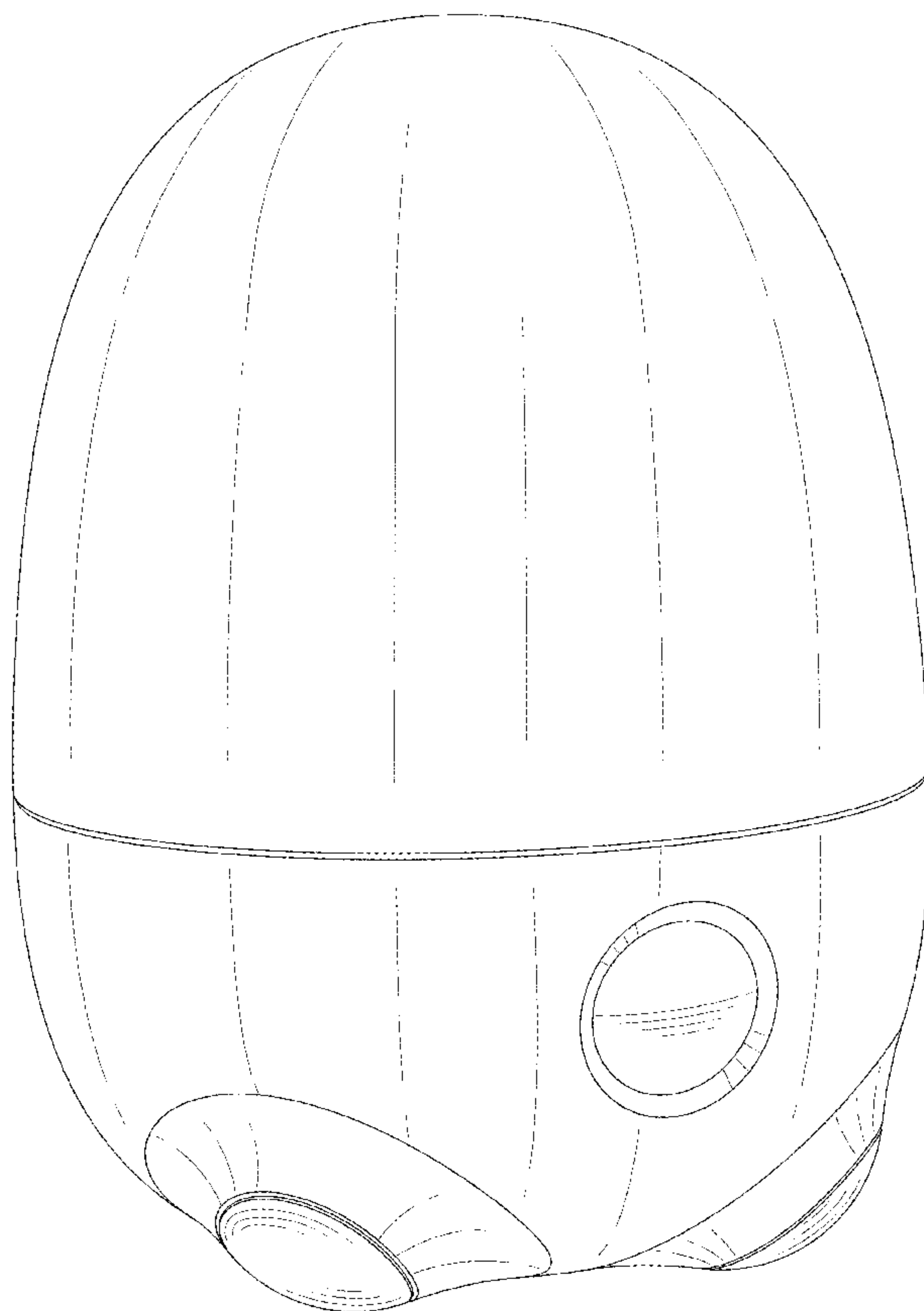
(57) **CLAIM**

The ornamental design for a timer night light, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a timer night light; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left elevational view thereof; FIG. 5 is a right elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is another perspective view thereof. The evenly broken lines where present illustrate portions of the timer night light that form no part of the claimed design.

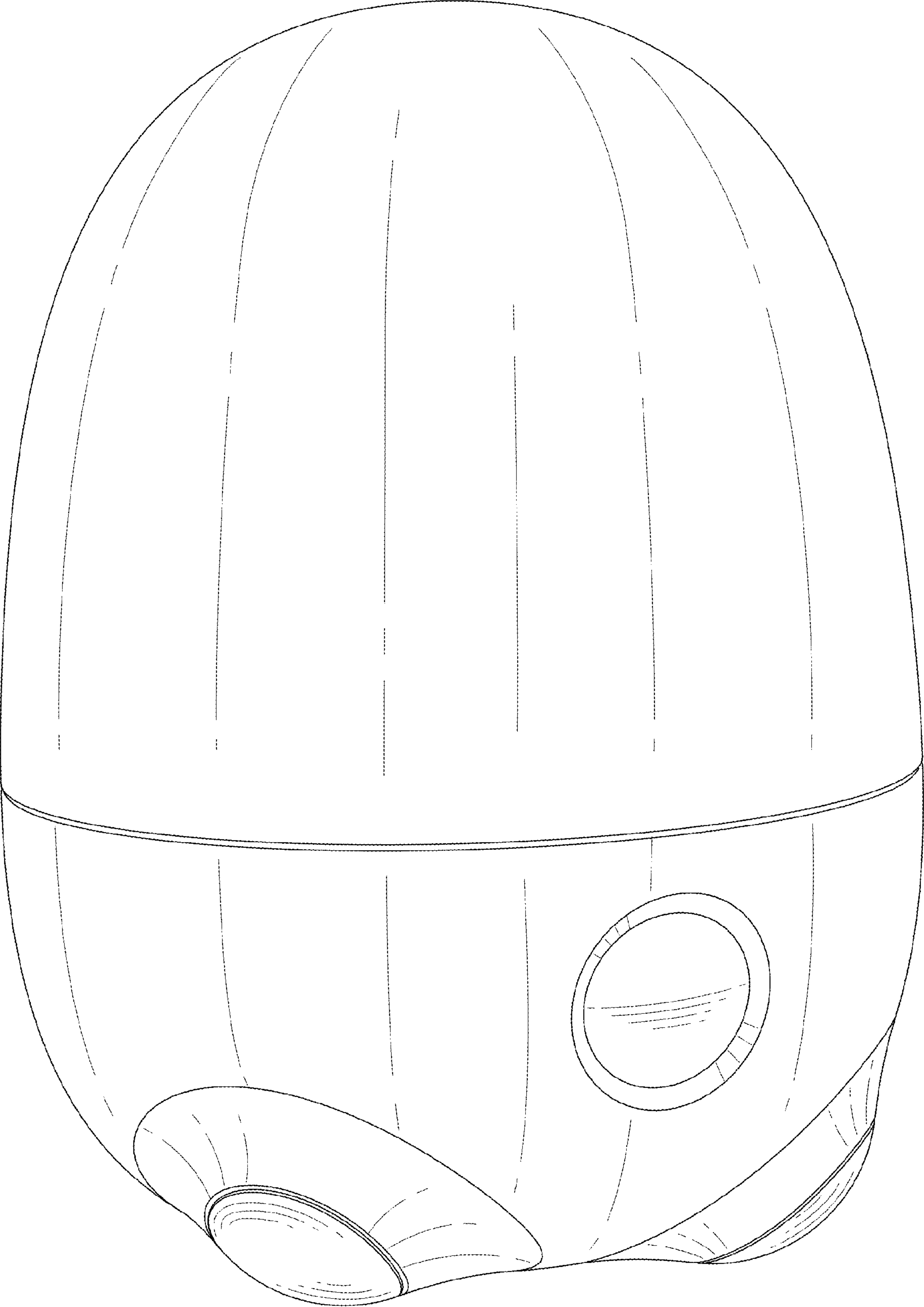

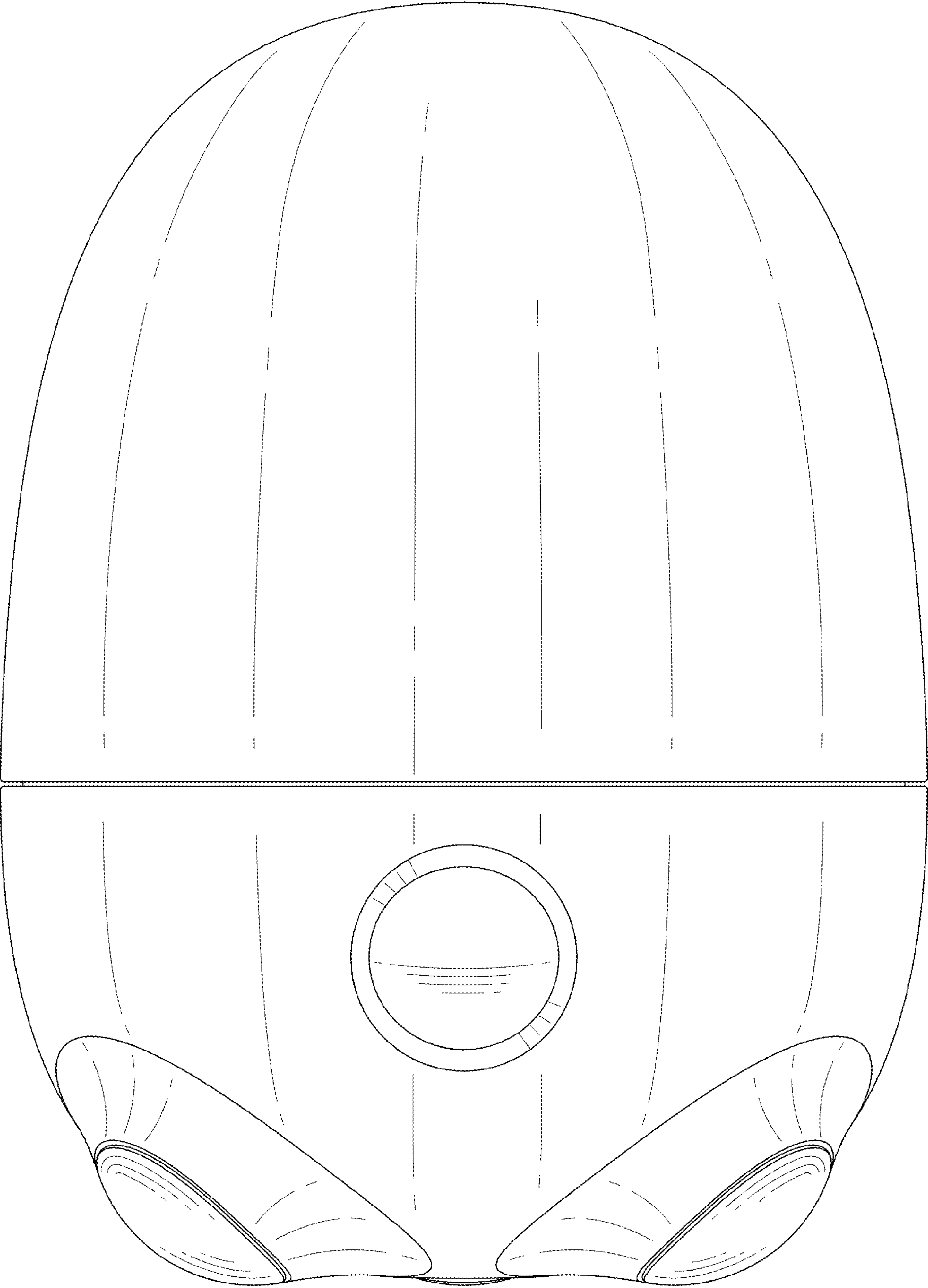

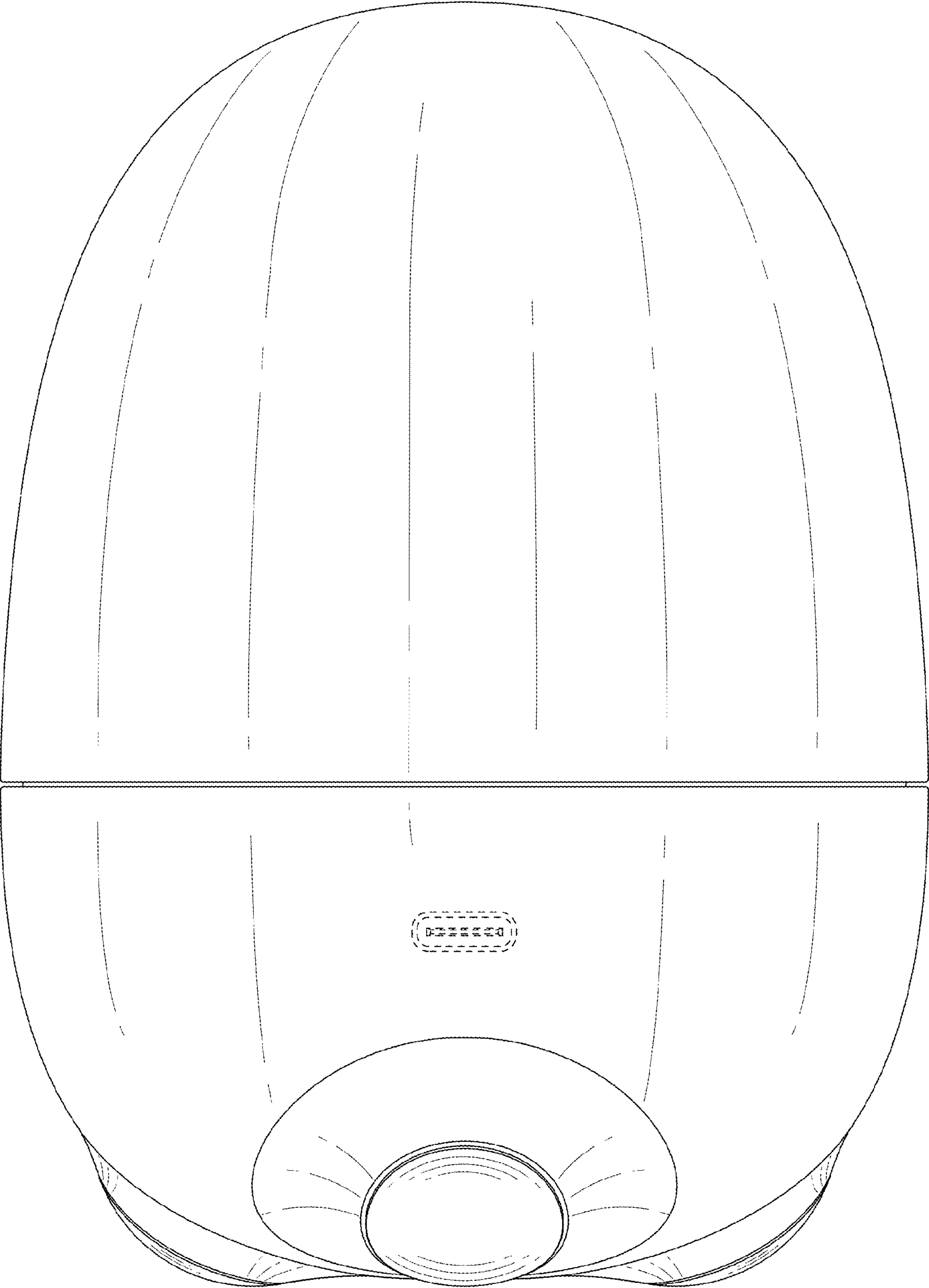

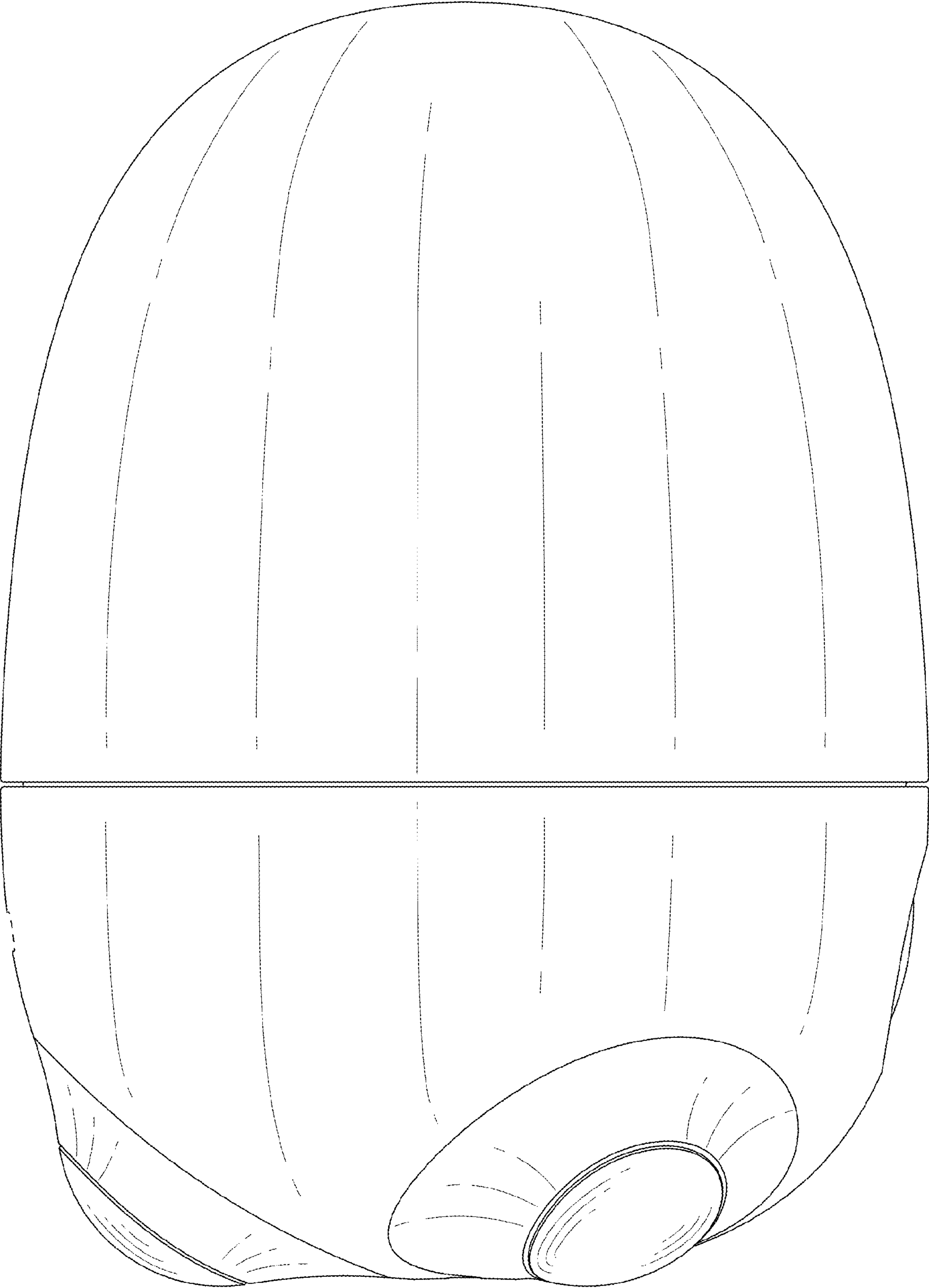

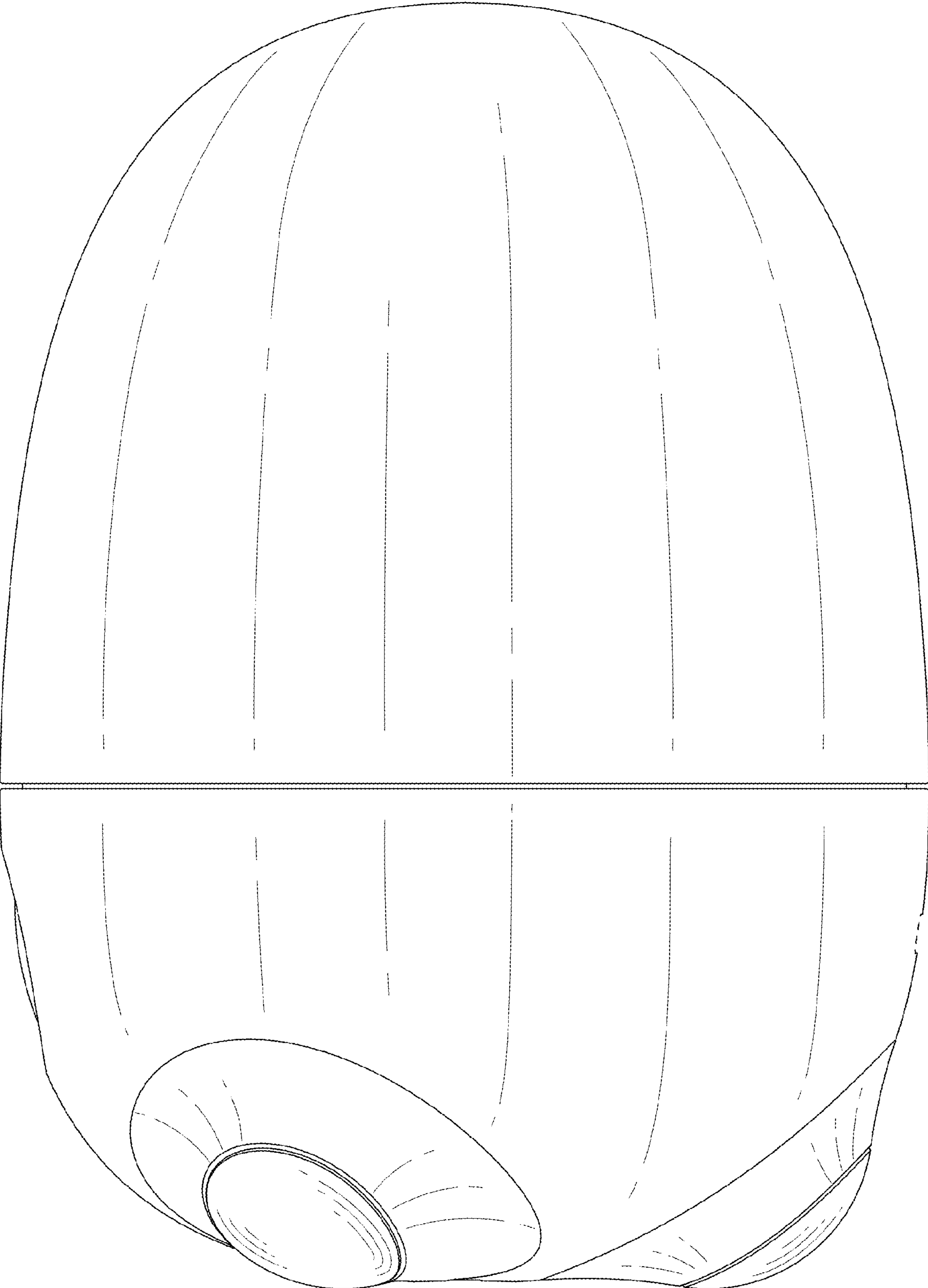

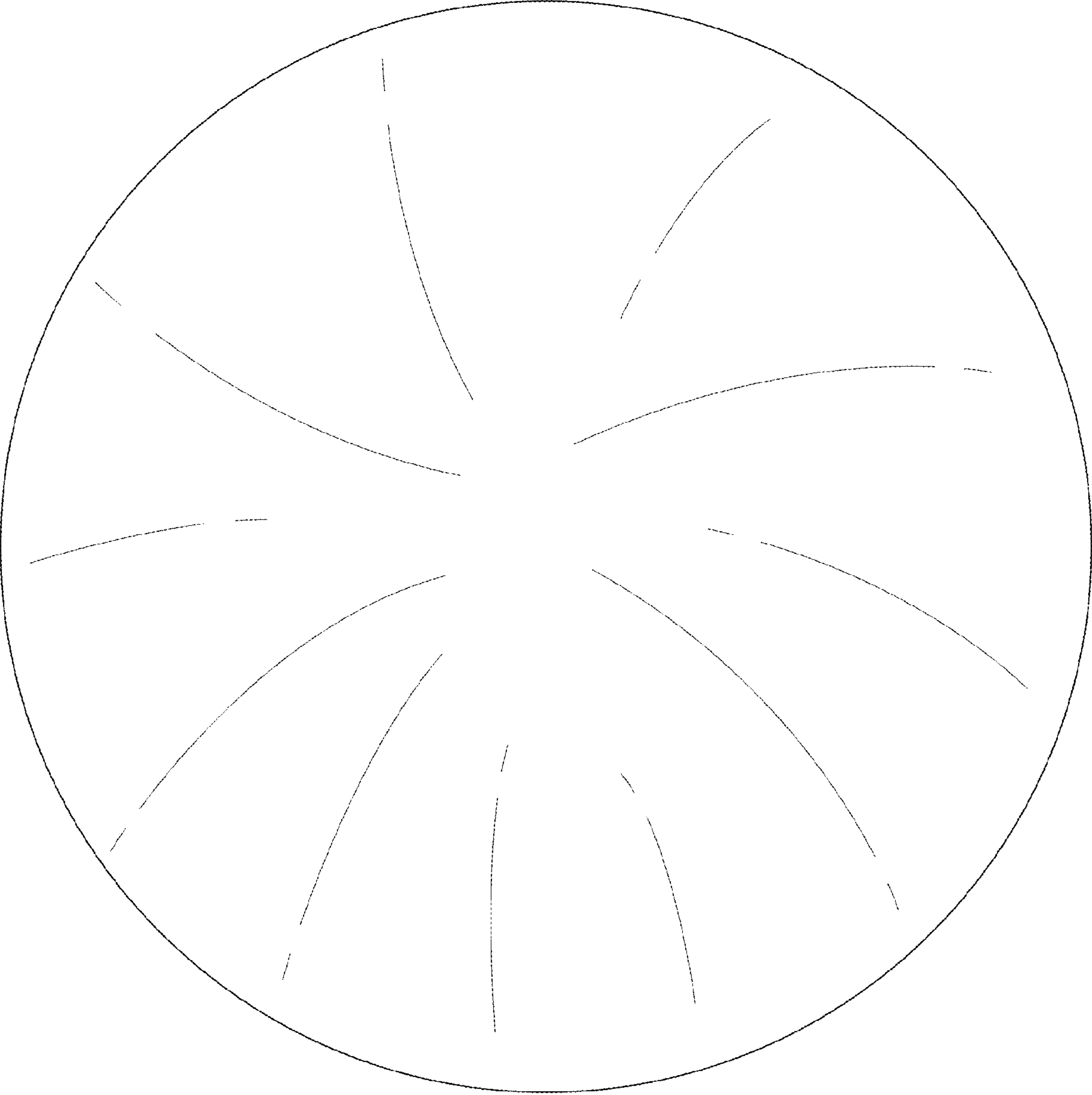

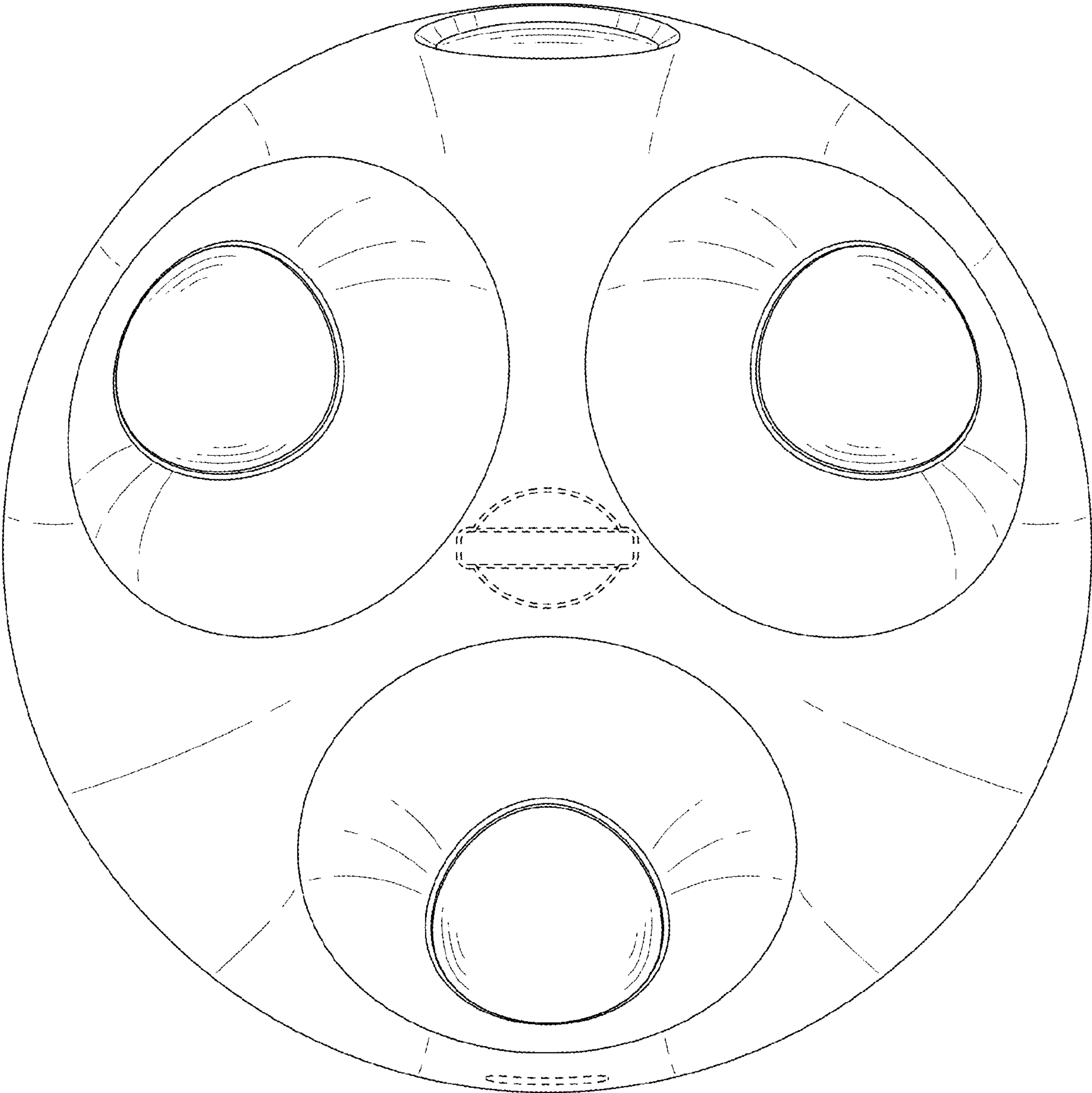

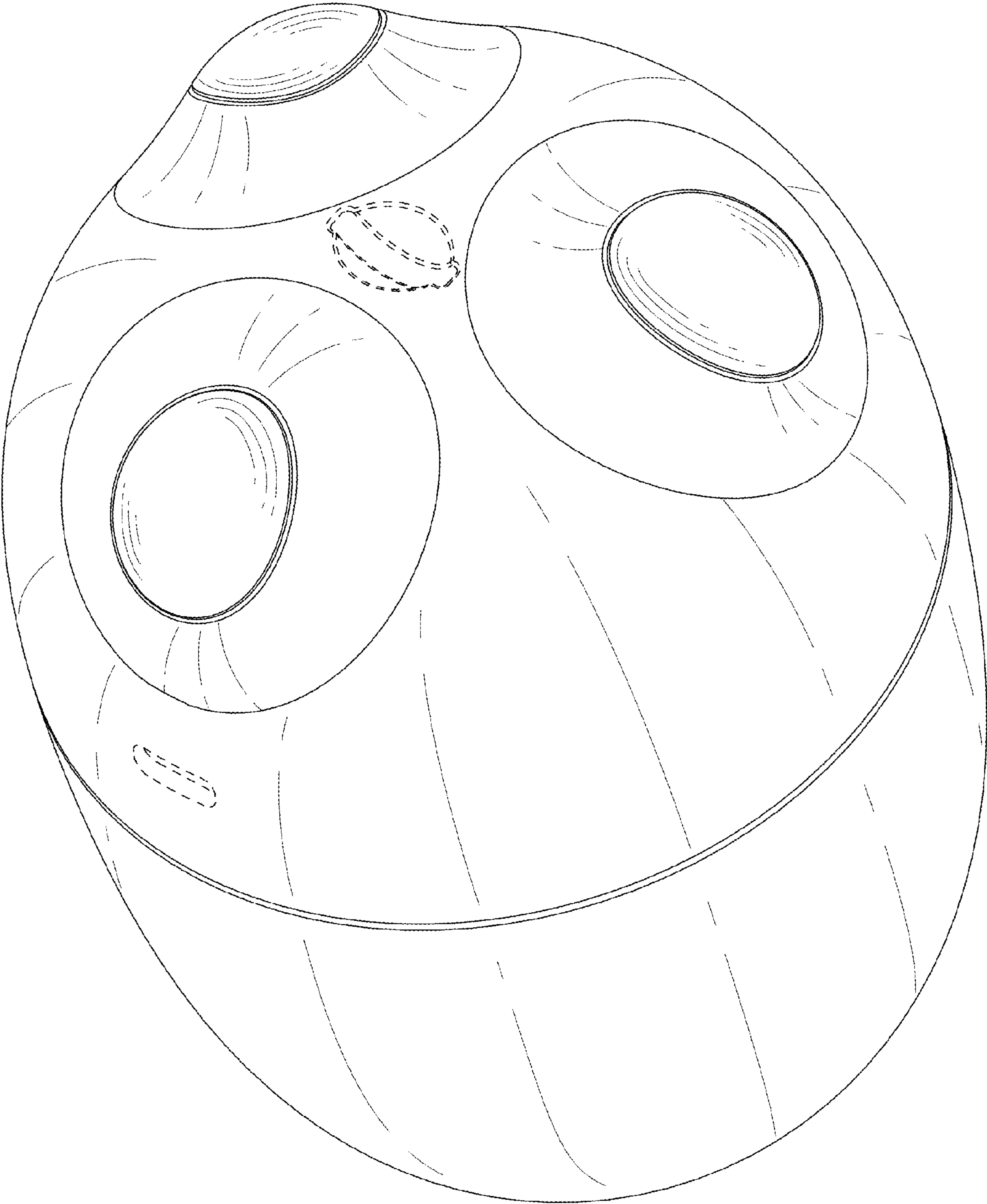
