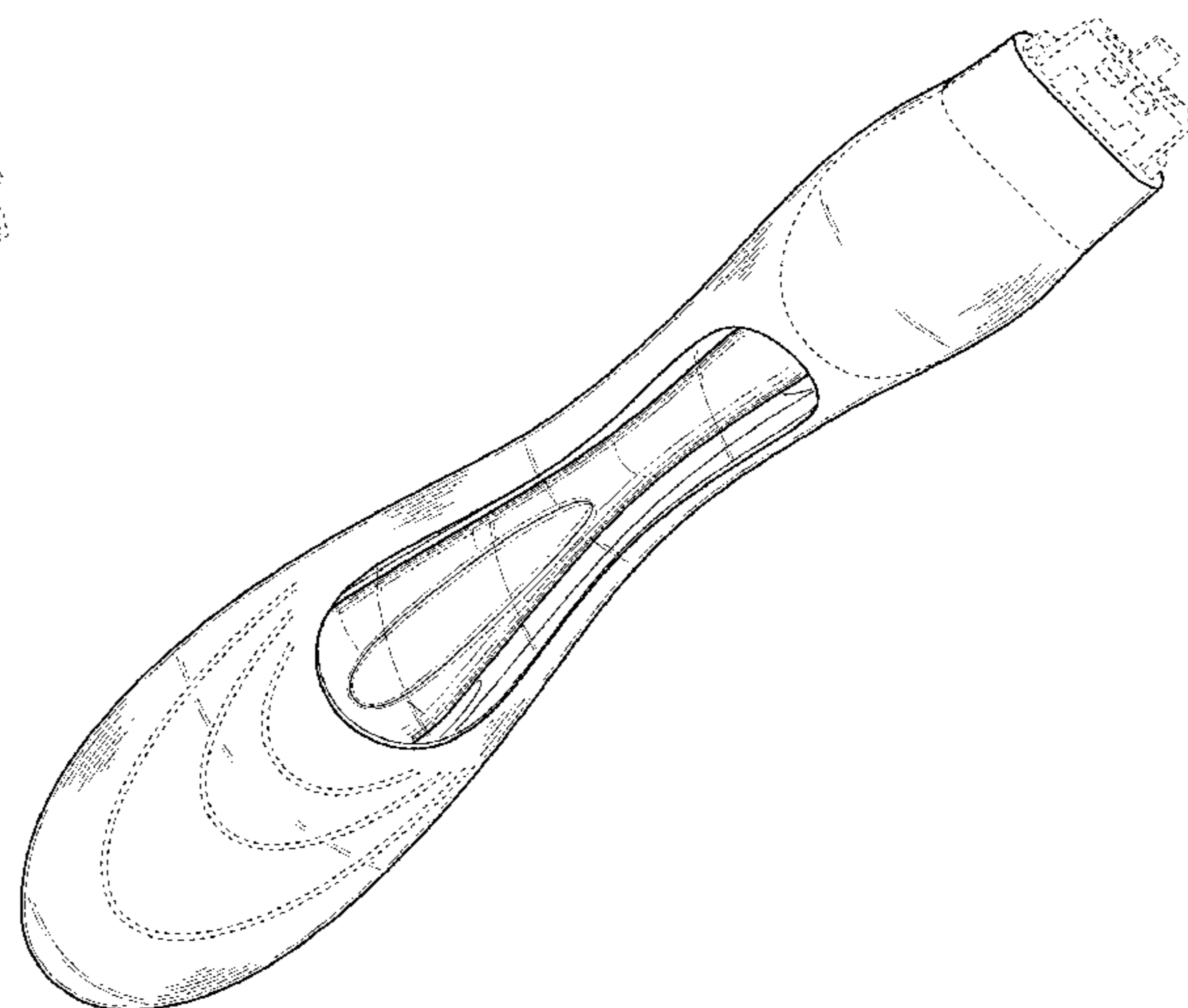
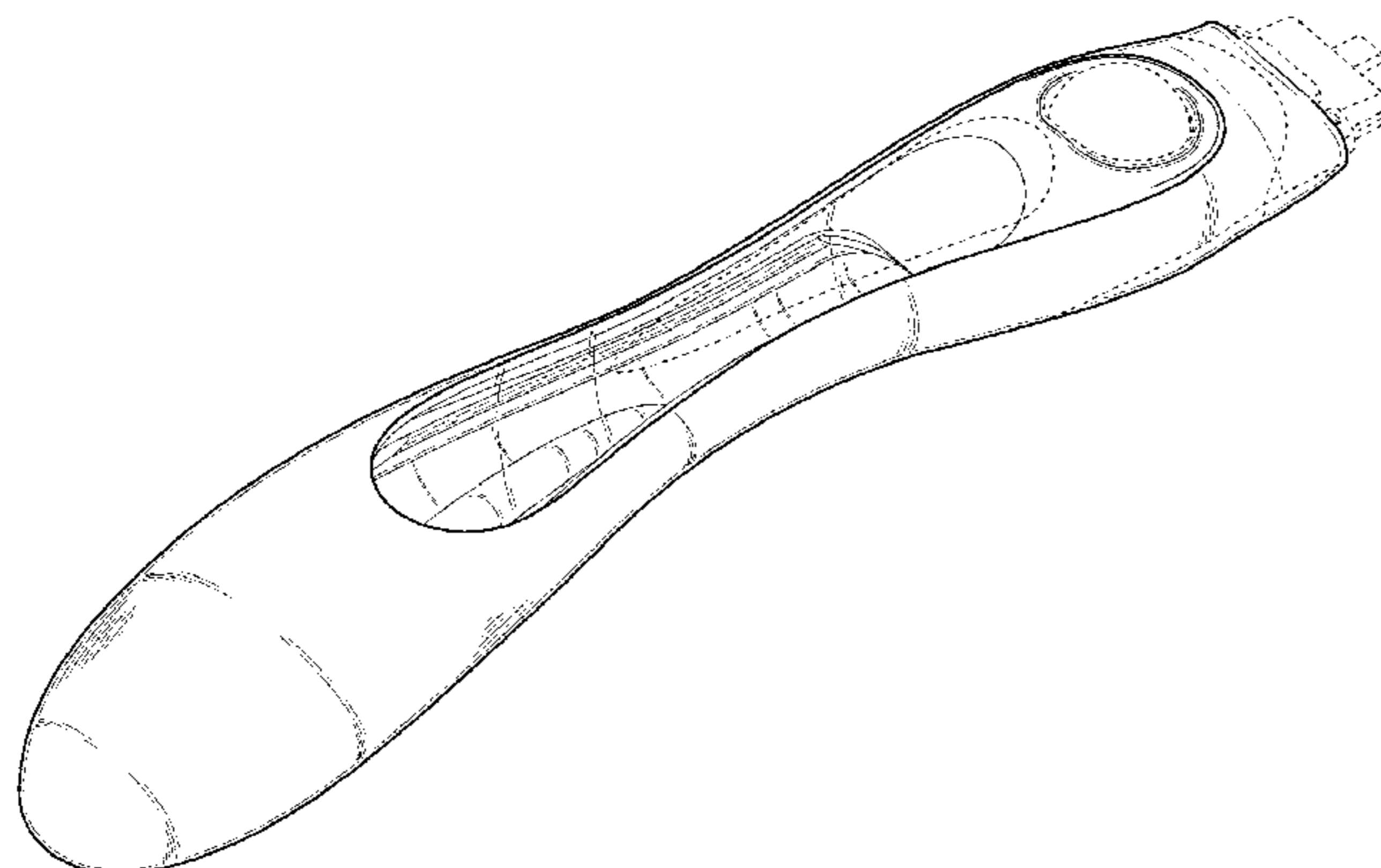
(57) **CLAIM**

We claim the ornamental design for a shaver handle, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of another embodiment of the ornamental design for a shaver handle with at least one translucent member according to the present invention; FIG. 2 is a bottom perspective view thereof; FIG. 3 is an end view thereof; FIG. 4 is the opposite end view thereof; FIG. 5 is a left view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a top view thereof; and, FIG. 8 is a bottom view thereof. The broken lines illustrate portions of the shaver handle and illustrate contour lines that form no part of the claimed design.

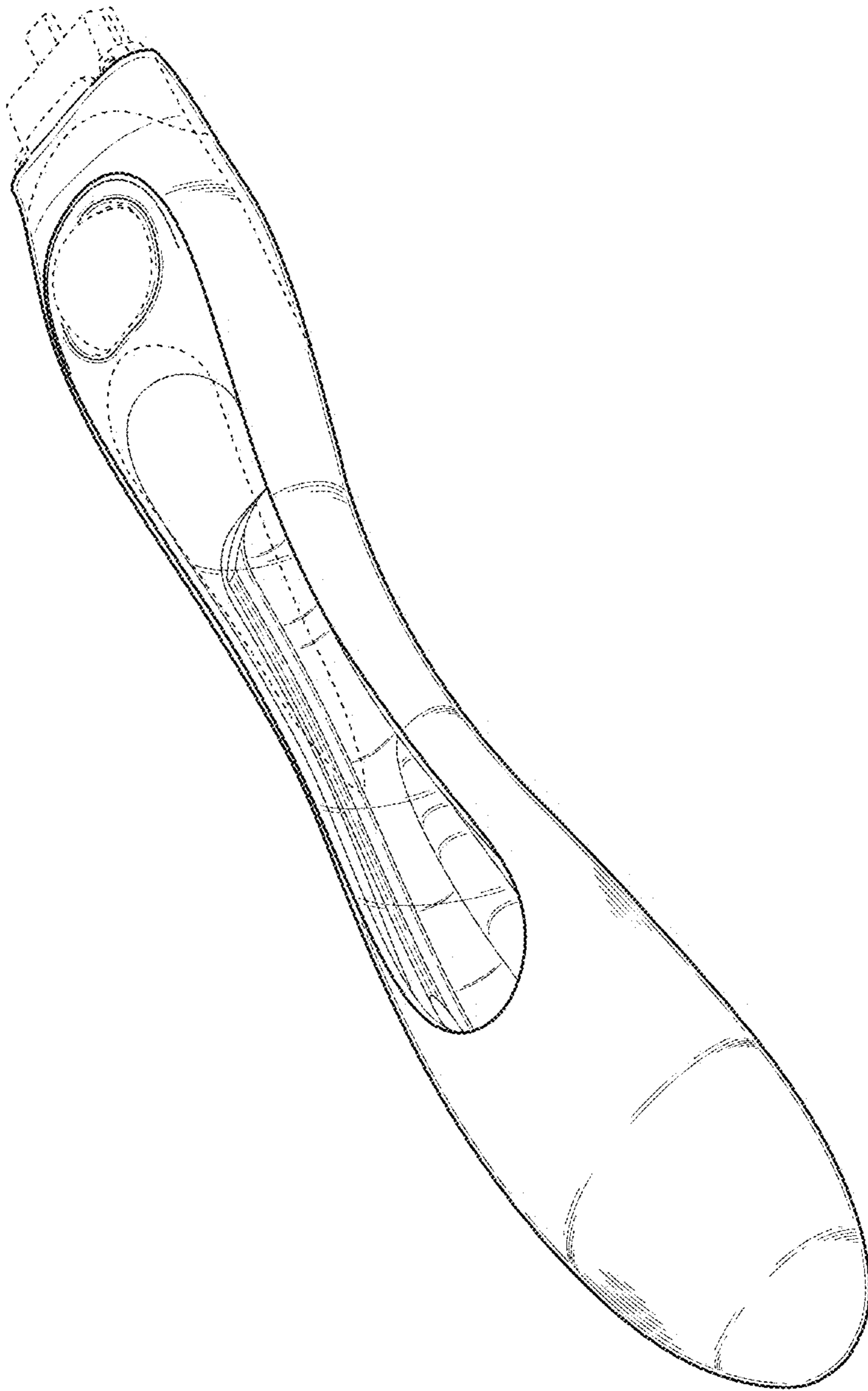

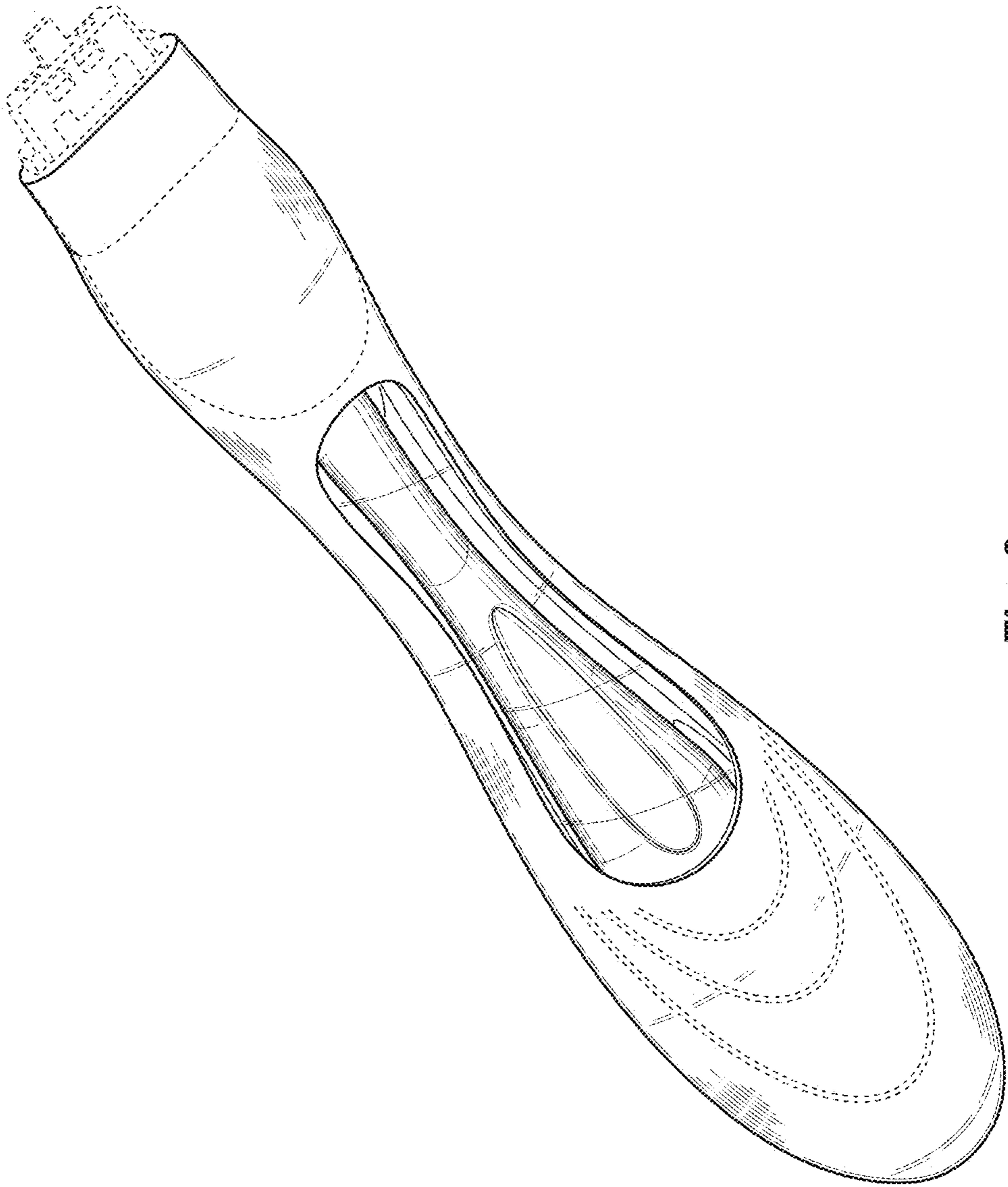

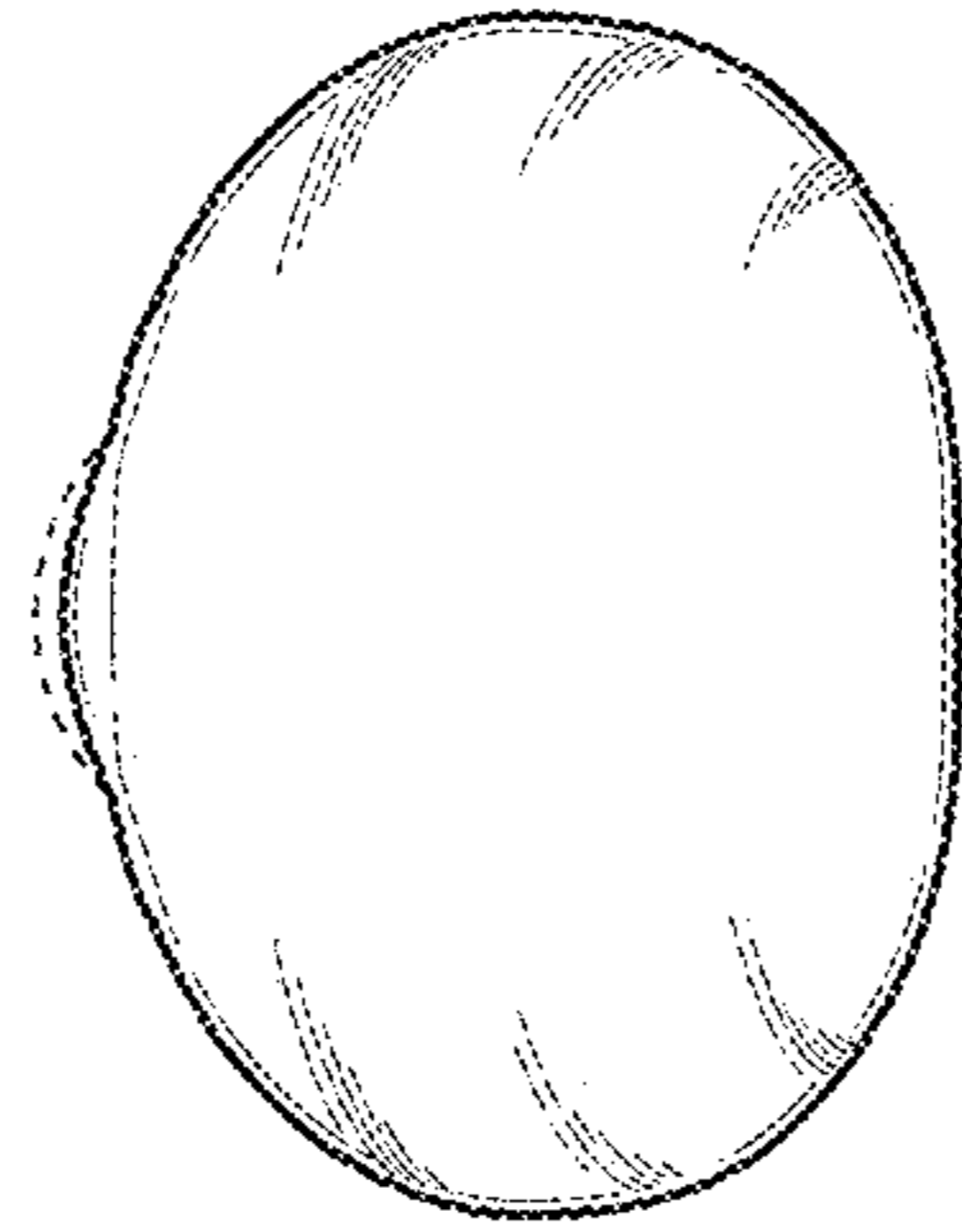

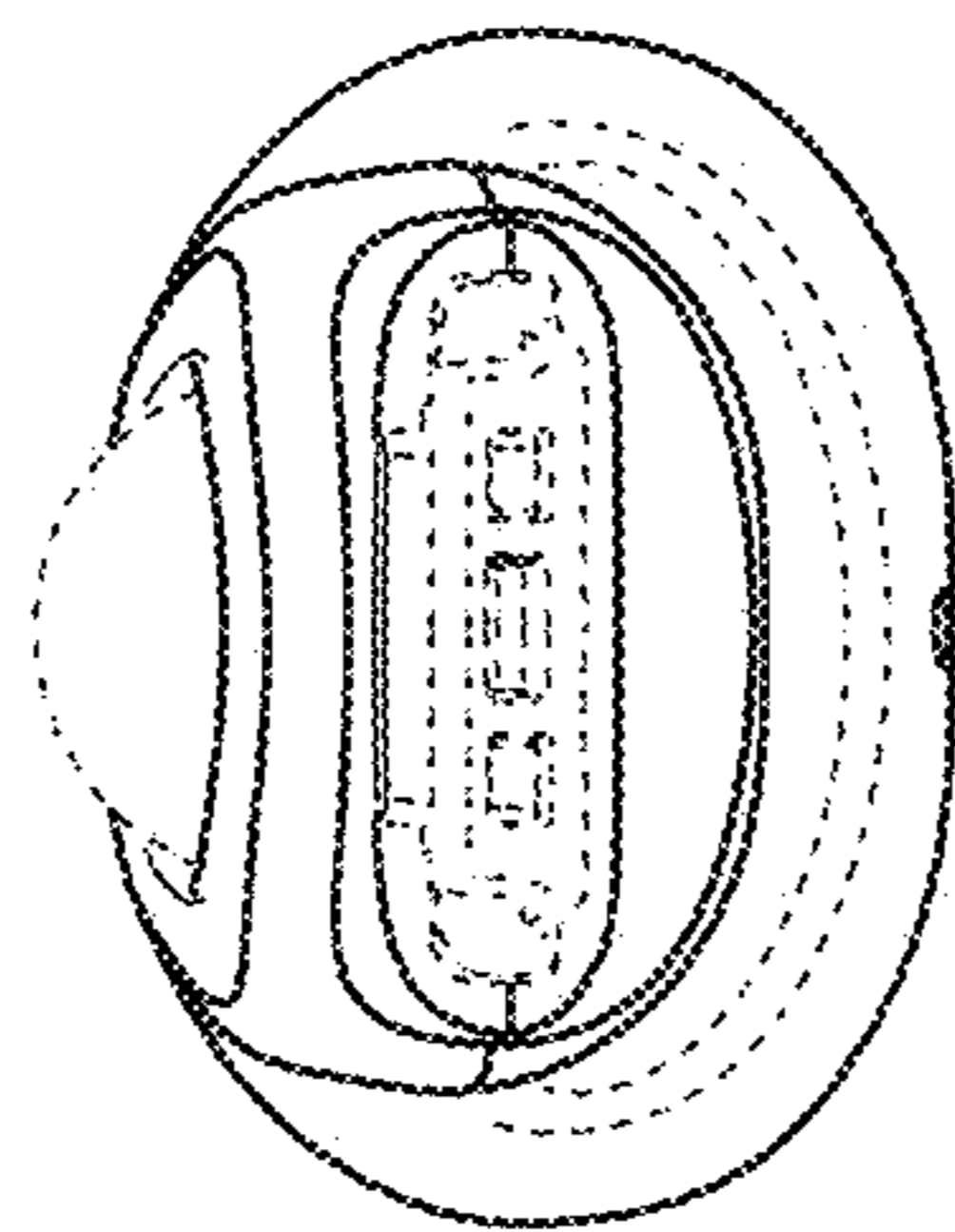

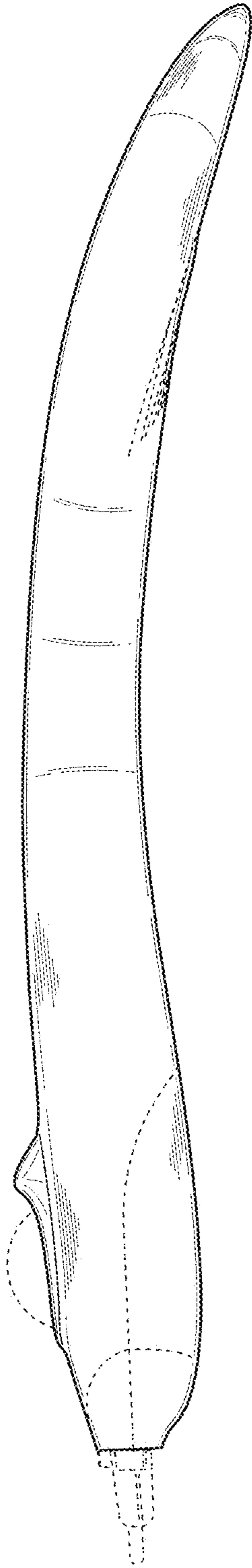

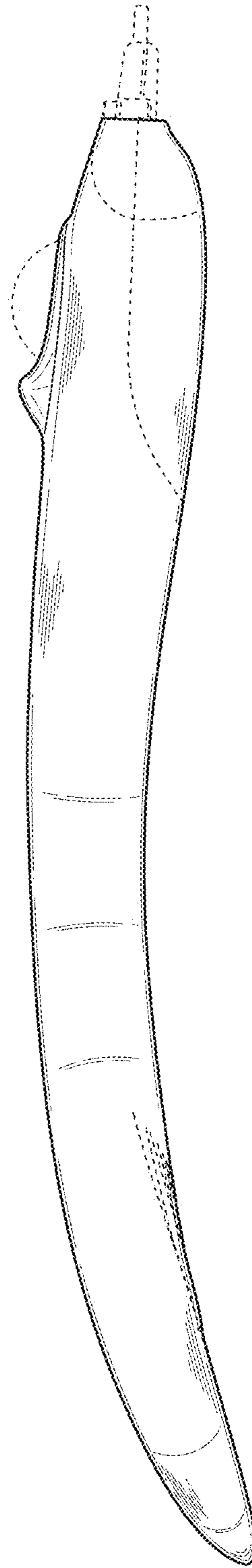

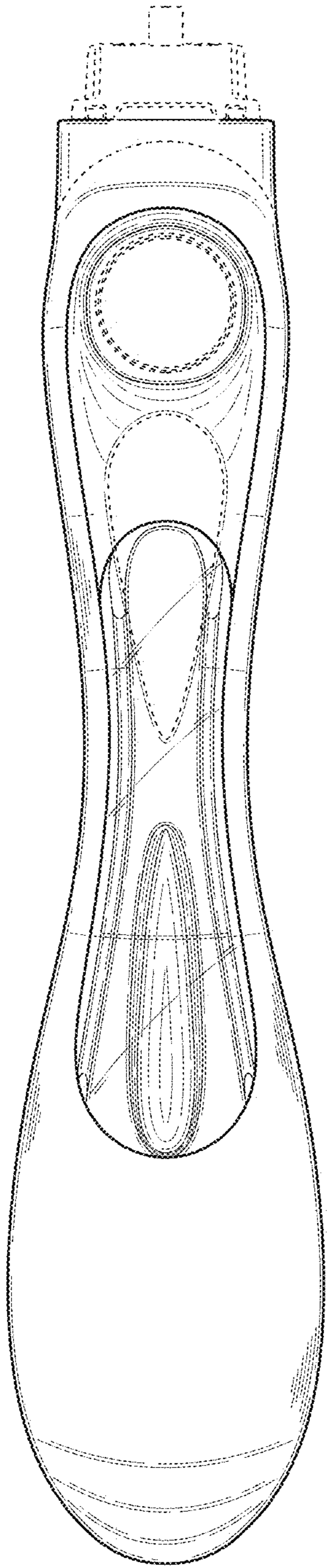

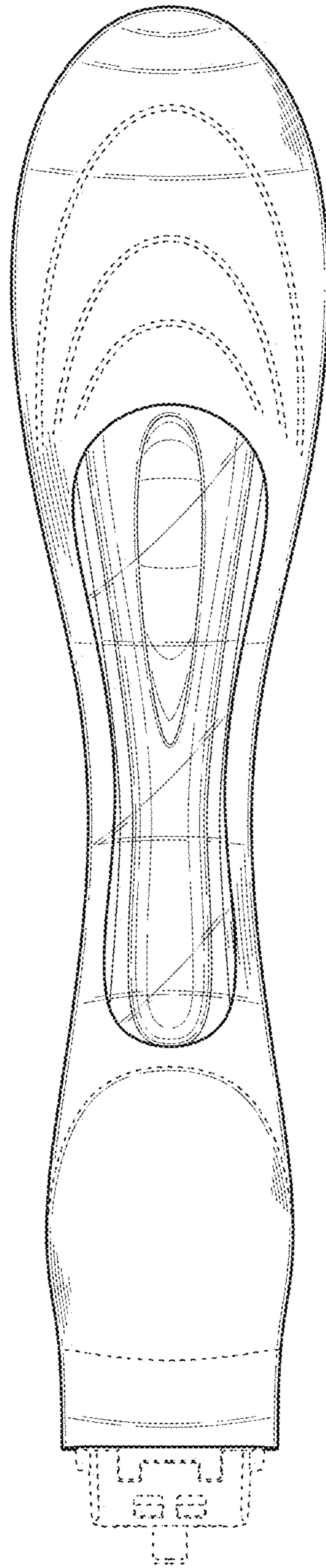
