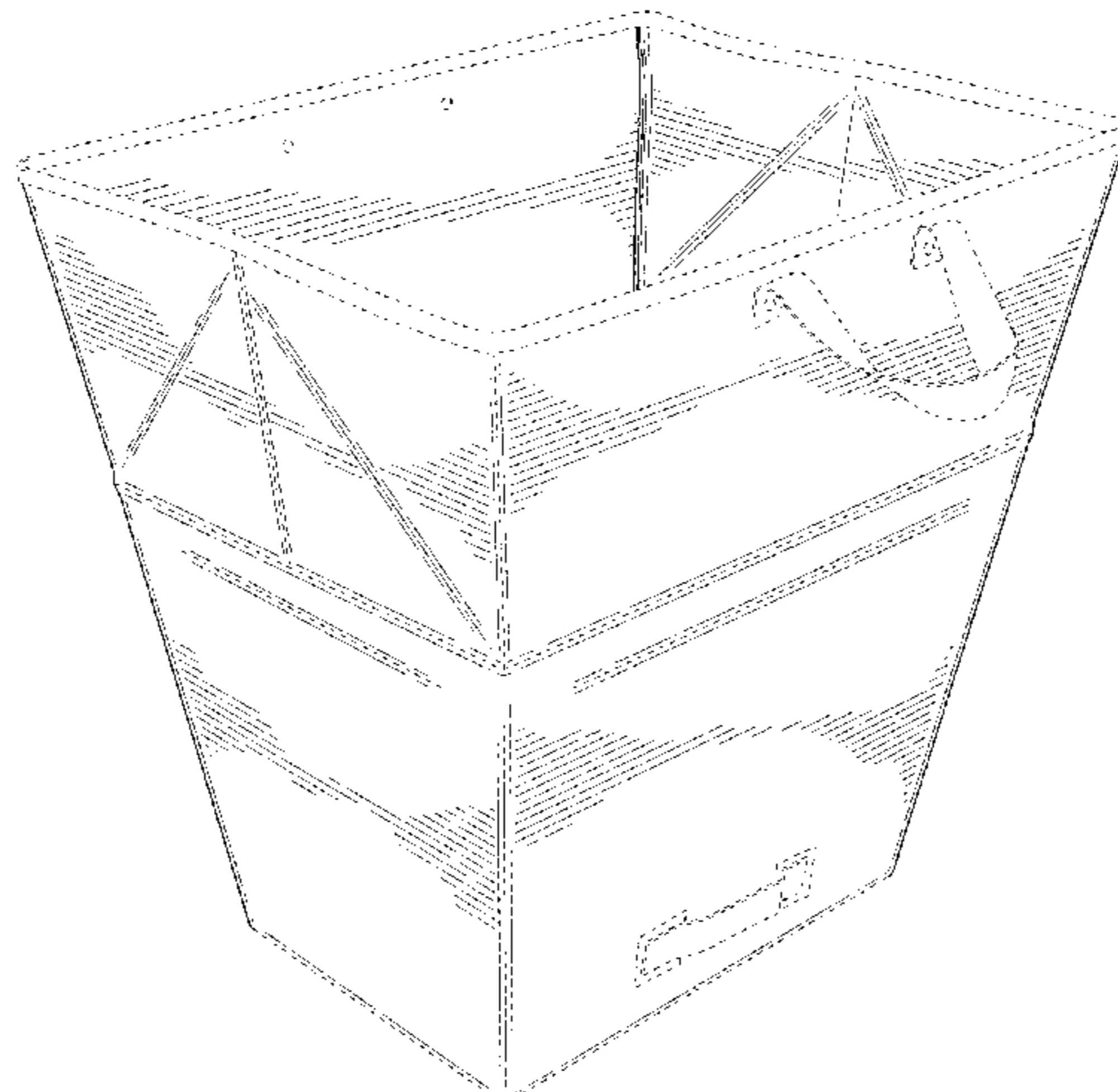
(57) **CLAIM**

The ornamental design for a garment basket, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the garment basket of the present invention, shown in a first configuration; FIG. 2 is a front elevation view of the garment basket of the present invention, shown in the first configuration, the rear elevation view being a mirror image thereof; FIG. 3 is a left-side elevation view of the garment basket of the present invention, shown in the first configuration, the right-side elevation view being a mirror image thereof; FIG. 4 is a top plan view of the garment basket of the present invention, shown in the first configuration; FIG. 5 is a bottom plan view of the garment basket of the present invention, shown in the first configuration; FIG. 6 is a front perspective view of the garment basket of the present invention, shown in a second configuration; FIG. 7 is a front elevation view of the garment basket of the present invention, shown in the second configuration, the rear elevation view being a mirror image thereof; FIG. 8 is a left-side elevation view of the garment basket of the present invention, shown in the second configuration, the right-side elevation view being a mirror image thereof; FIG. 9 is a top plan view of the garment basket of the present invention, shown in the second configuration; and, FIG. 10 is a bottom plan view of the garment basket of the present invention, shown in the second configuration. The portions of the garment basket shown in broken lines form no part of the claimed design.

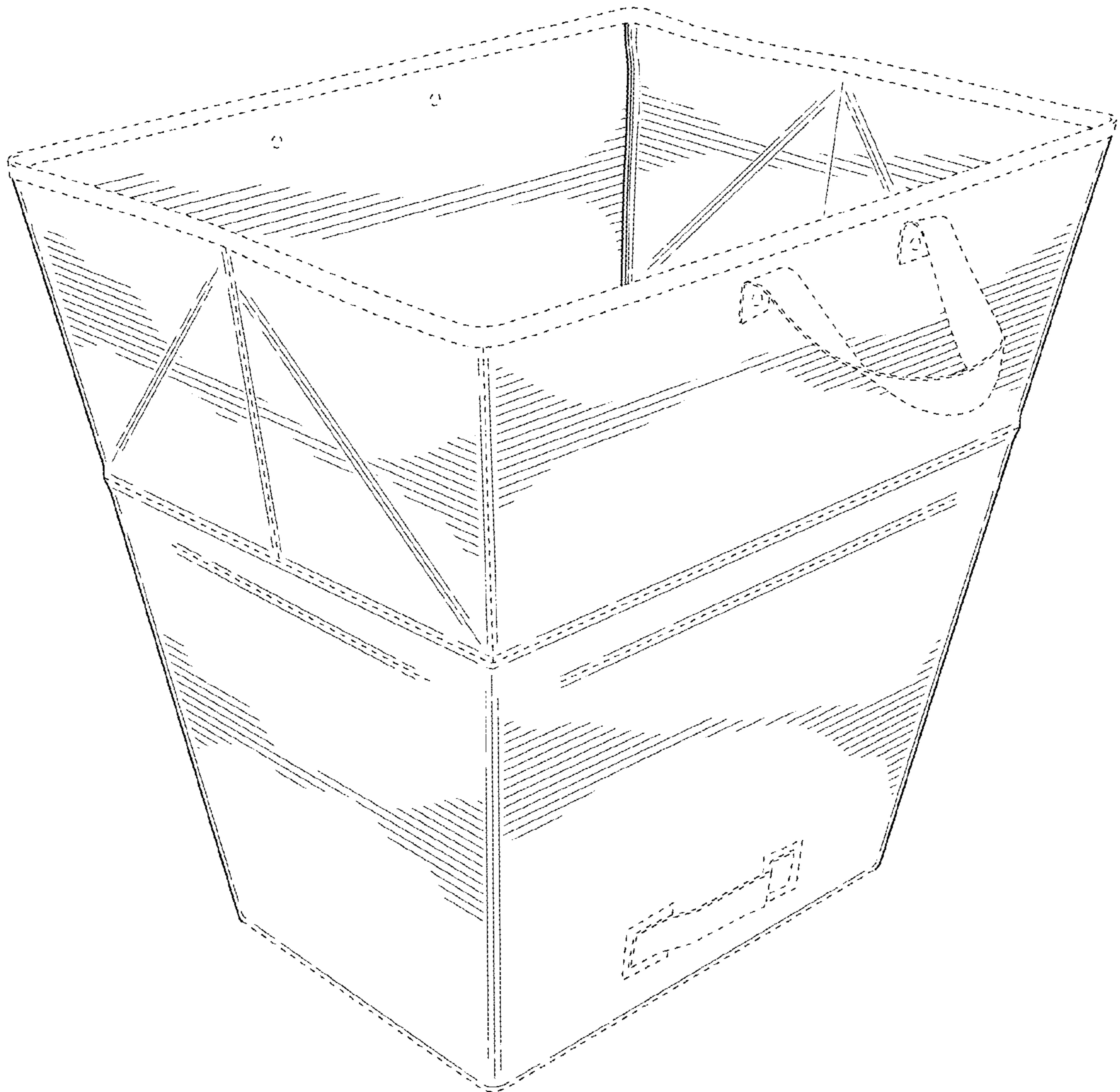

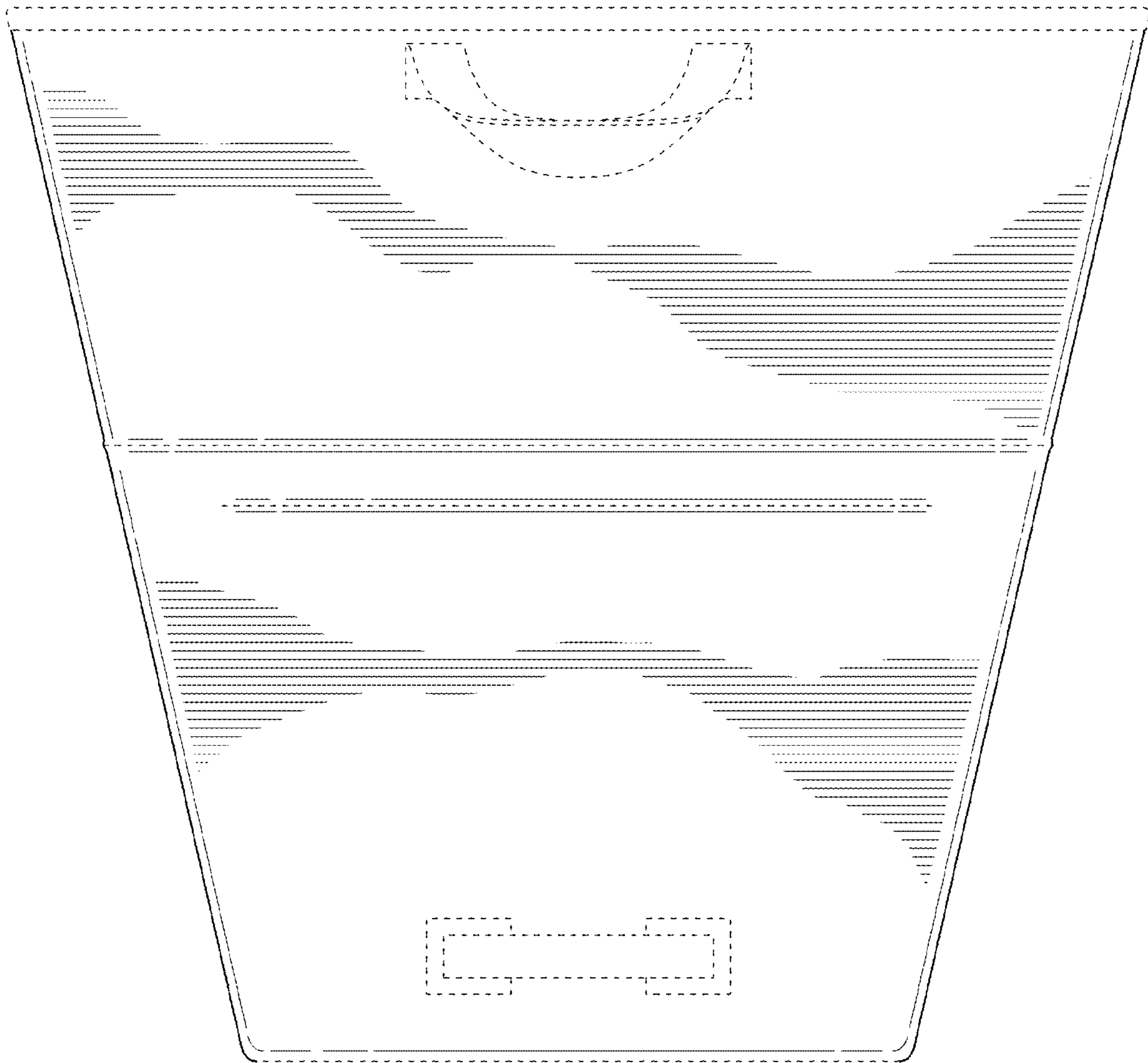

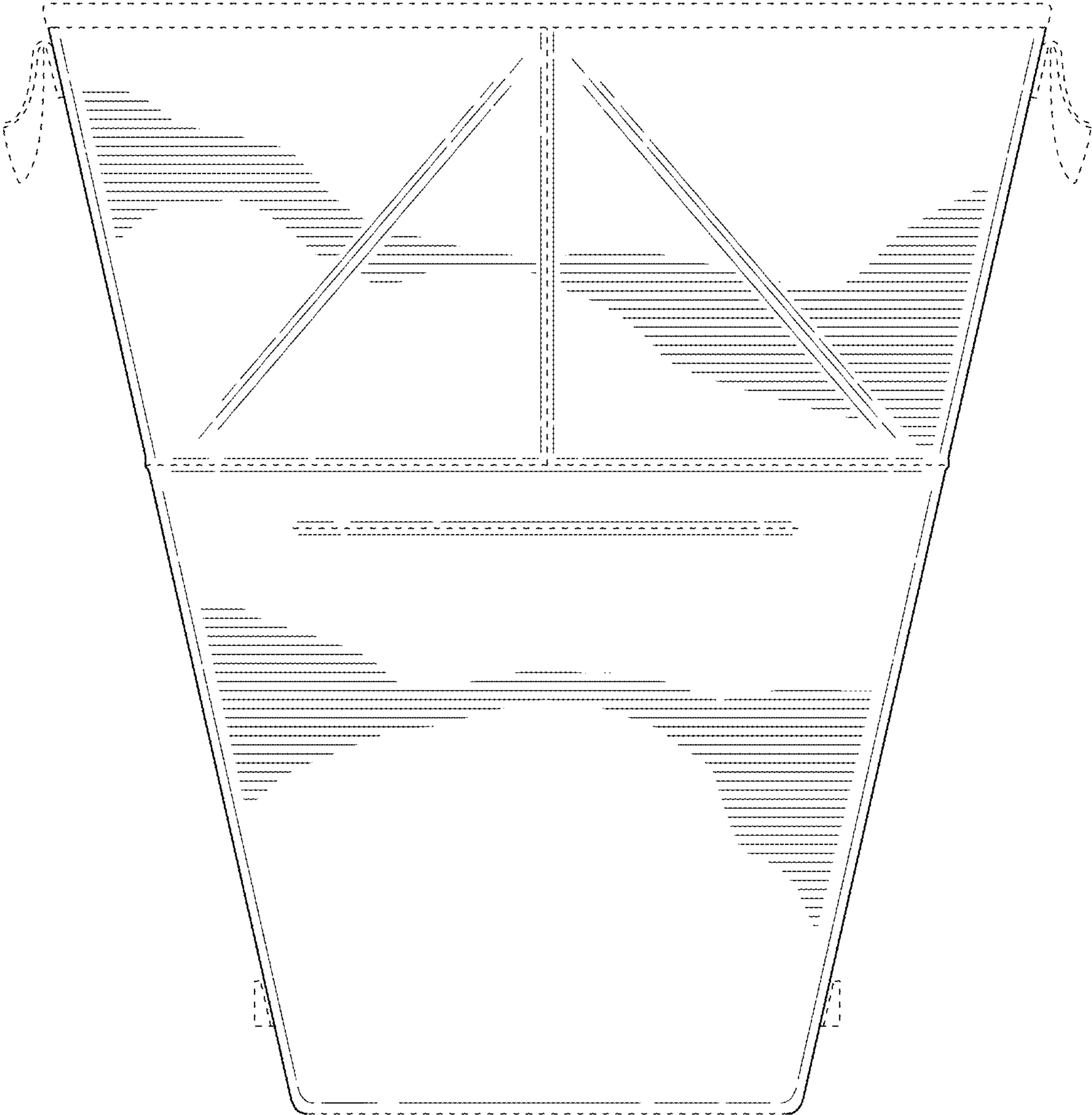

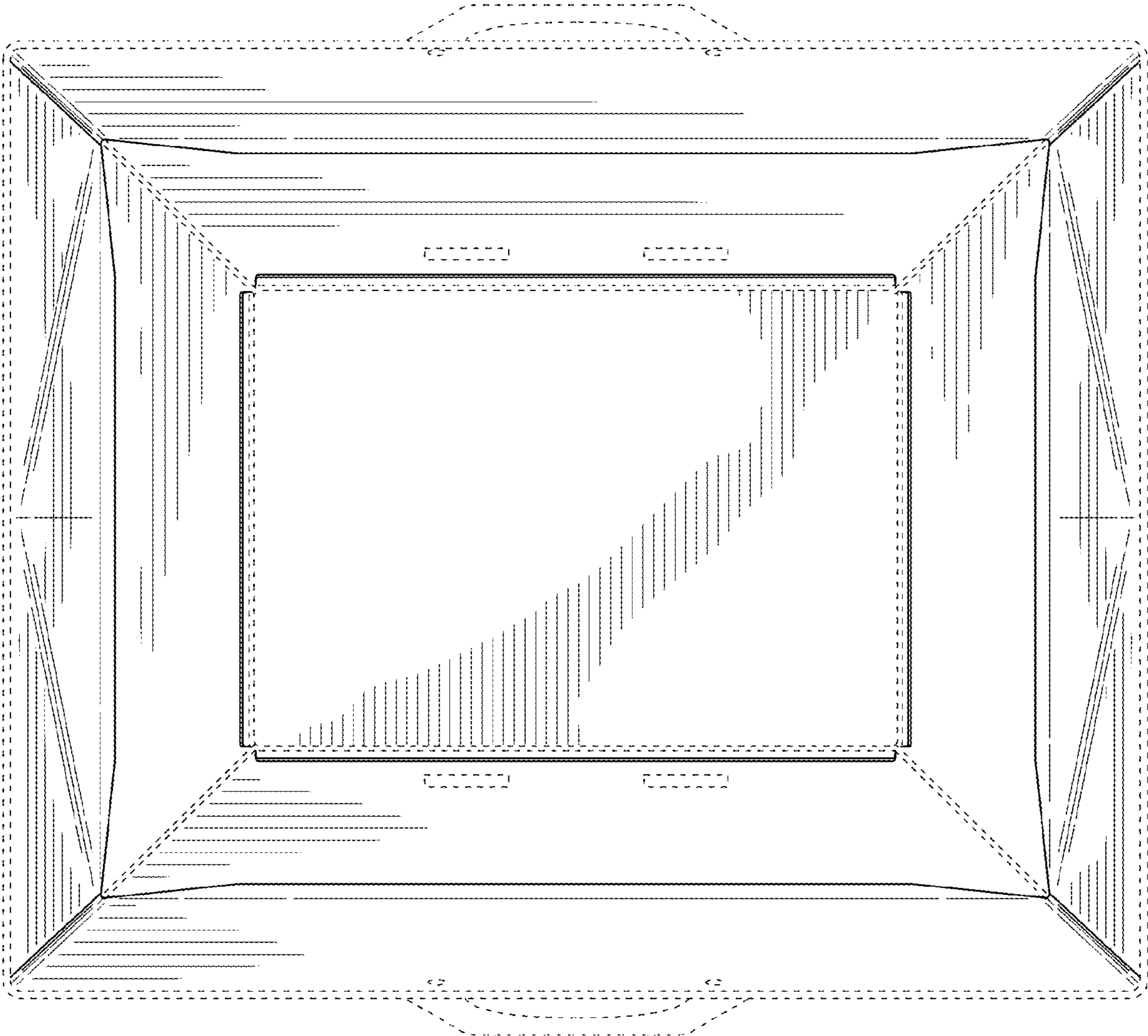

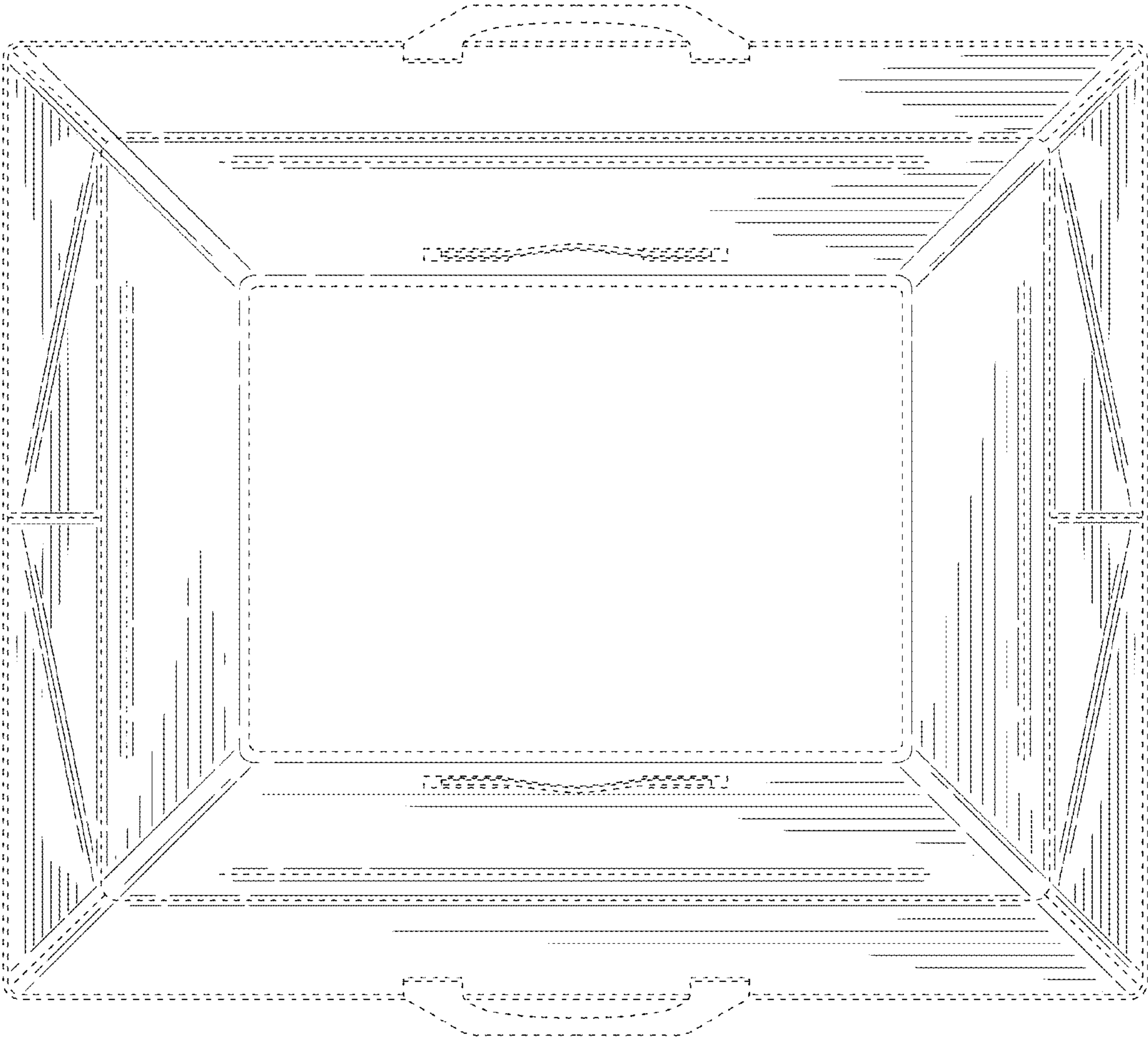

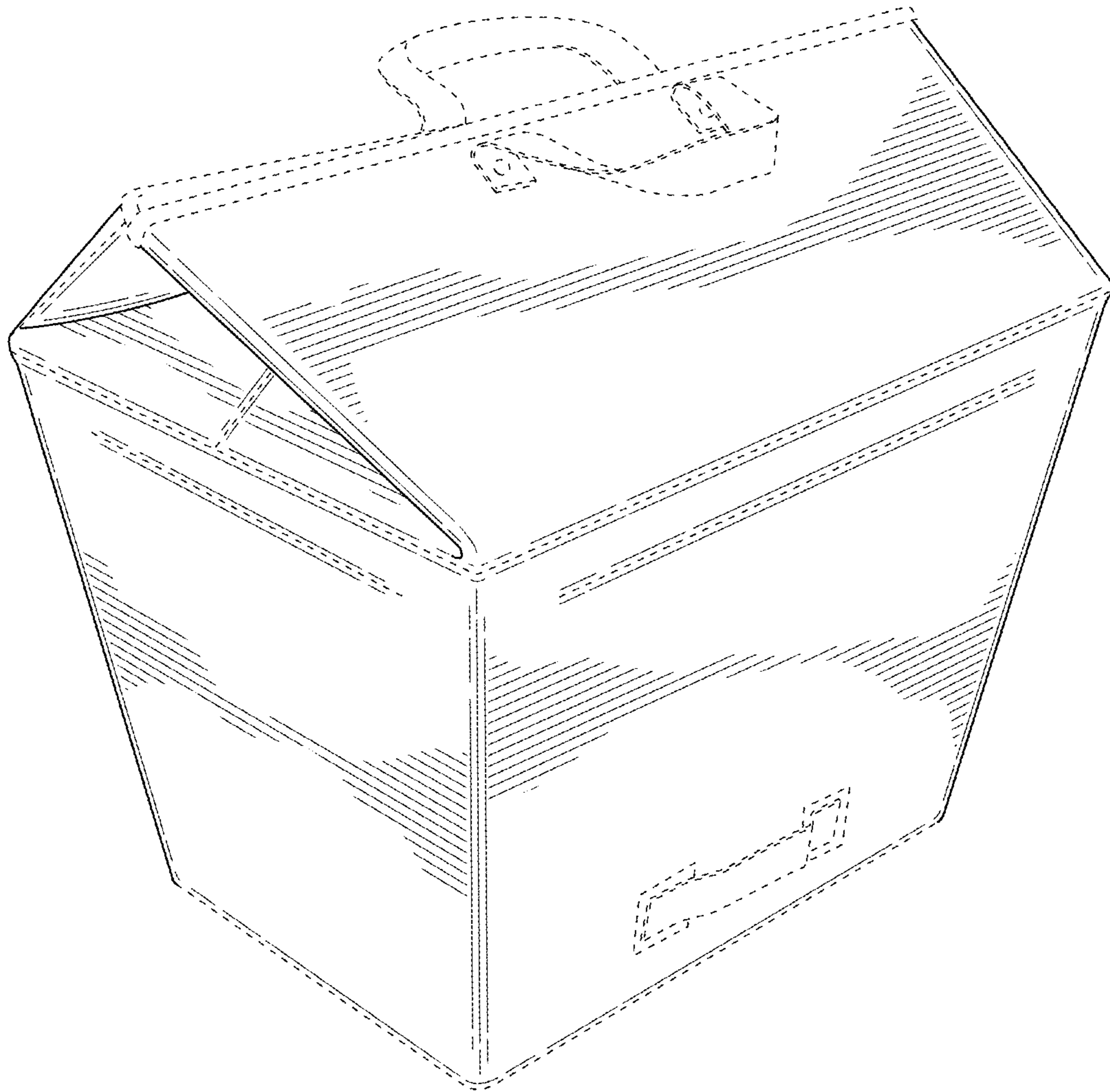

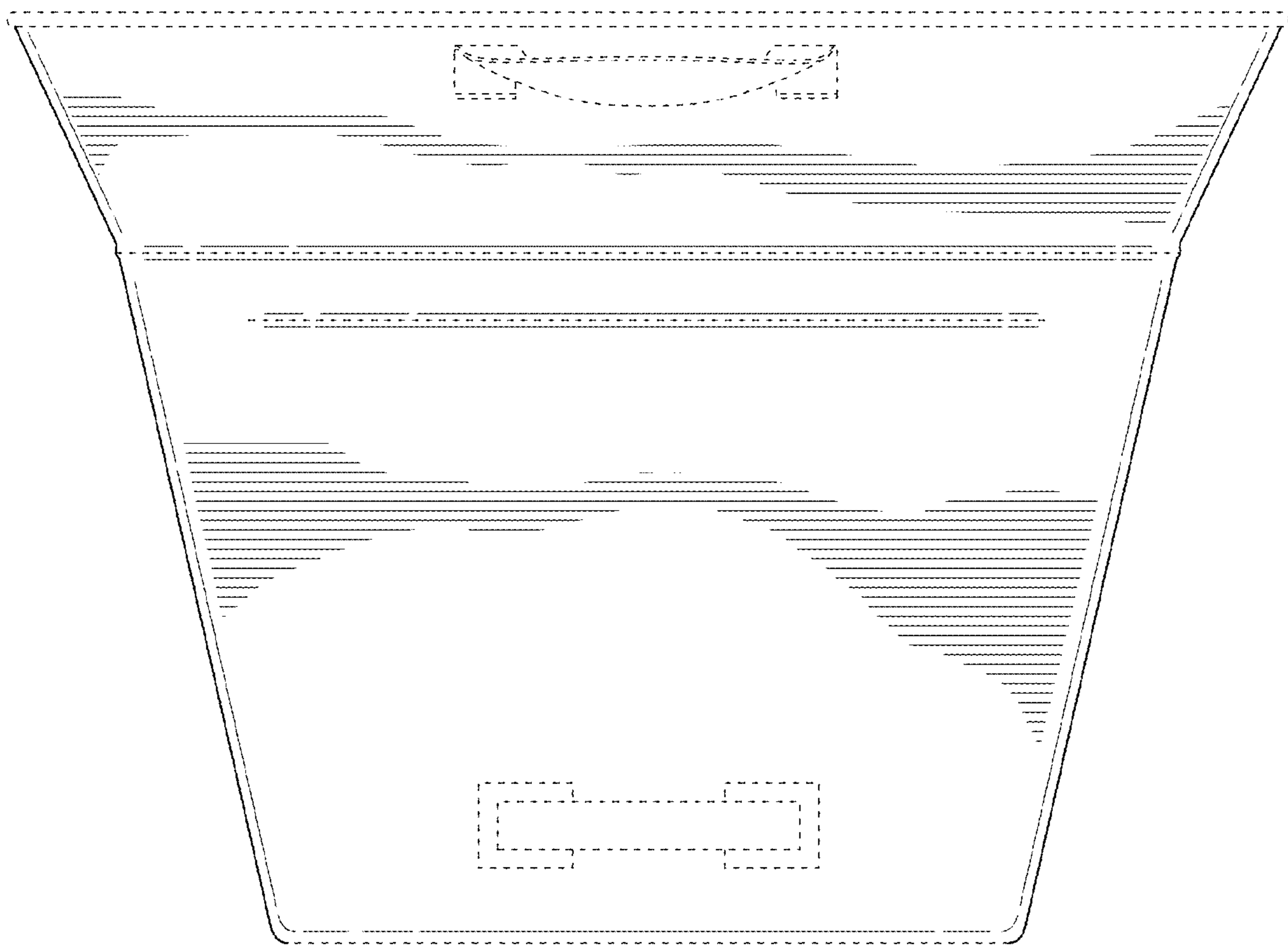

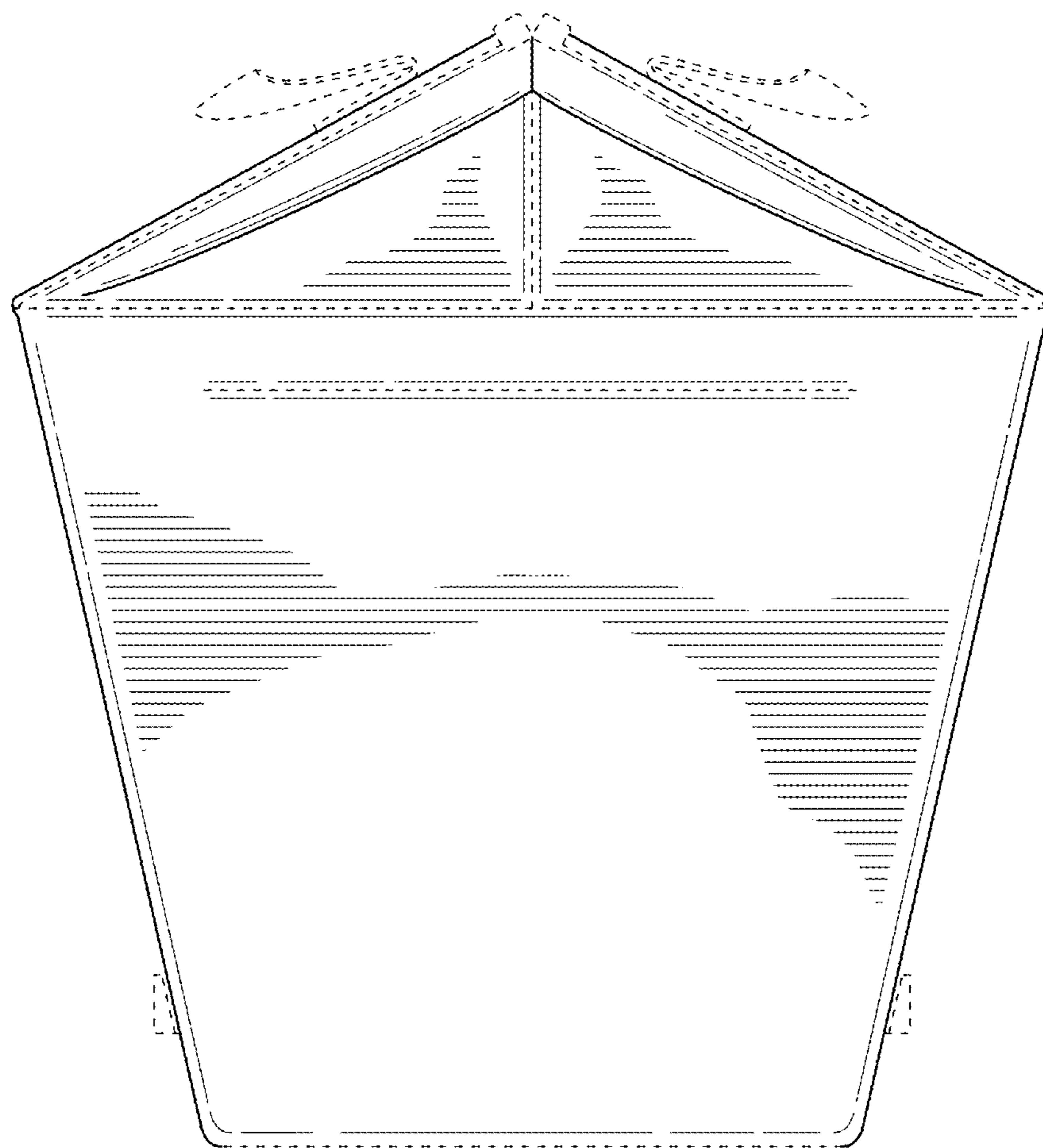

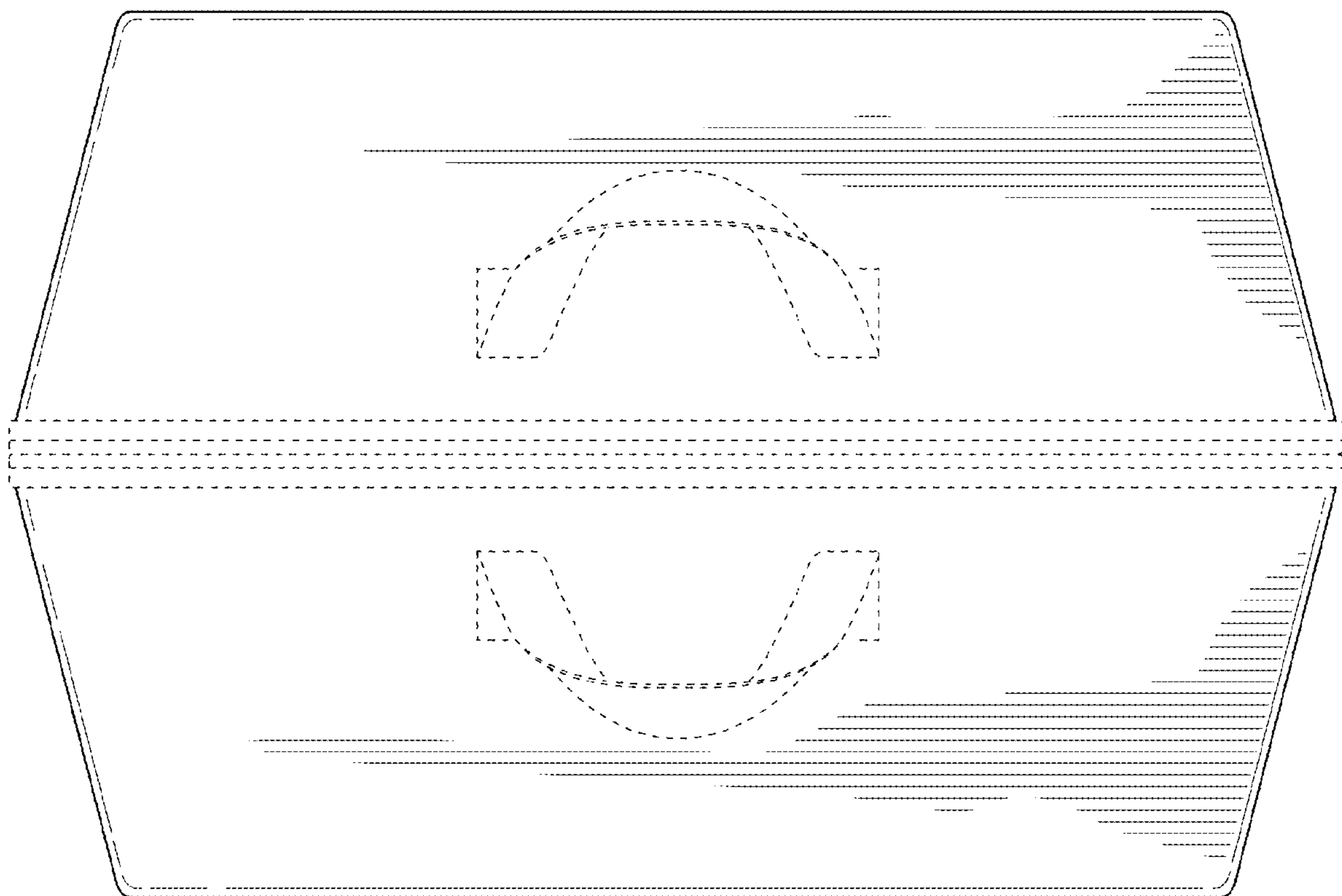

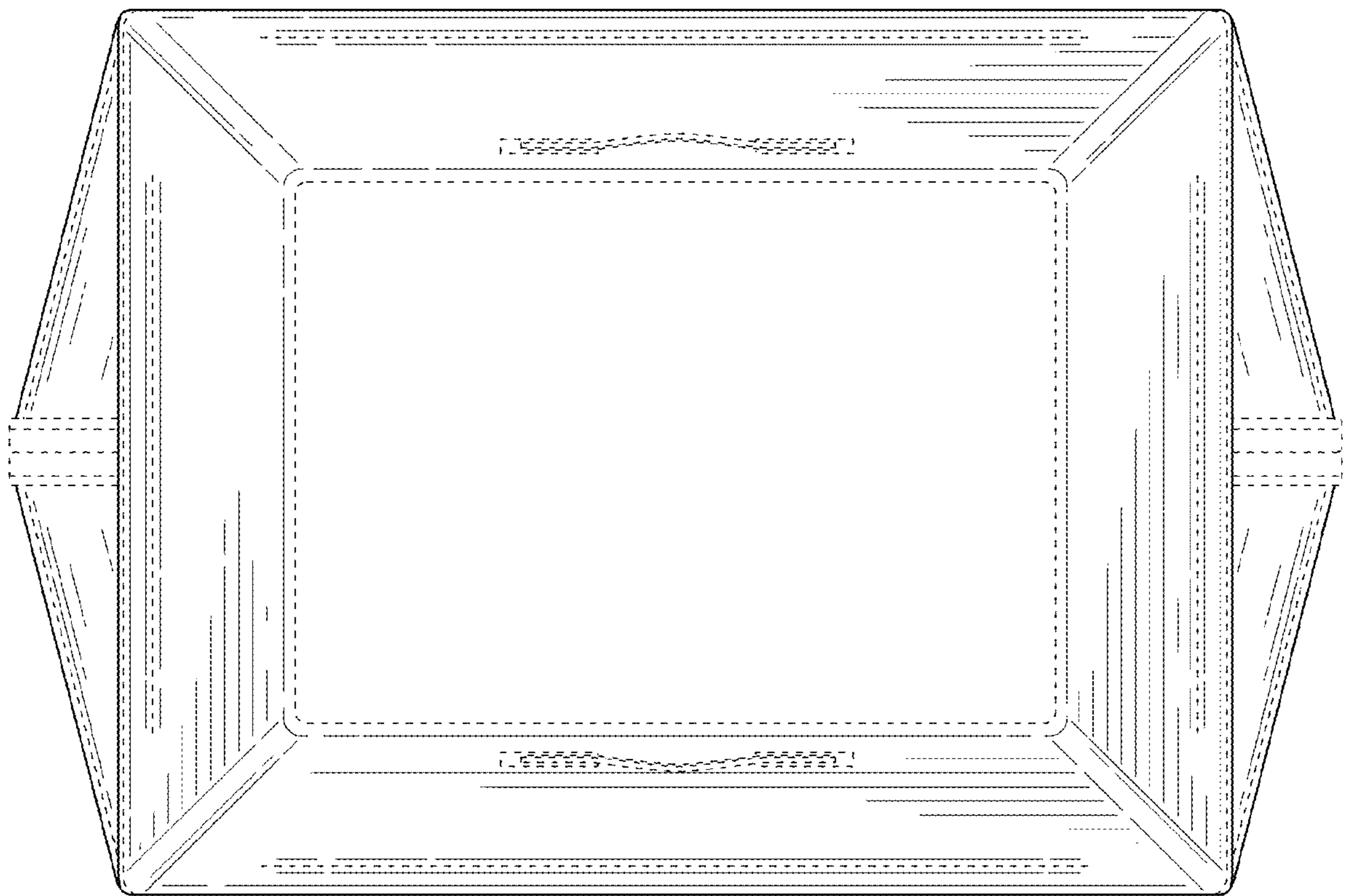
