(57) **CLAIM**

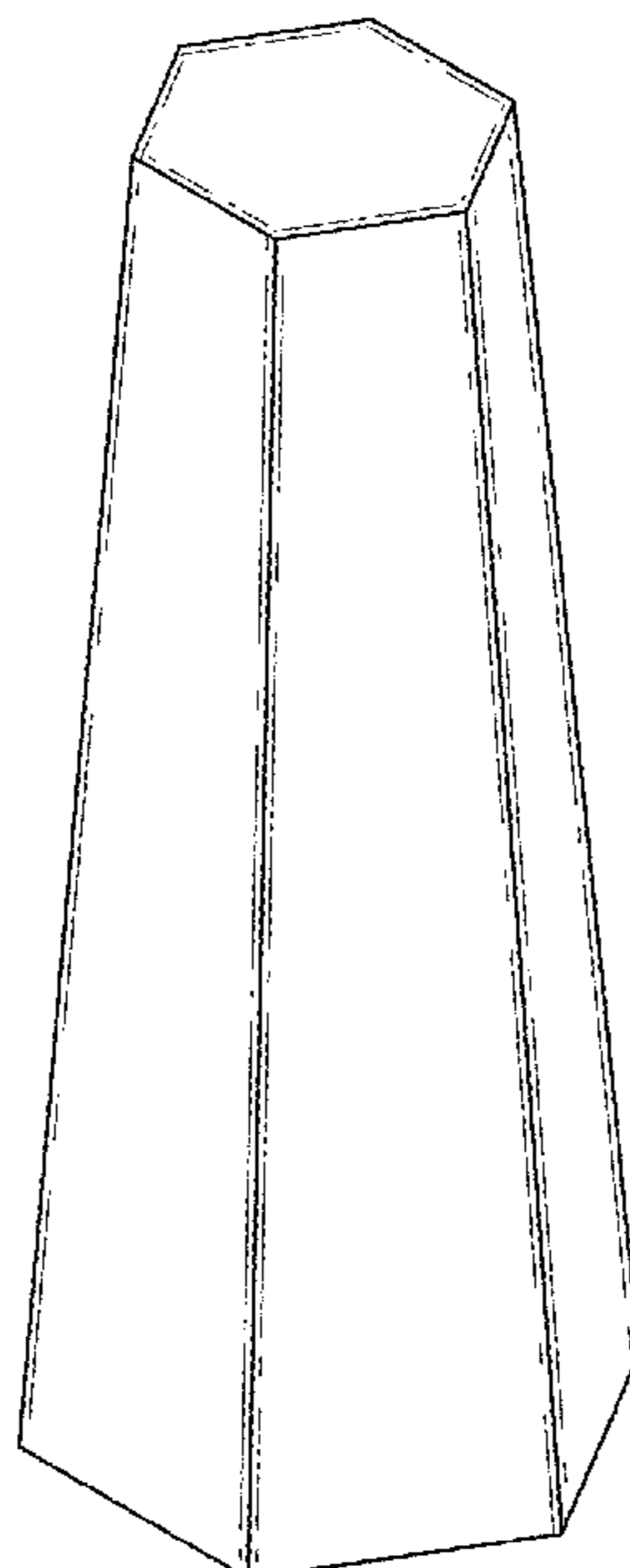
We claim the ornamental design for a candy, as shown and described.

DESCRIPTION

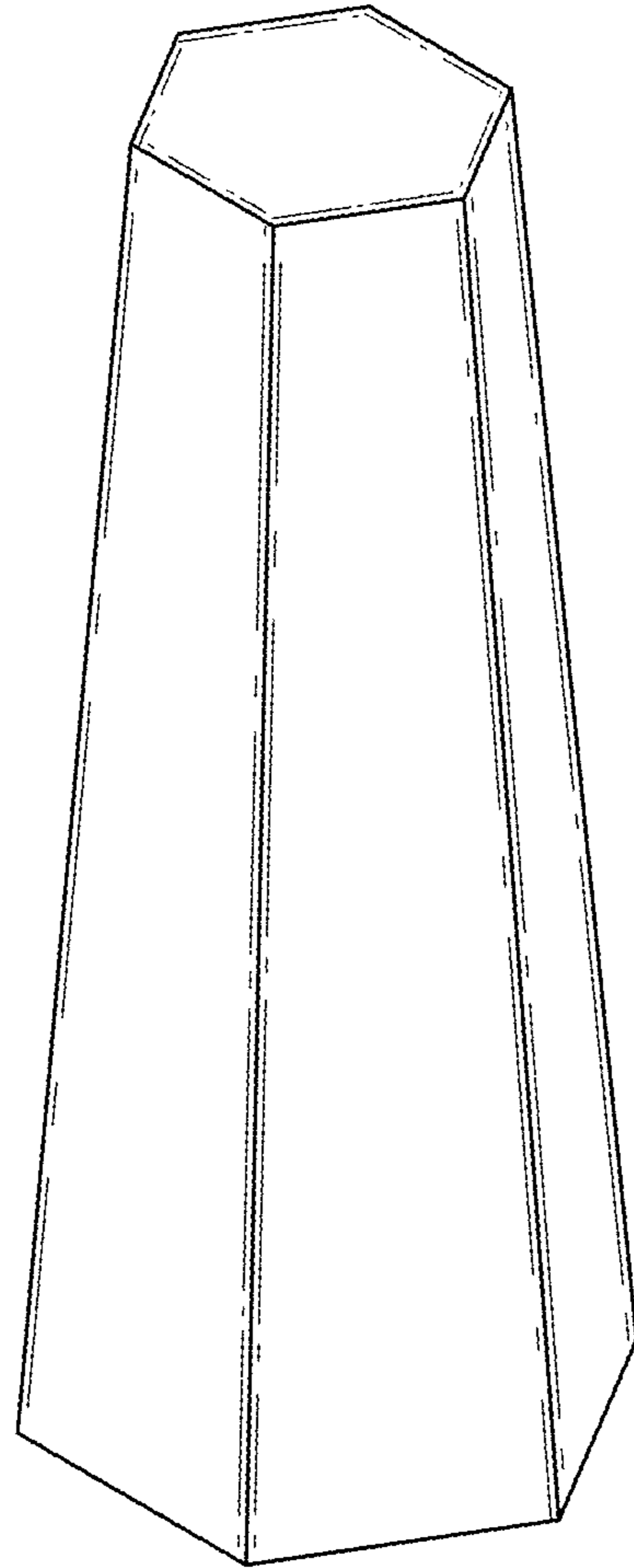

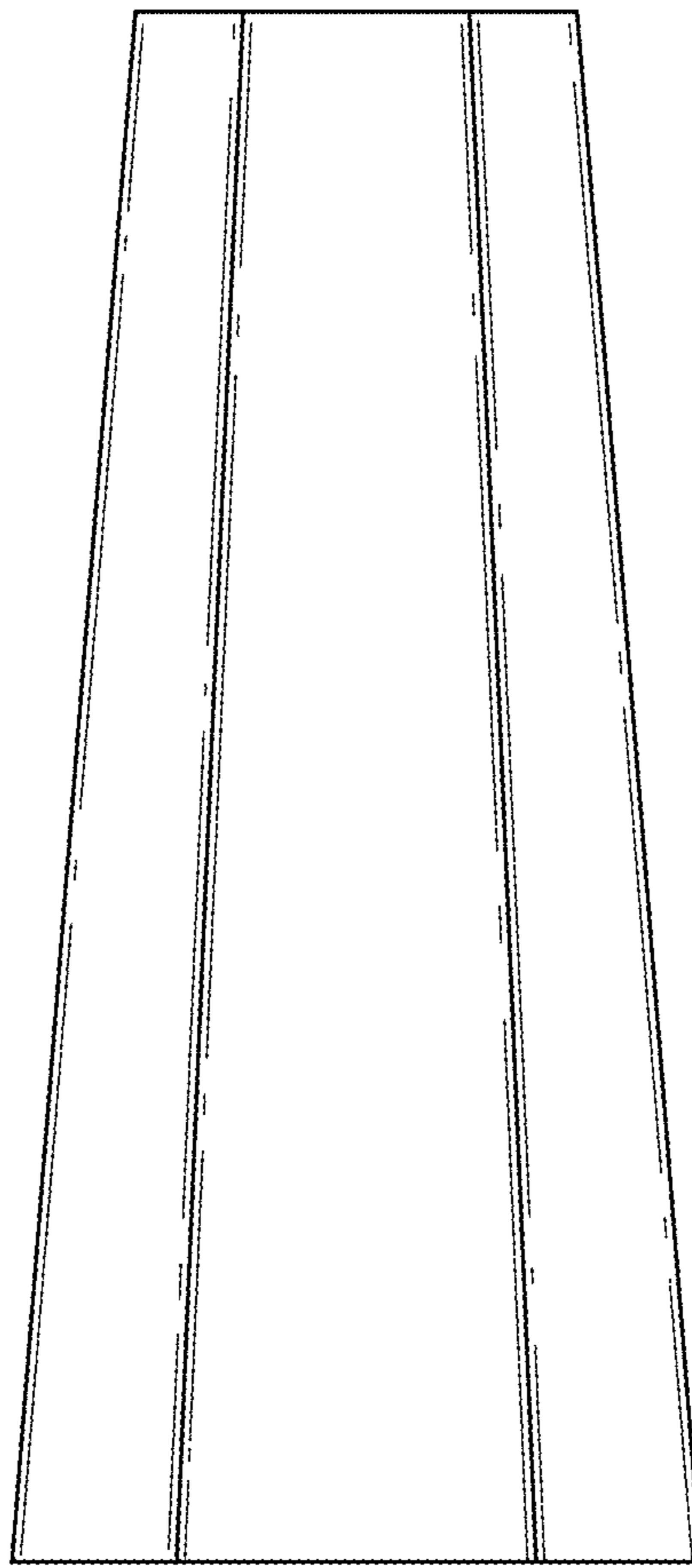

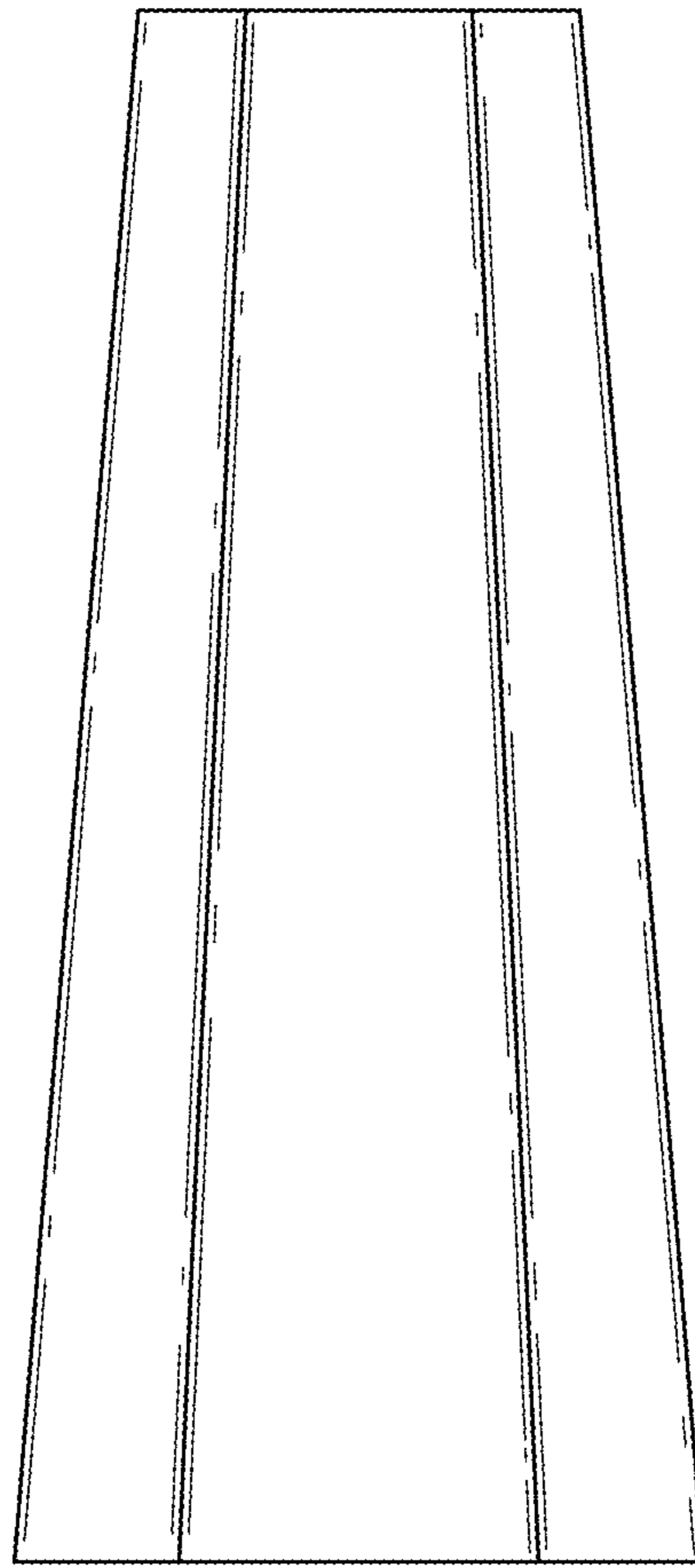

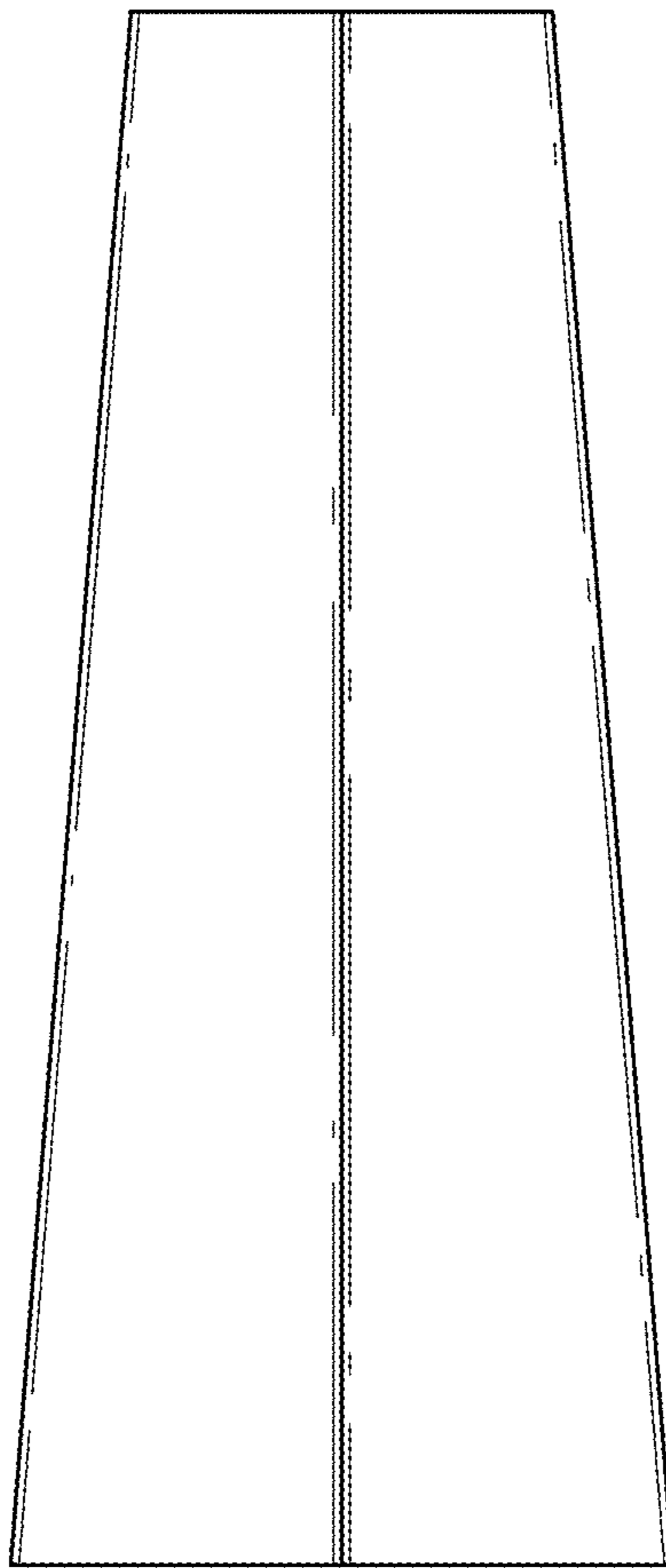

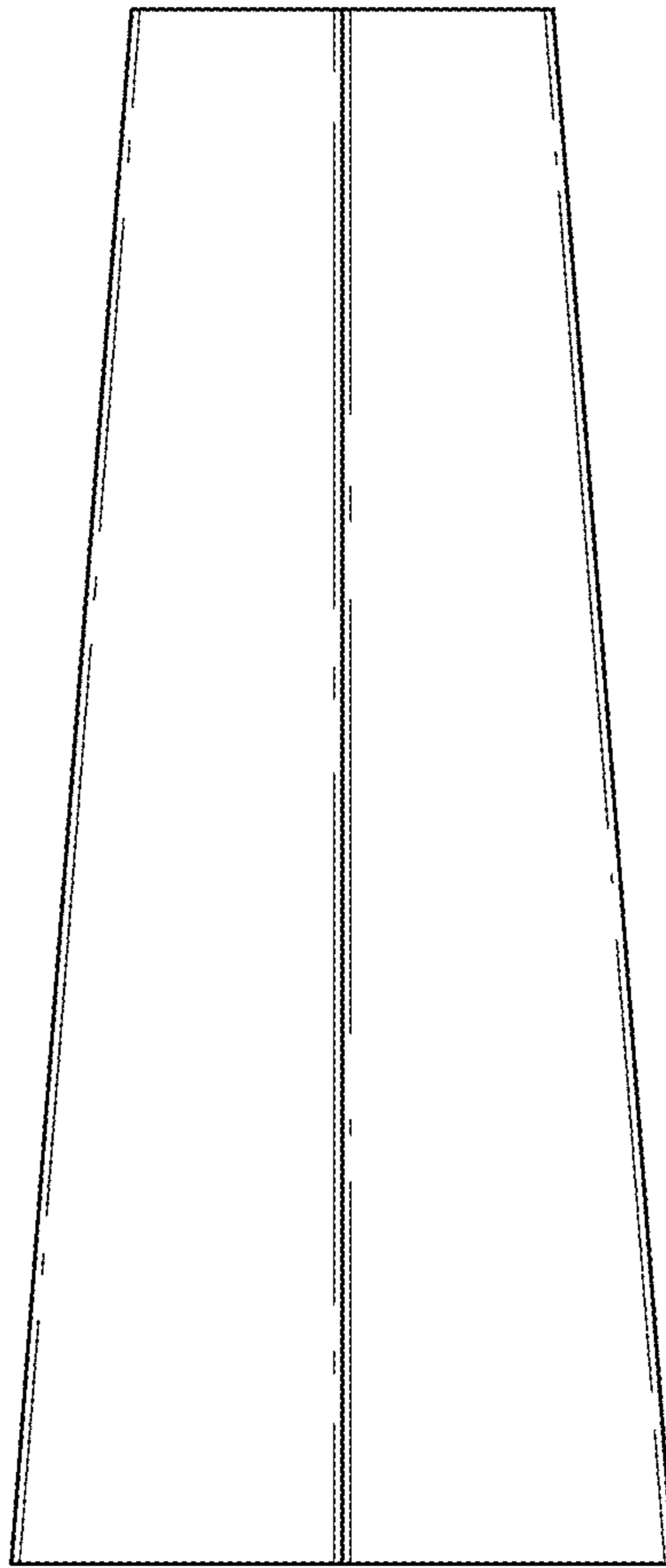

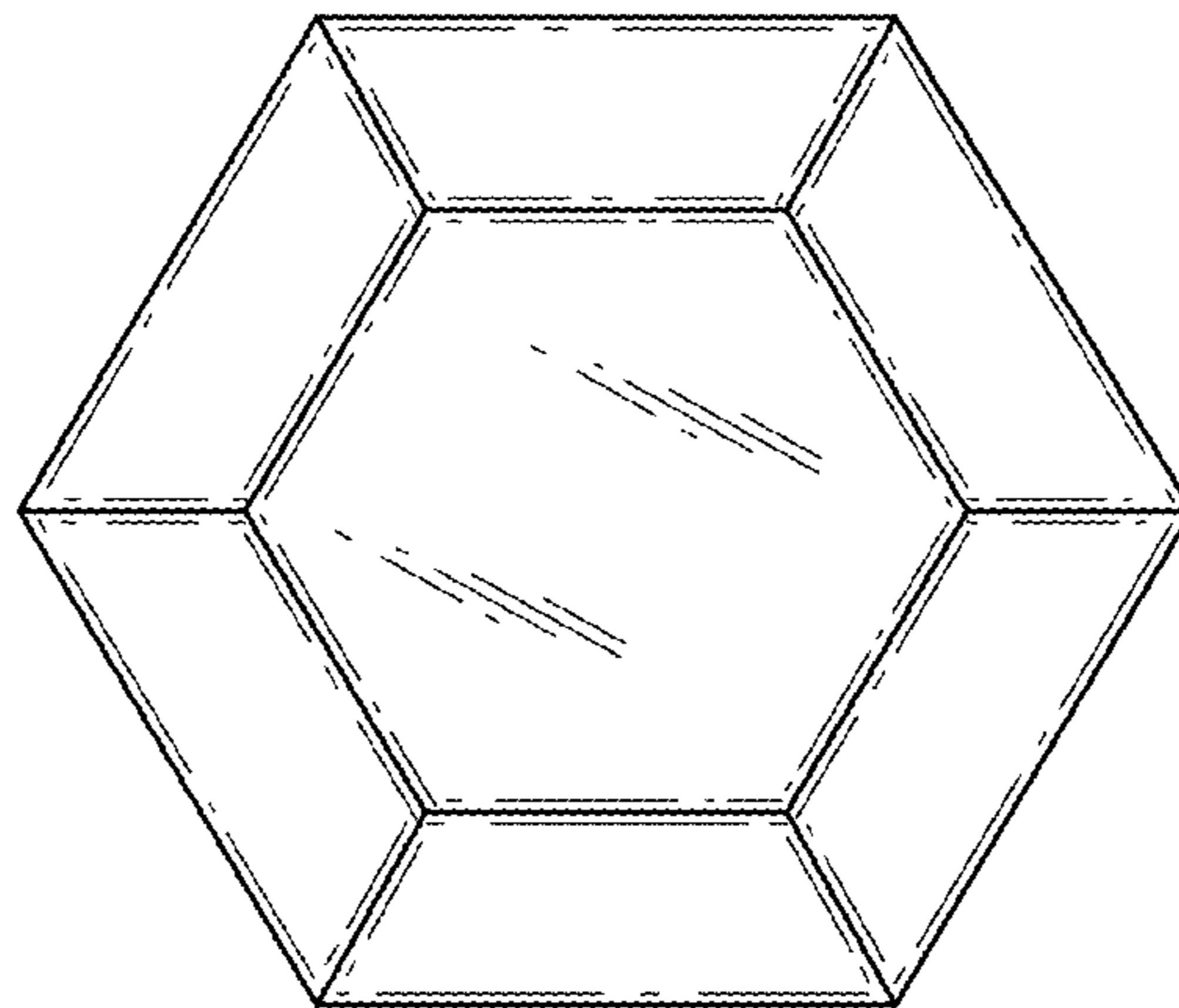

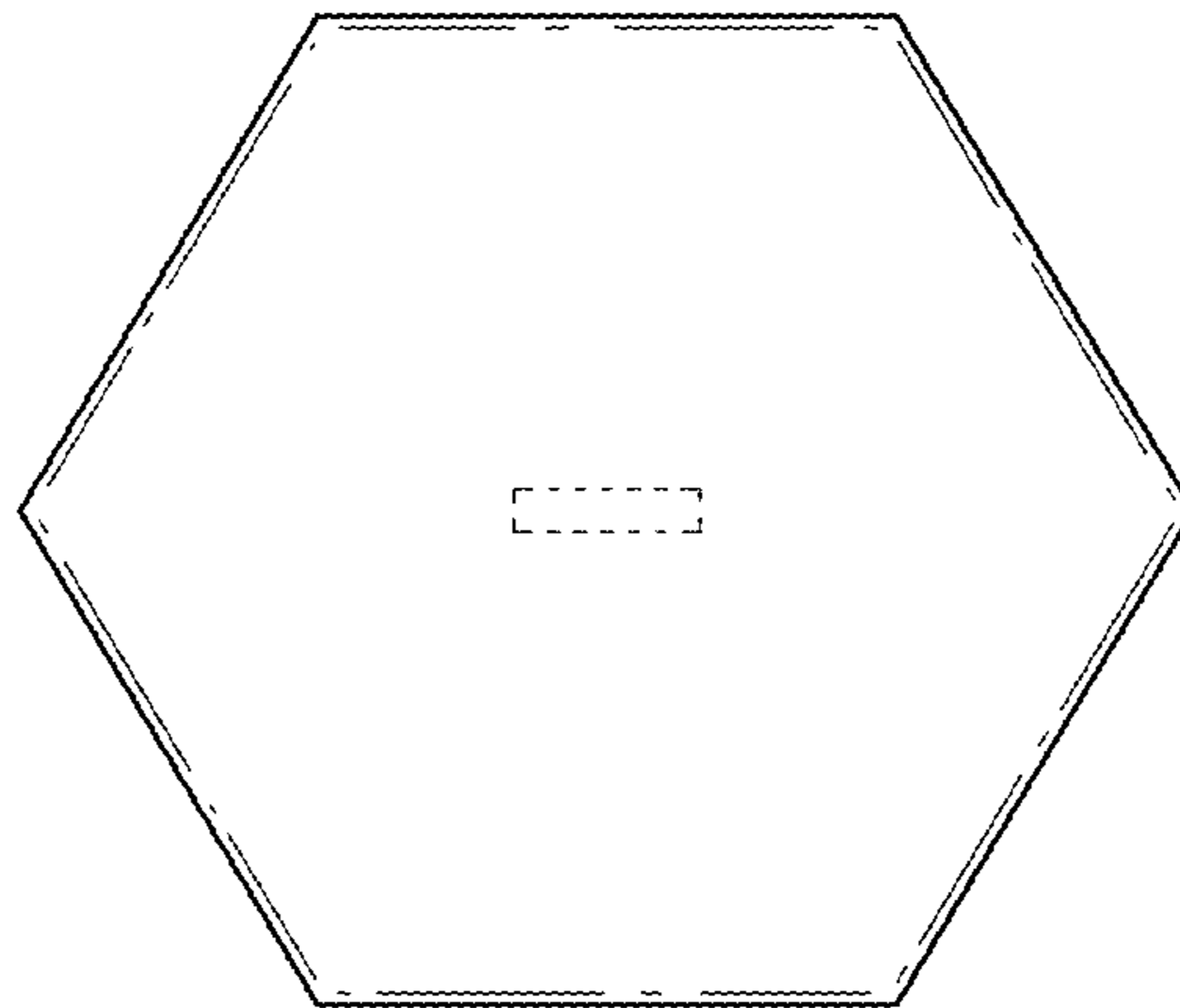
