(57) **CLAIM**

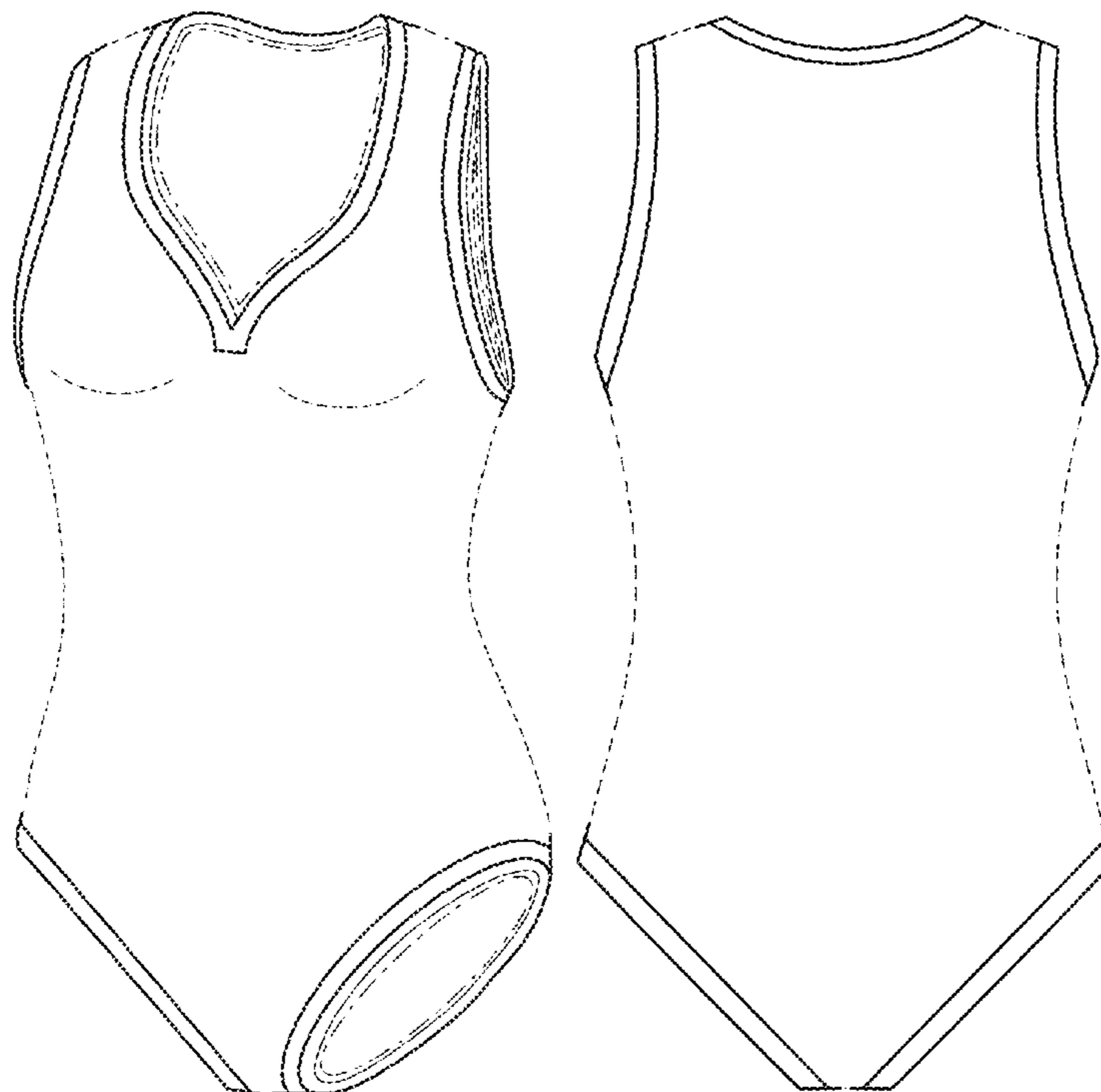
The ornamental design for a bodysuit, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bodysuit, showing my new design;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a rear elevation view thereof;
 FIG. 4 is a left elevation view thereof, the right elevation view being a mirror image of thereof;
 FIG. 5 is a top plan view thereof; and,
 FIG. 6 is a bottom plan view thereof.

The evenly sized broken lines shown in the drawings depict portions of the bodysuit that form no part of the claimed design, while the unevenly sized (dash-dot-dash) broken lines represent the bounds of the claimed design.

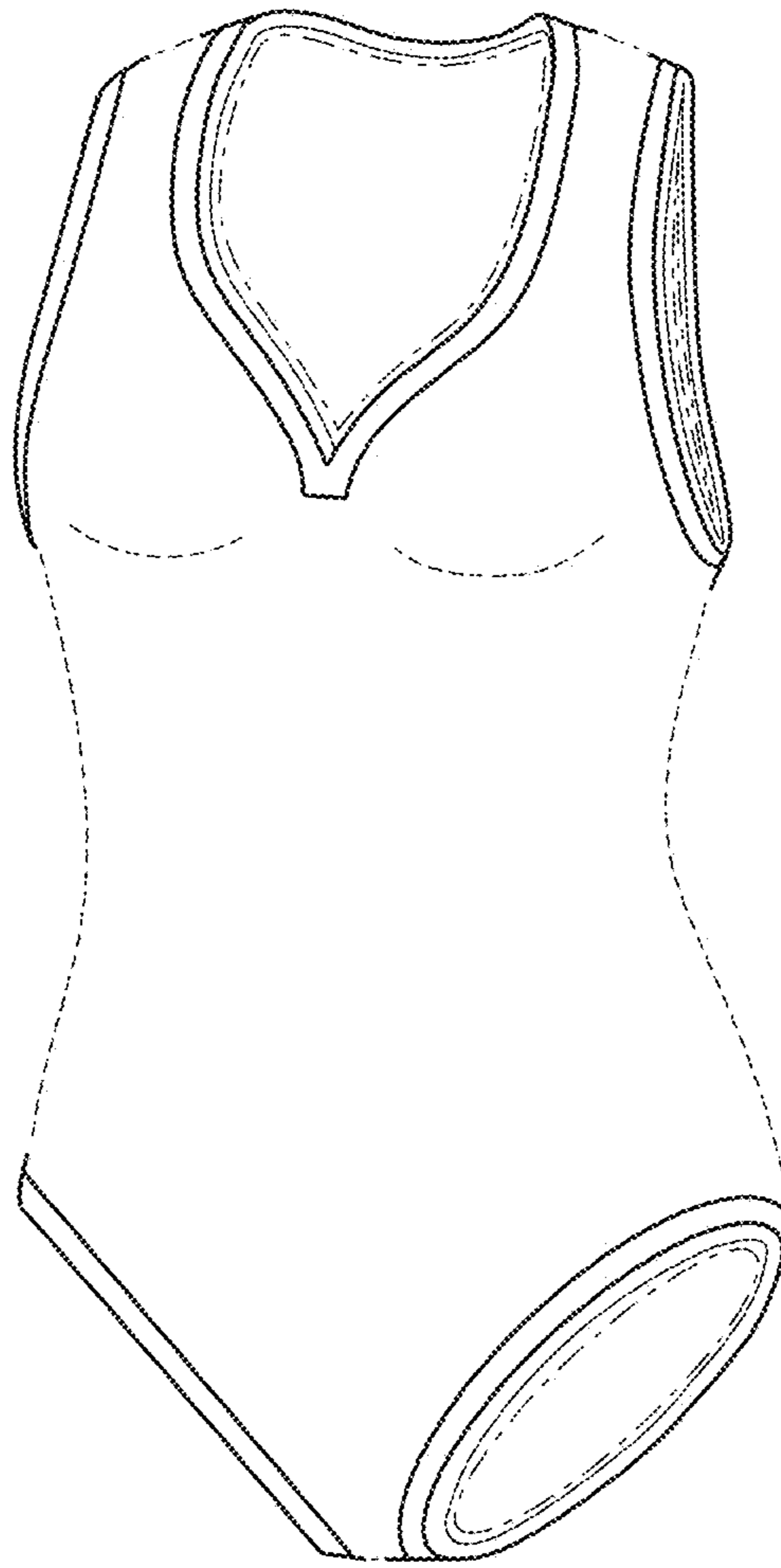

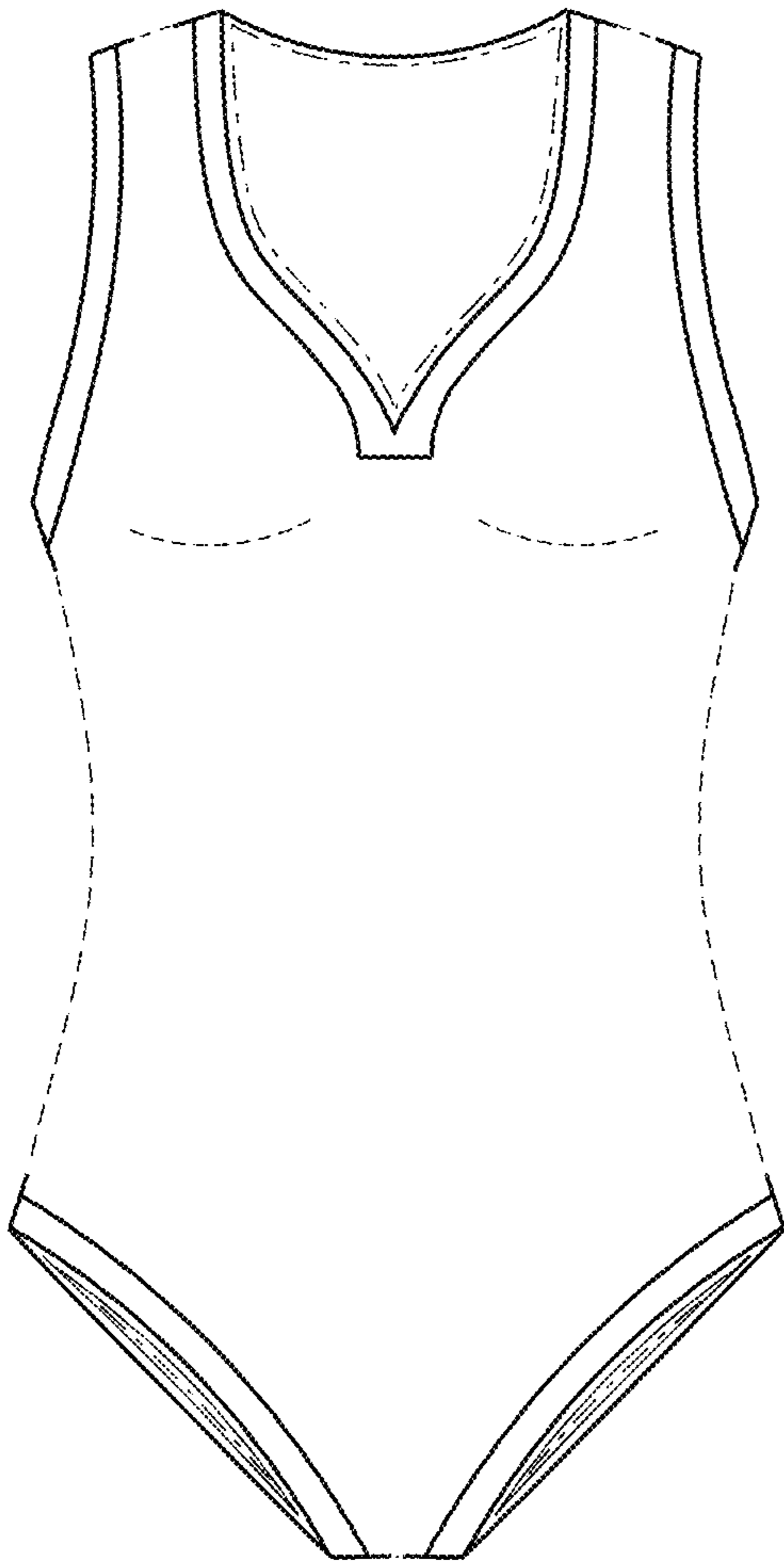

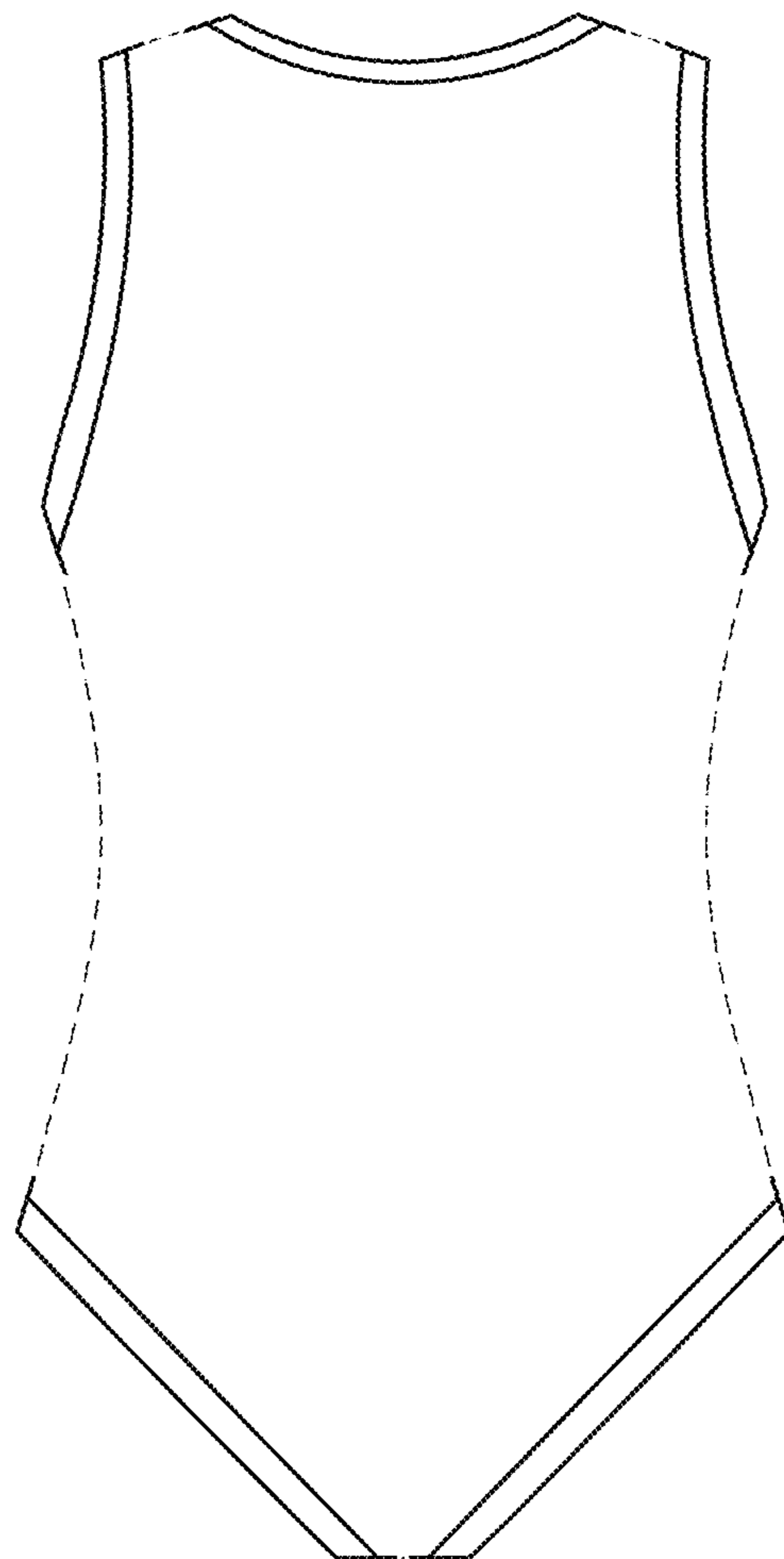
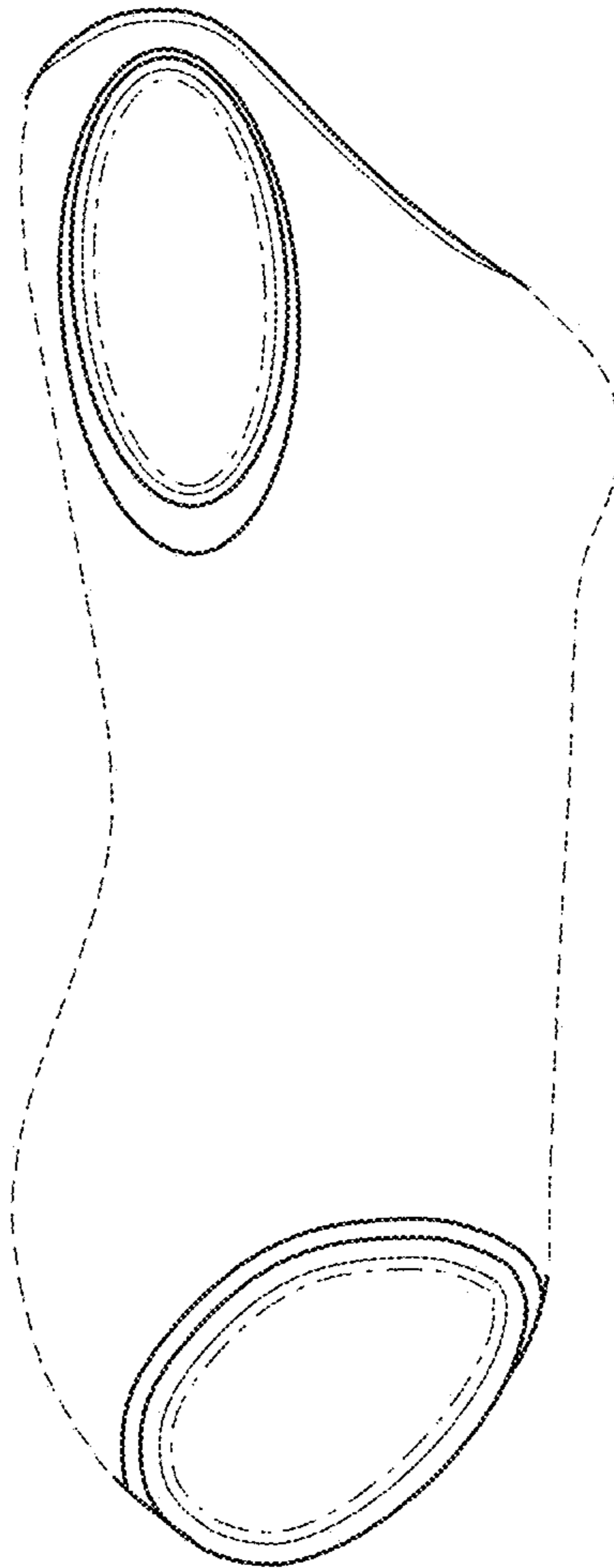

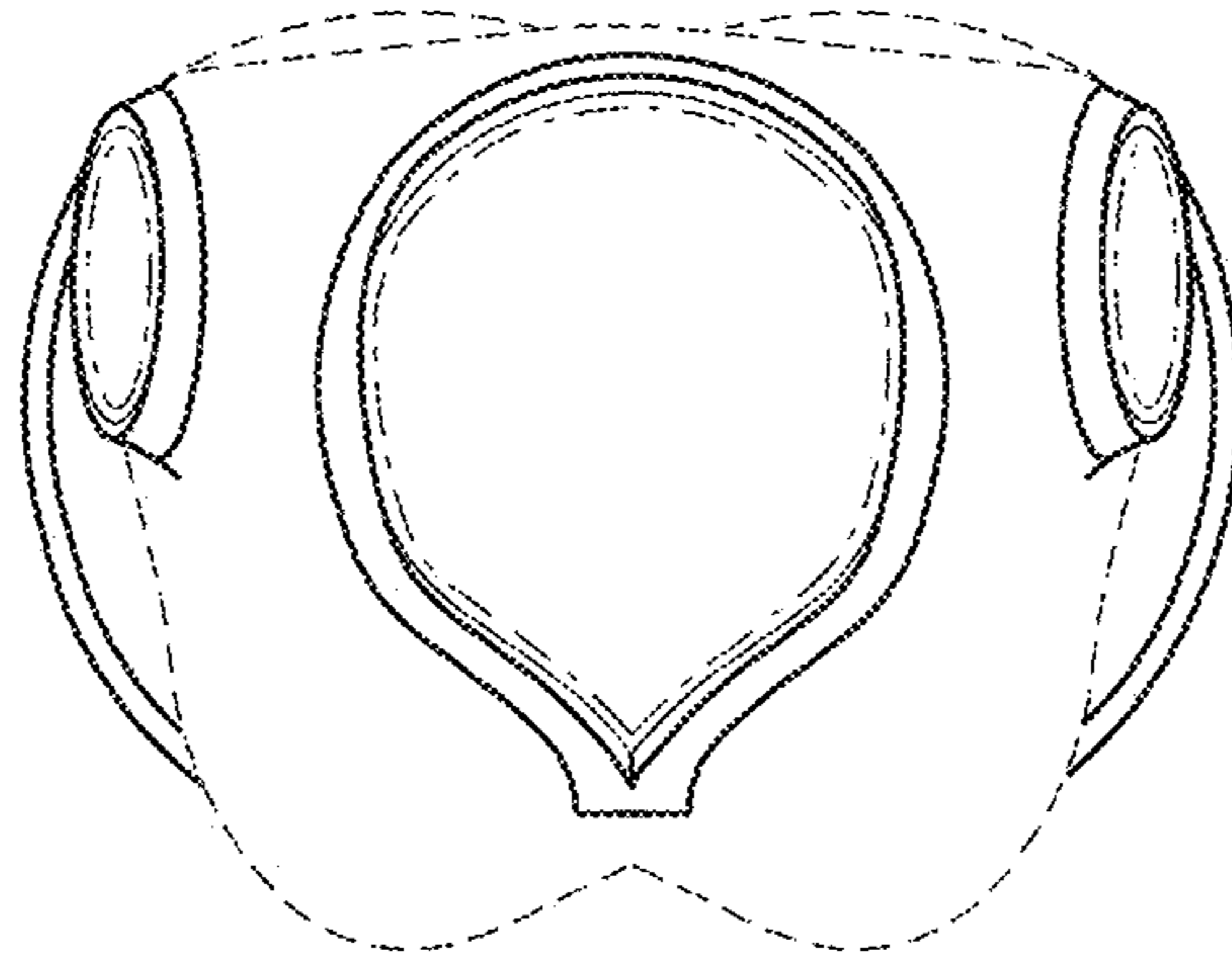

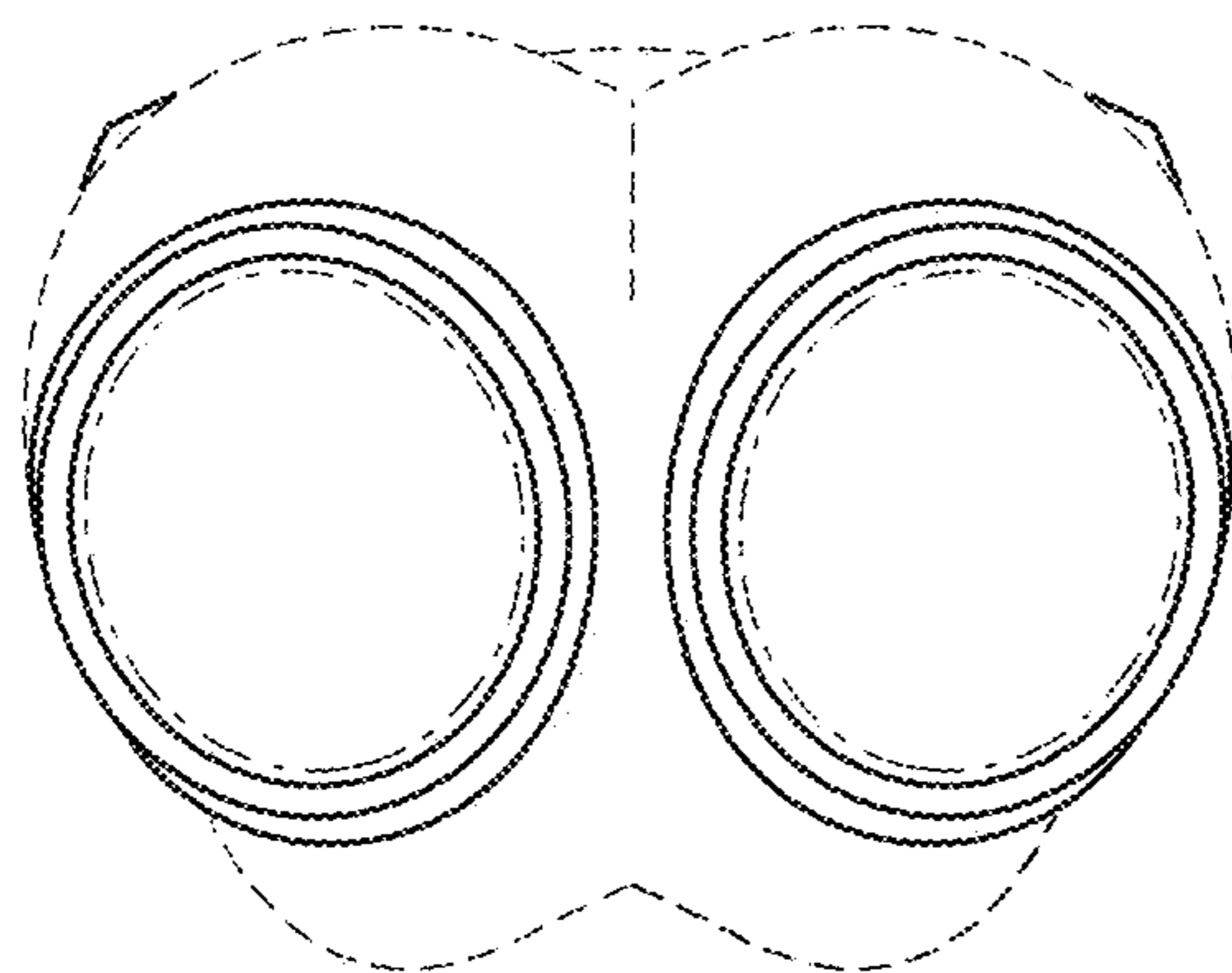
