DESCRIPTION

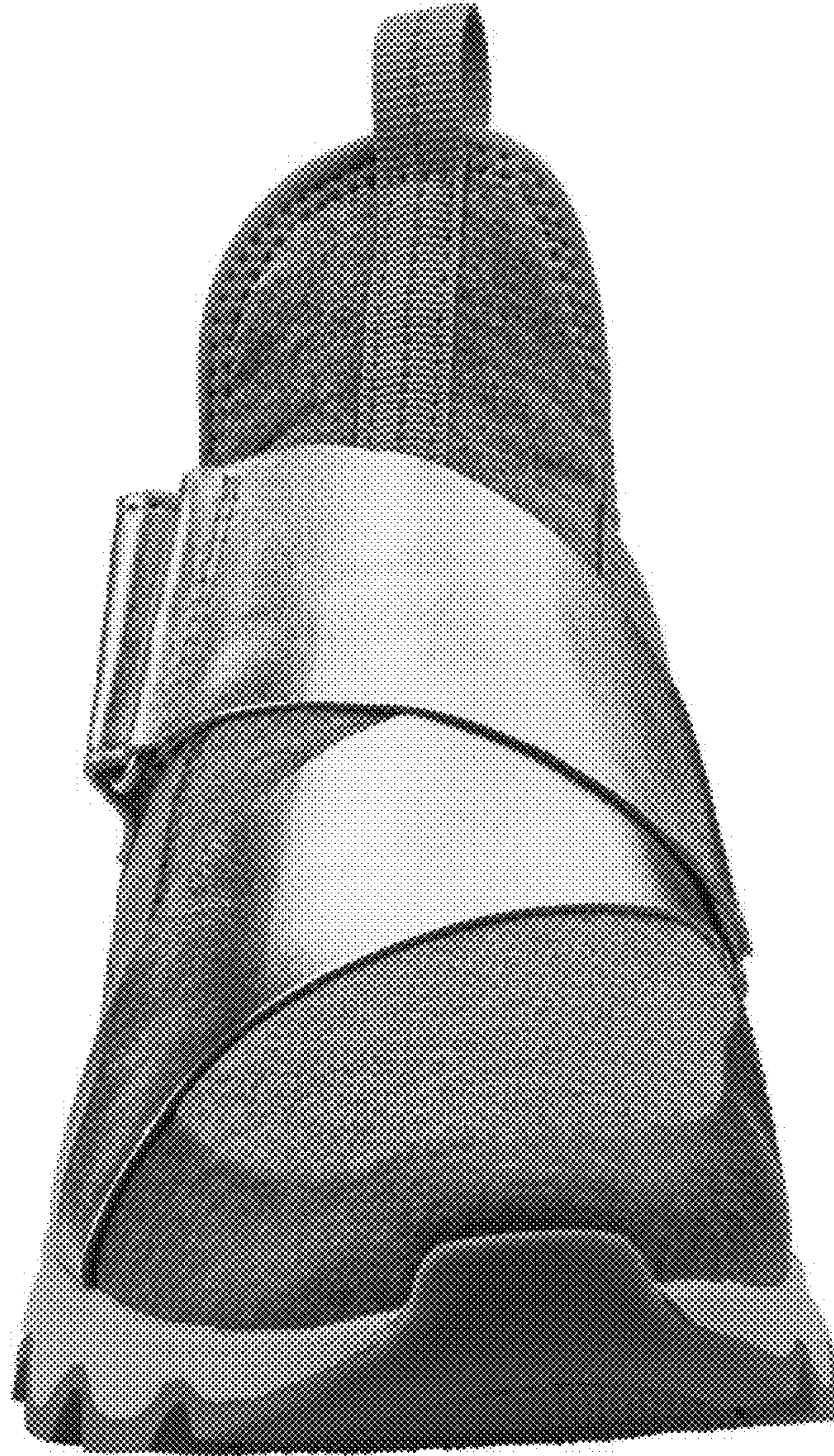
